FIG. 2 is a front view of the compression shorts shown in FIG. 1;

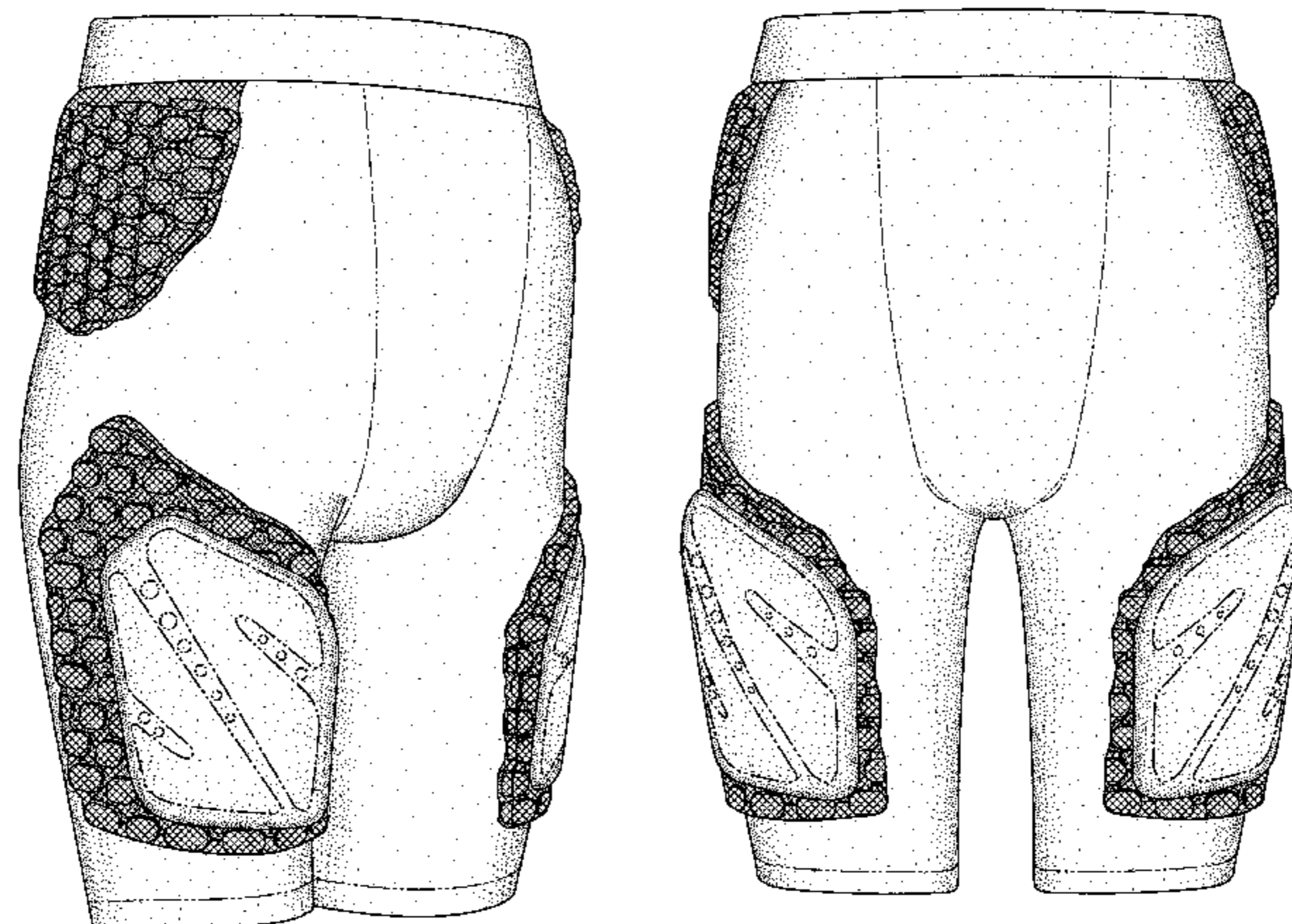
FIG. 3 is a rear view the compression shorts shown in FIG. 1;

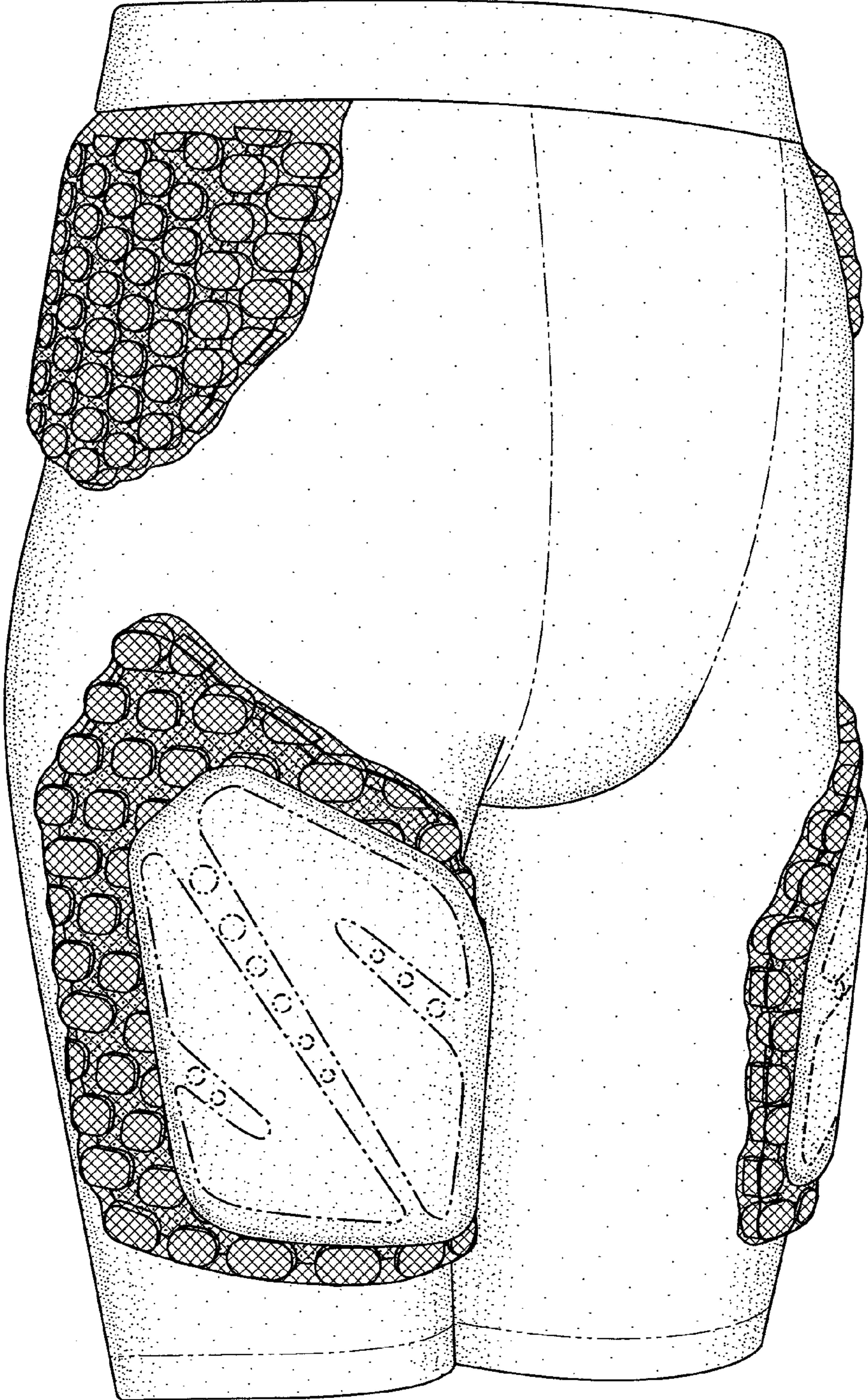

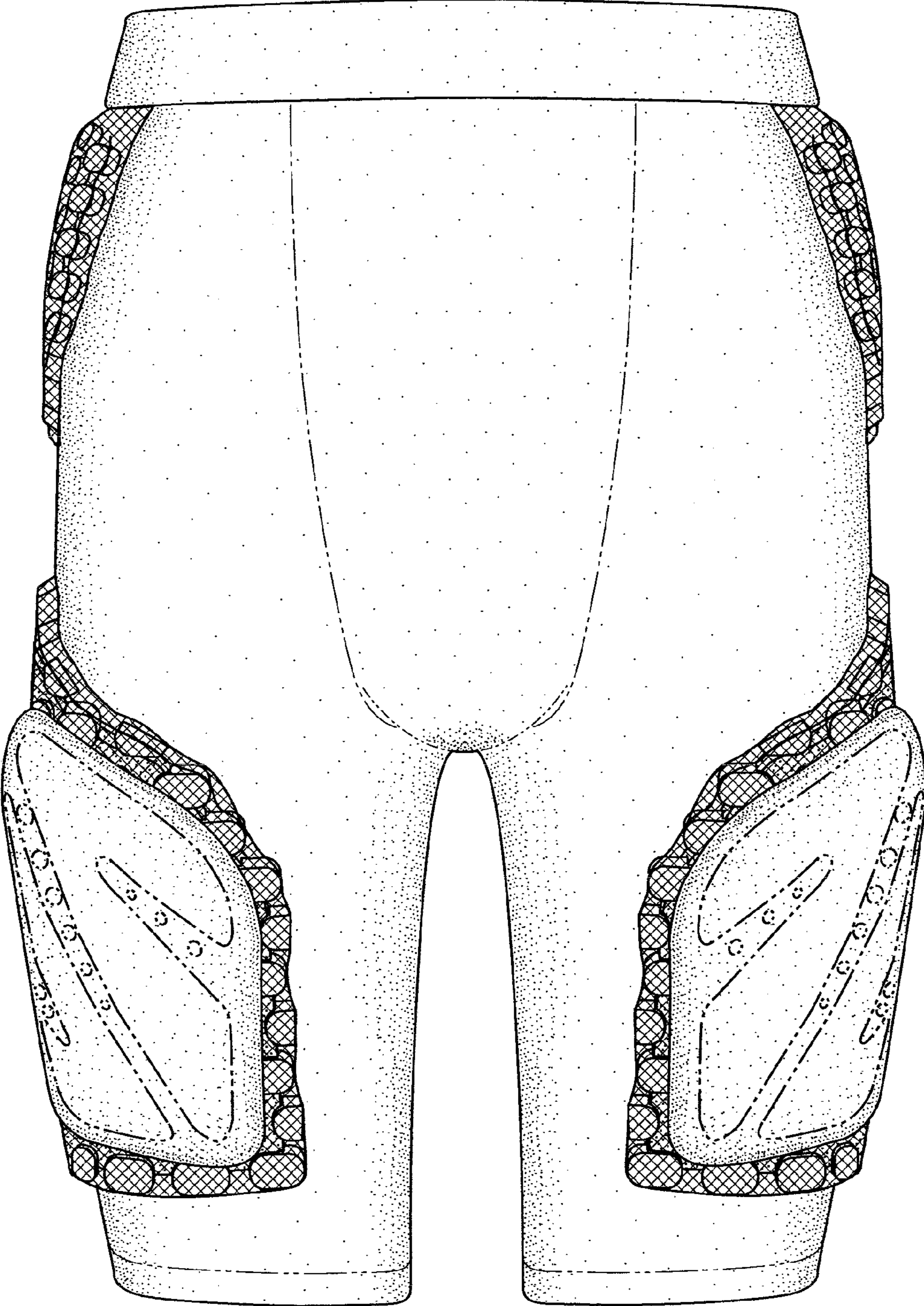
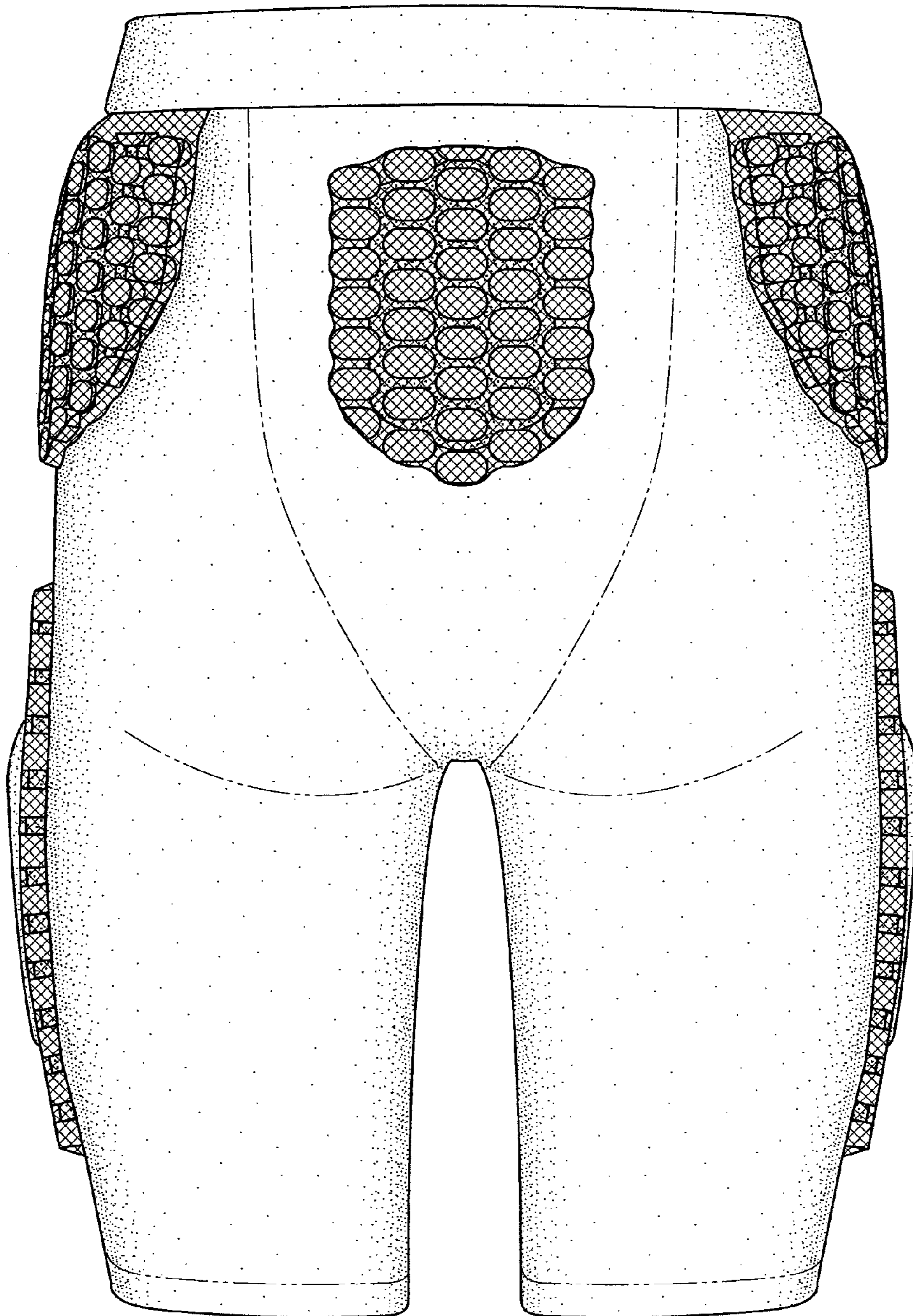
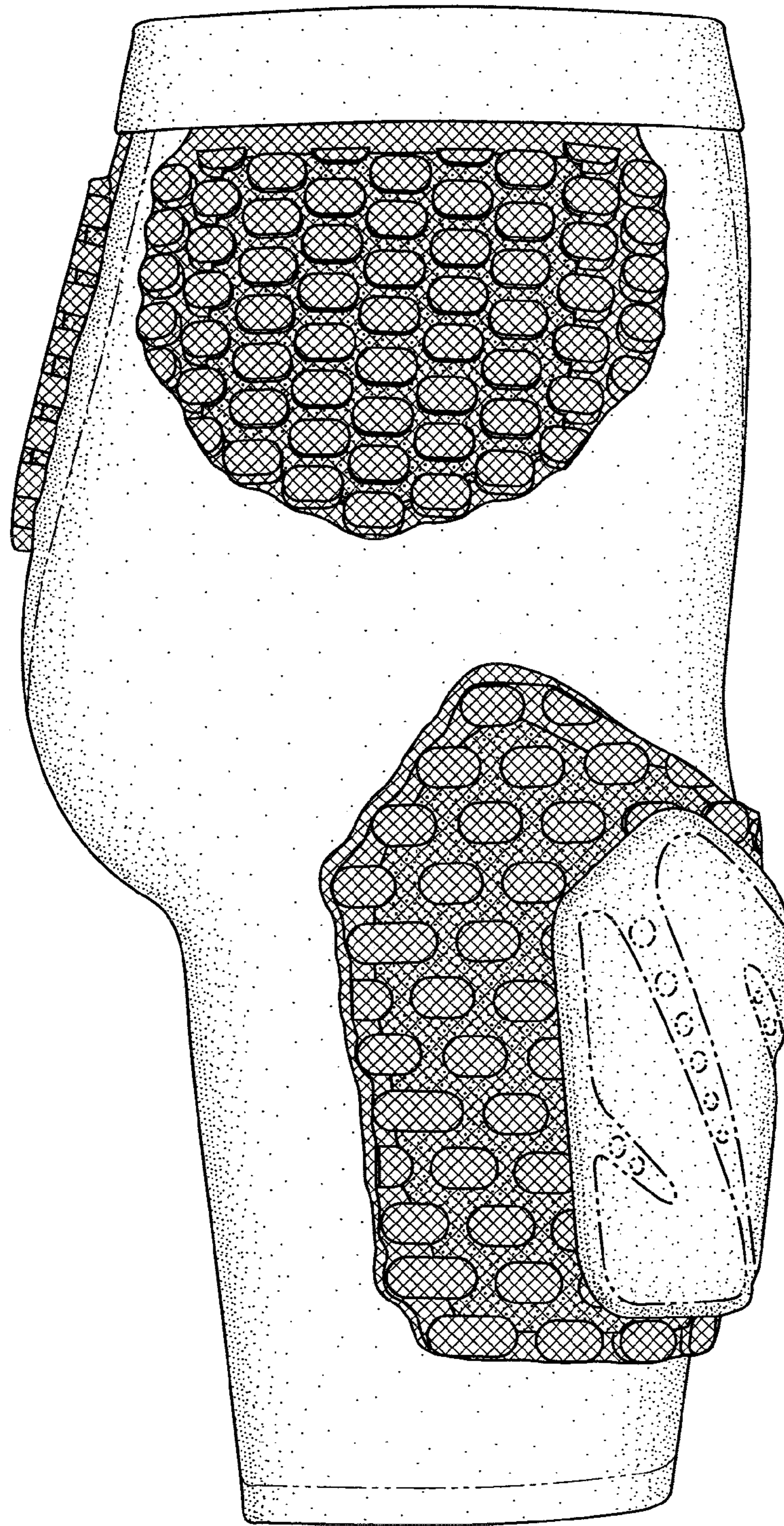


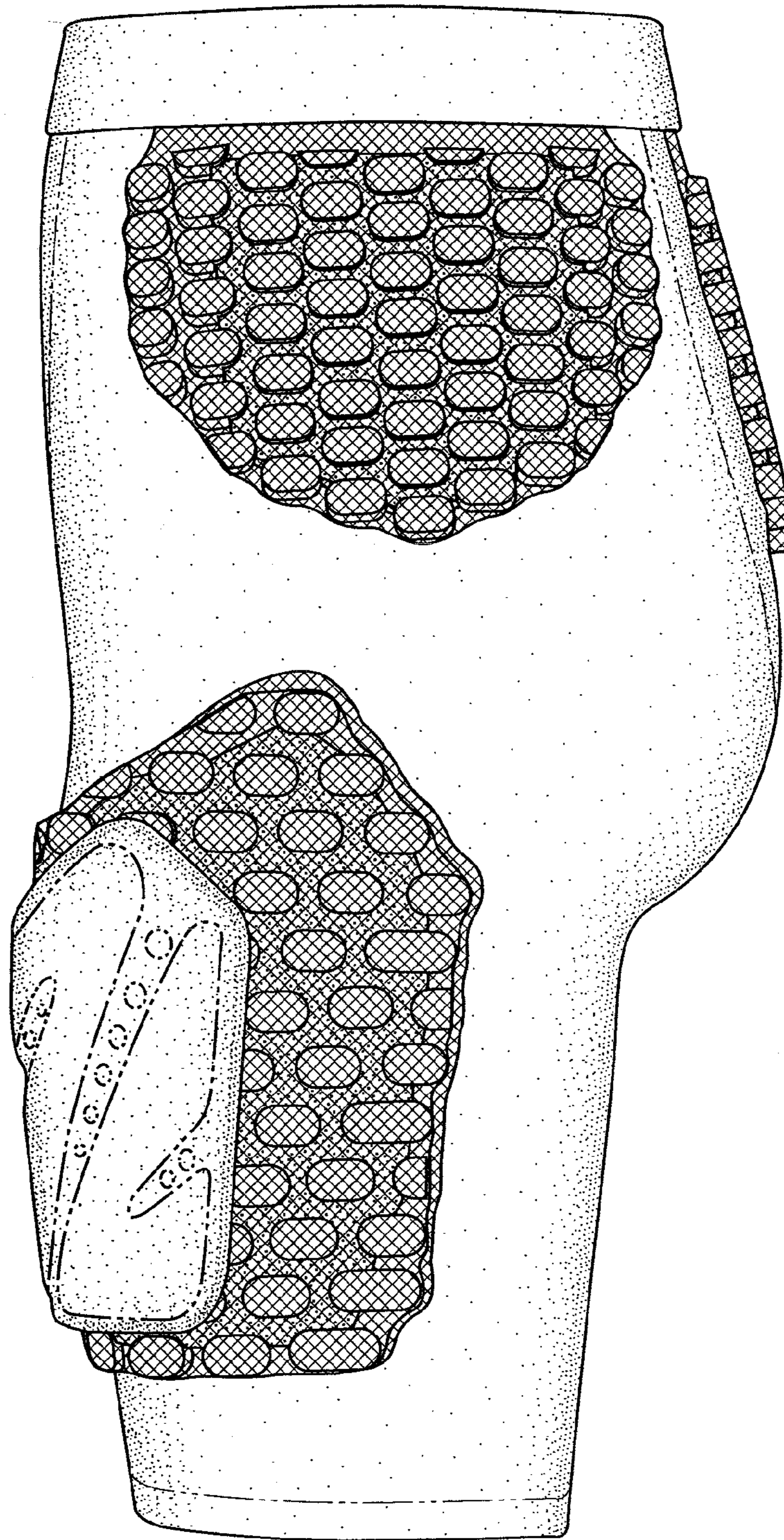
