FIG. 8 is a front view showing the shirt being worn thereof;

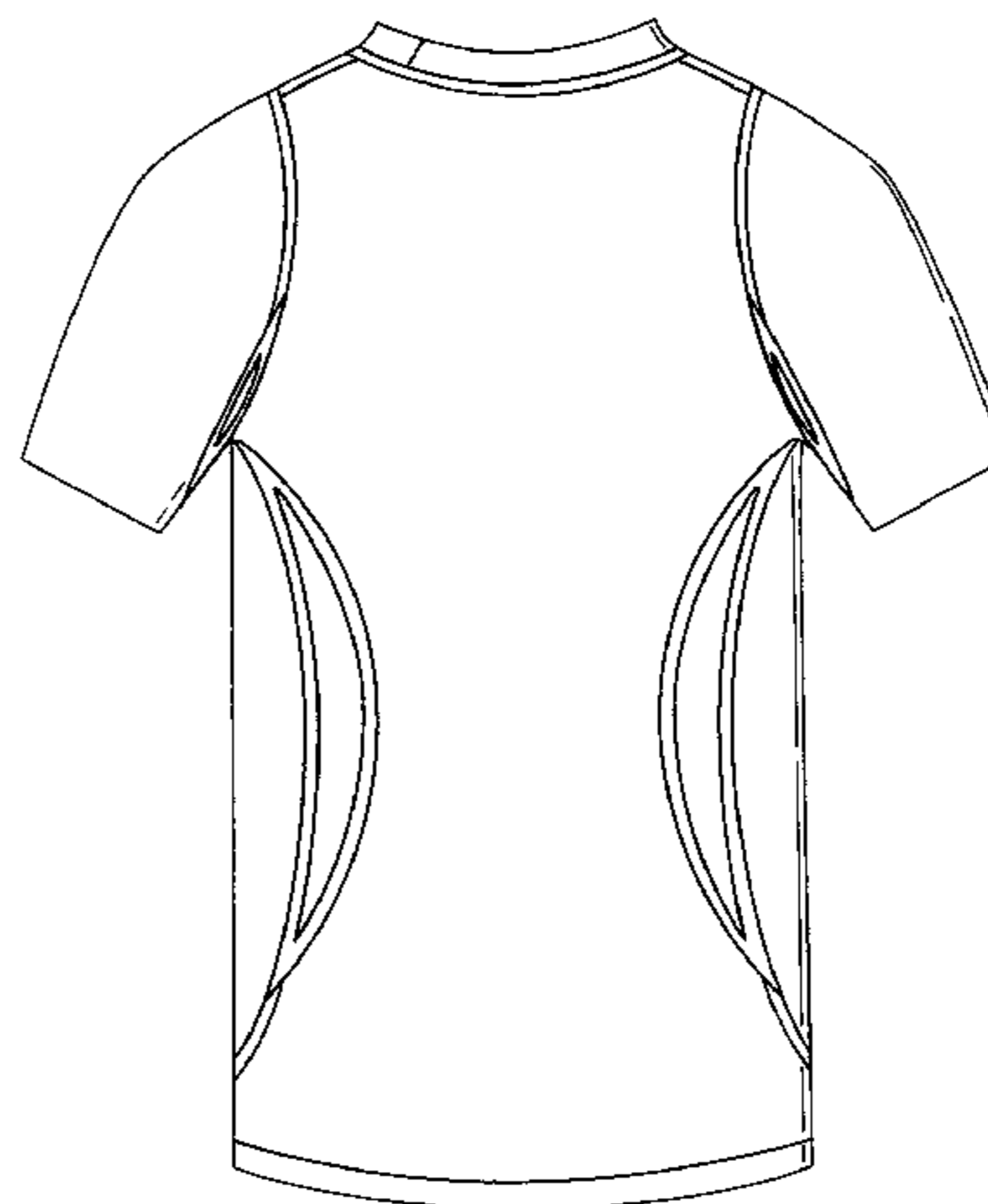
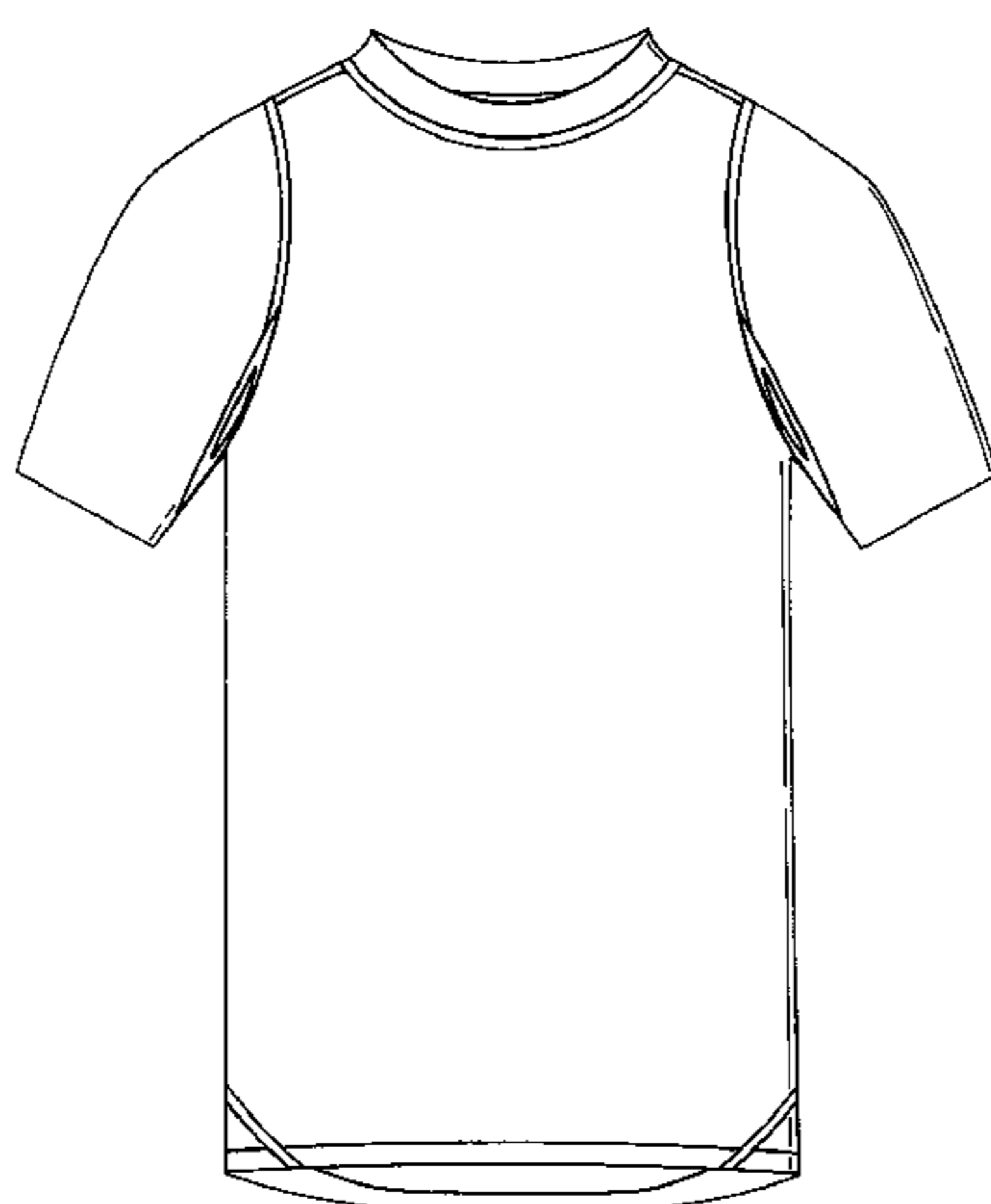
FIG. 9 is a rear view showing the shirt being worn thereof;

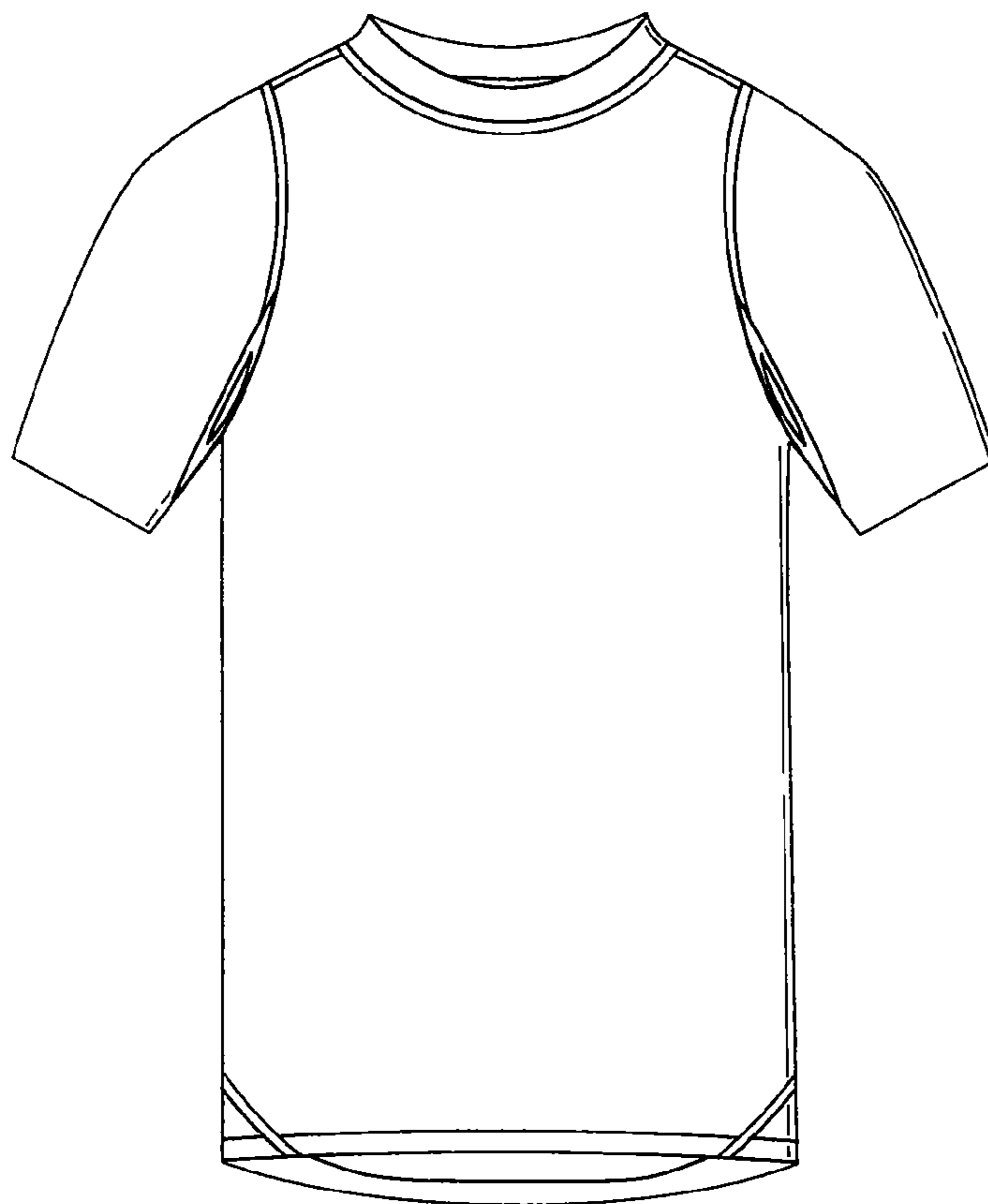

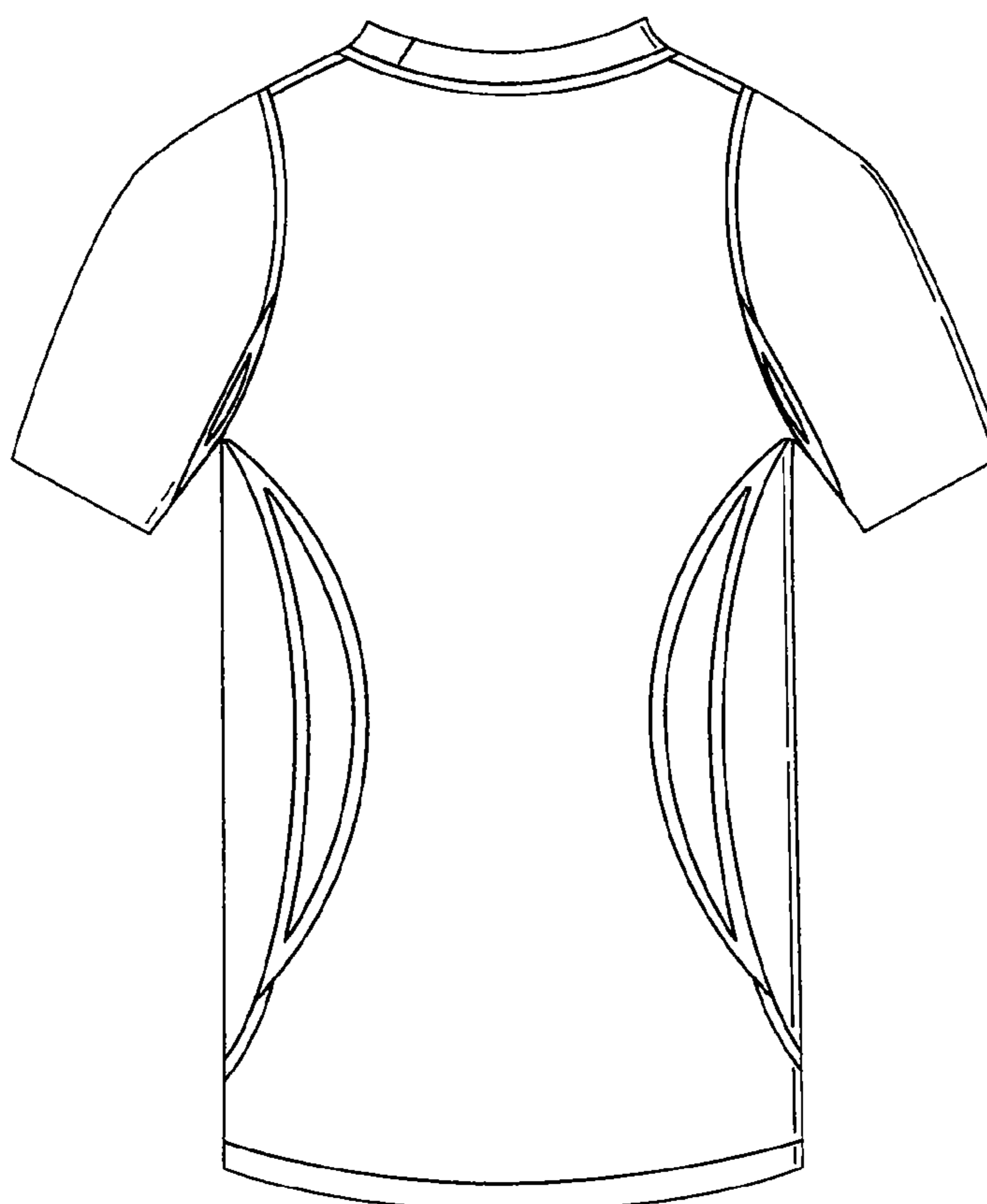

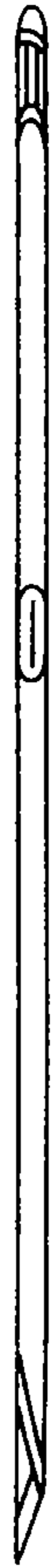

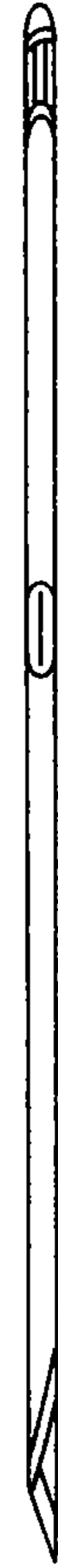

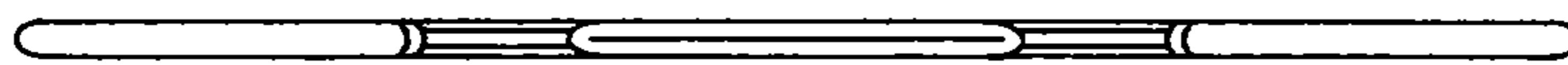

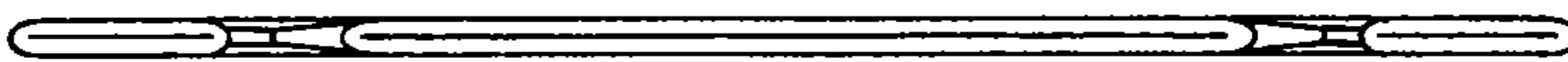

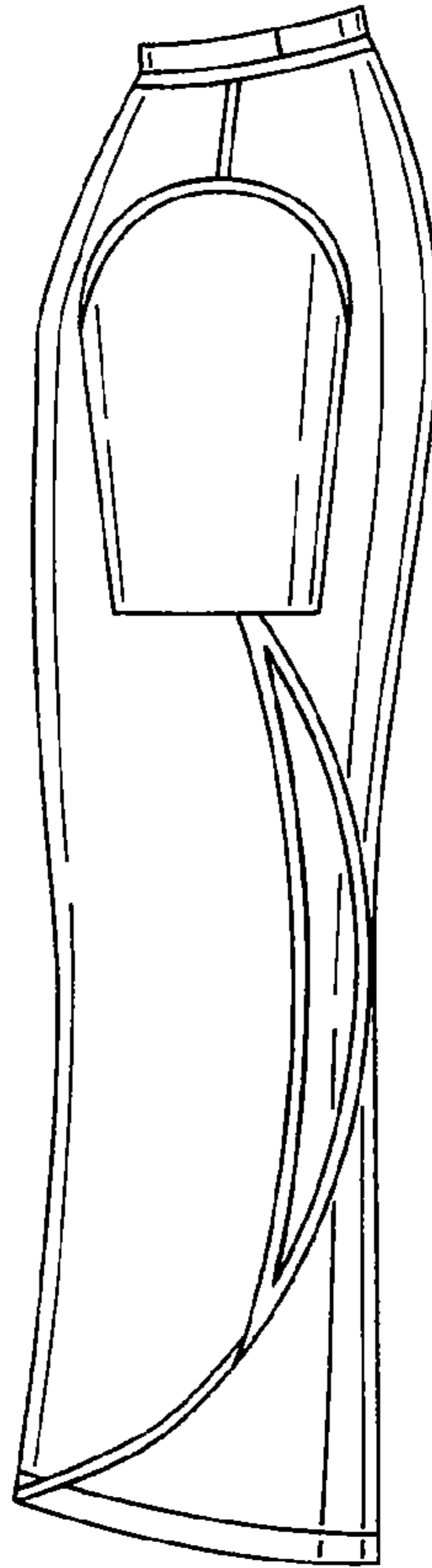

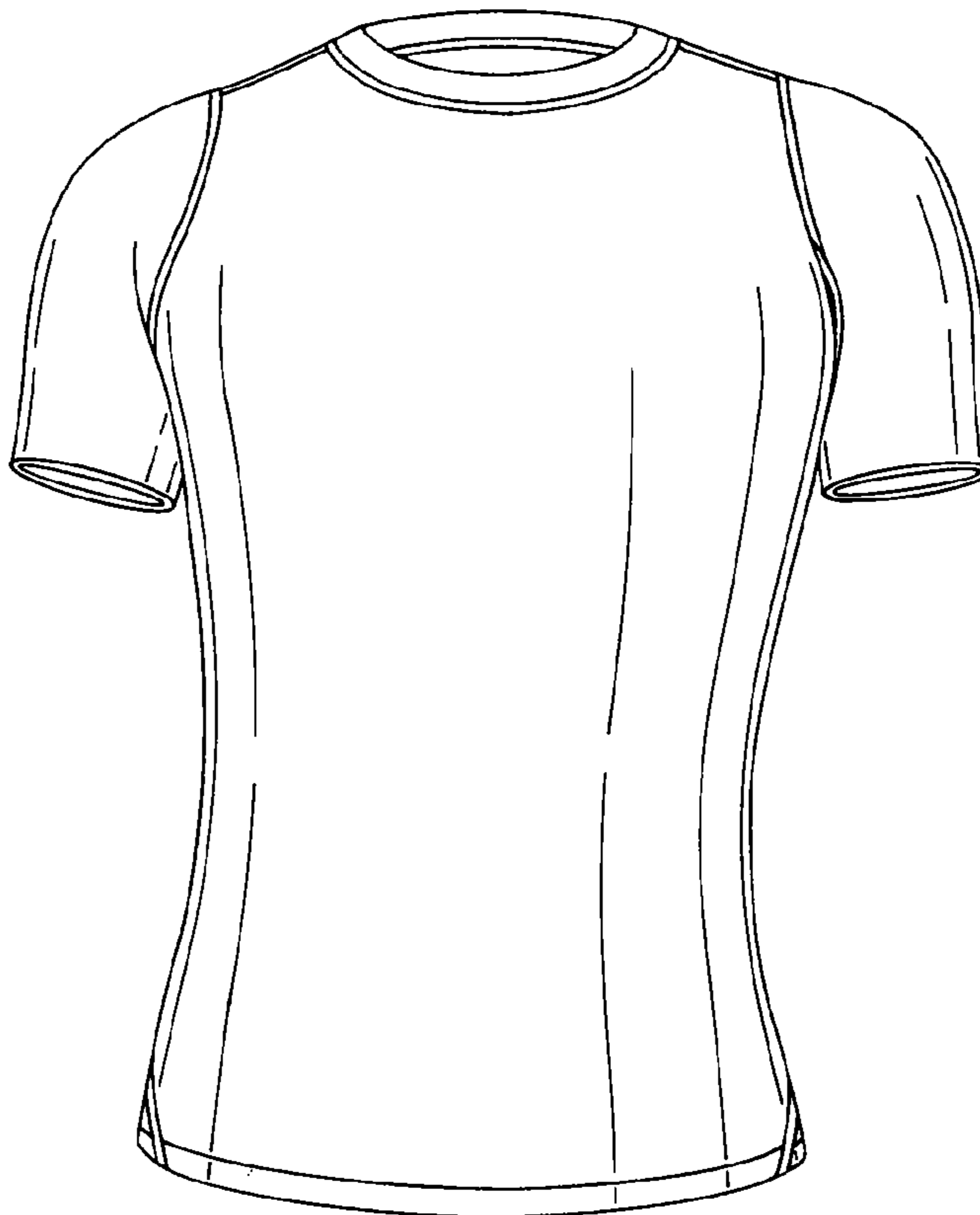

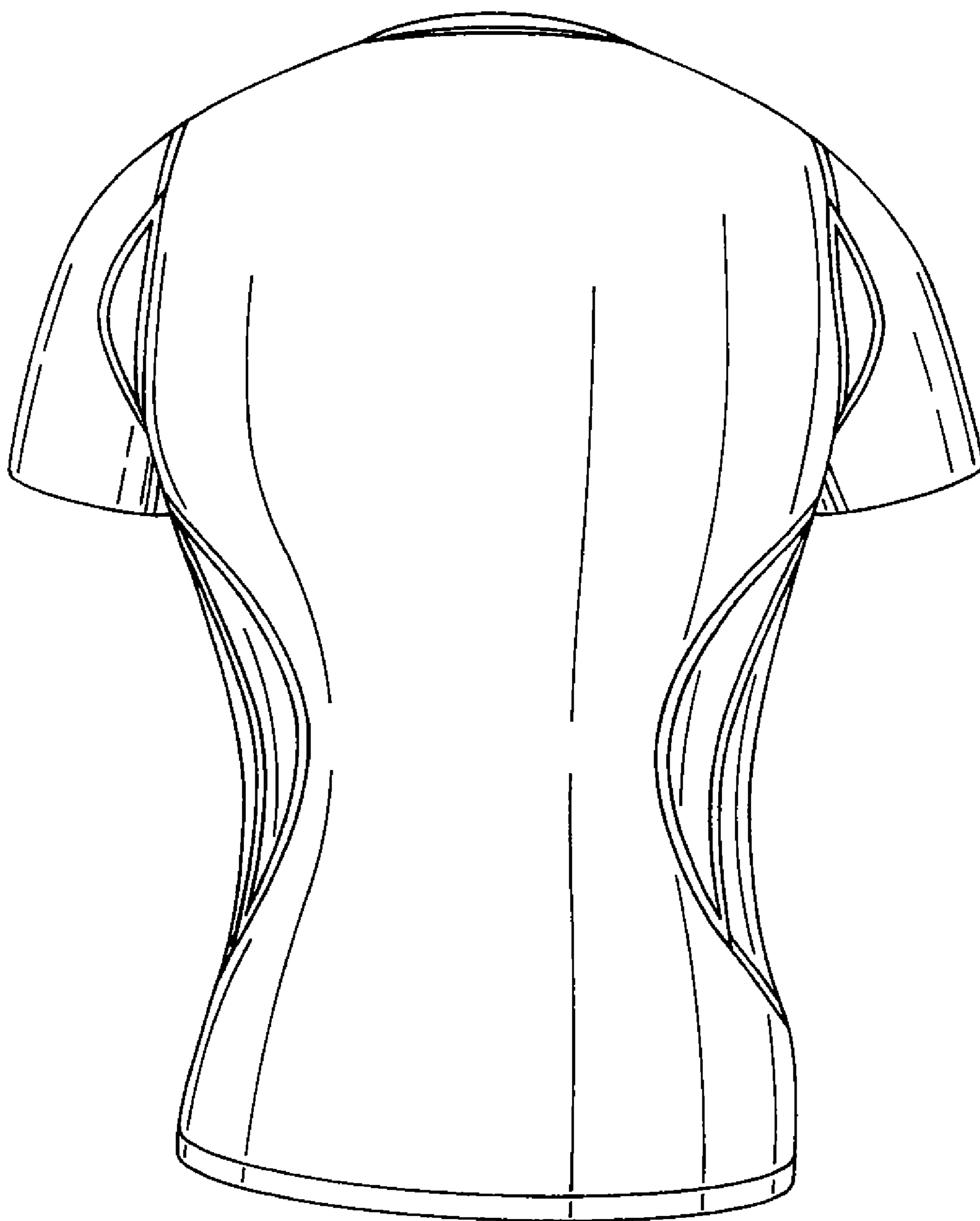

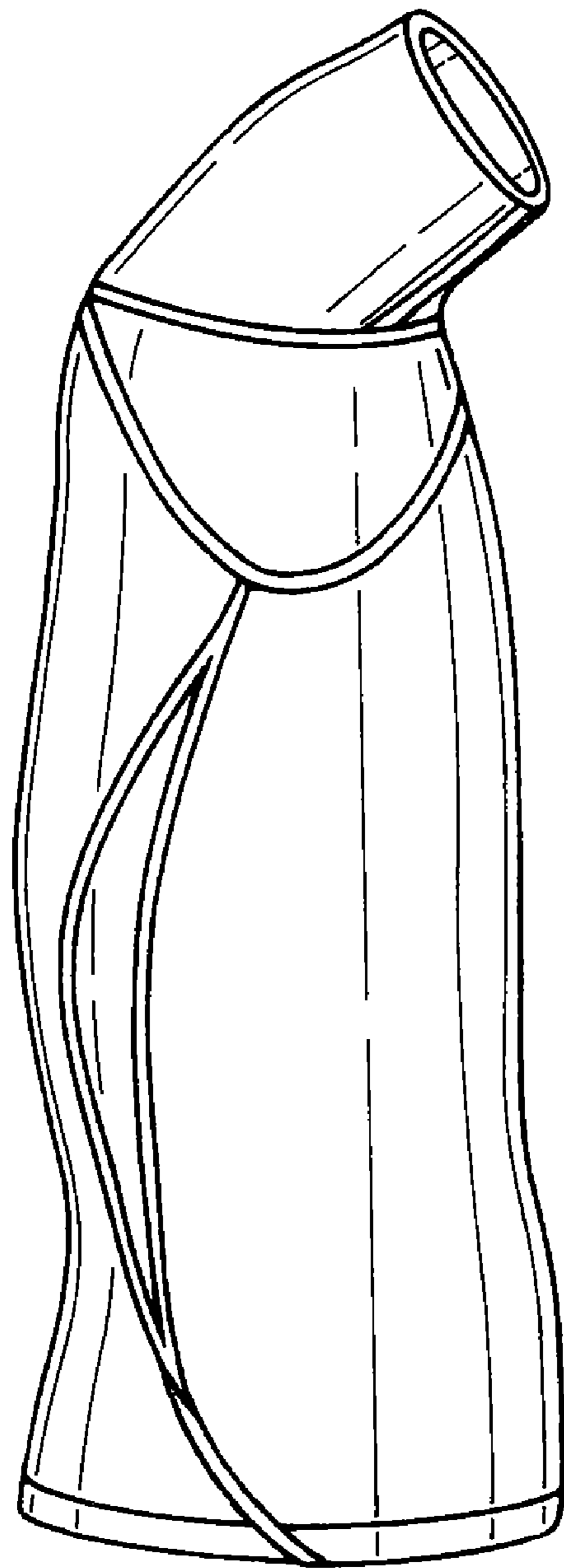
