FIG. 11 is a top plan view thereof with the upper panel open; and,

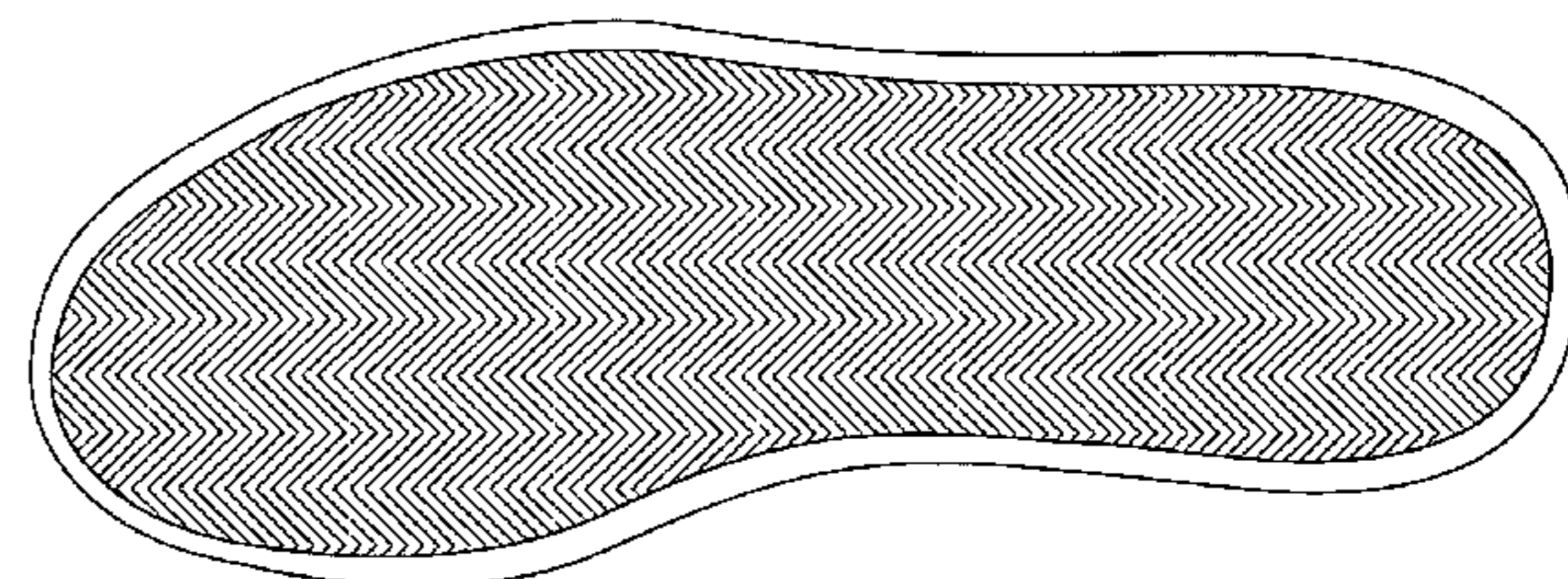
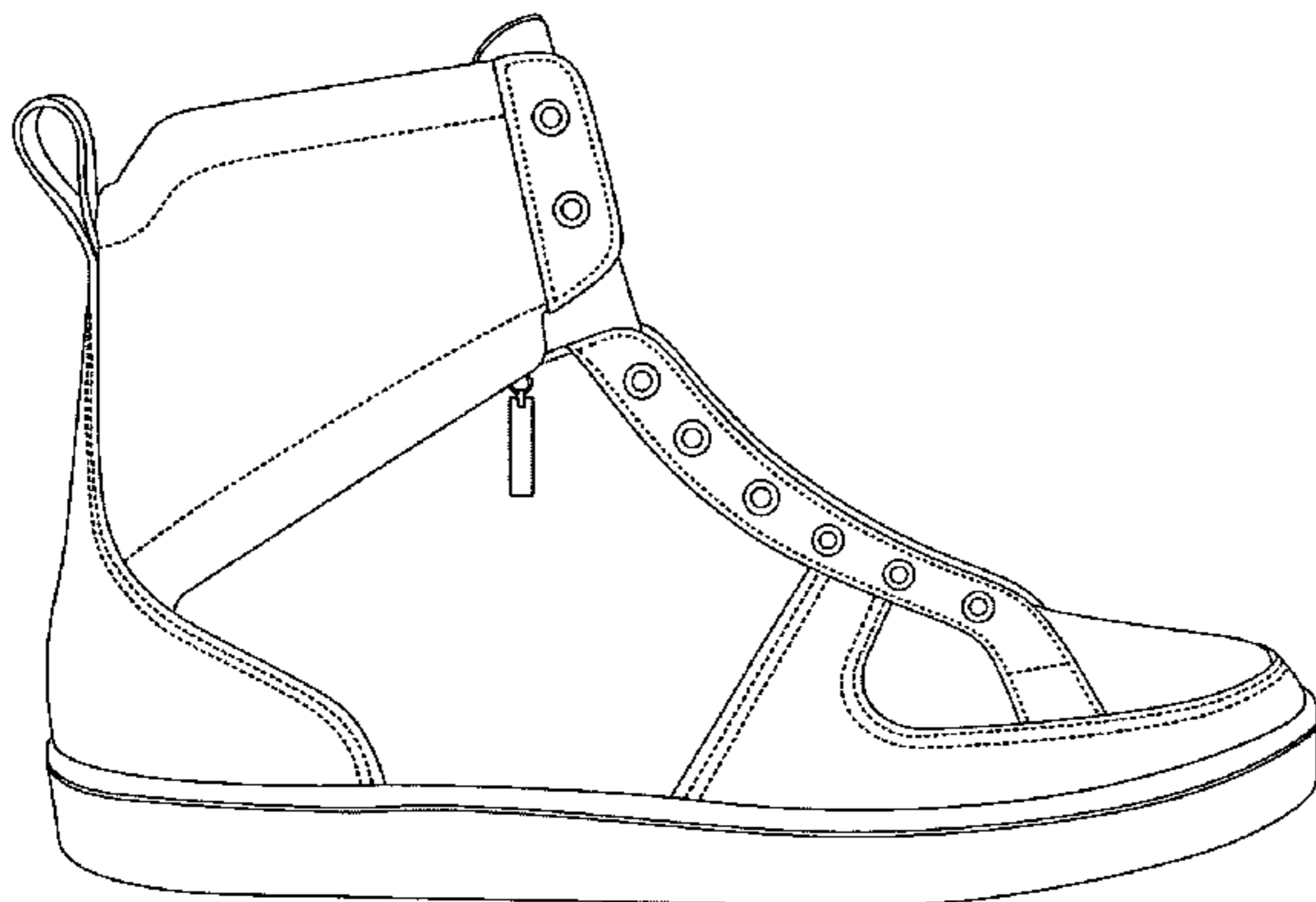
FIG. 12 is a bottom plan view thereof with the upper panel open.

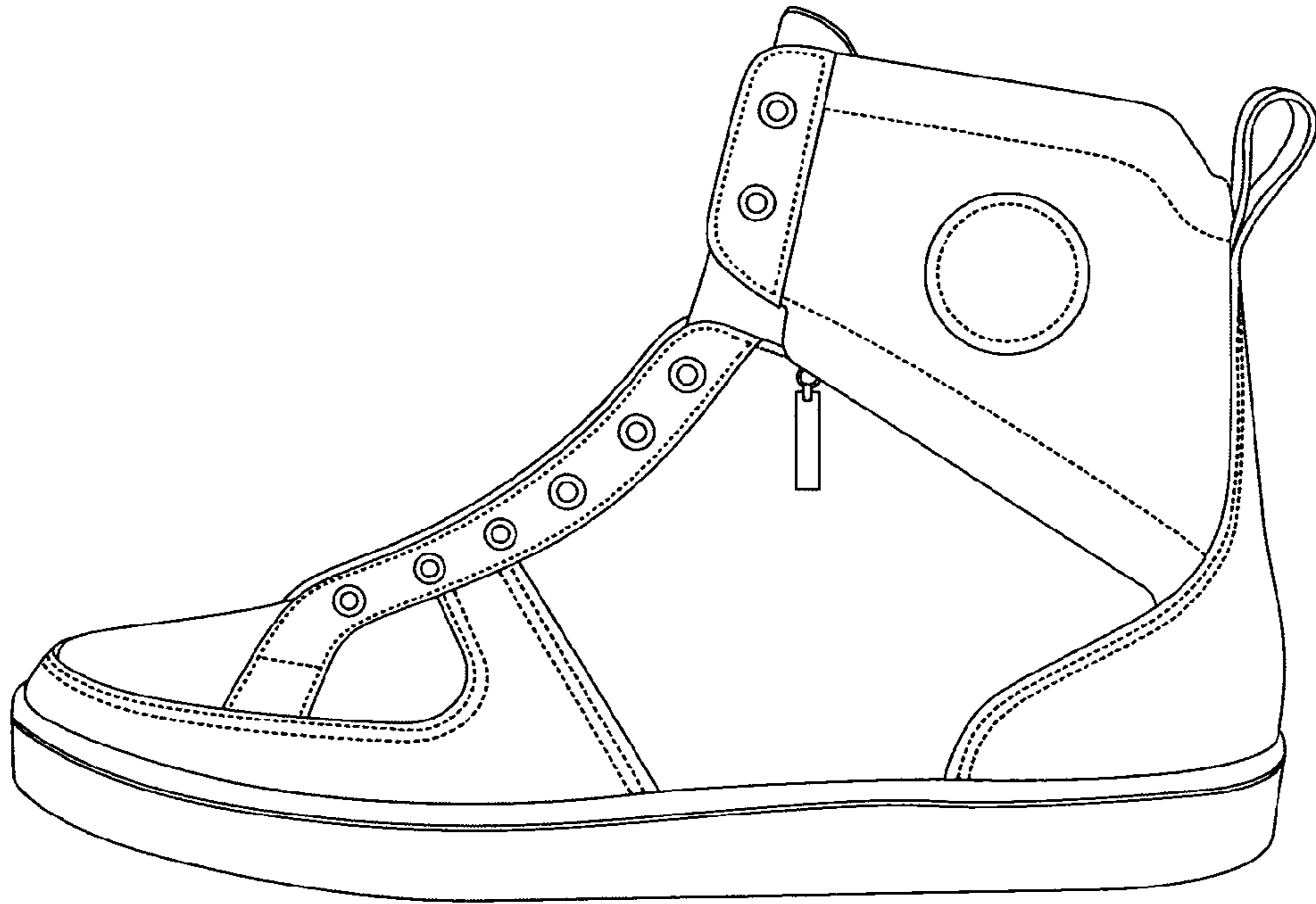

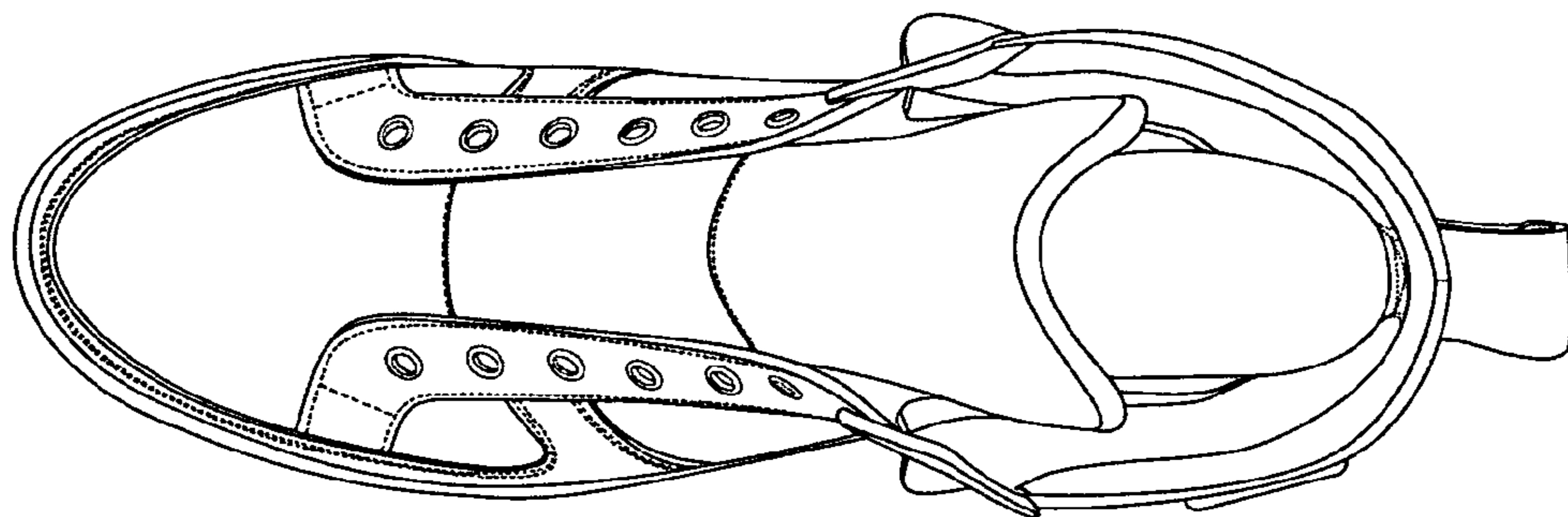

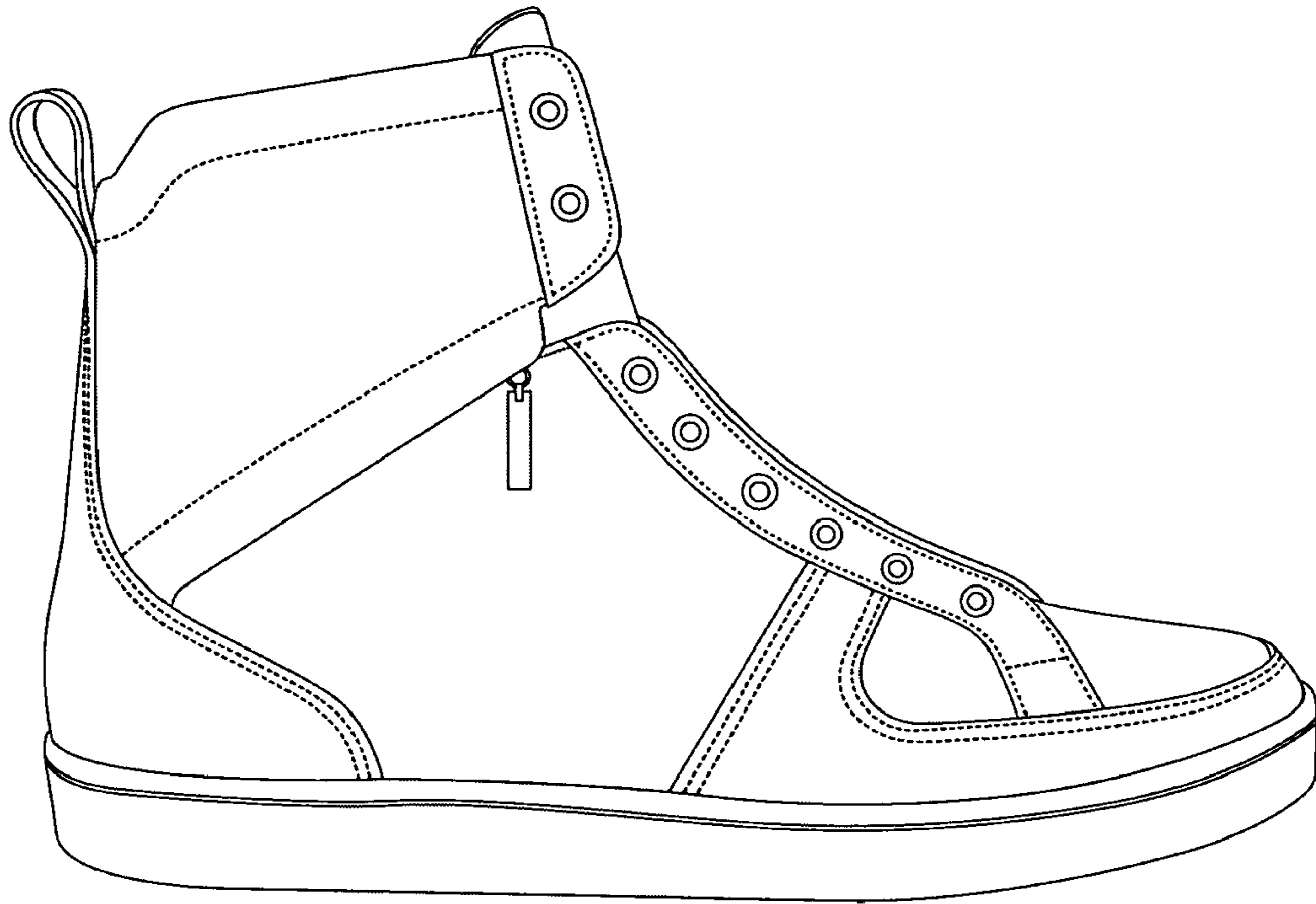

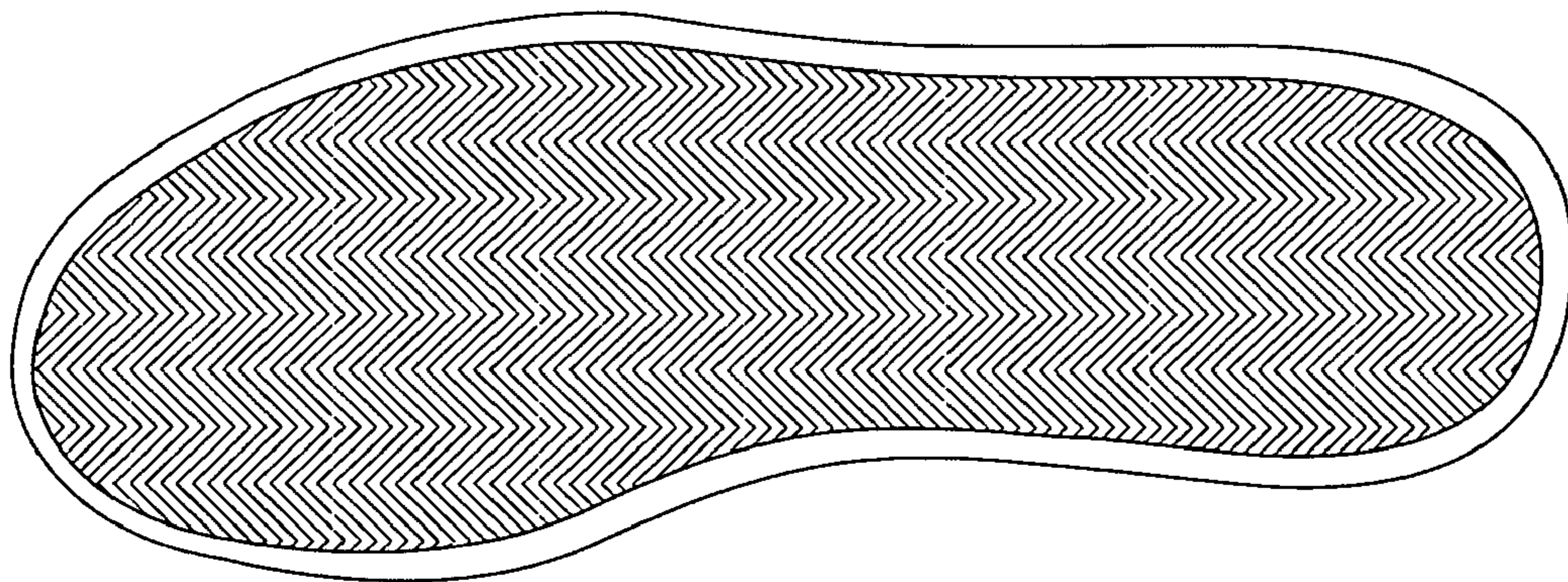

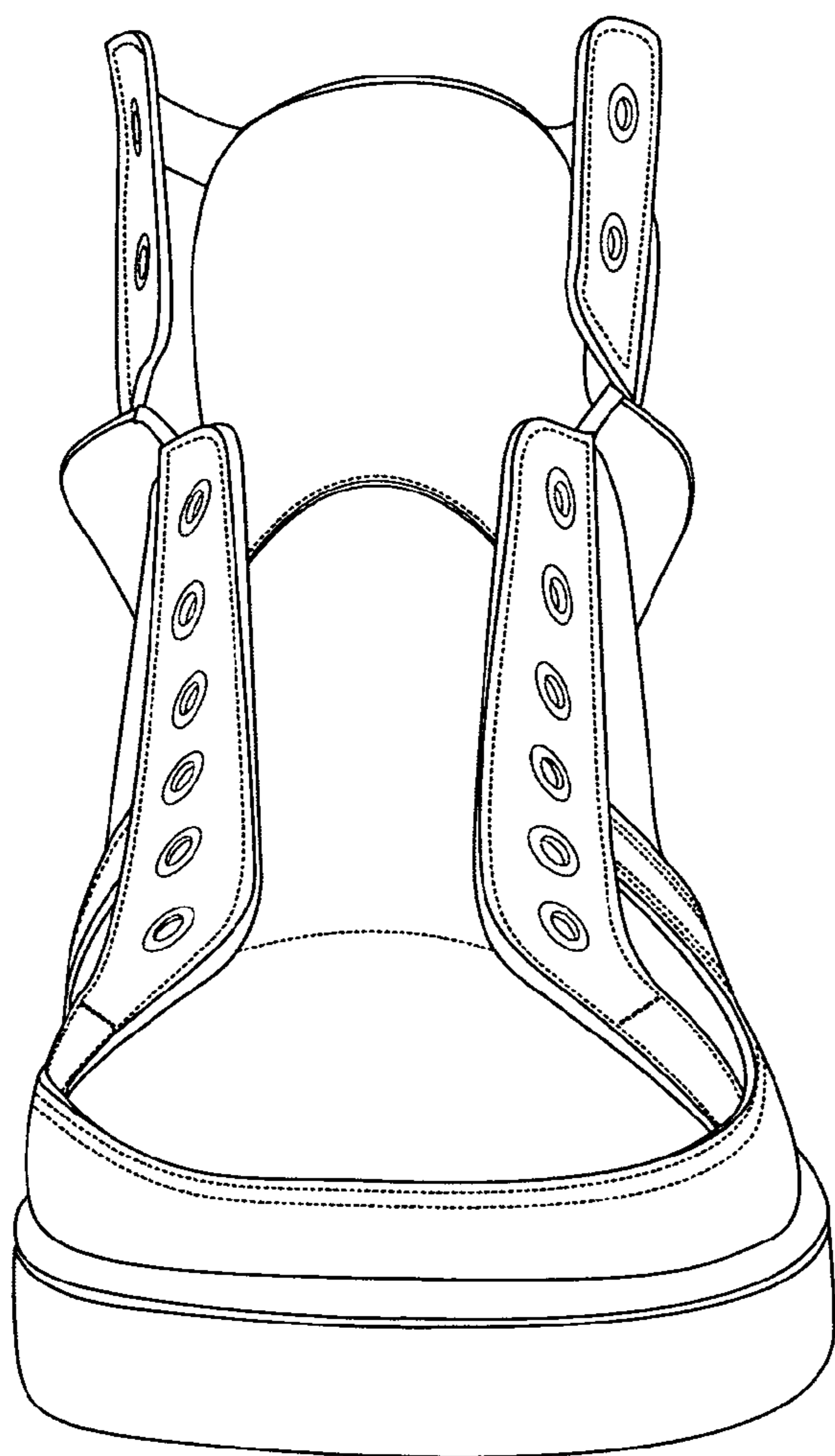

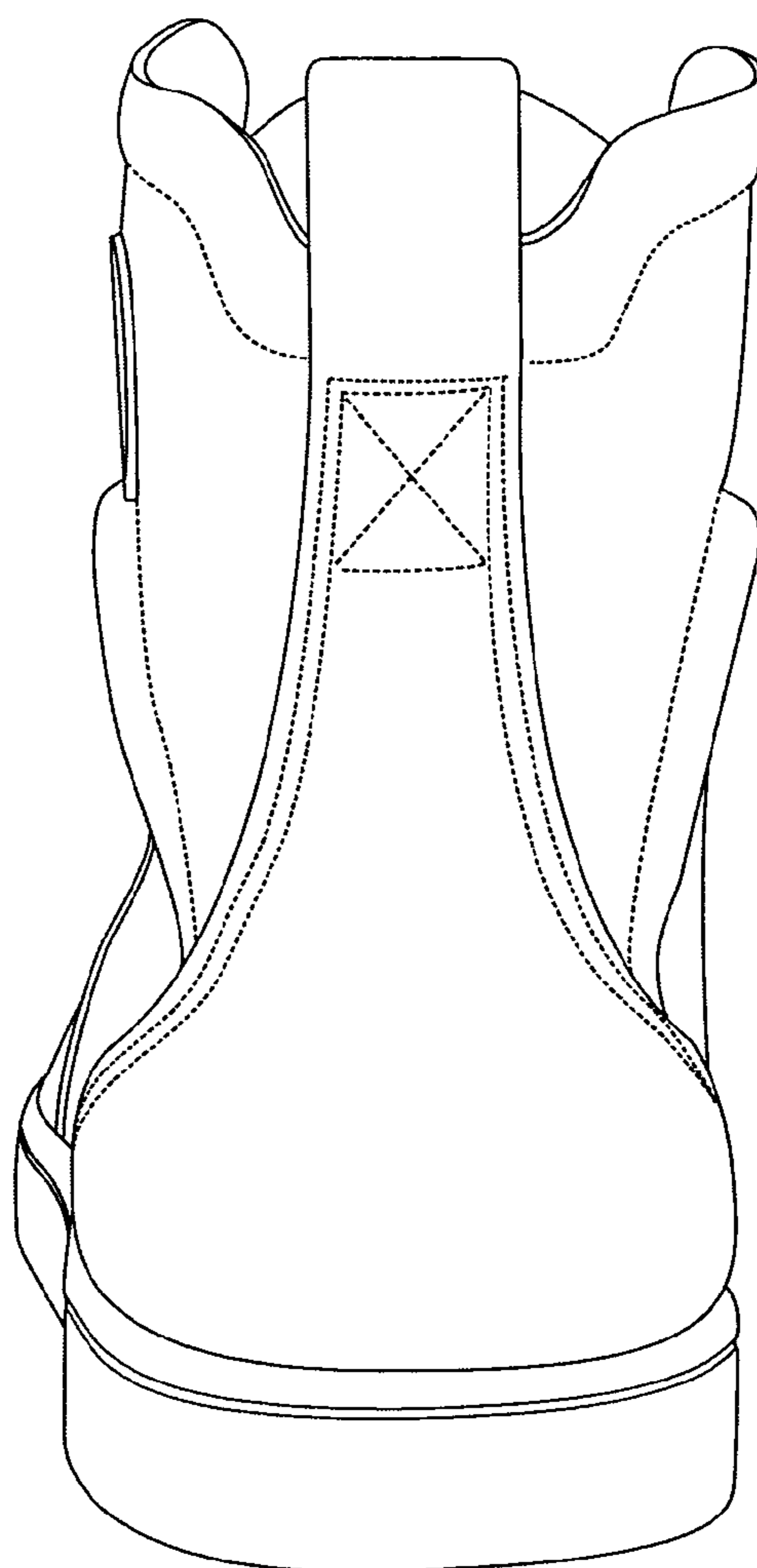

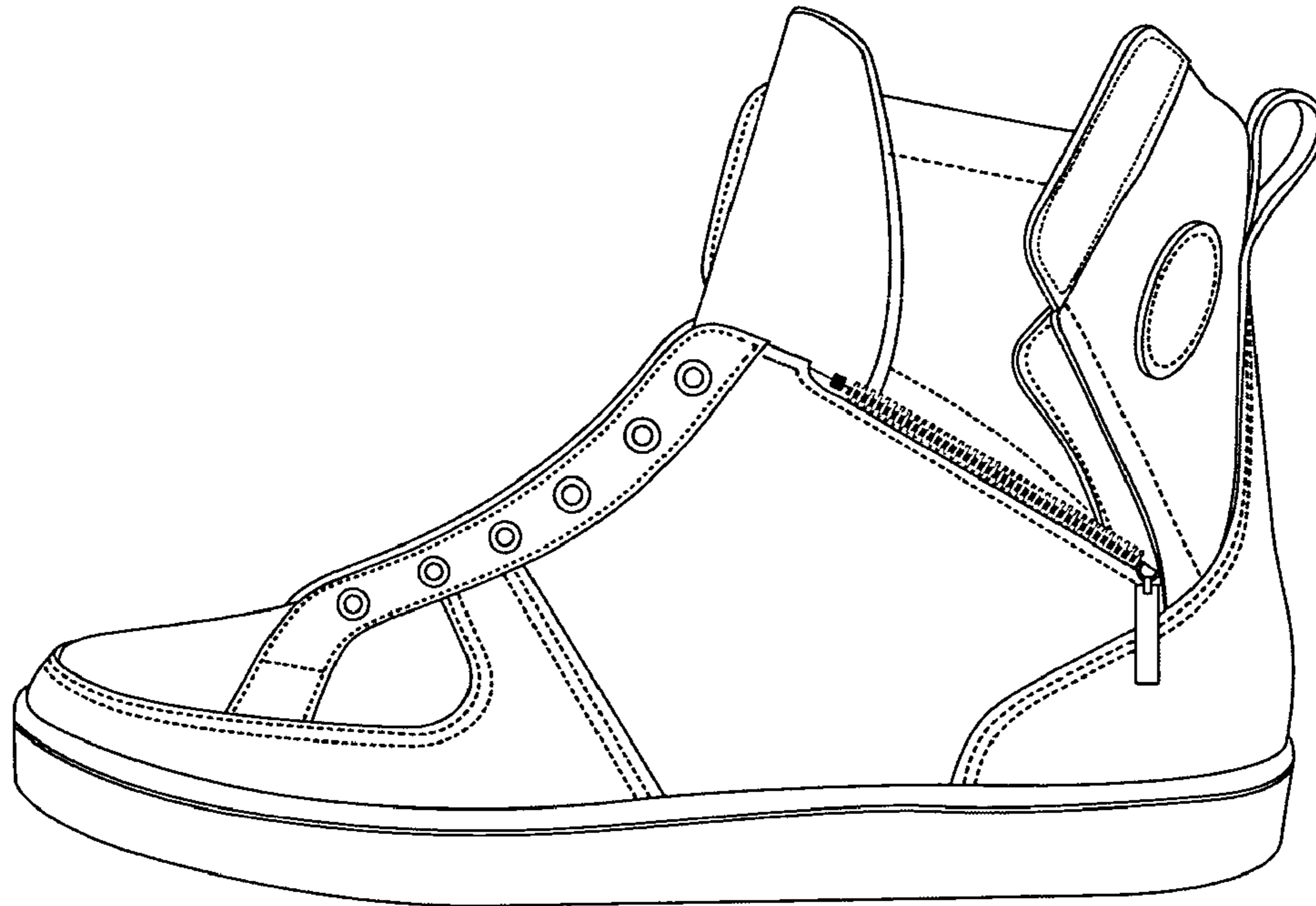

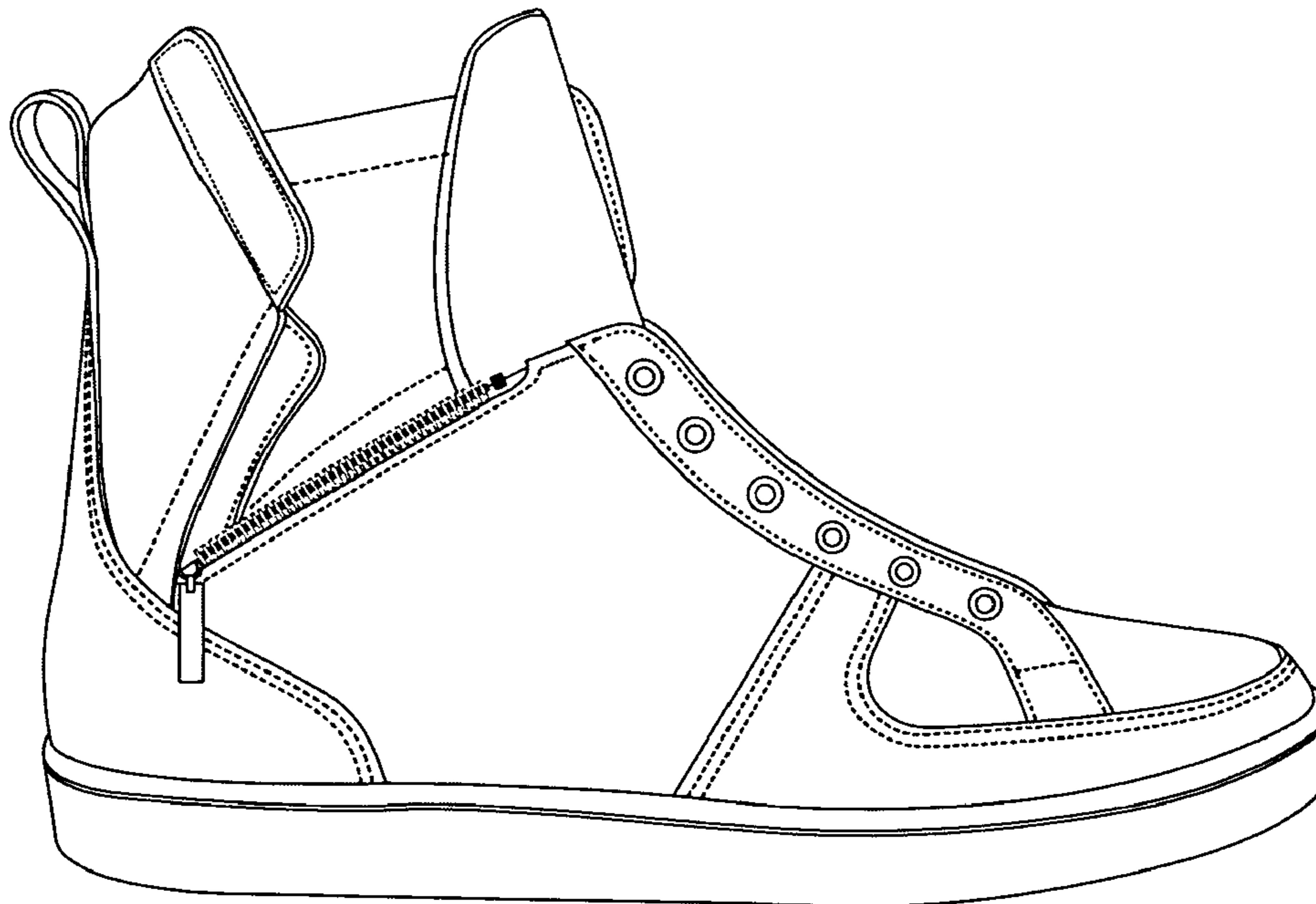

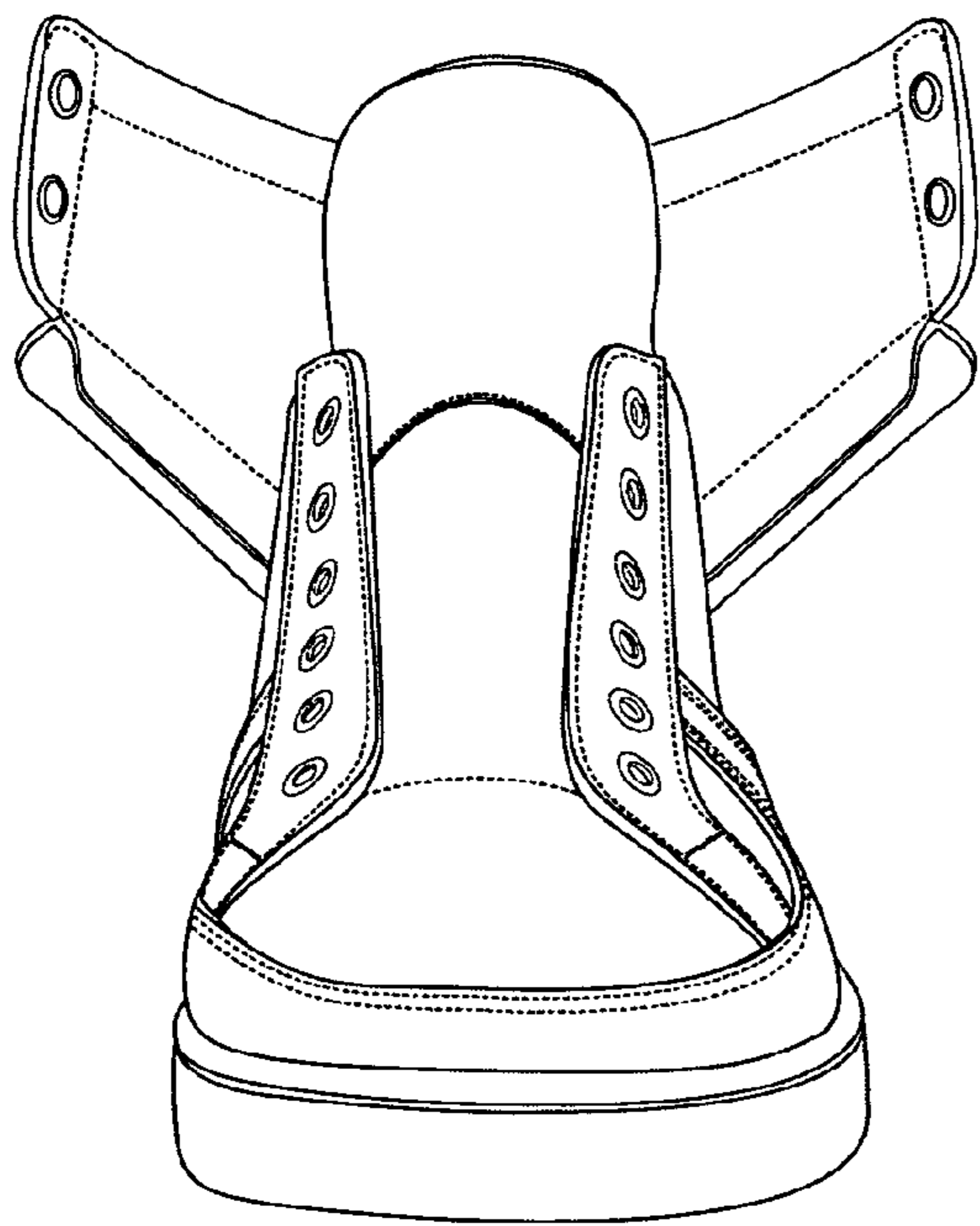

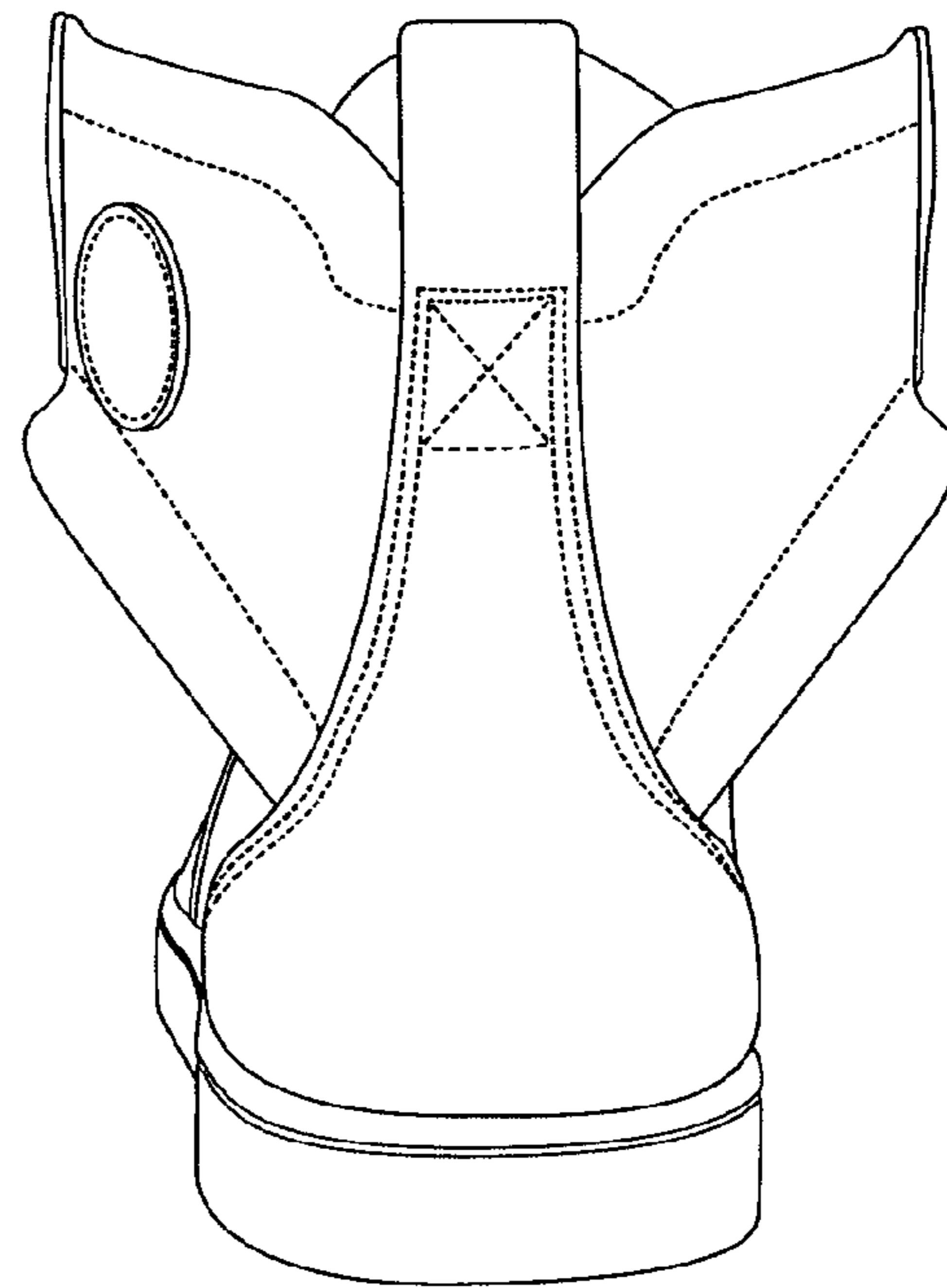

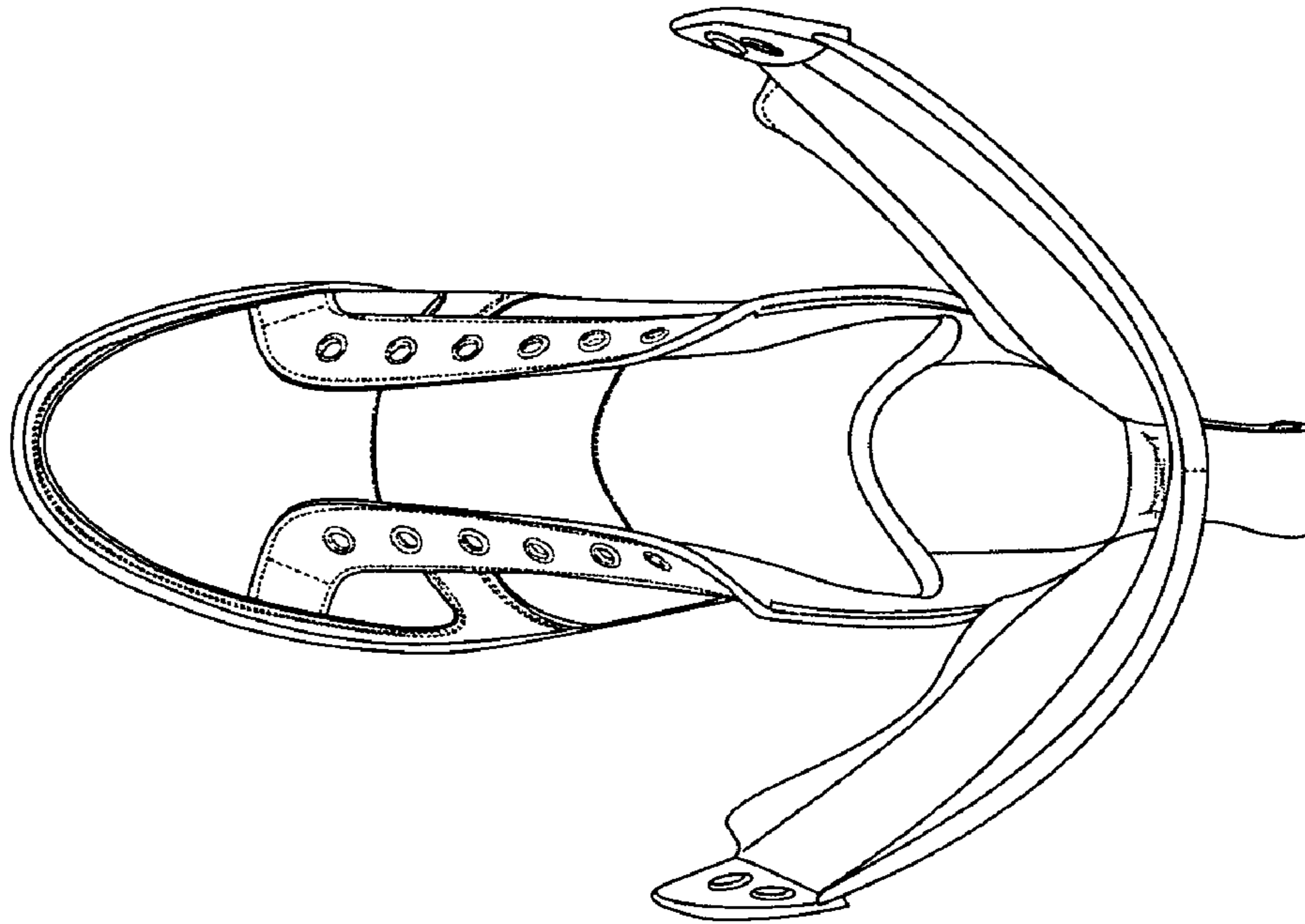

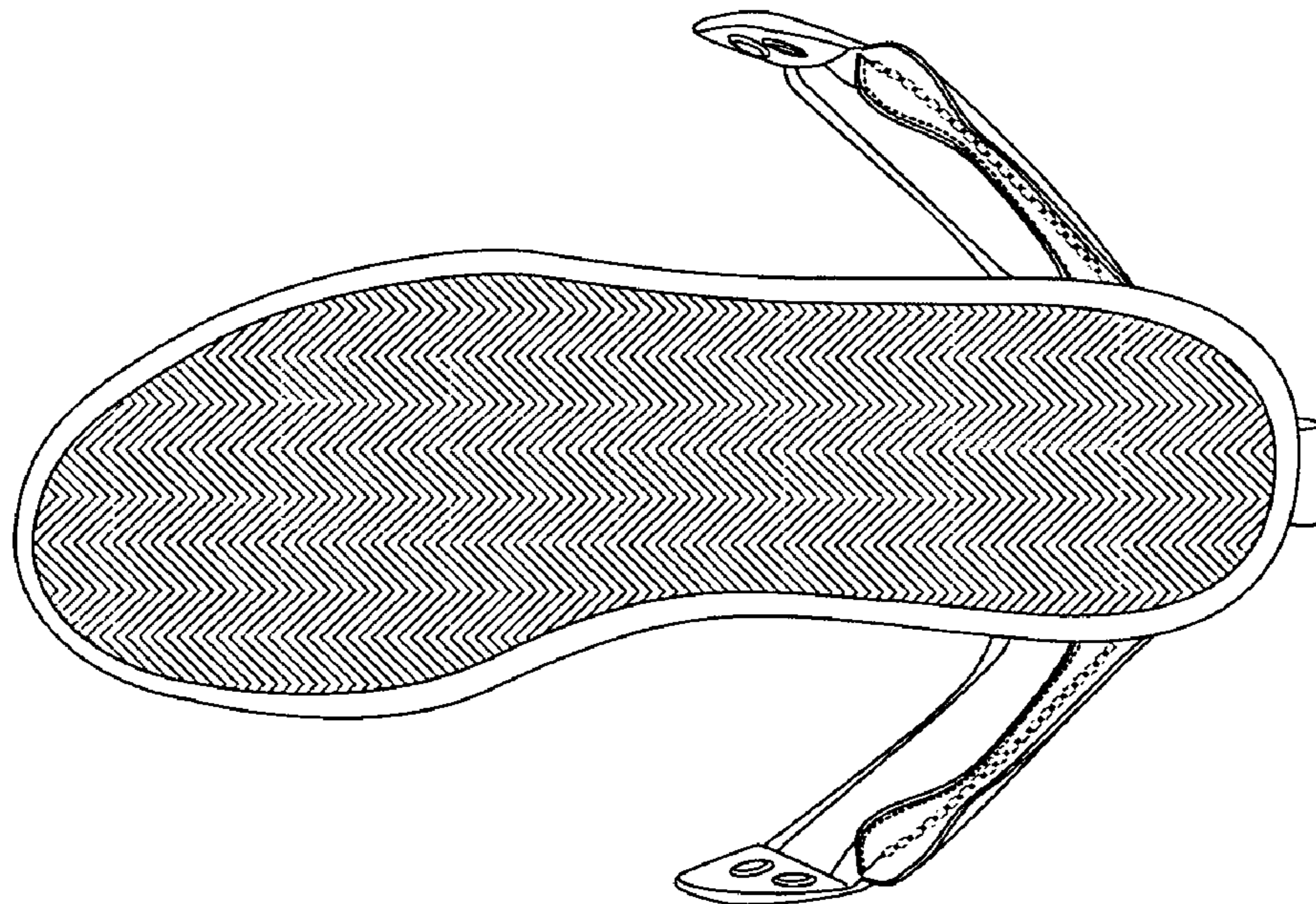
