FIG. 4 is a side view of a sandal shown in FIG. 1;

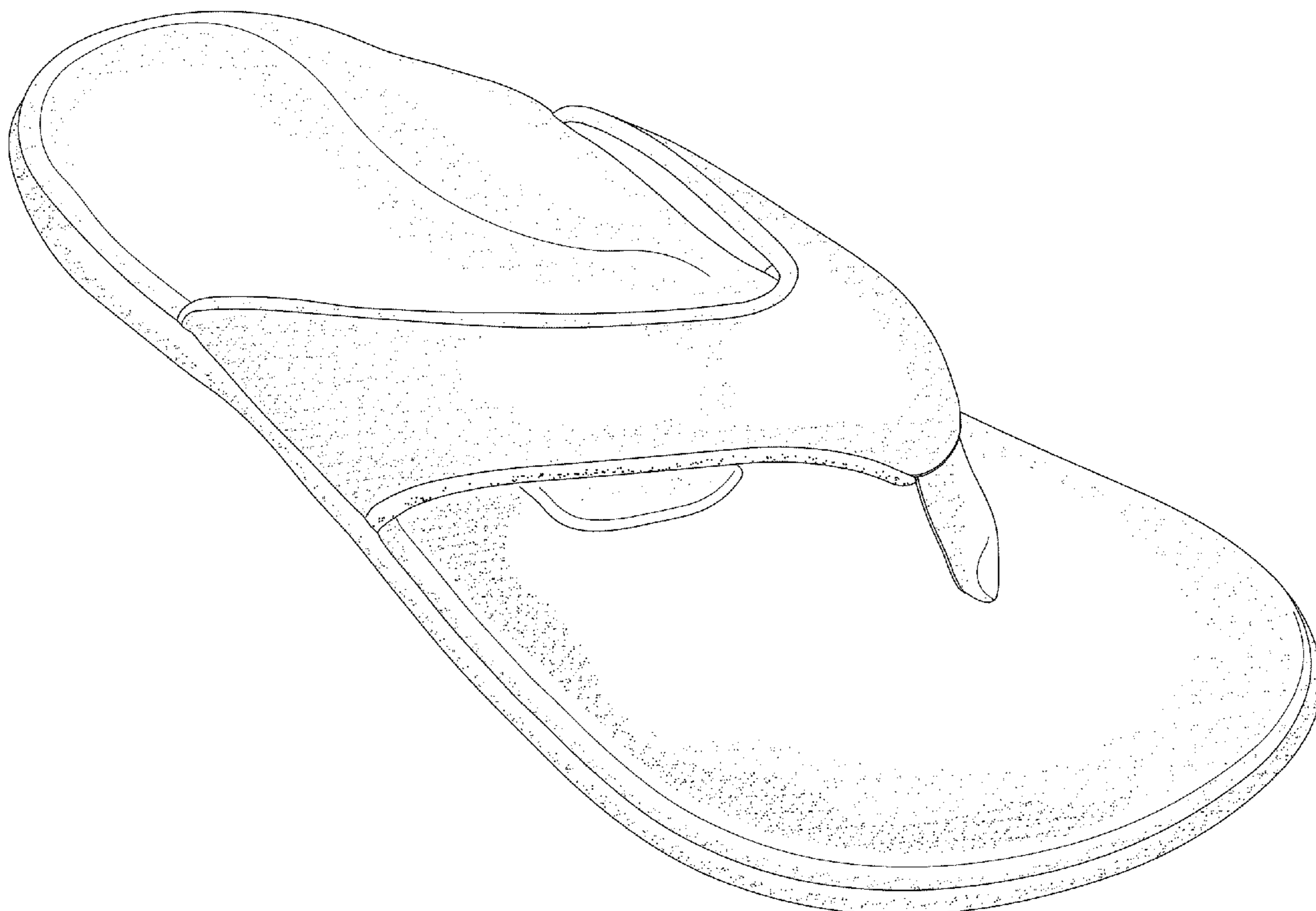
FIG. 5 is a side view of a sandal shown in FIG. 1;

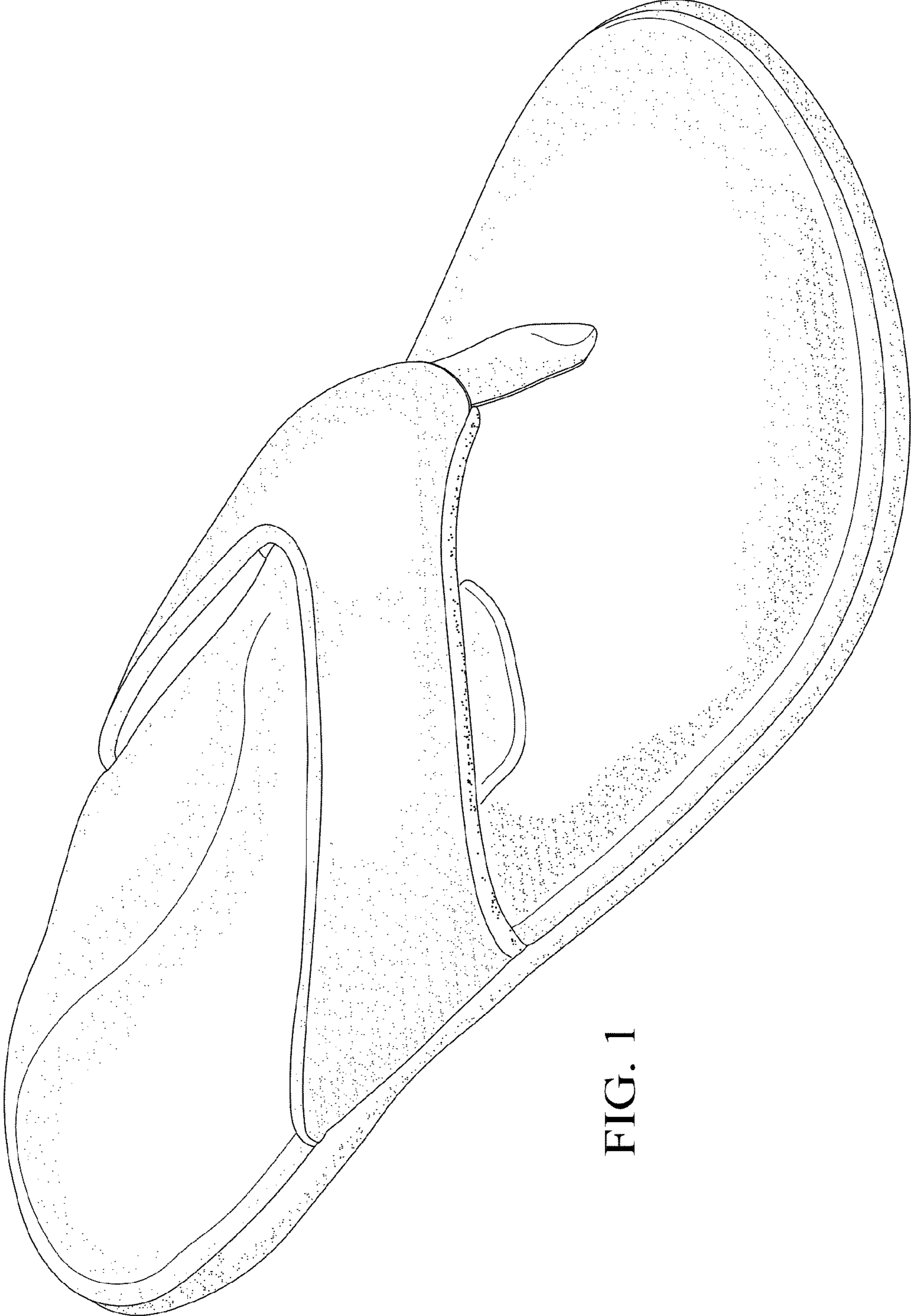

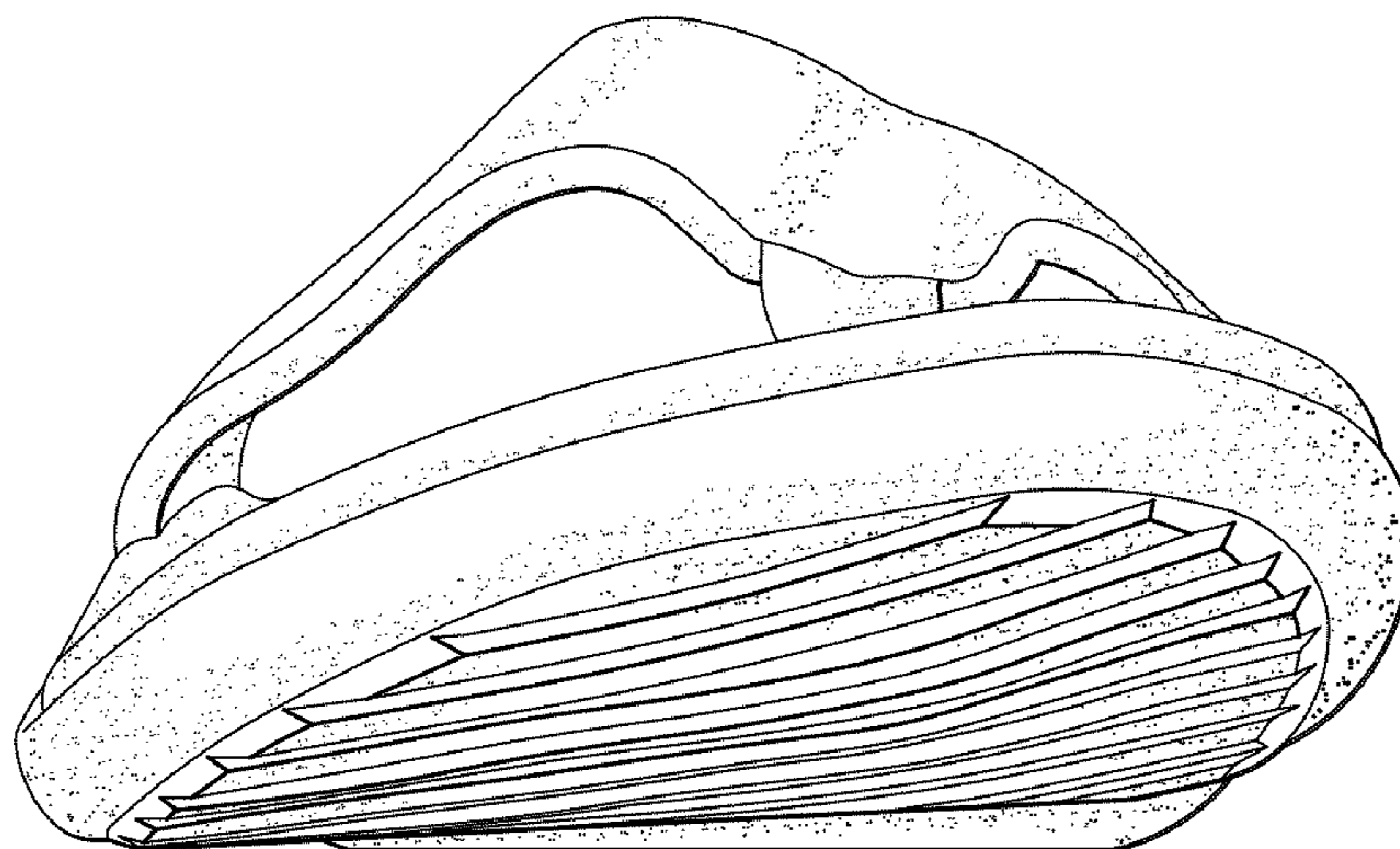

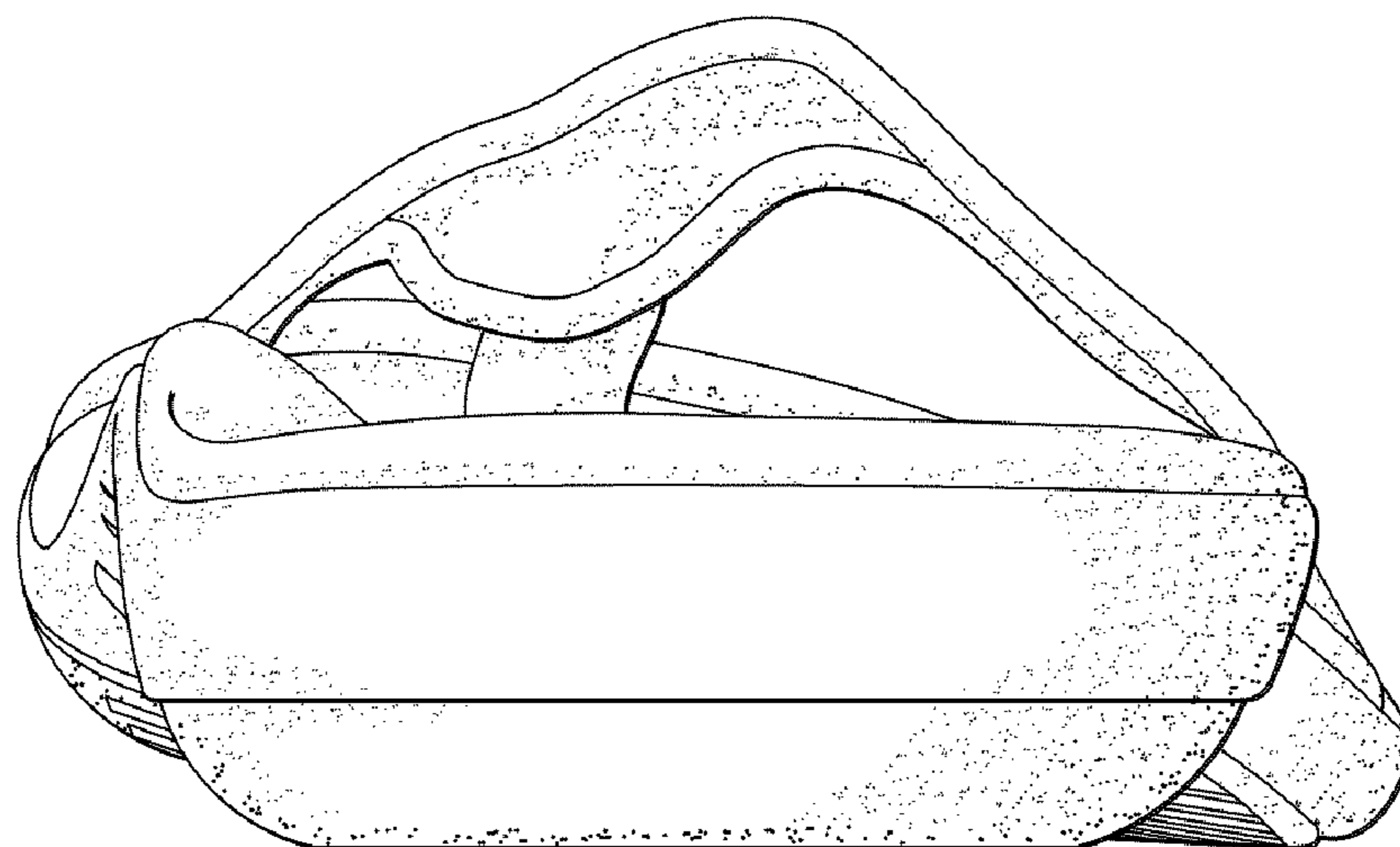

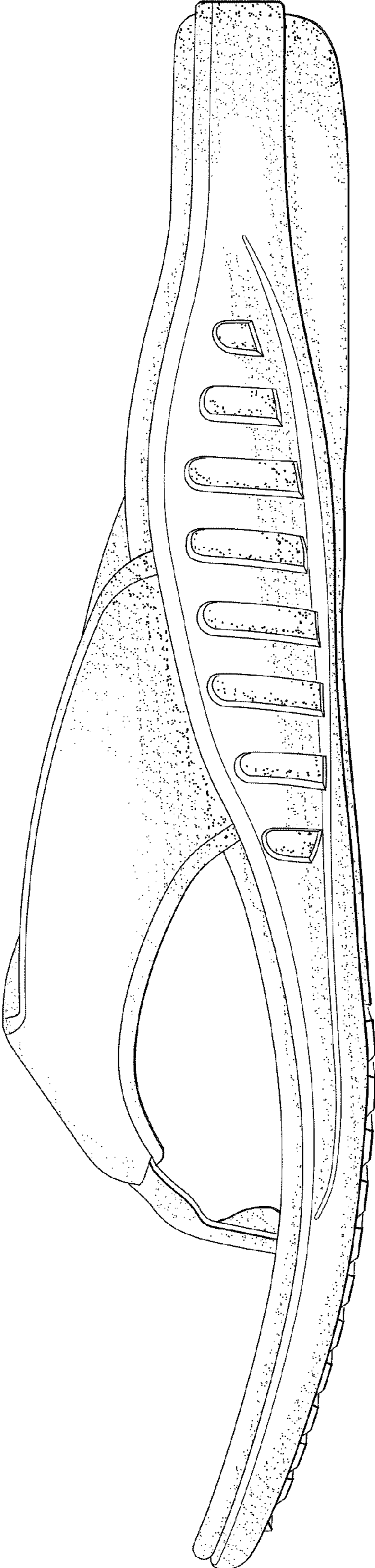

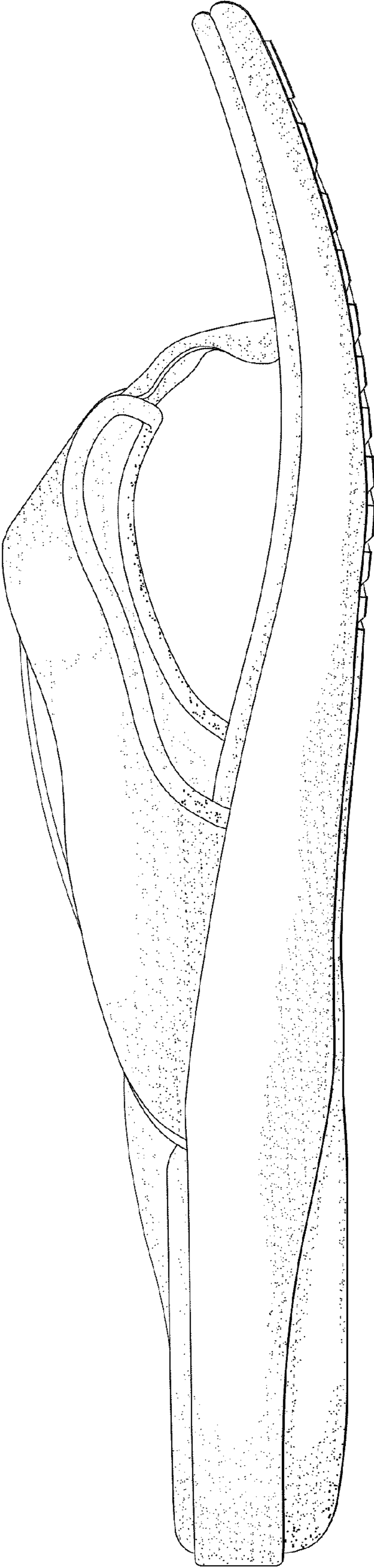

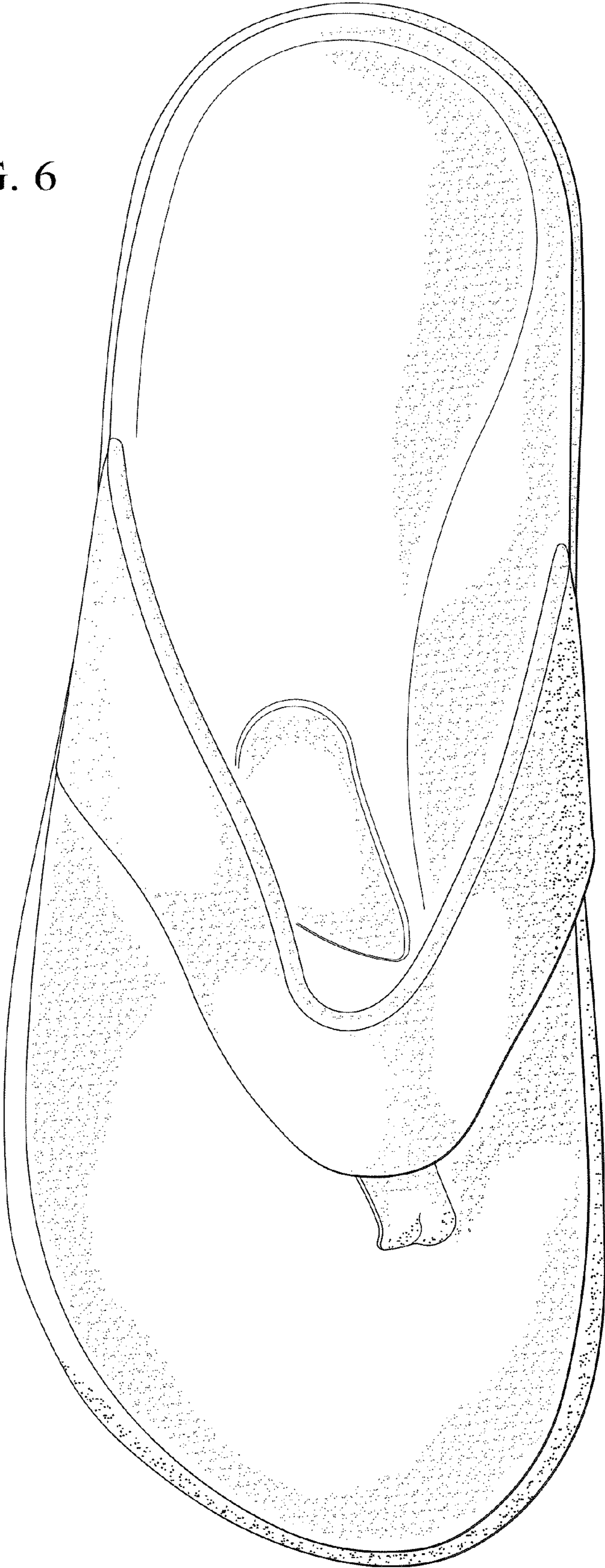
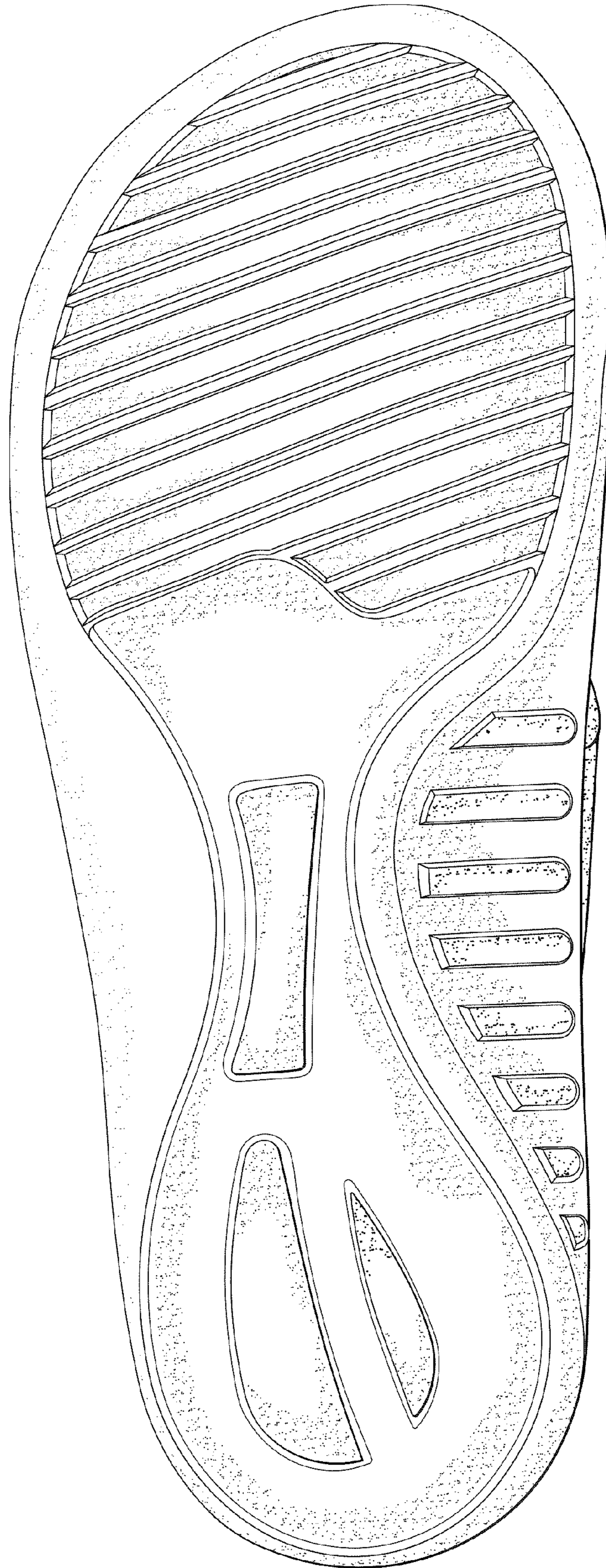

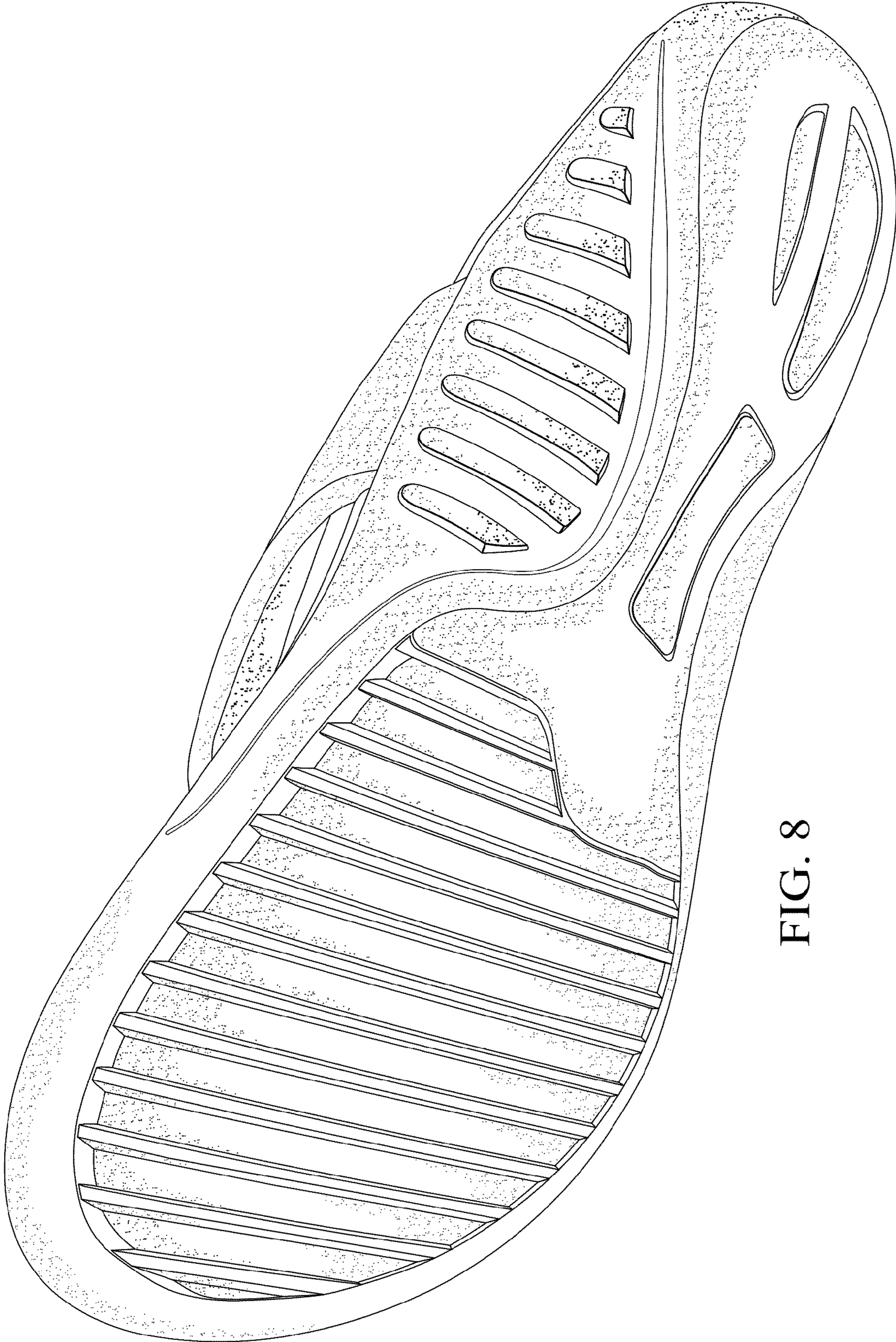
