The ornamental design for a picture frame, as shown and described.

DESCRIPTION

FIG. 1 is front view of a faith frame picture frame embodying my new design;

FIG. 10 is a right side view of the picture frame of FIG. 8,

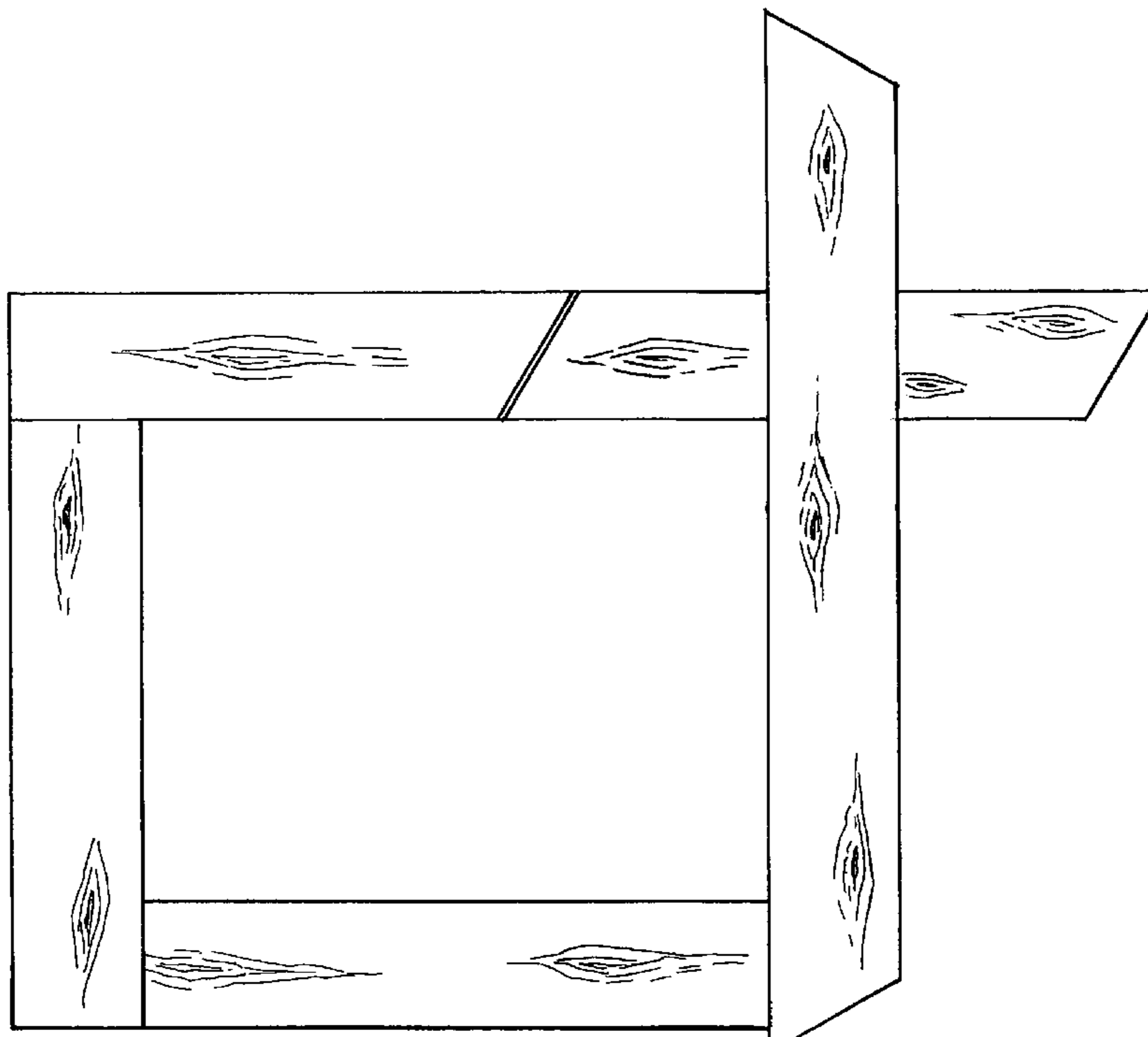
FIG. 11 is a left side view of the picture frame of FIG. 8,

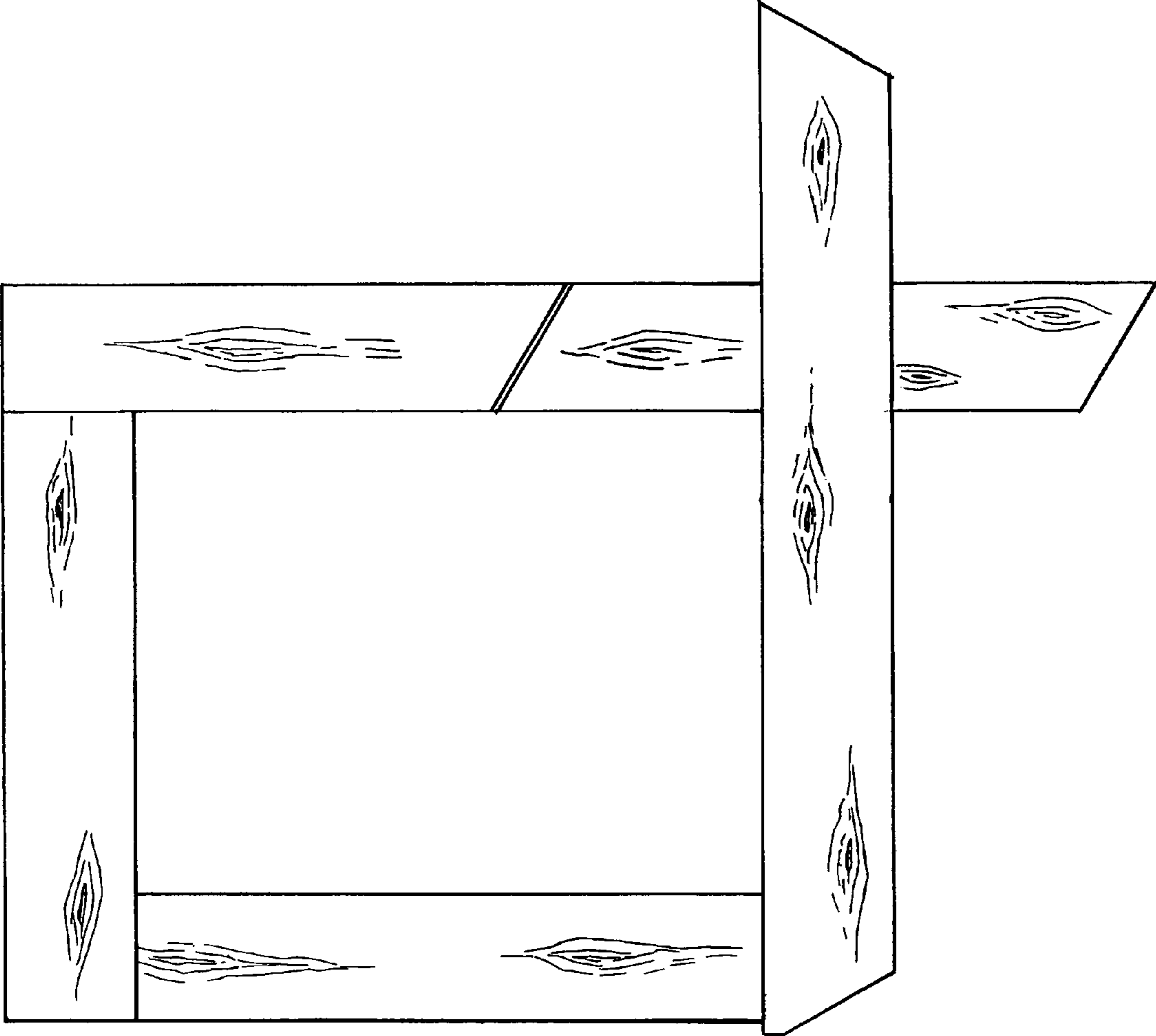

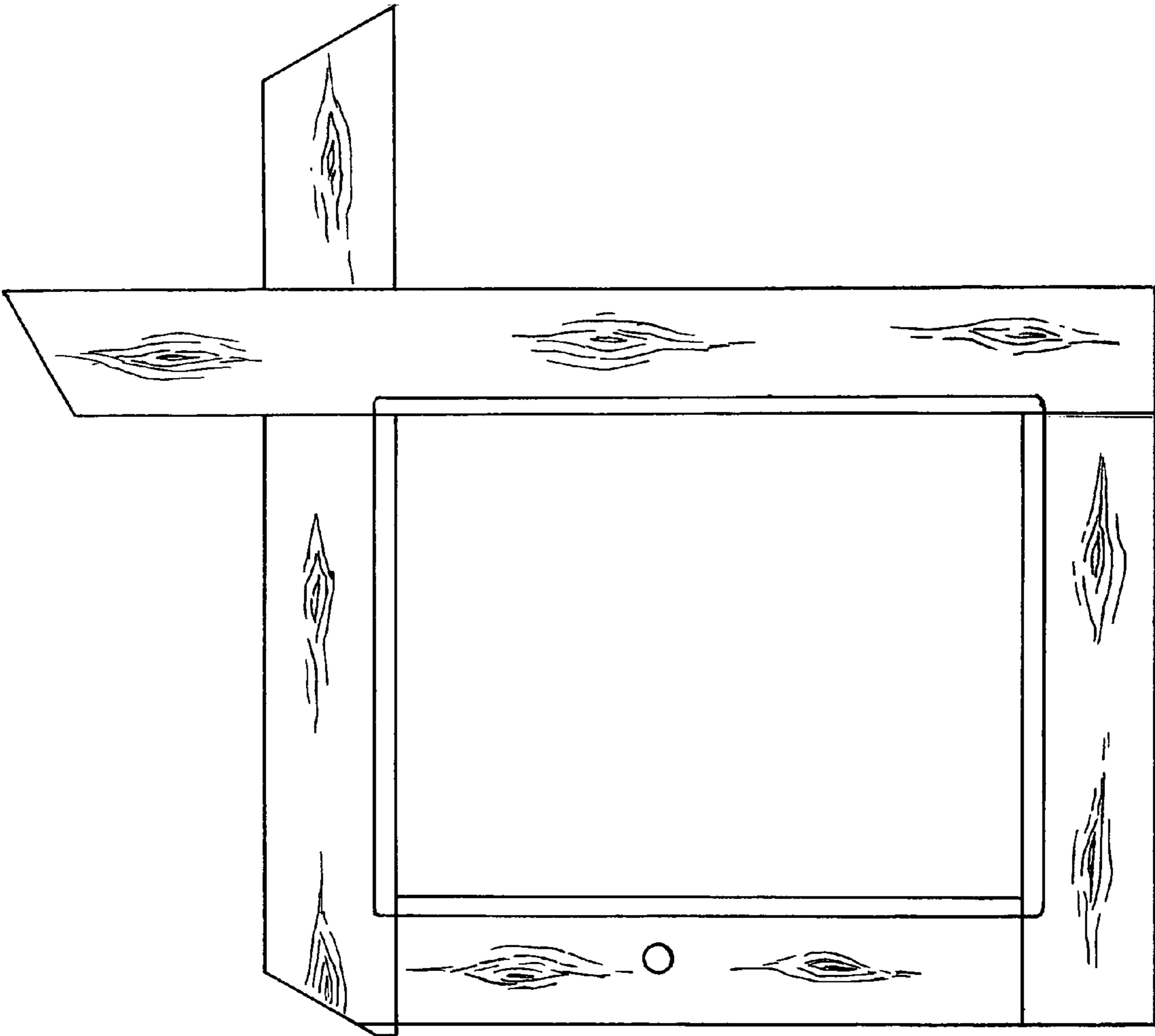

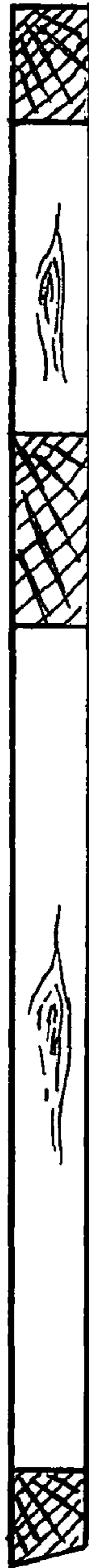

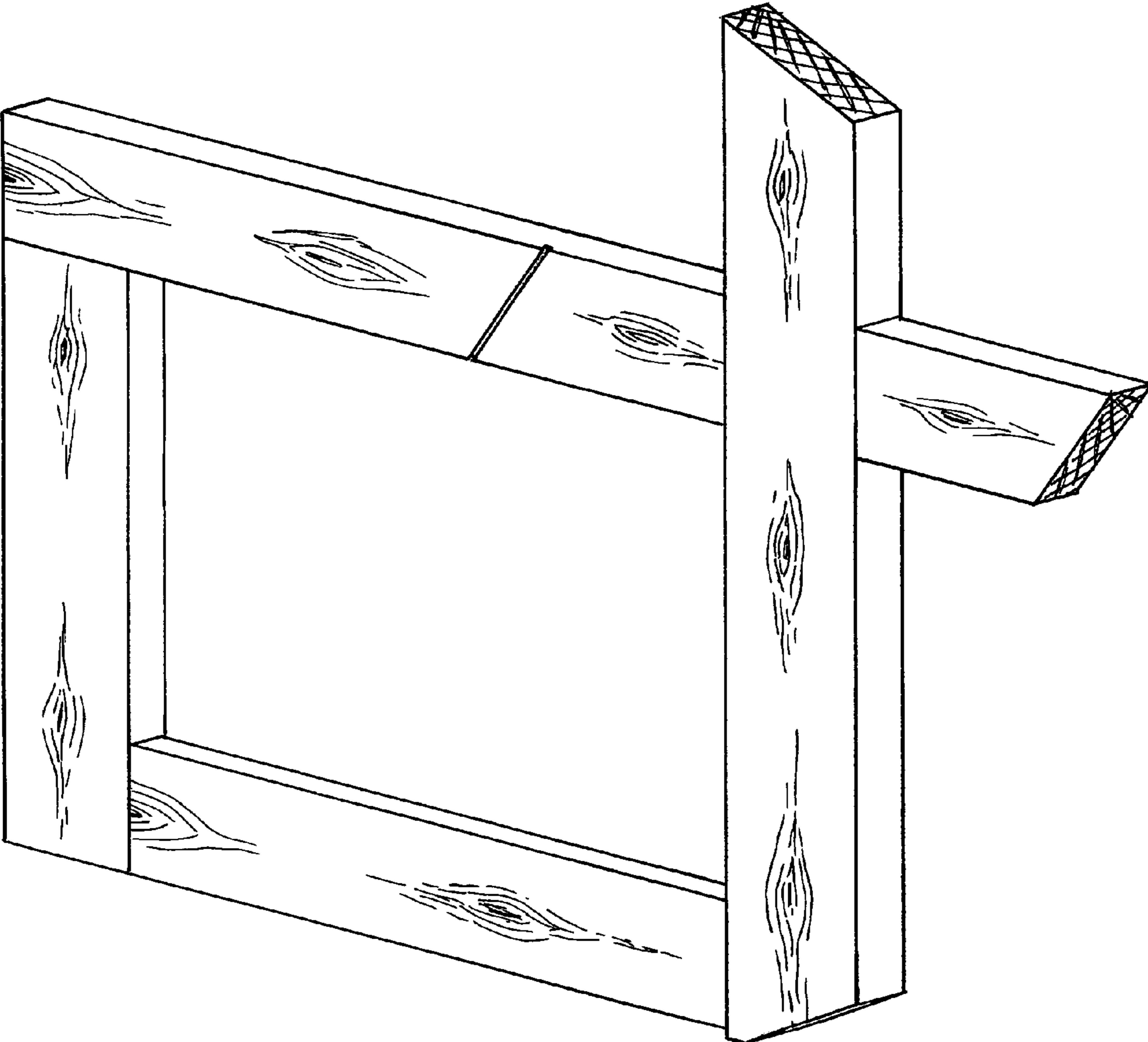

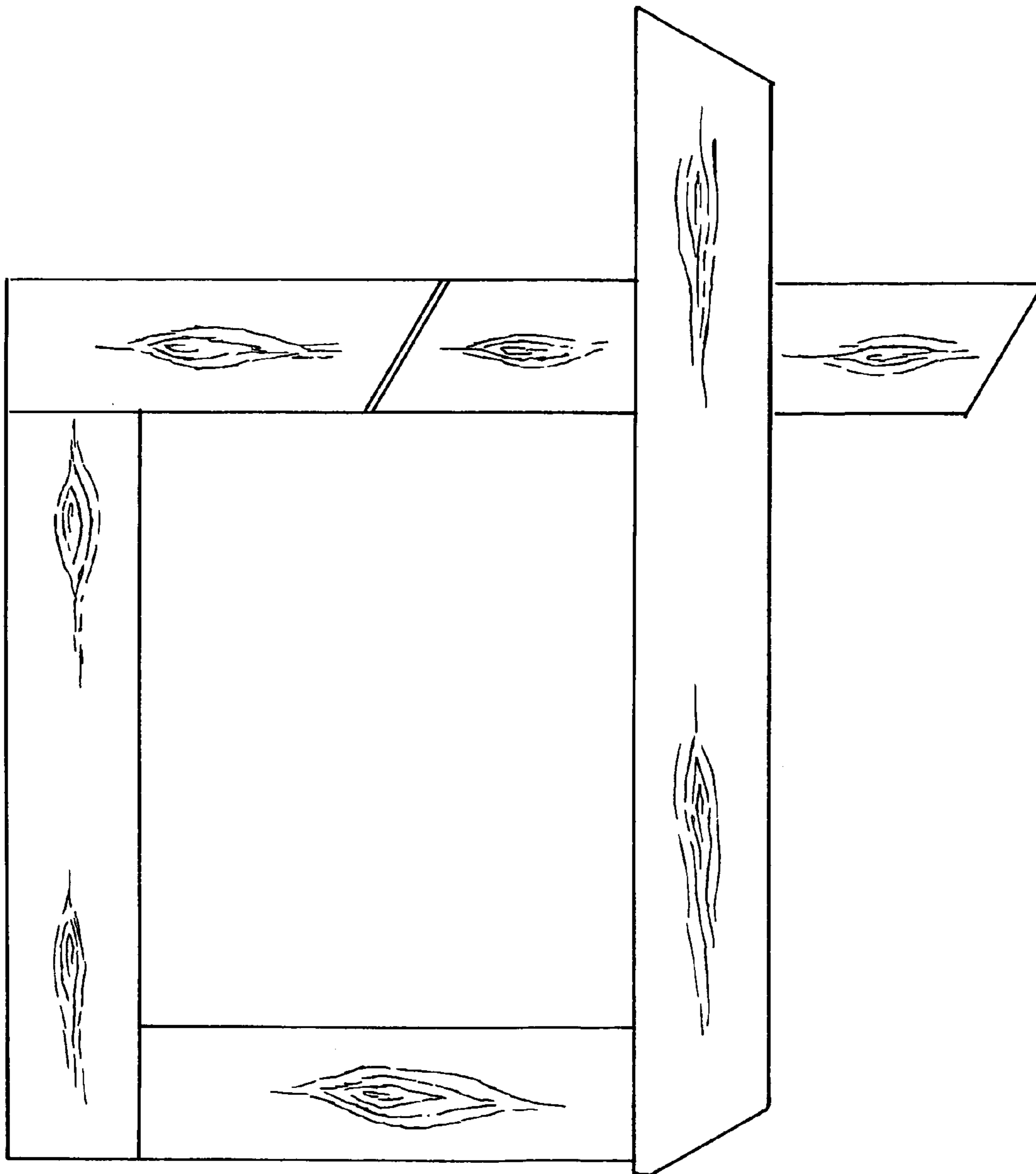

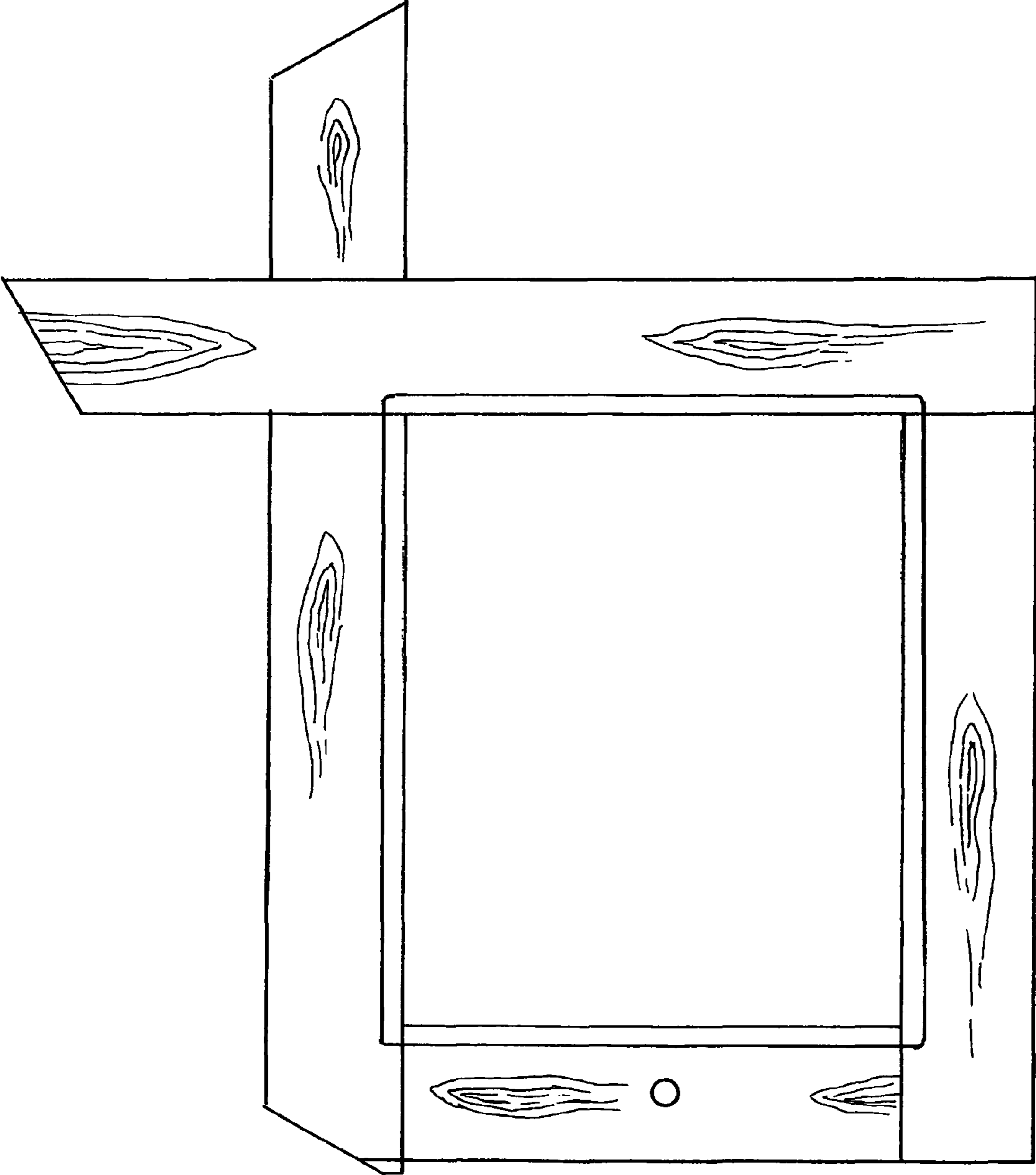

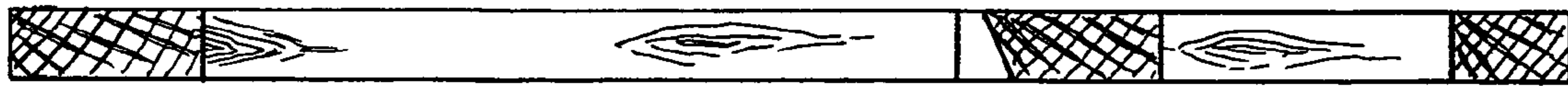

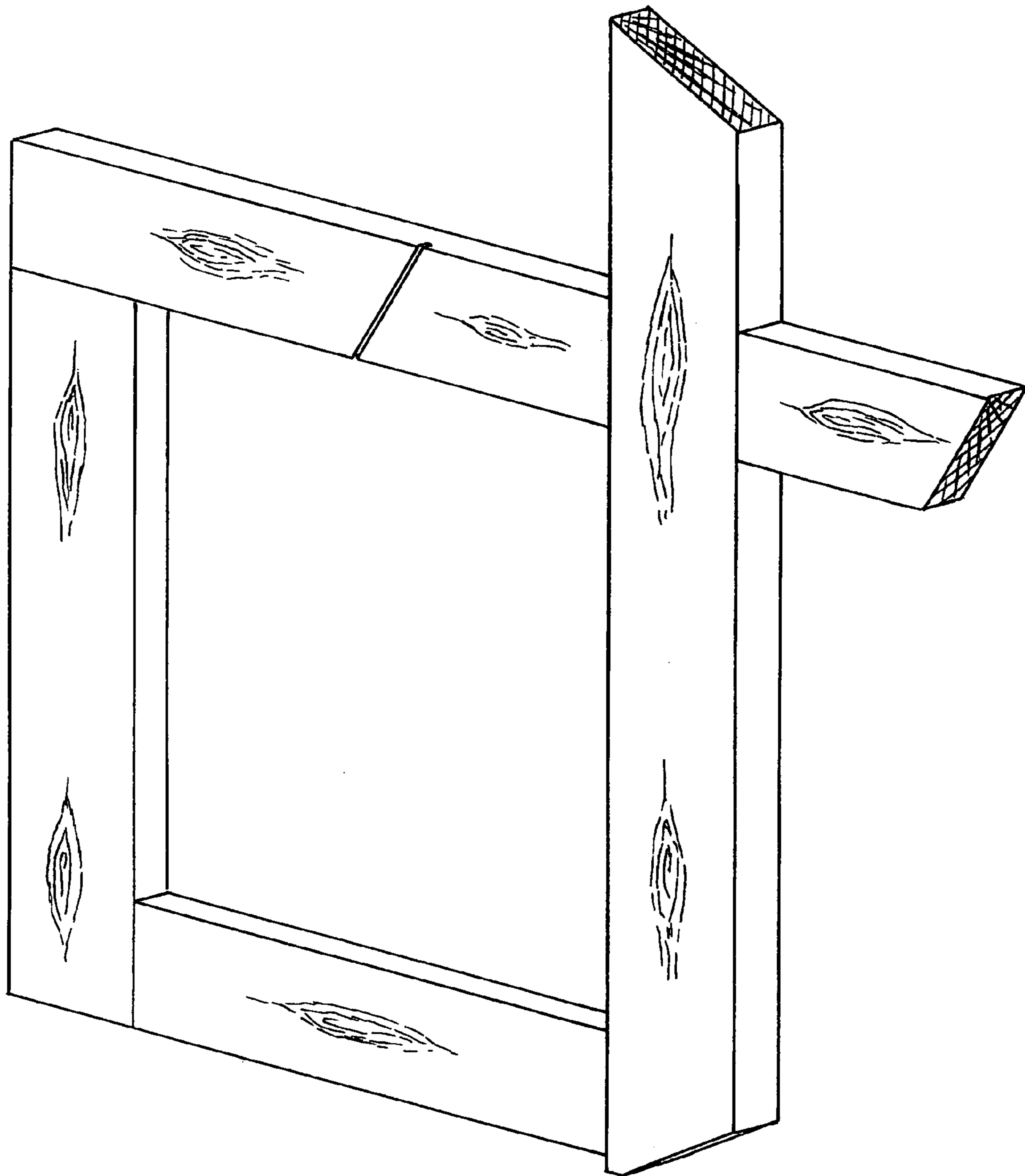
