FIG. 1 is a top plan view of a feet mat;

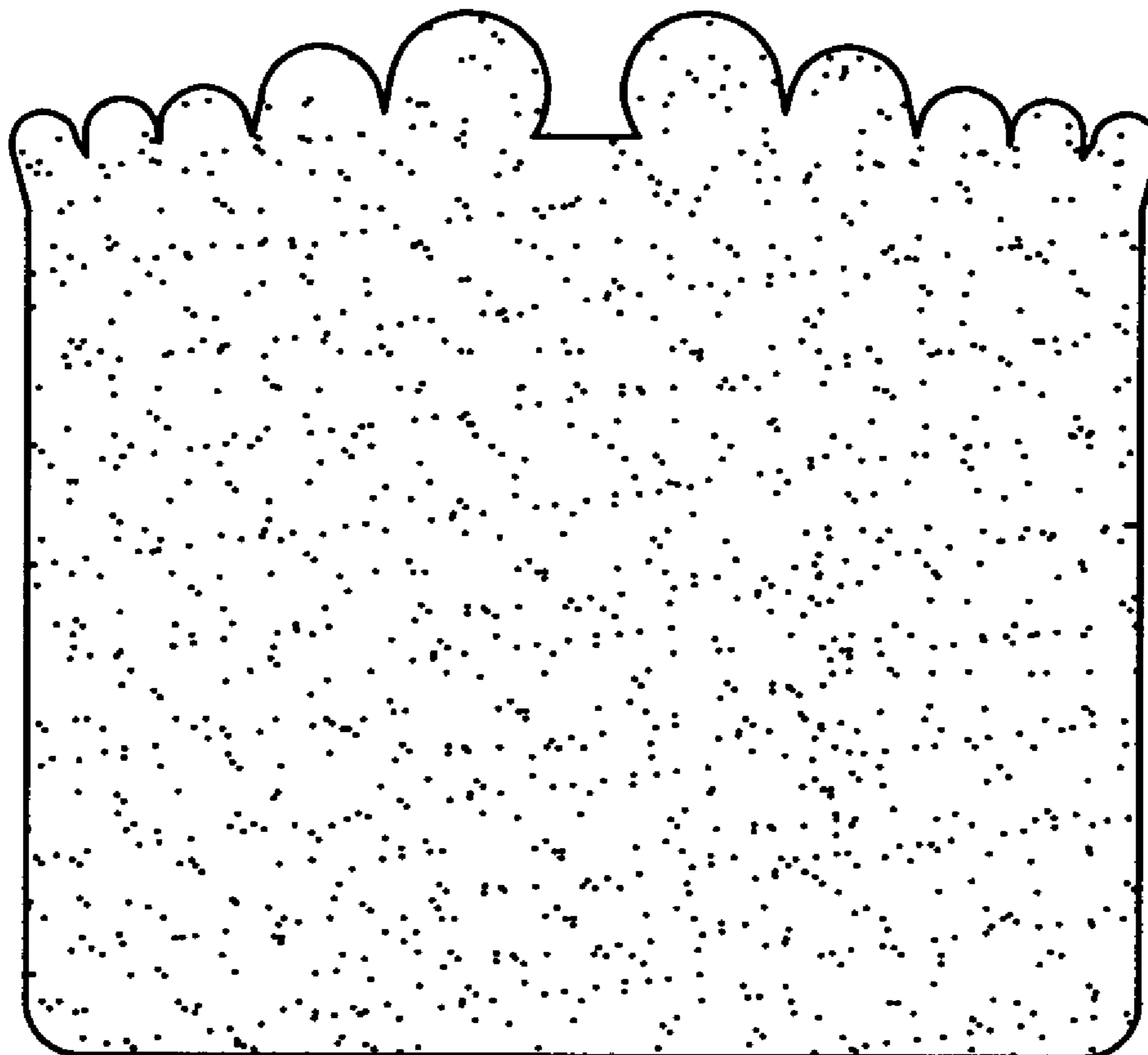
FIG. 2 is a bottom plan view thereof;

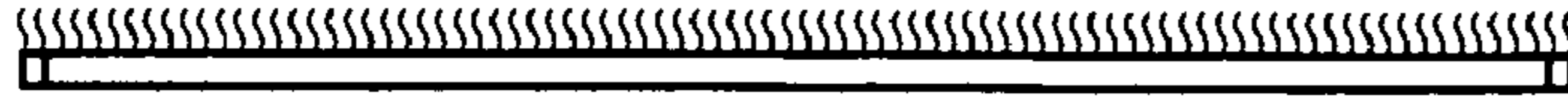

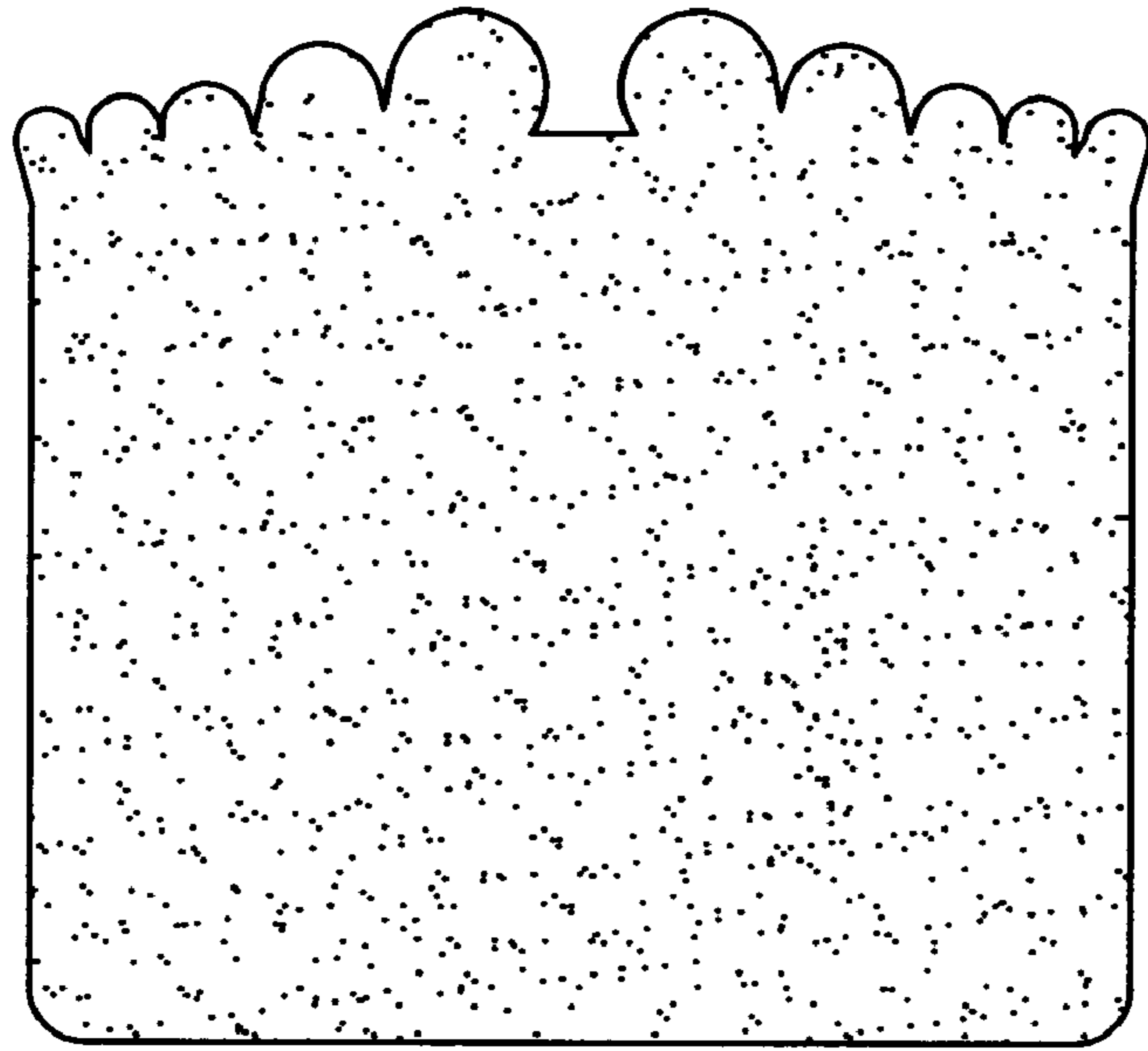

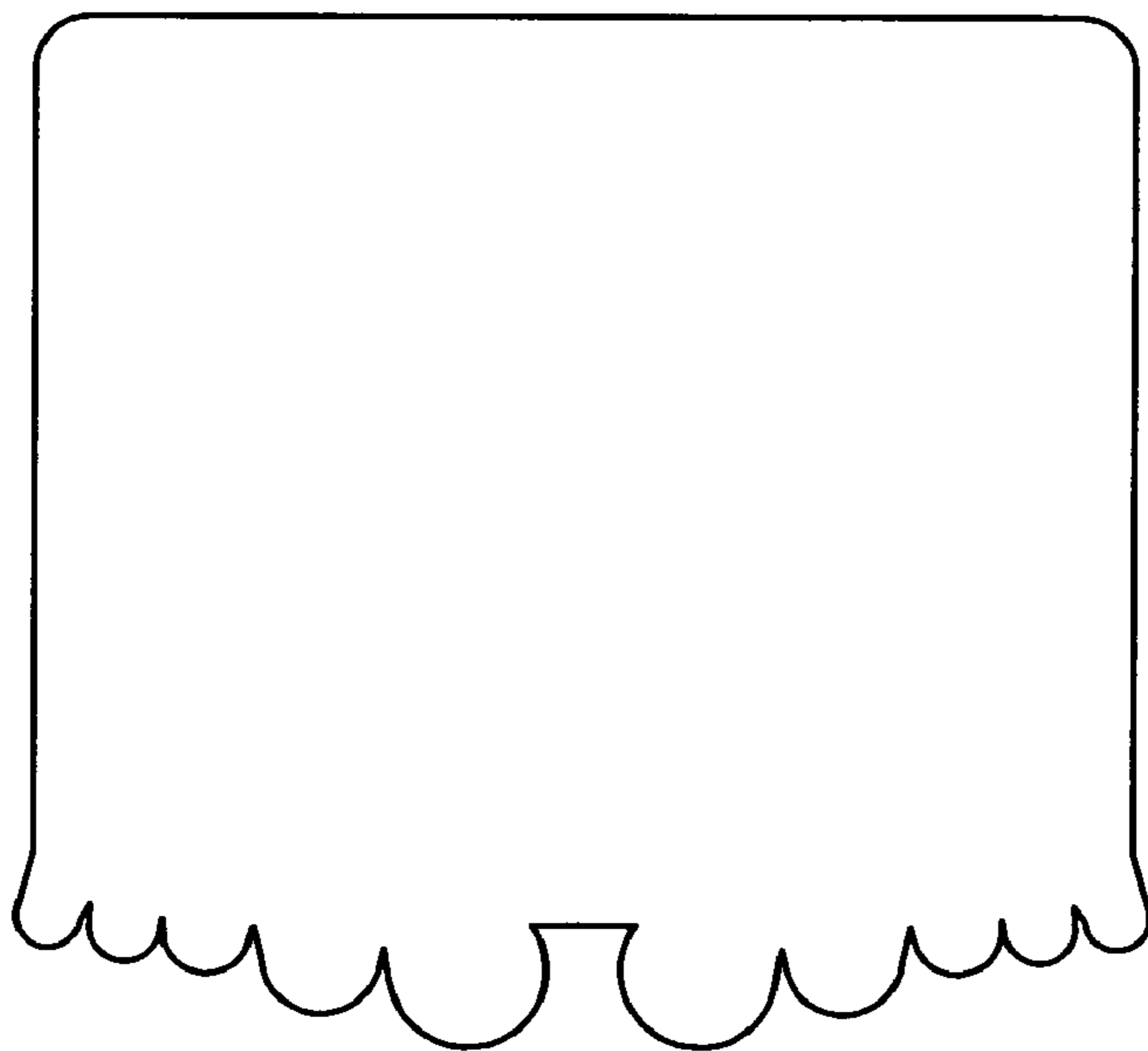
