FIG. 3 is a top end view thereof;

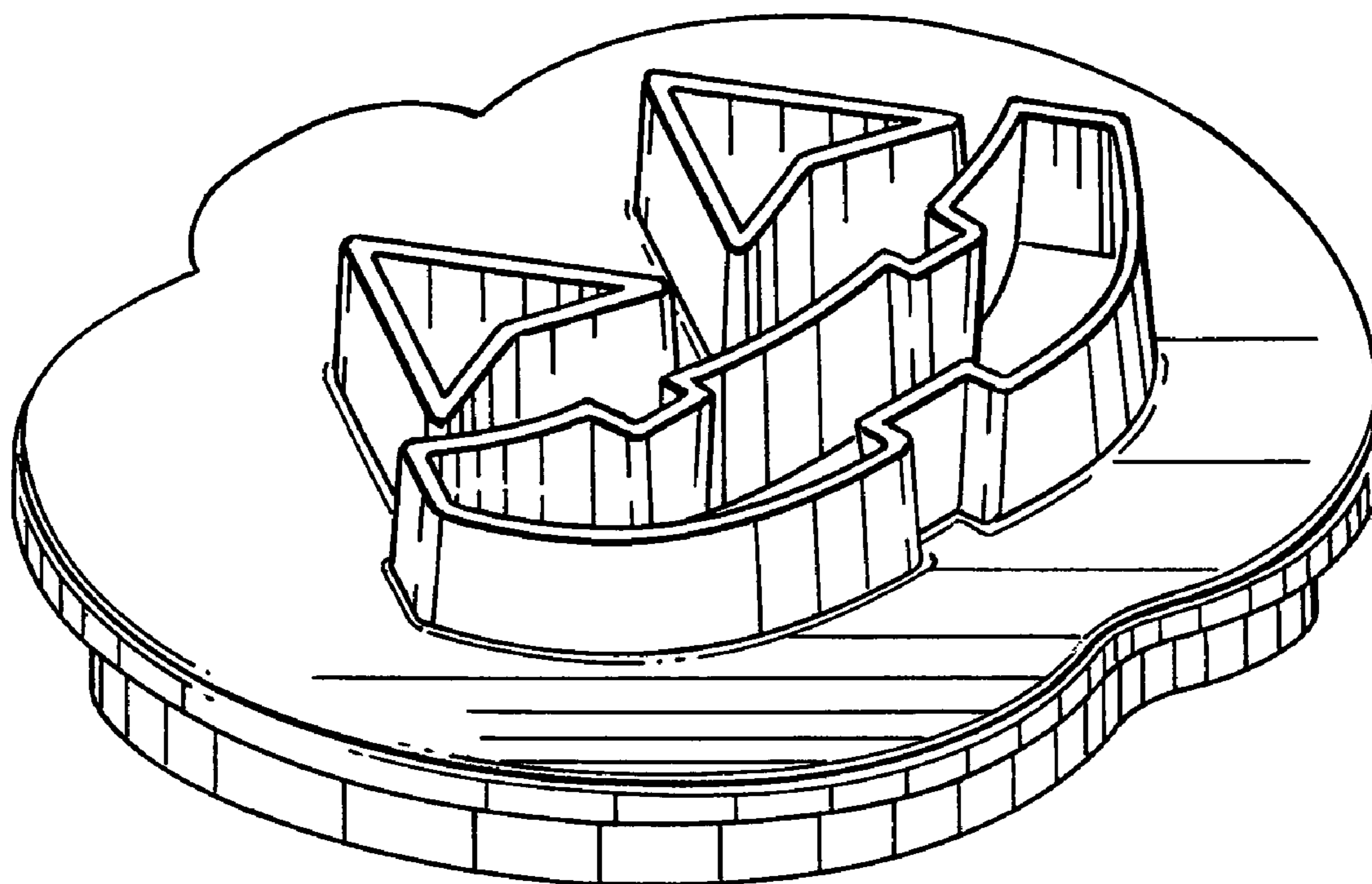
FIG. 4 is a bottom end view thereof;

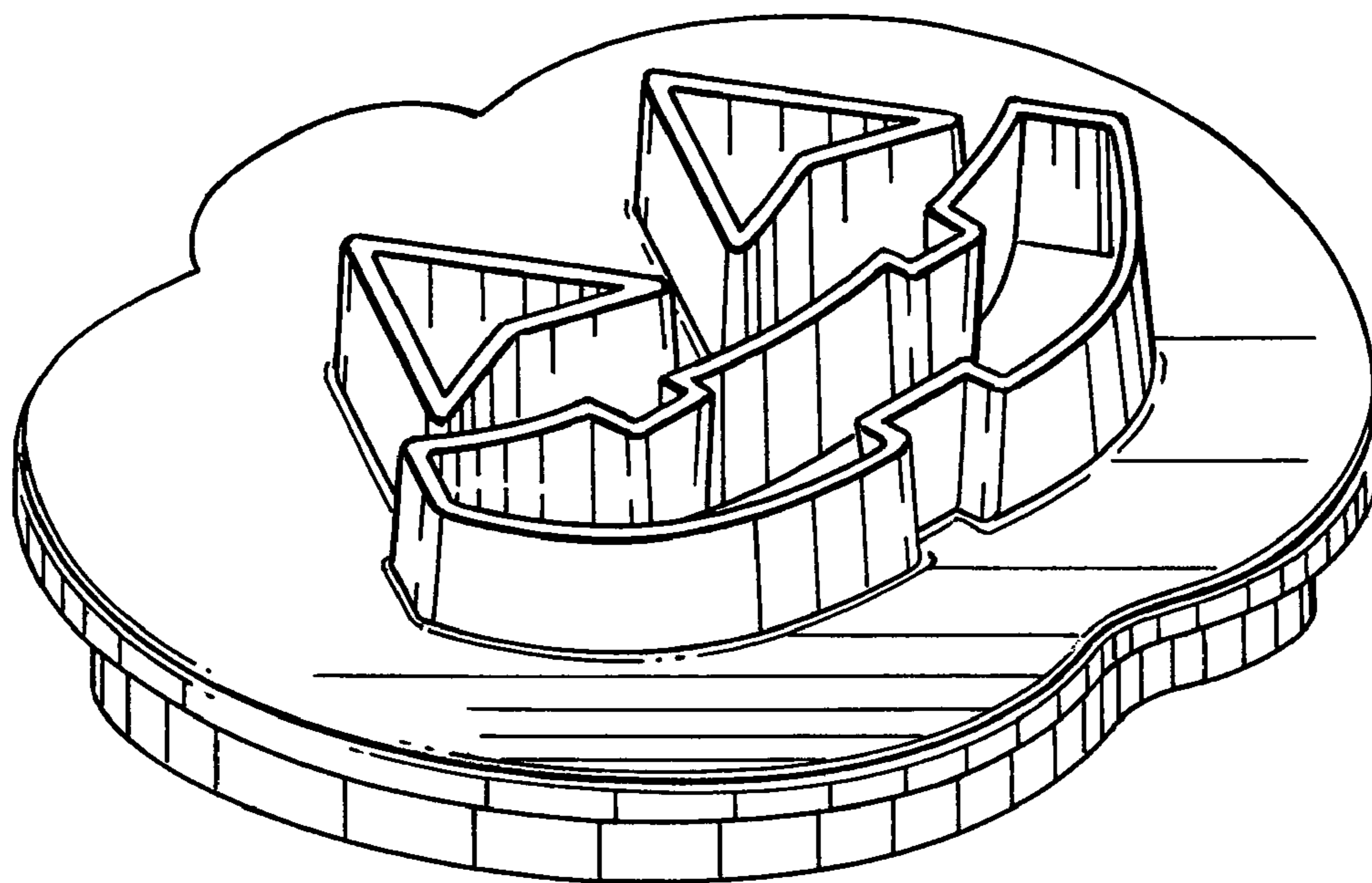

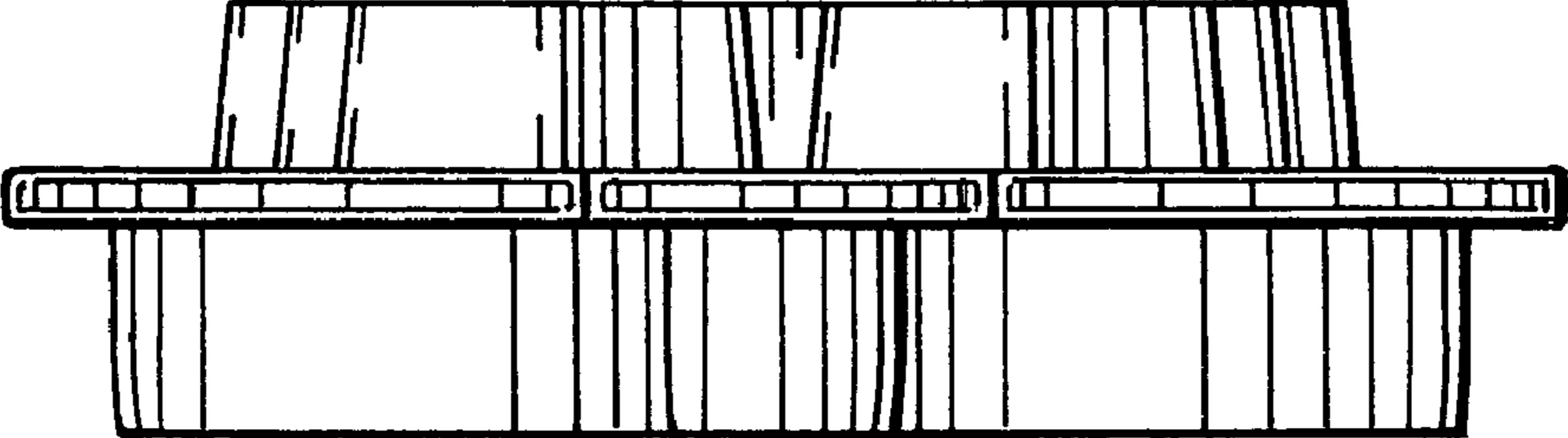

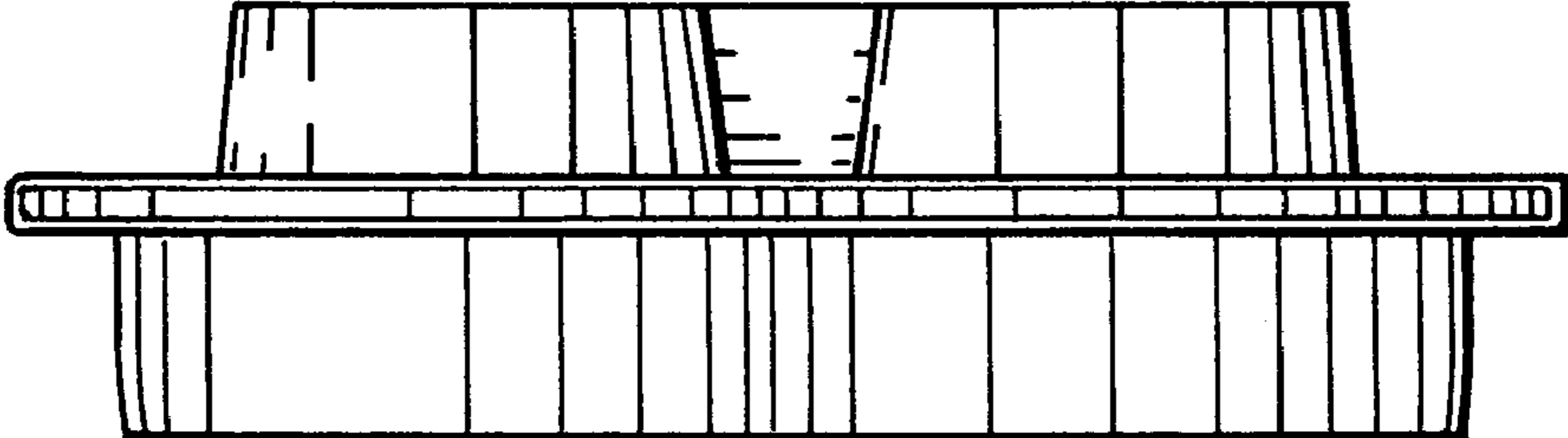

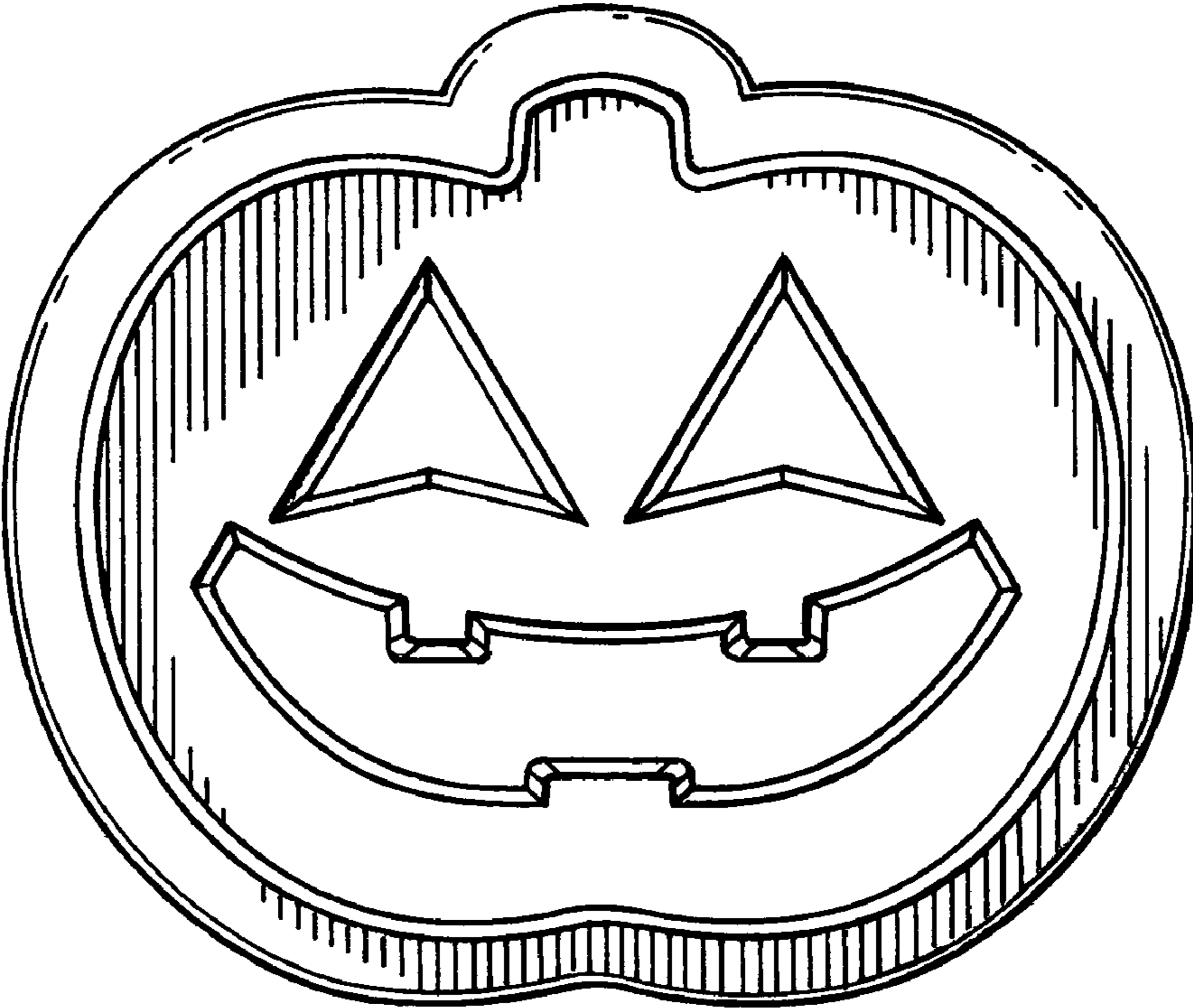

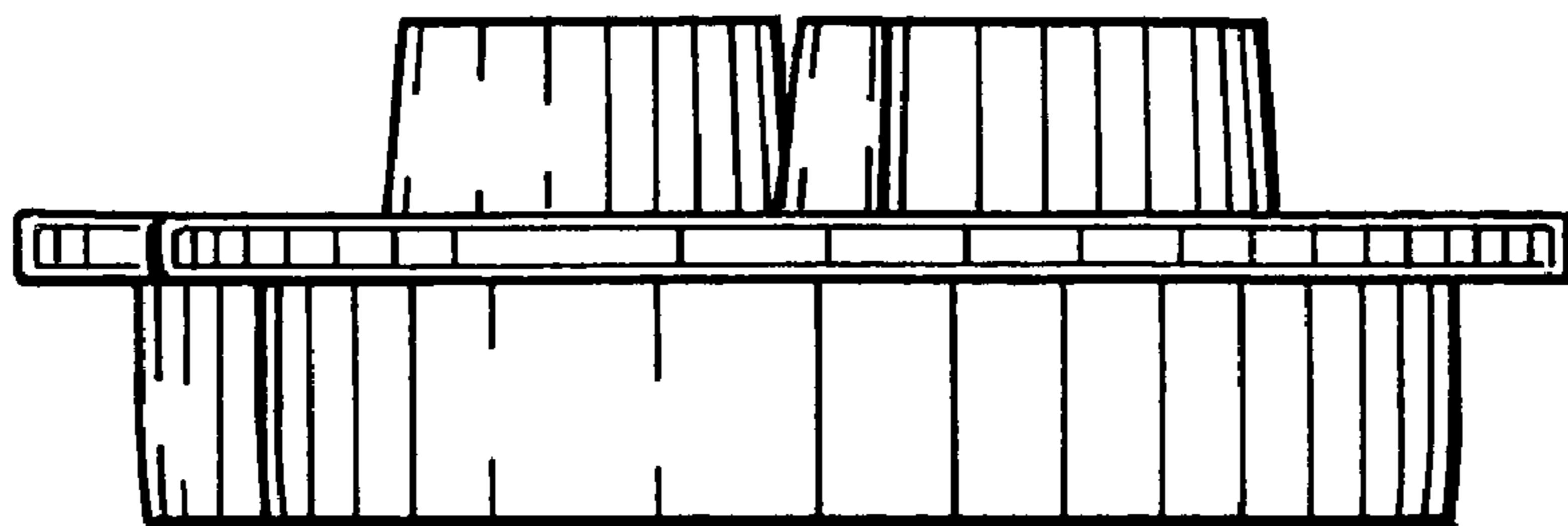

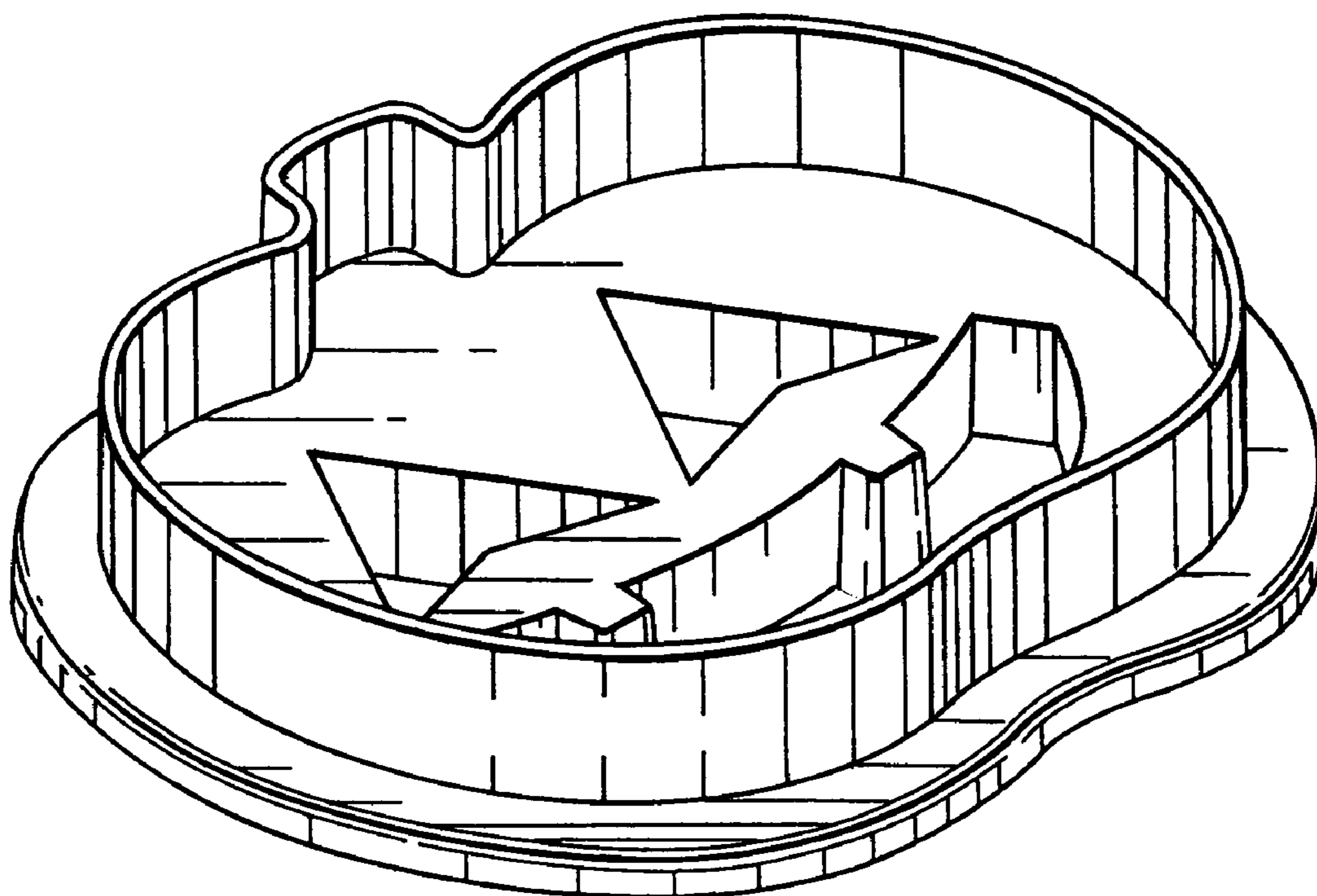
