FIG. 21 is a back view thereof.

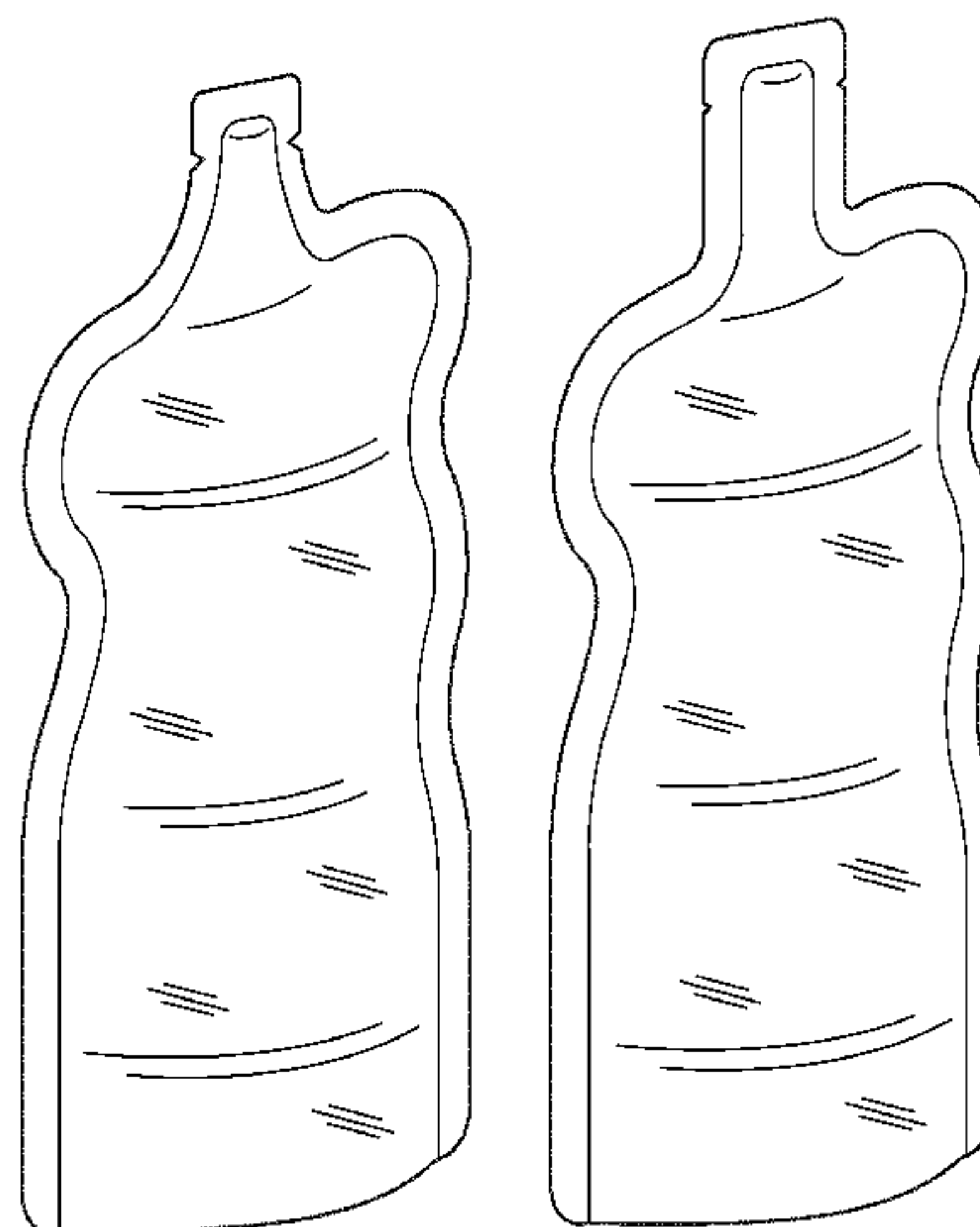

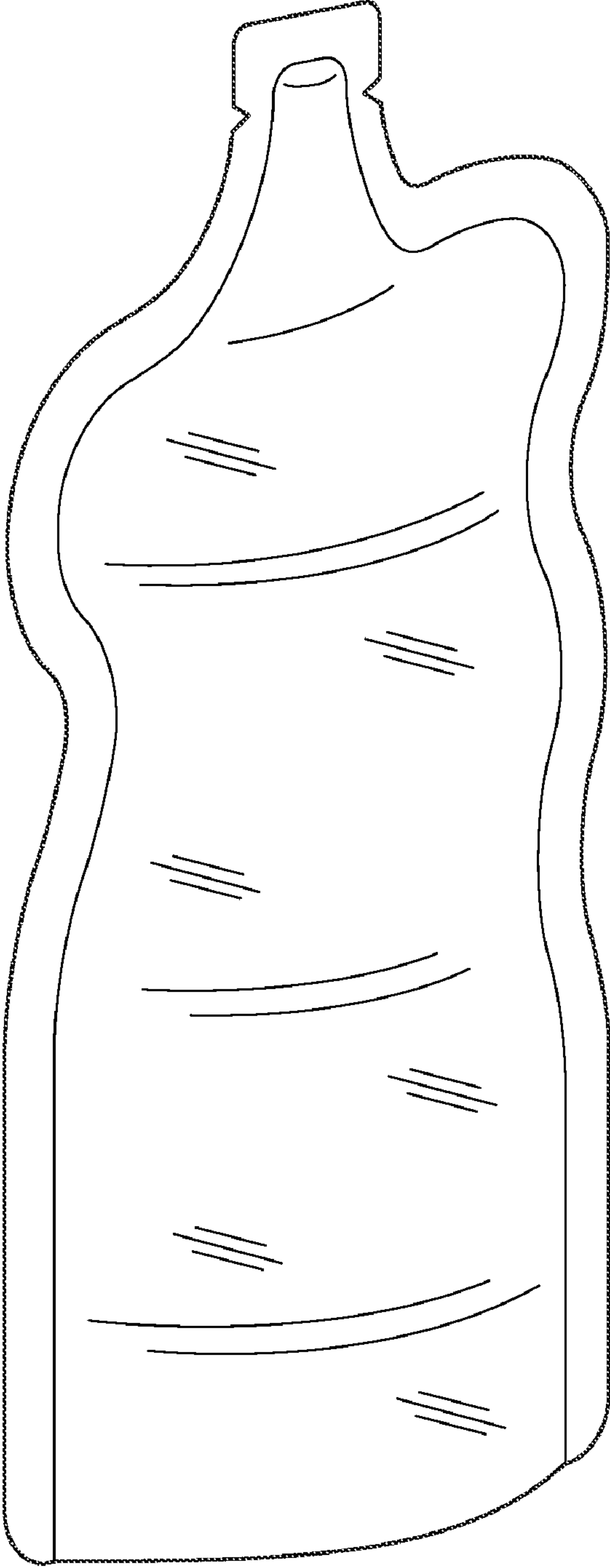

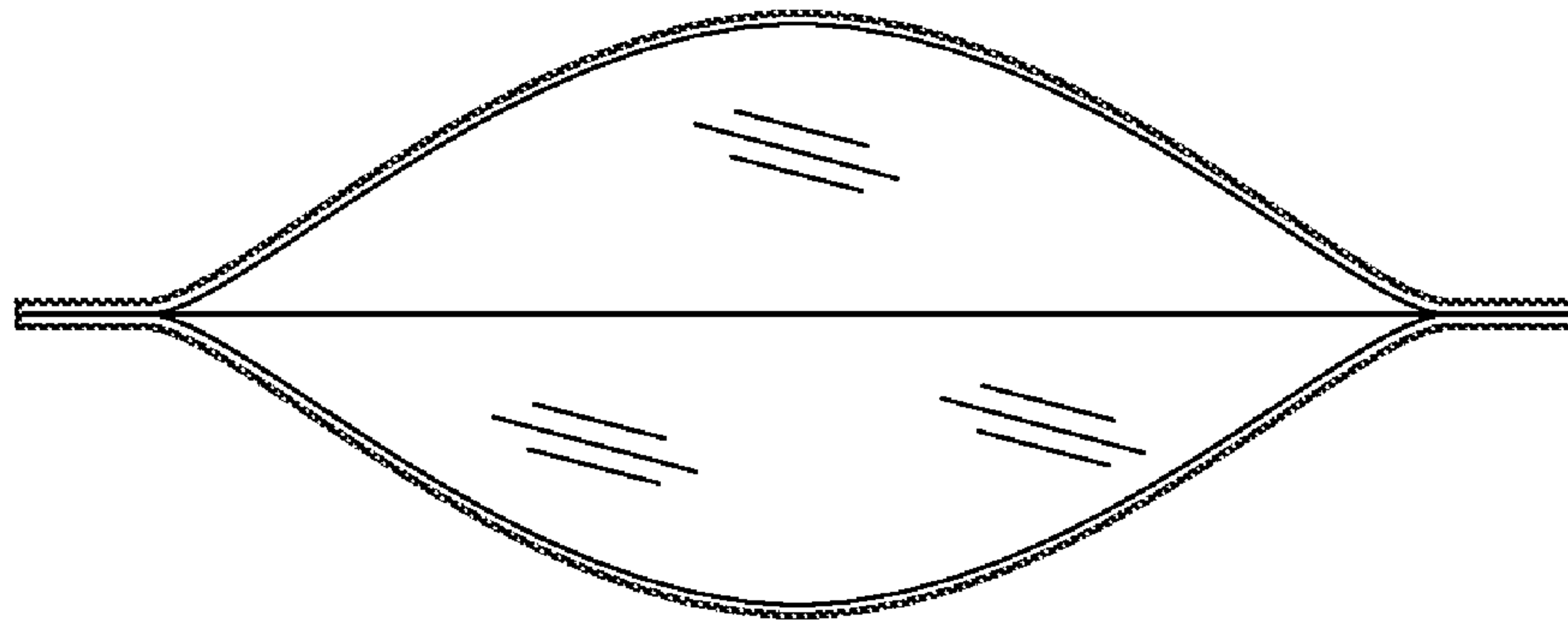

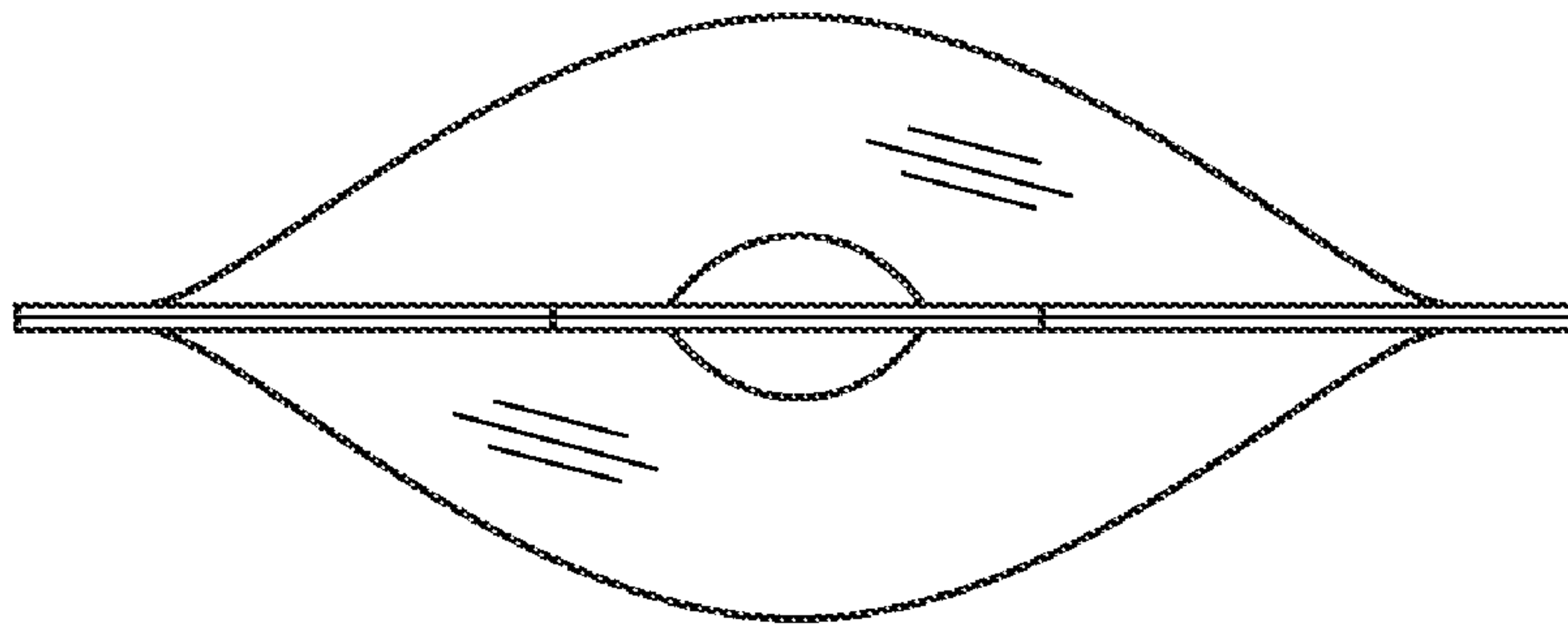

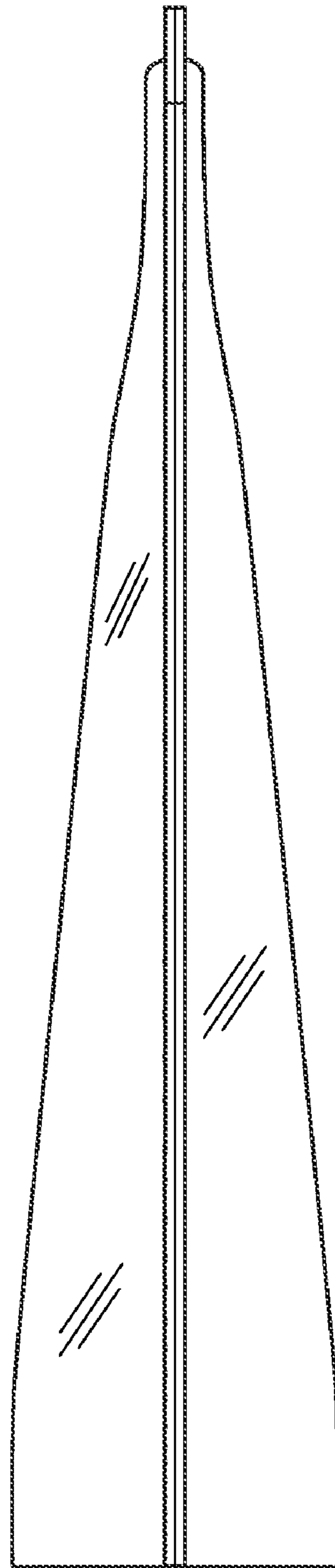

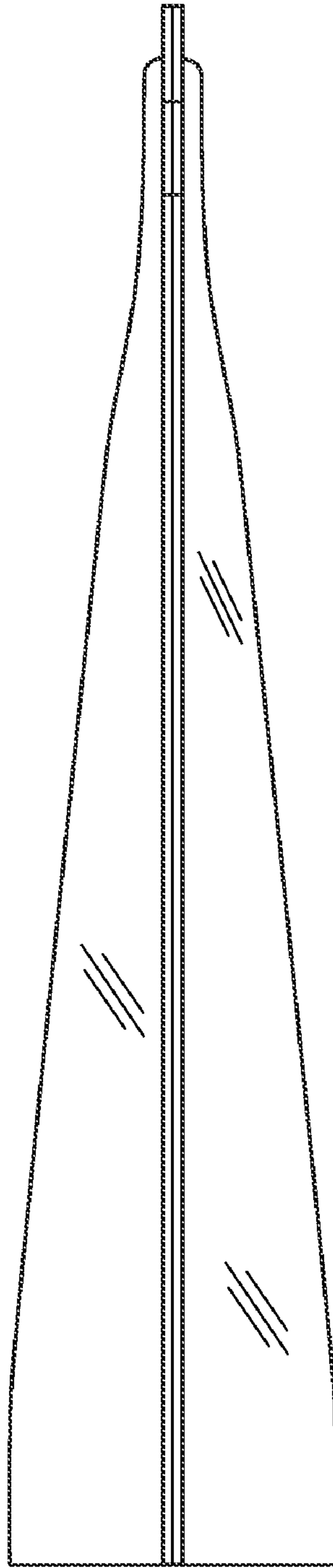

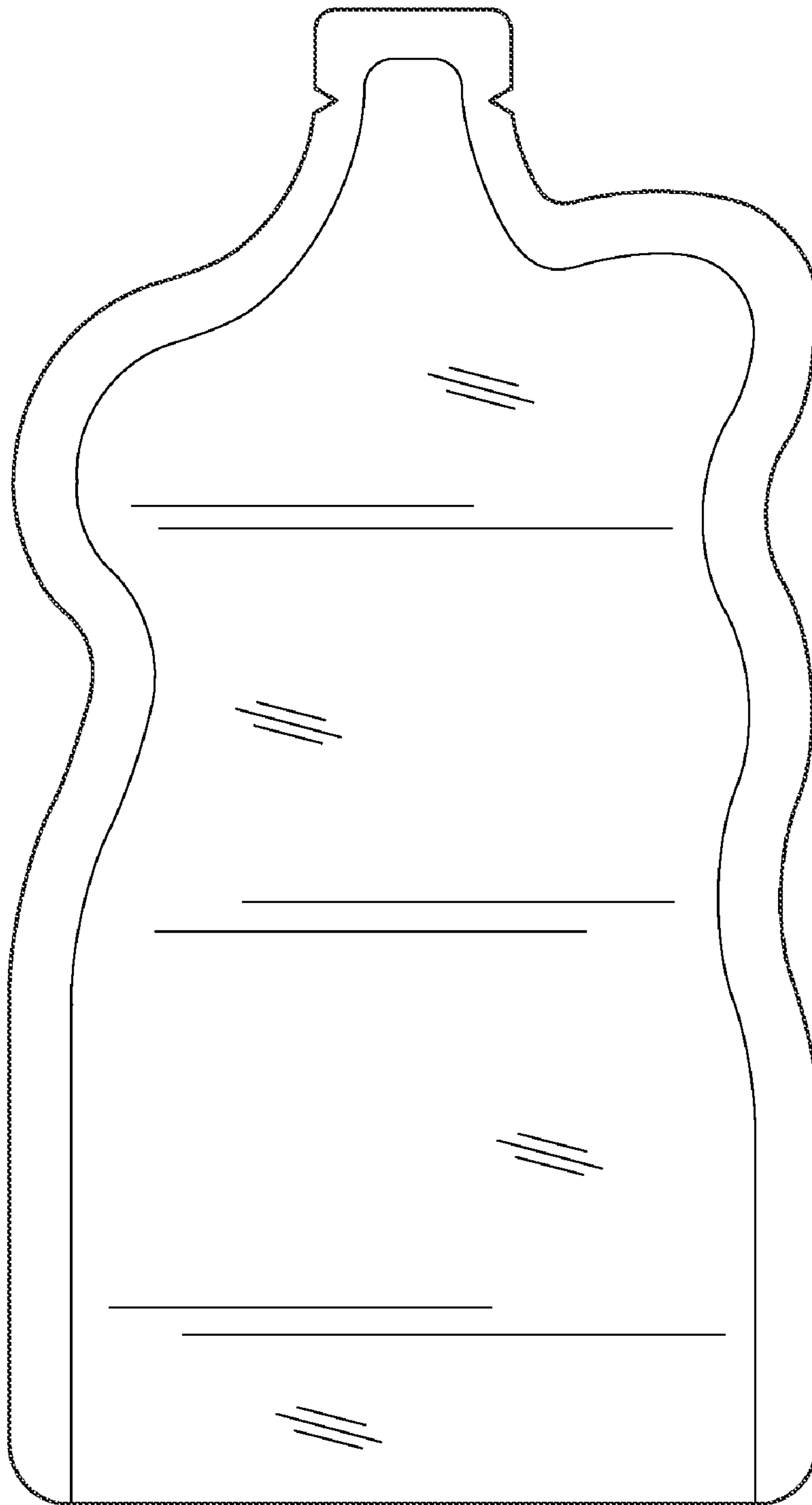

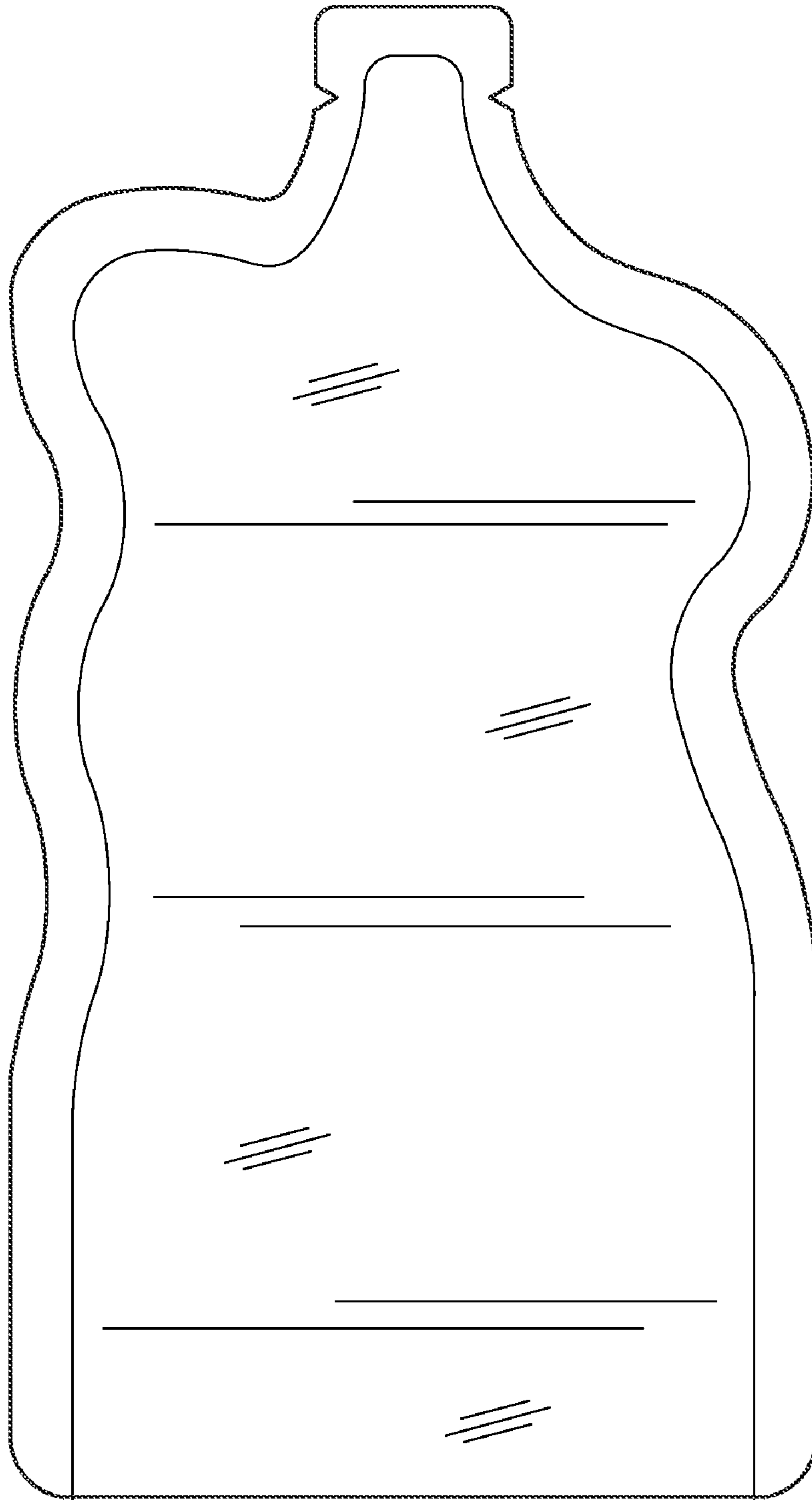

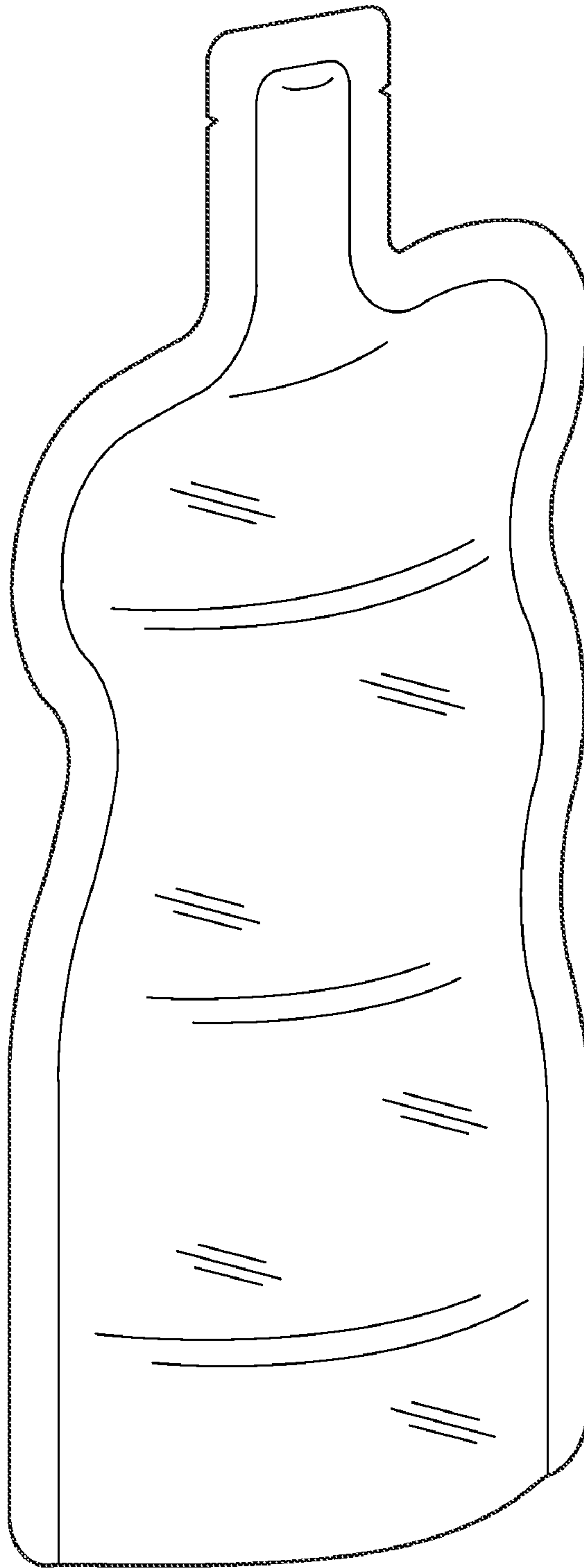

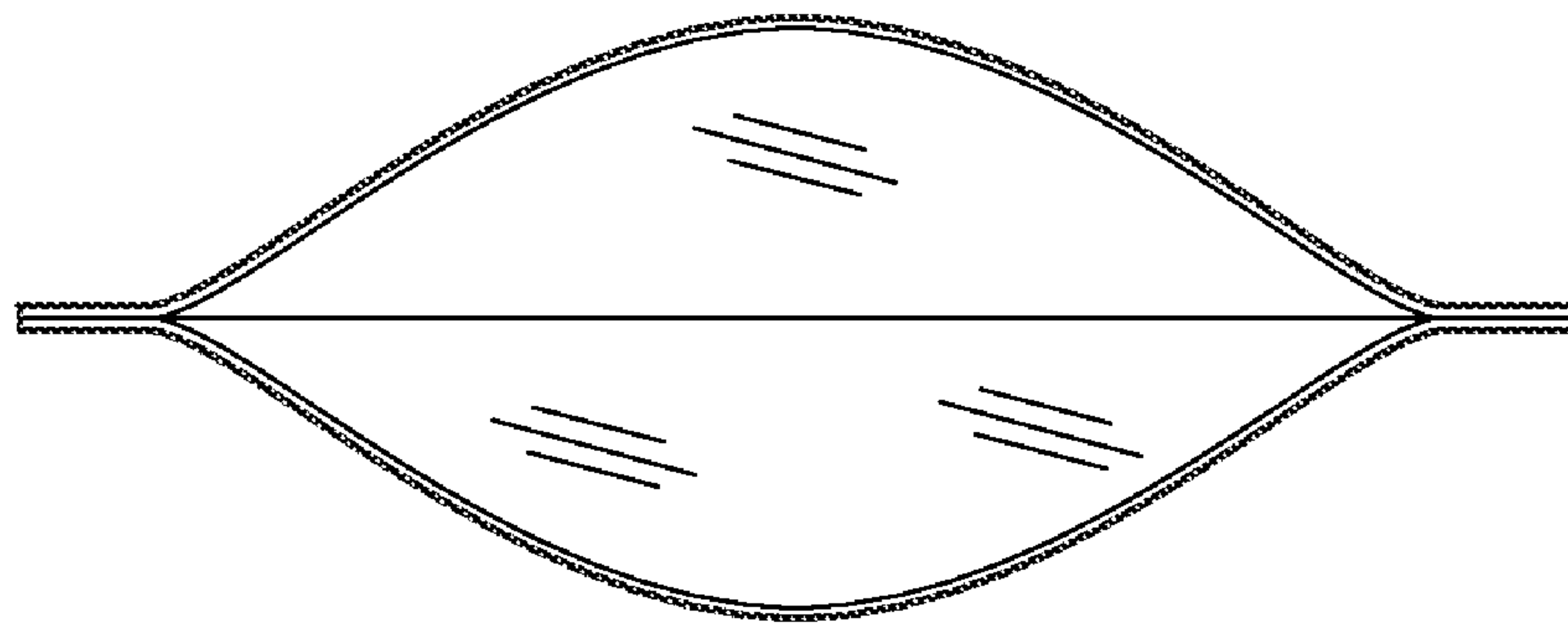

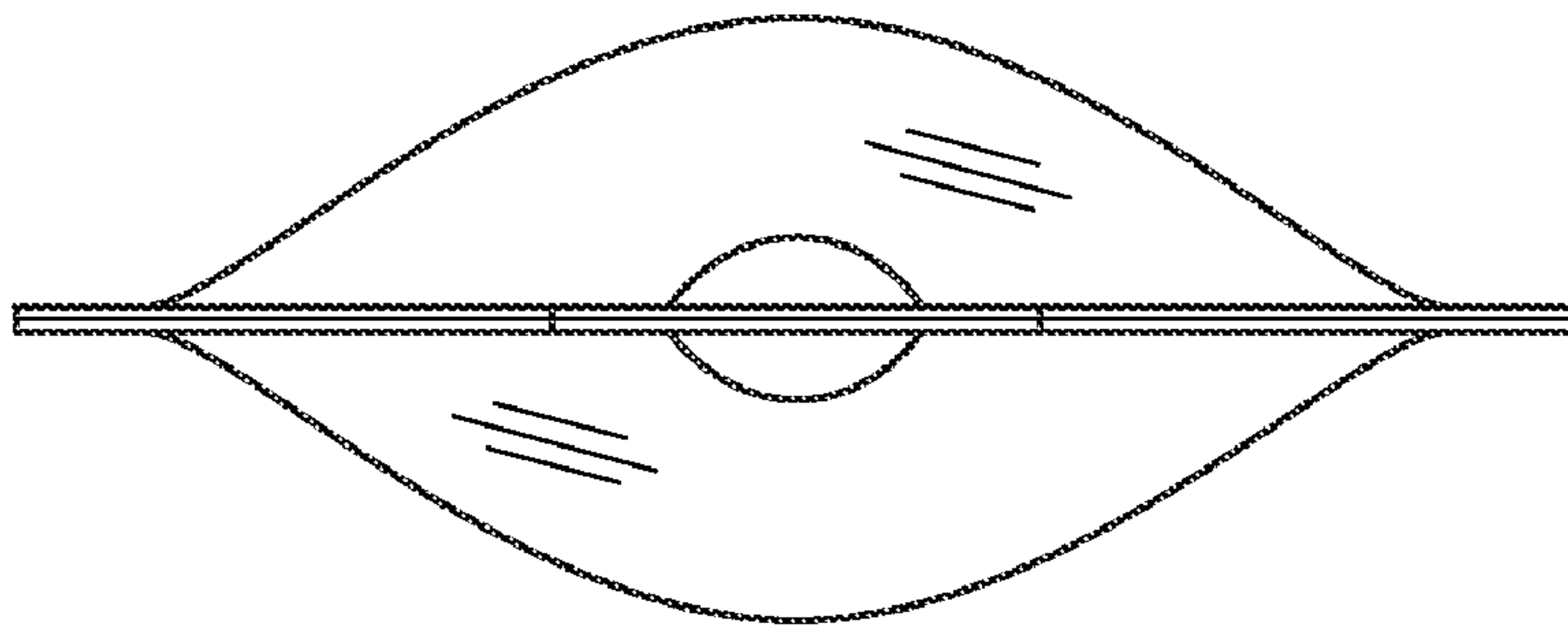

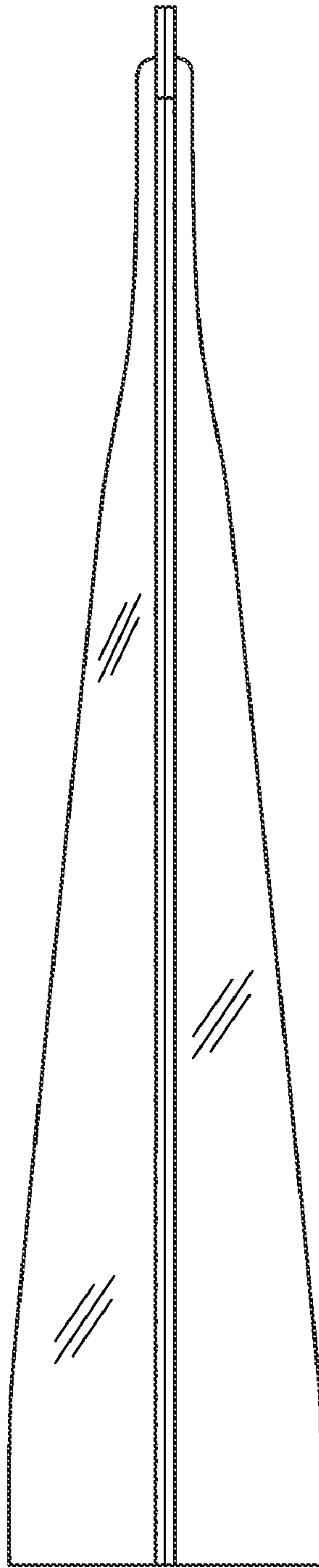

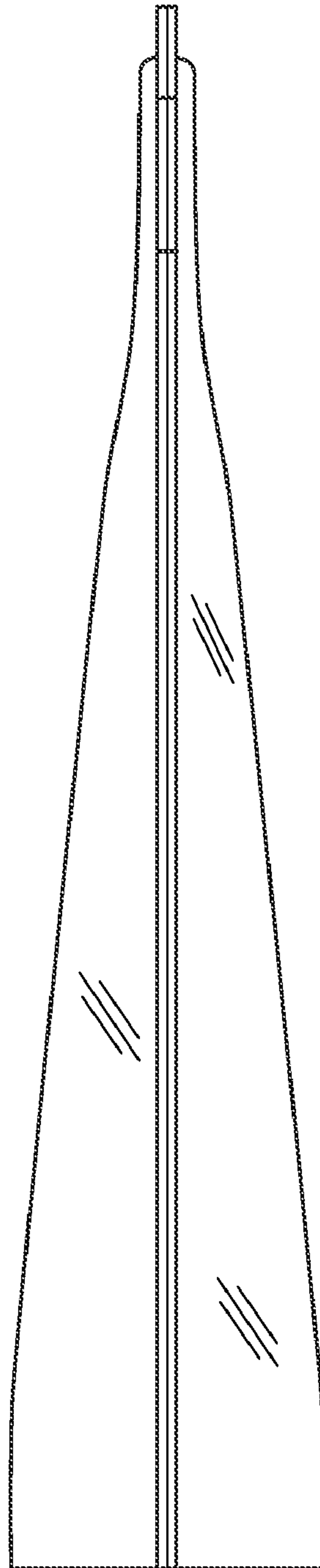

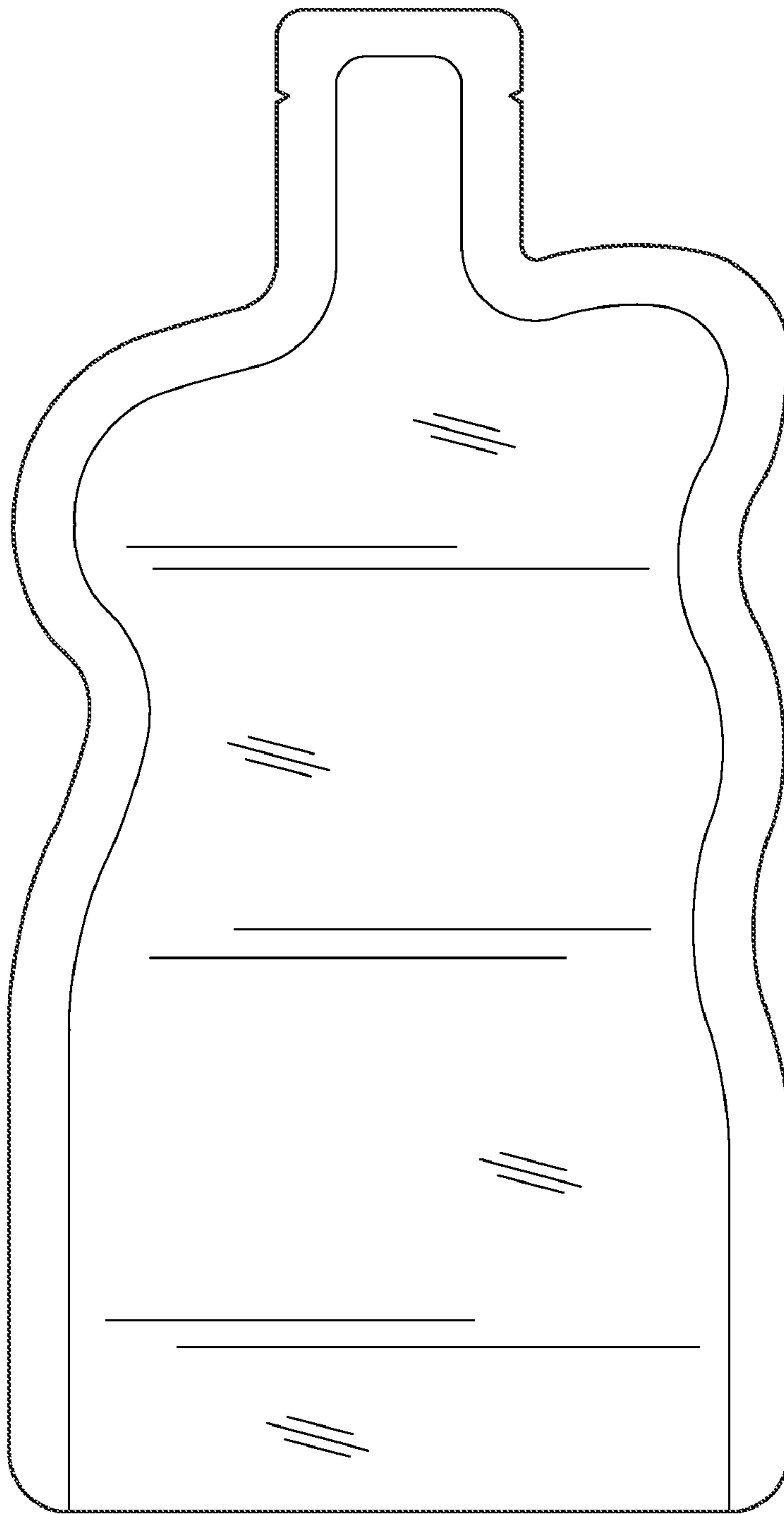

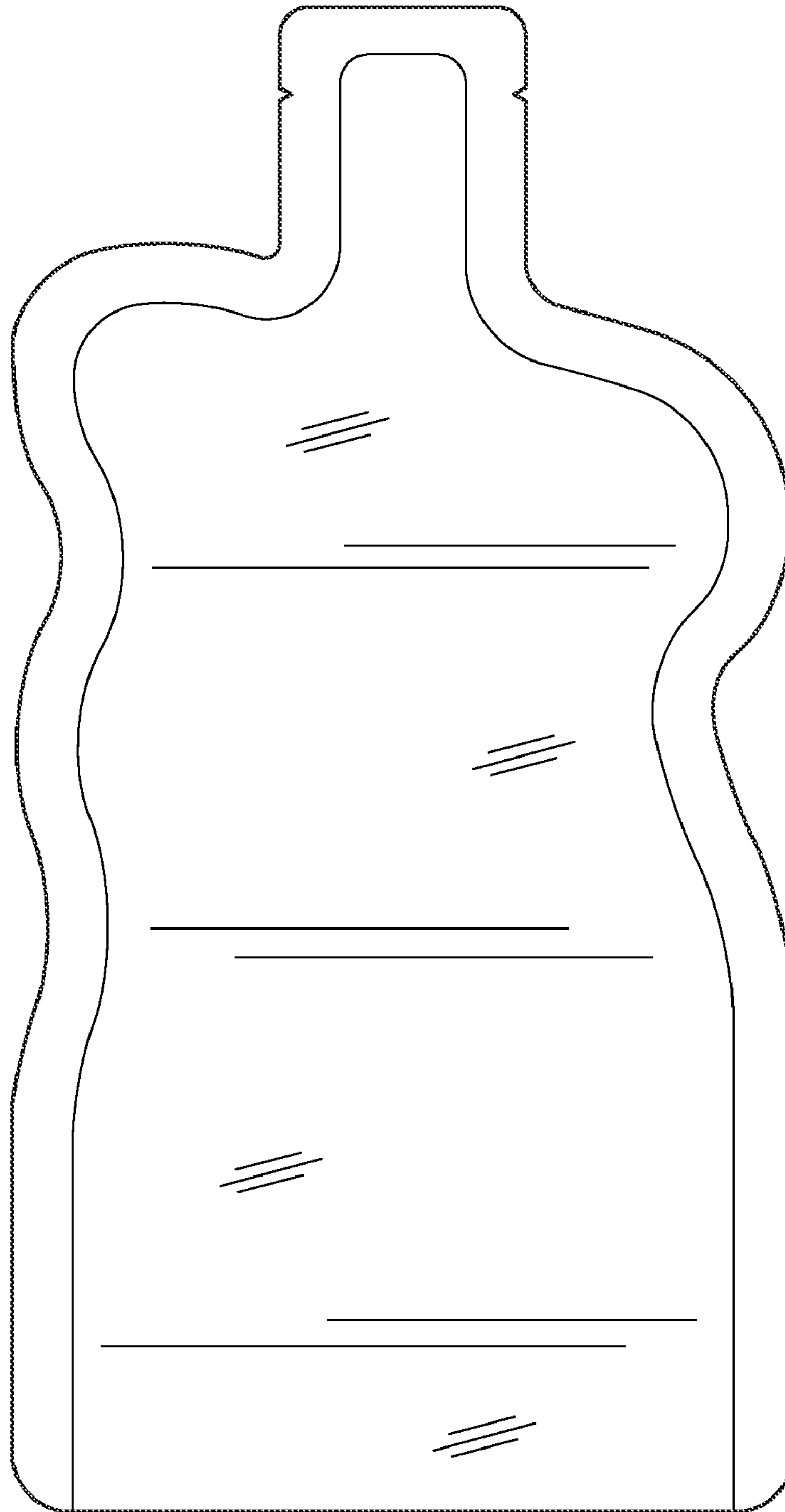

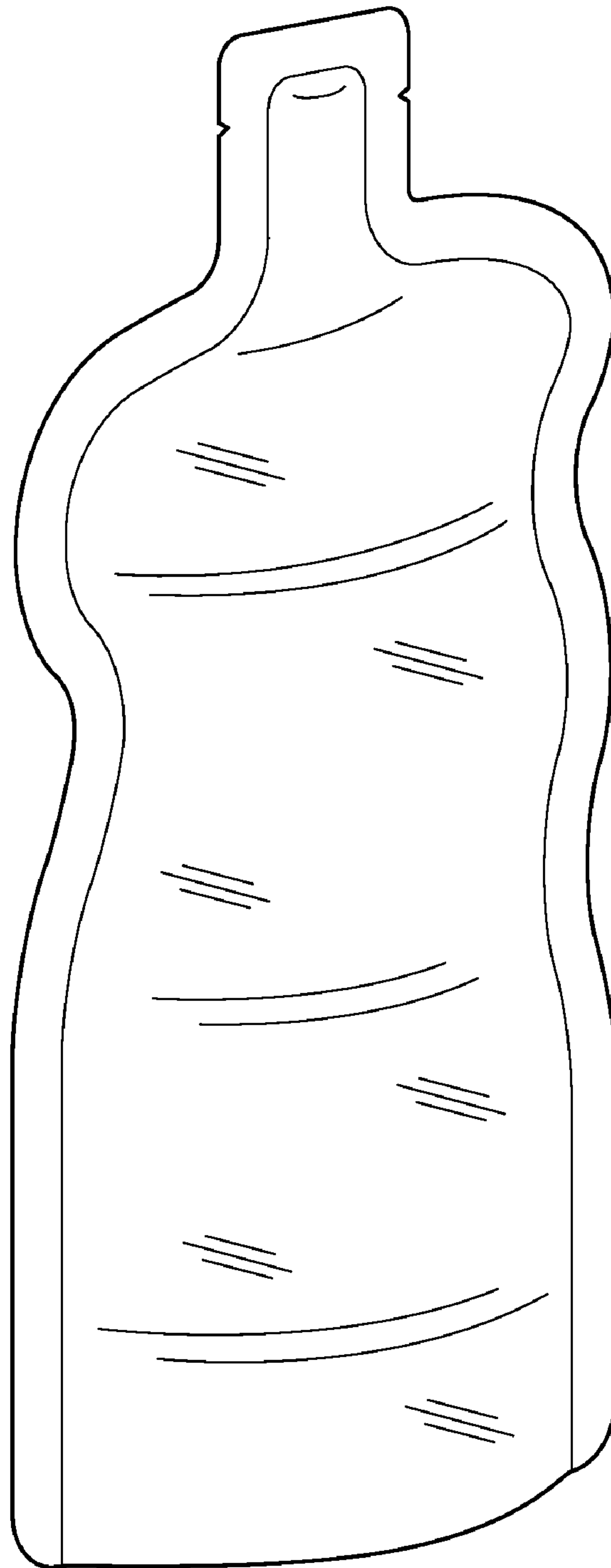

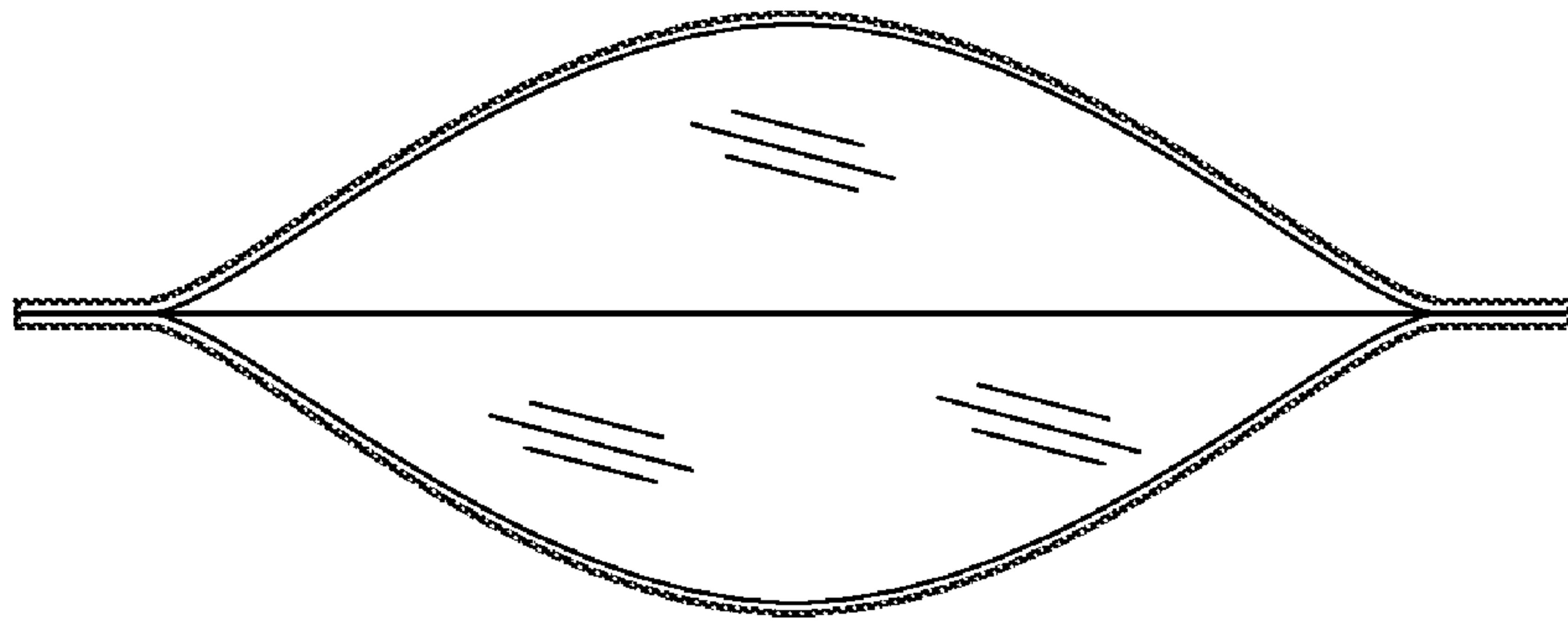

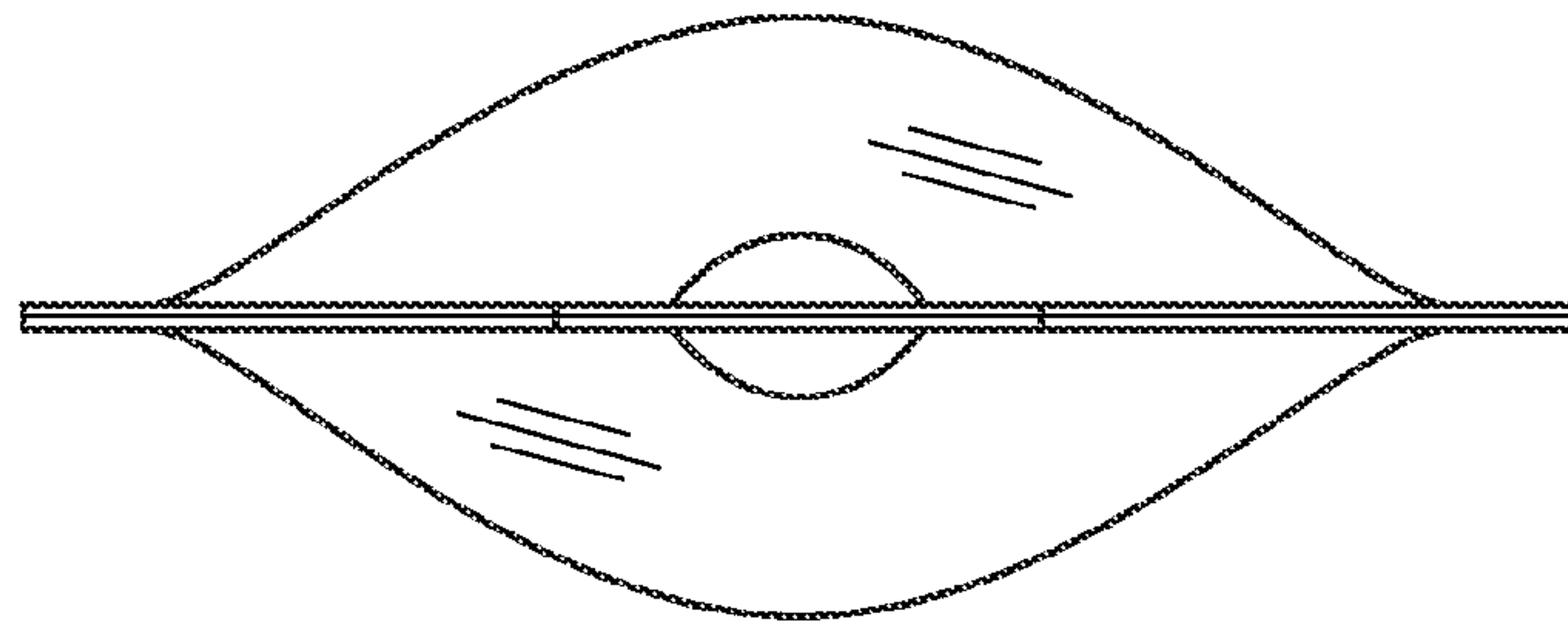

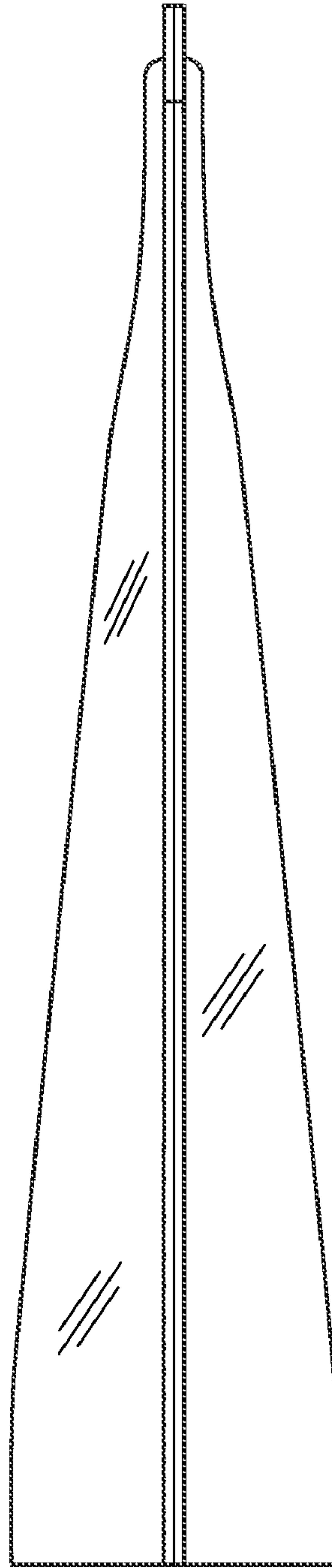

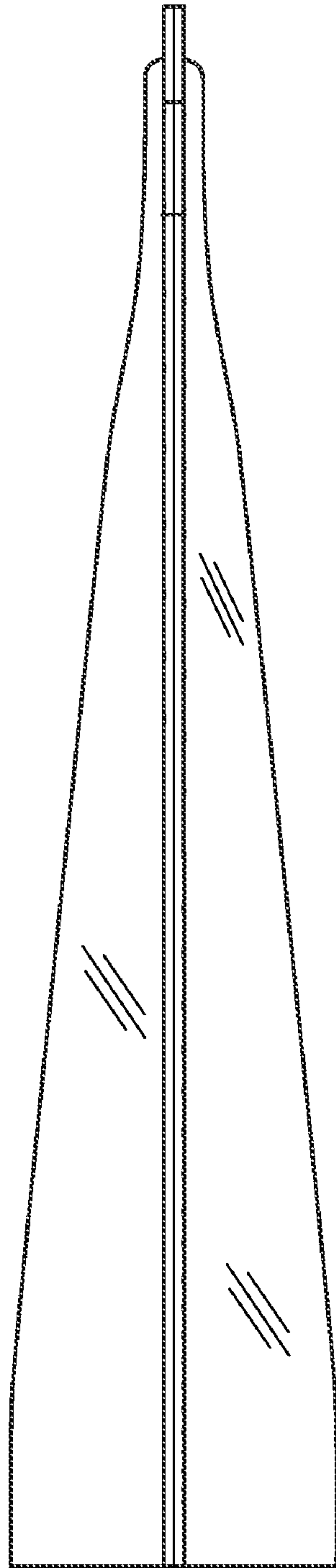

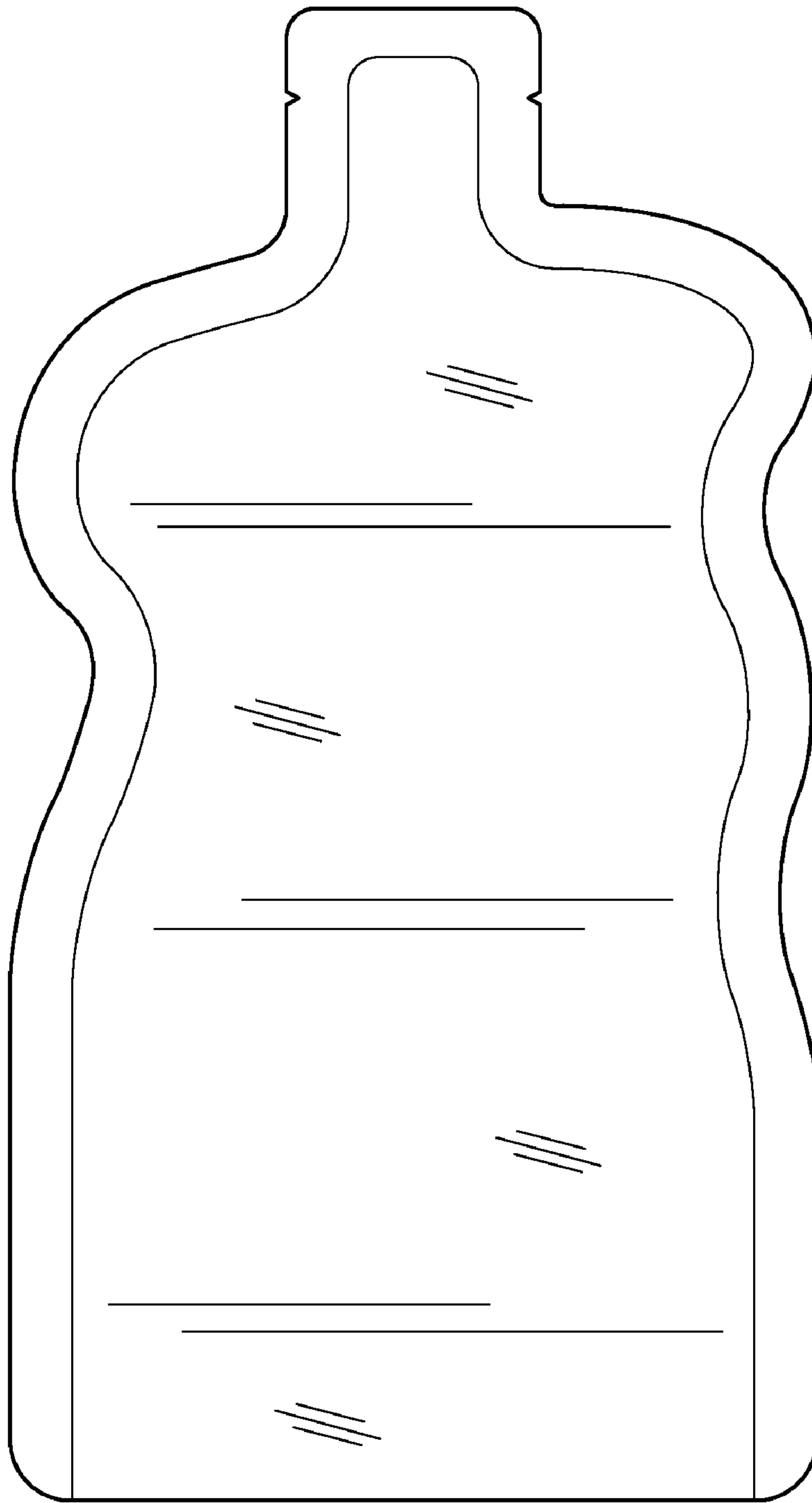

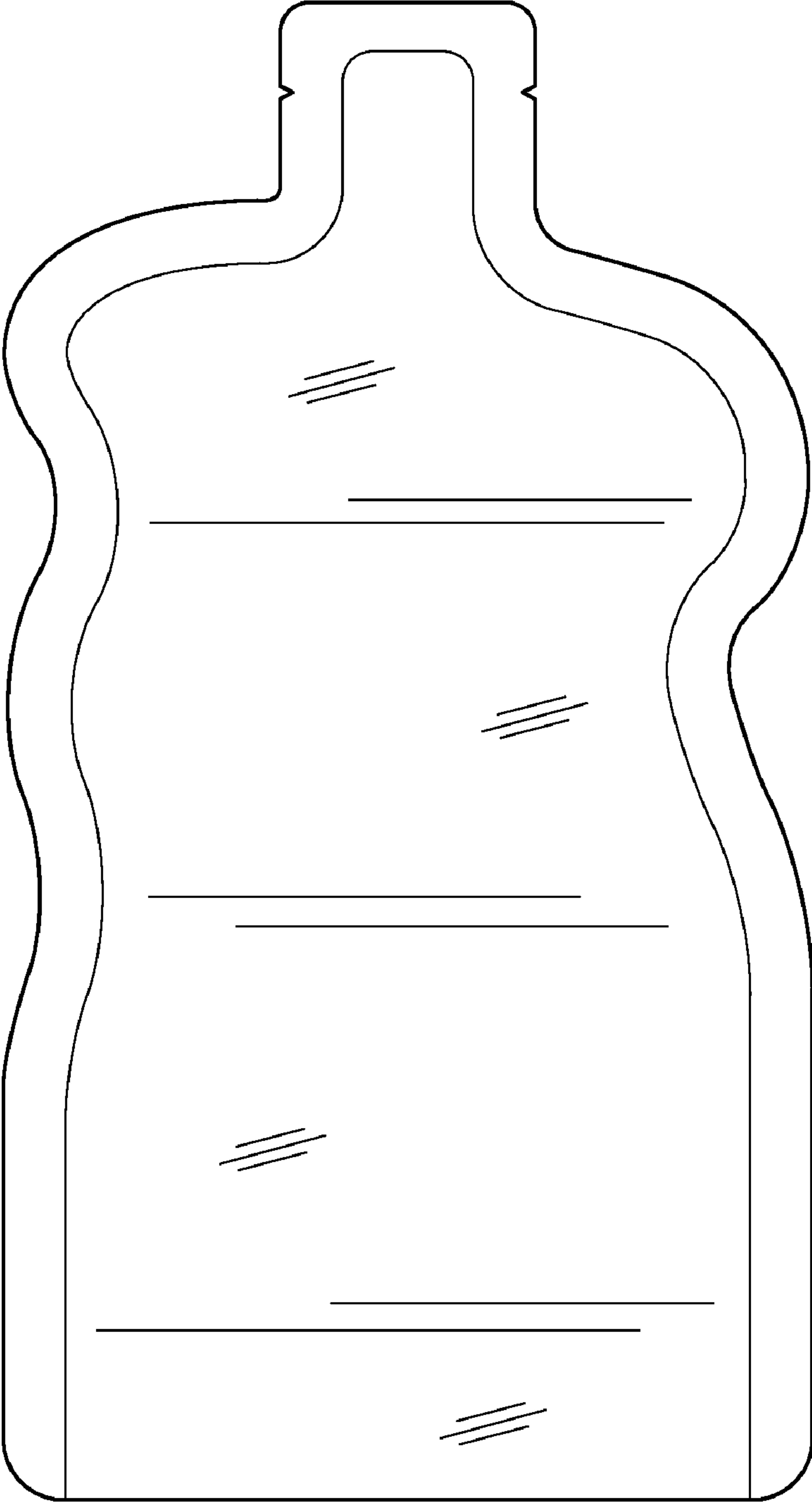
