A new ornamental design for a child in back seat of car streamer, as shown and described.

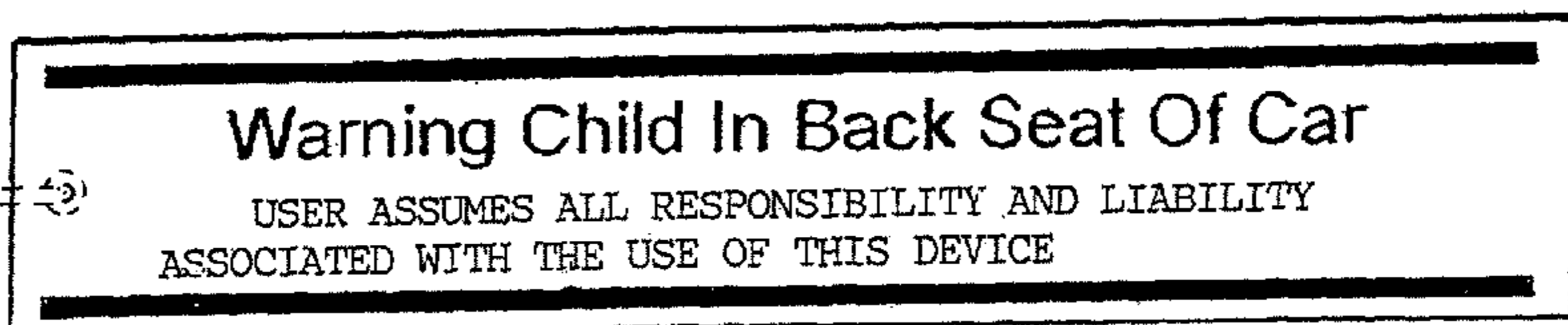
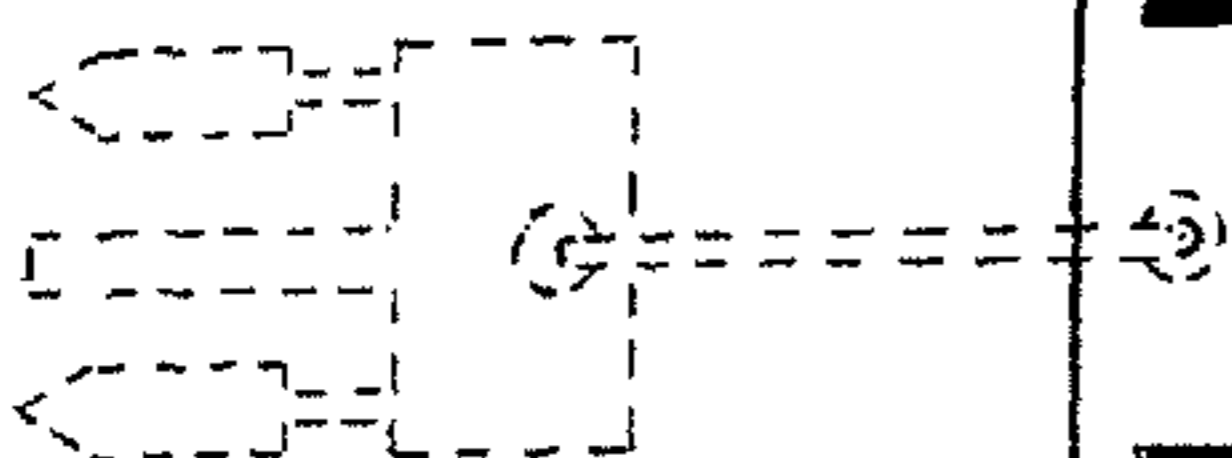
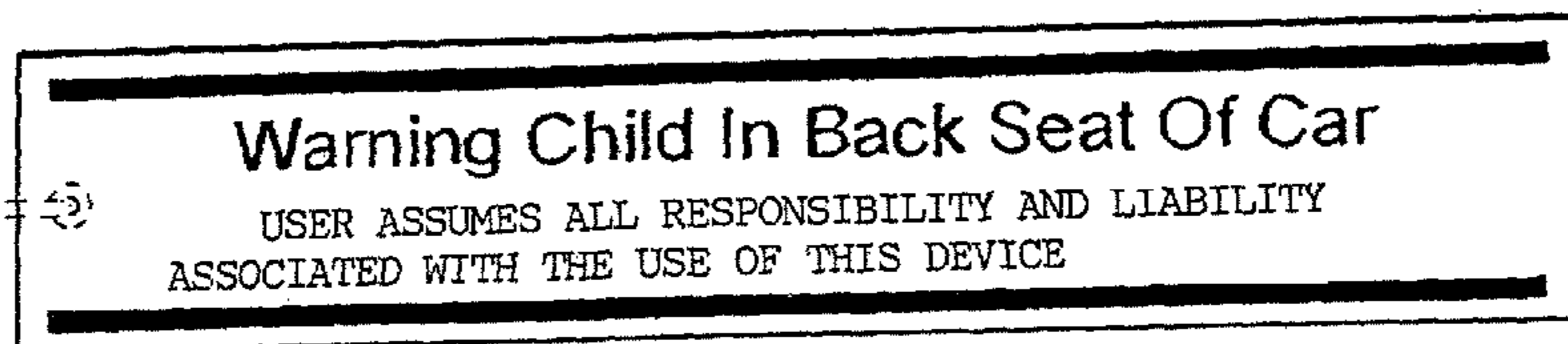
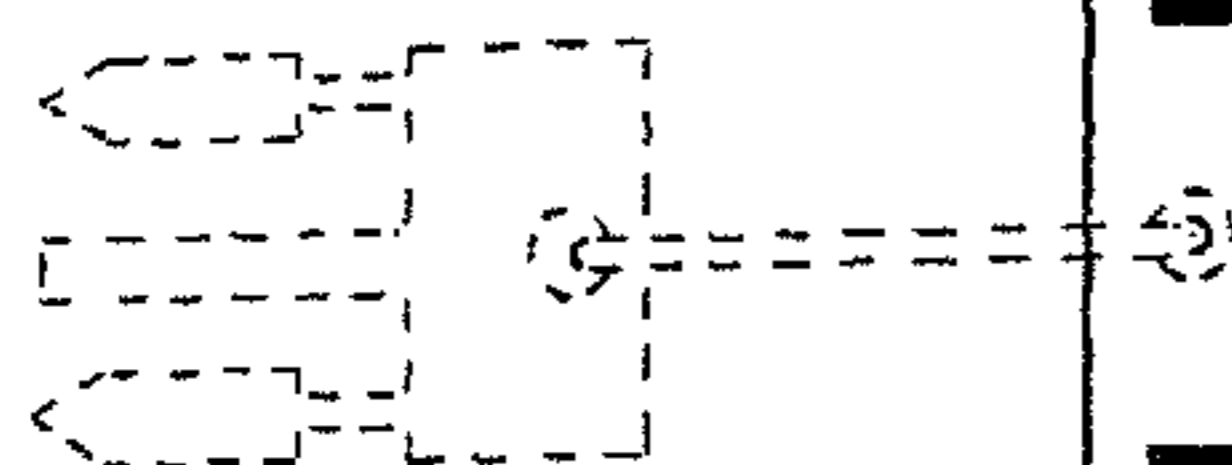
DESCRIPTION

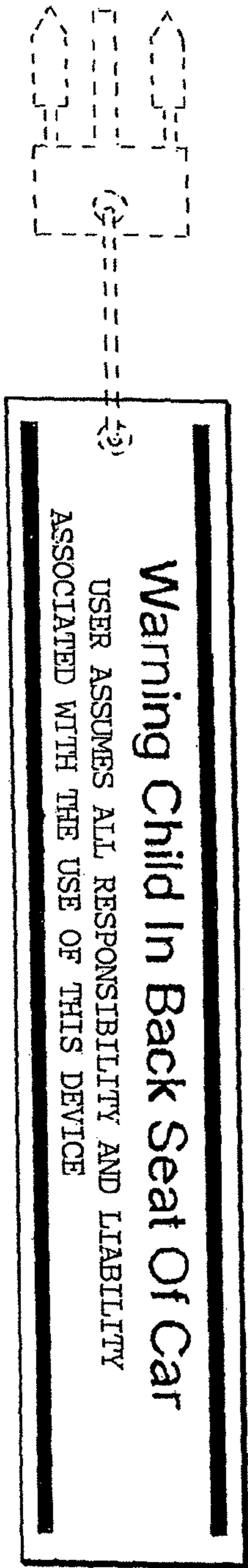

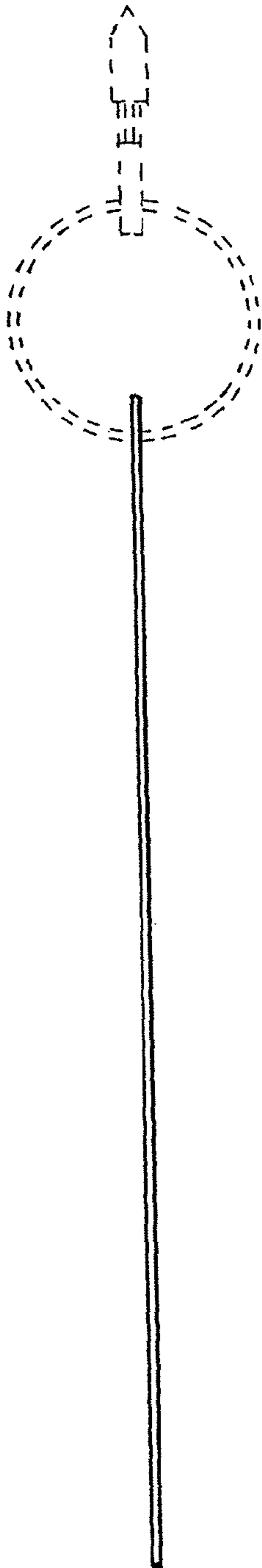

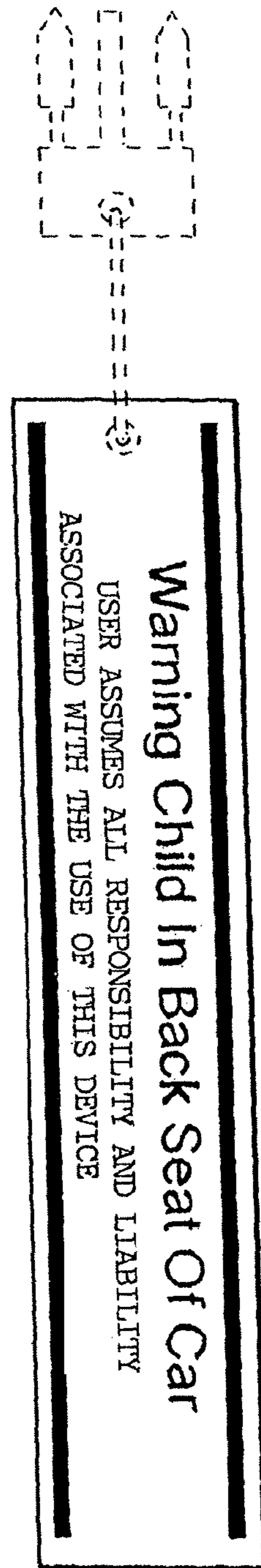
