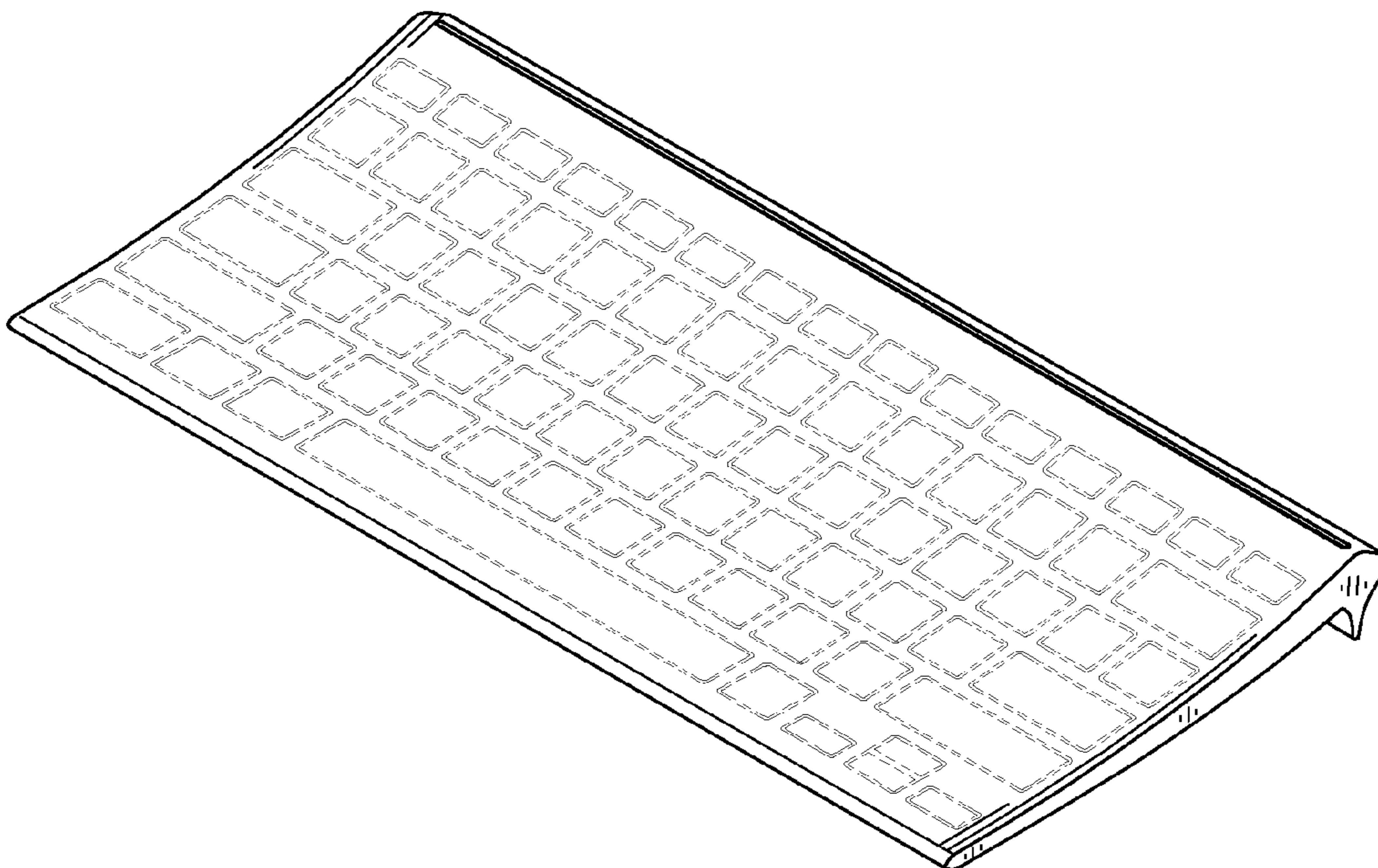
**DESCRIPTION**

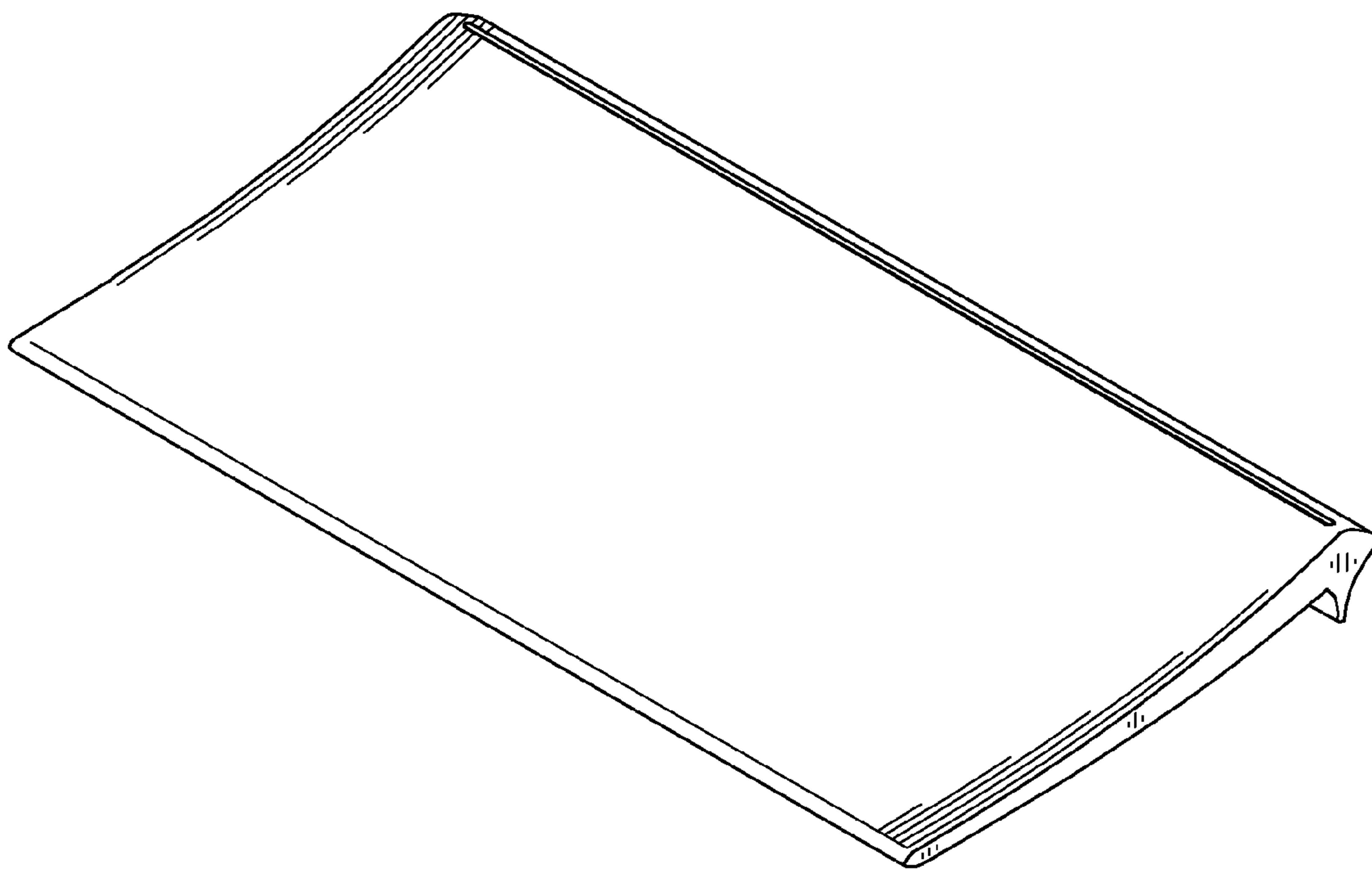

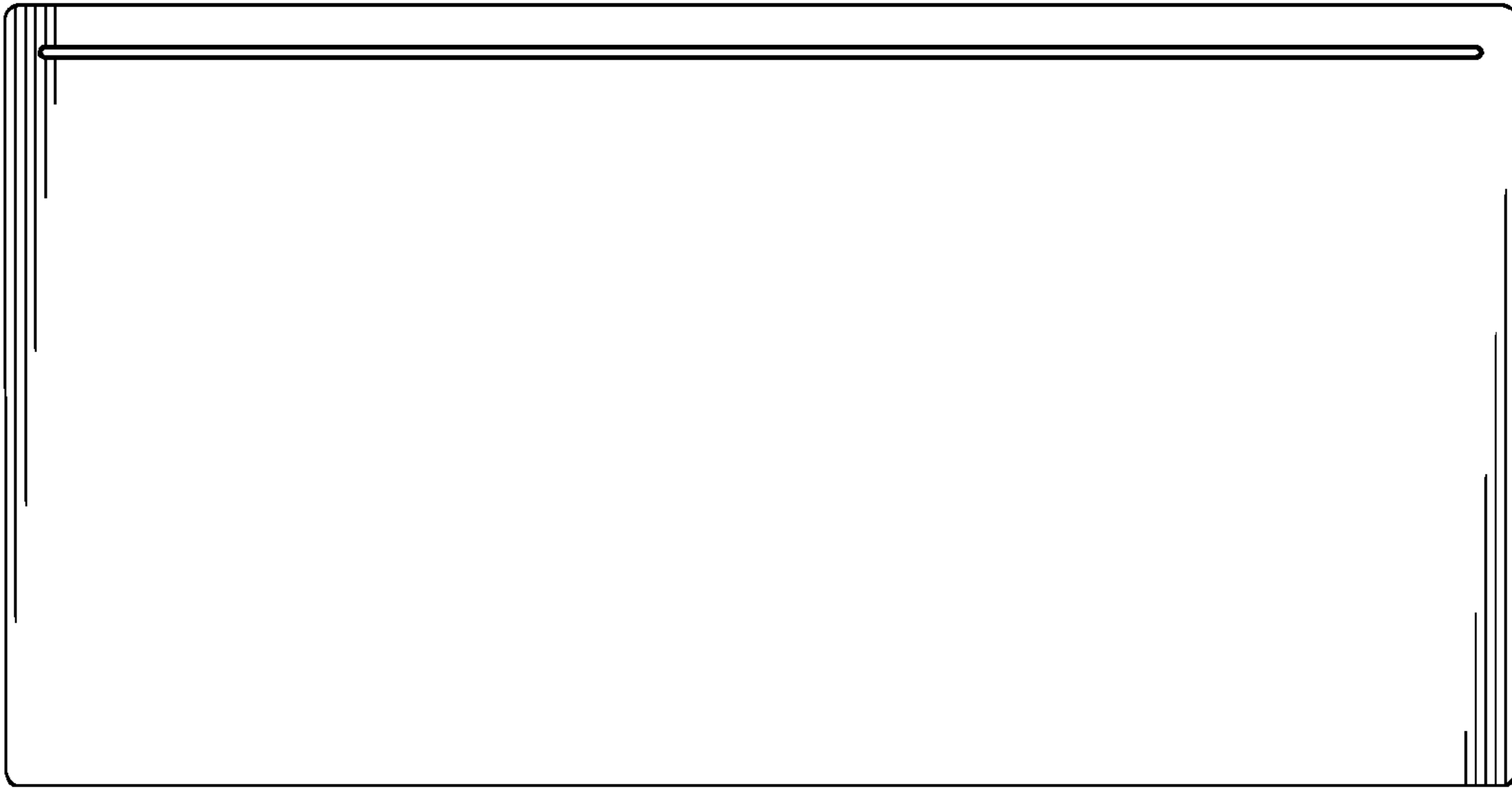

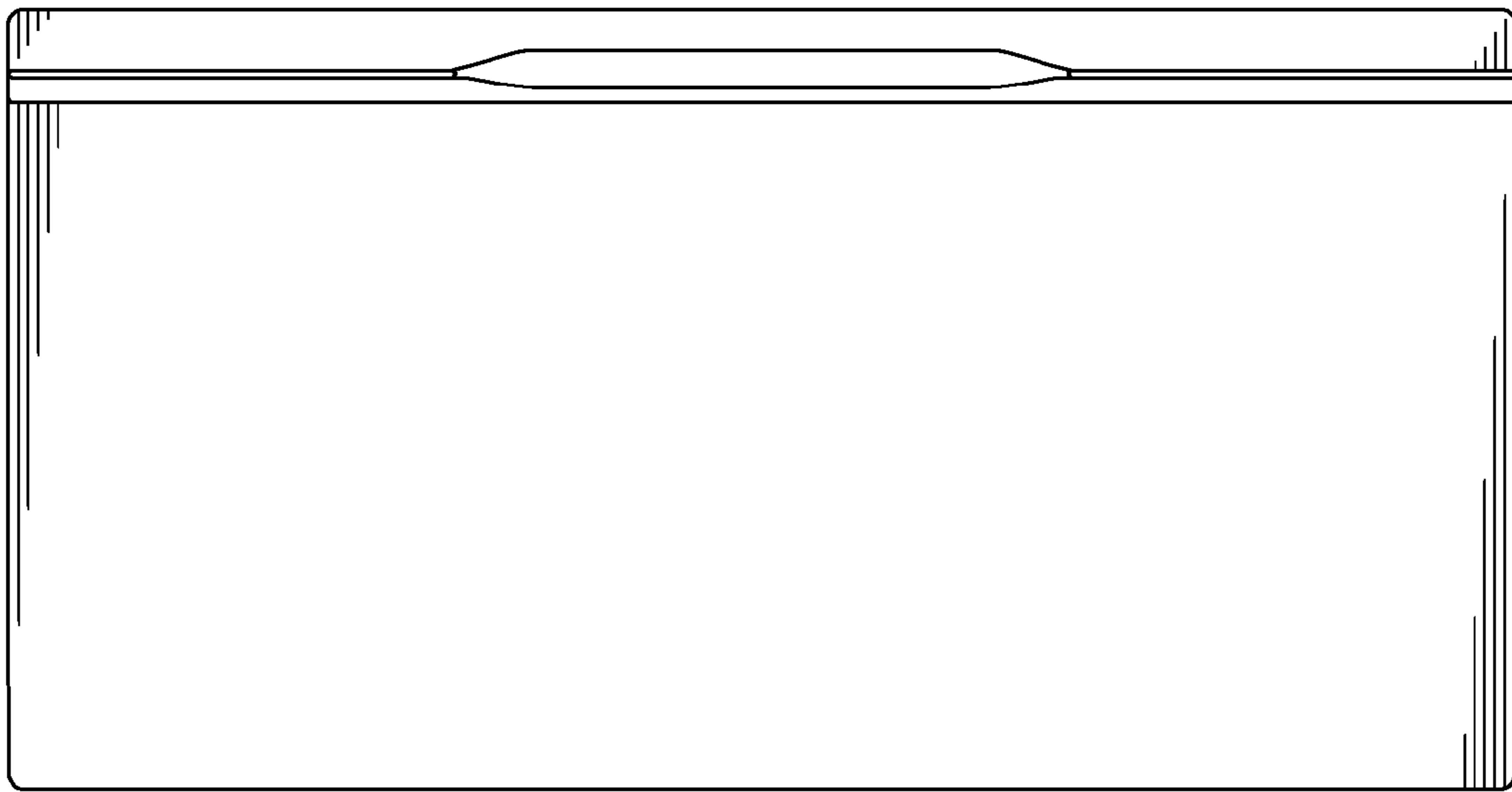

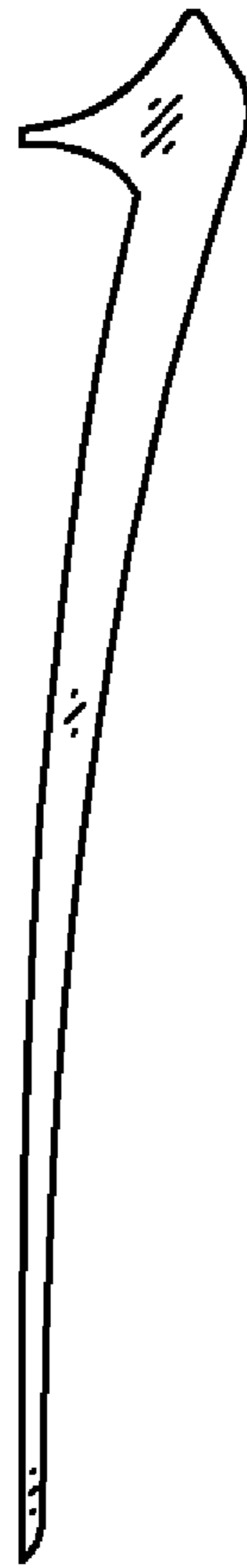

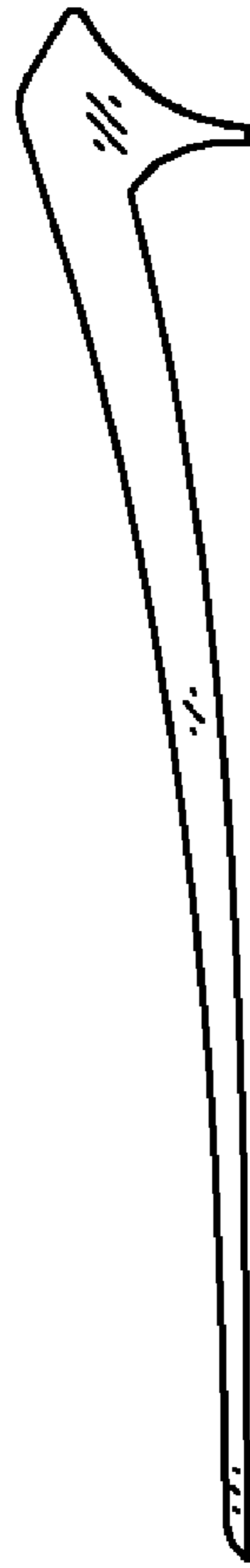

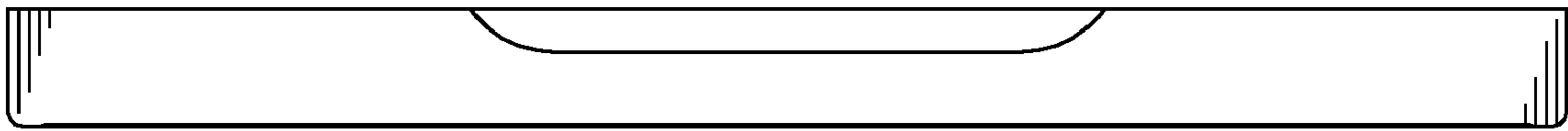

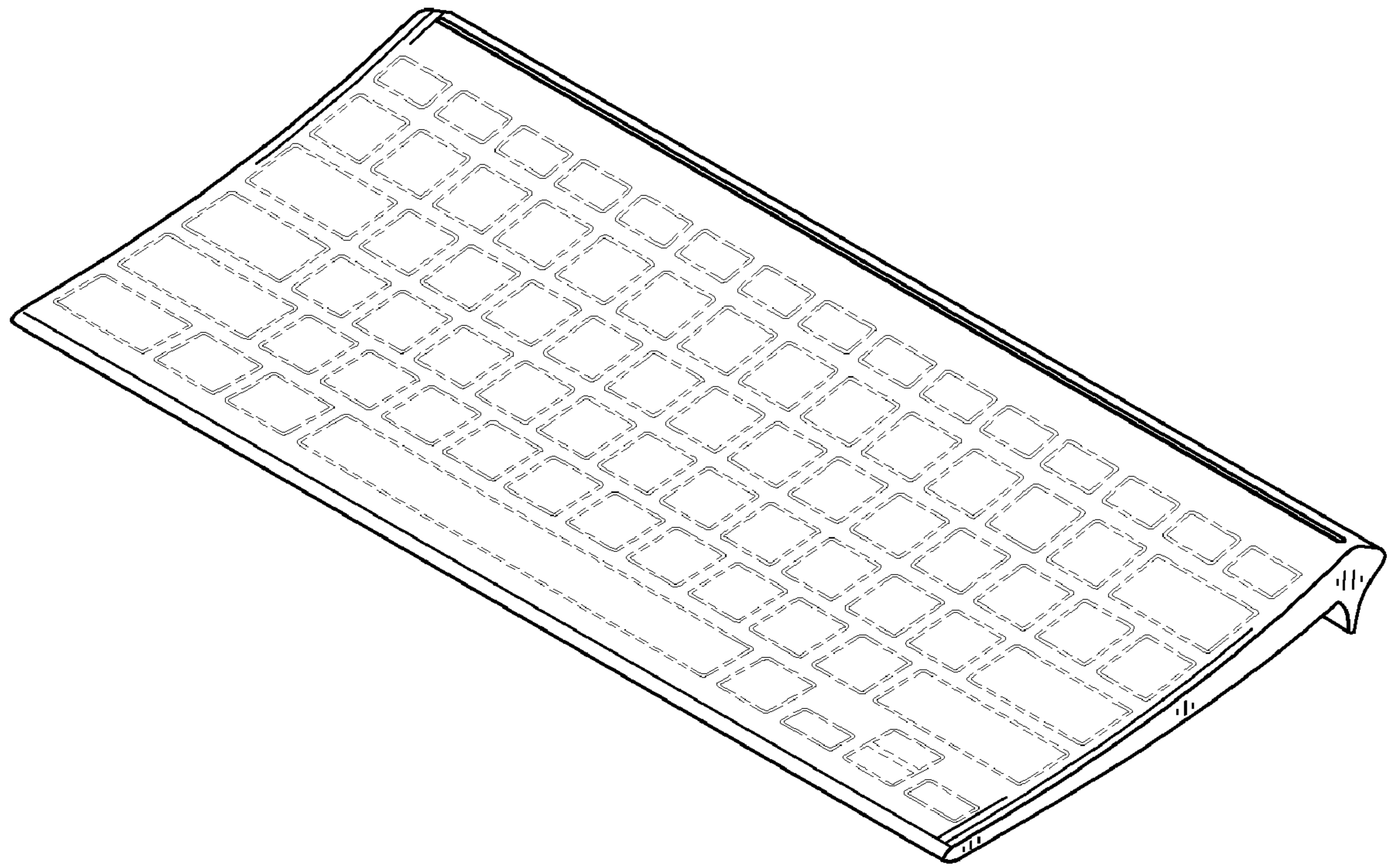
