We claim the ornamental design for a hand-held electronic device, as shown and described.

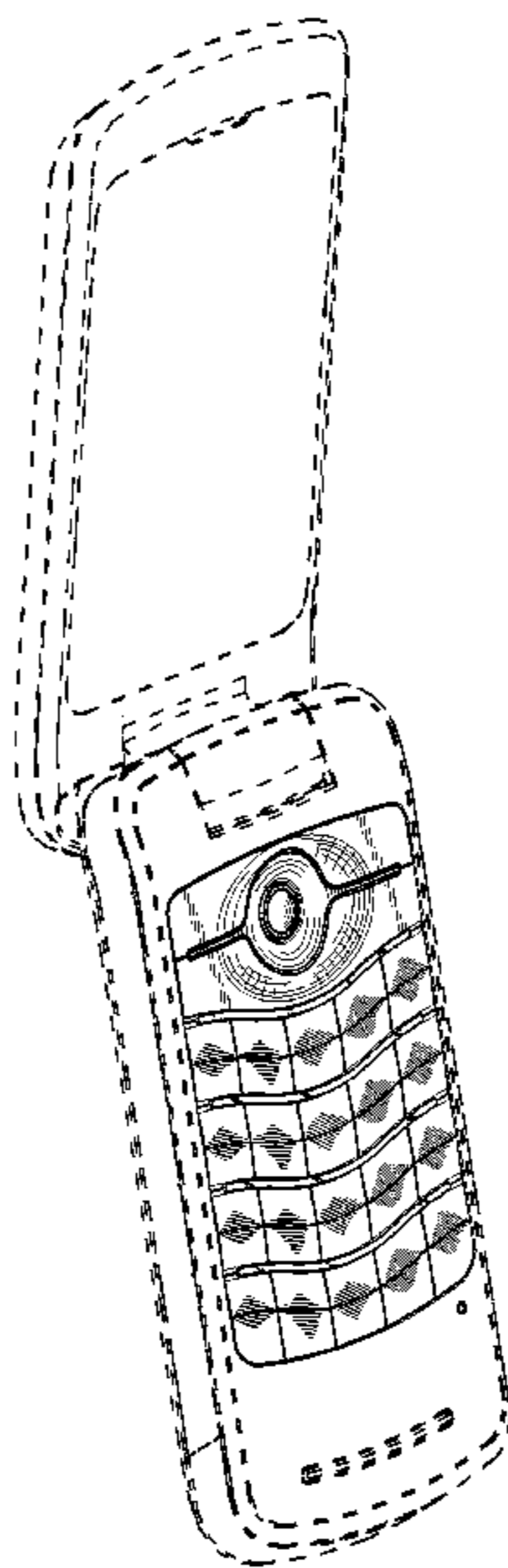
DESCRIPTION

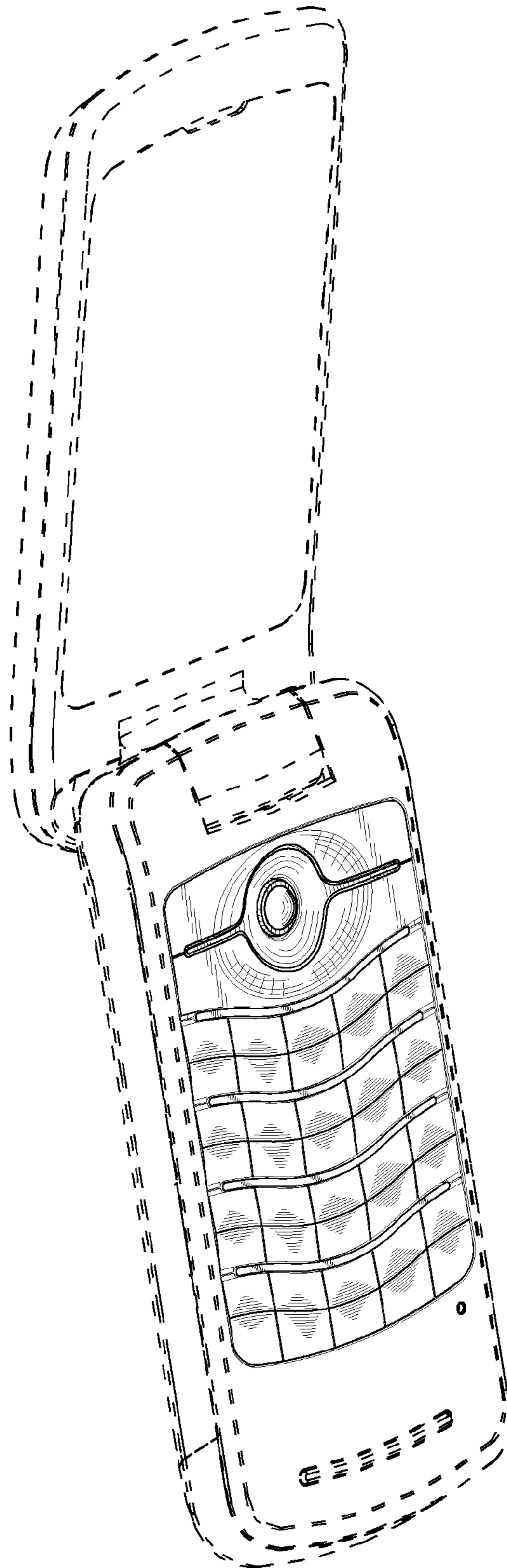

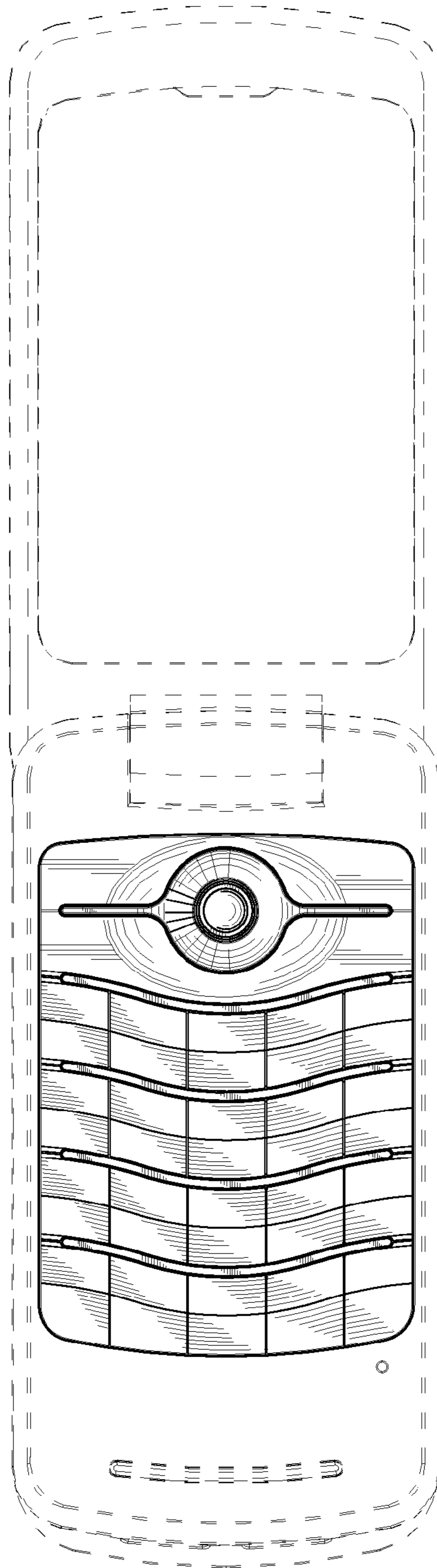
