(57) **CLAIM**

We claim the ornamental design for a display board, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a display board of the present invention.

FIG. 4 a top view of the display board of FIG. 1.

FIG. 5 is a bottom view of the display board of FIG. 1.

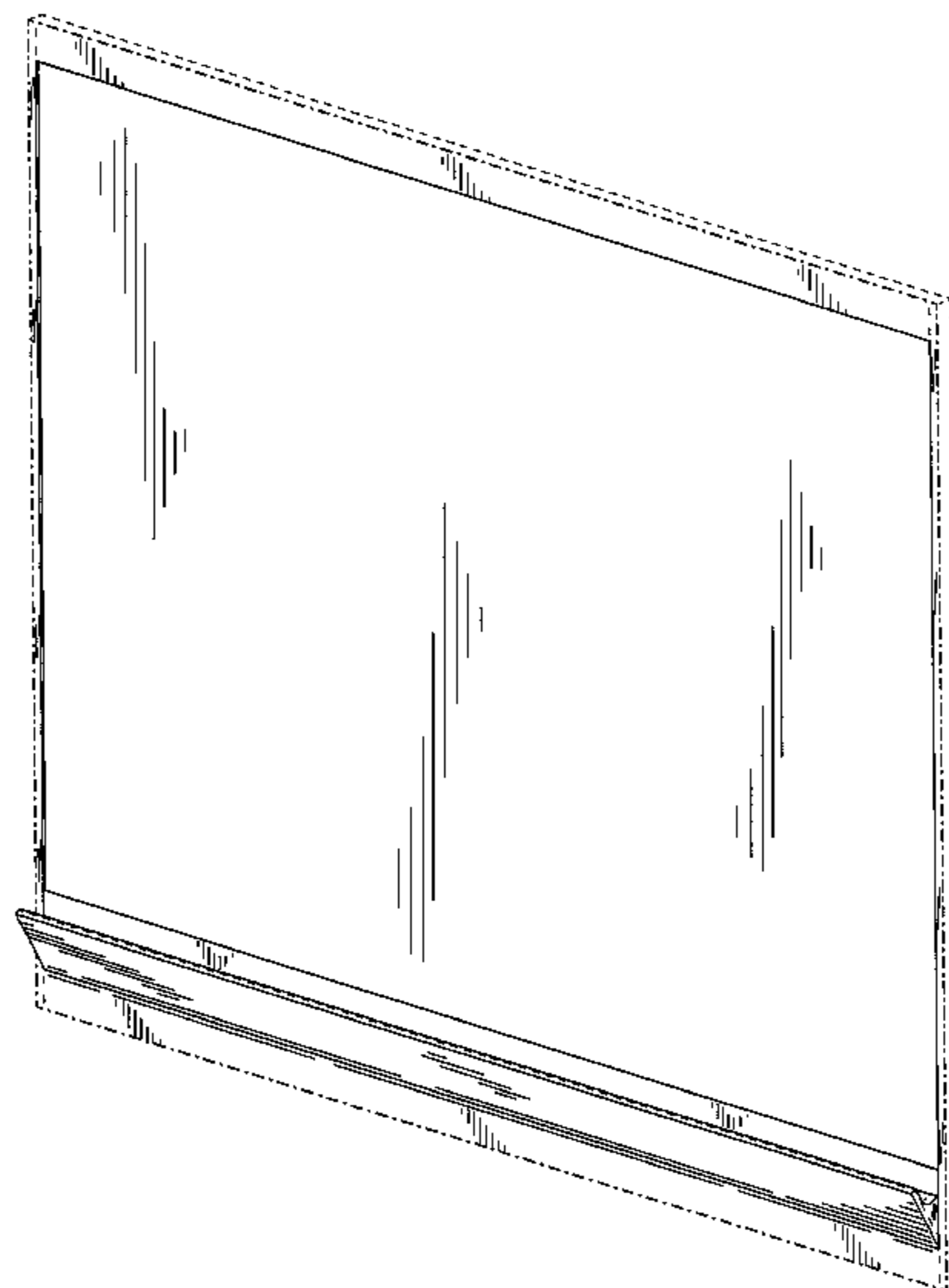
FIG. 6 is a front view of the display board of FIG. 1; and,

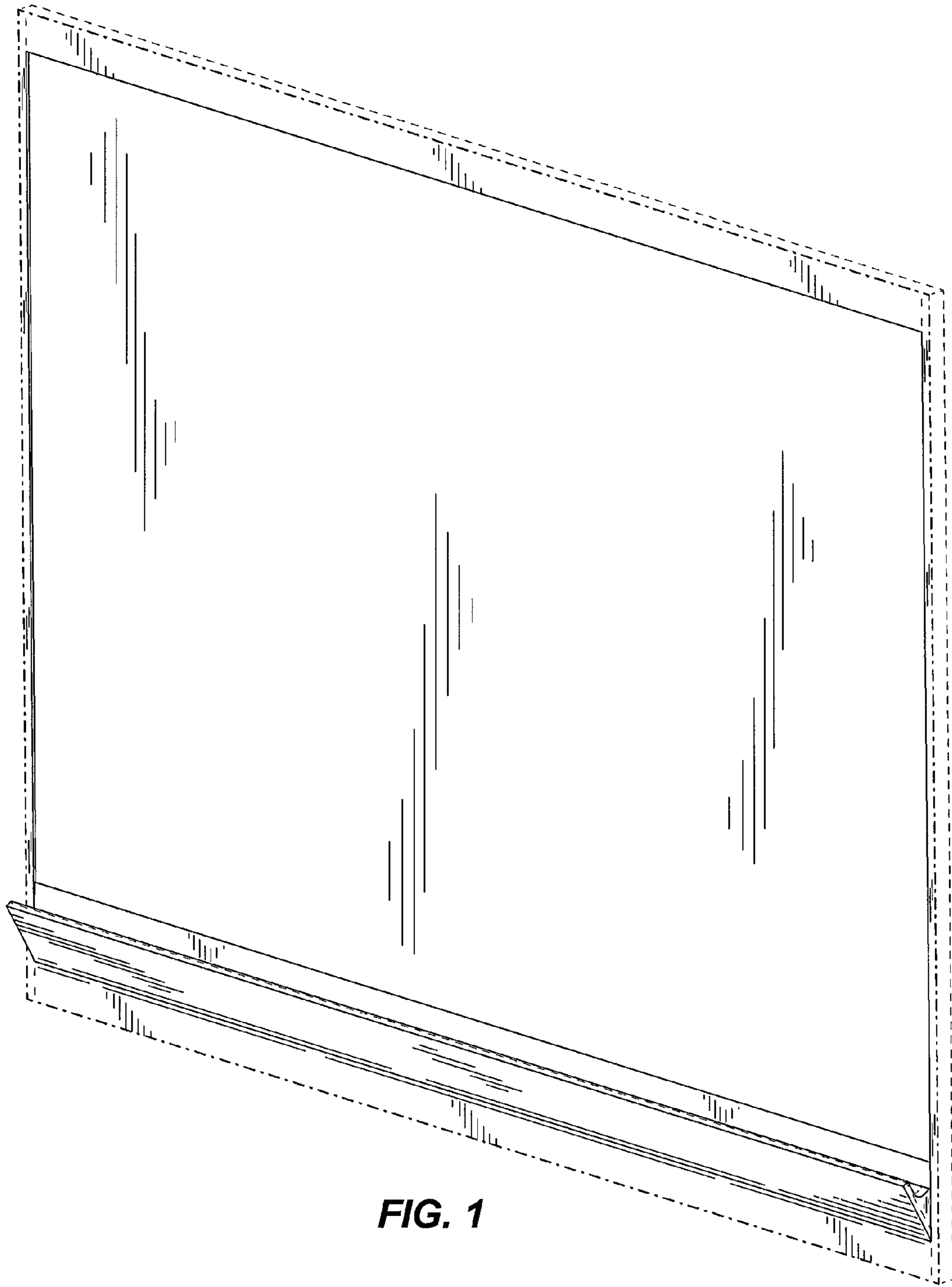

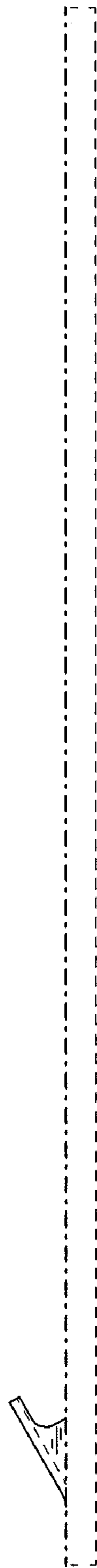

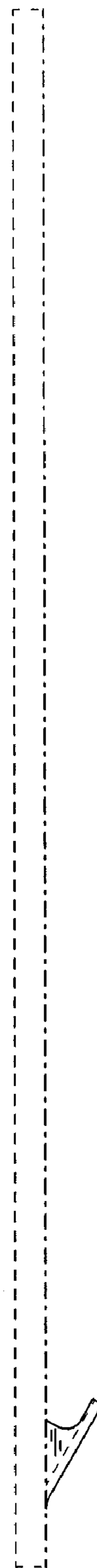

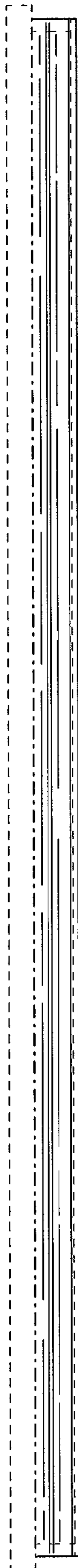

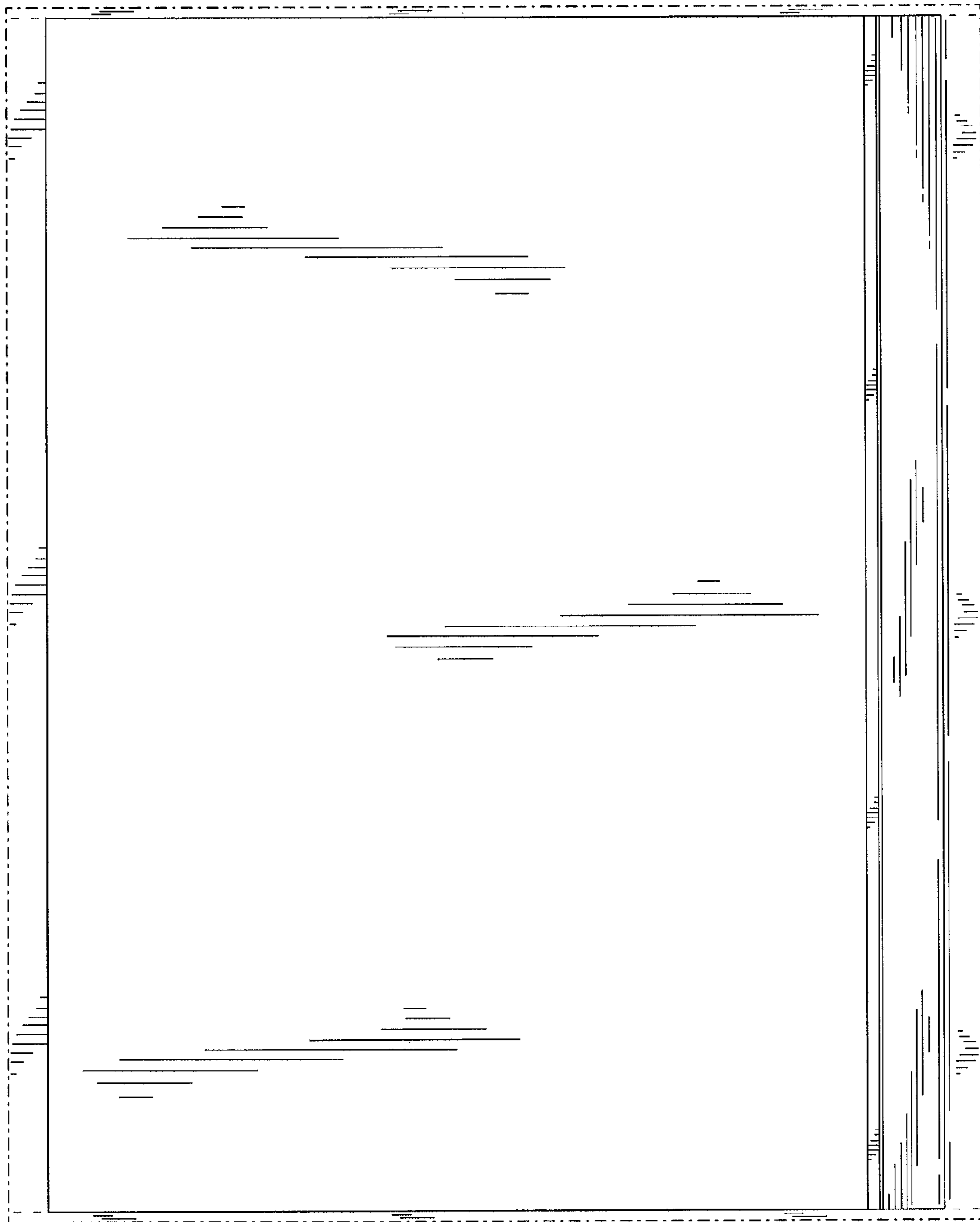

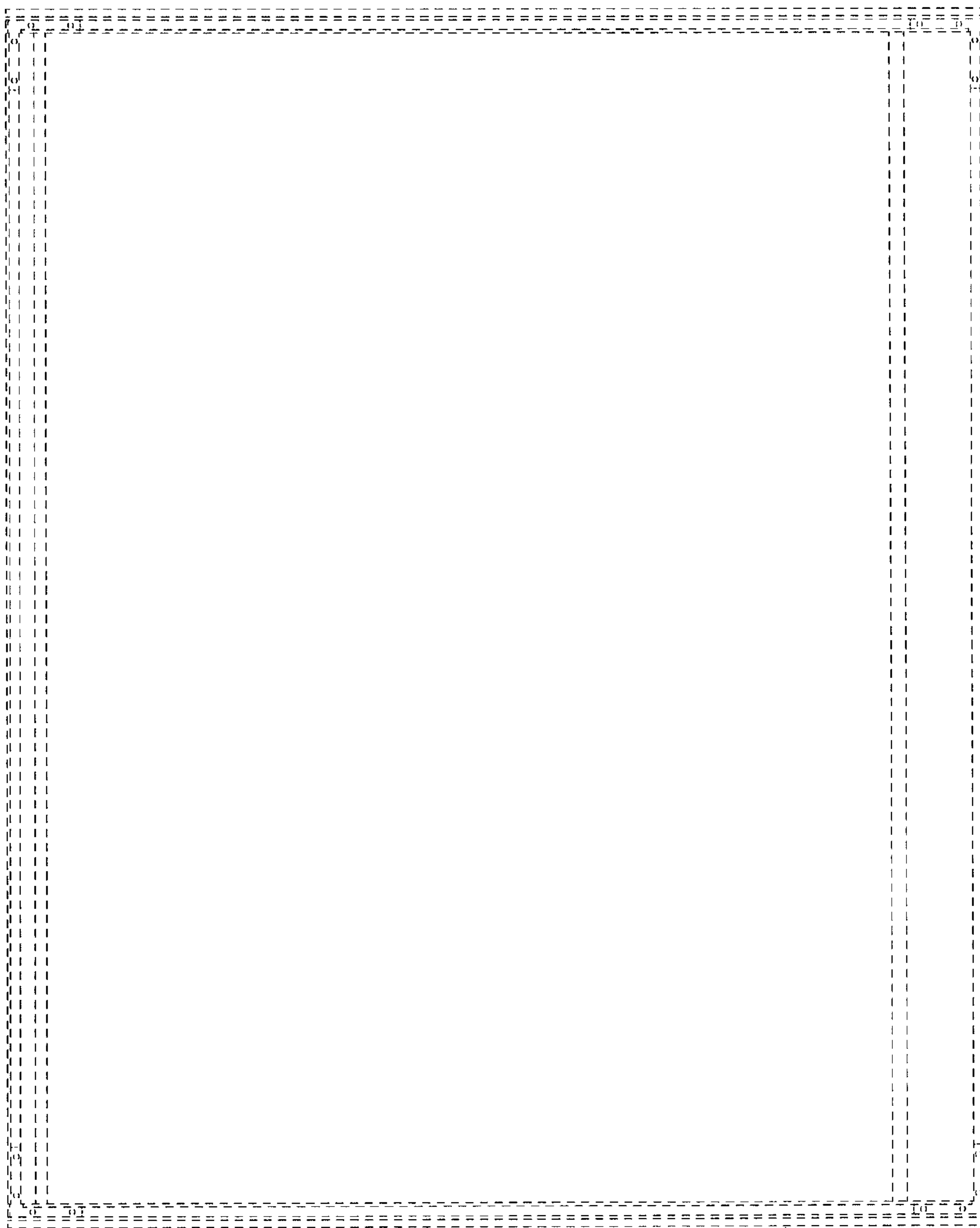
