The ornamental design for a dental tool, as shown and described.

**DESCRIPTION**

FIG. 1 is a side perspective view of a dental tool showing my new design;

FIG. 2 is a side elevation of the dental tool, as shown in FIG. 1;

FIG. 3 is a side elevation of the dental tool, opposite the side elevation shown in FIG. 2;

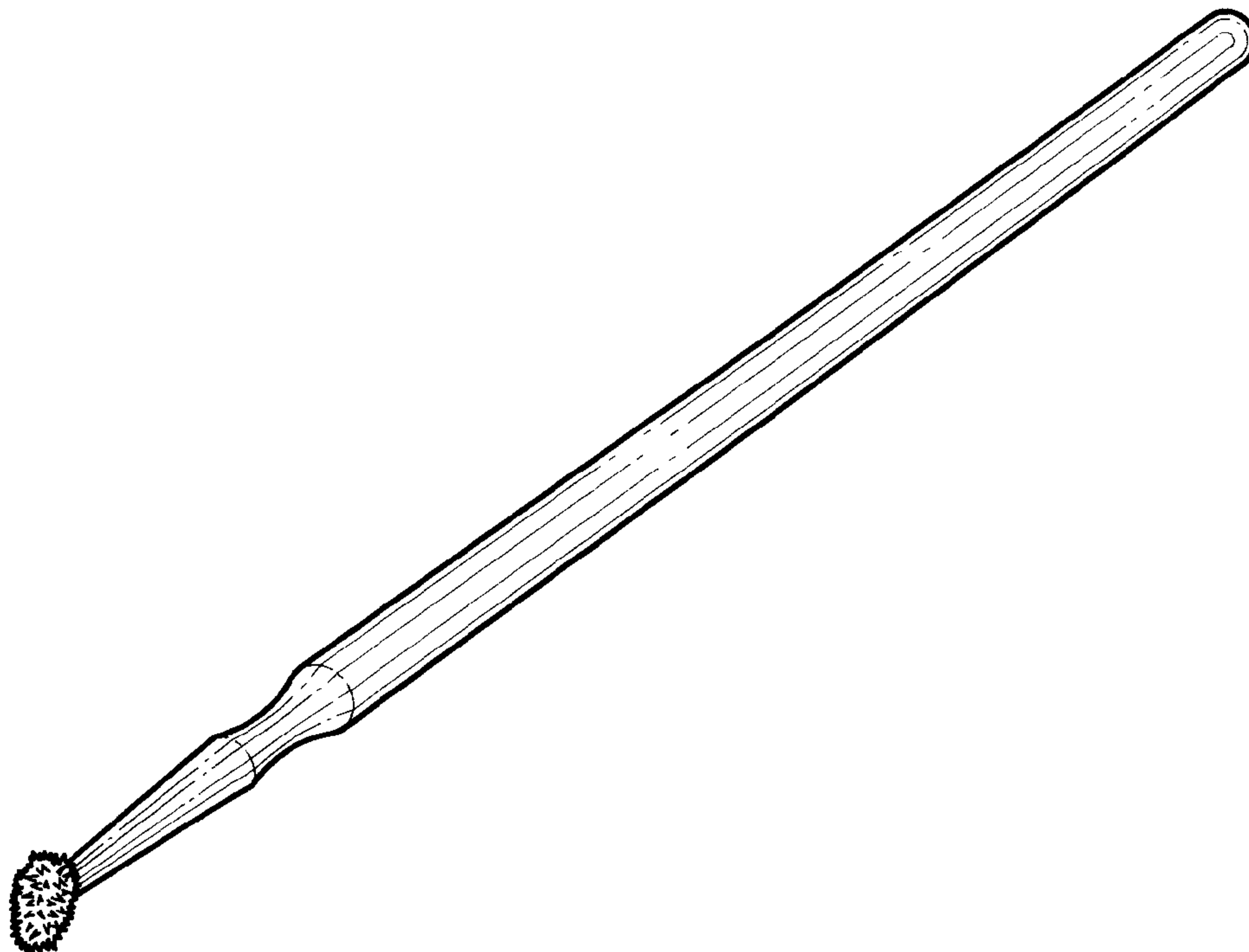
FIG. 4 is a top plan view of the dental tool, as shown in FIG. 1;

FIG. 5 is a bottom plan view of the dental tool, opposite the view shown in FIG. 4;

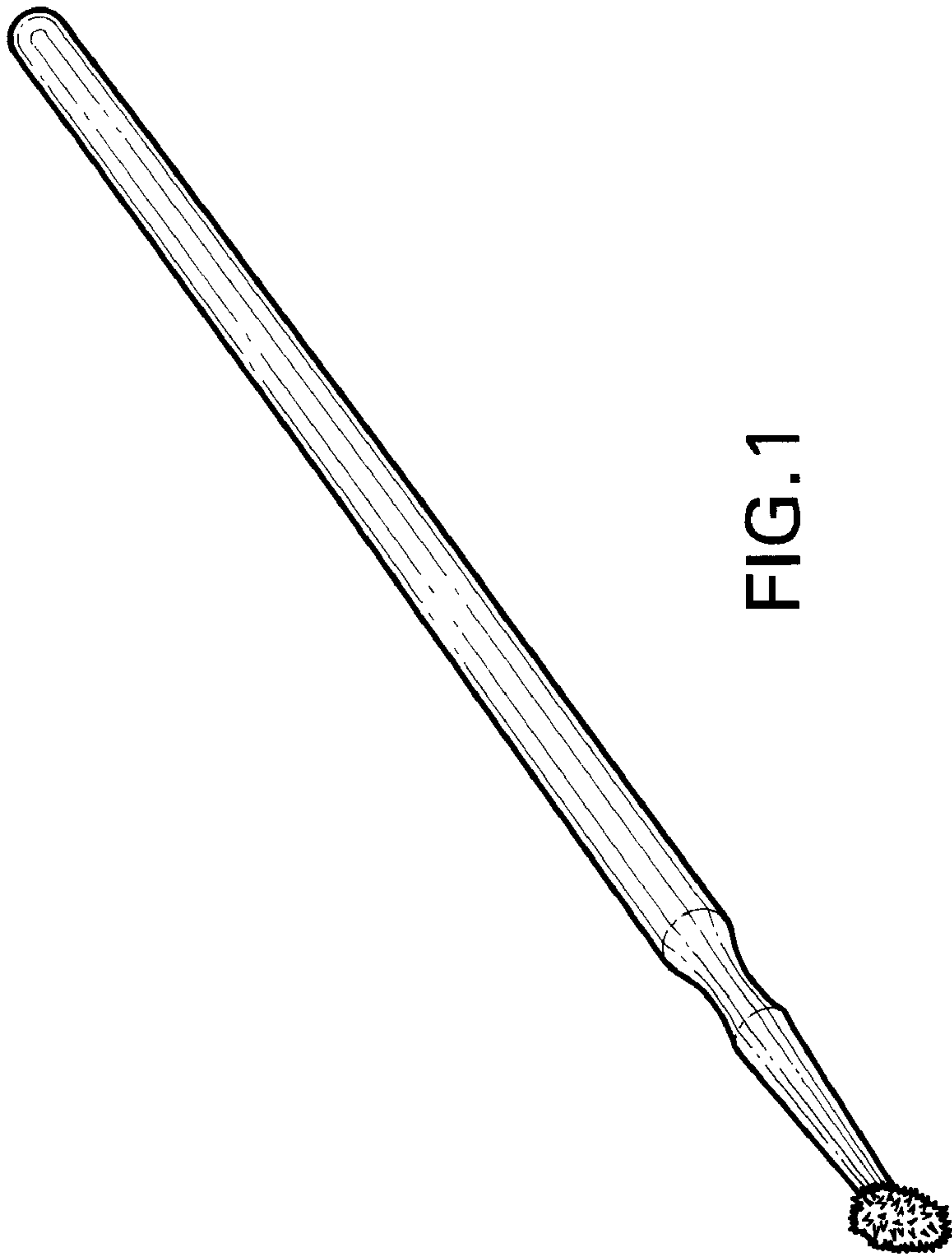

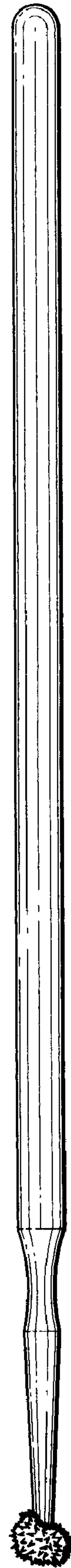

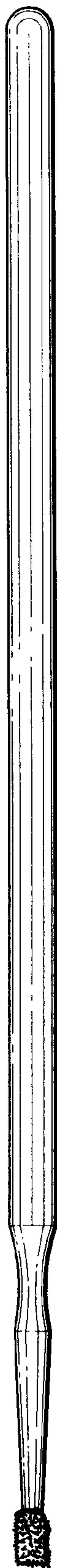
