FIG. 19 is a rear view thereof;

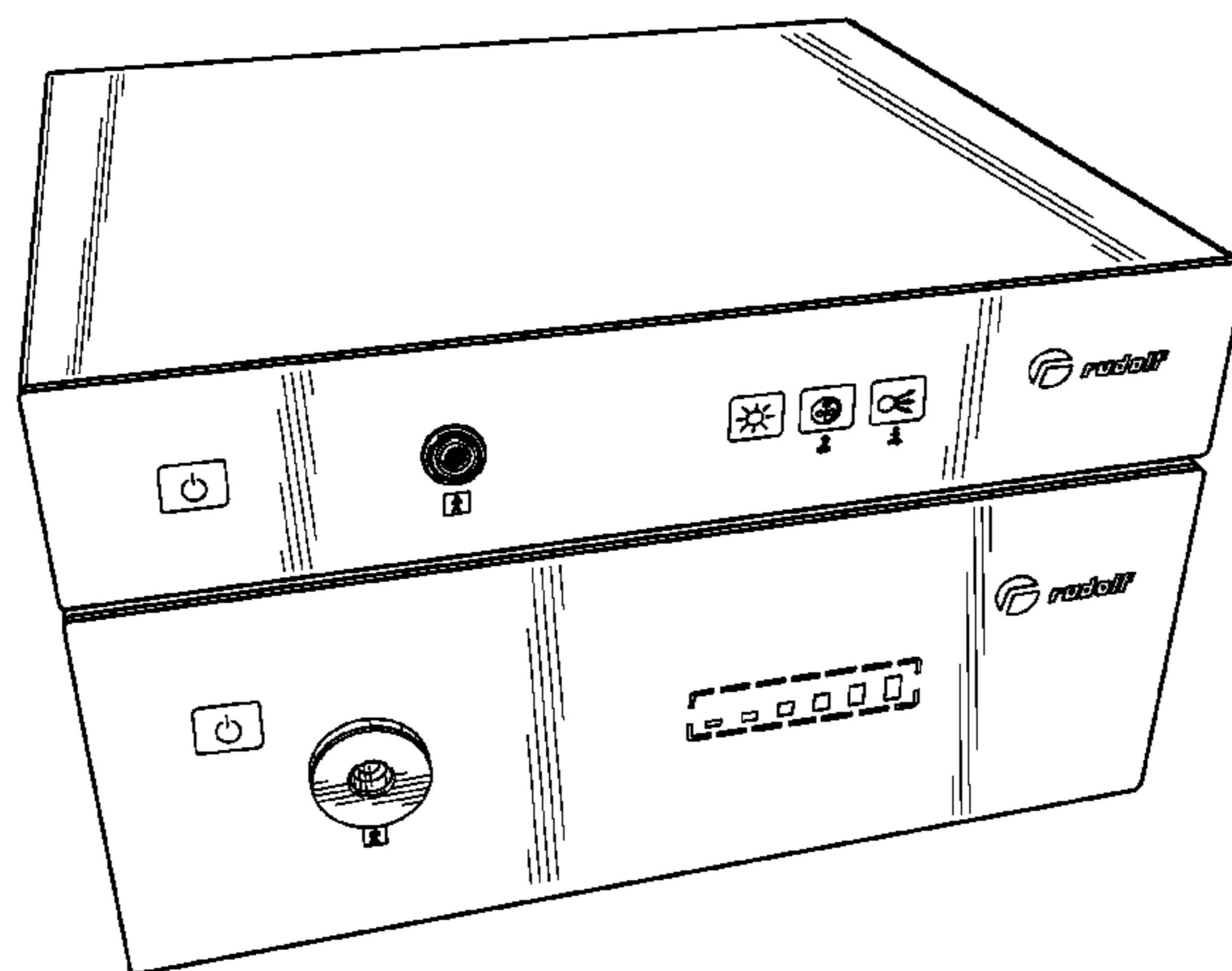
FIG. 20 is a top view thereof; and,

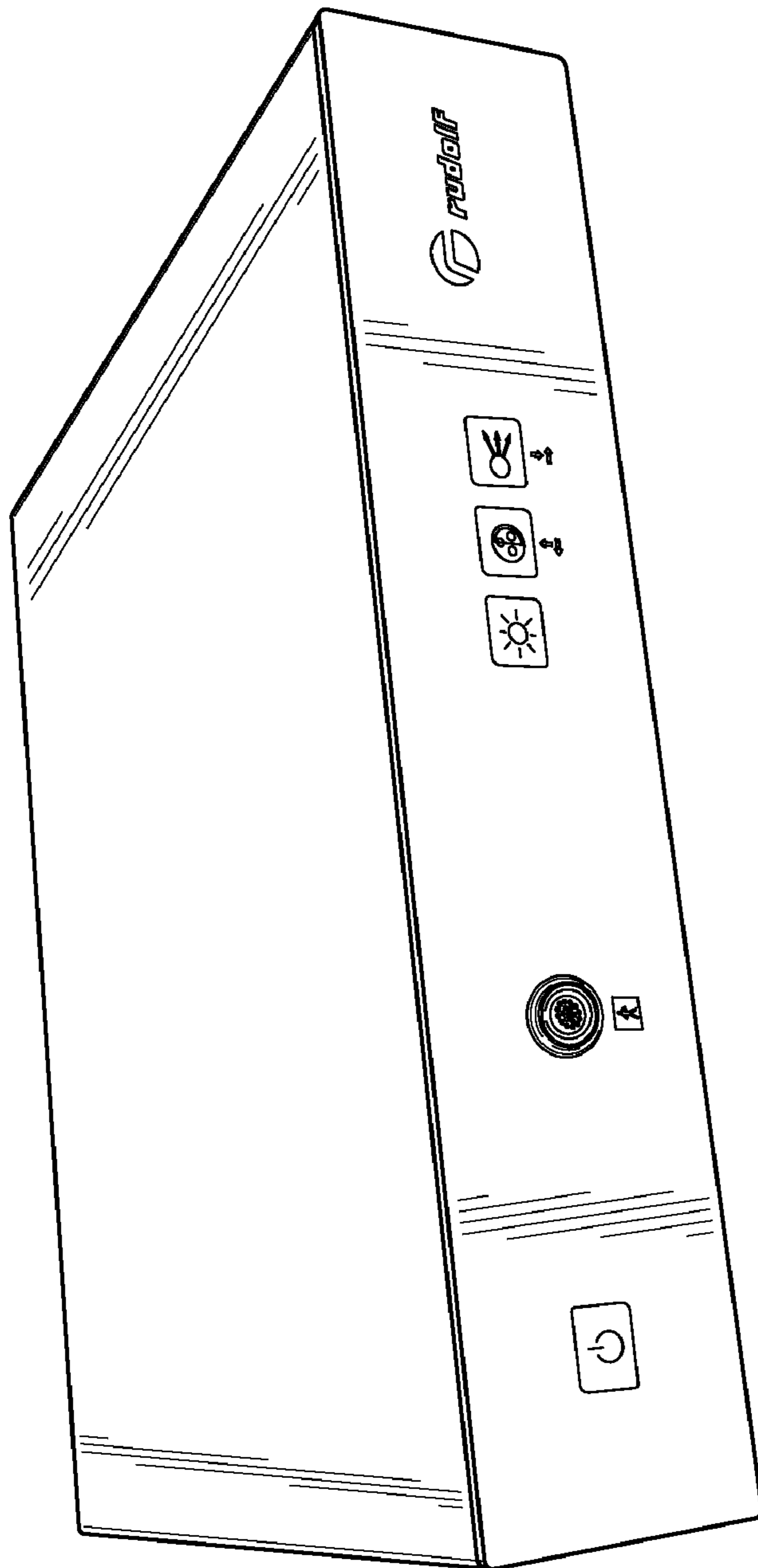

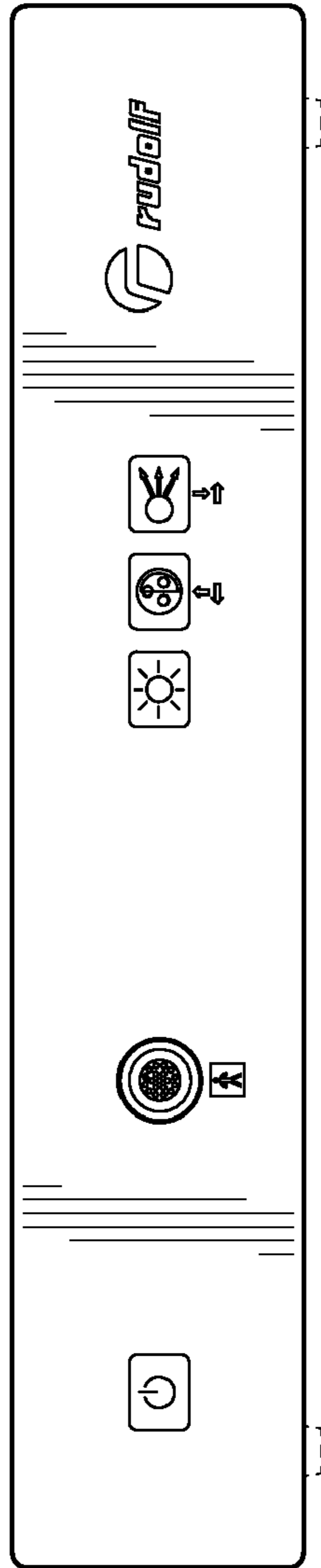

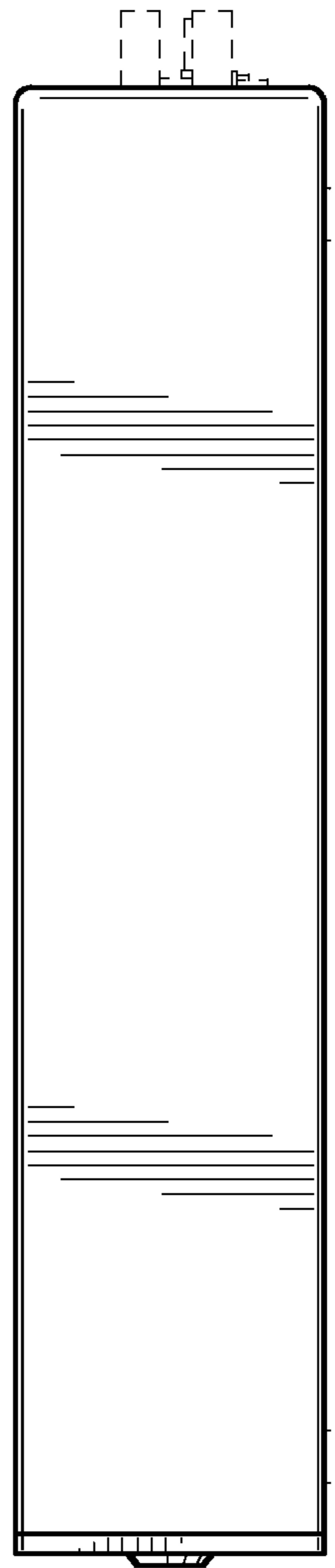

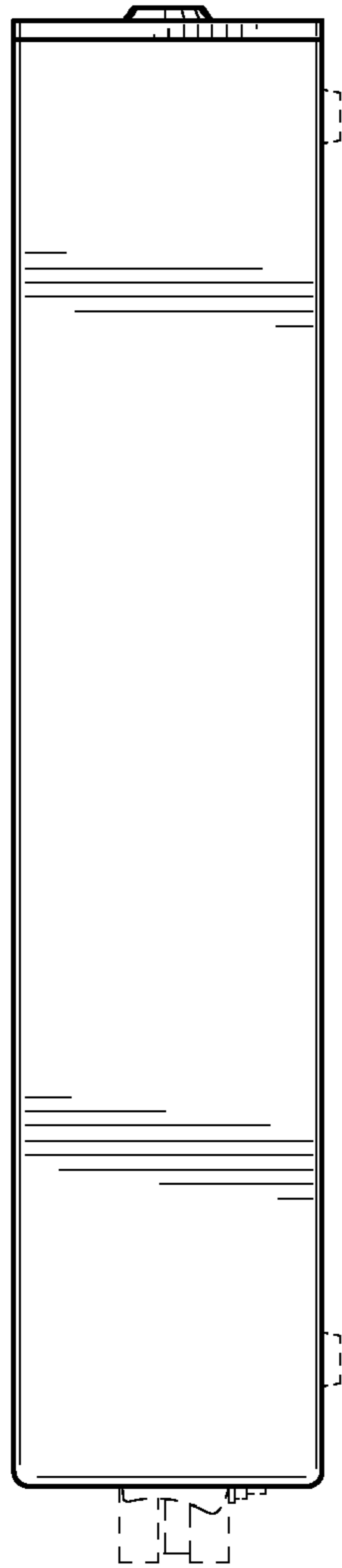

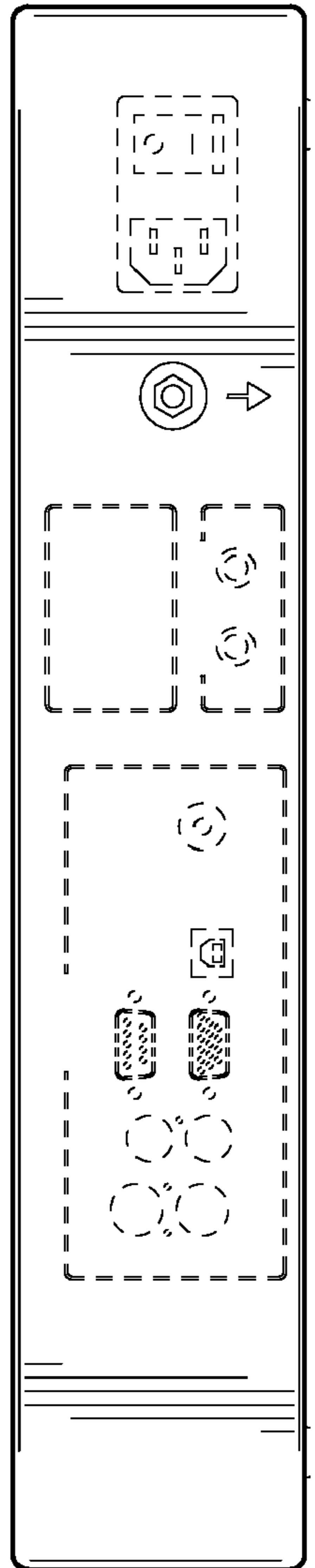

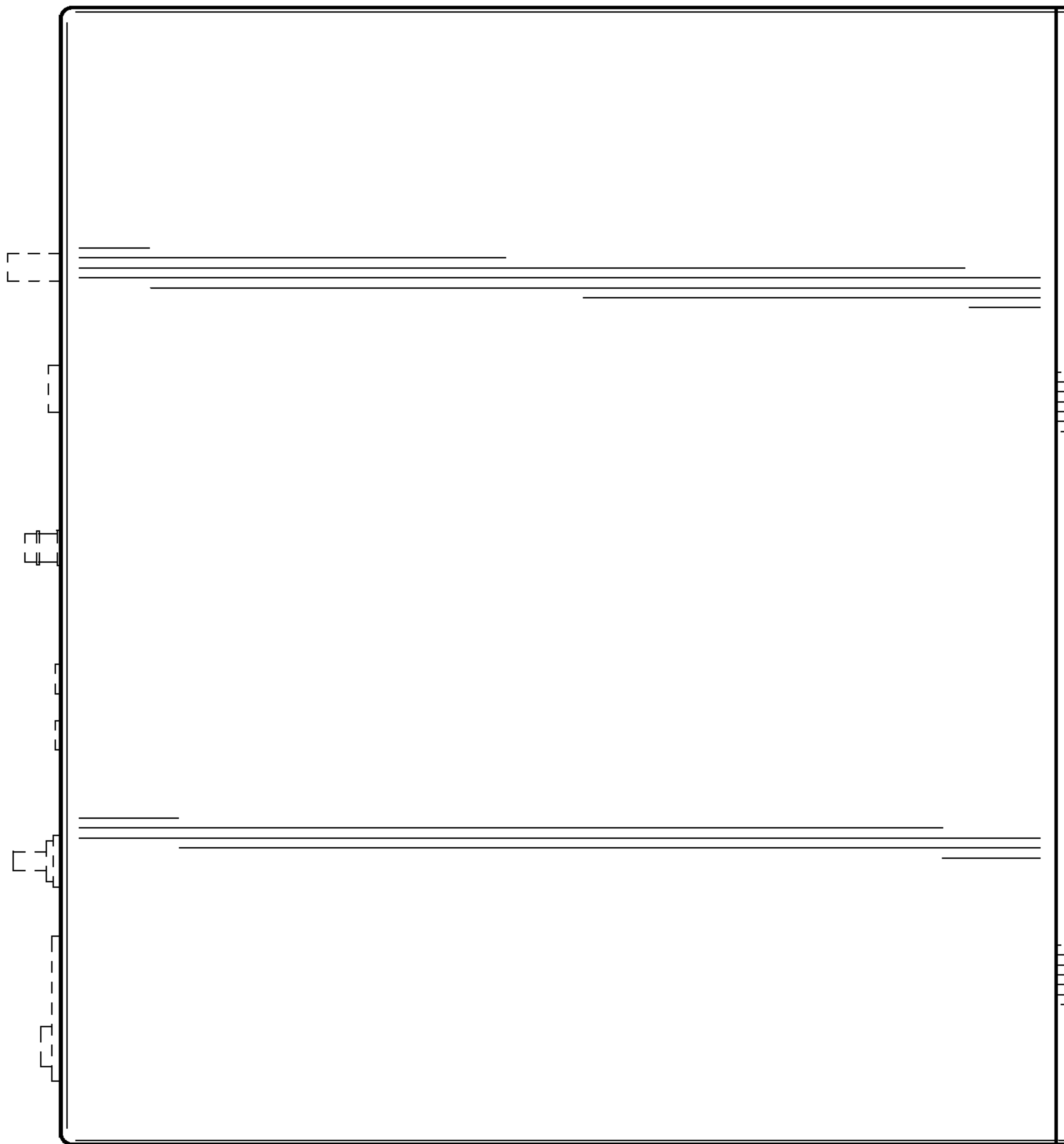

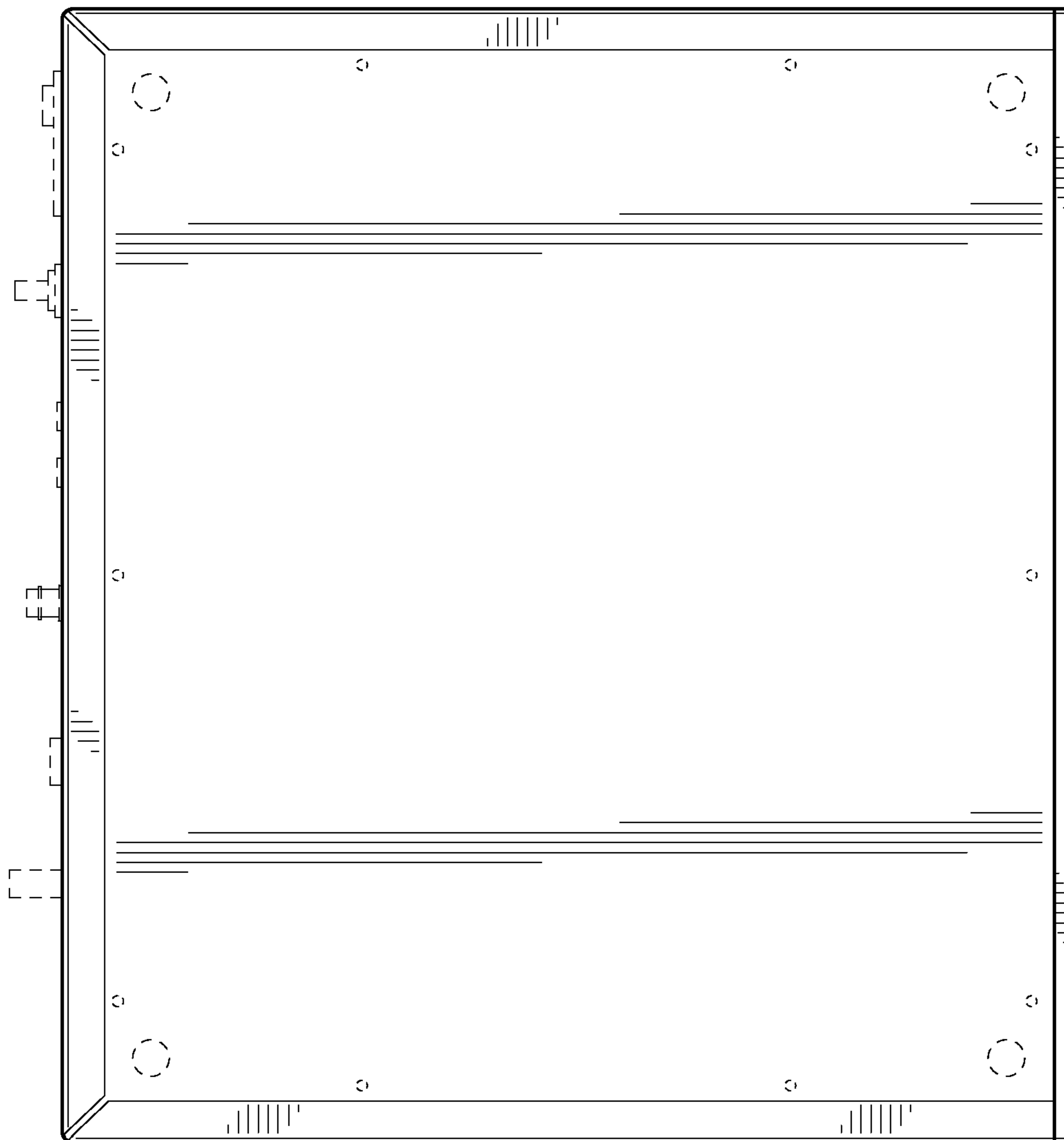

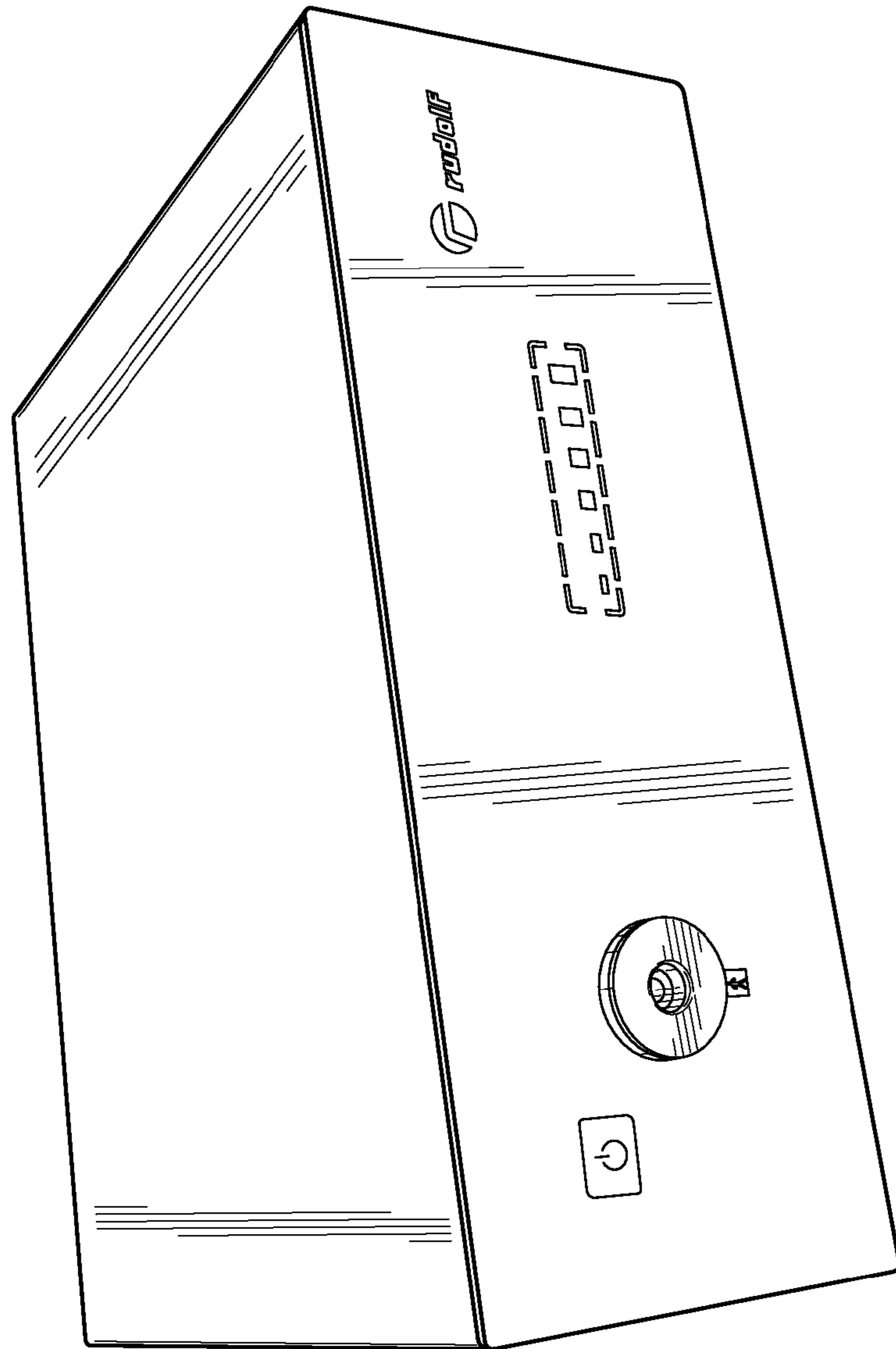

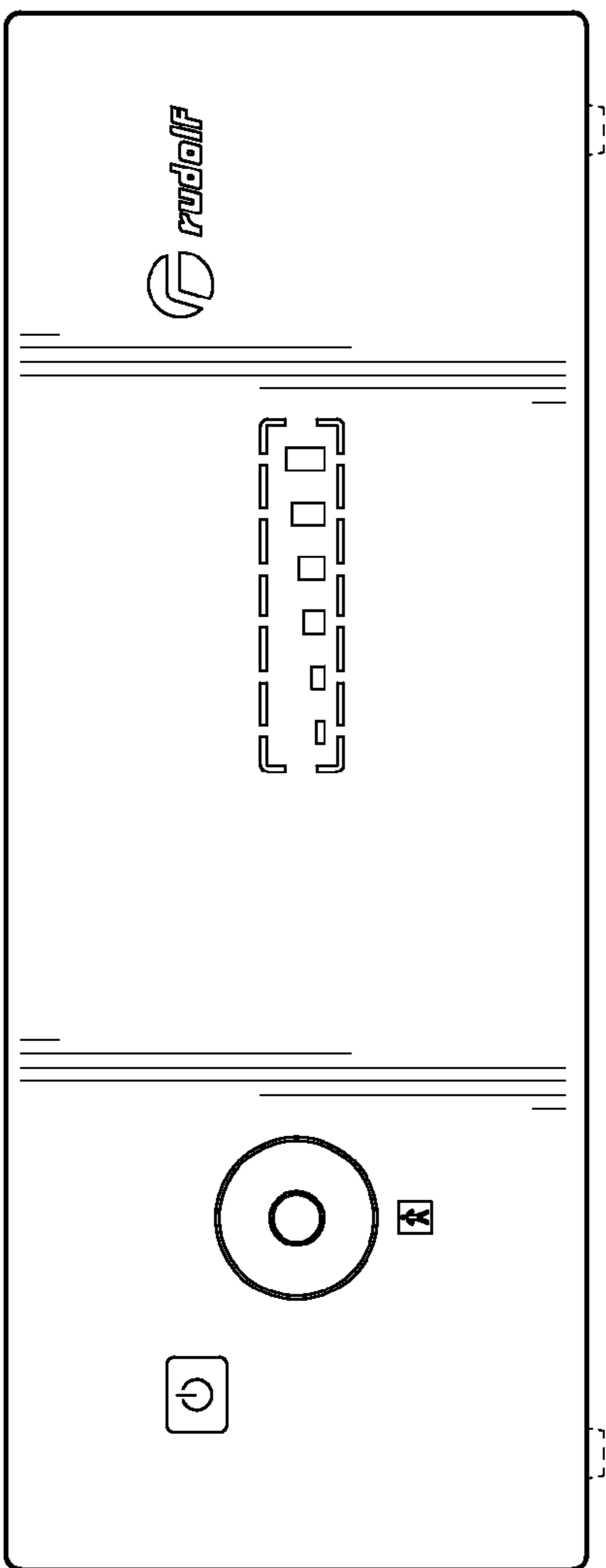

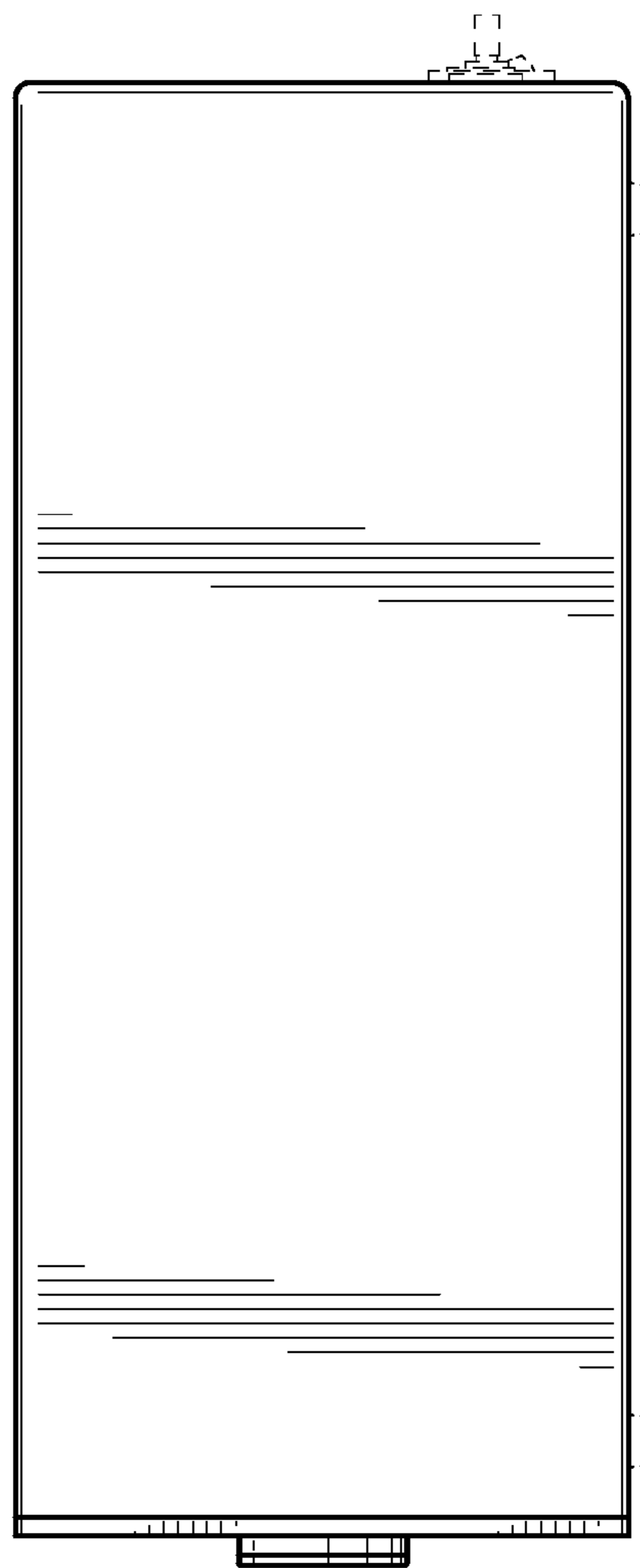

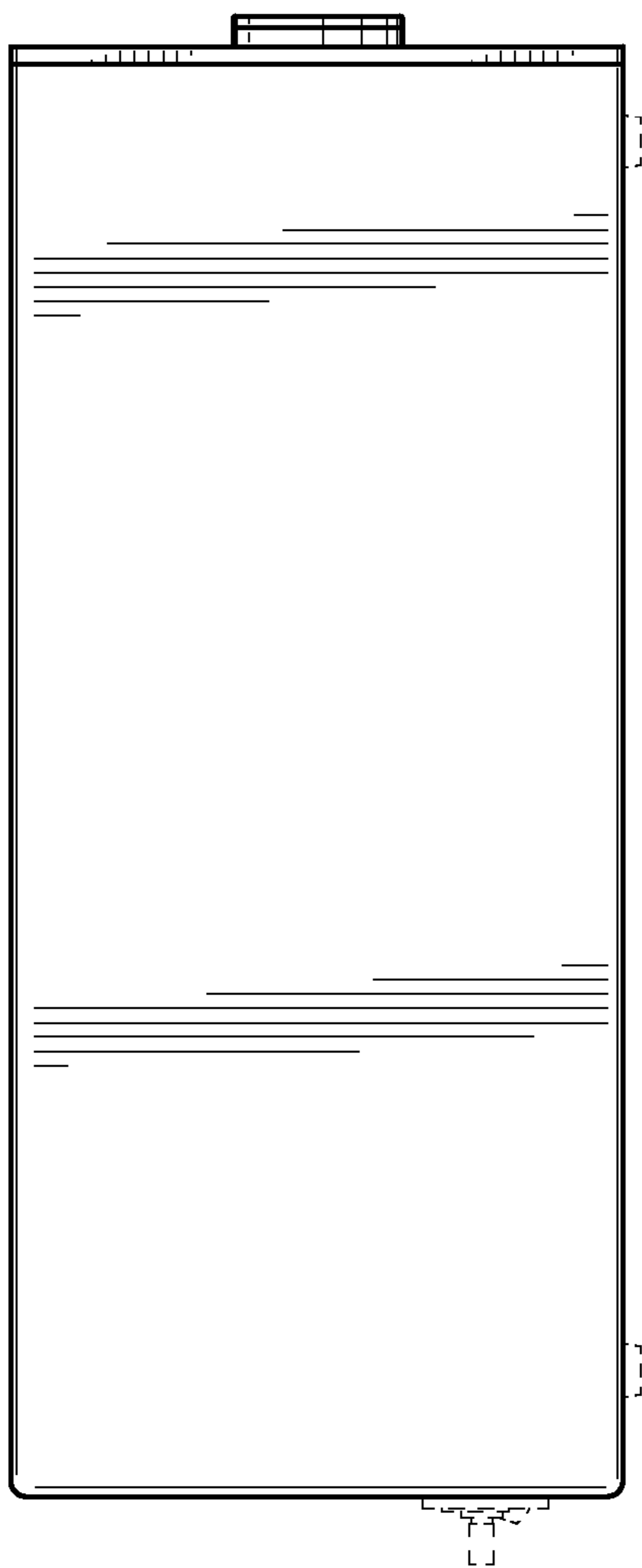

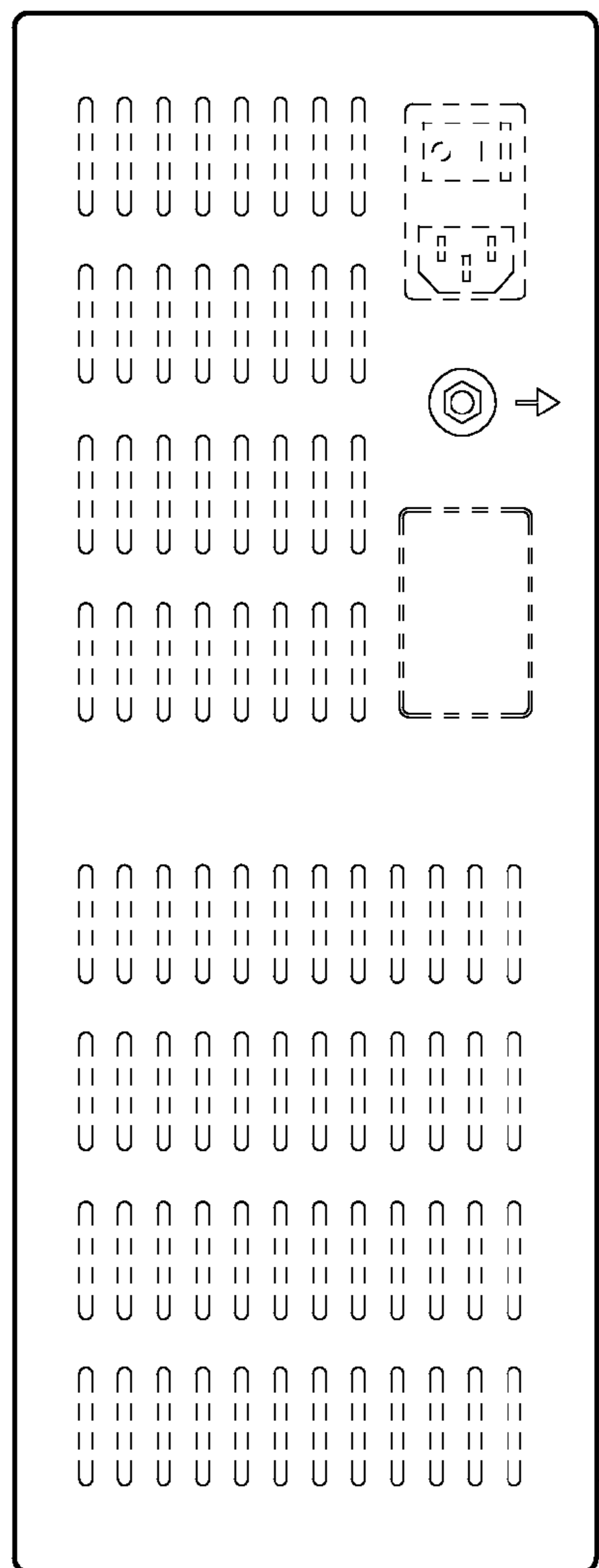

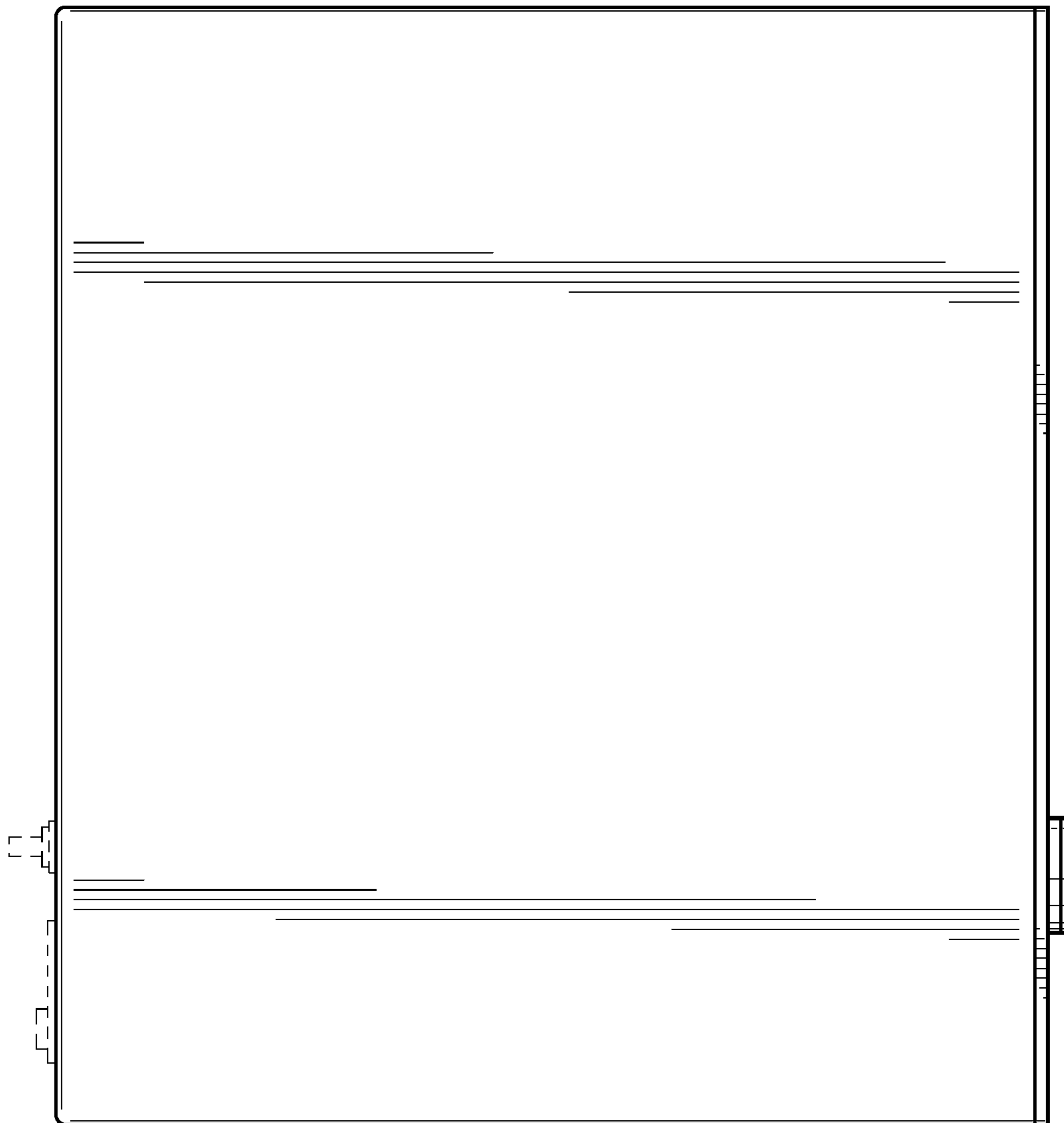

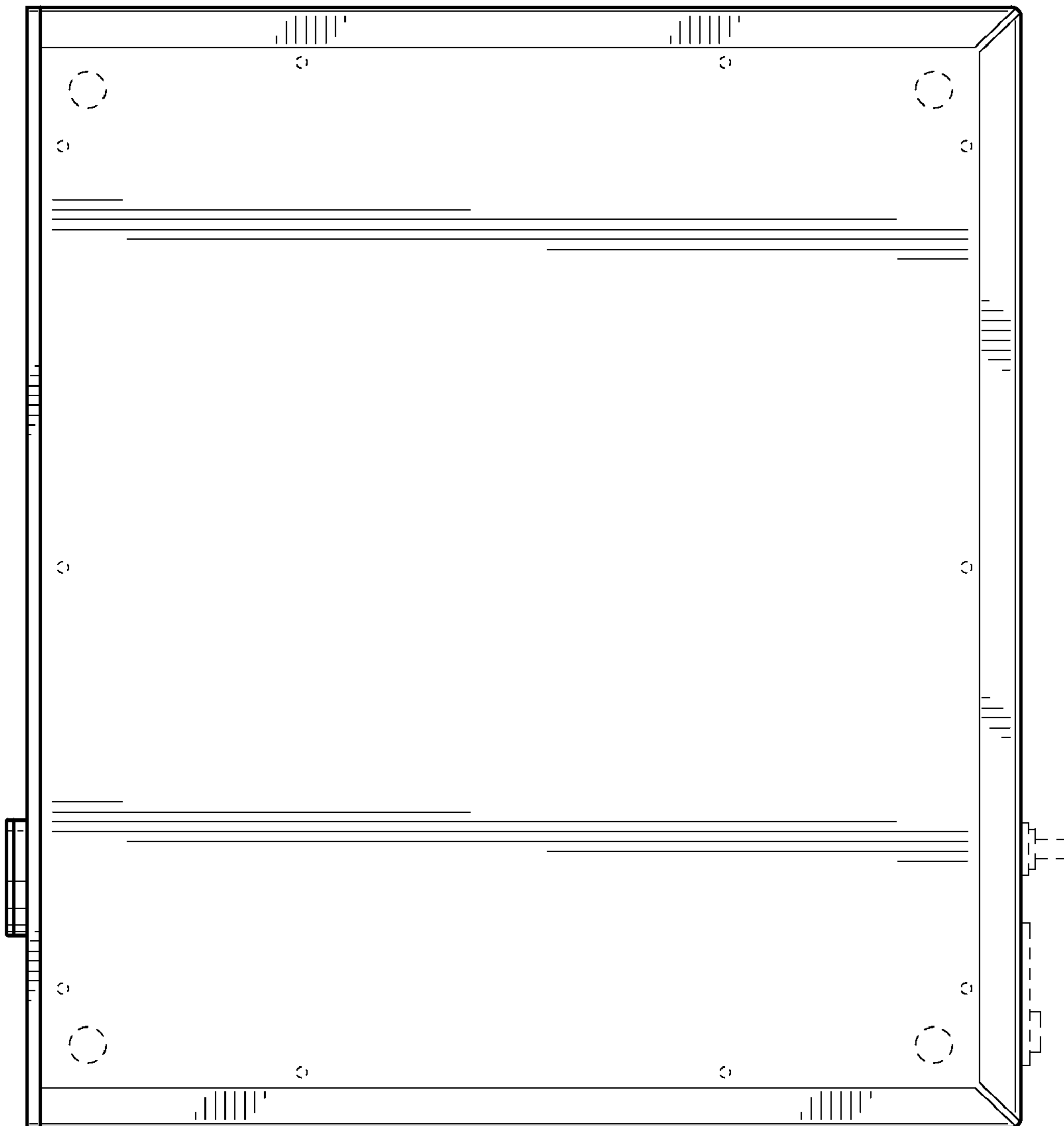

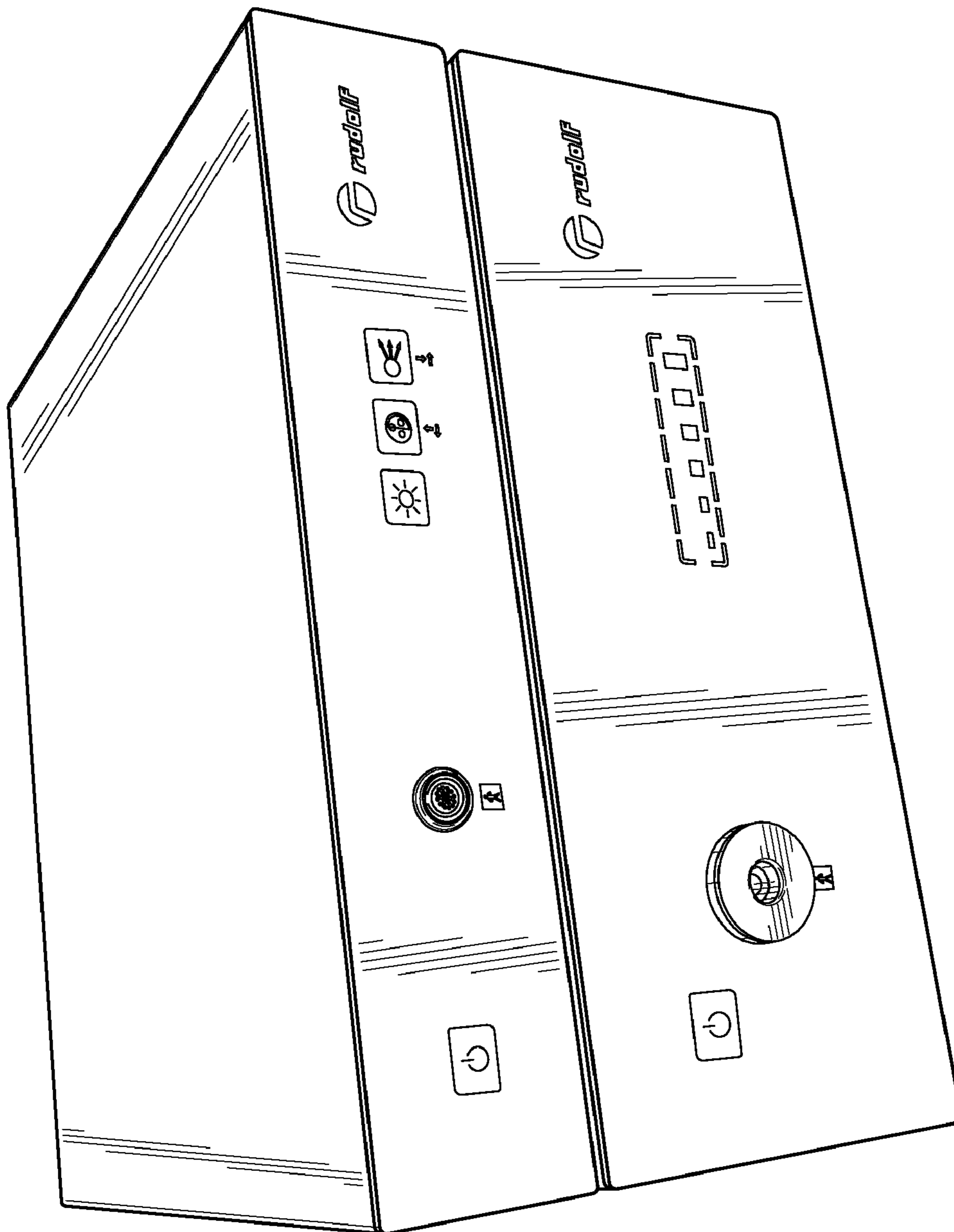

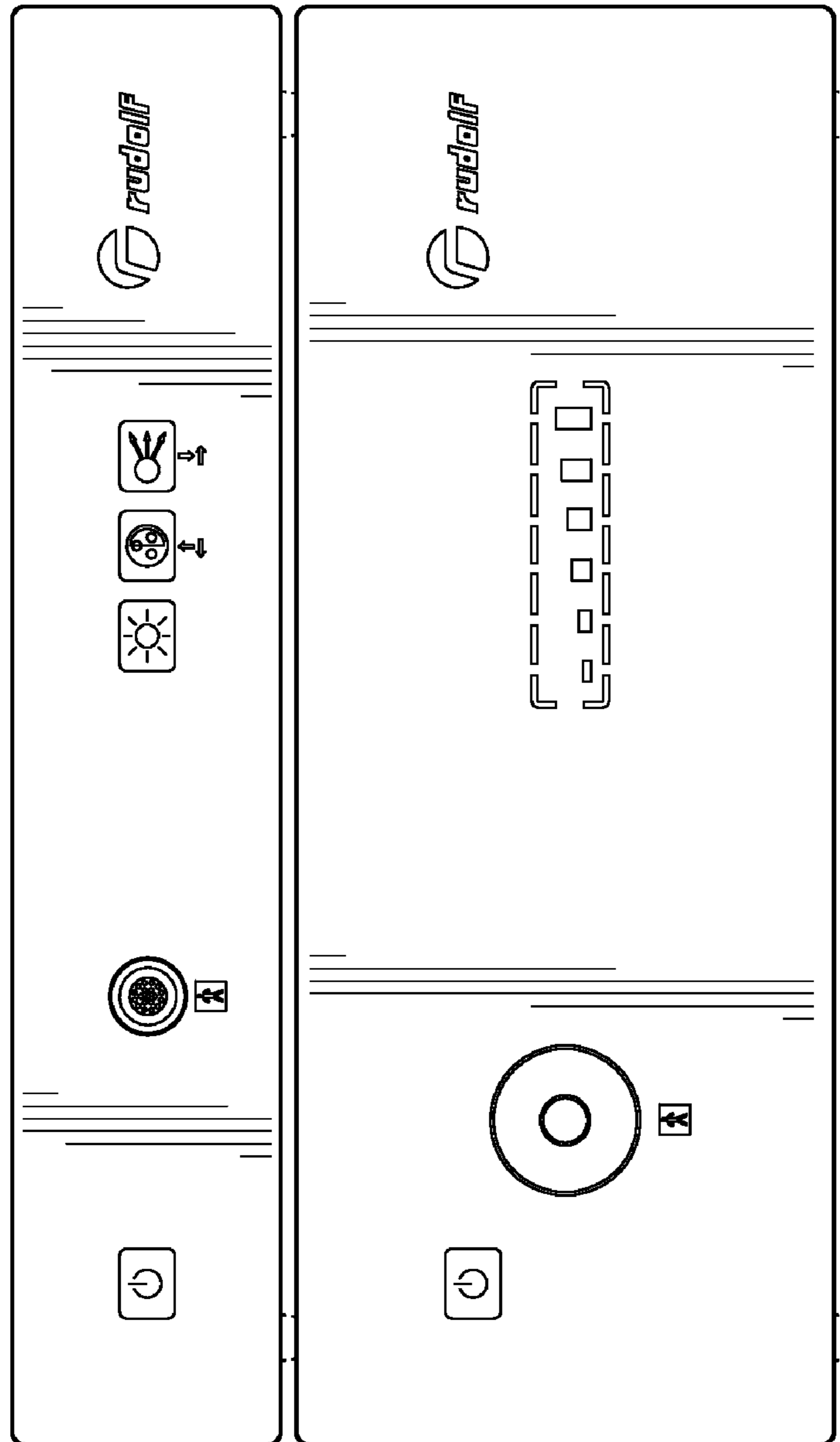

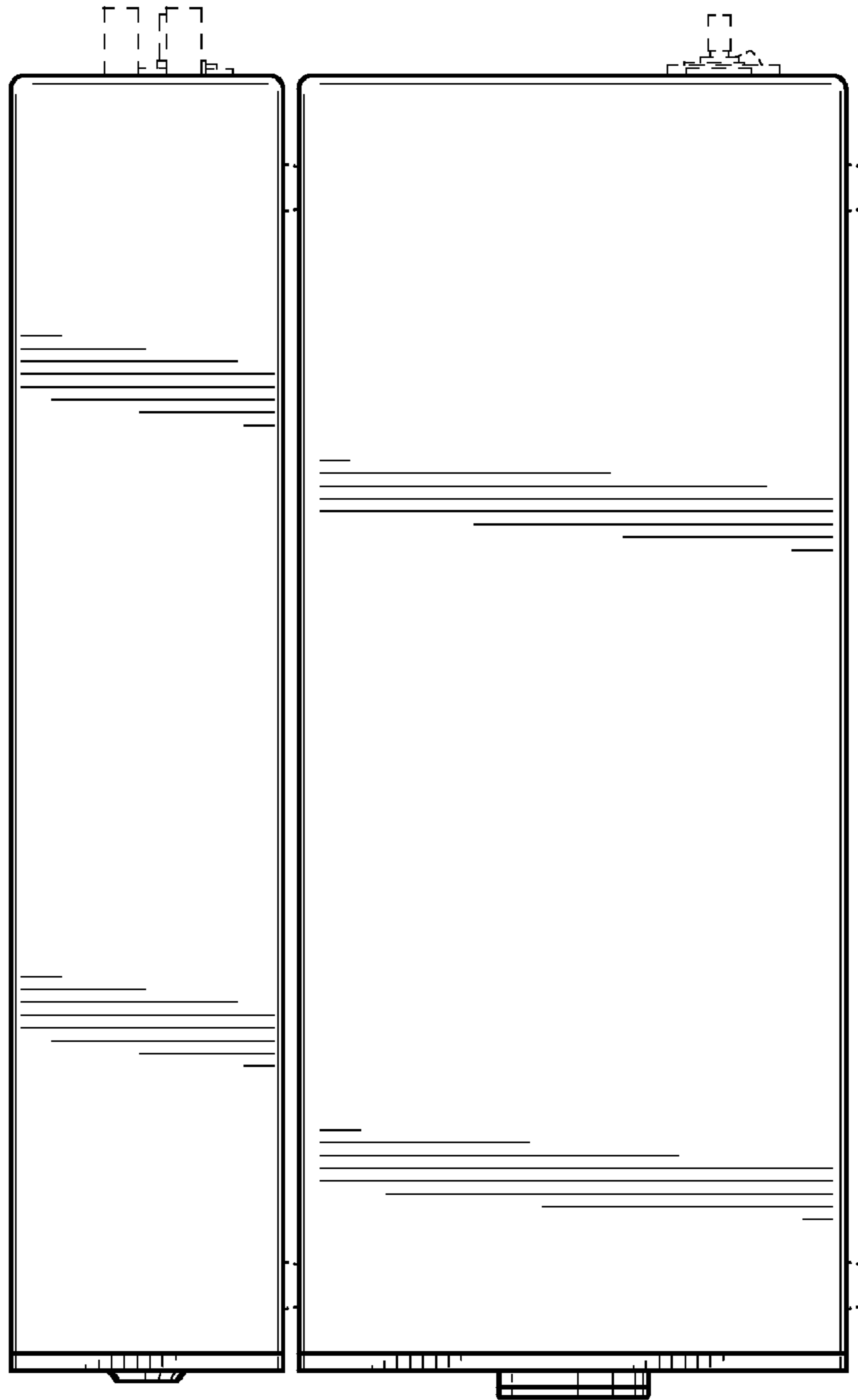

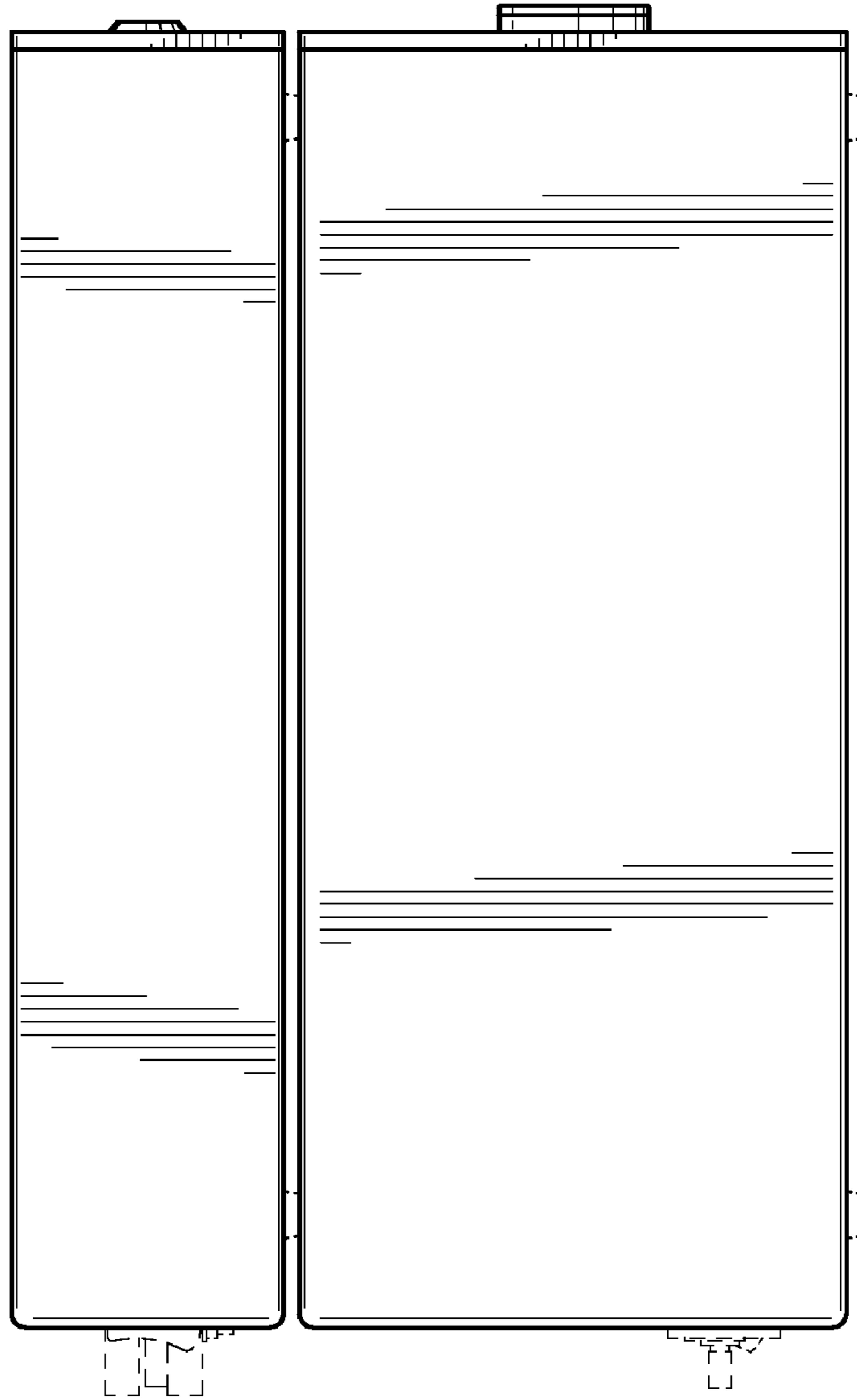

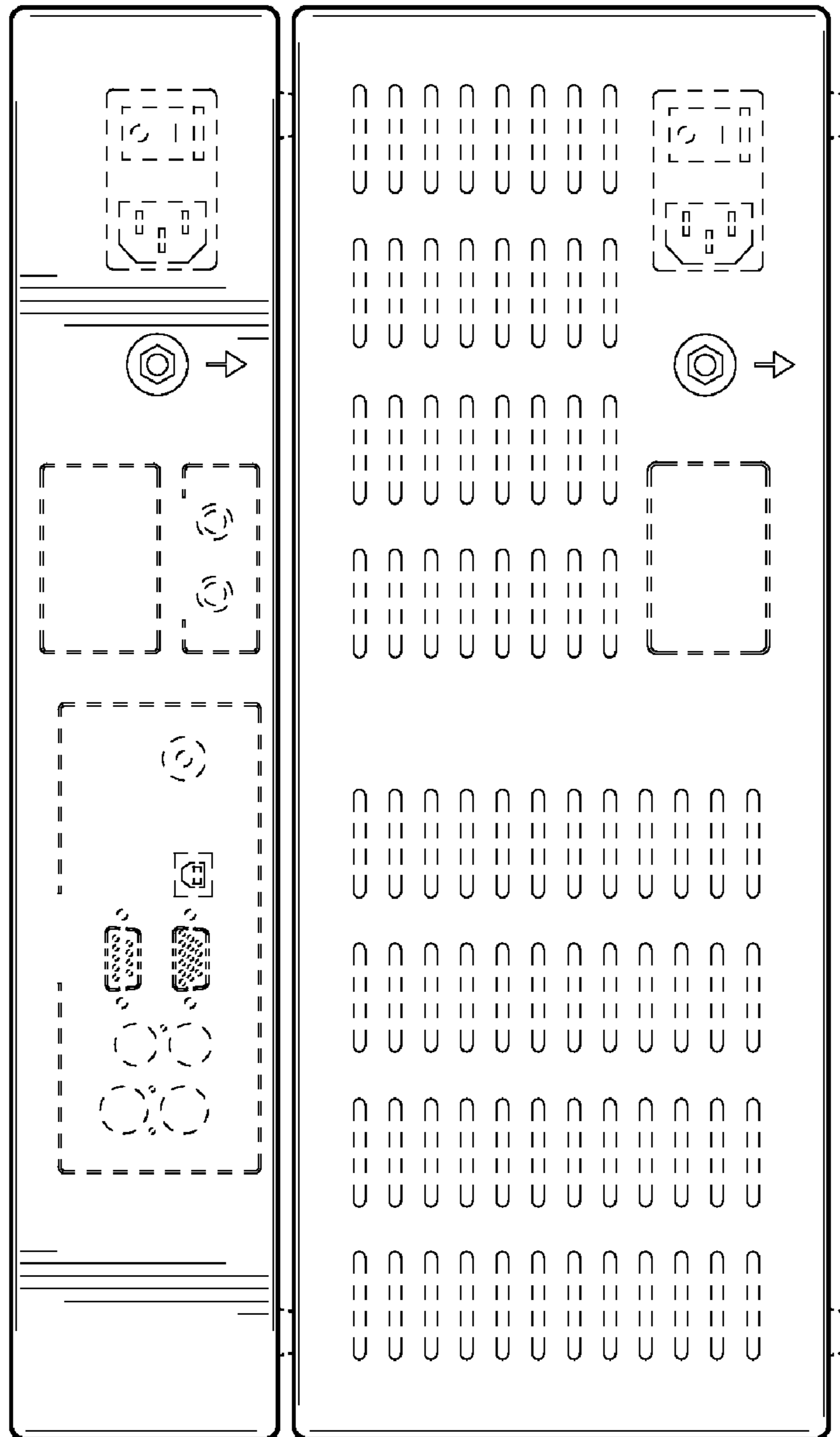

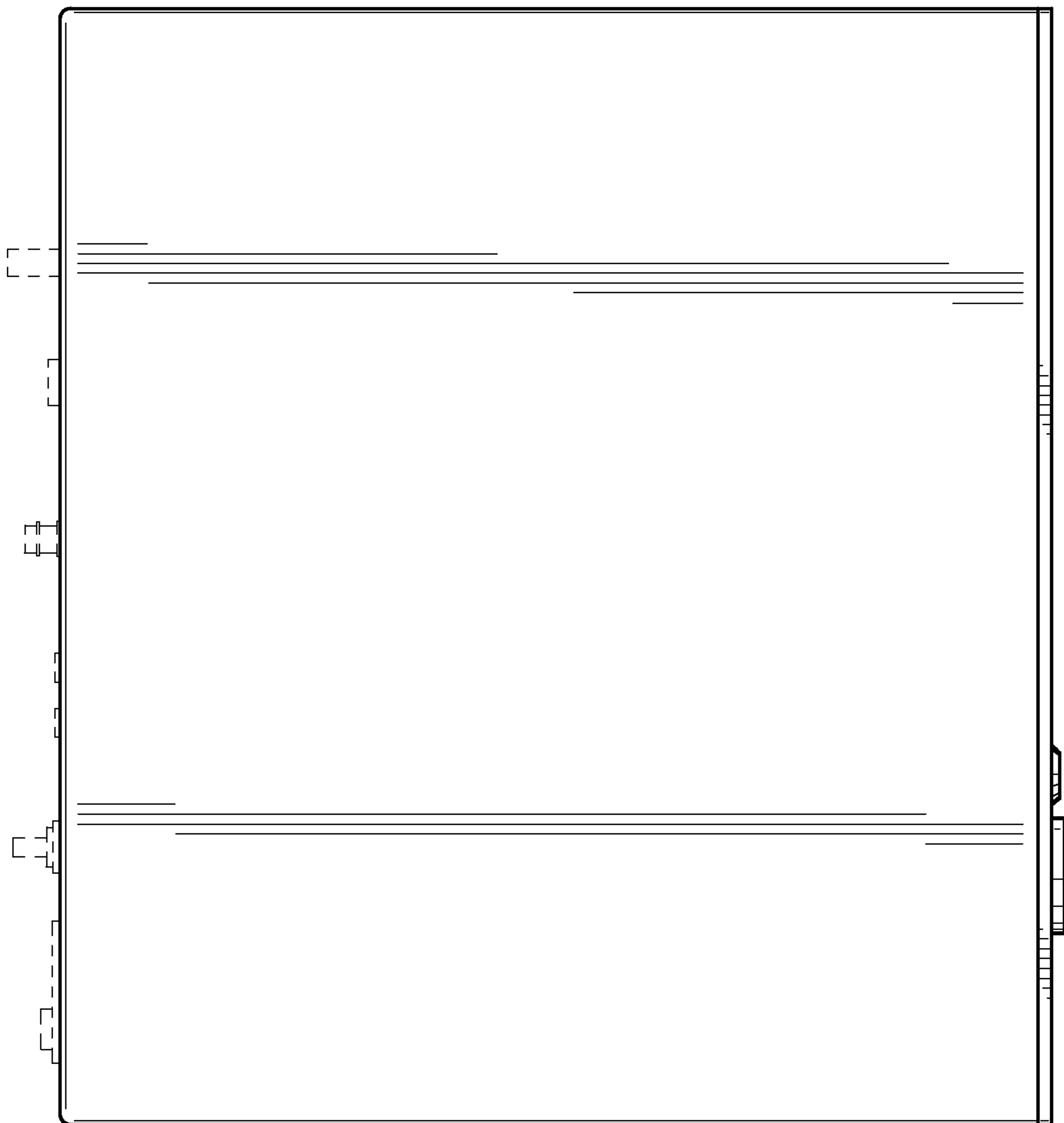

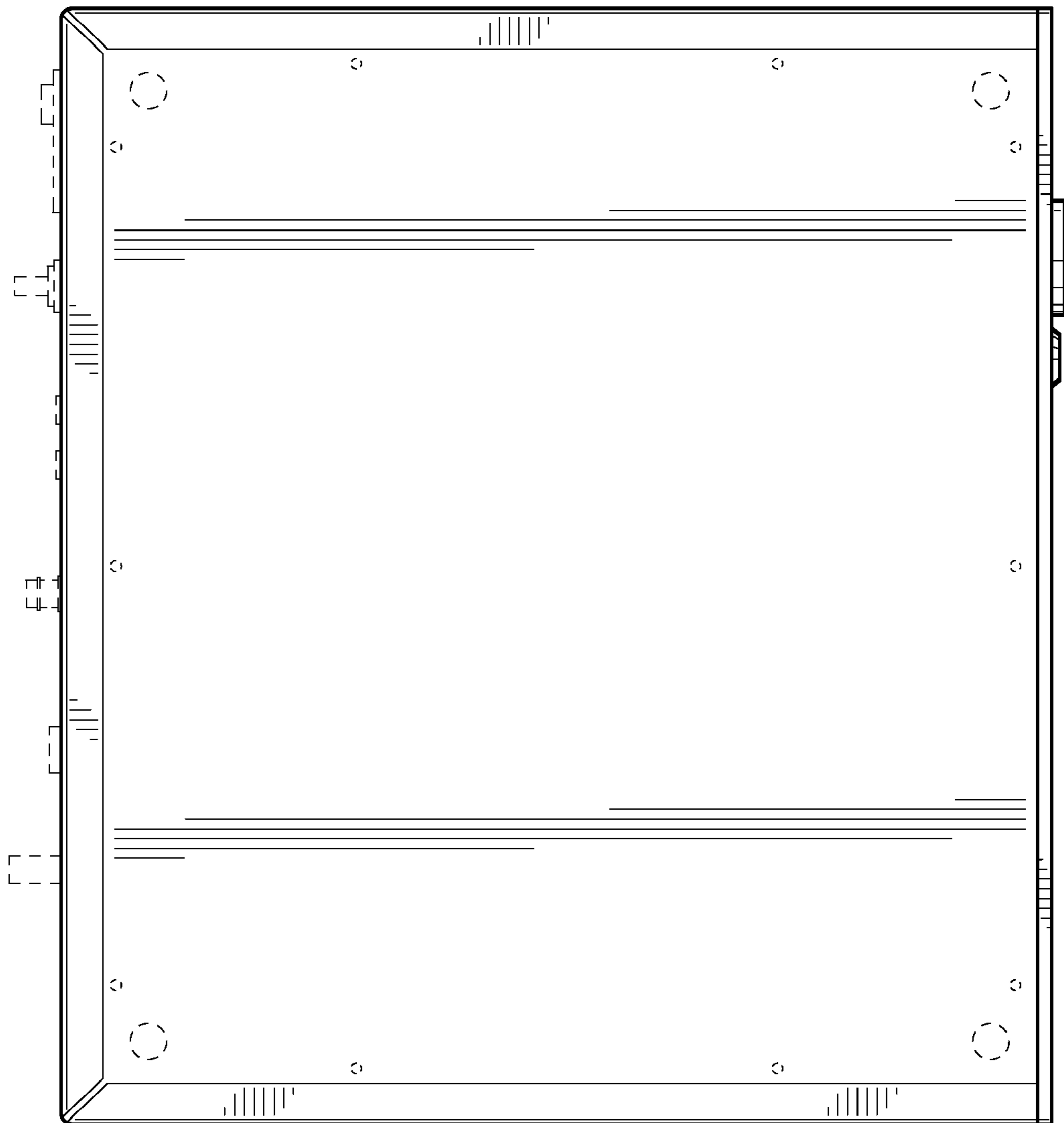
