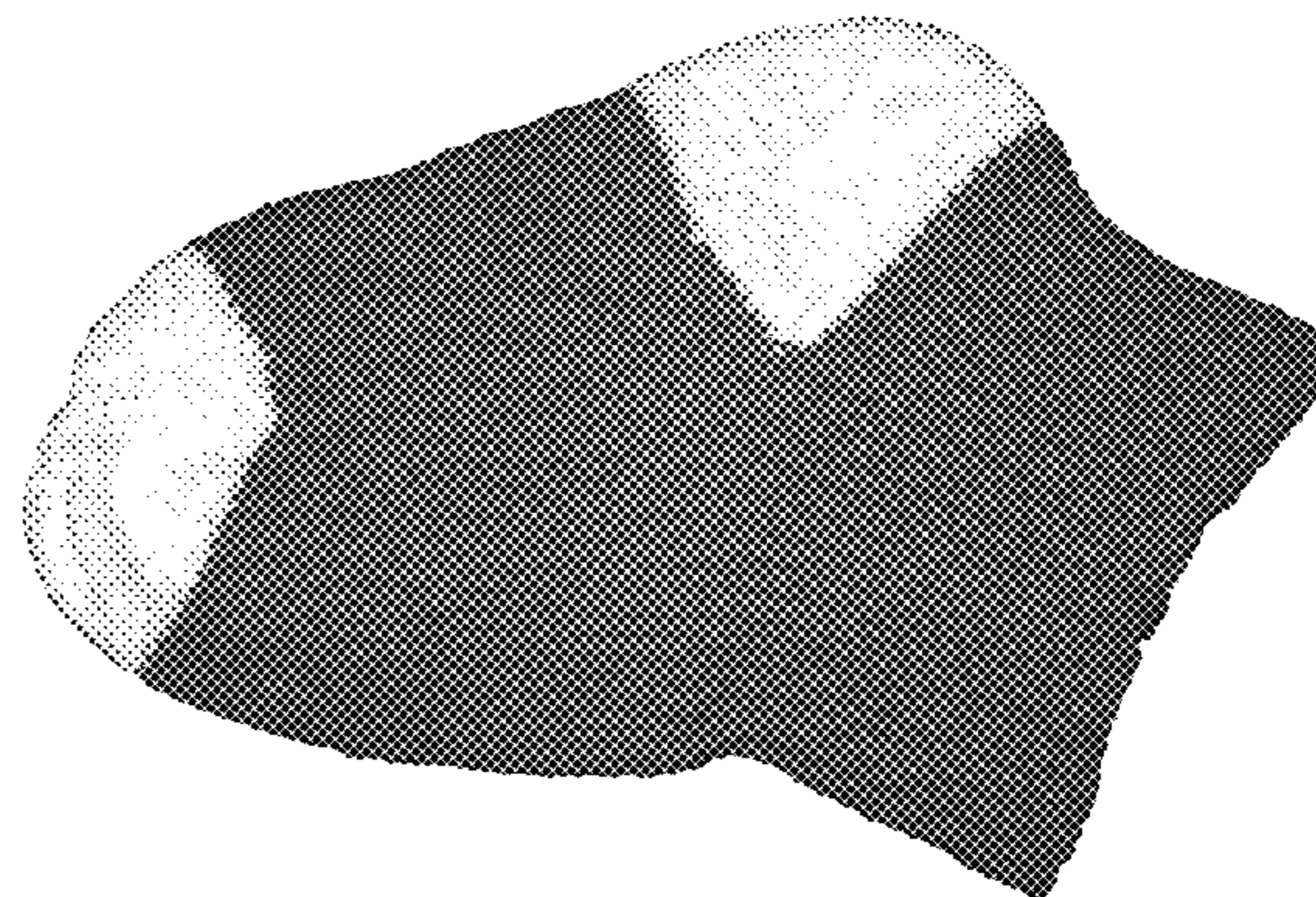
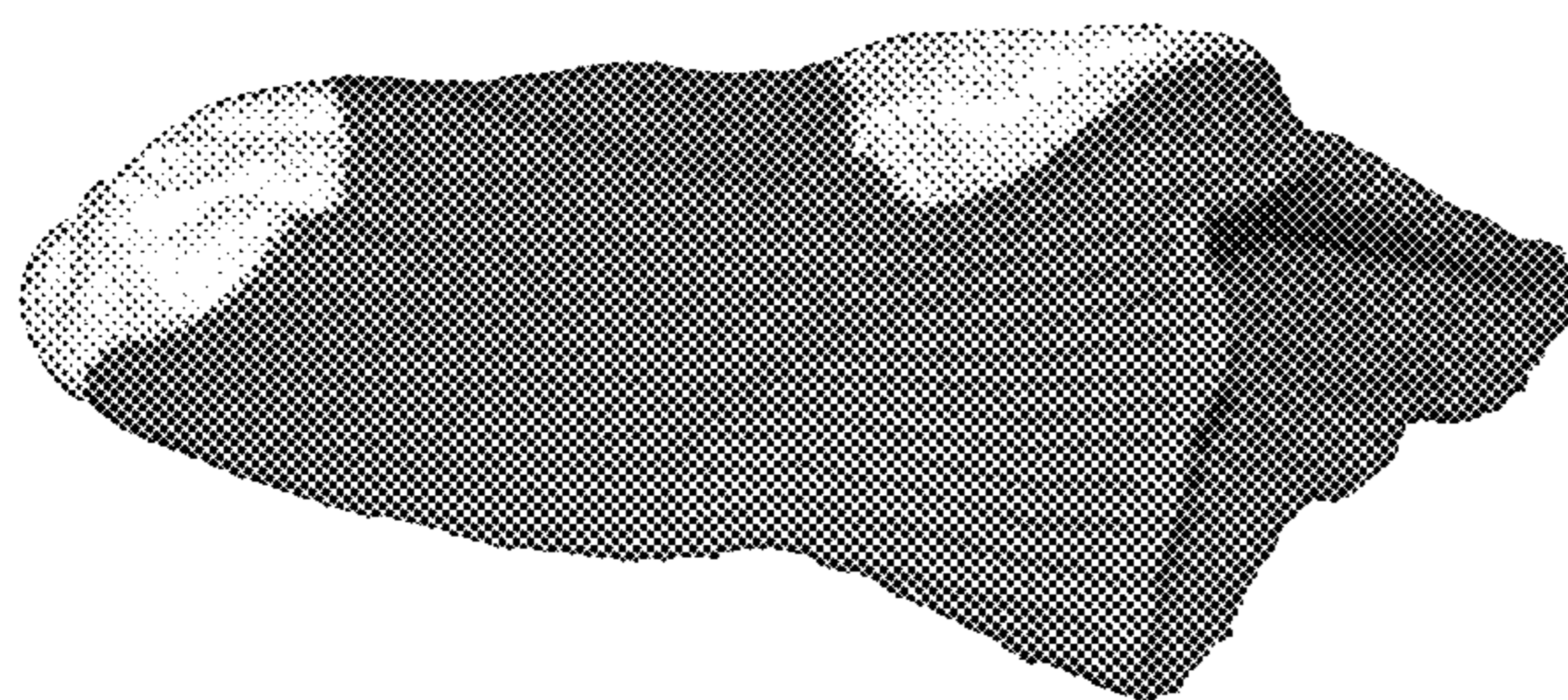
The ornamental design for a head apparel, substantially as shown and described.

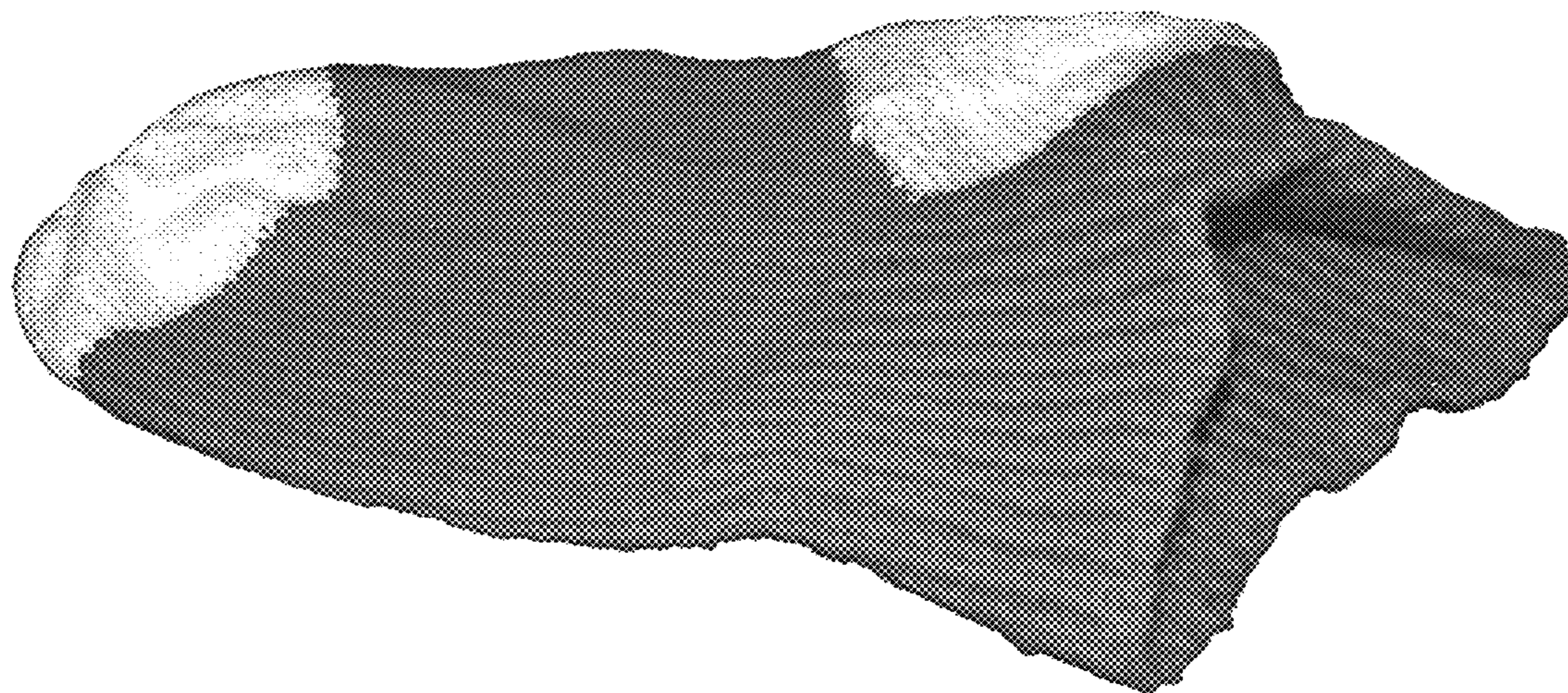
