FIG. 3 is a first side elevation view of FIG. 1;

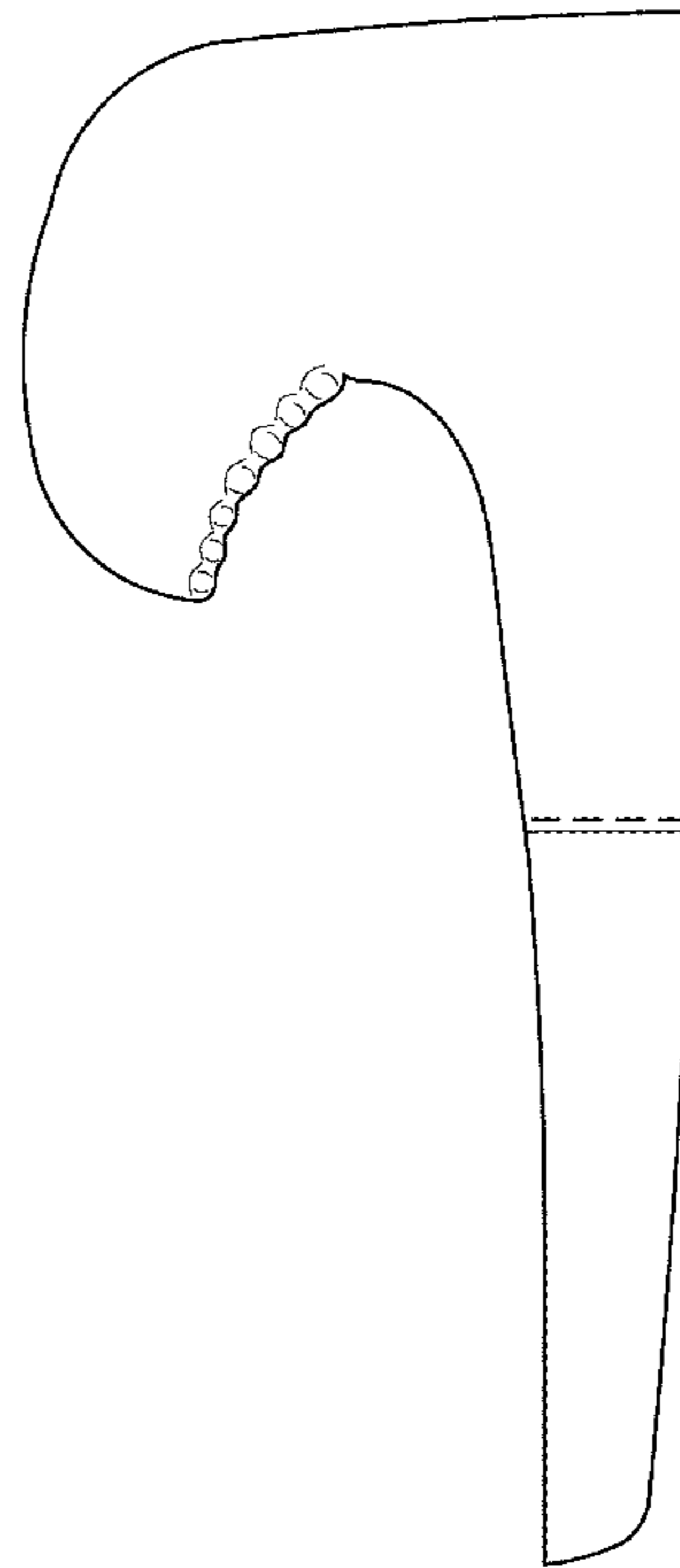
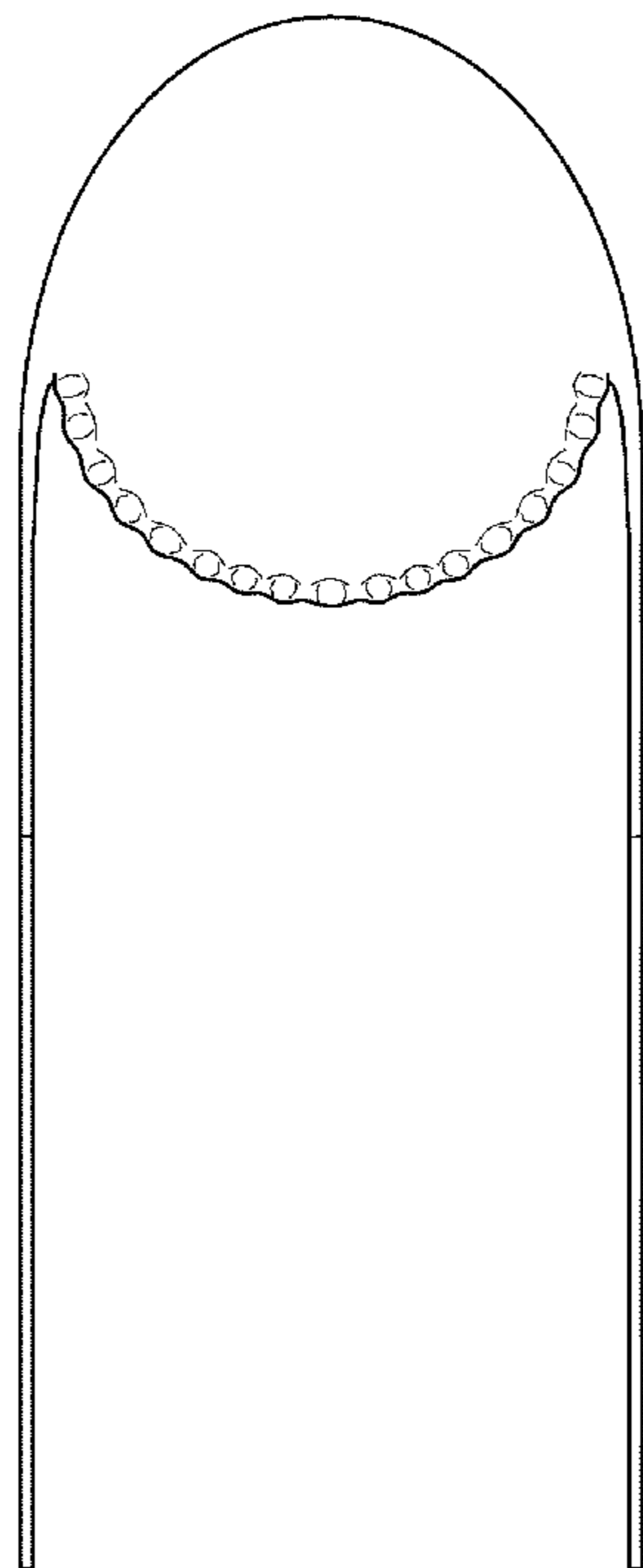
FIG. 4 is a second side elevation view of FIG. 1;

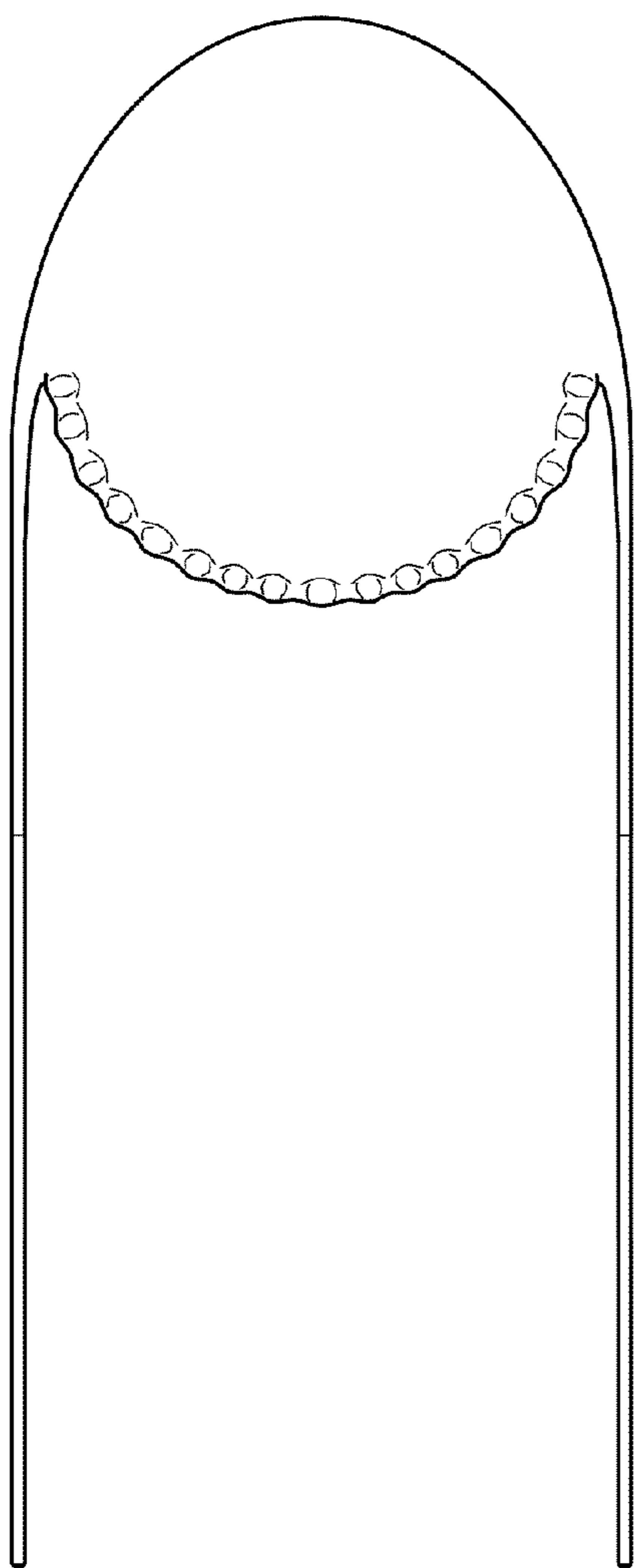

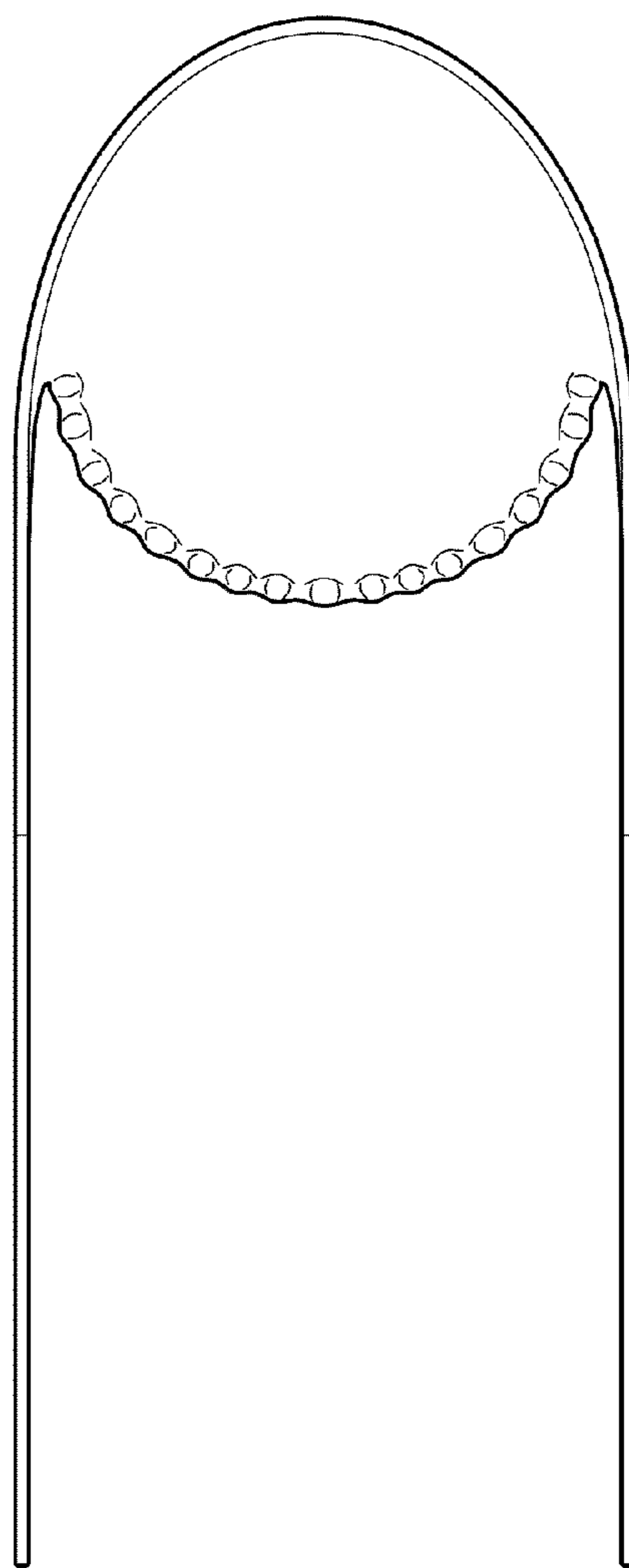

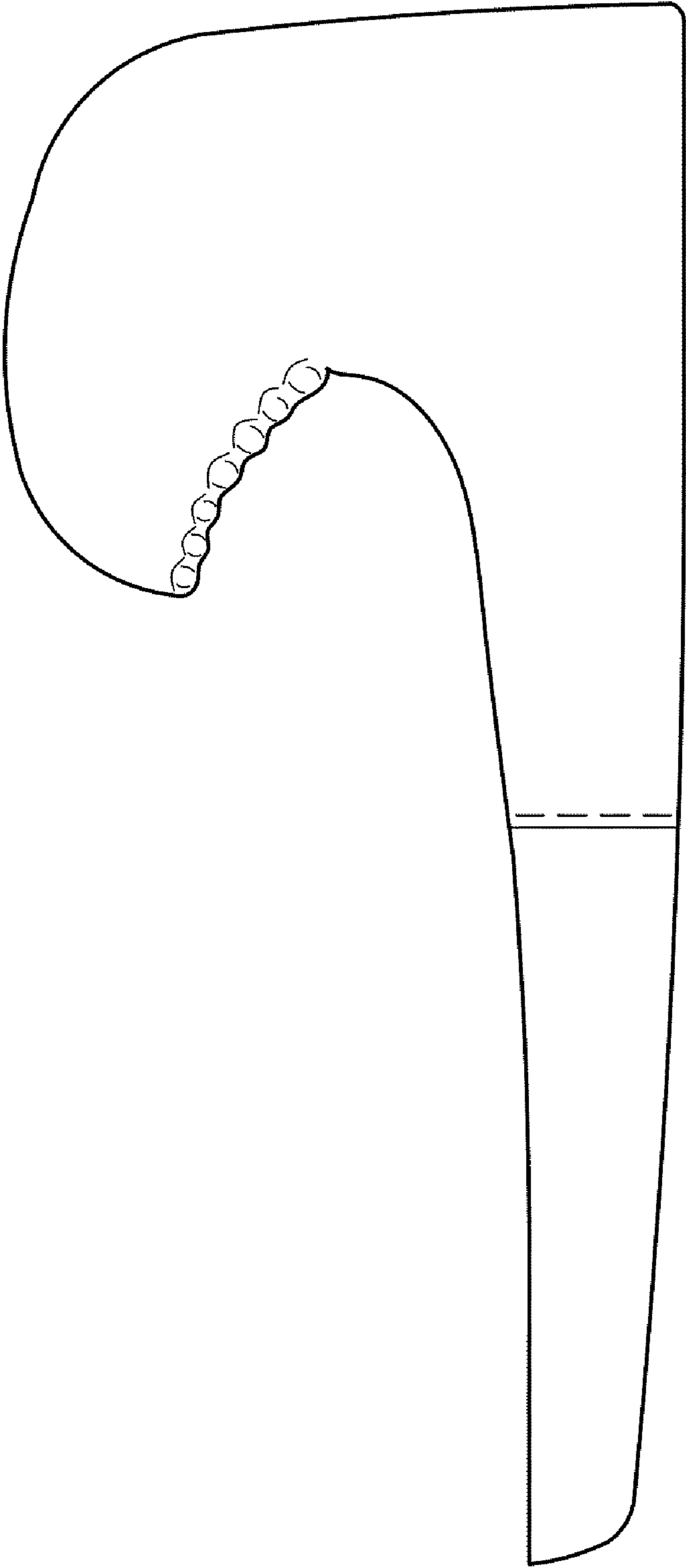

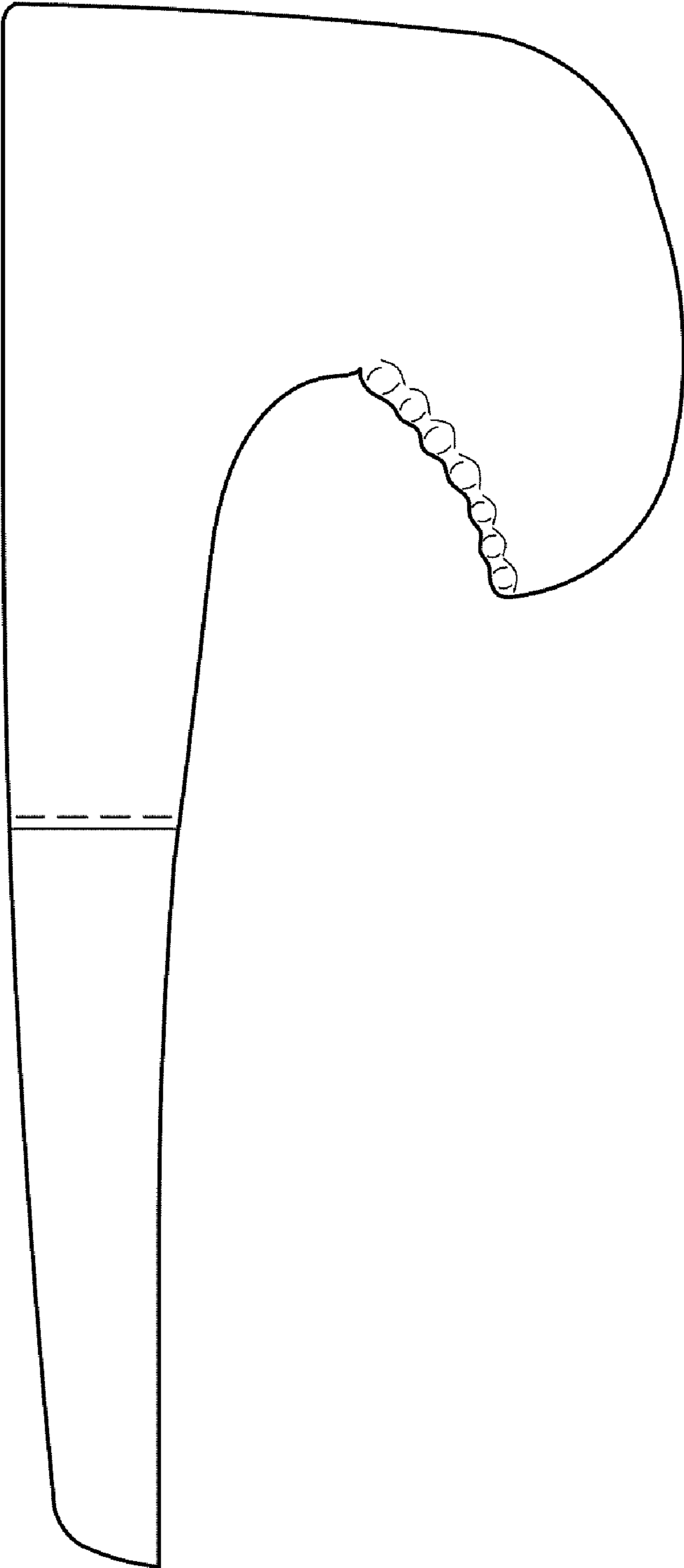

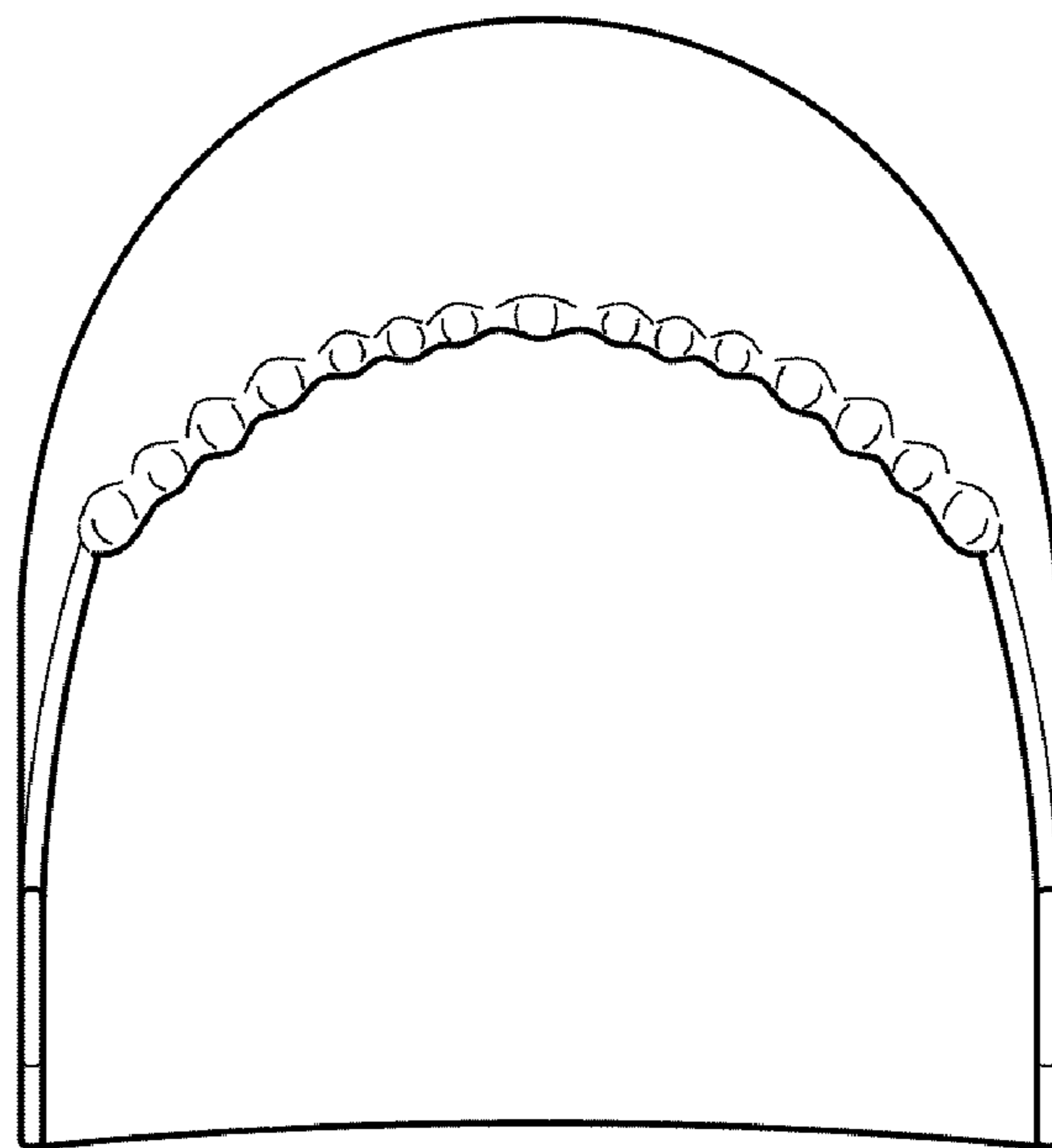

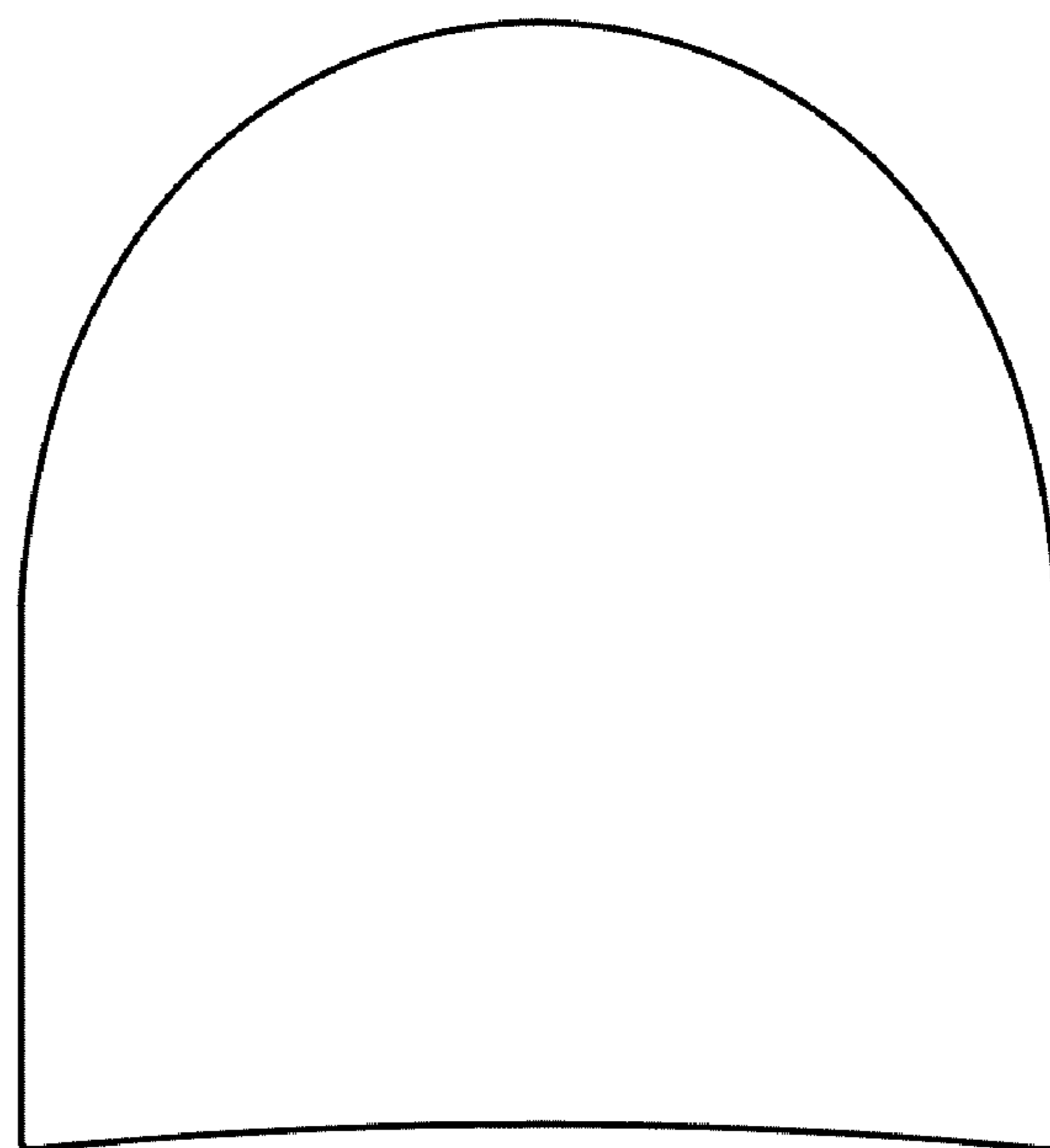
