The ornamental design for a cap having lights, as shown and described.

DESCRIPTION

FIG. 1 is a magnified elevated perspective view of a brim of the cap having lights;

FIG. 2 is a front view of the cap having lights;

FIG. 3 is an elevated perspective view of the cap having lights;

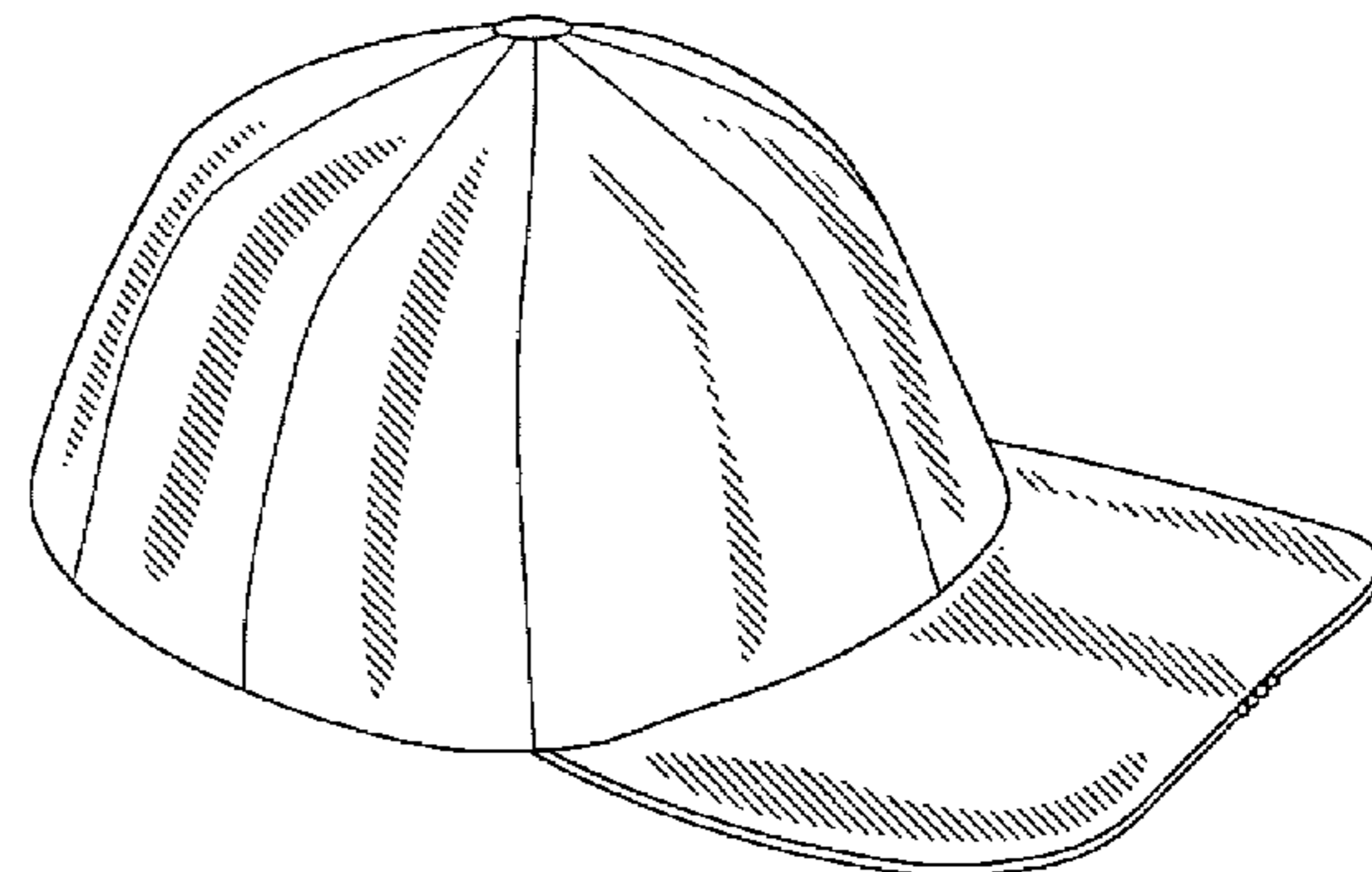
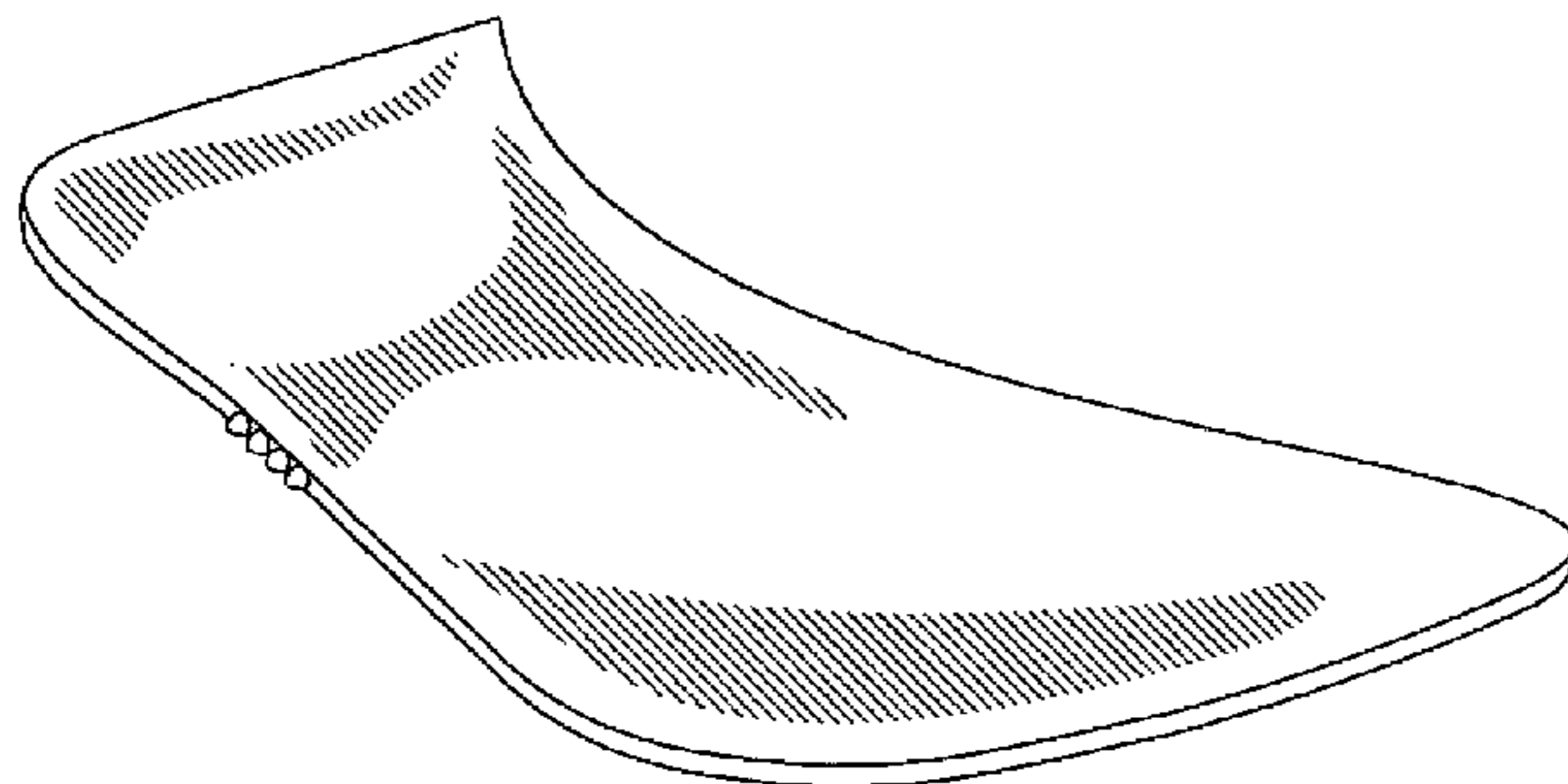
FIG. 4 is a side view of the cap having lights, the other side being a mirror image thereof;

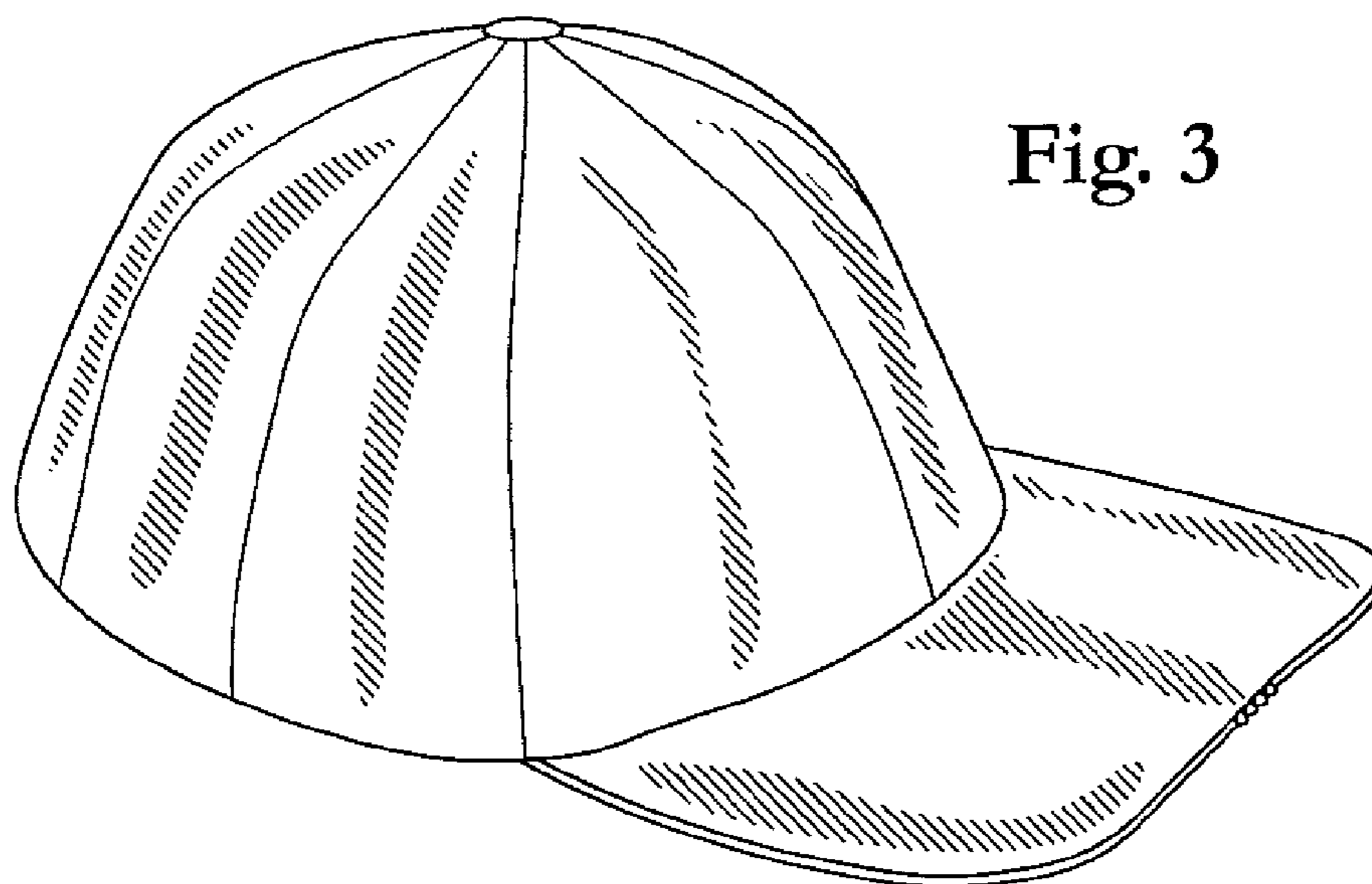
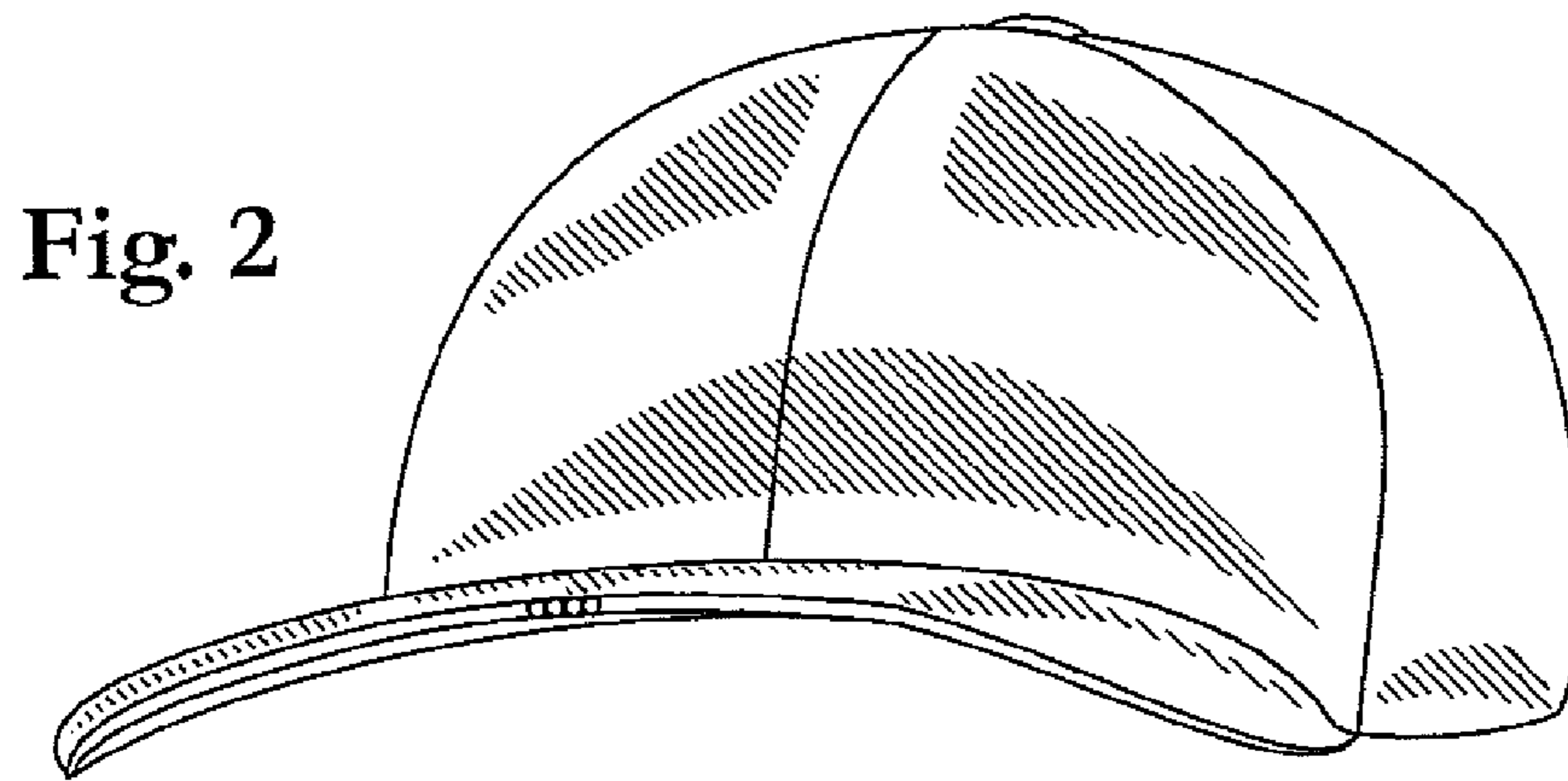
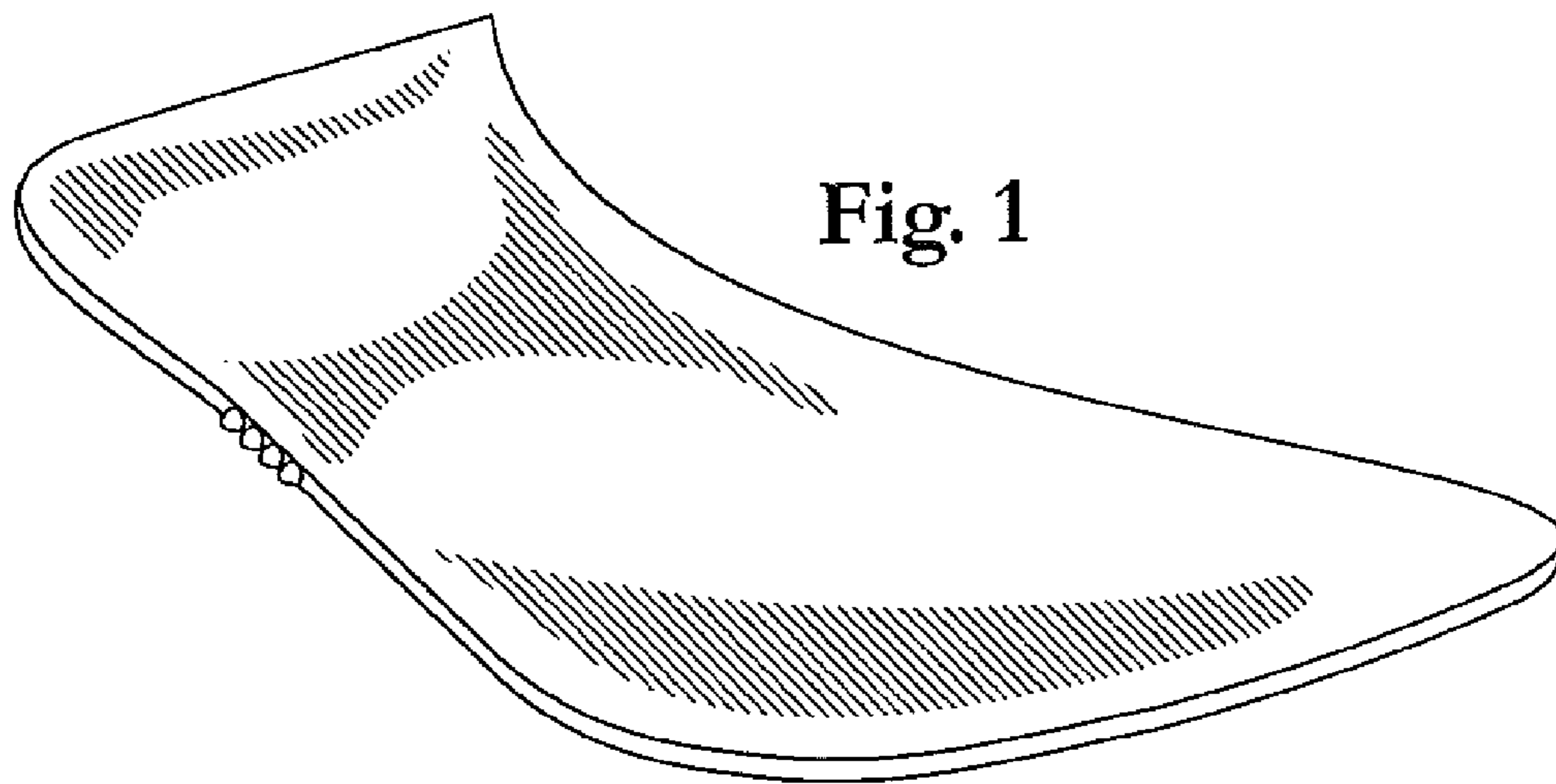

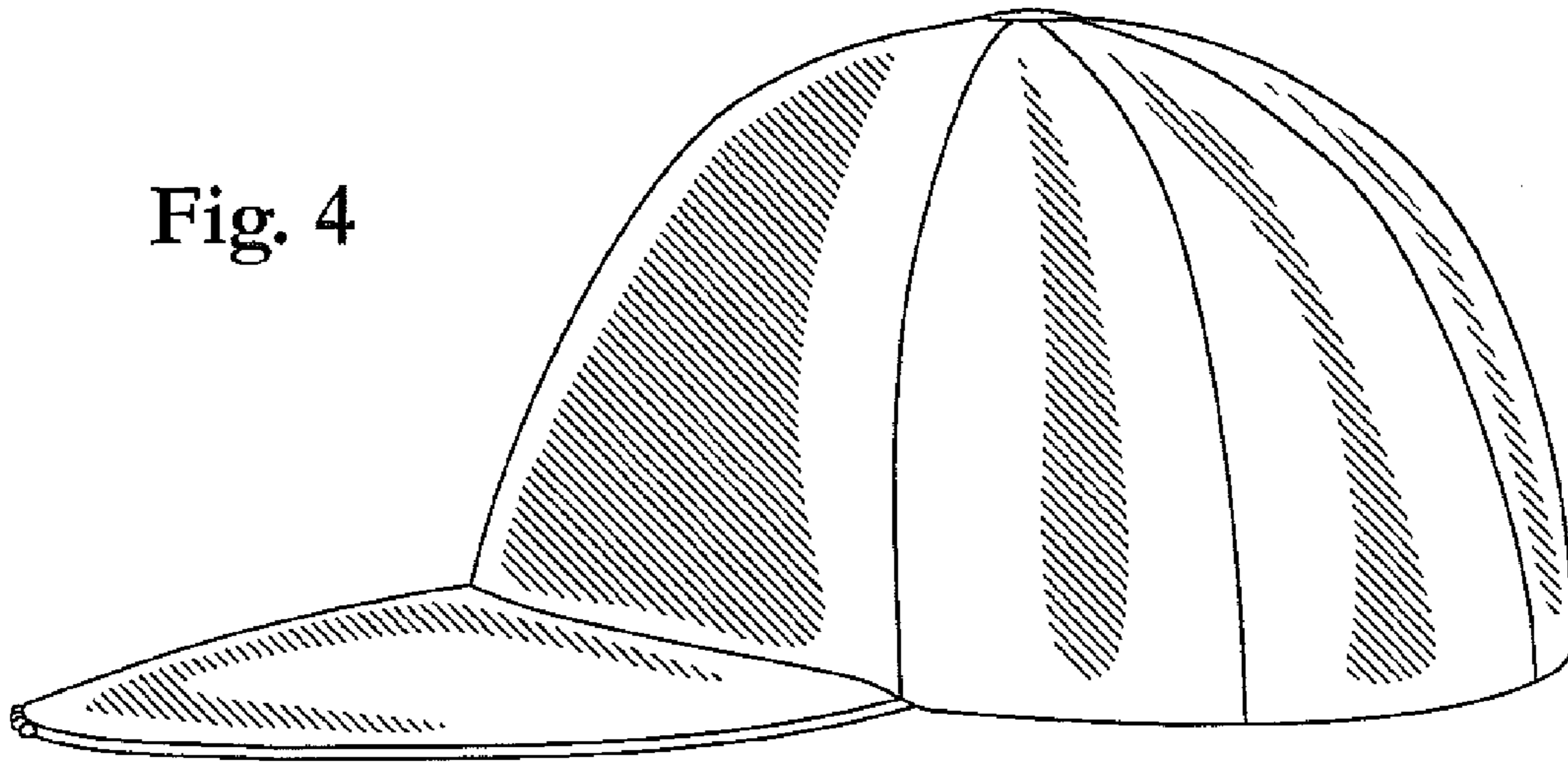

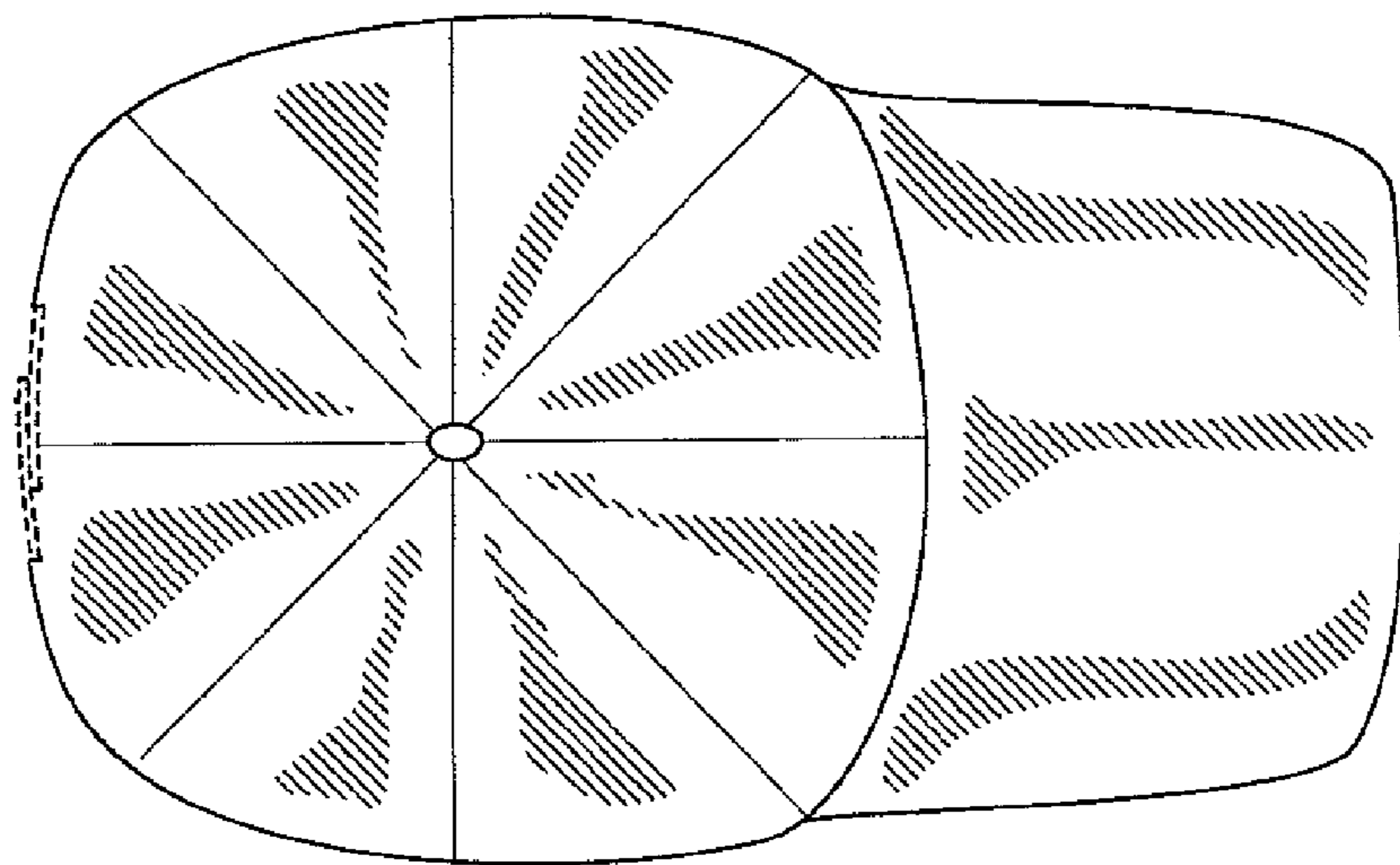
