(57) **CLAIM**

What is claimed is the ornamental design for a bat pack, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a bat pack, showing the new design in a collapsed position;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a right-side elevational view thereof;

FIG. 5 is a left-side elevational view thereof;

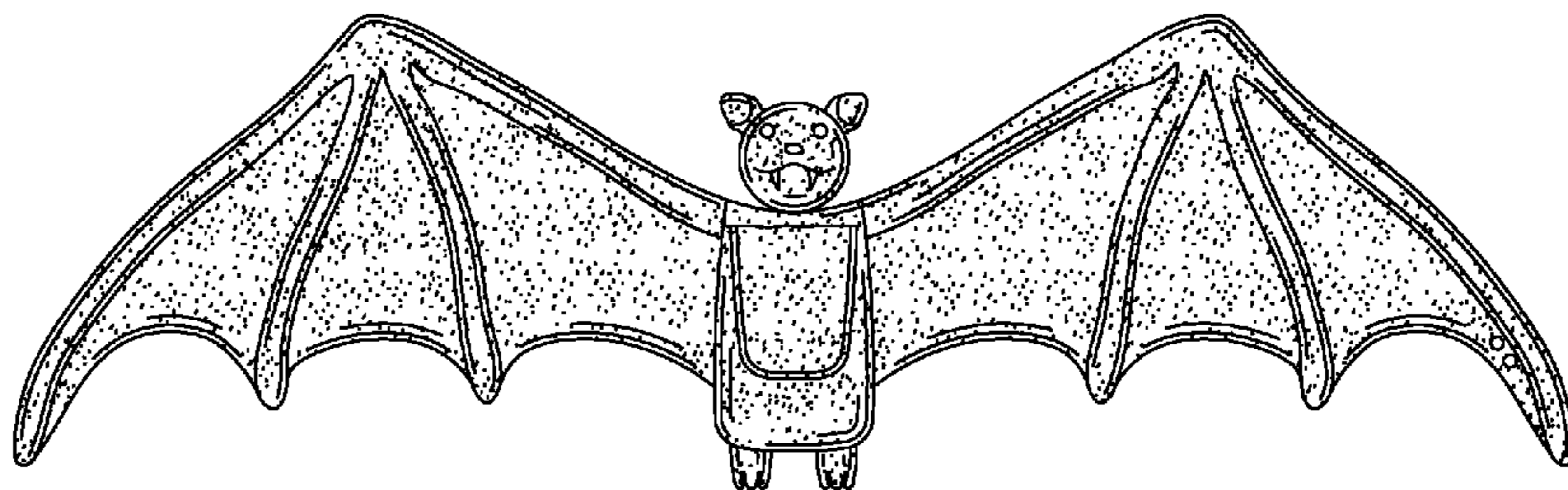
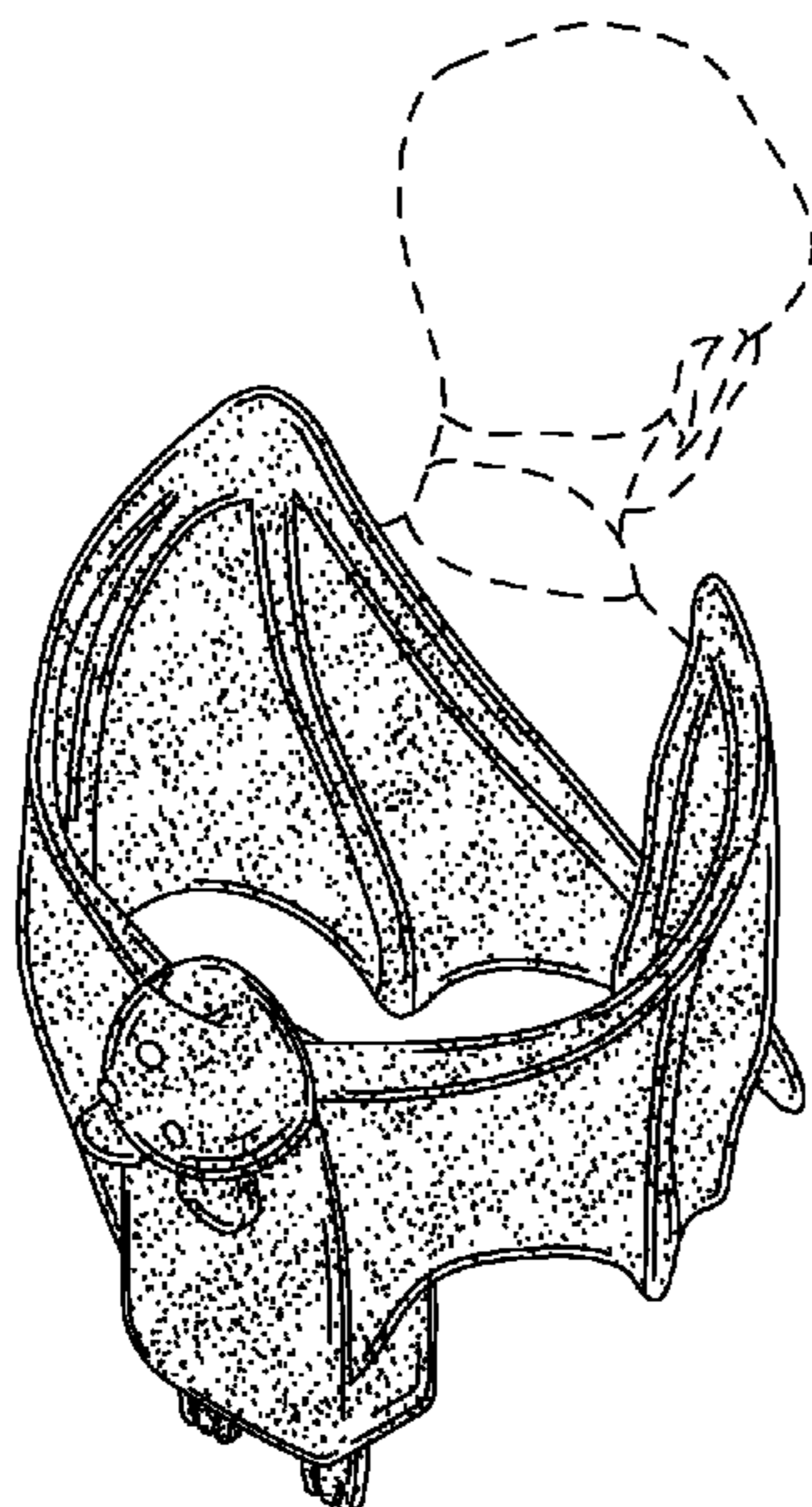
FIG. 6 is a top plan view thereof; and

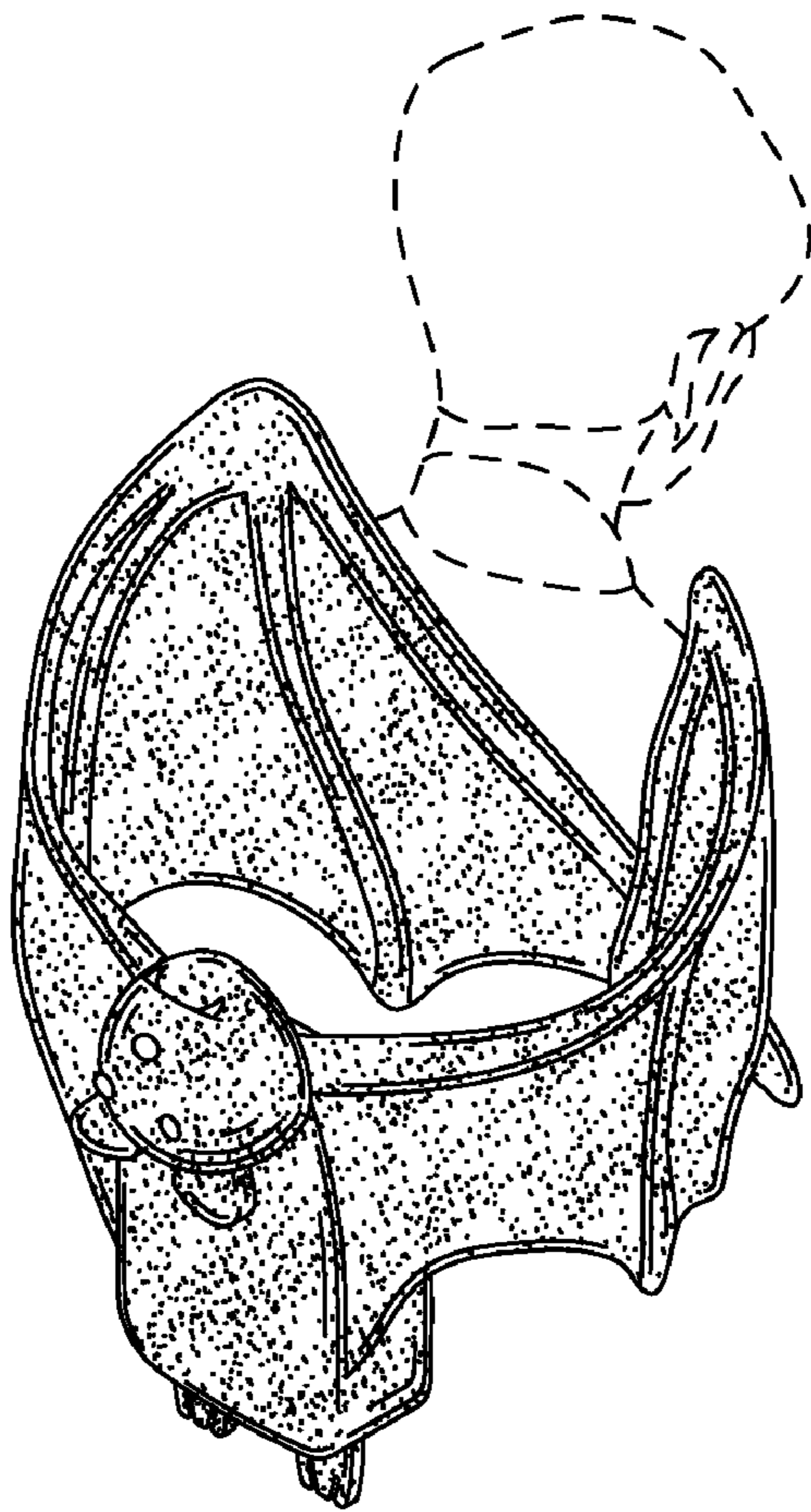

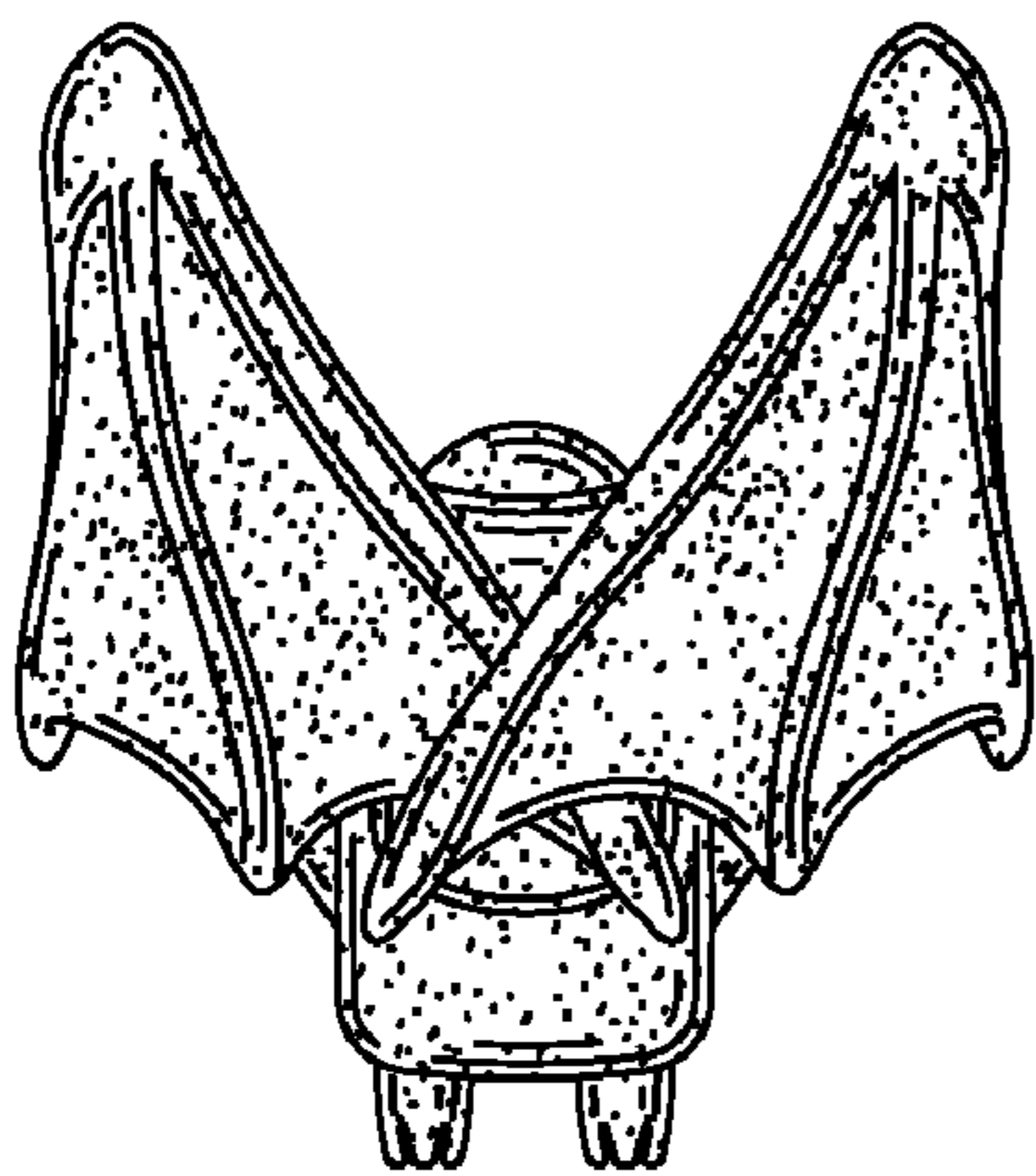

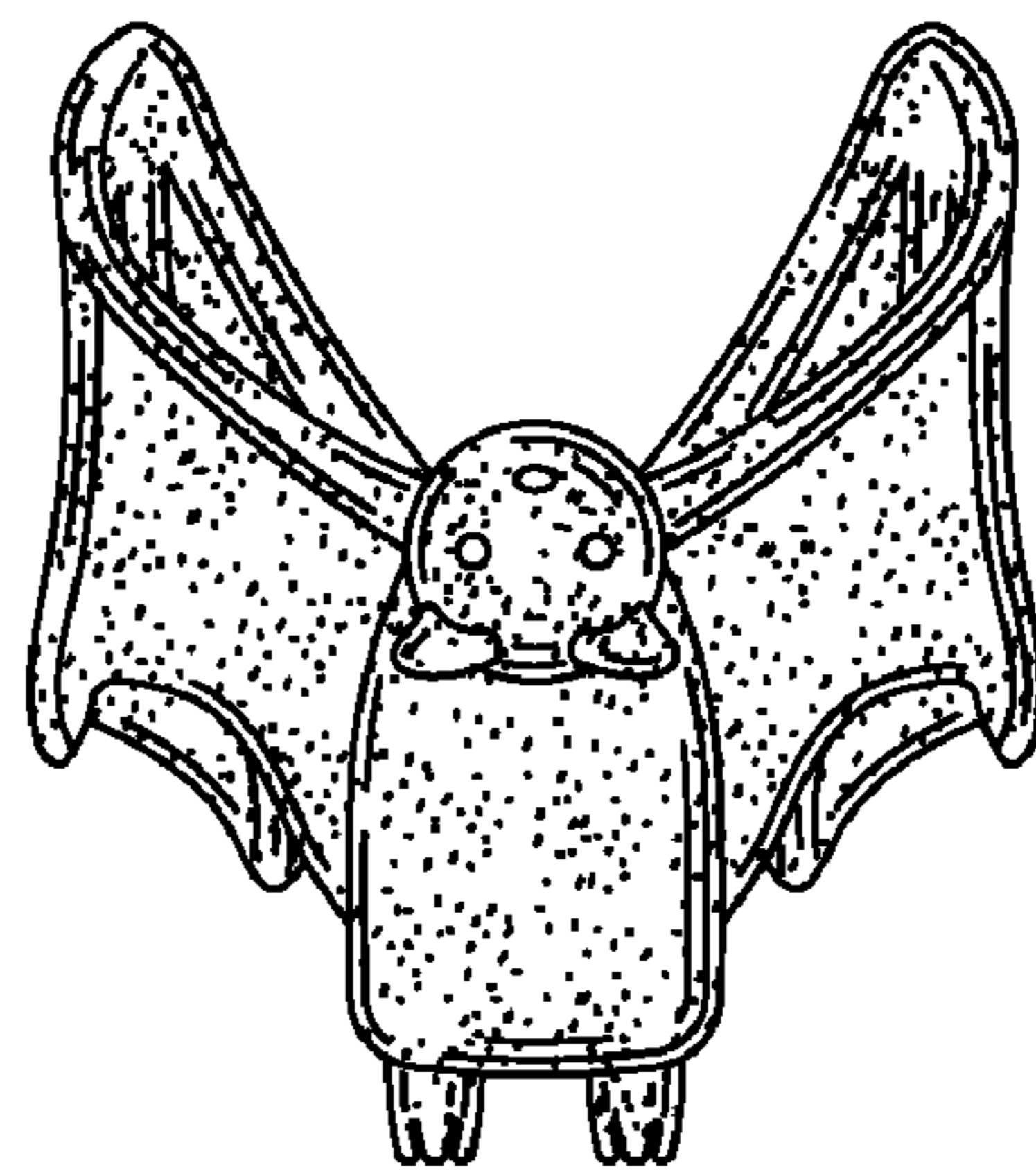

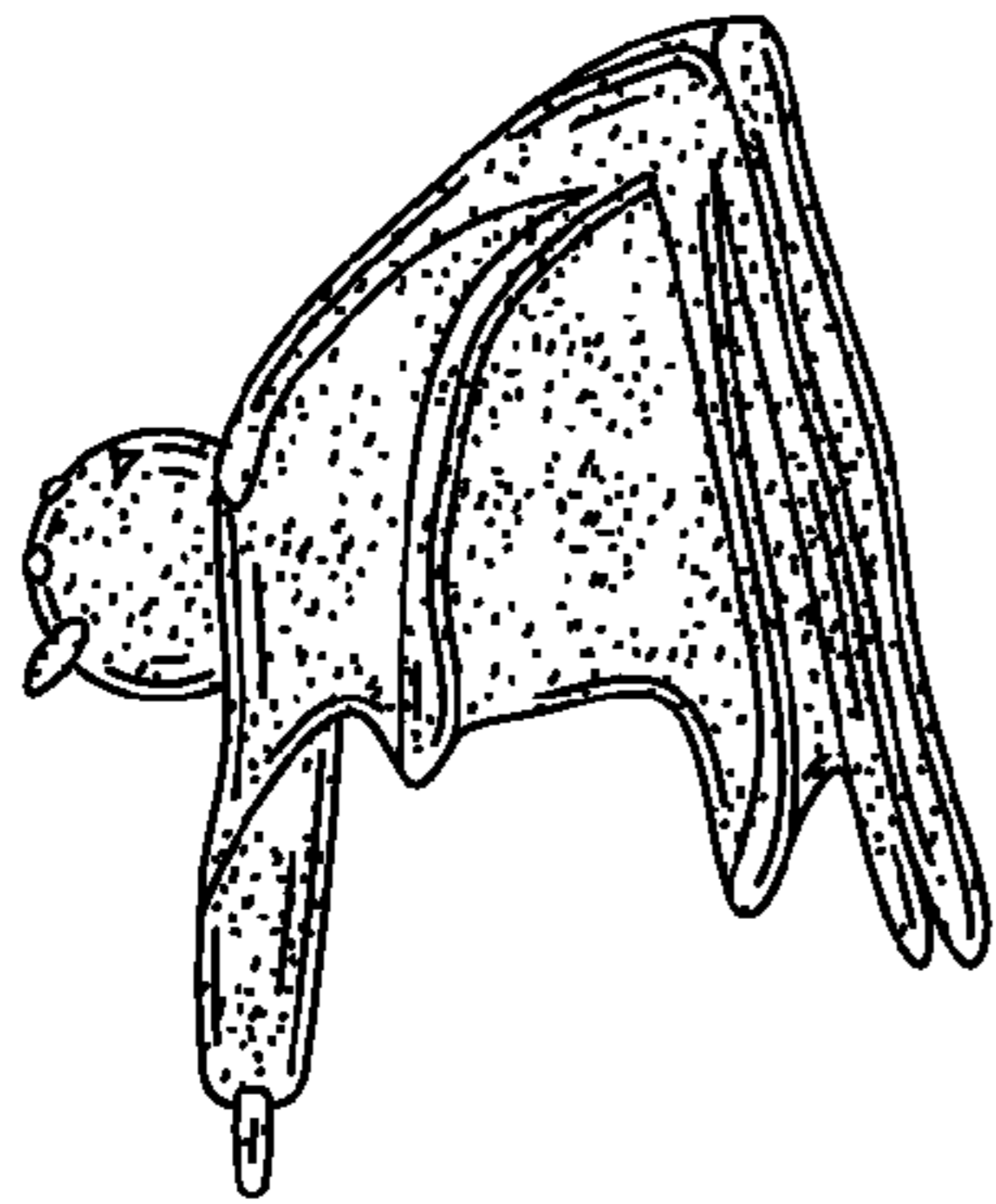

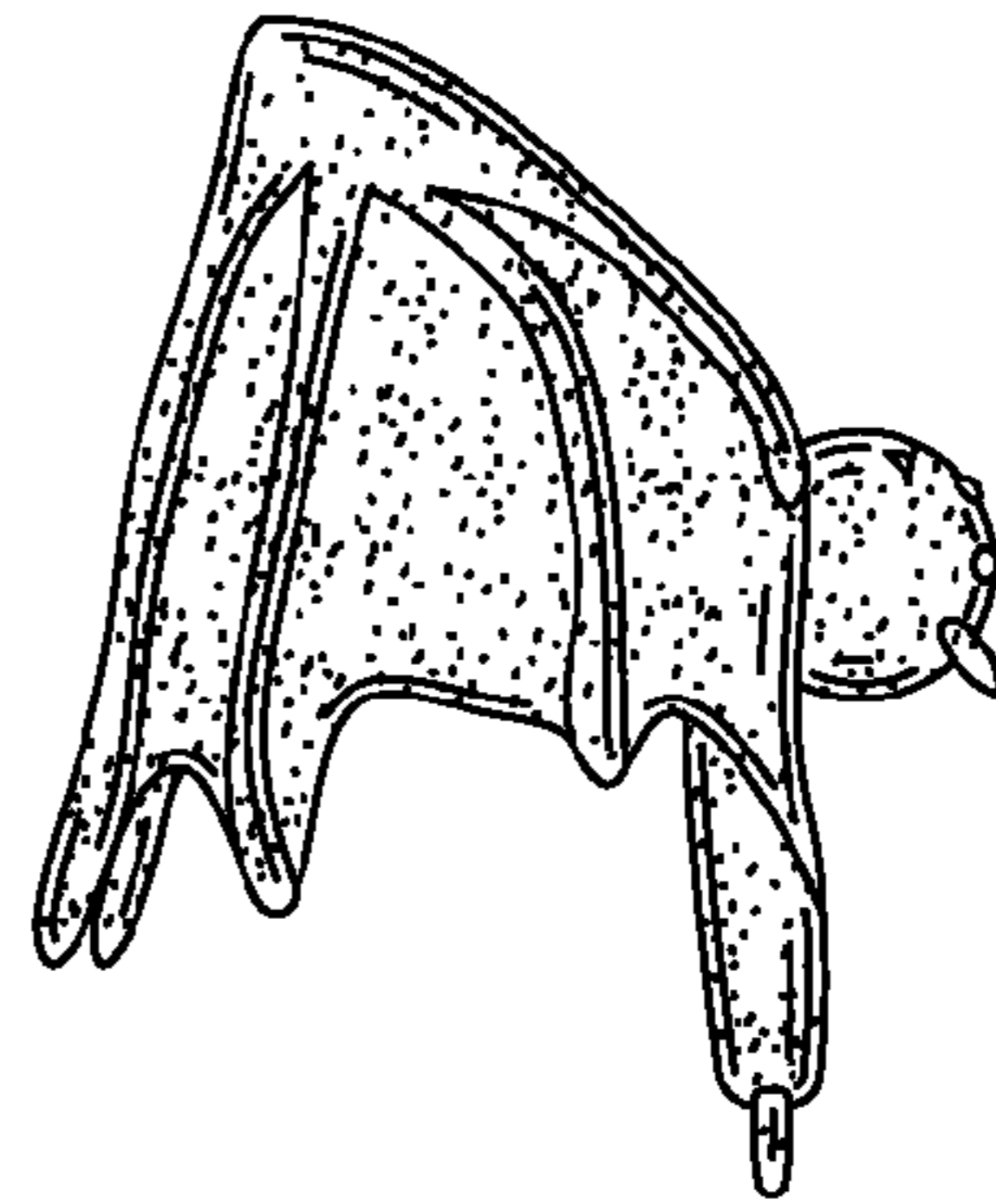

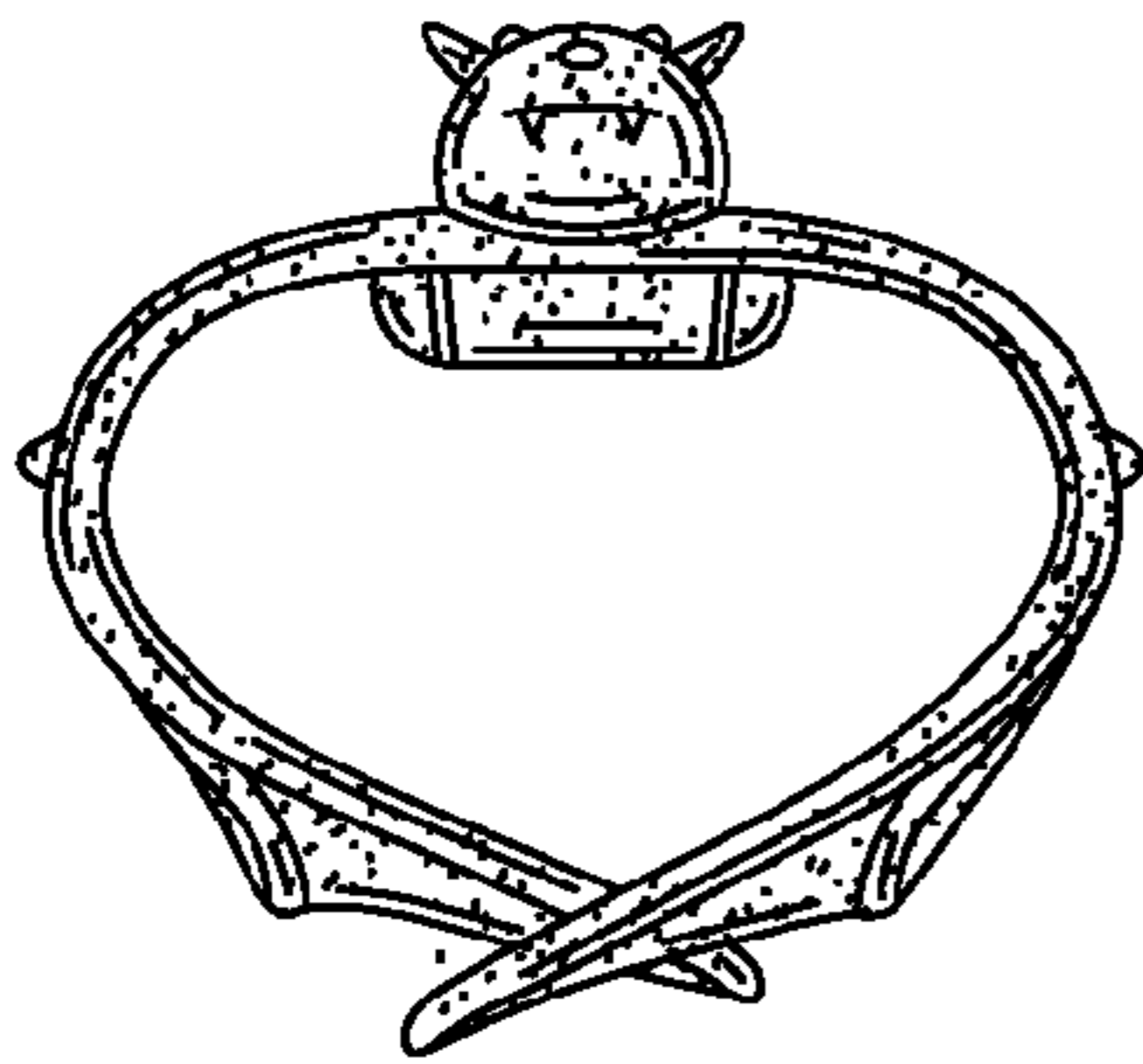

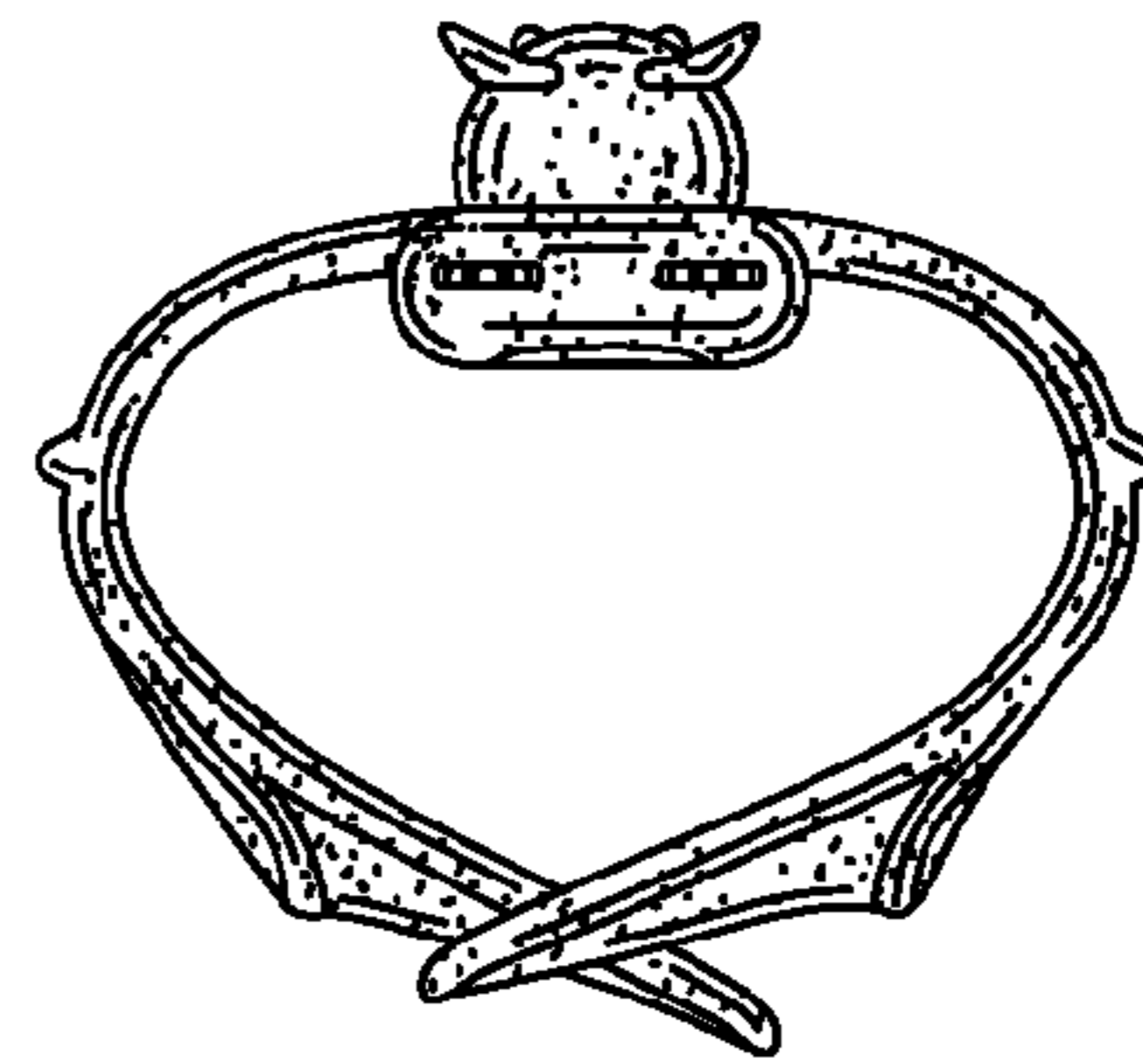

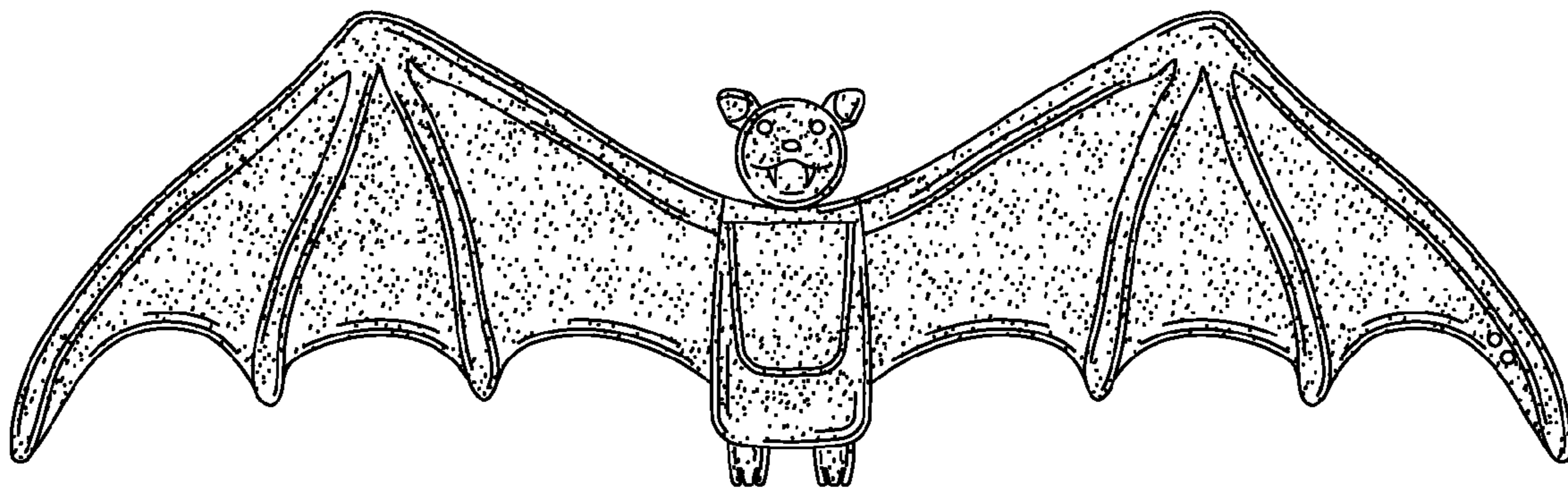
