(57) **CLAIM**

The ornamental design for a mascara brush head, substantially as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front and right side perspective view of my new design for a mascara brush head;

FIG. 2 is a right side elevation view of the mascara brush head shown in FIG. 1, a left side elevation view being a mirror image thereof;

FIG. 3 is a top plan view of the mascara brush head shown in FIG. 1, a bottom plan view being a mirror image thereof;

FIG. 4 is a front elevation view of the mascara brush head shown in FIG. 1; and,

FIG. 5 is a rear elevation view of the mascara brush head shown in FIG. 1.

The broken lines shown in the drawings illustrate environment and form no part of the claimed design.

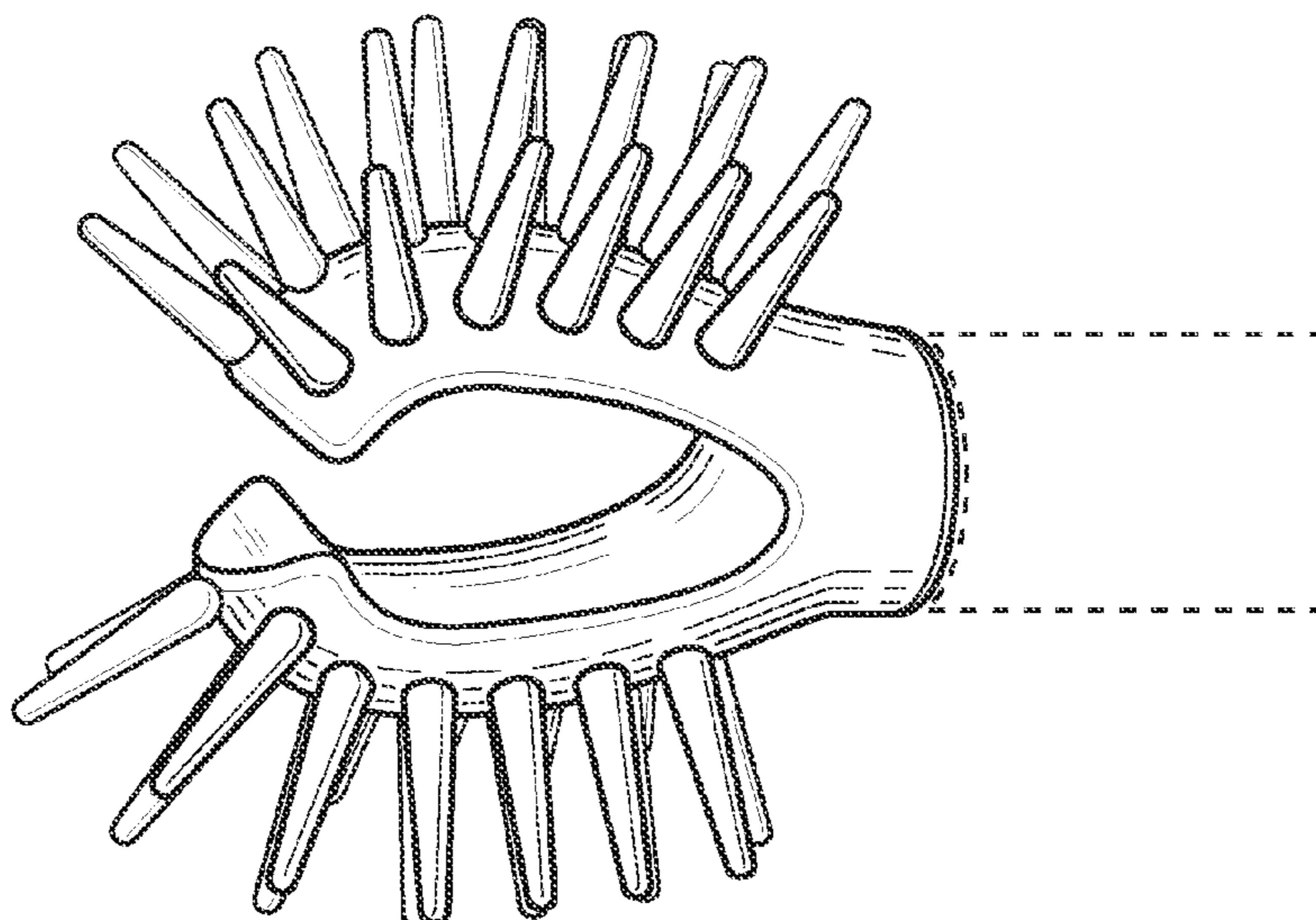

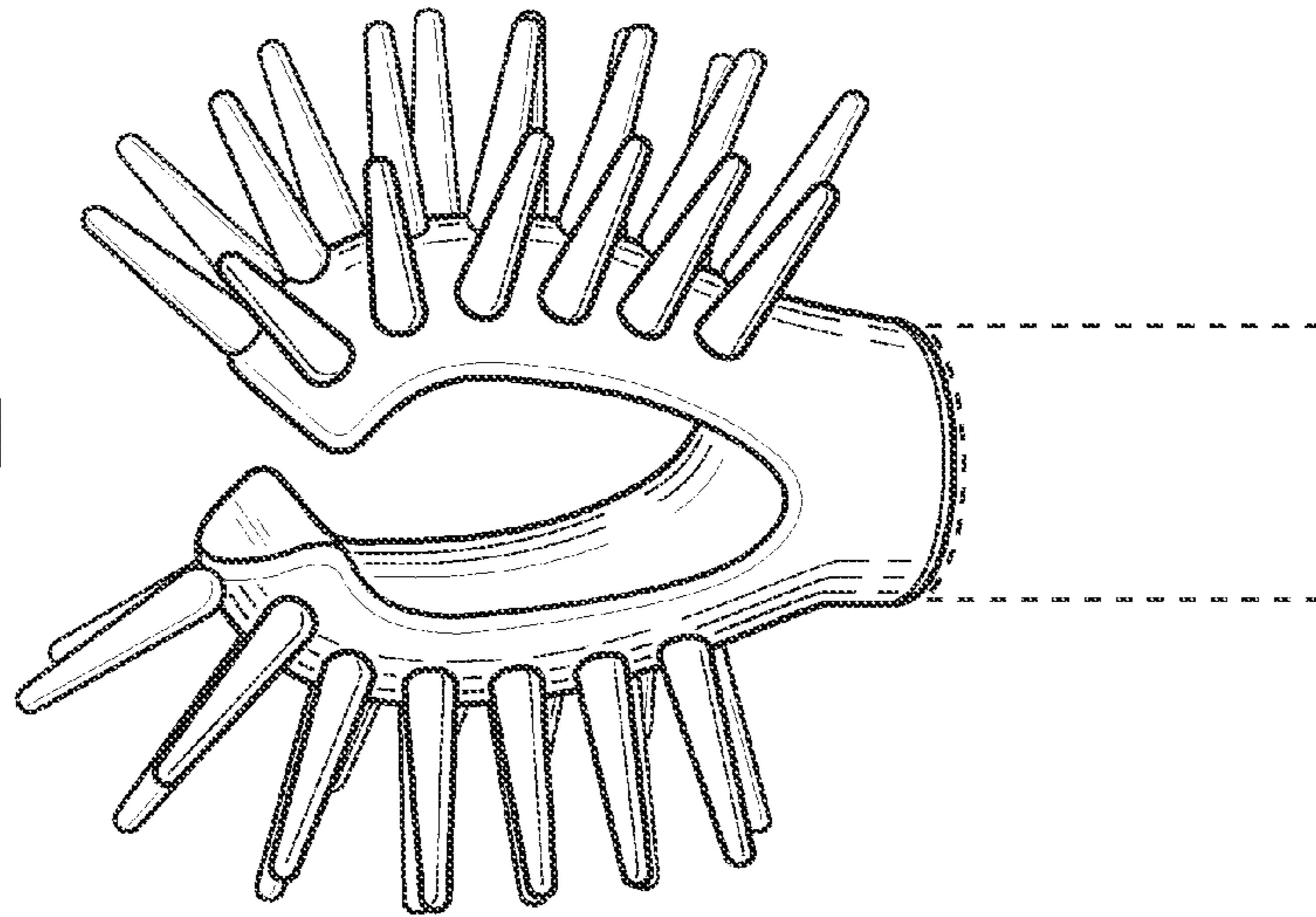
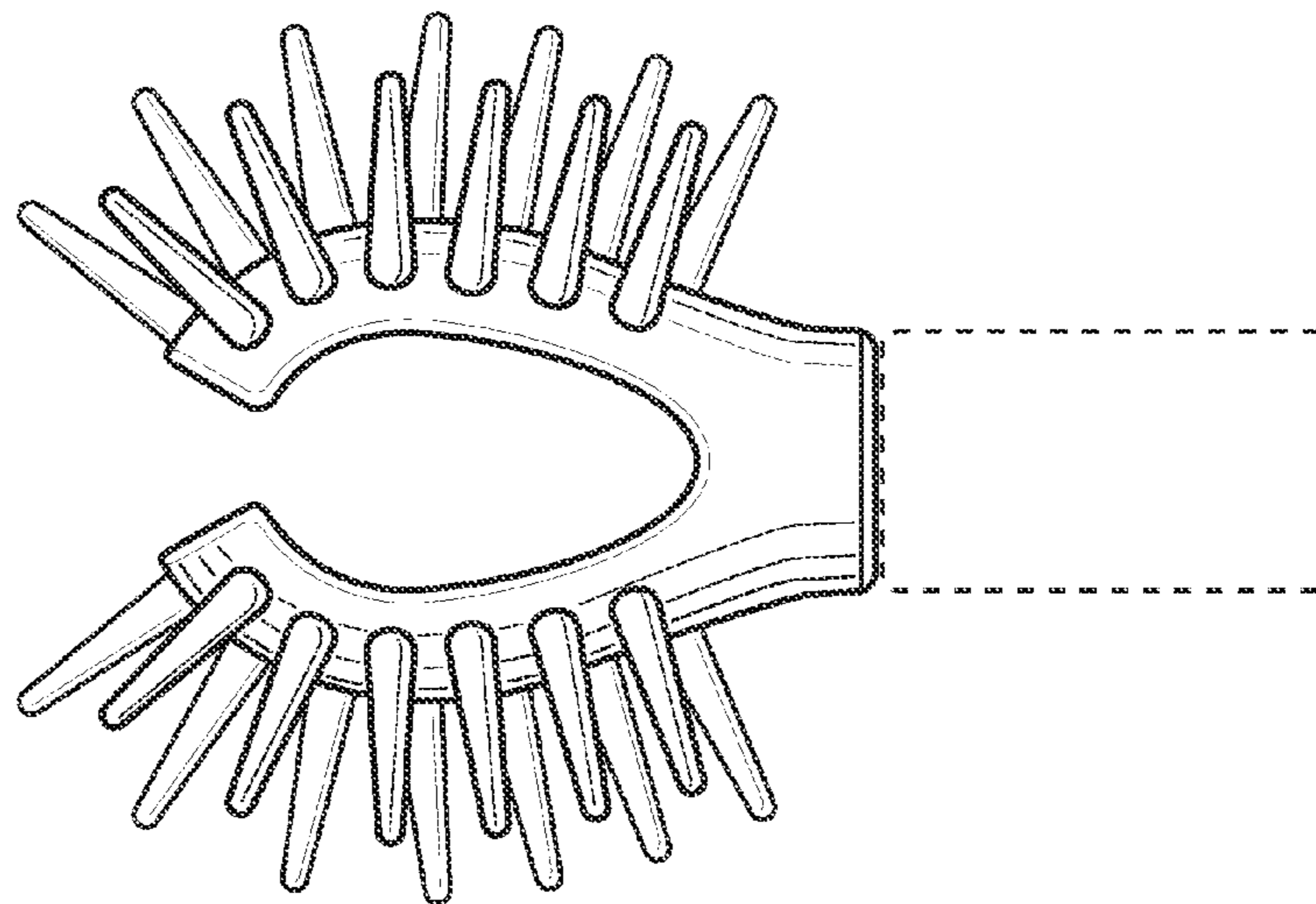
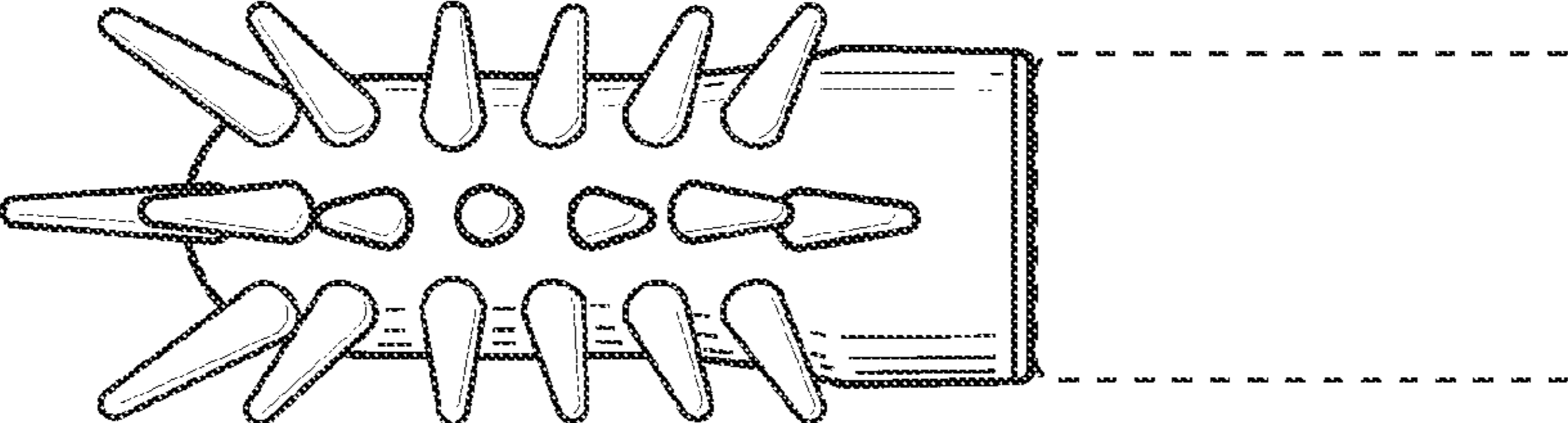


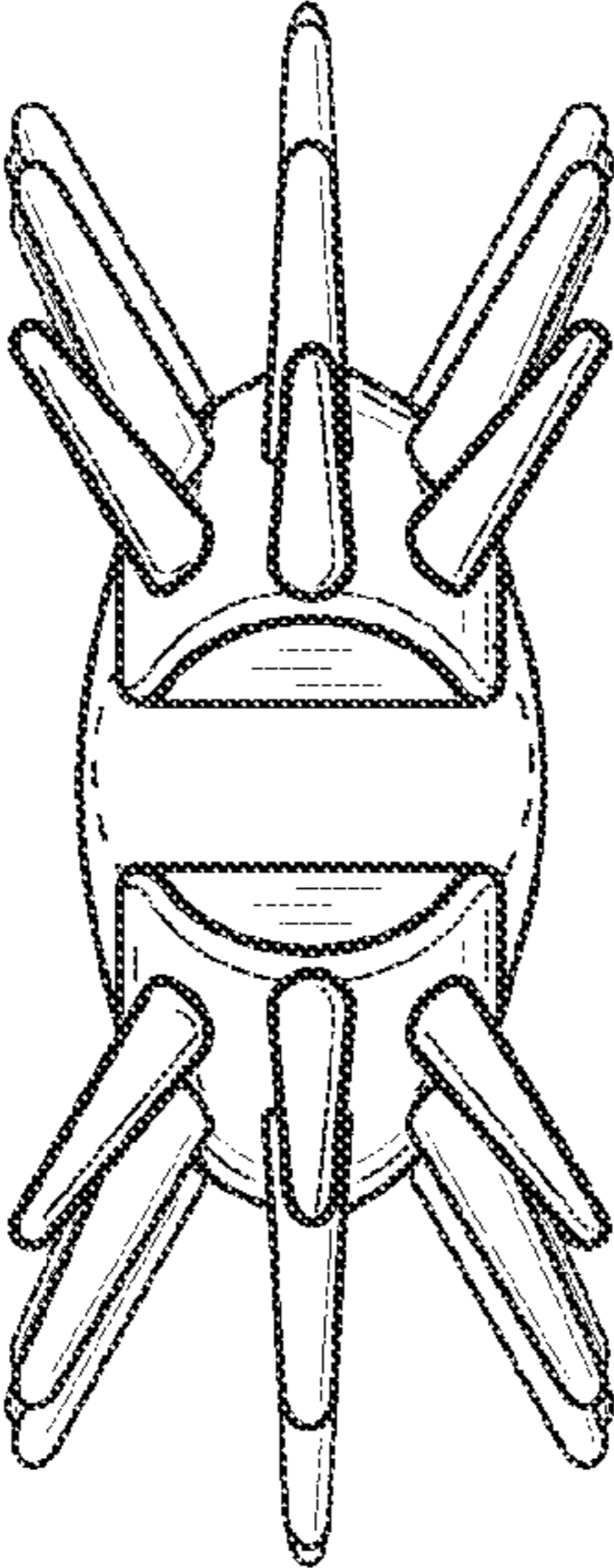
