The ornamental design for a cutting edge, as shown and described.

DESCRIPTION

FIG. 1 is front right bottom perspective view of a cutting edge of a knife blade with the rest of the blade and the handle shown in phantom line forming no part of the design;

FIG. 2 is a rear top left perspective view thereof;

FIG. 3 is a right side elevational view thereof;

FIG. 4 is a left side elevational view thereof;

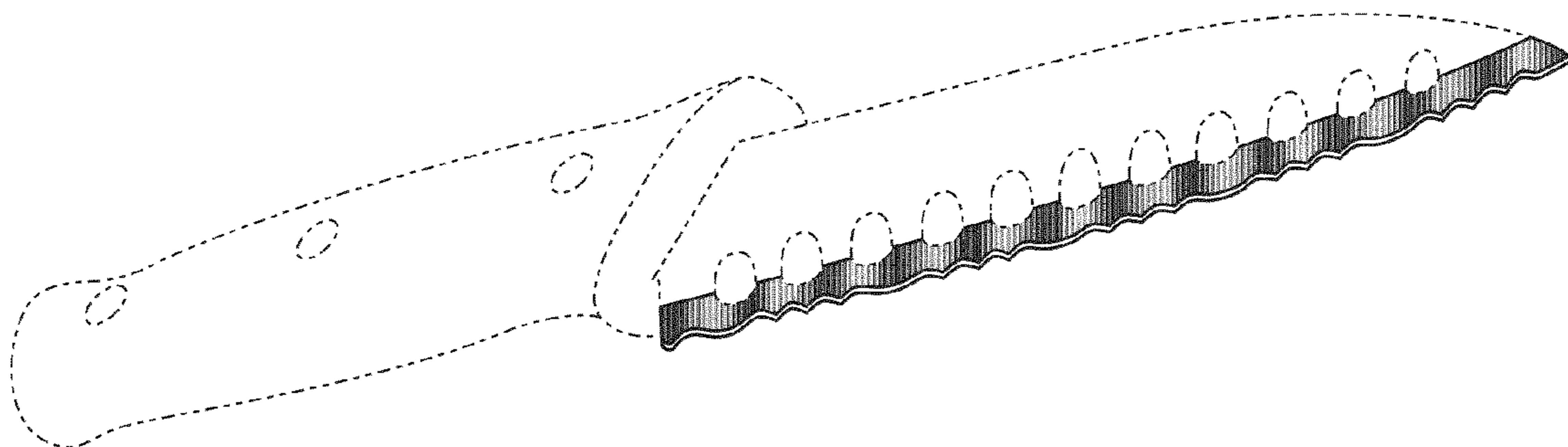
FIG. 5 is a front elevational view thereof;

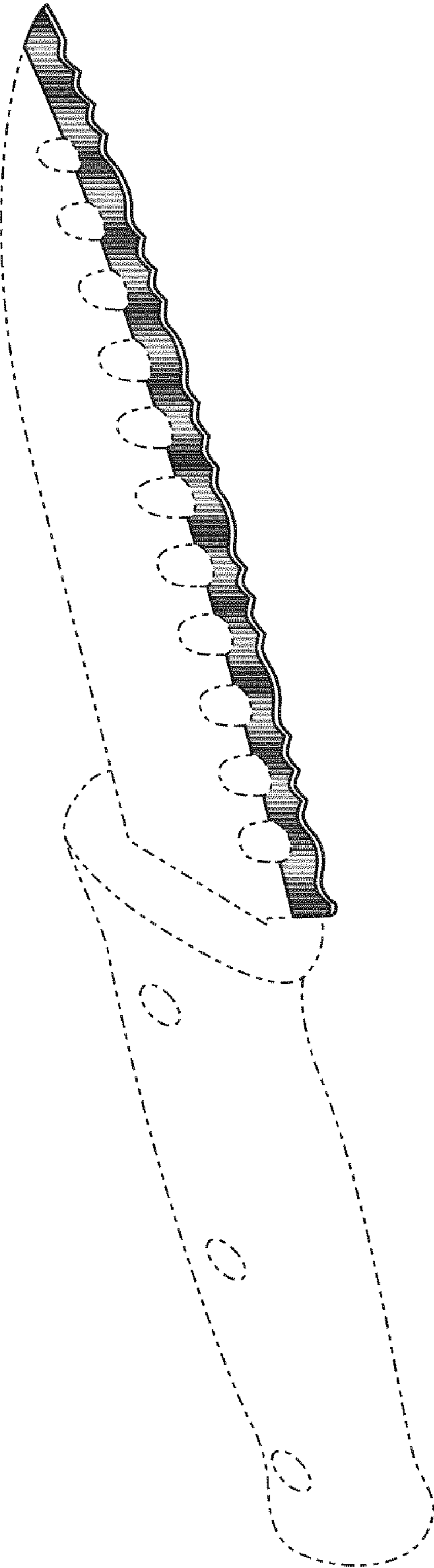

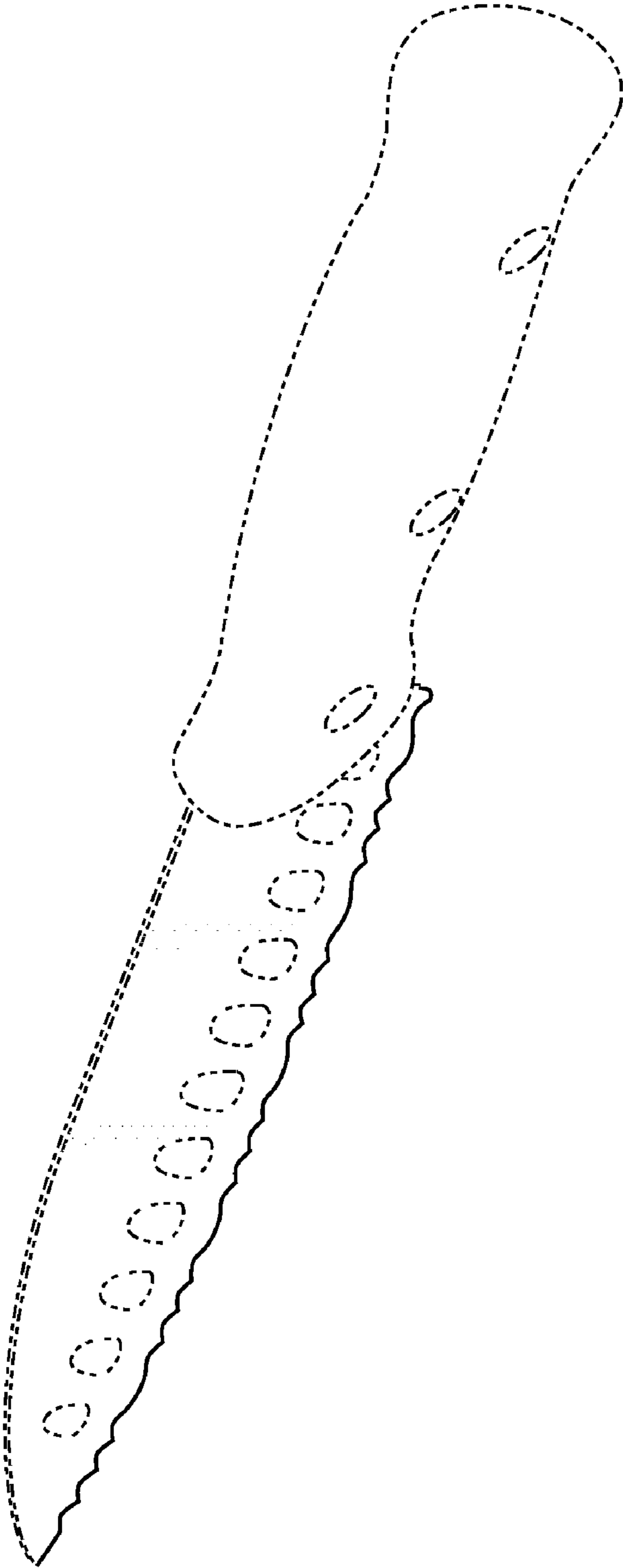

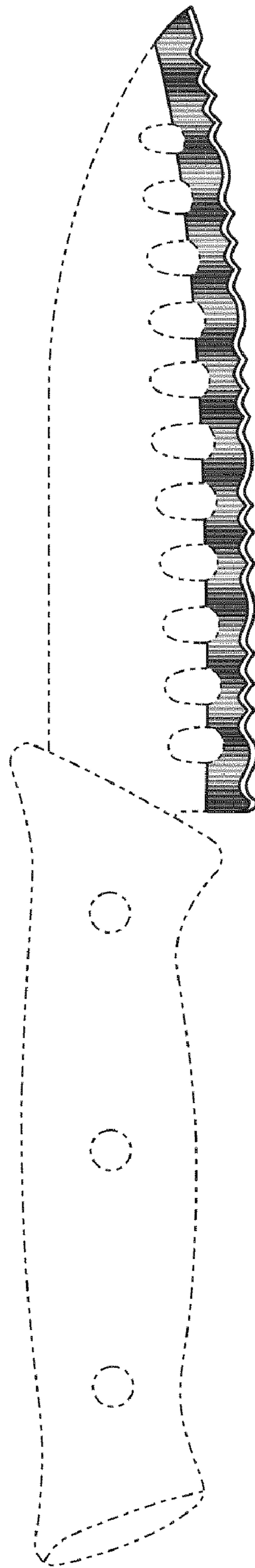

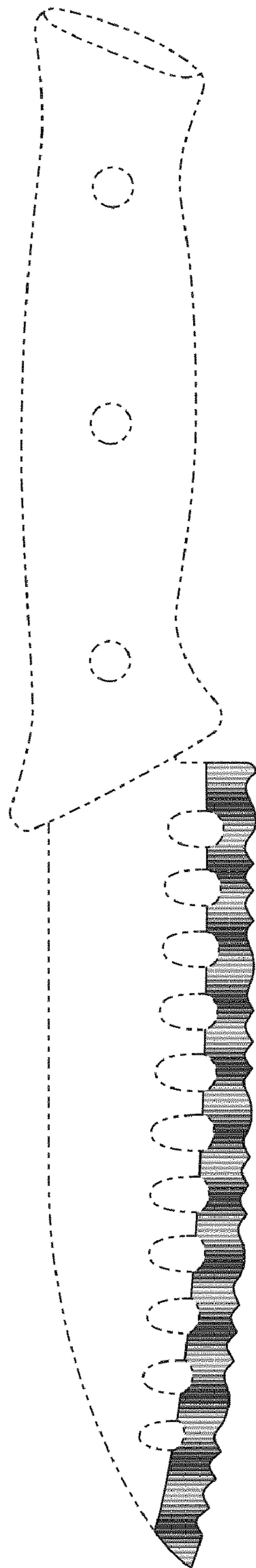

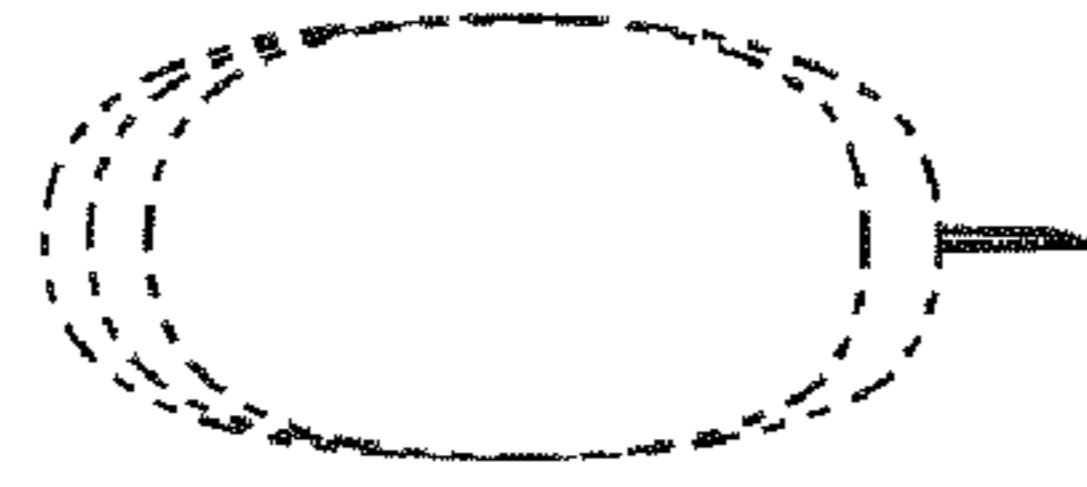

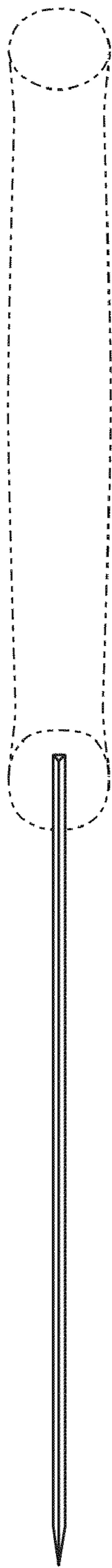
