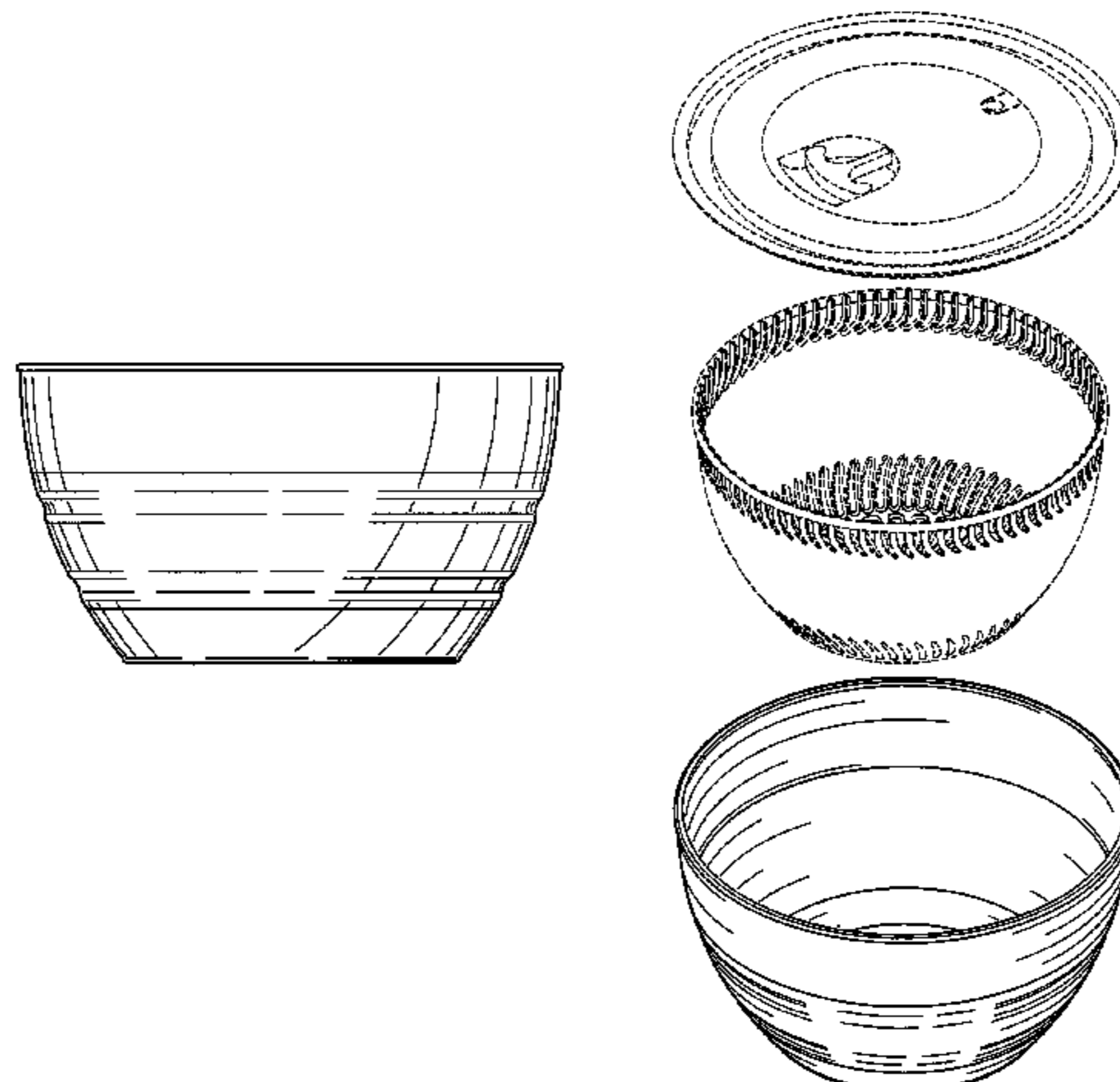
(57) **CLAIM**

I claim the ornamental design for a collapsible salad spinner bowl, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the collapsible salad spinner bowl, showing my new design;  
FIG. 2 is a front view of the collapsible salad spinner bowl, the back, left side, and right side views being identical;  
FIG. 3 is a top view of the collapsible salad spinner bowl;  
FIG. 4 is a bottom view of the collapsible salad spinner bowl;  
and,  
FIG. 5 is an exploded view of the collapsible salad spinner bowl, shown together with a representative strainer basket and lid in which the strainer basket and lid are shown in phantom and form no part of the claimed invention.

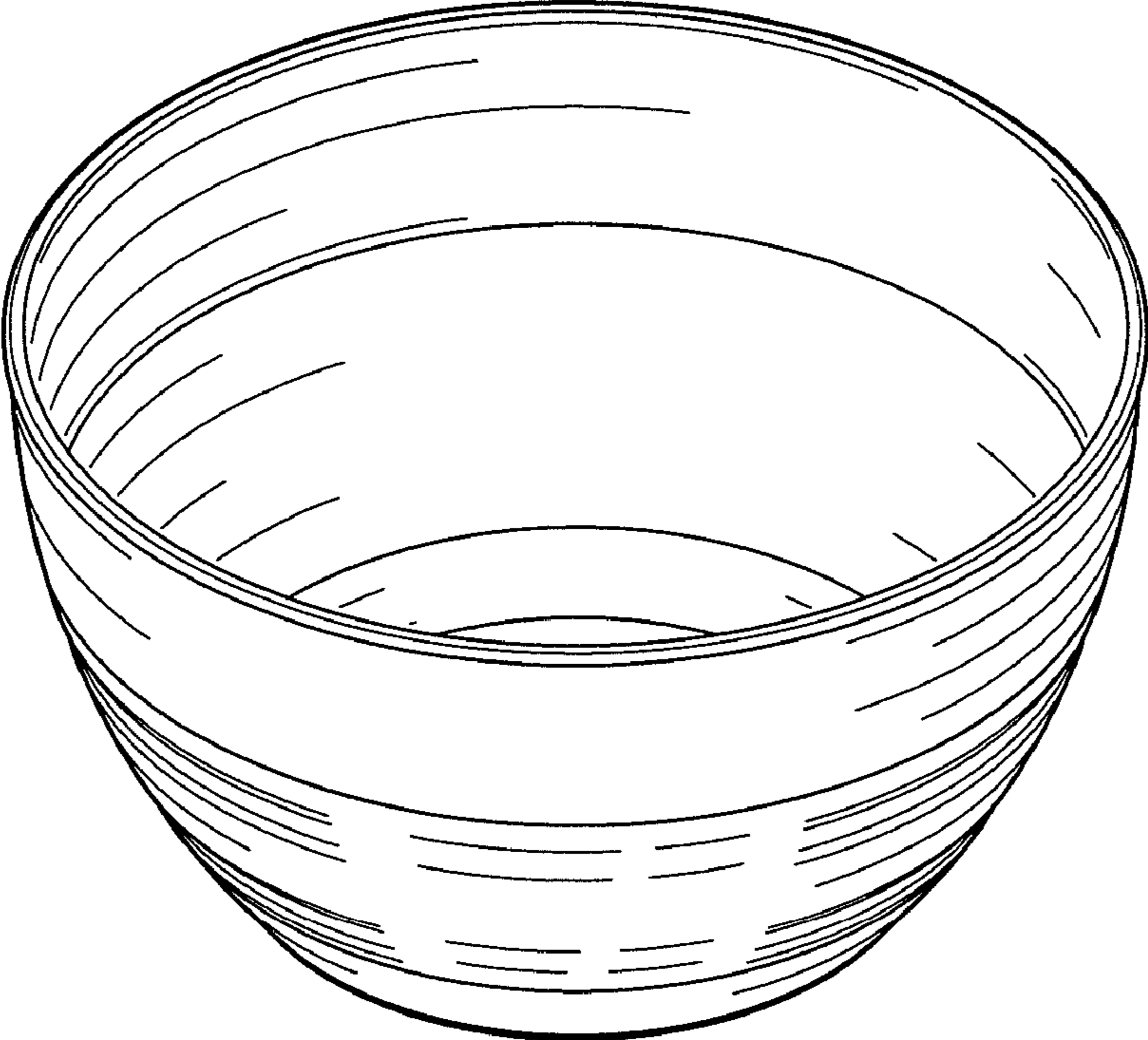

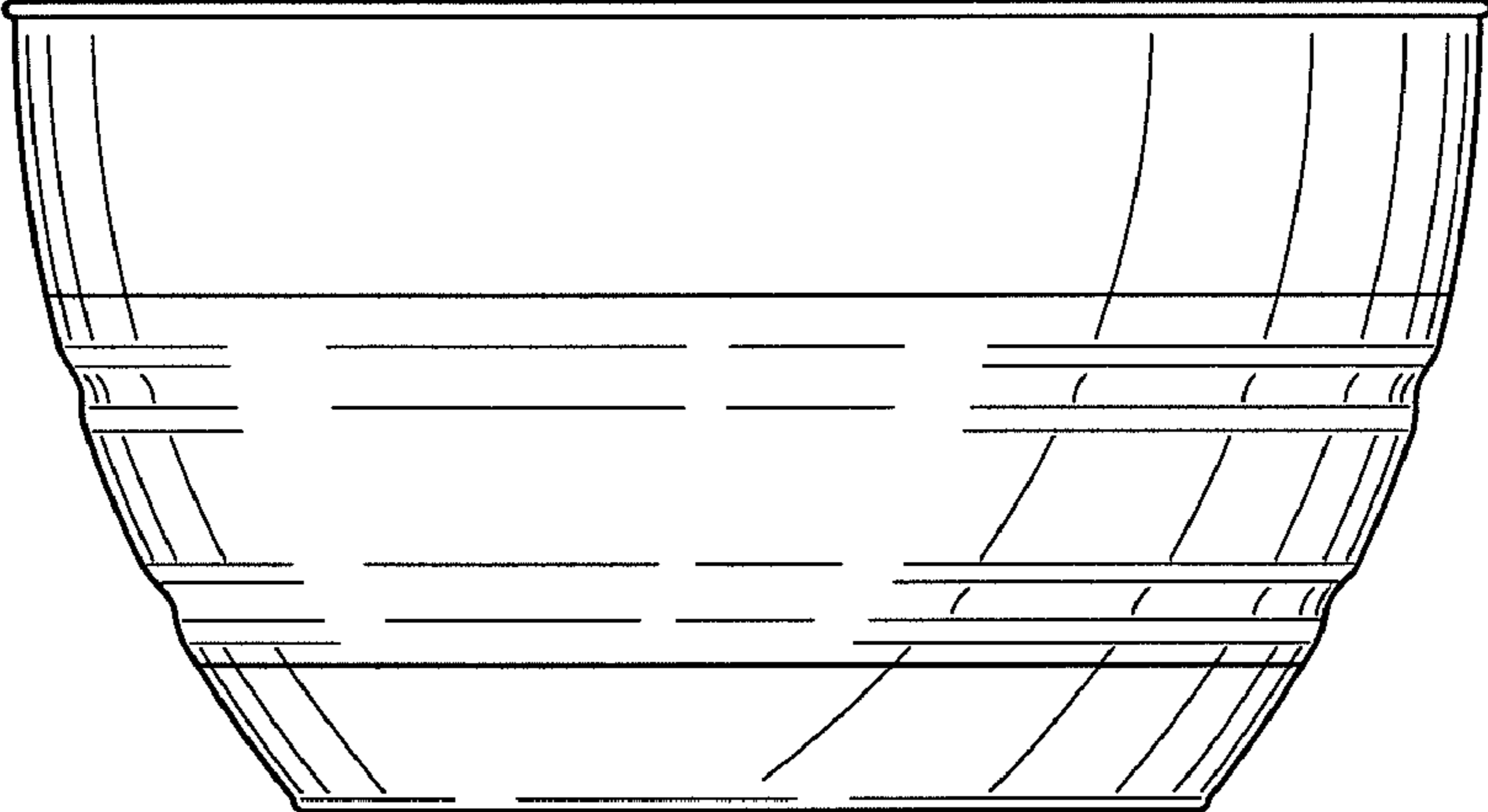

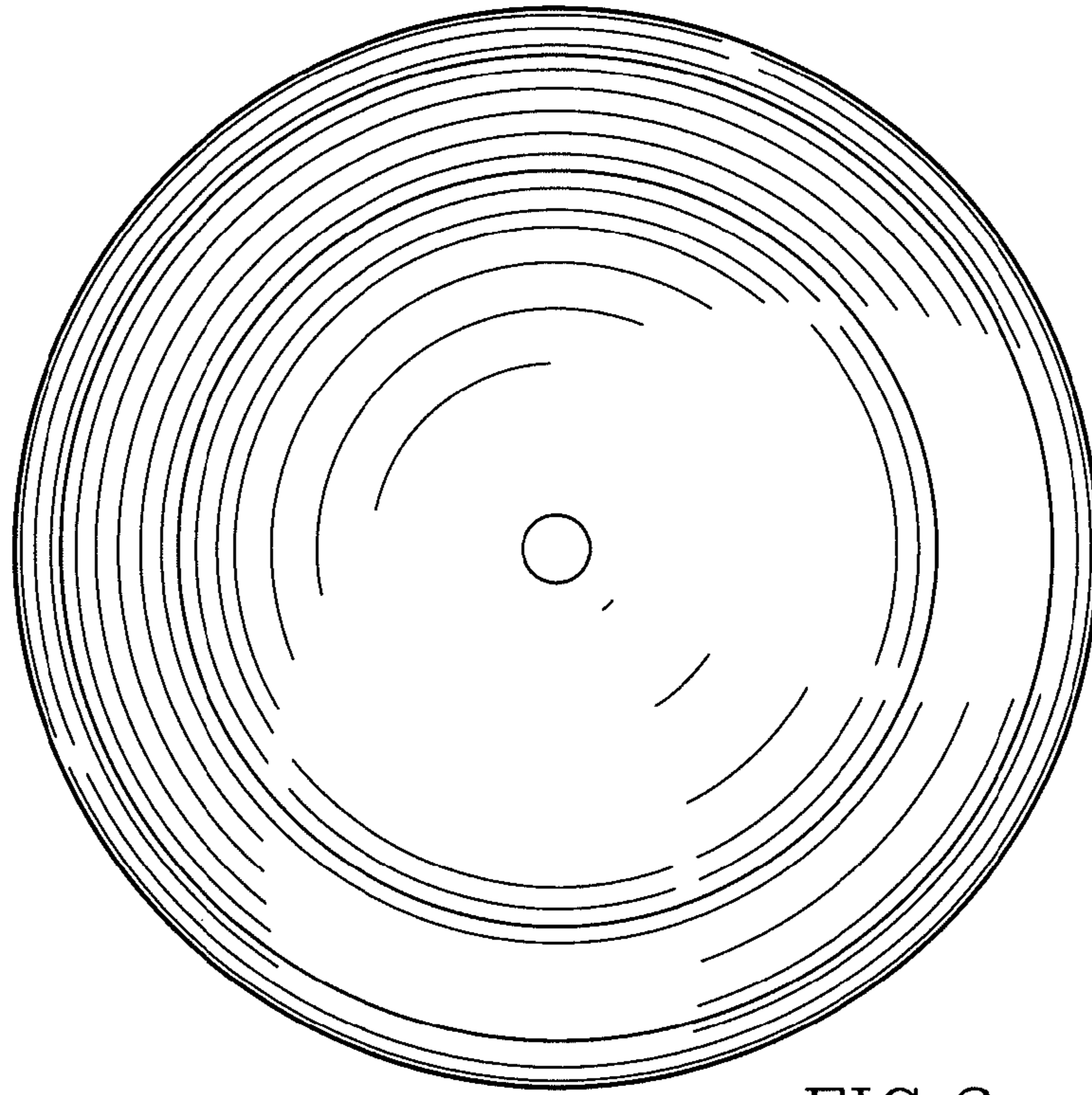

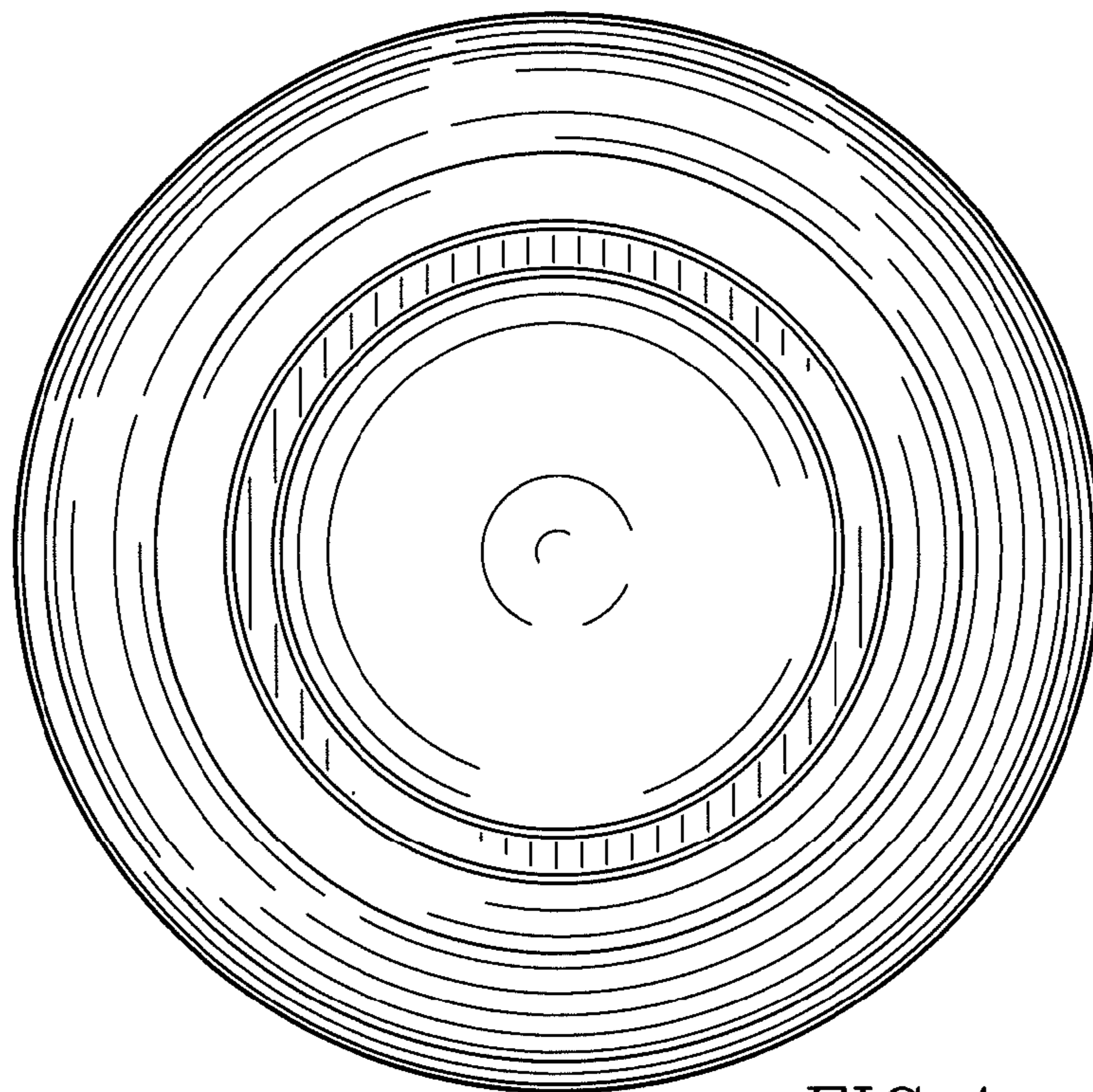

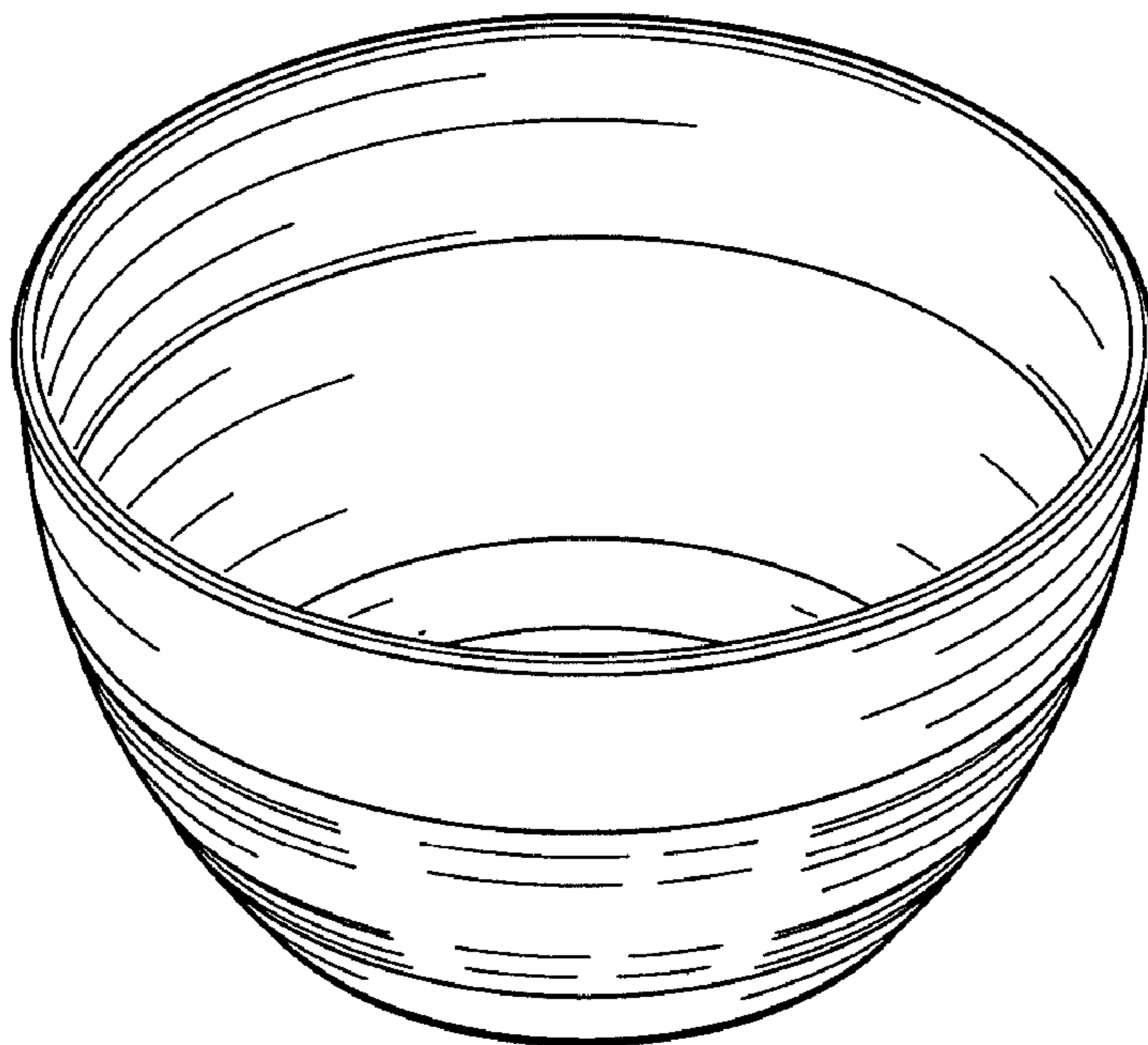
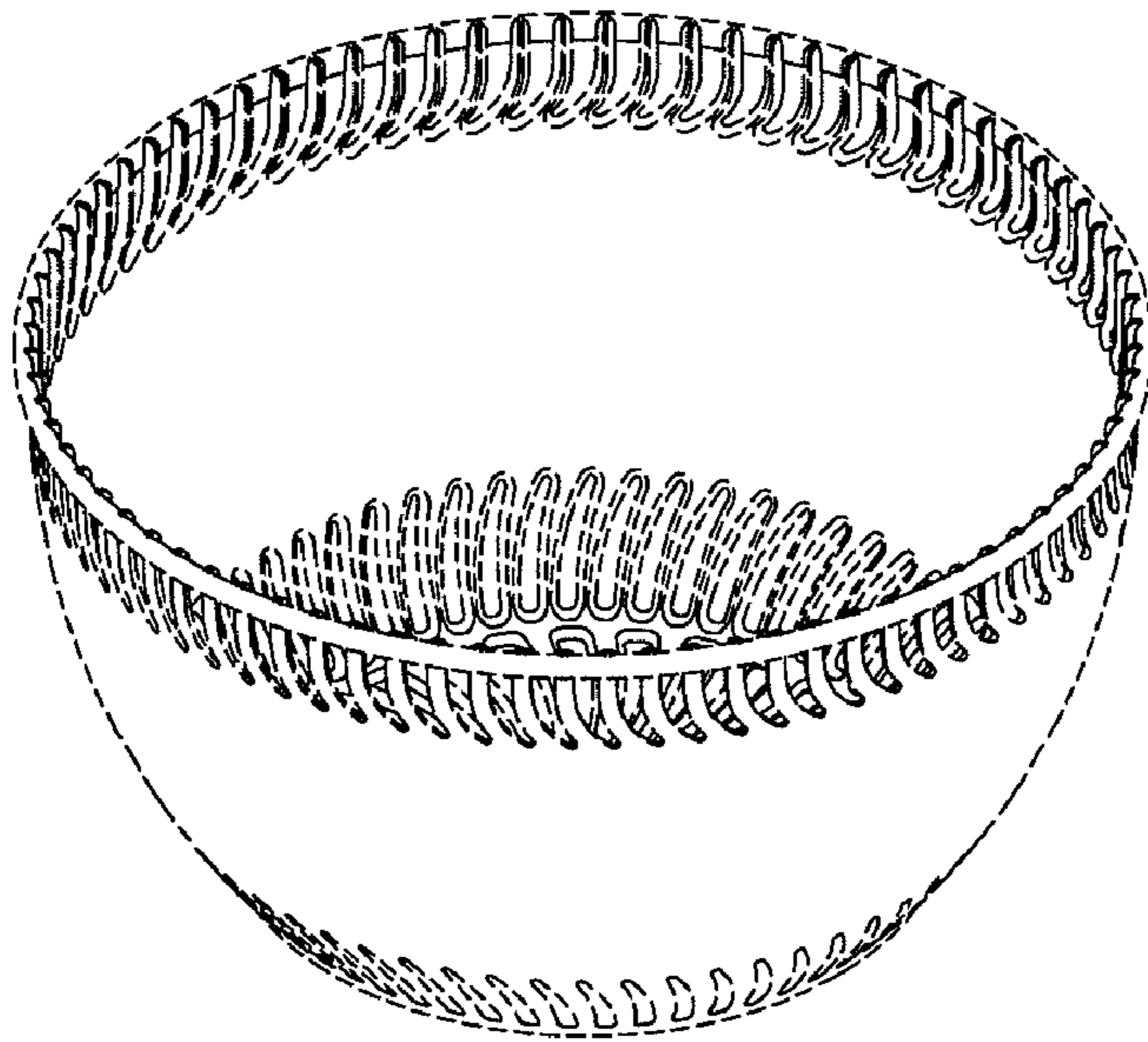
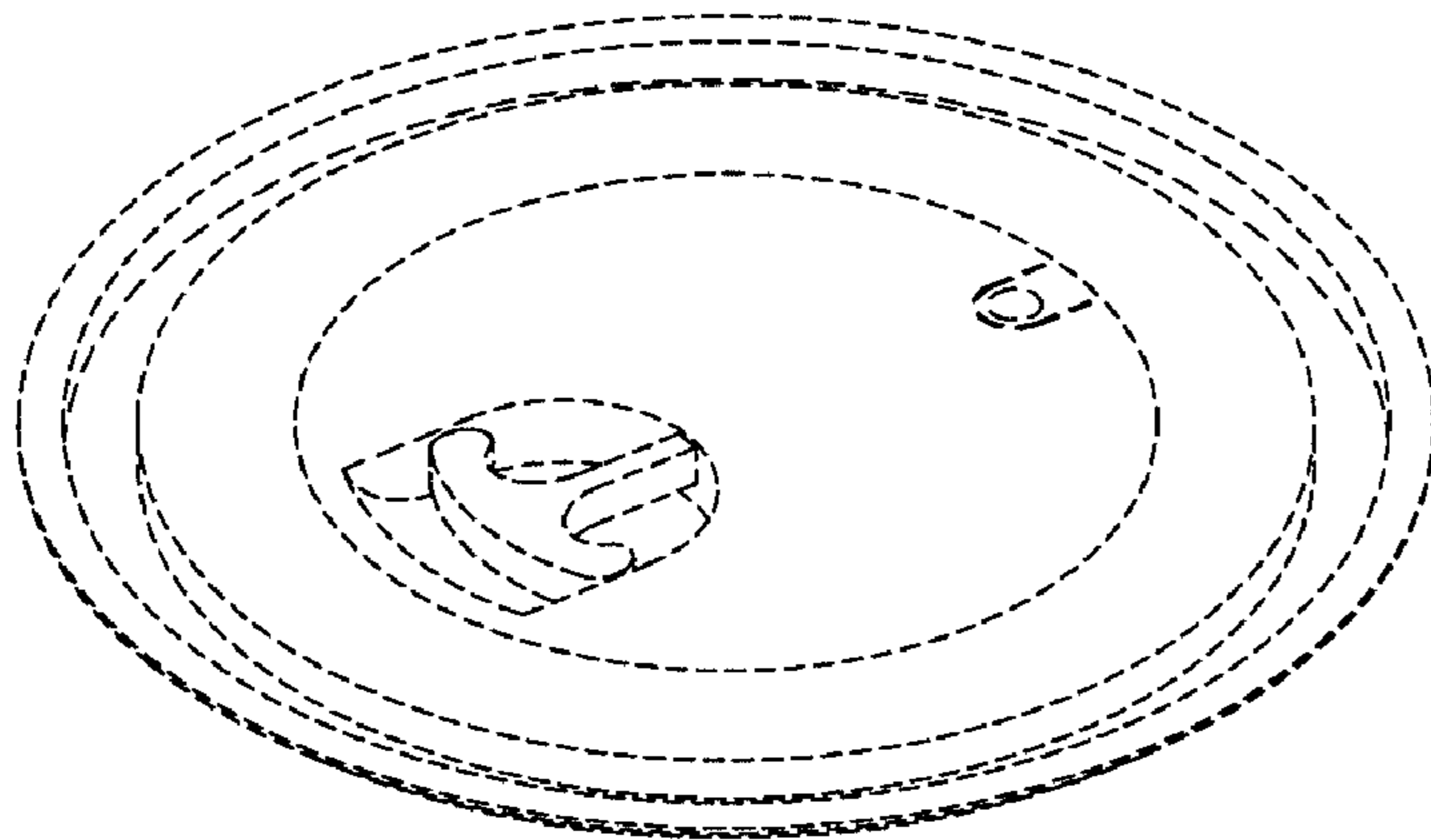
