(57) **CLAIM**

The ornamental design for a cutting board serving tray, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the cutting board serving tray showing my new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a bottom perspective view thereof;

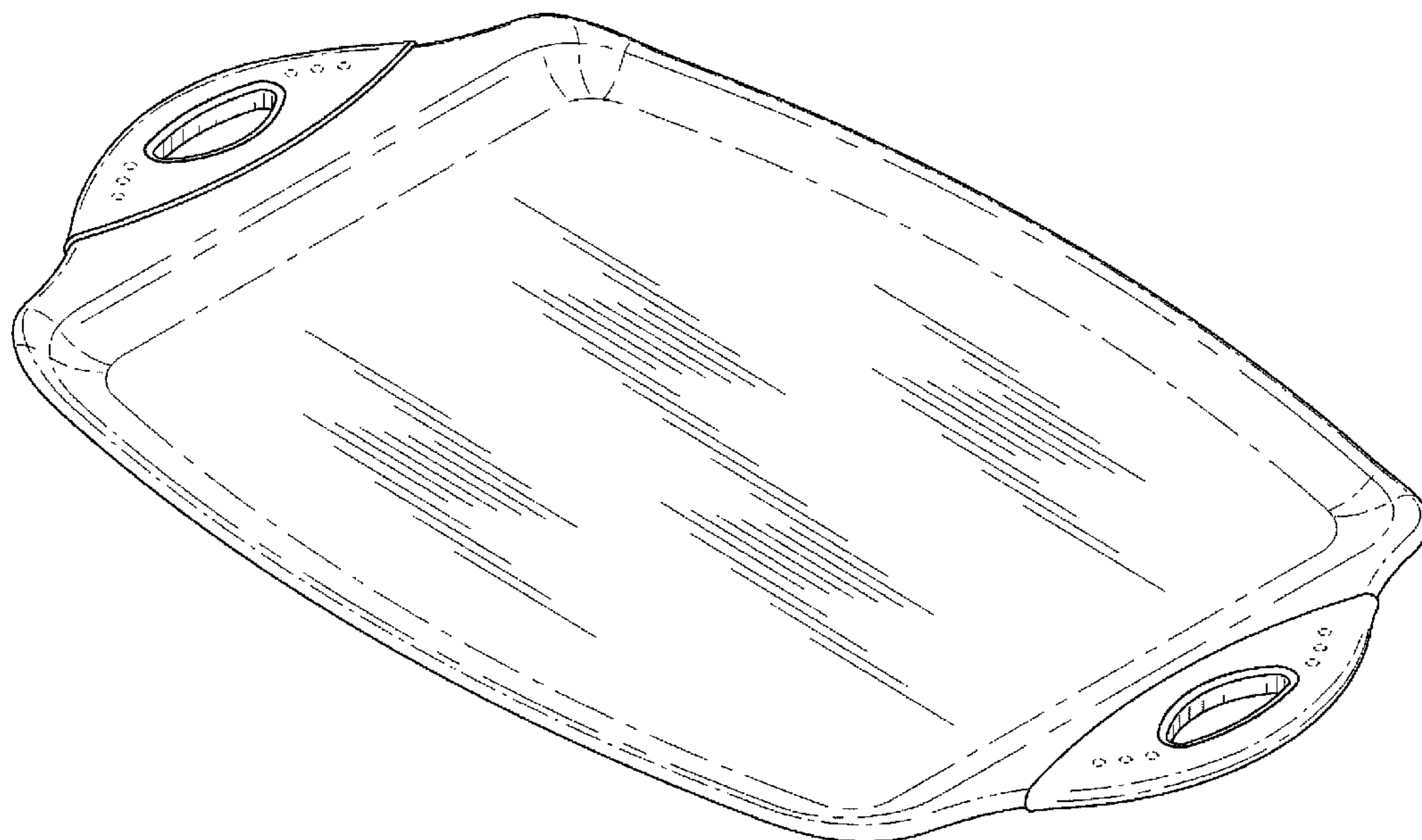
FIG. 4 is a right side elevational view thereof; and,

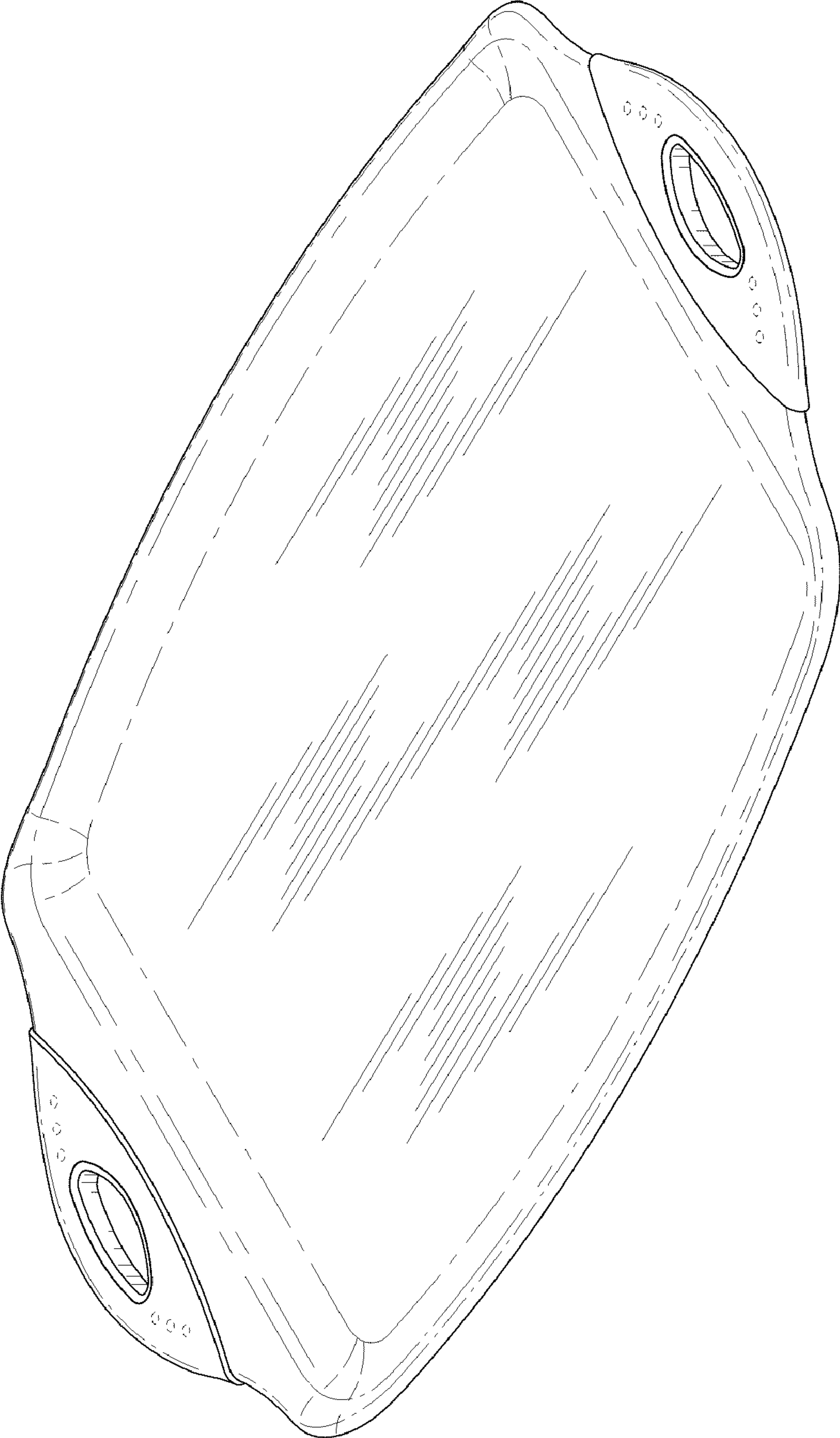

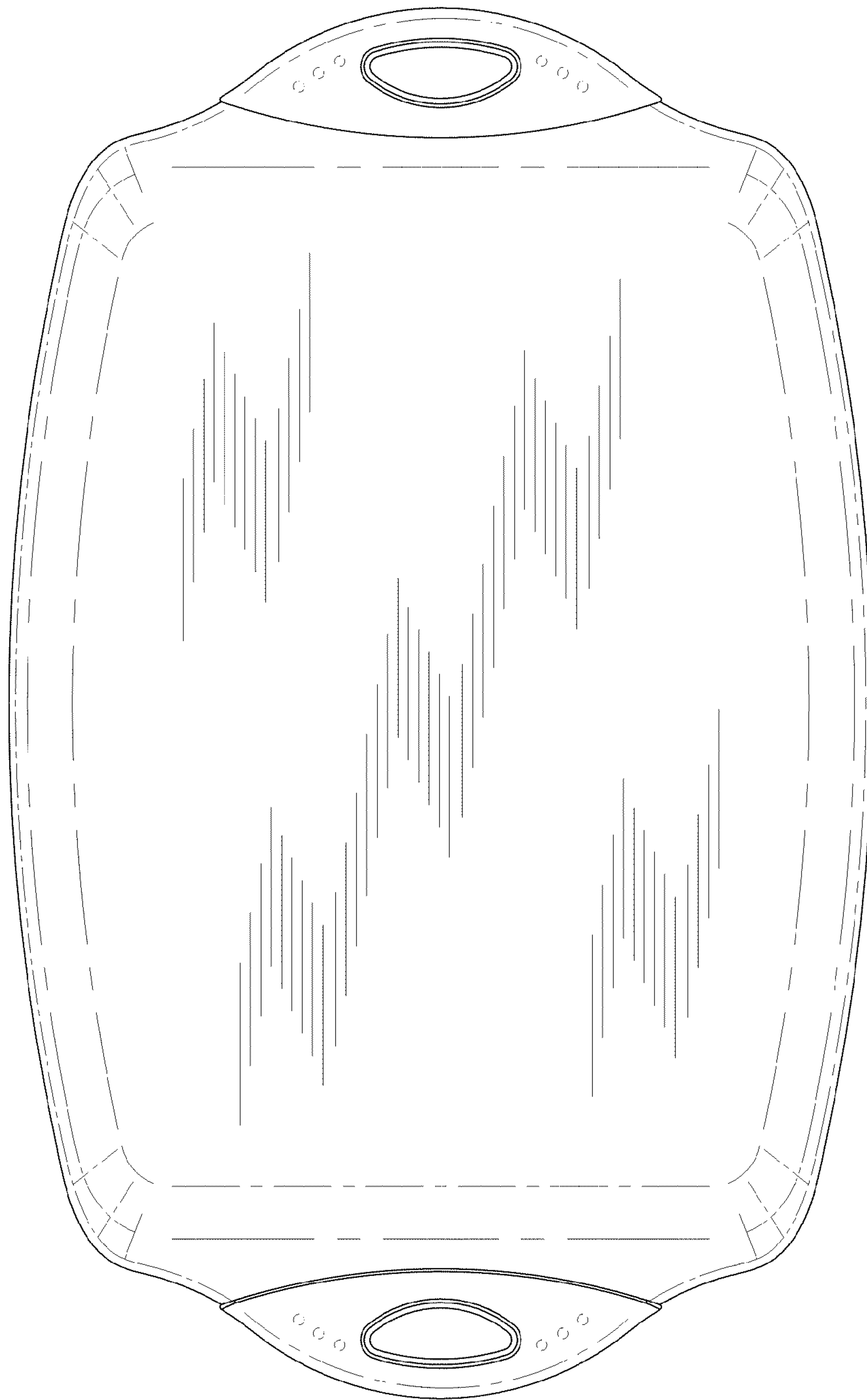

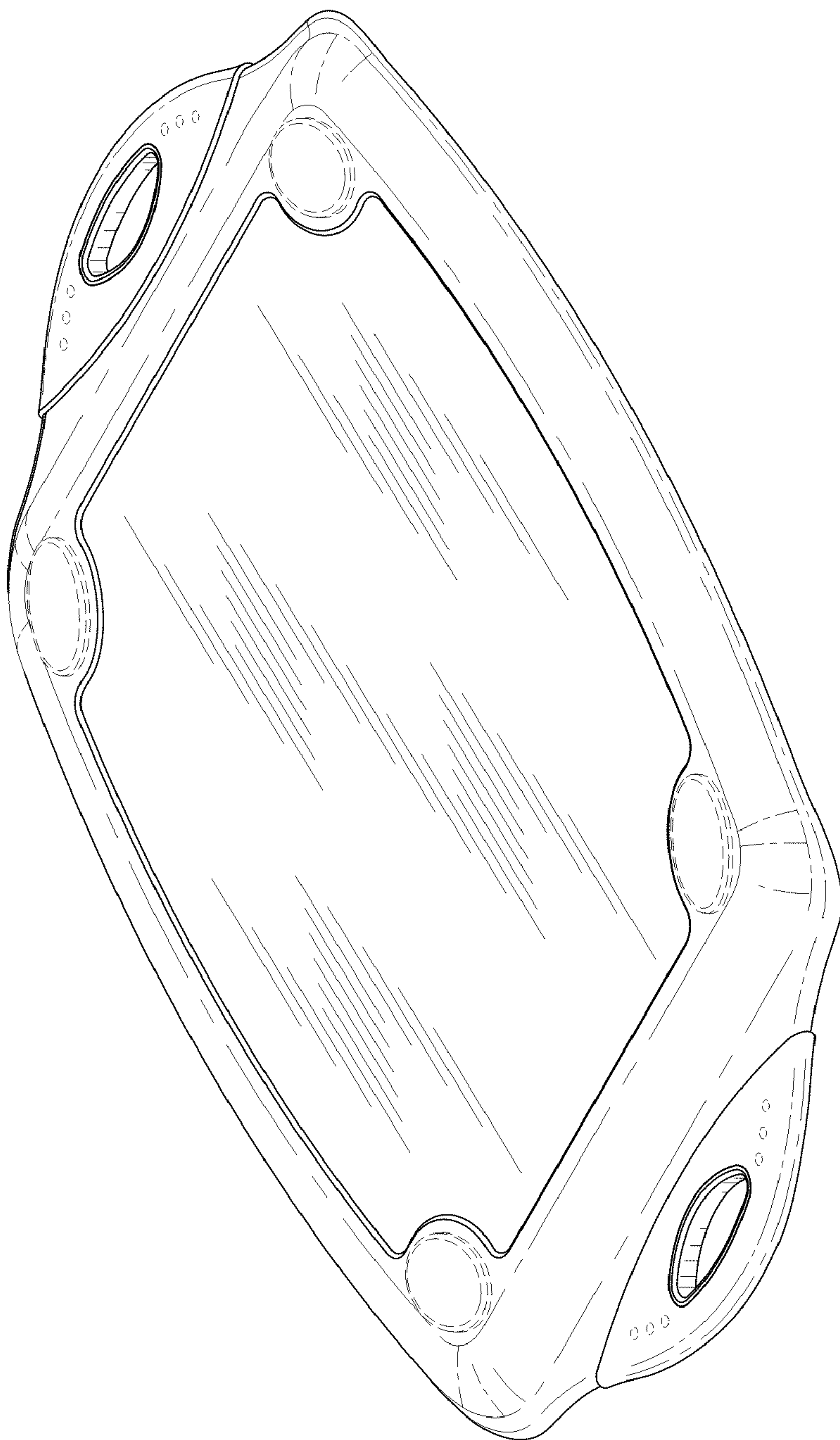

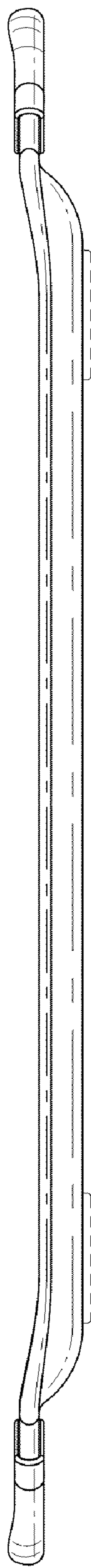

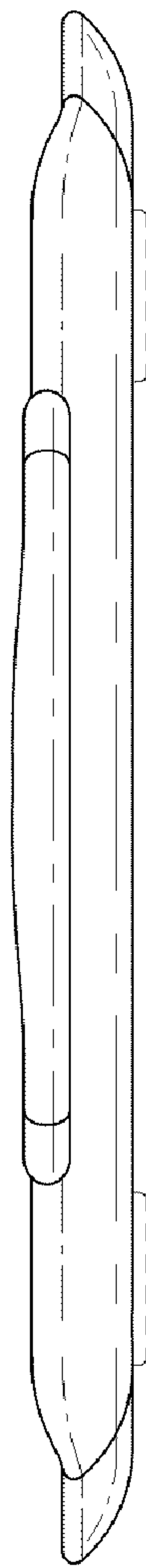
