FIG. 3 is a right side elevation view of FIG. 1.

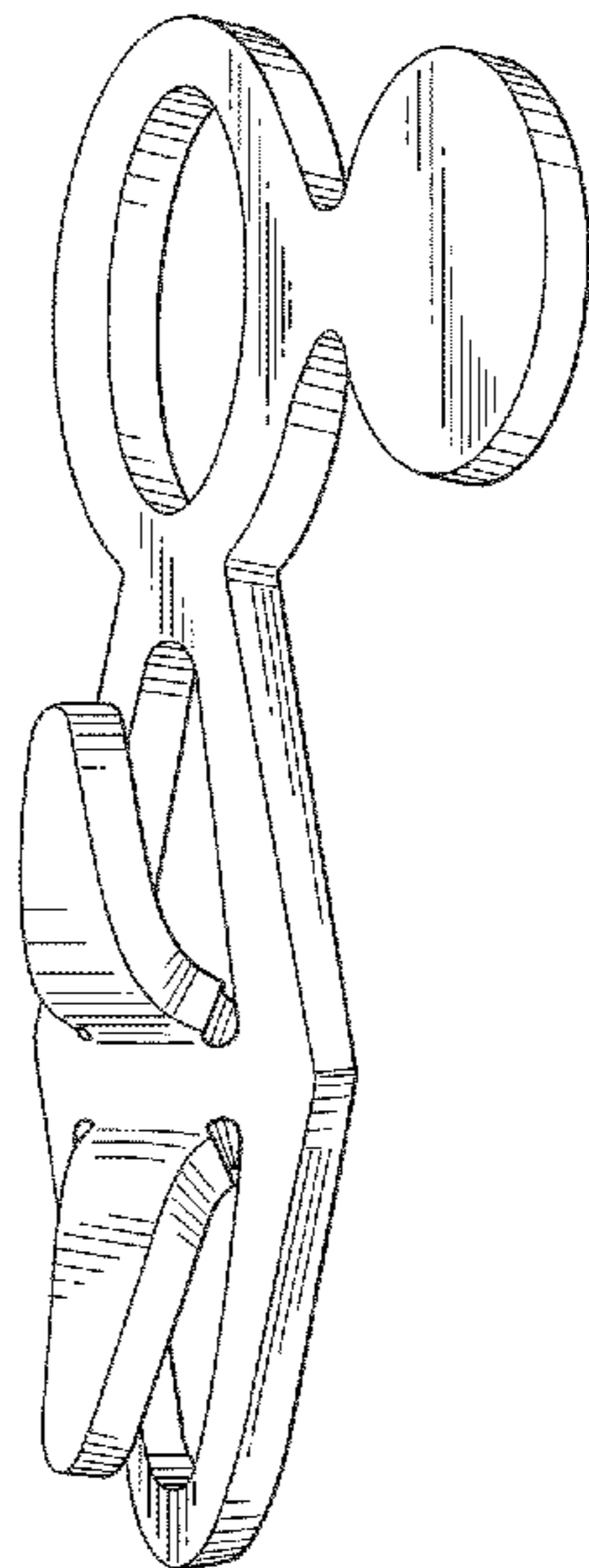
FIG. 4 is a left elevation view of FIG. 1.

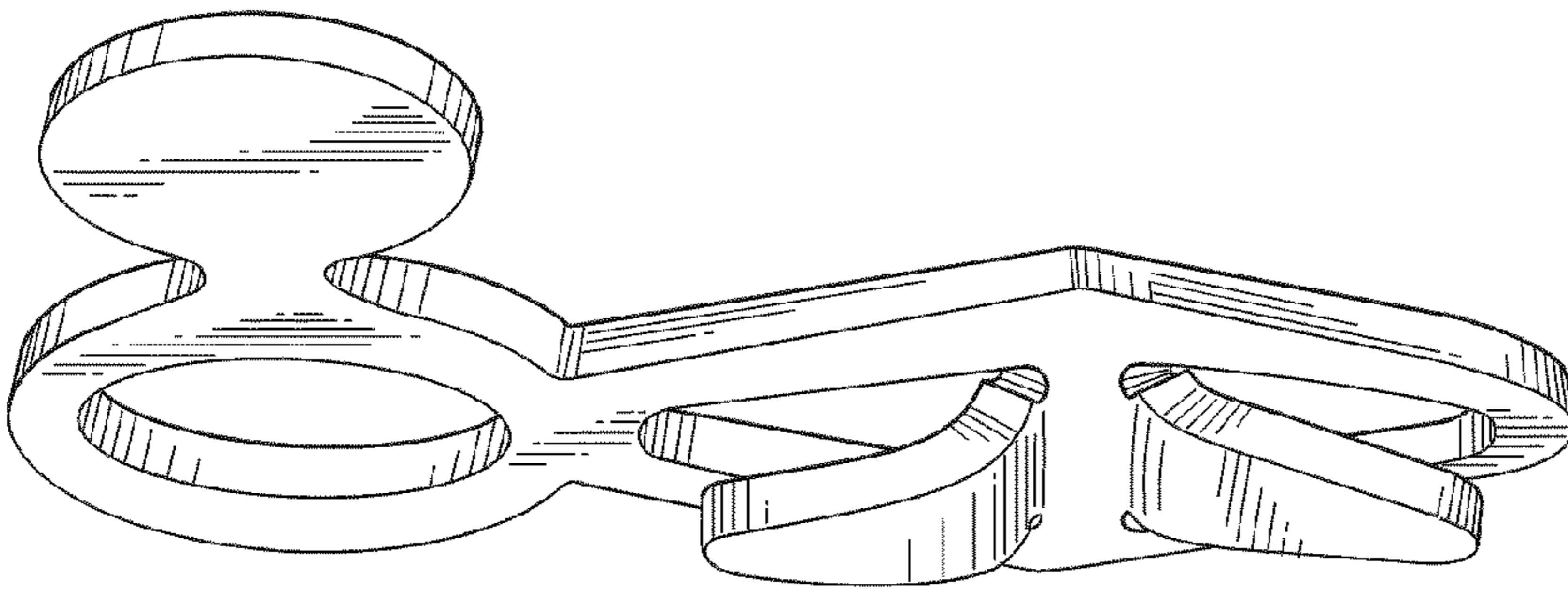

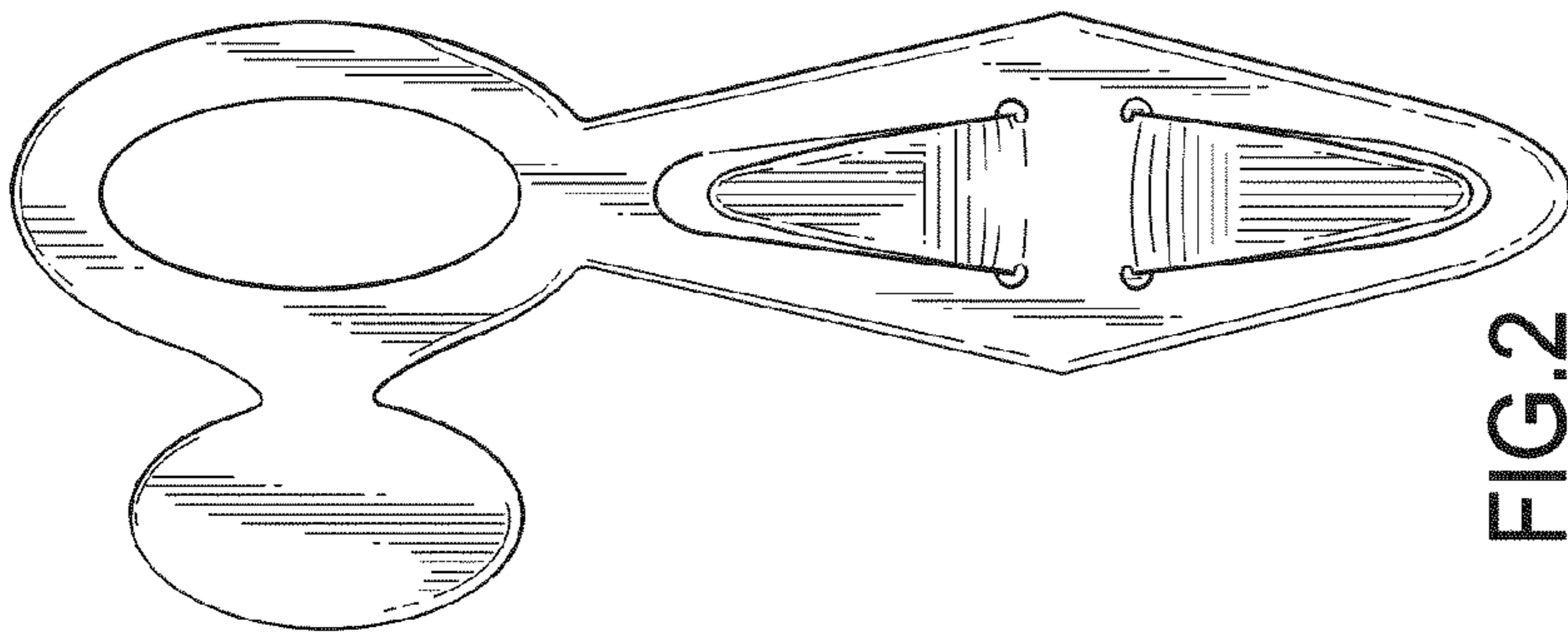

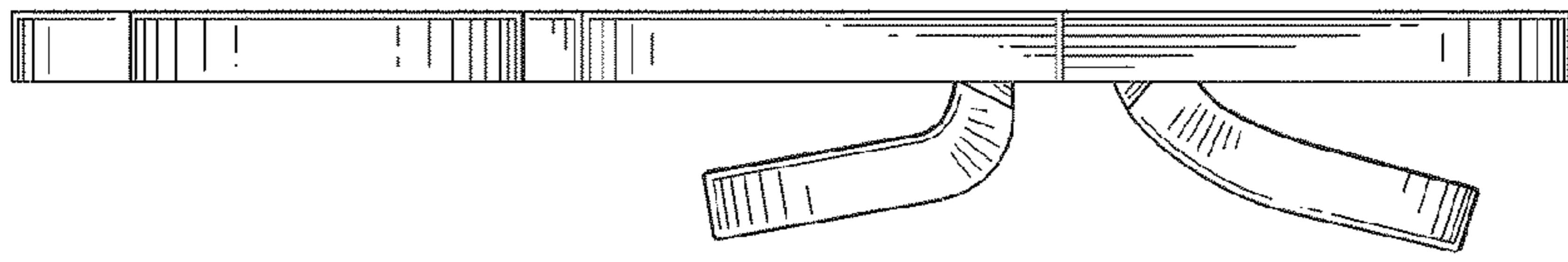

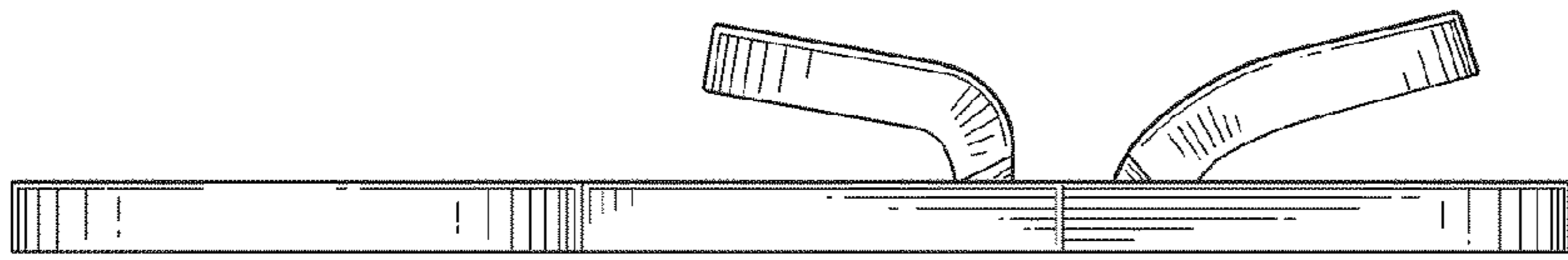

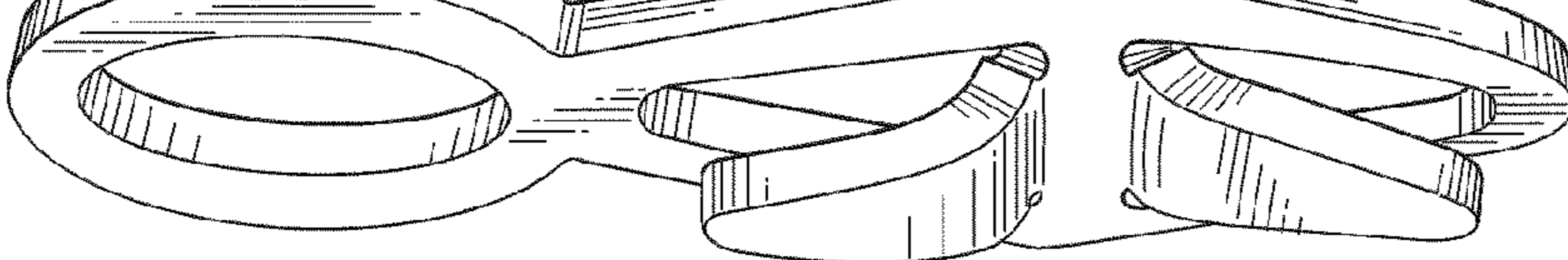

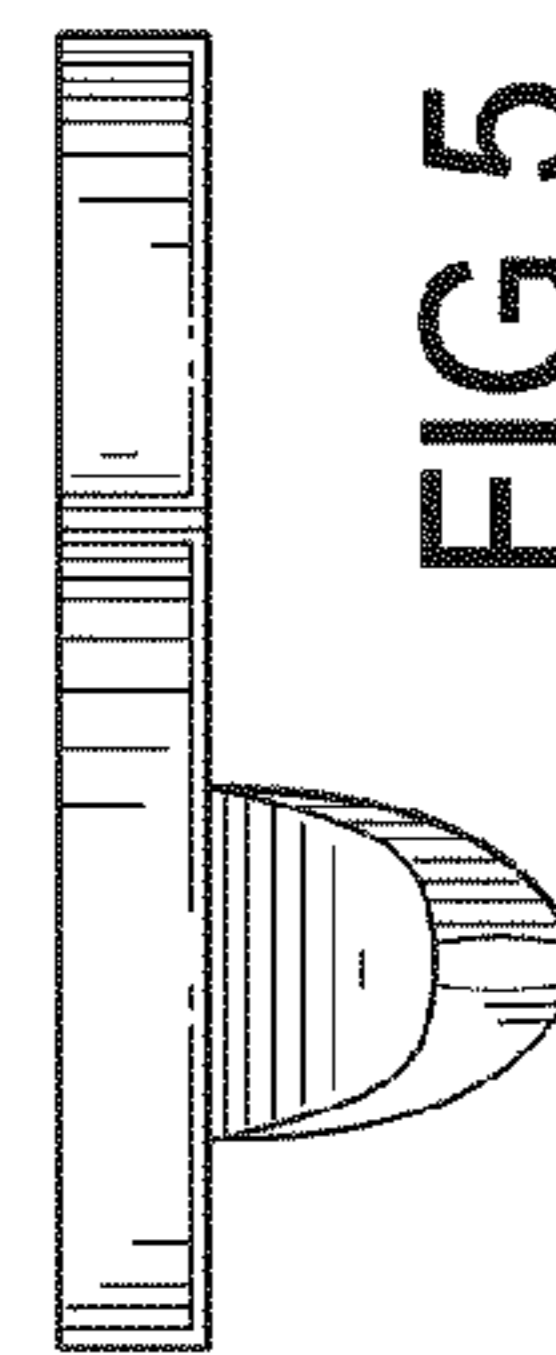

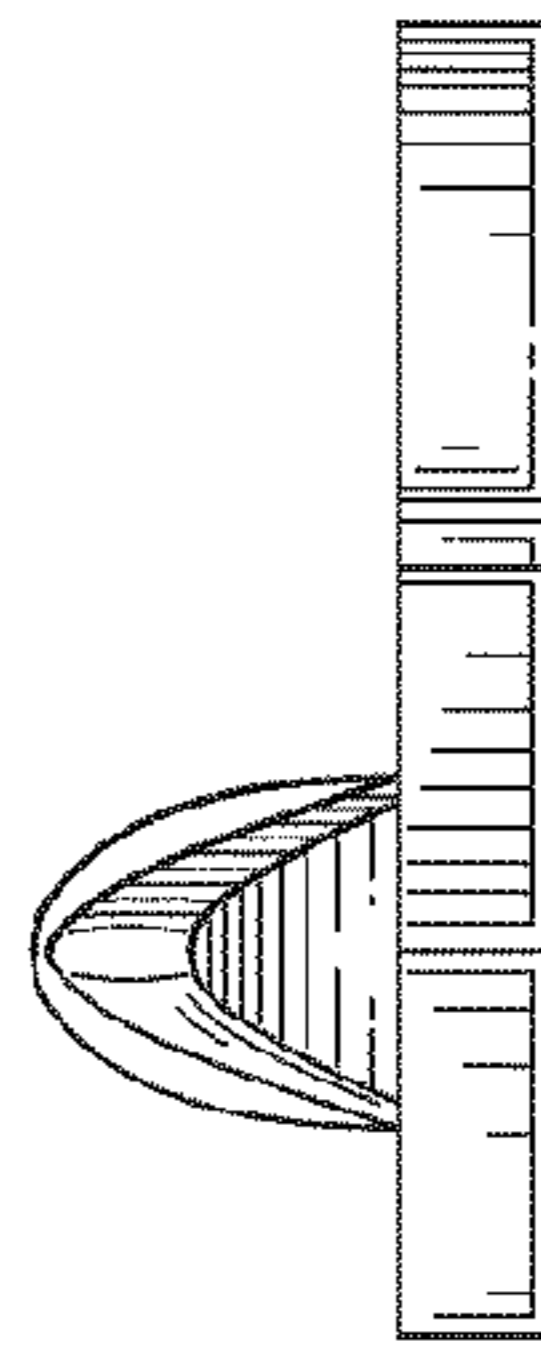
