The broken line showing of a partial rope is included for the purpose of illustrating environment and forms no part of the claimed design.

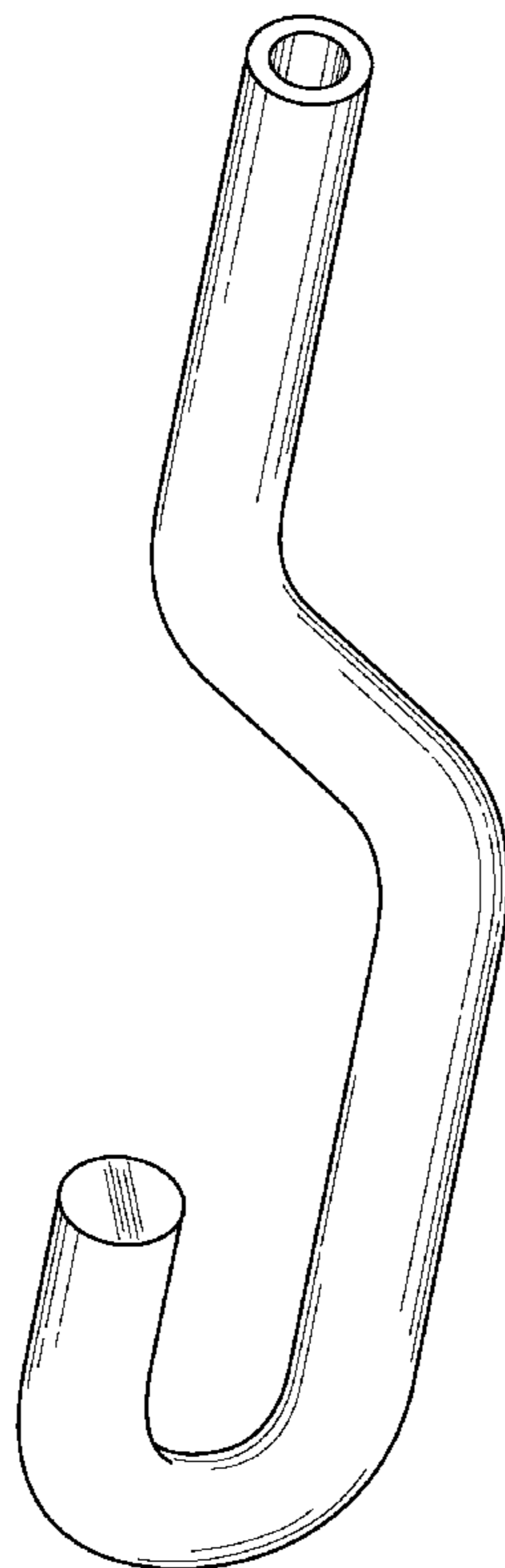

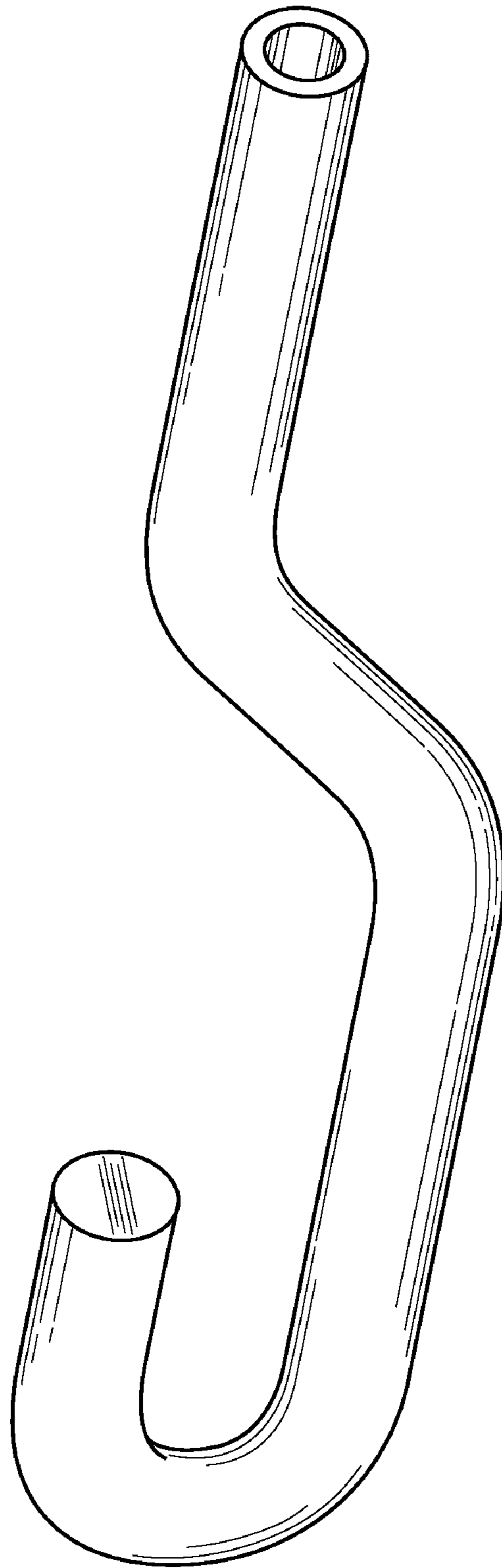

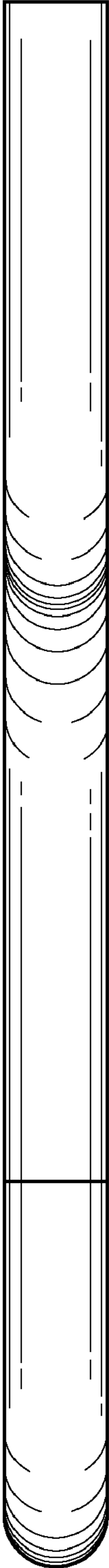

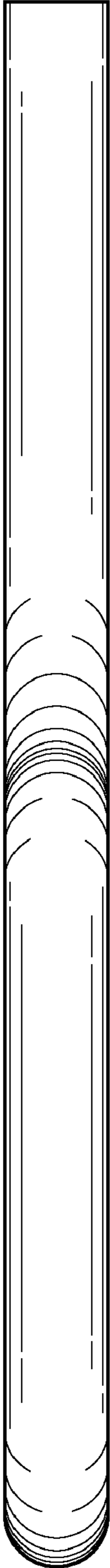

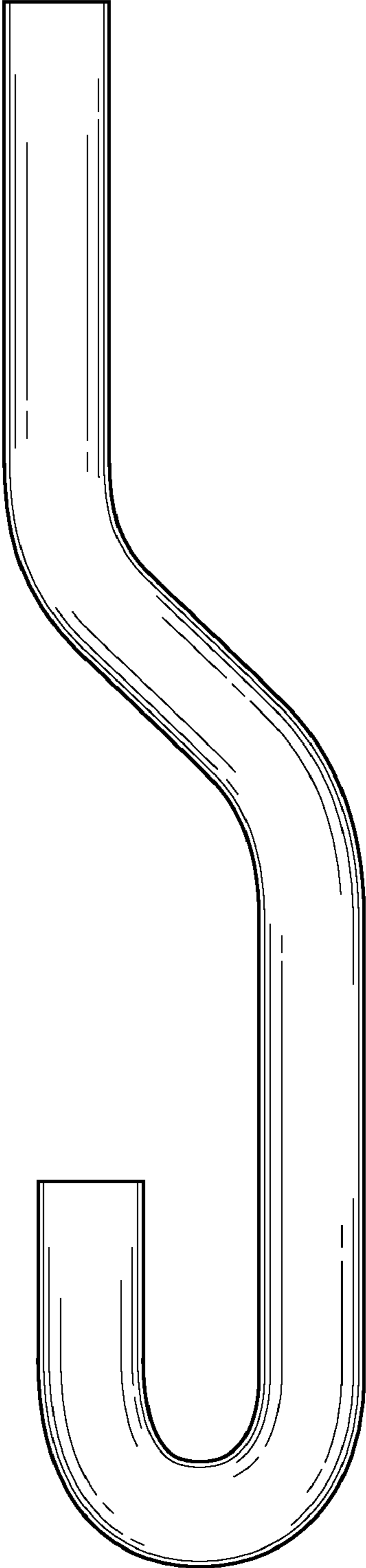

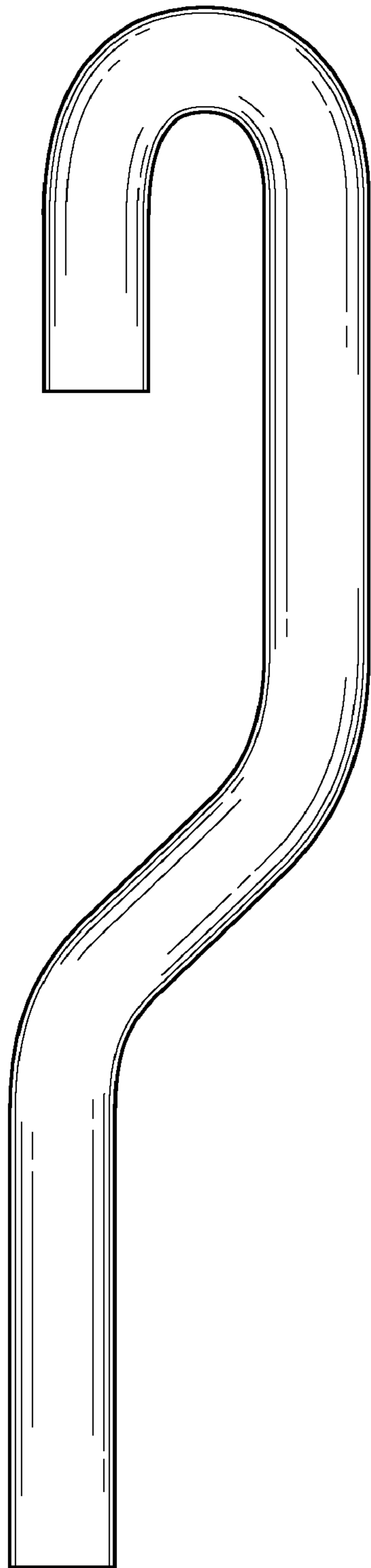

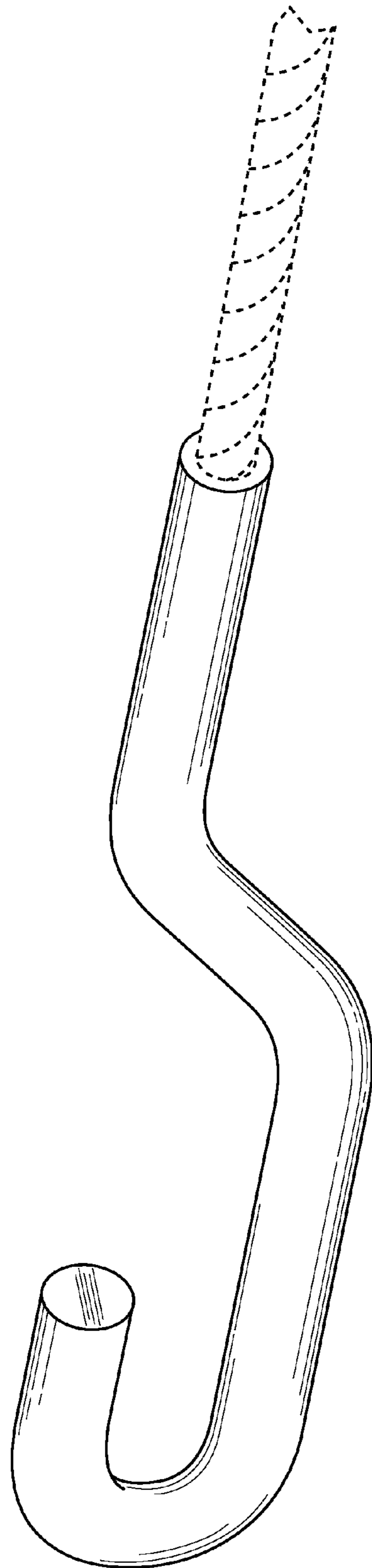
