FIG. 2 is a bottom plan view thereof.

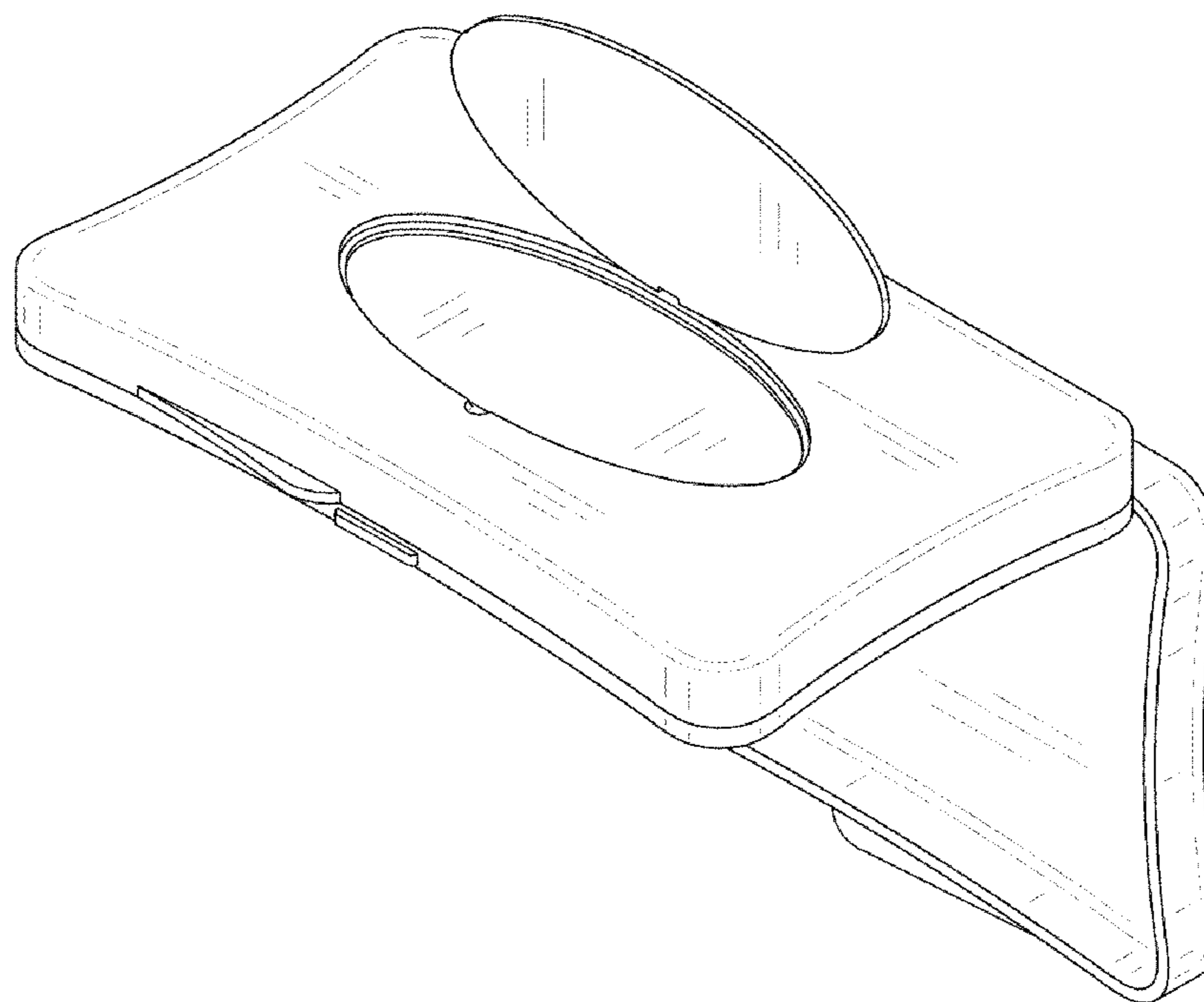
FIG. 3 is a side elevation view thereof.

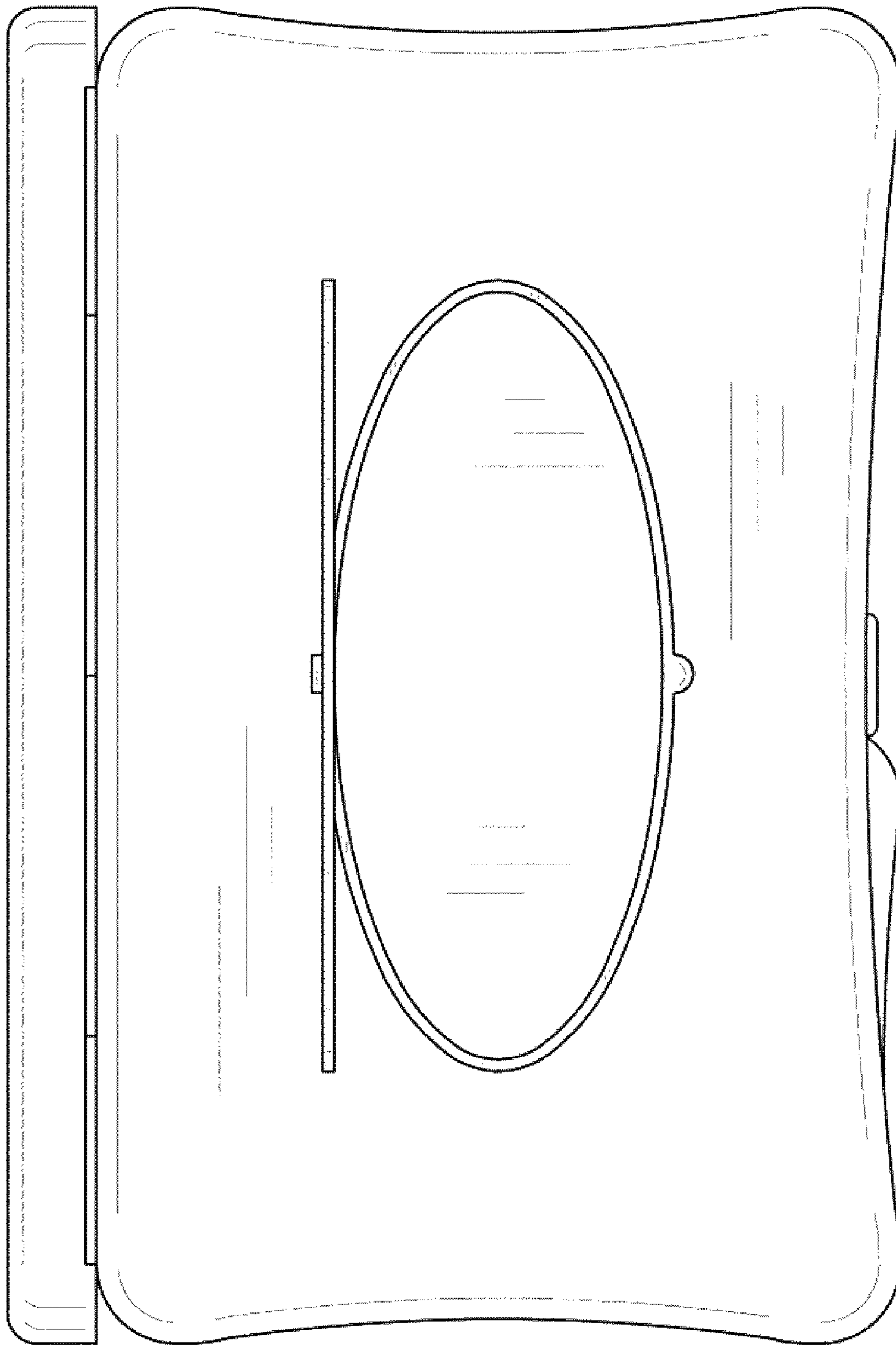

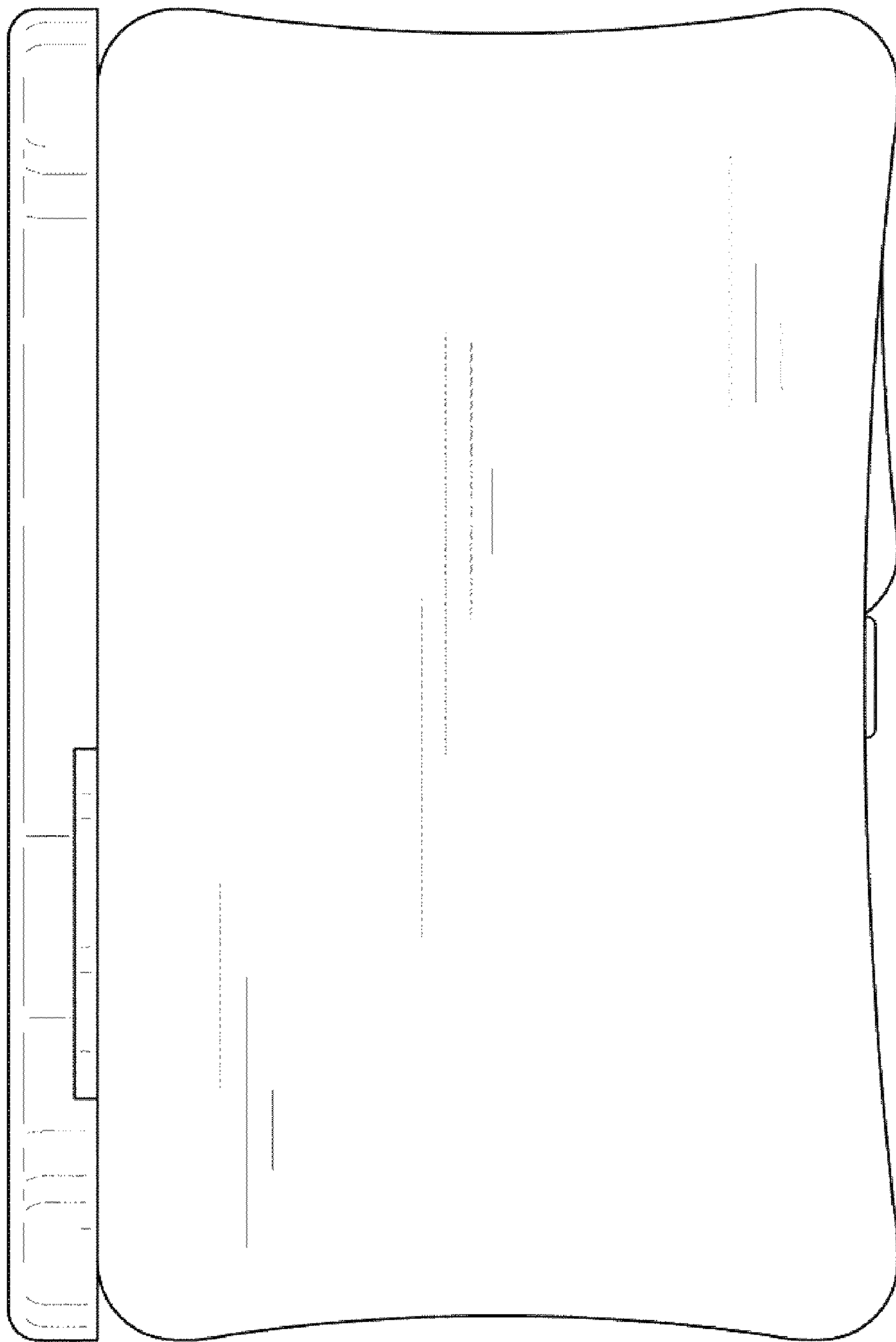

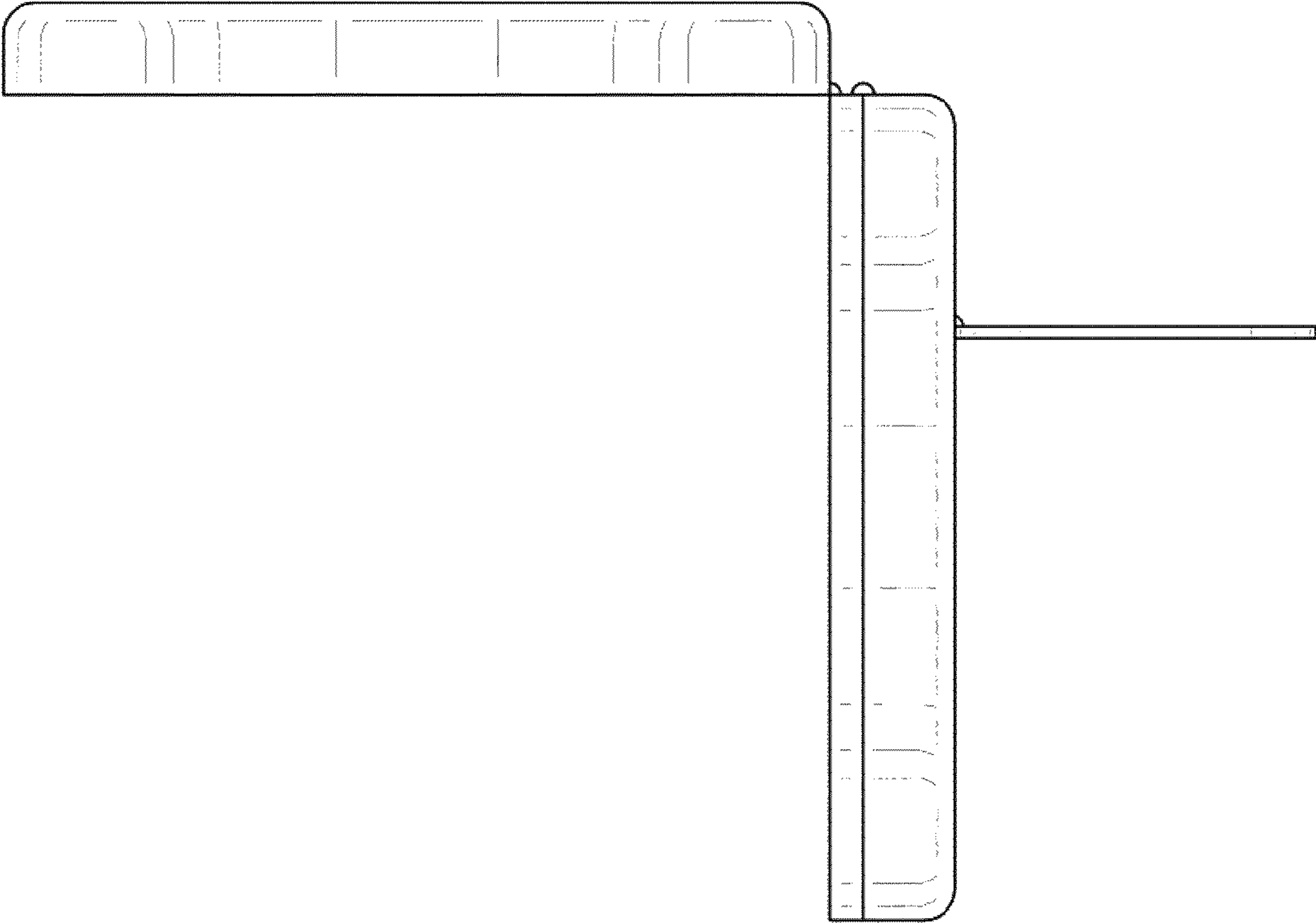

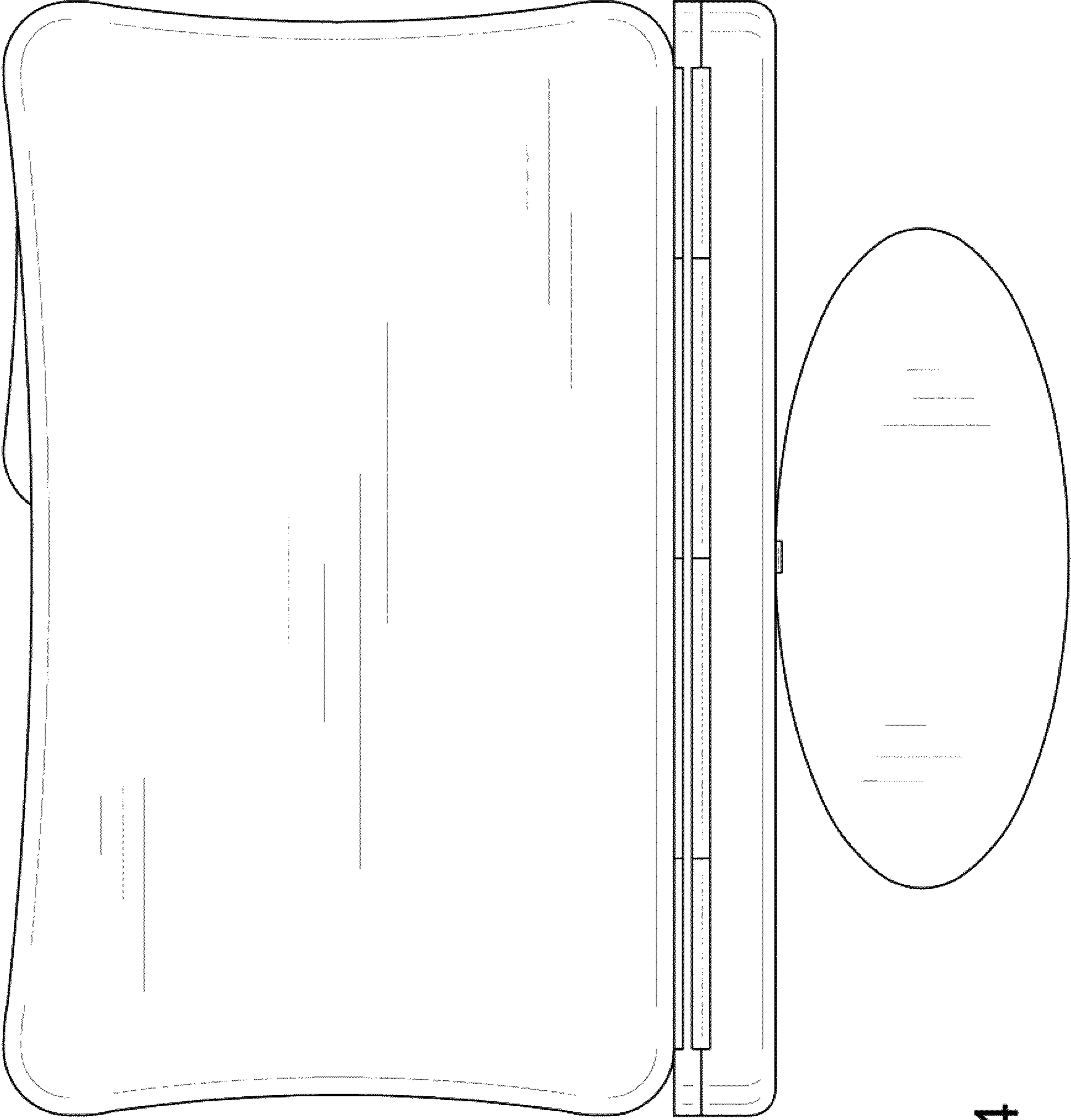
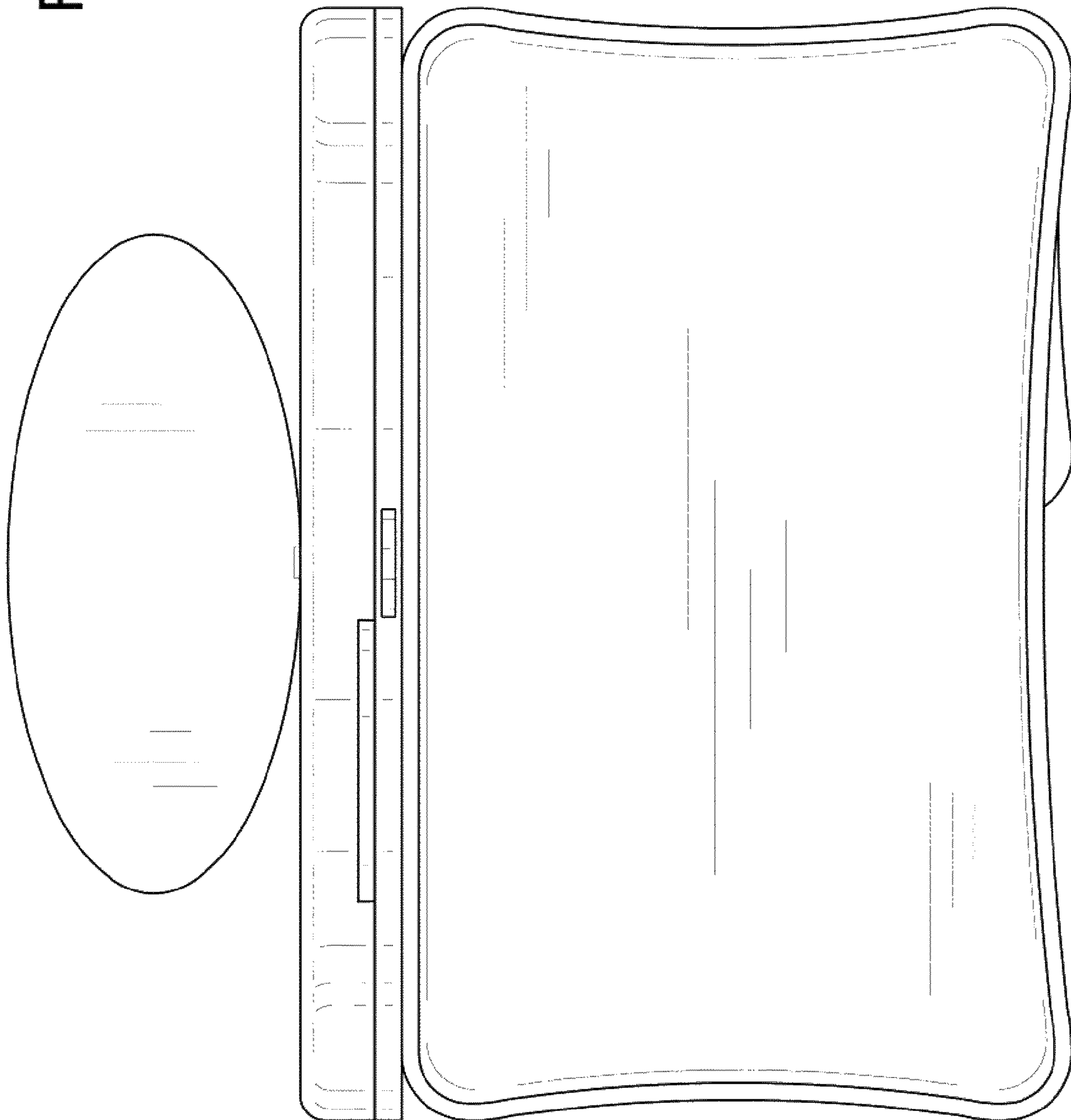

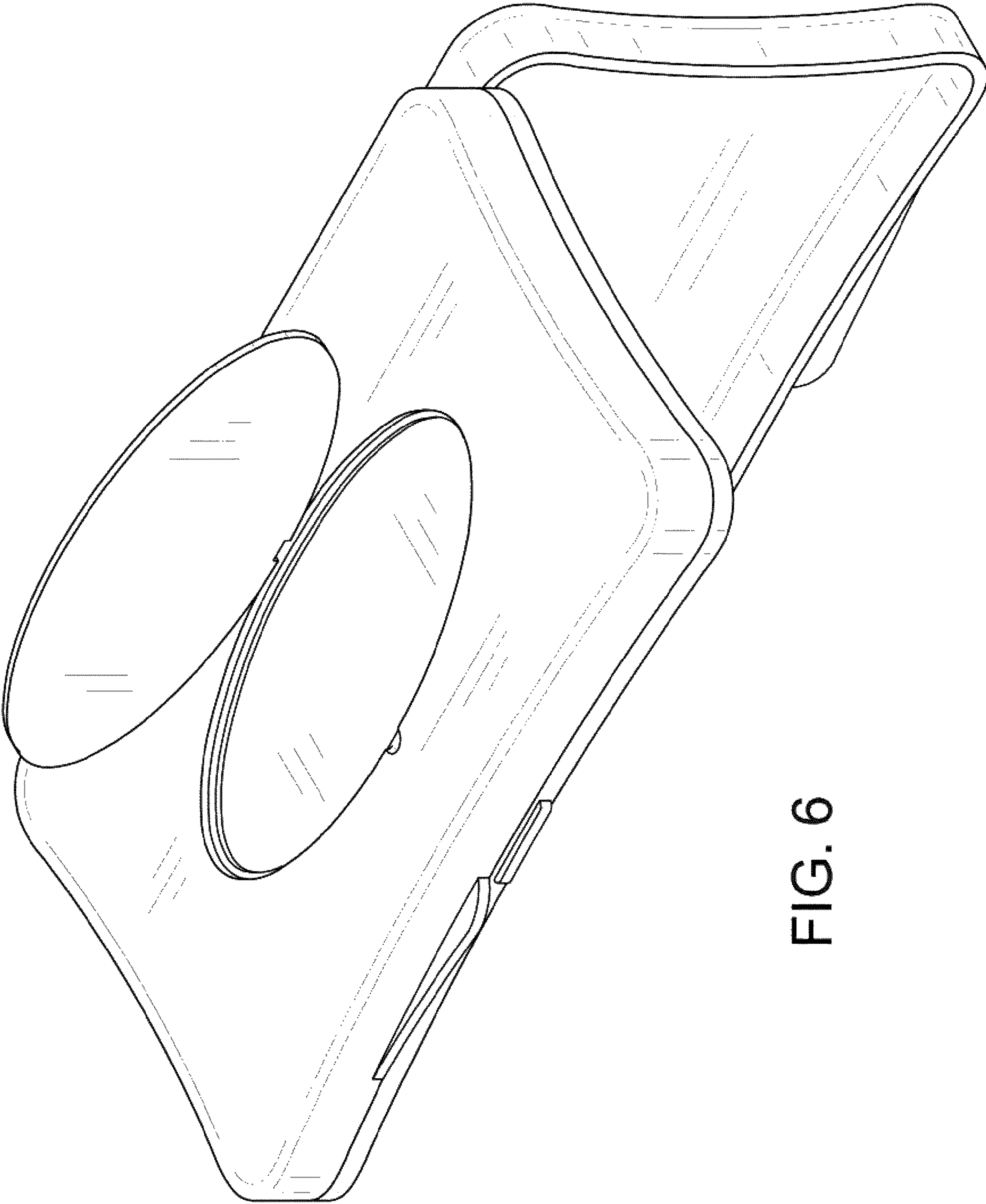
