What is claimed is the ornamental design for a seashell rock garden, as shown and described.

DESCRIPTION

FIG. 4 is a front elevational view thereof;

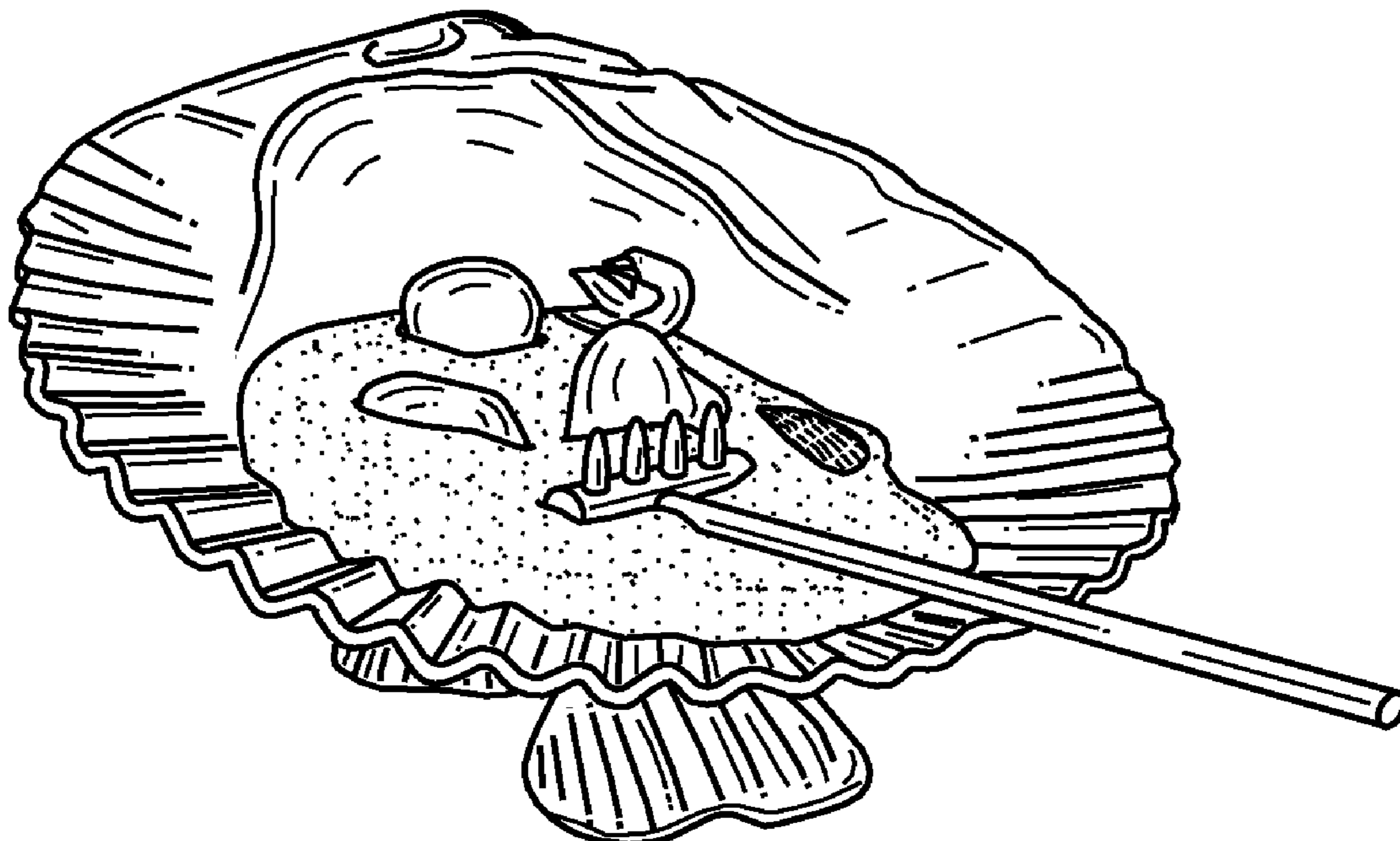
FIG. 5 is a right-side elevational view thereof;

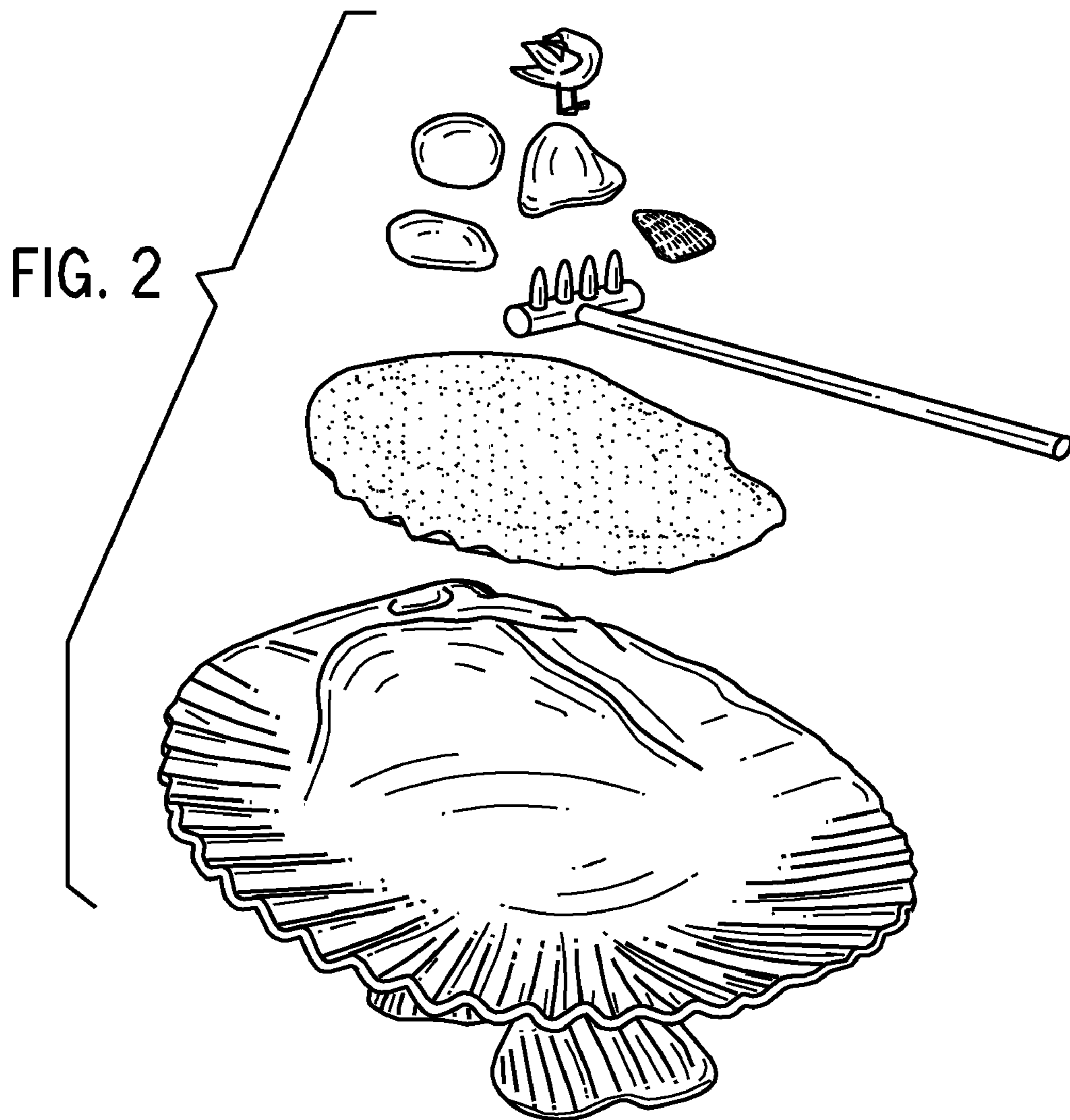
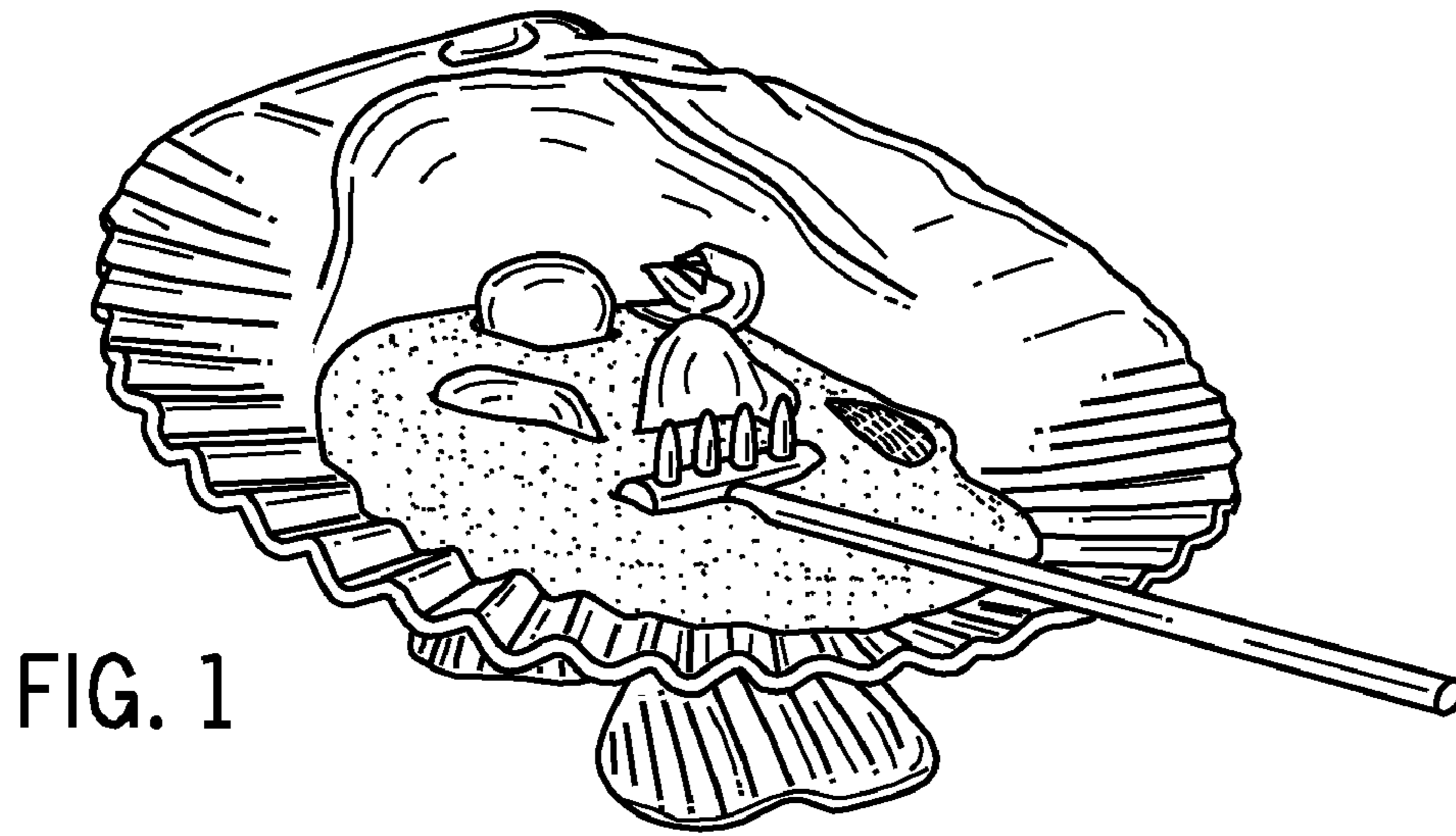

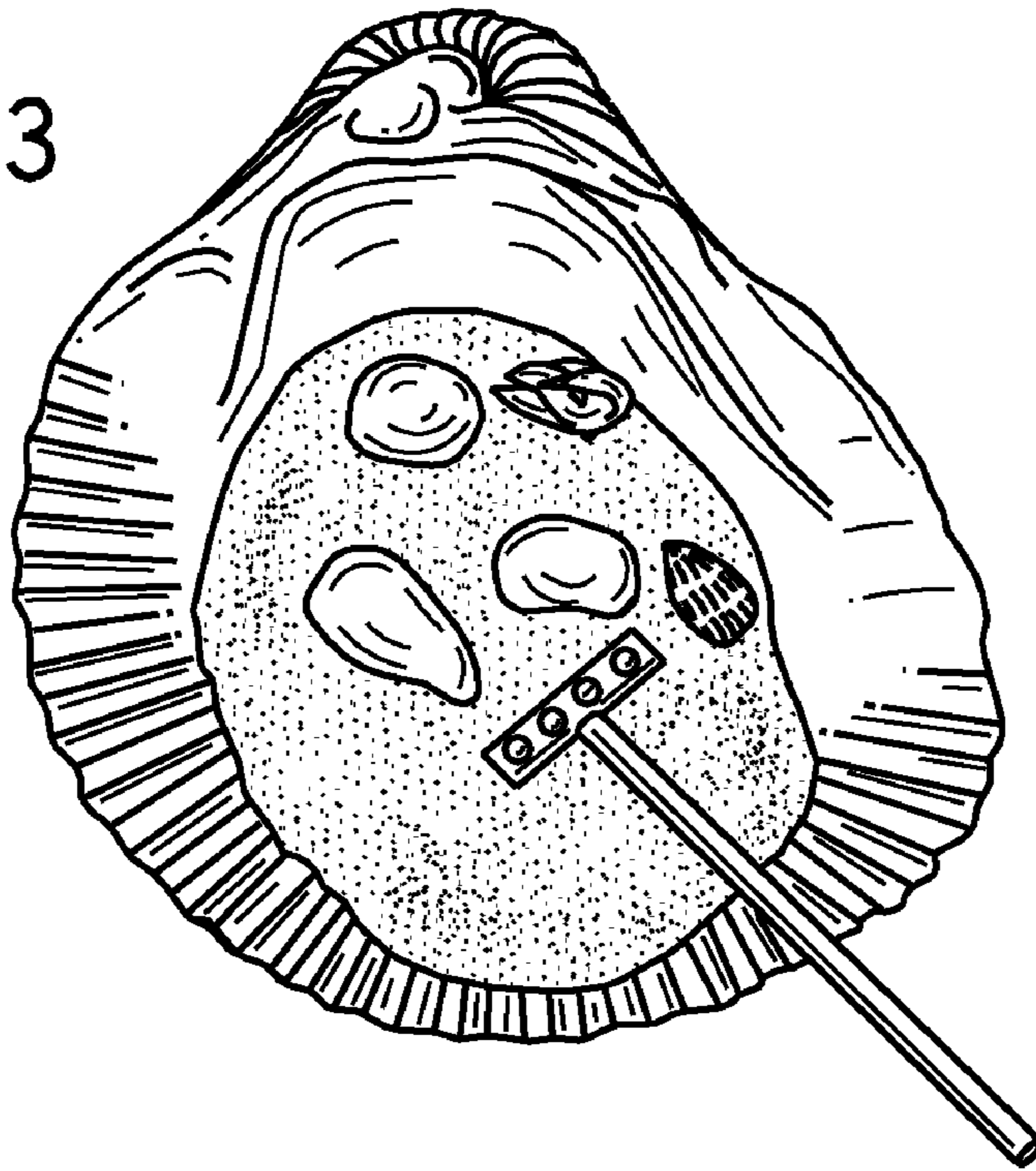

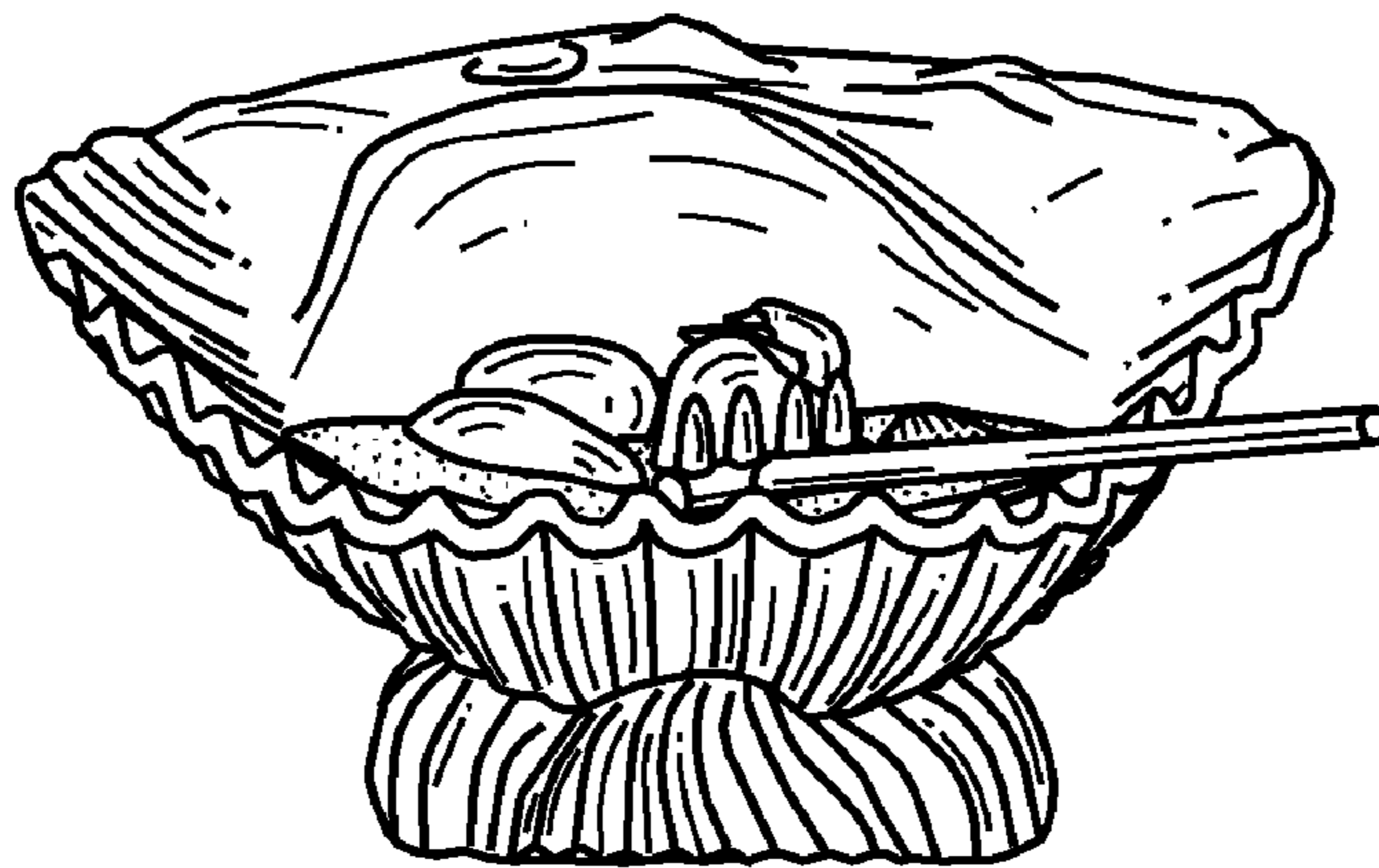
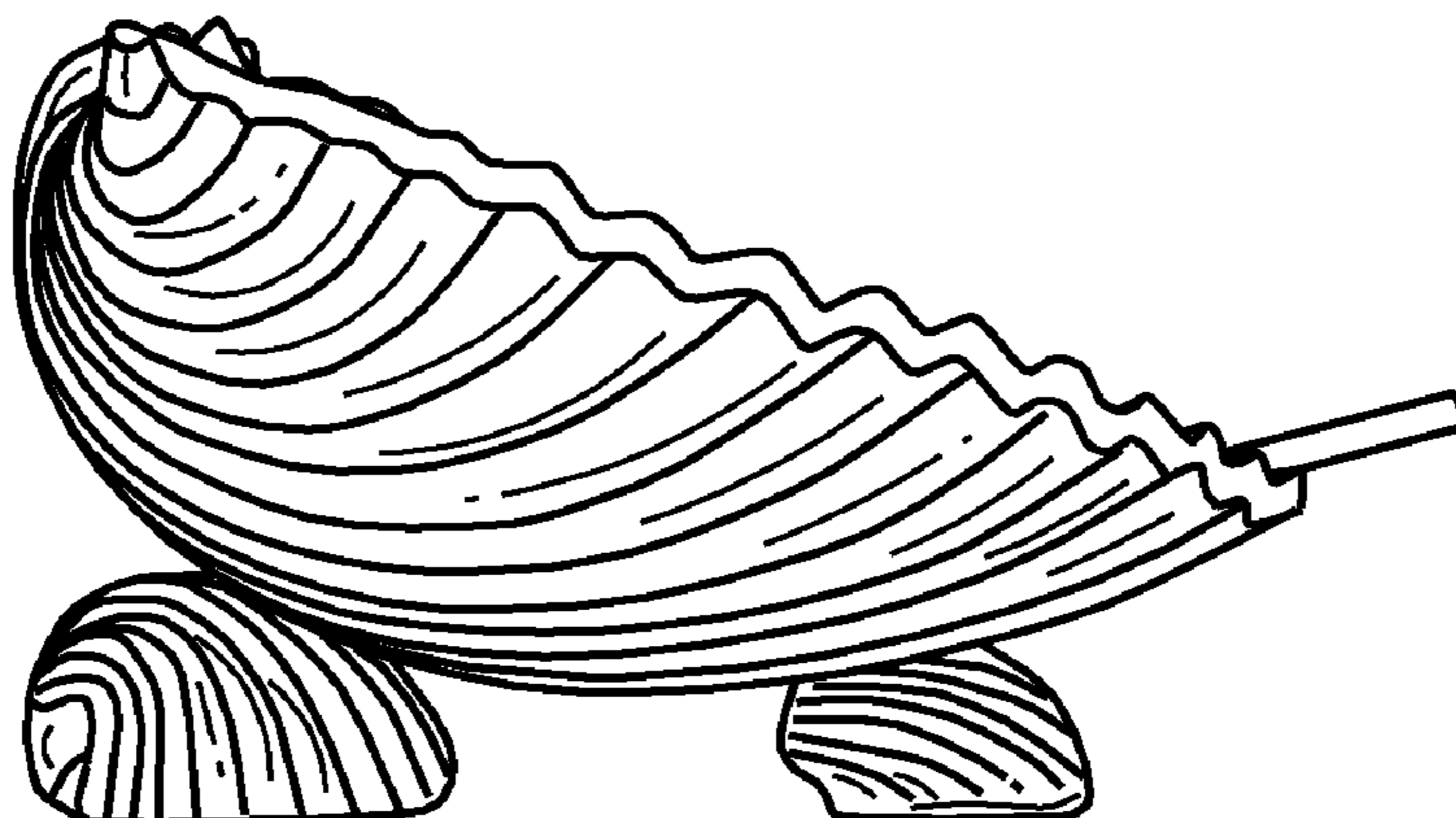

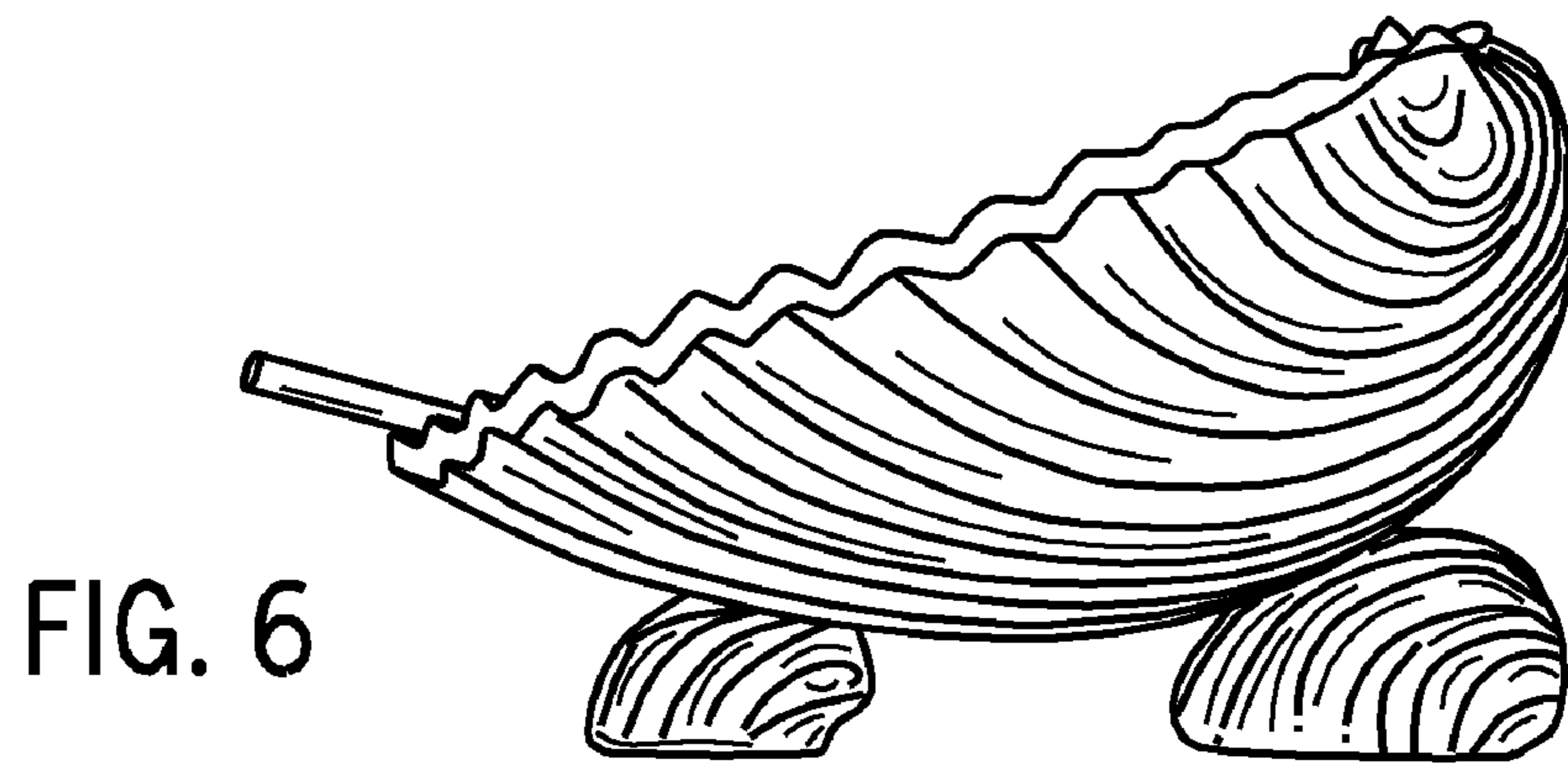

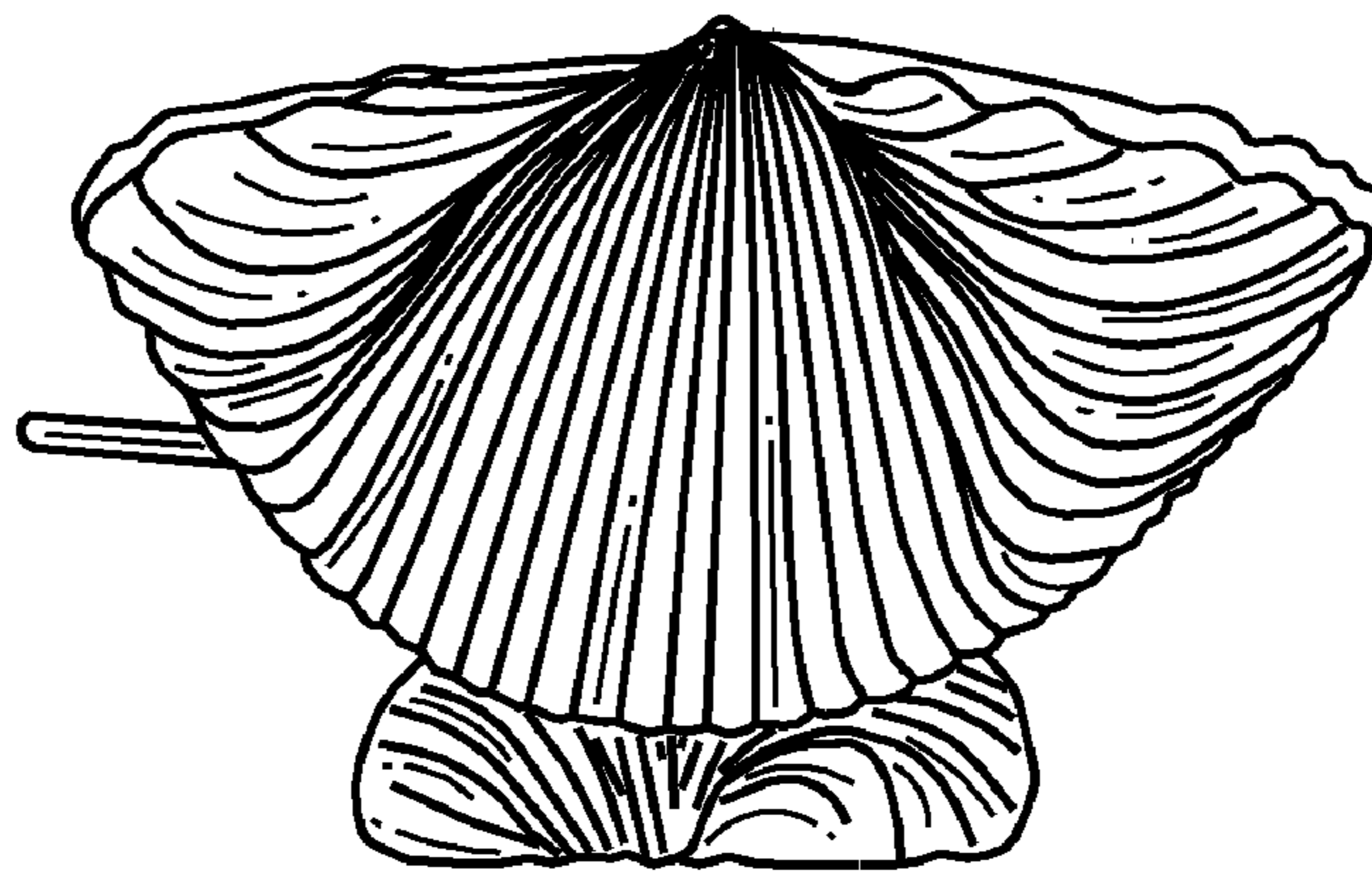

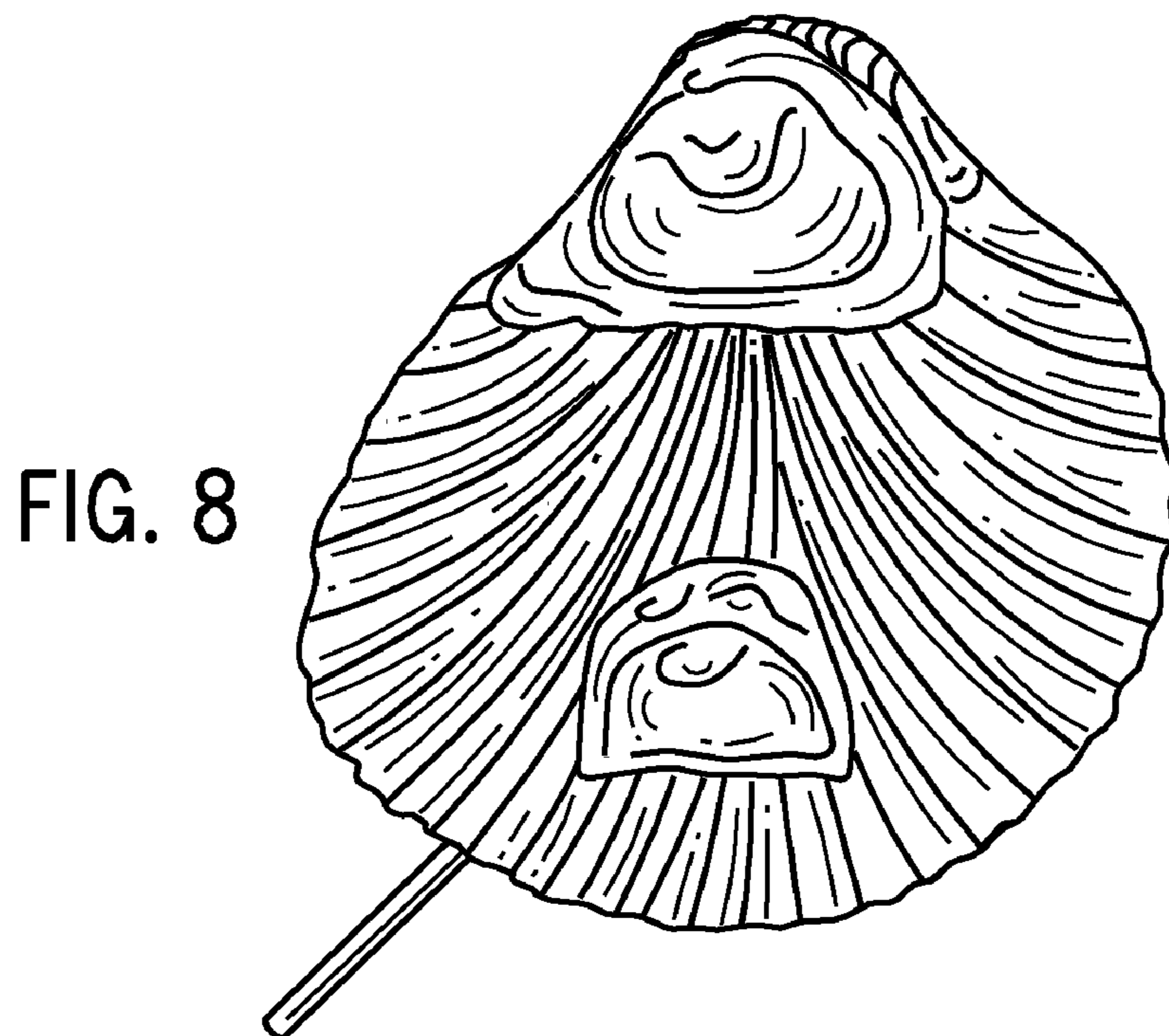
