(57) **CLAIM**

The ornamental design for a motorcycle ignition and control switch trim, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of the motorcycle ignition and control switch trim of the present invention.

FIG. 2 is a front side elevation view thereof.

FIG. 3 is a rear side elevation view thereof.

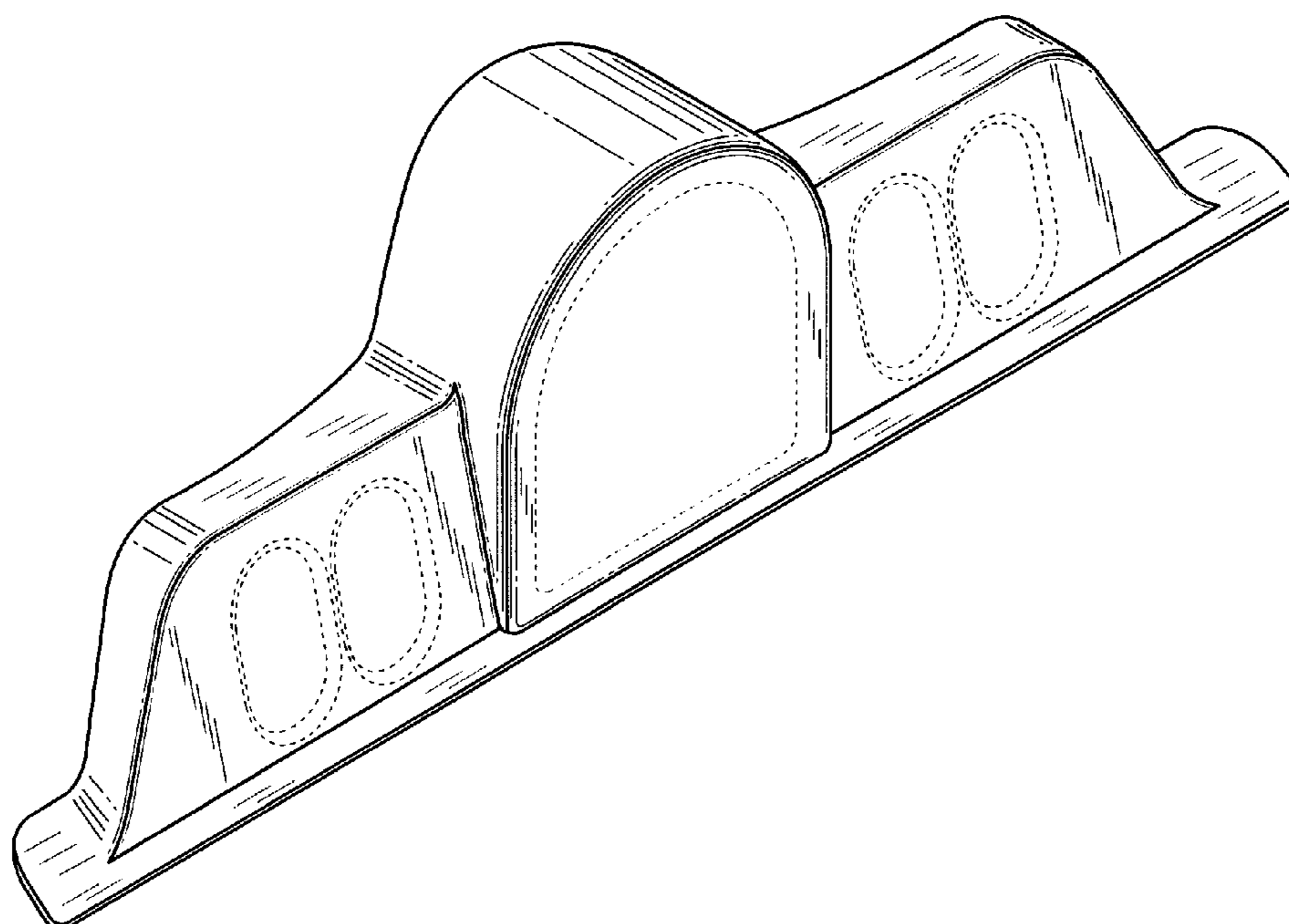
FIG. 4 is a top view thereof.

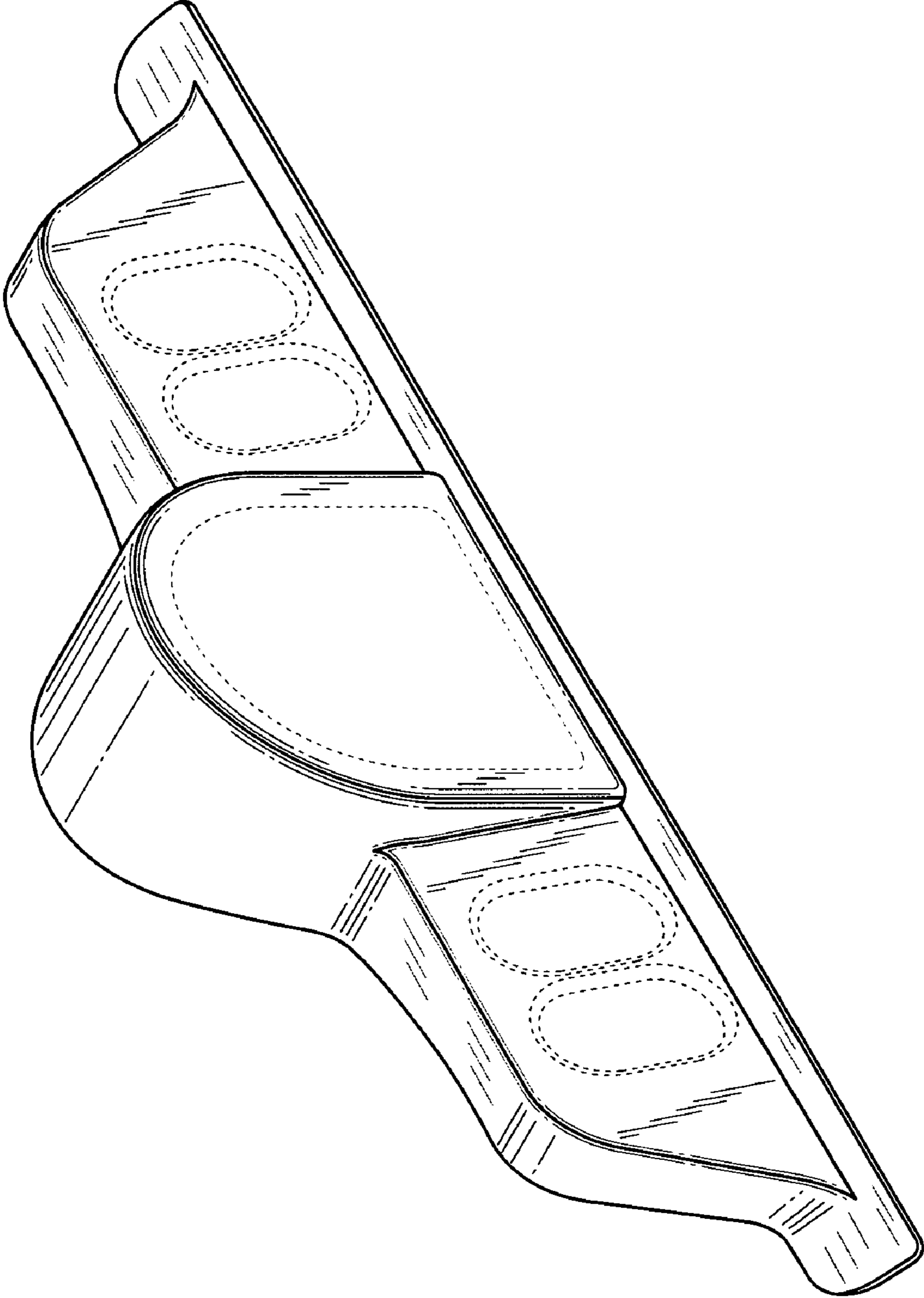

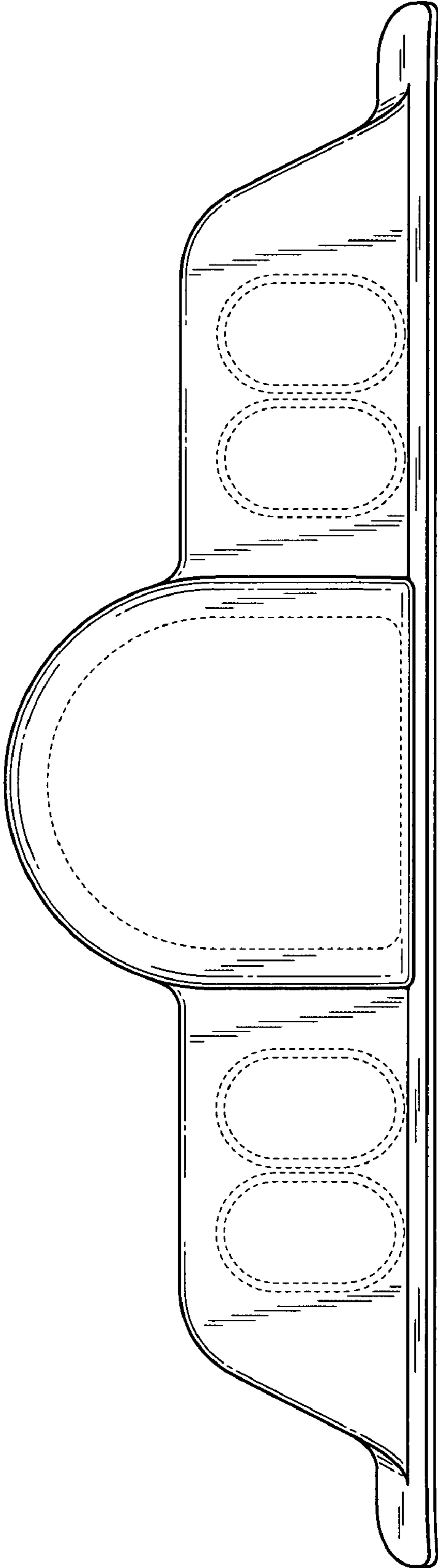

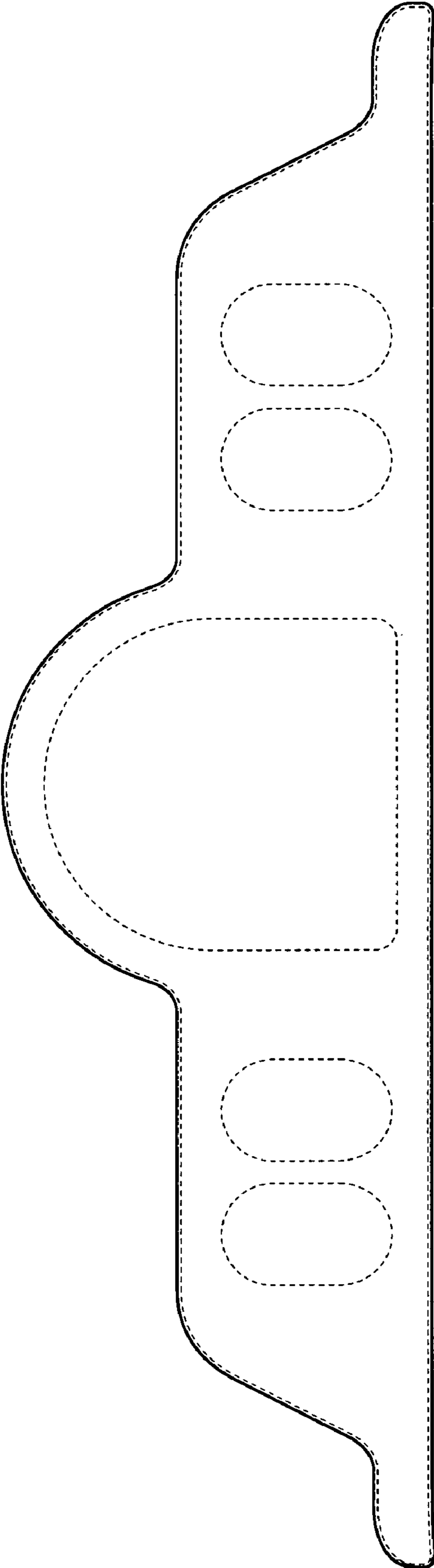

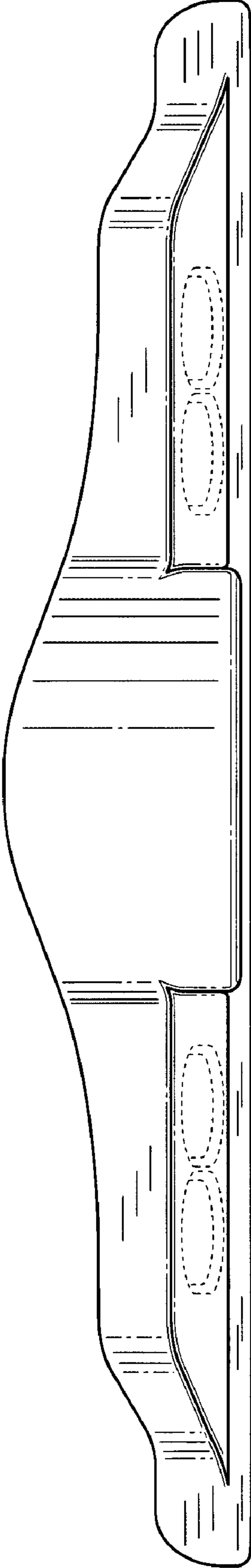

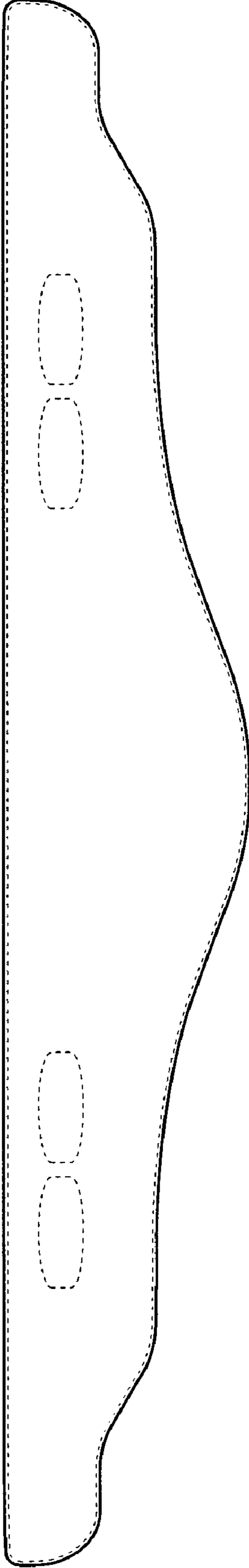
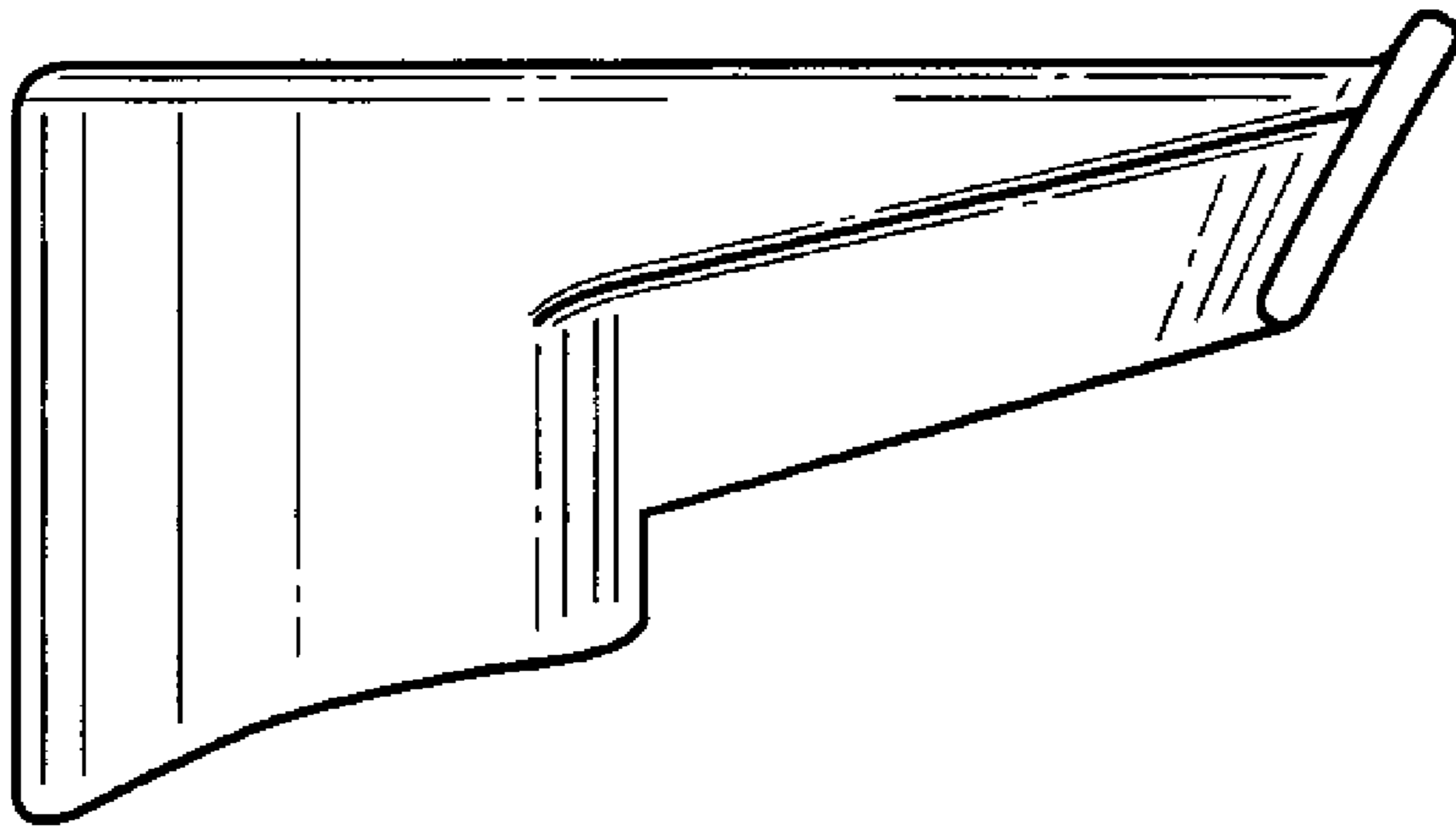
