FIG. 4 is a left side view thereof;

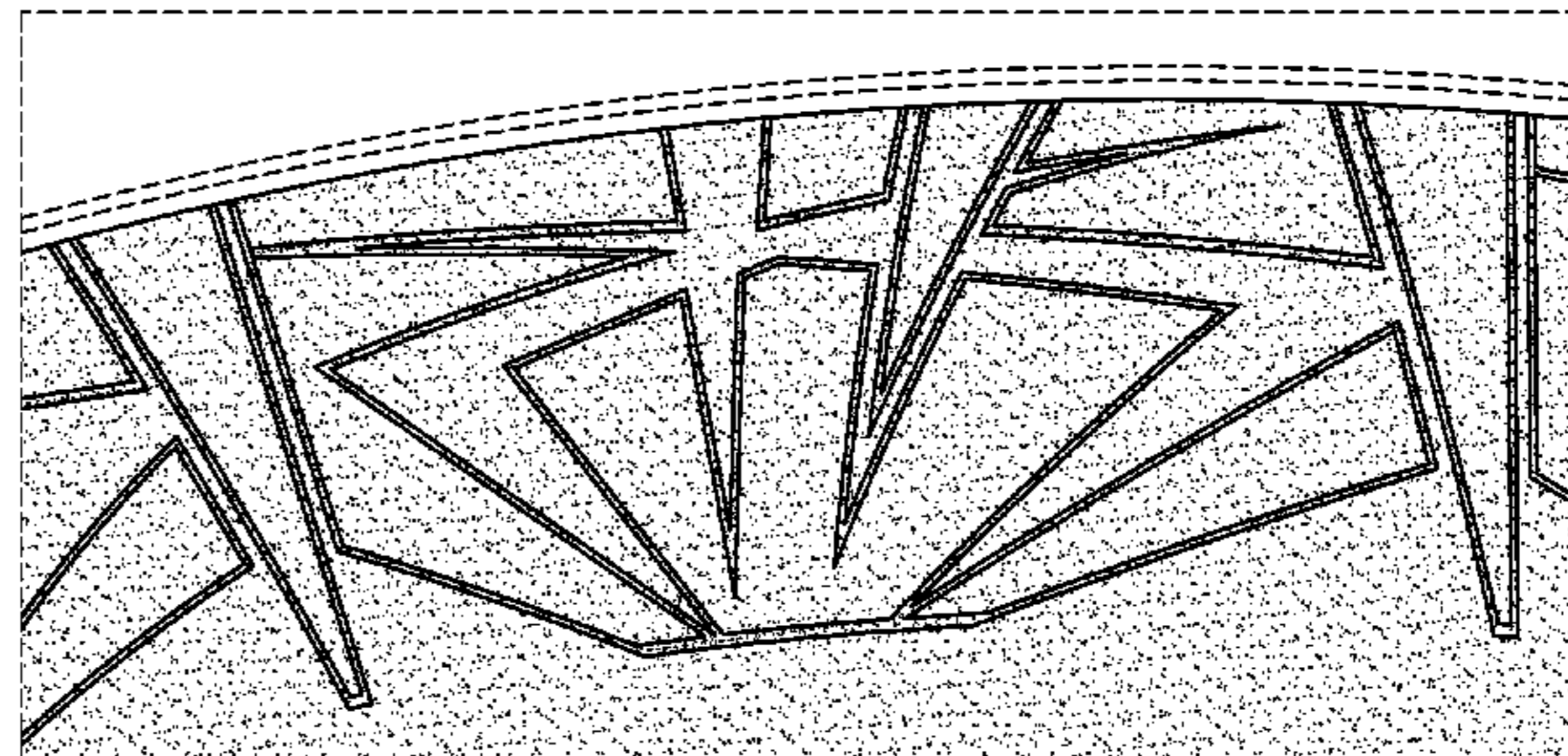
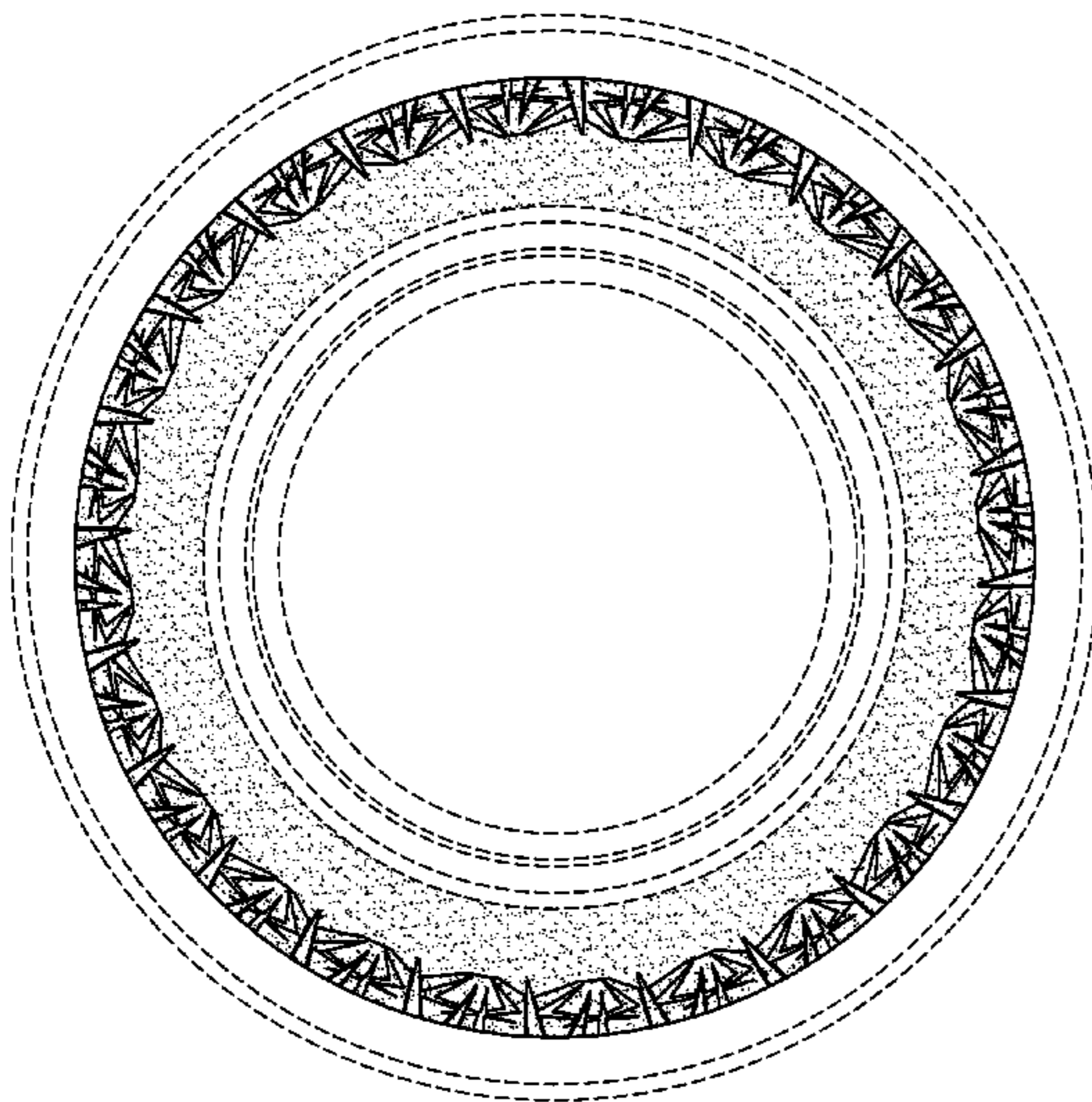
FIG. 5 is an enlarged view of FIG. 3; and,

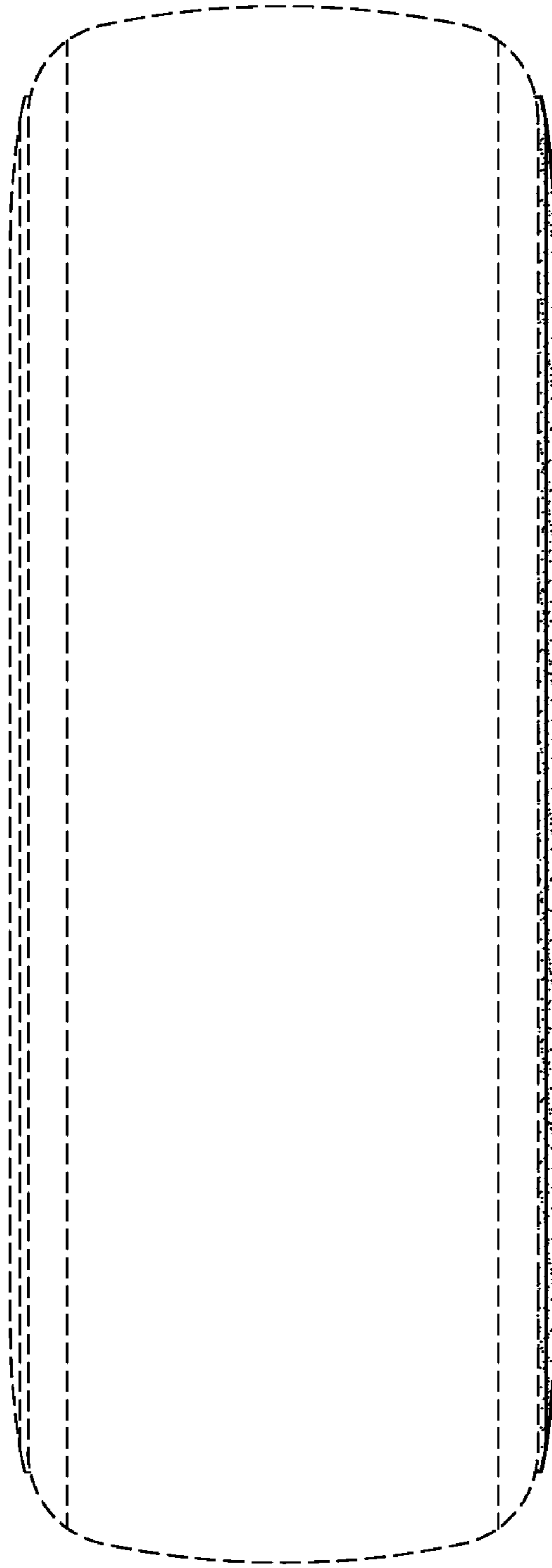

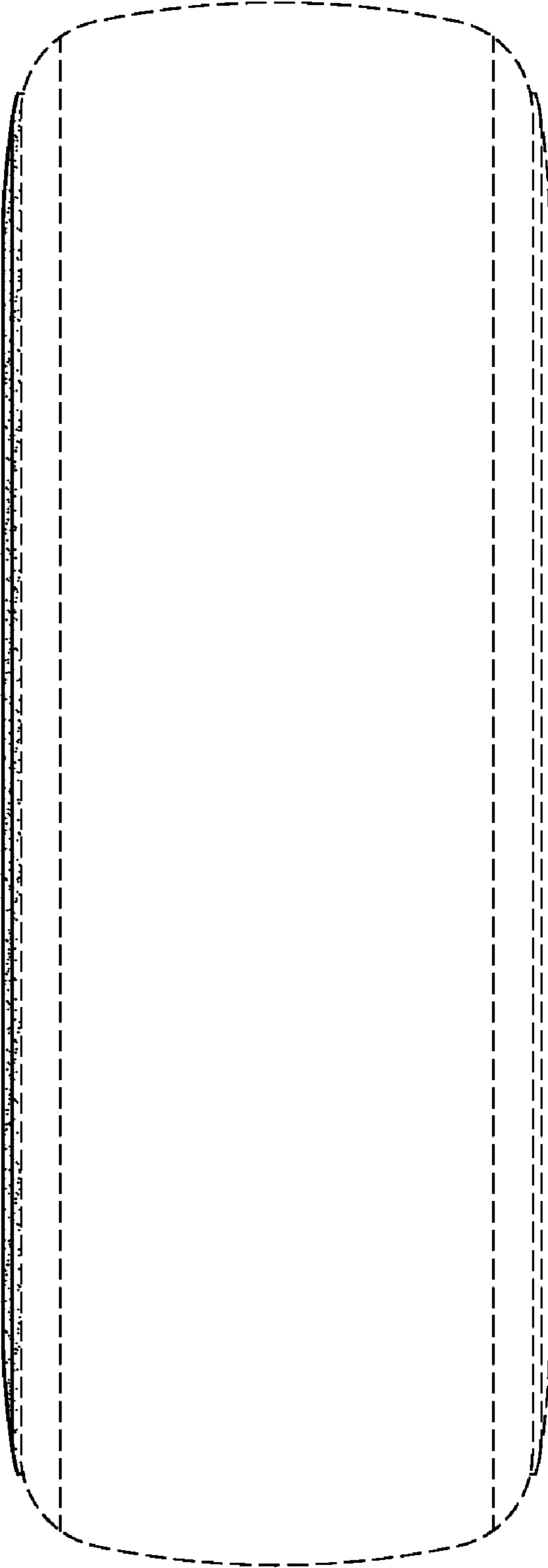

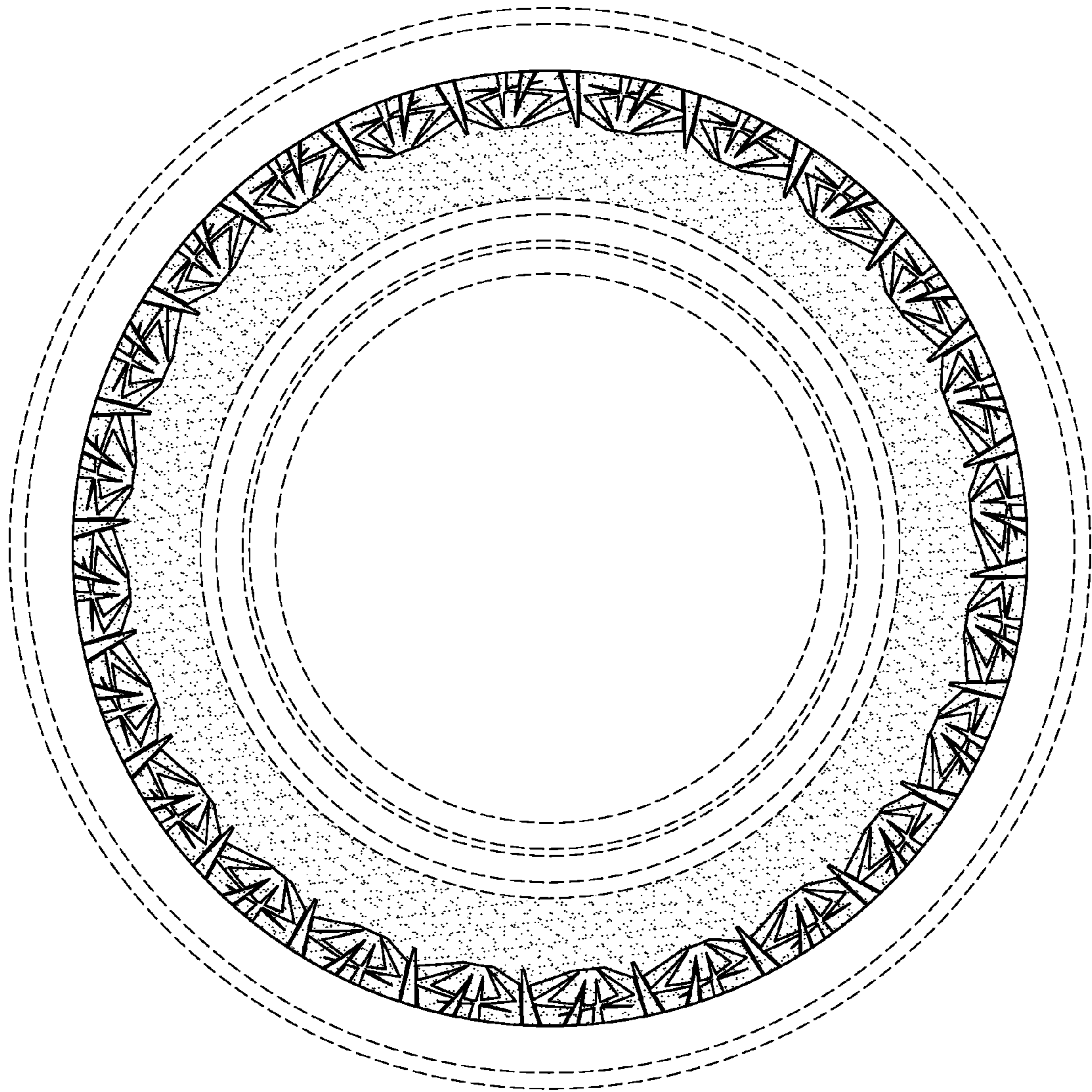

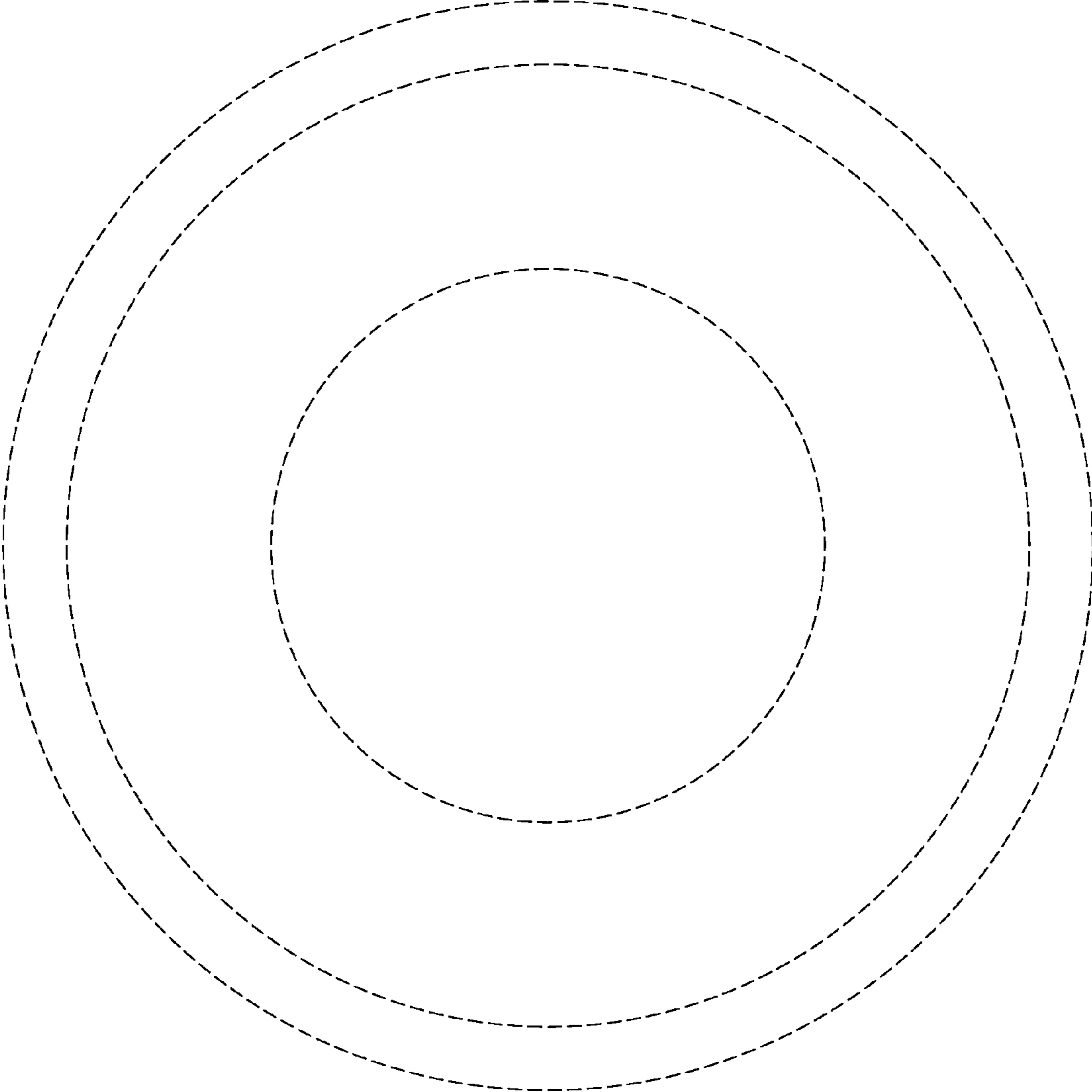

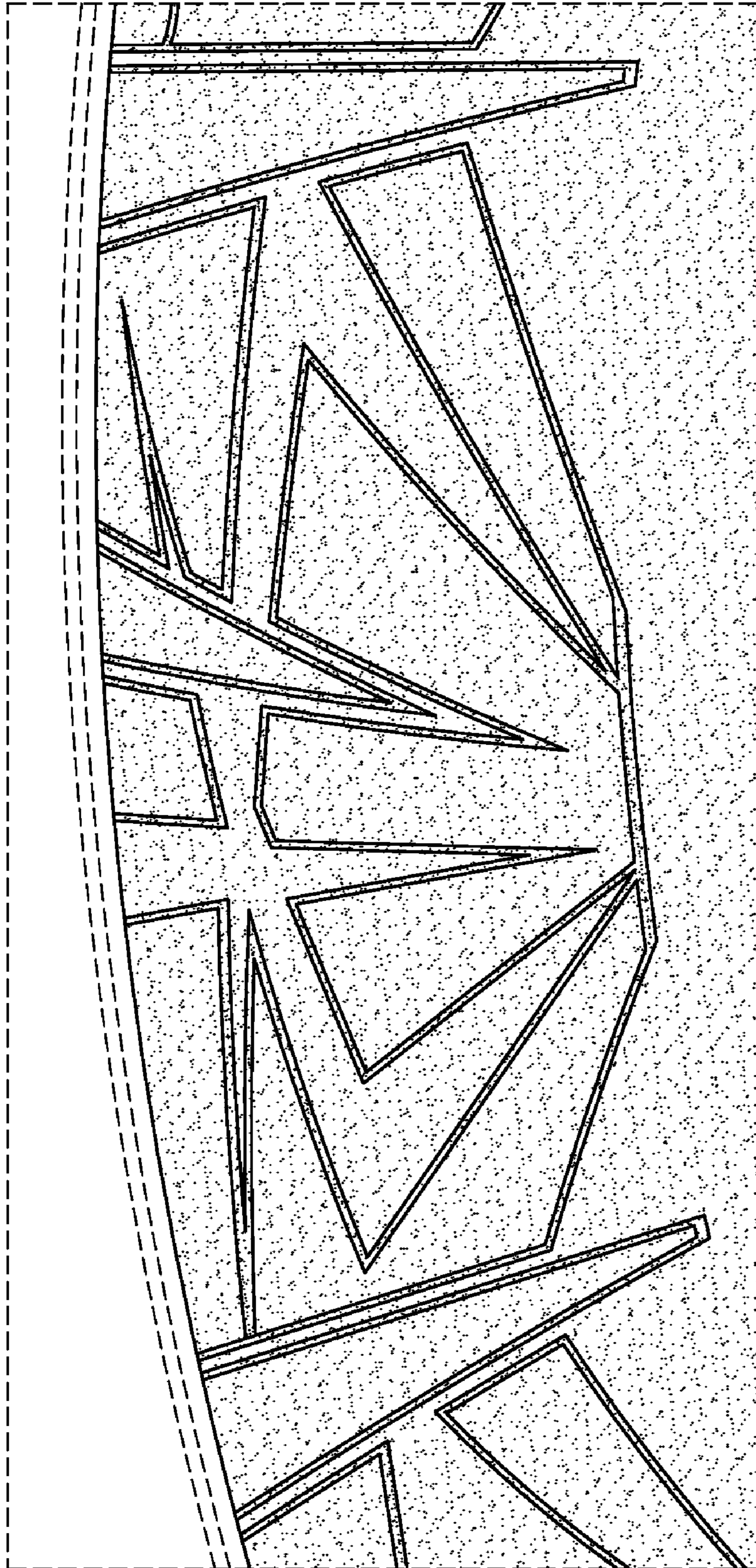

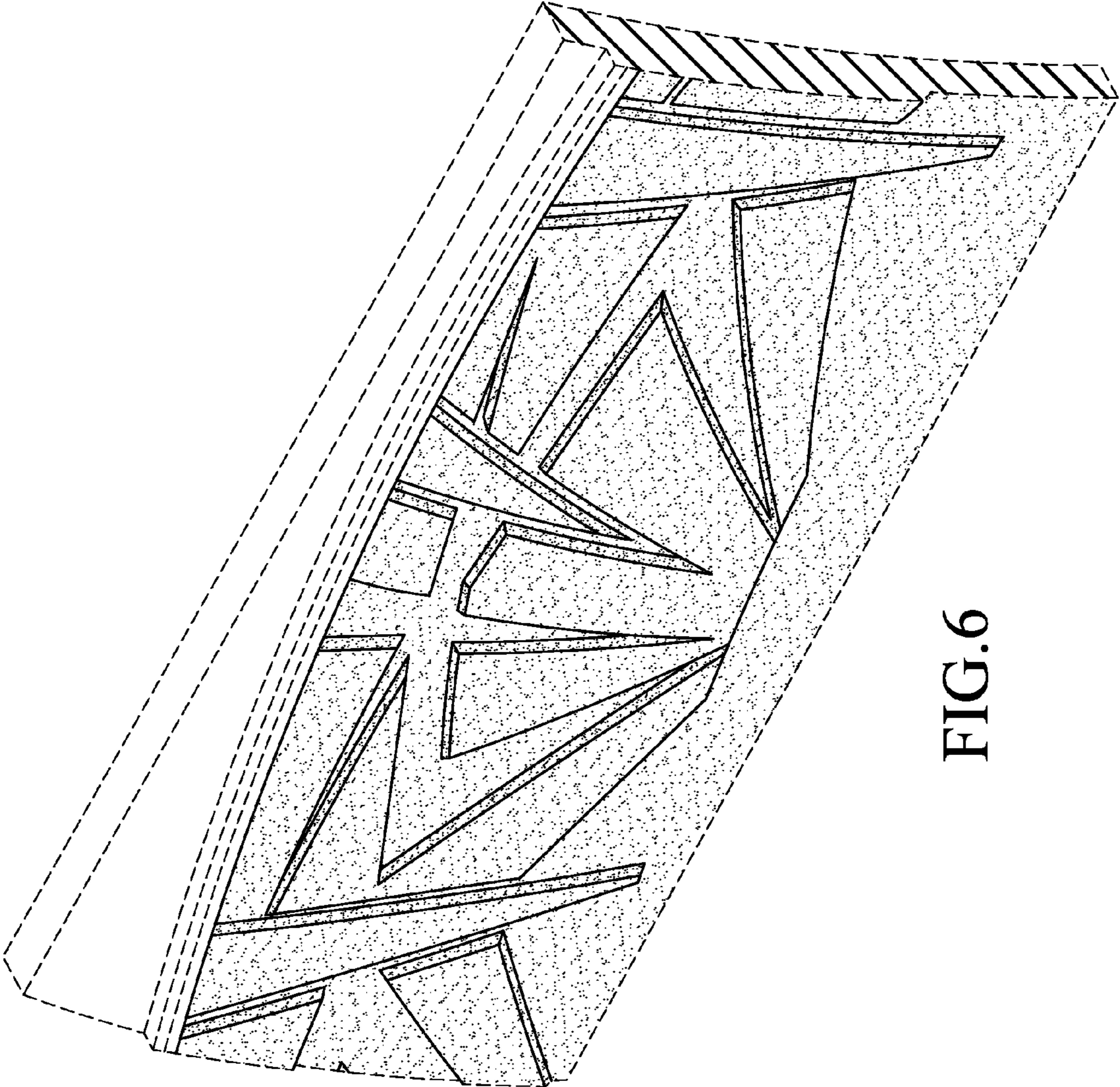
