FIG. 3. is a rear elevational view thereof;

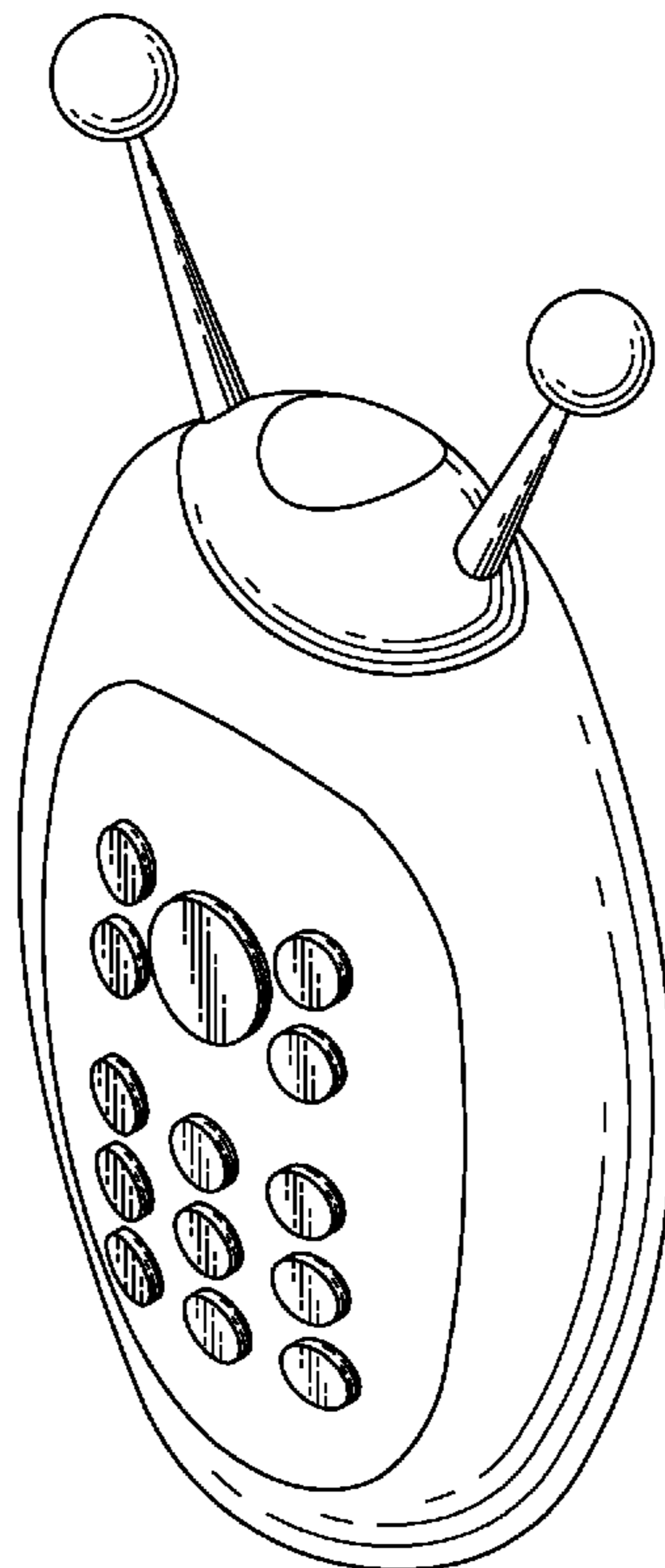
FIG. 4. is a left side elevational view thereof;

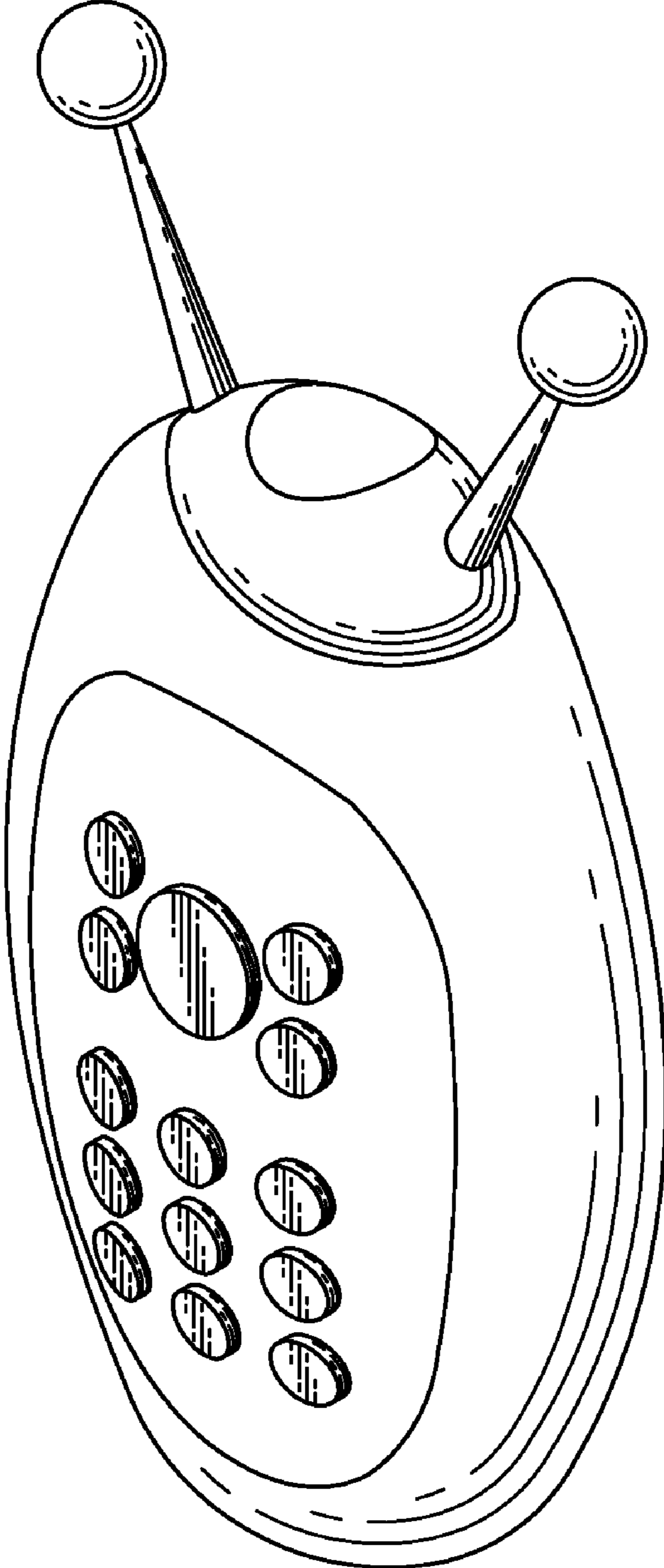

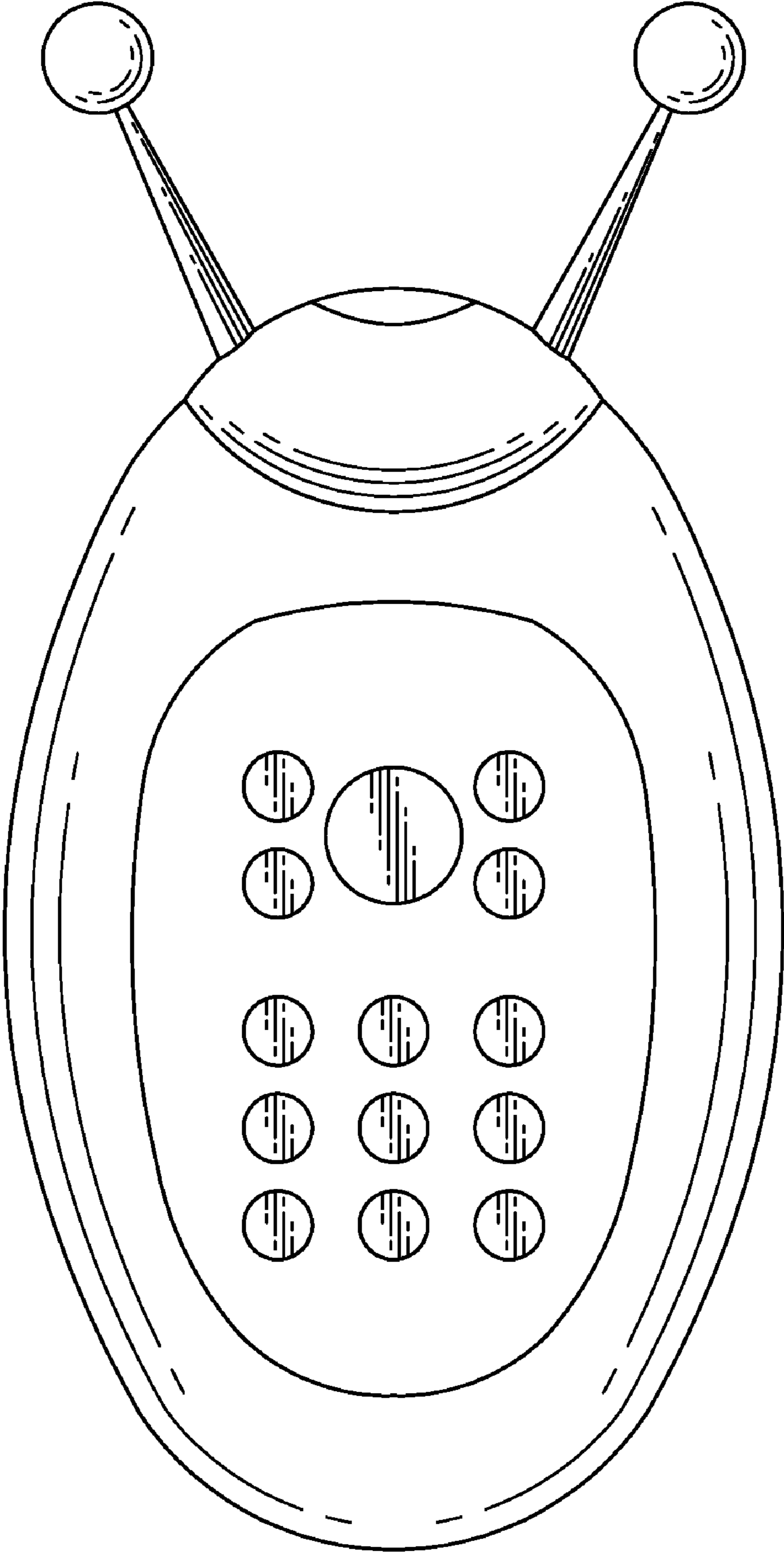

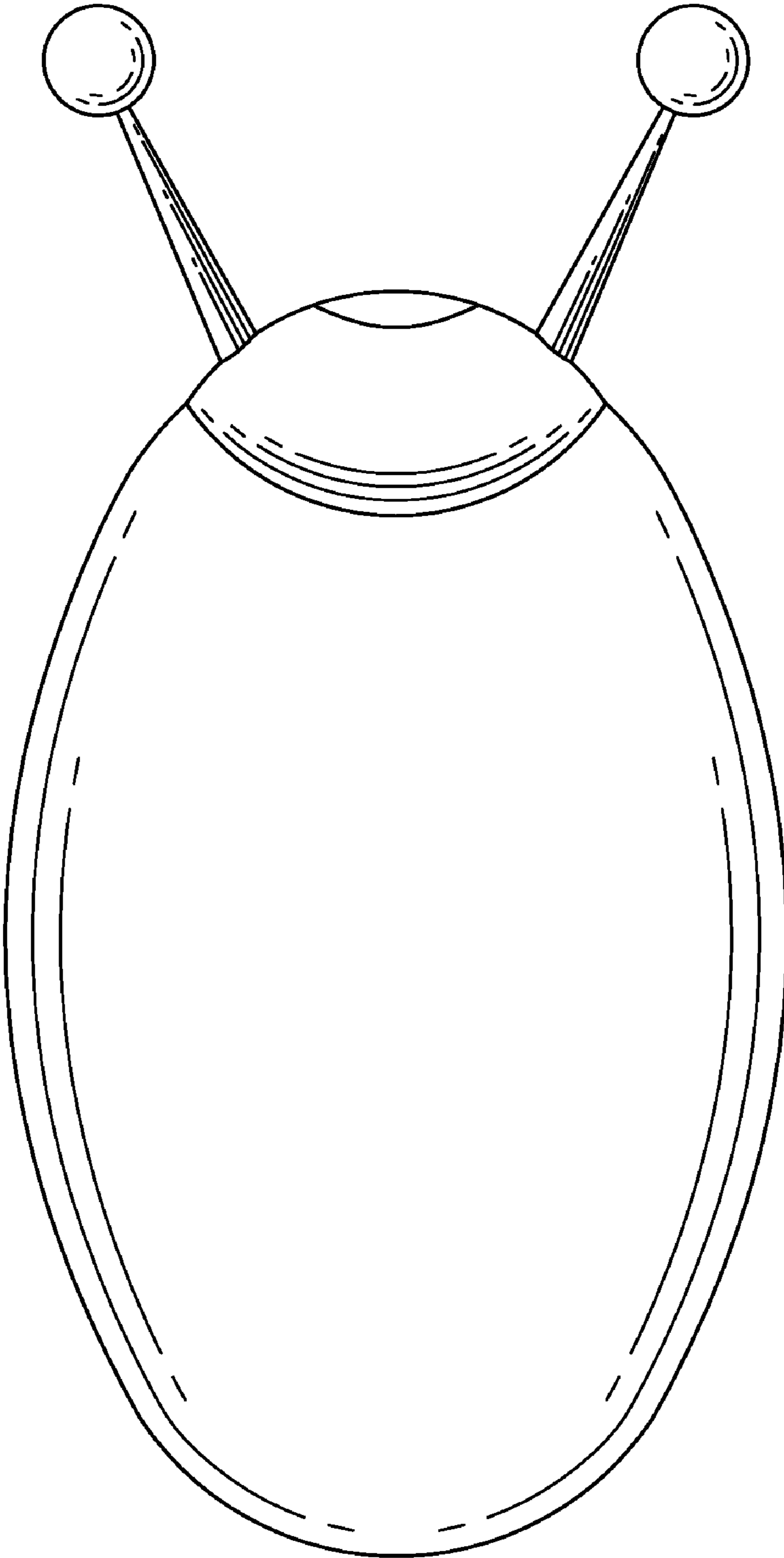

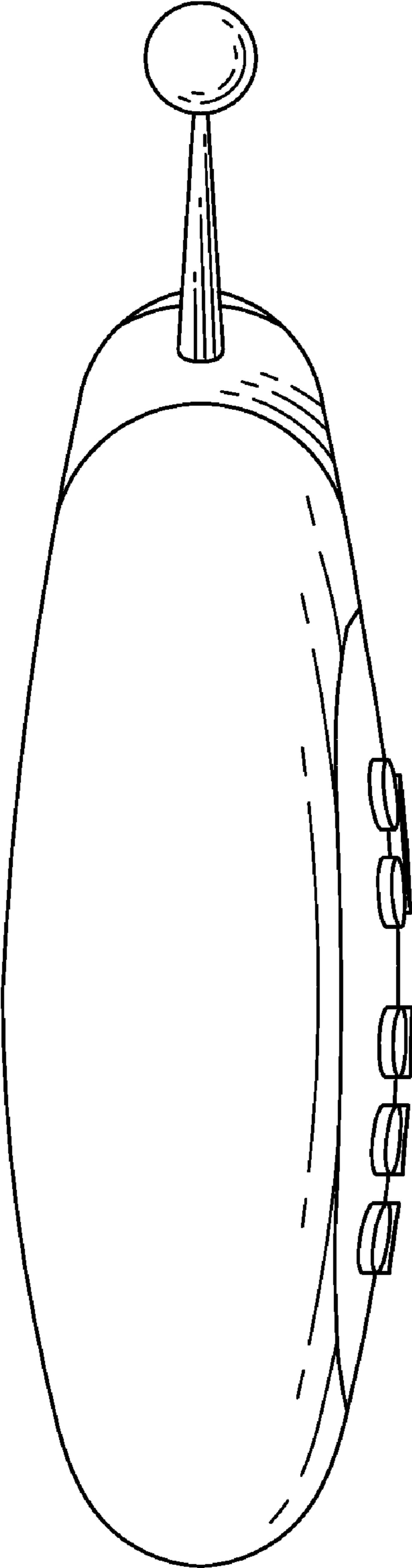

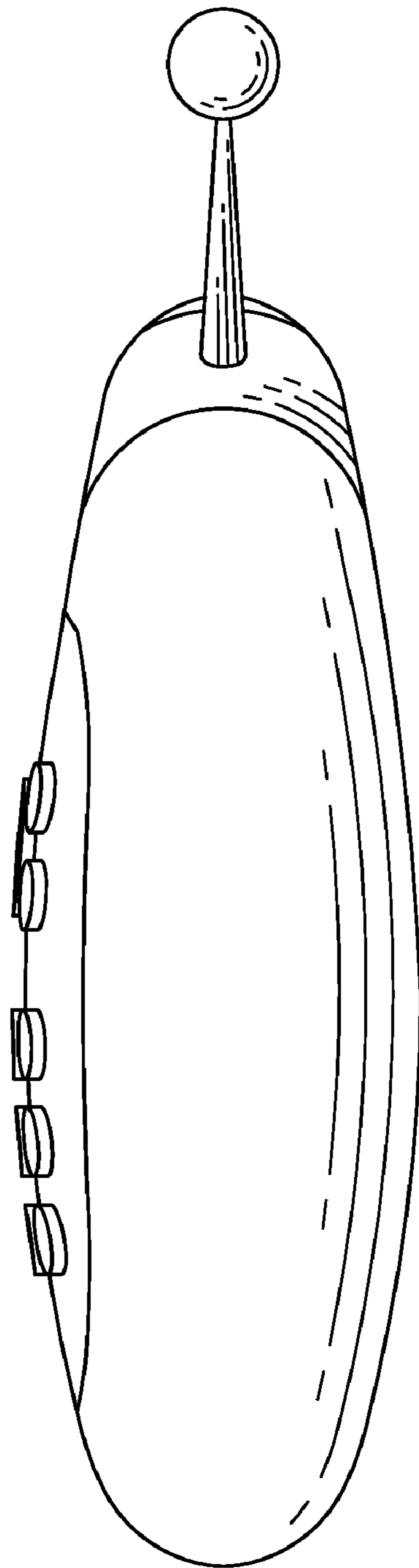

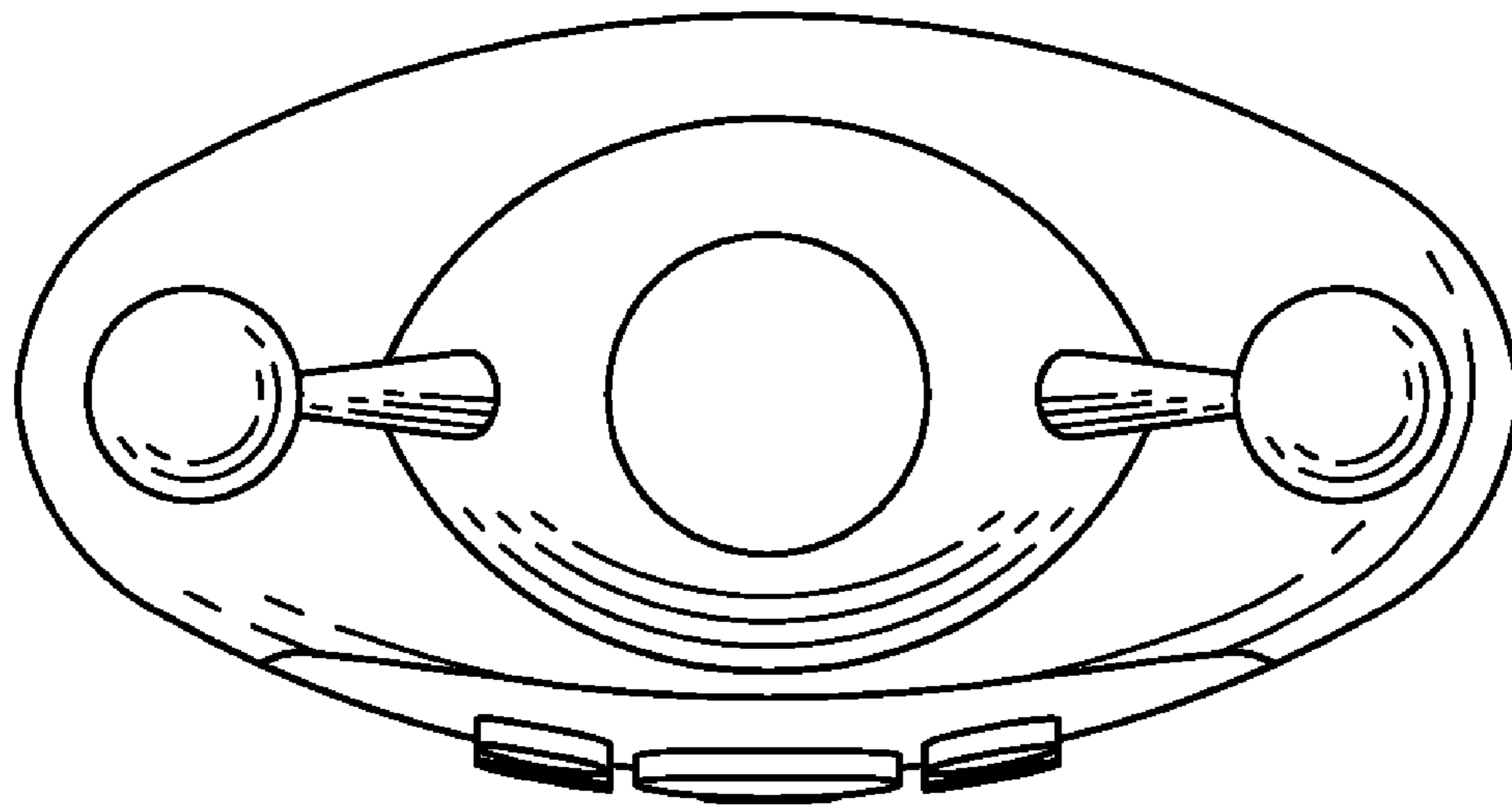

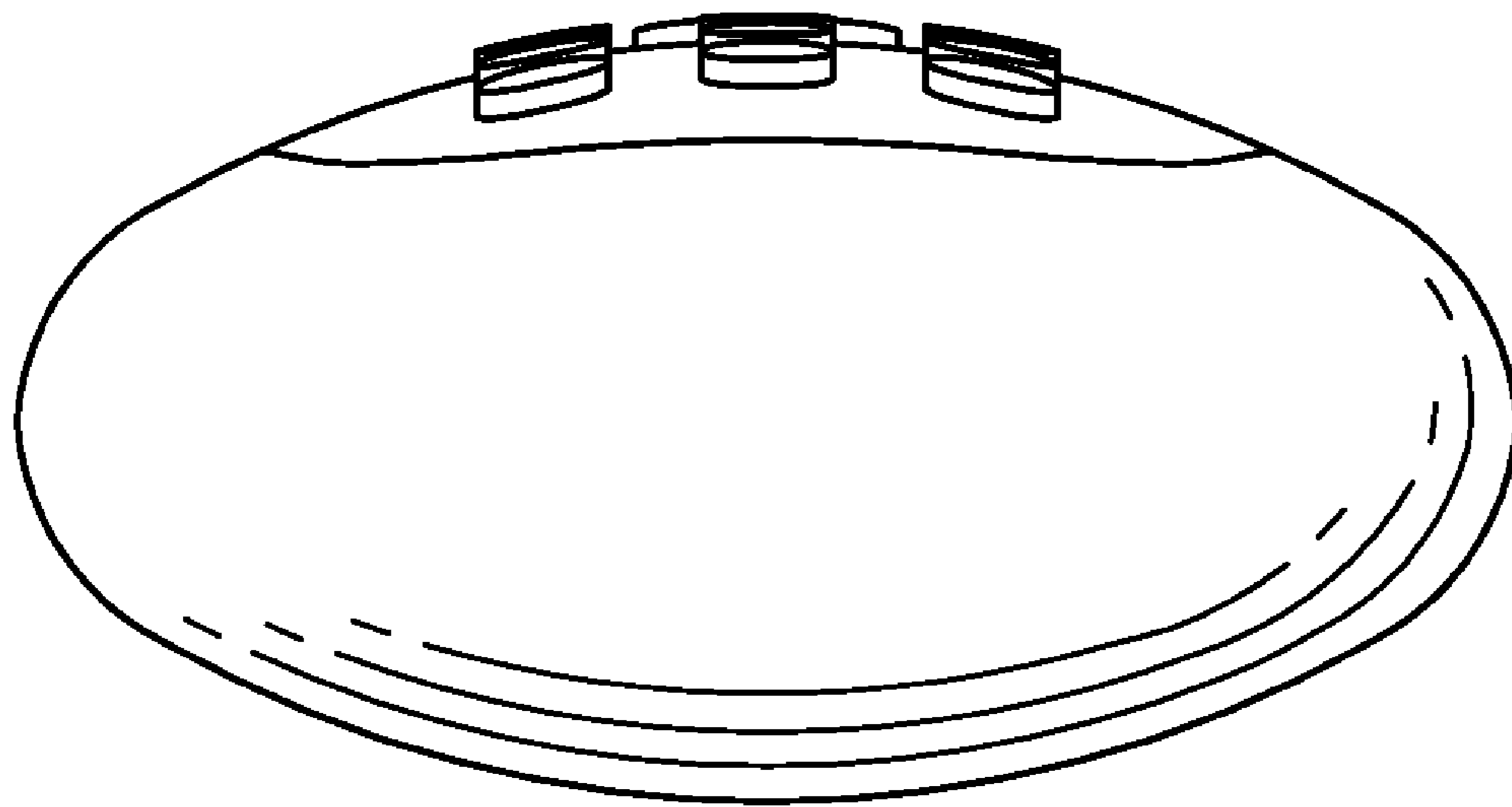
