(57) **CLAIM**

The ornamental design for a handheld remote control unit, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a handheld remote control unit showing my new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a bottom plan view thereof;

FIG. 4 is a right side elevational view thereof;

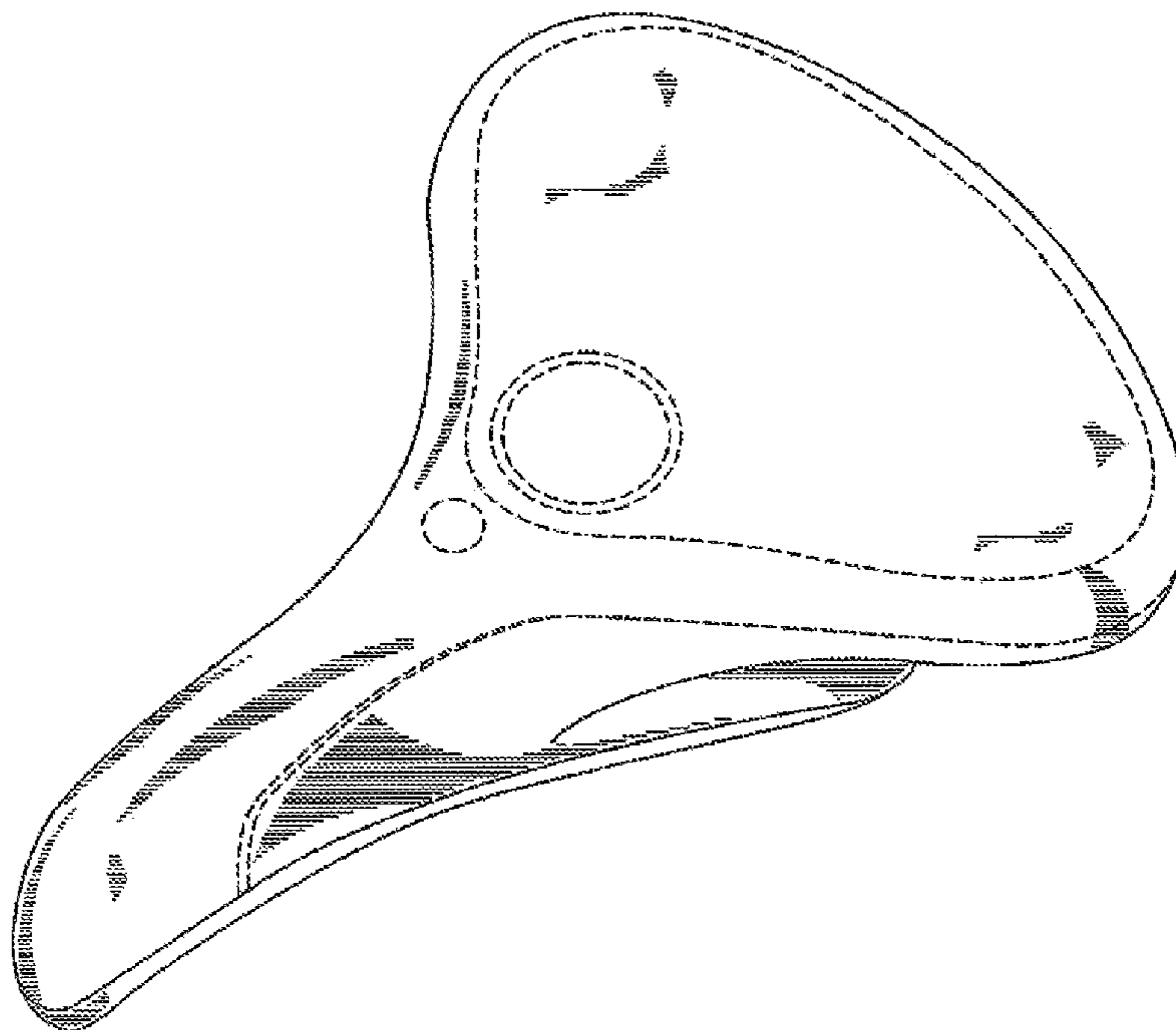
FIG. 5 is a left side elevational view thereof;

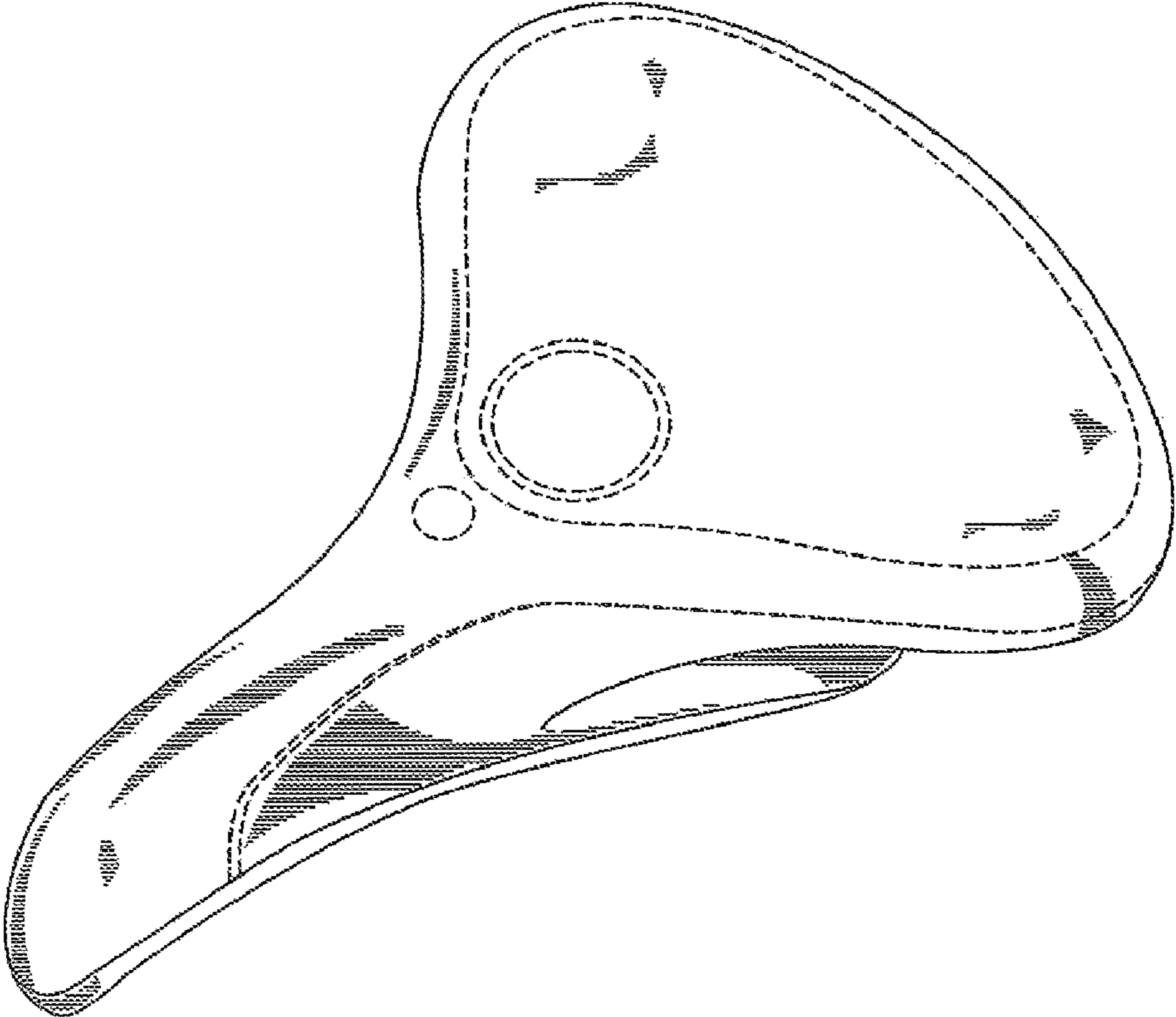

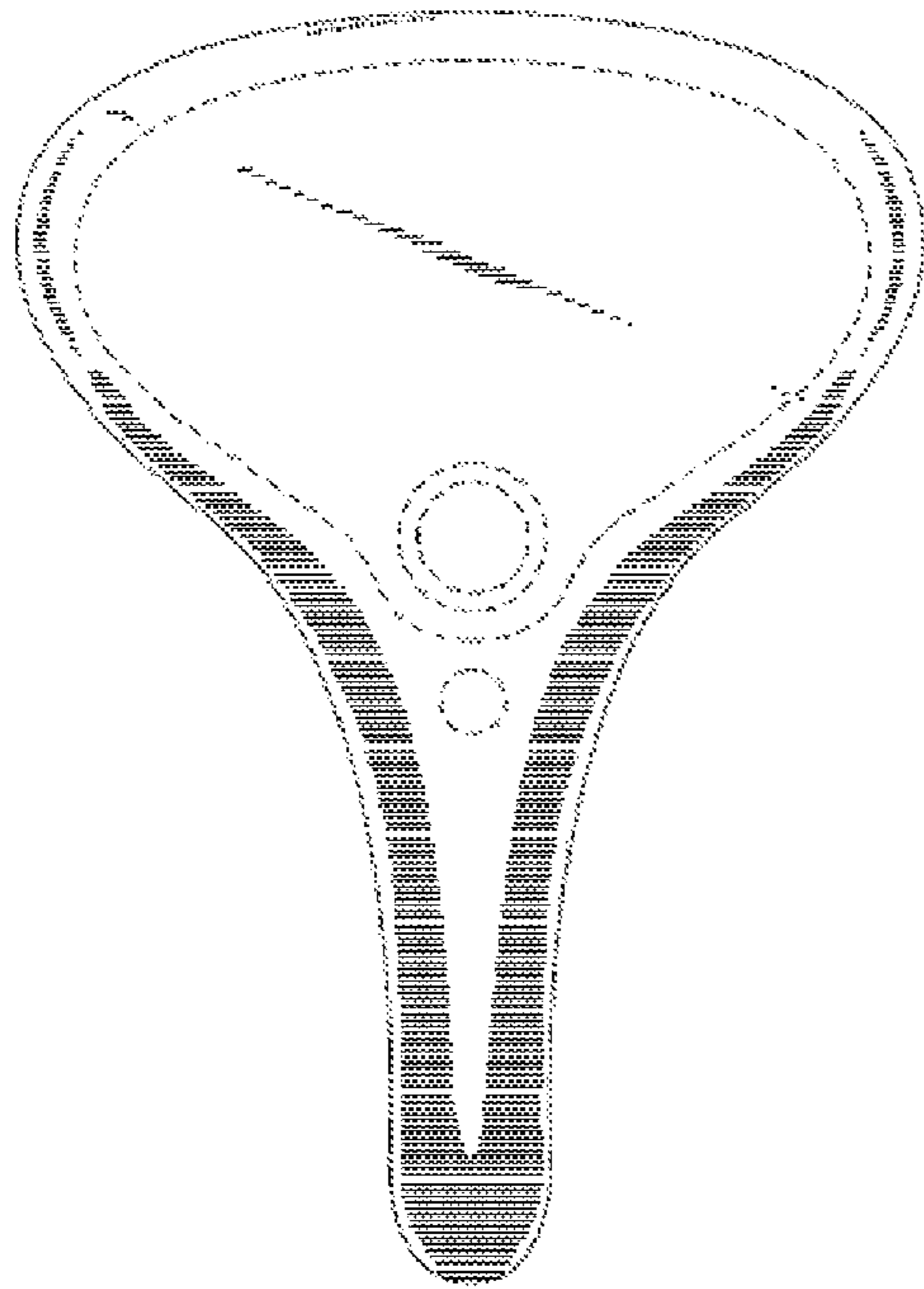

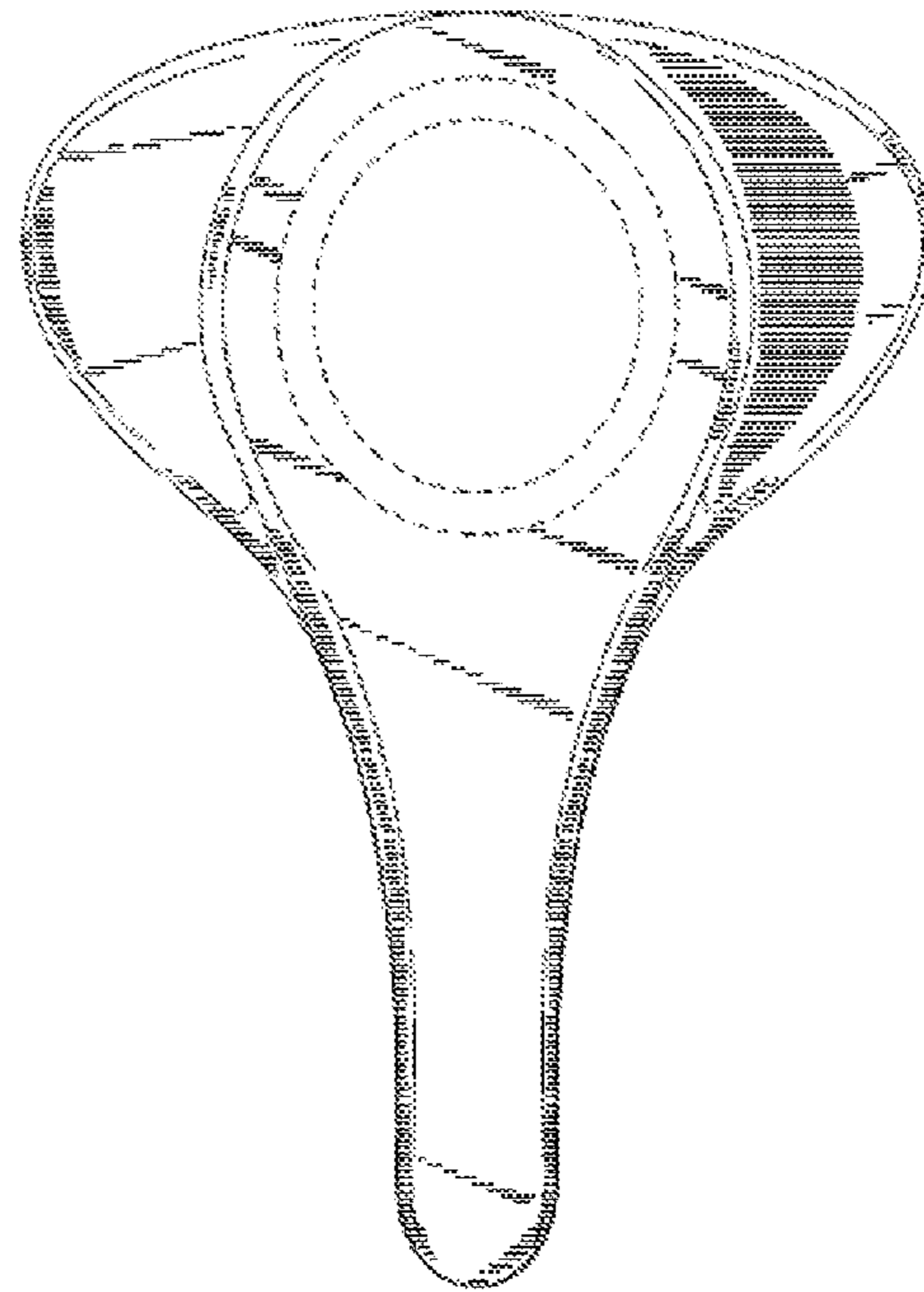

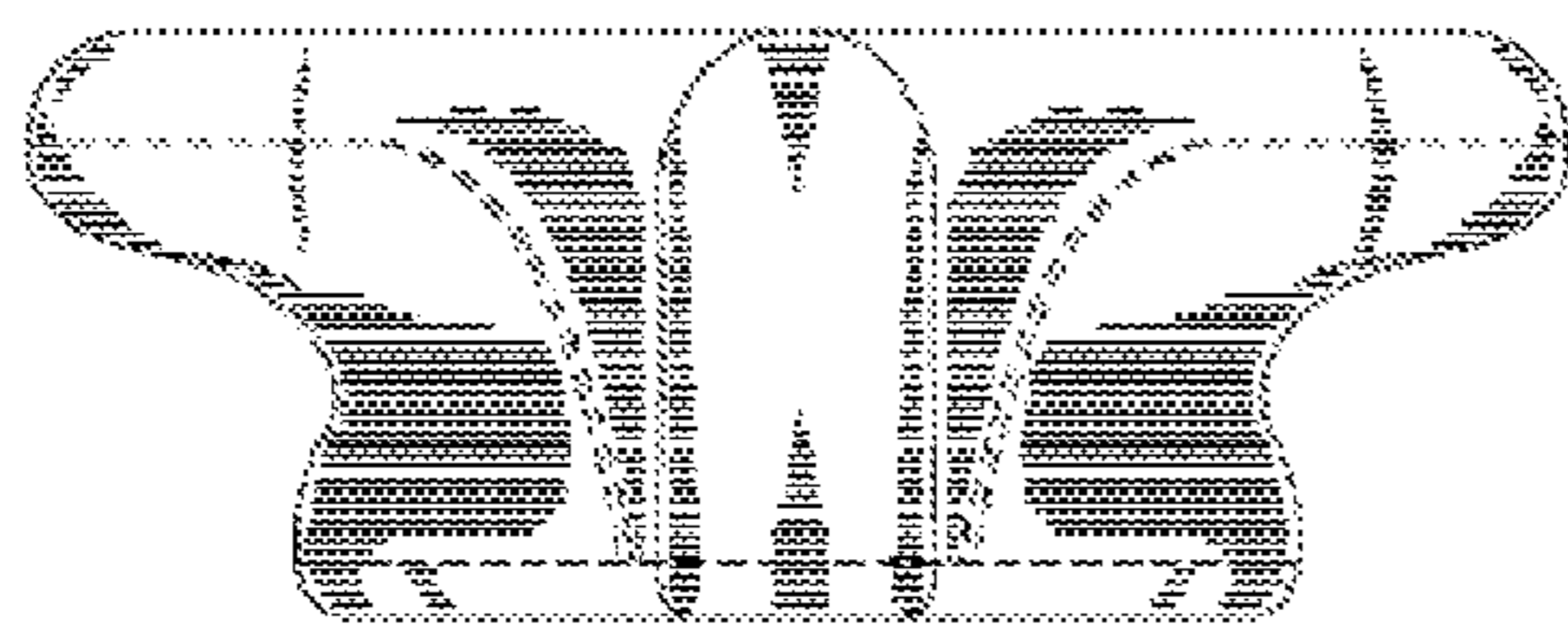

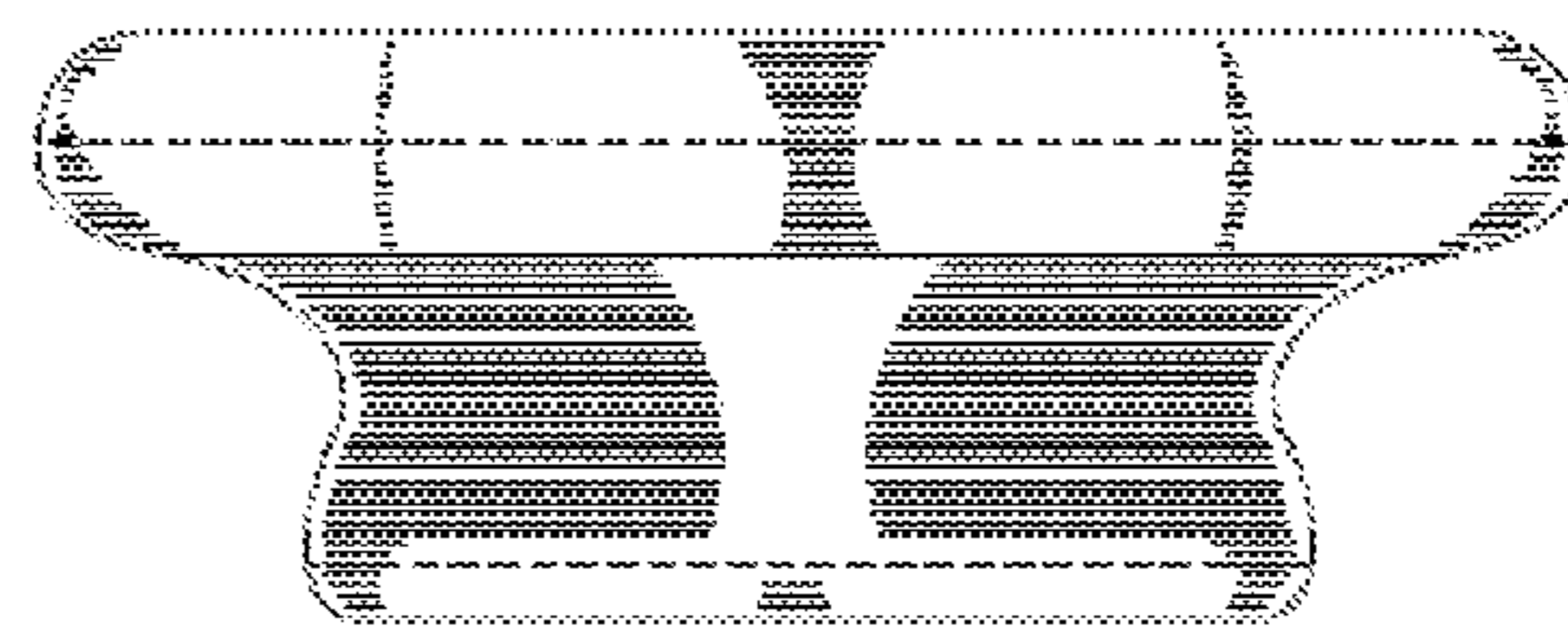
