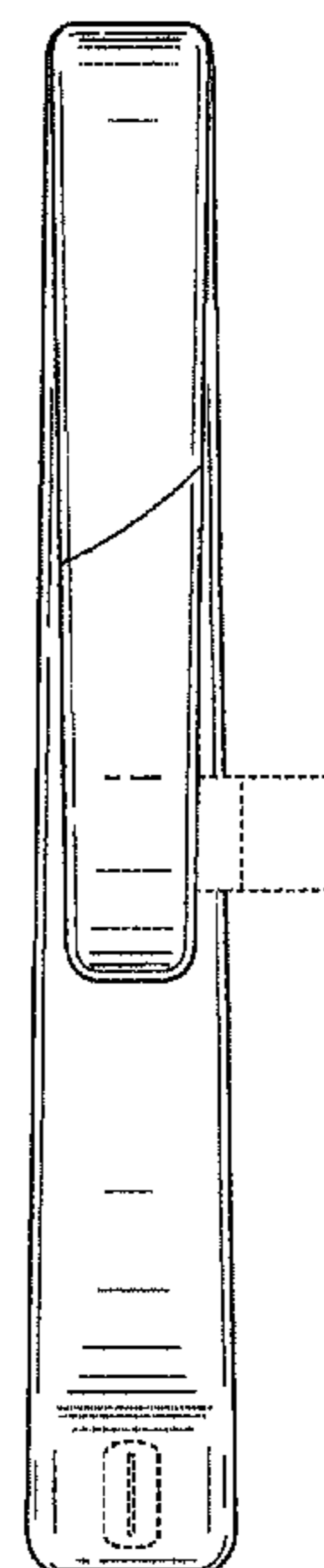
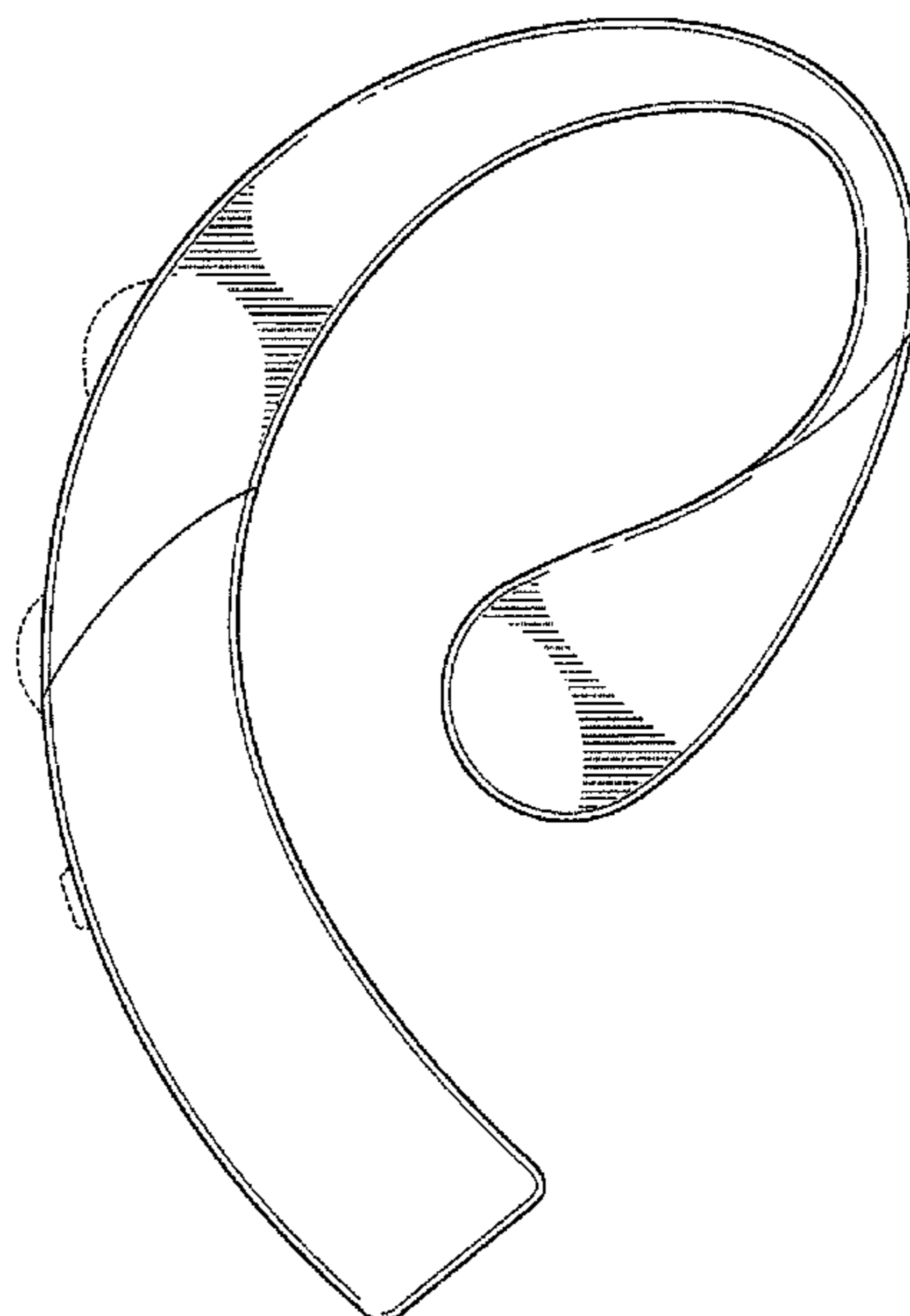
The ornamental design for an audio earphone device, as

DESCRIPTION

FIG. 1 is an outside elevational view of a right portion thereof;

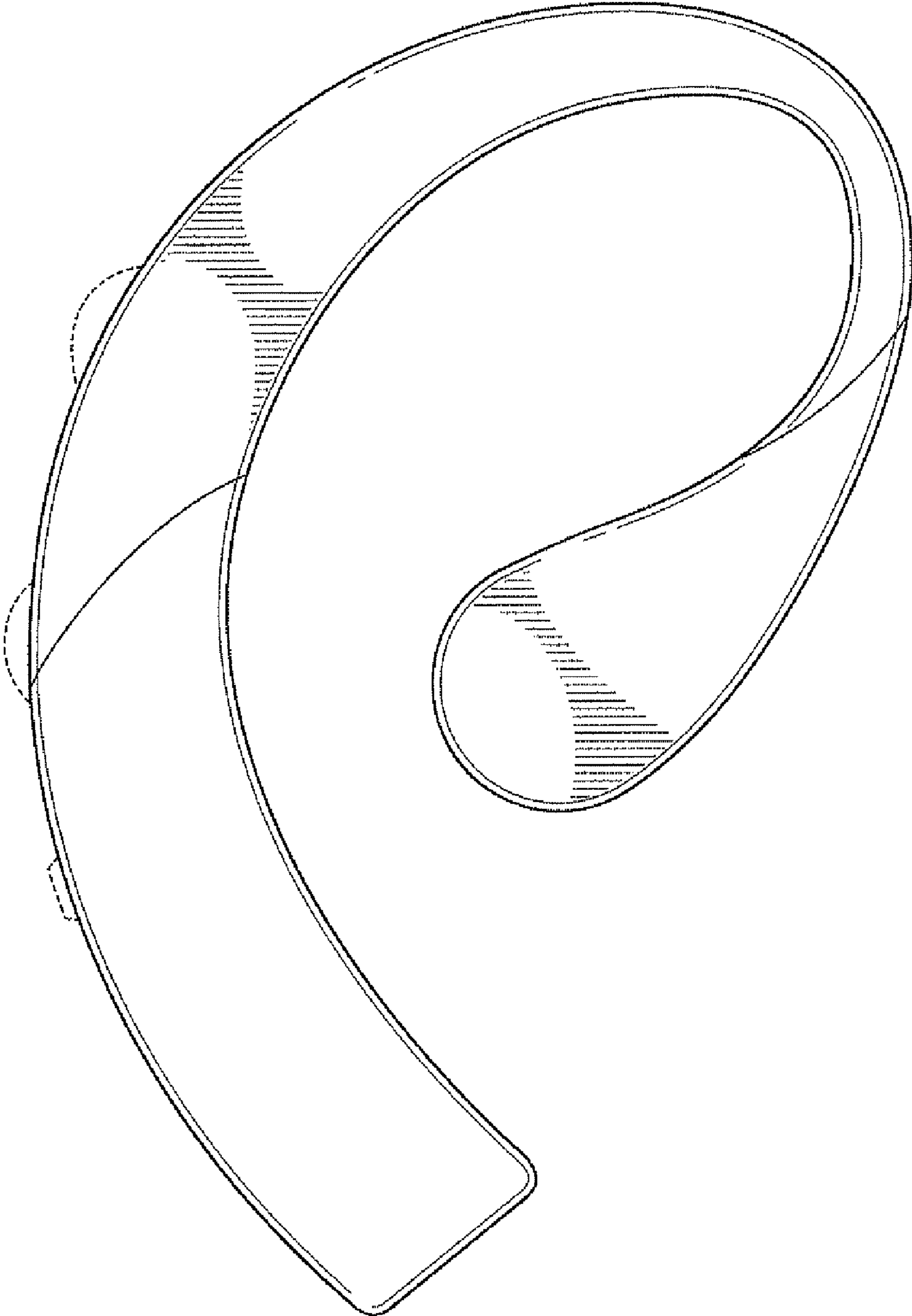

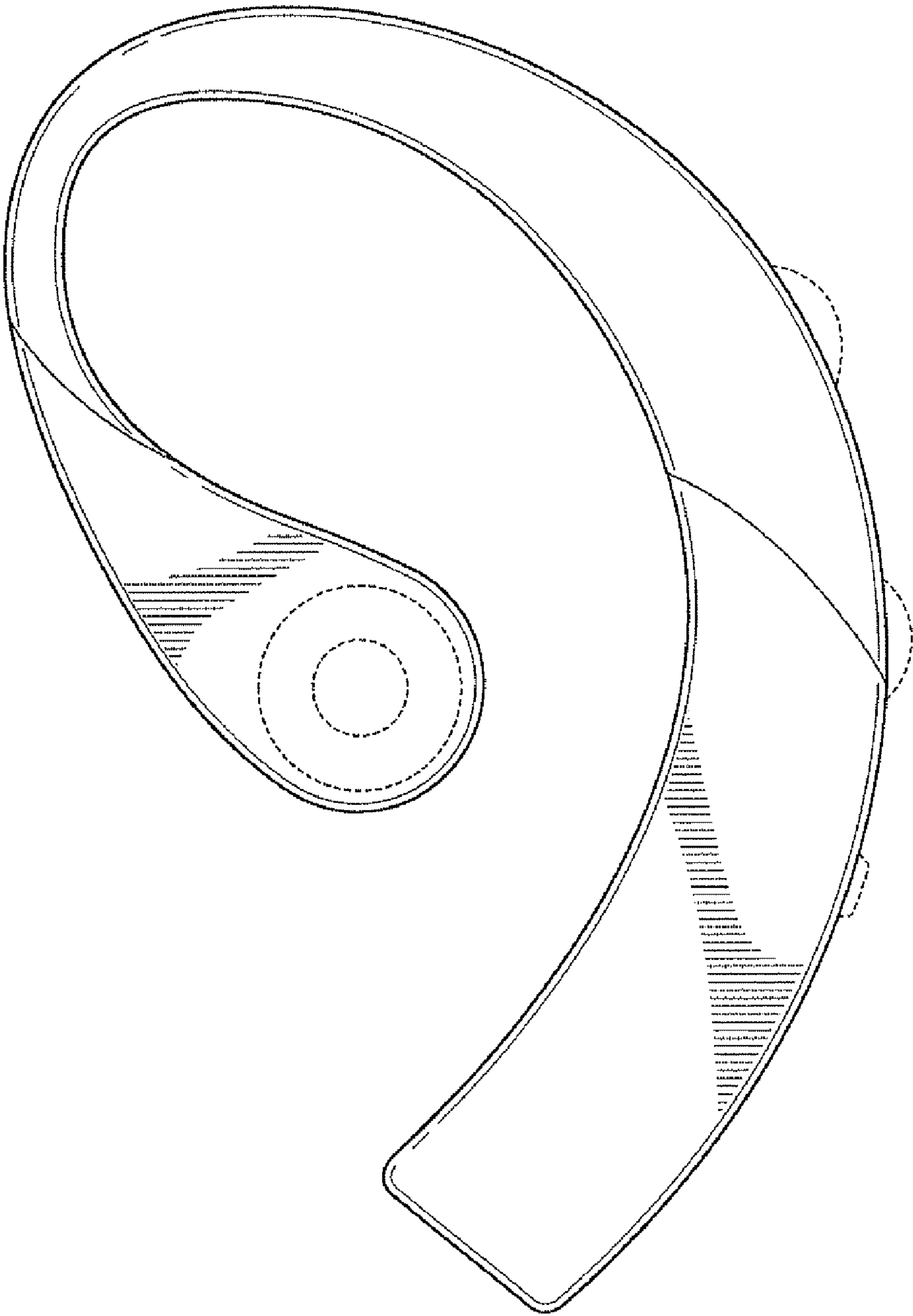

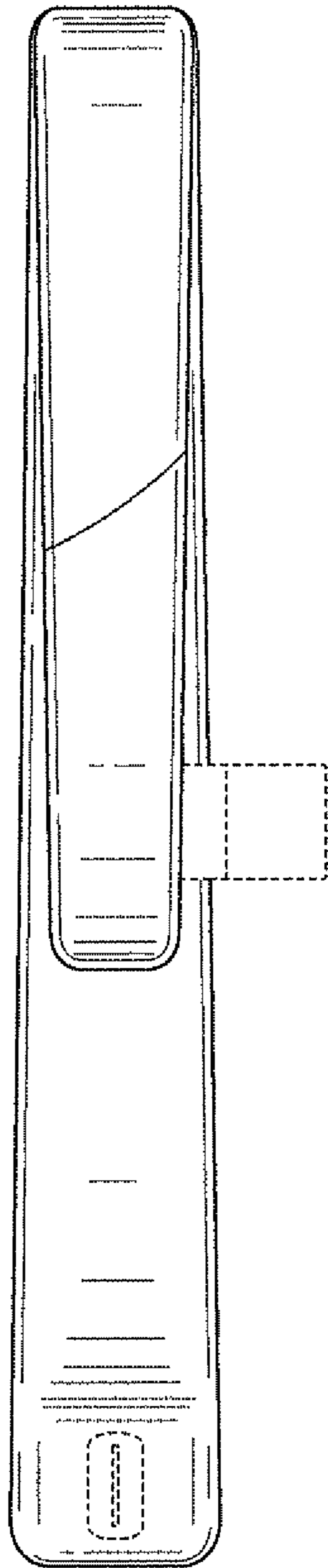

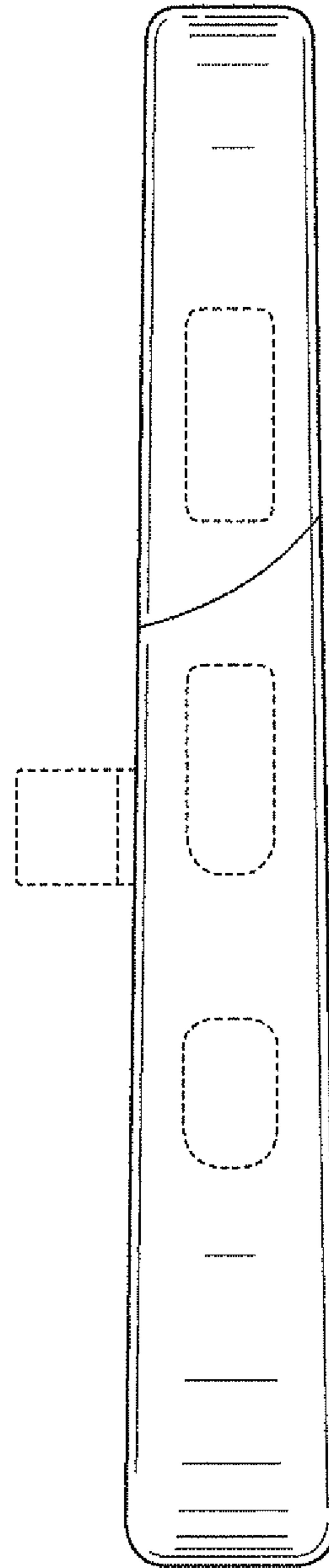

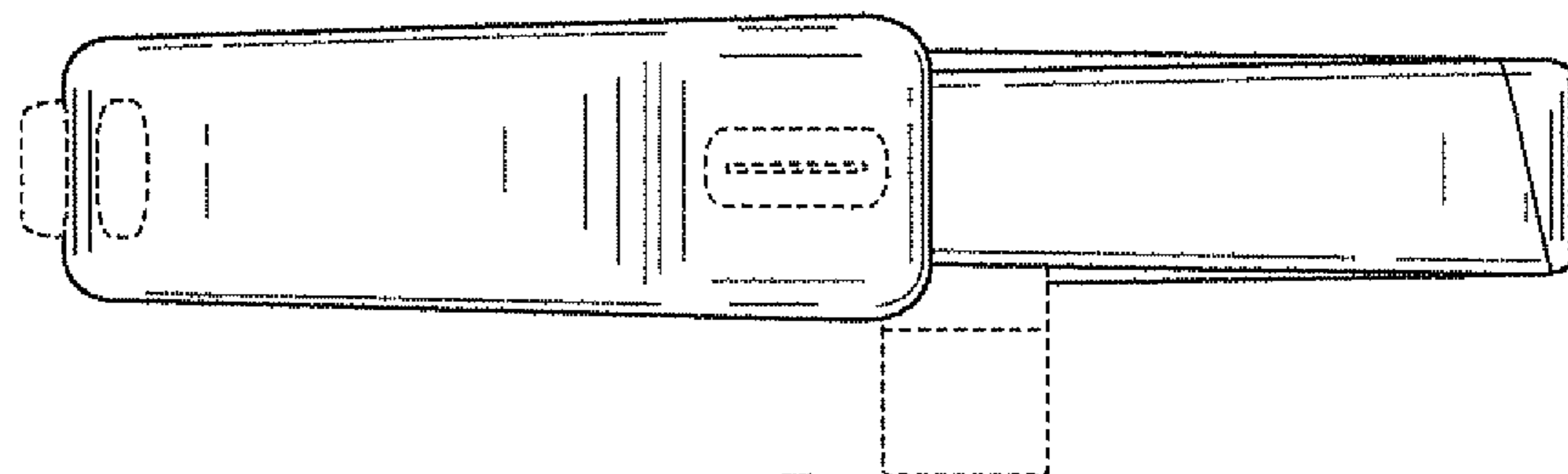

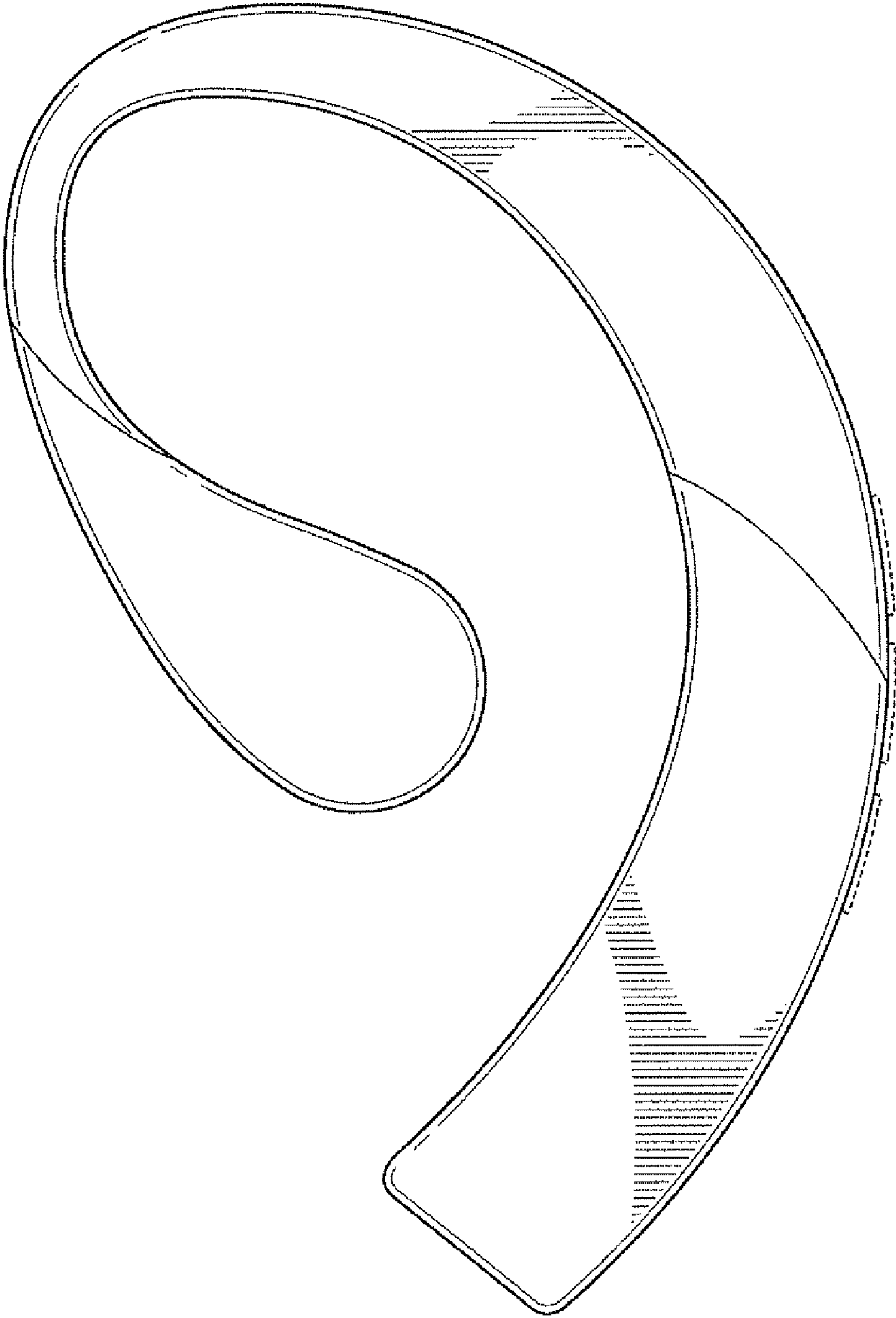

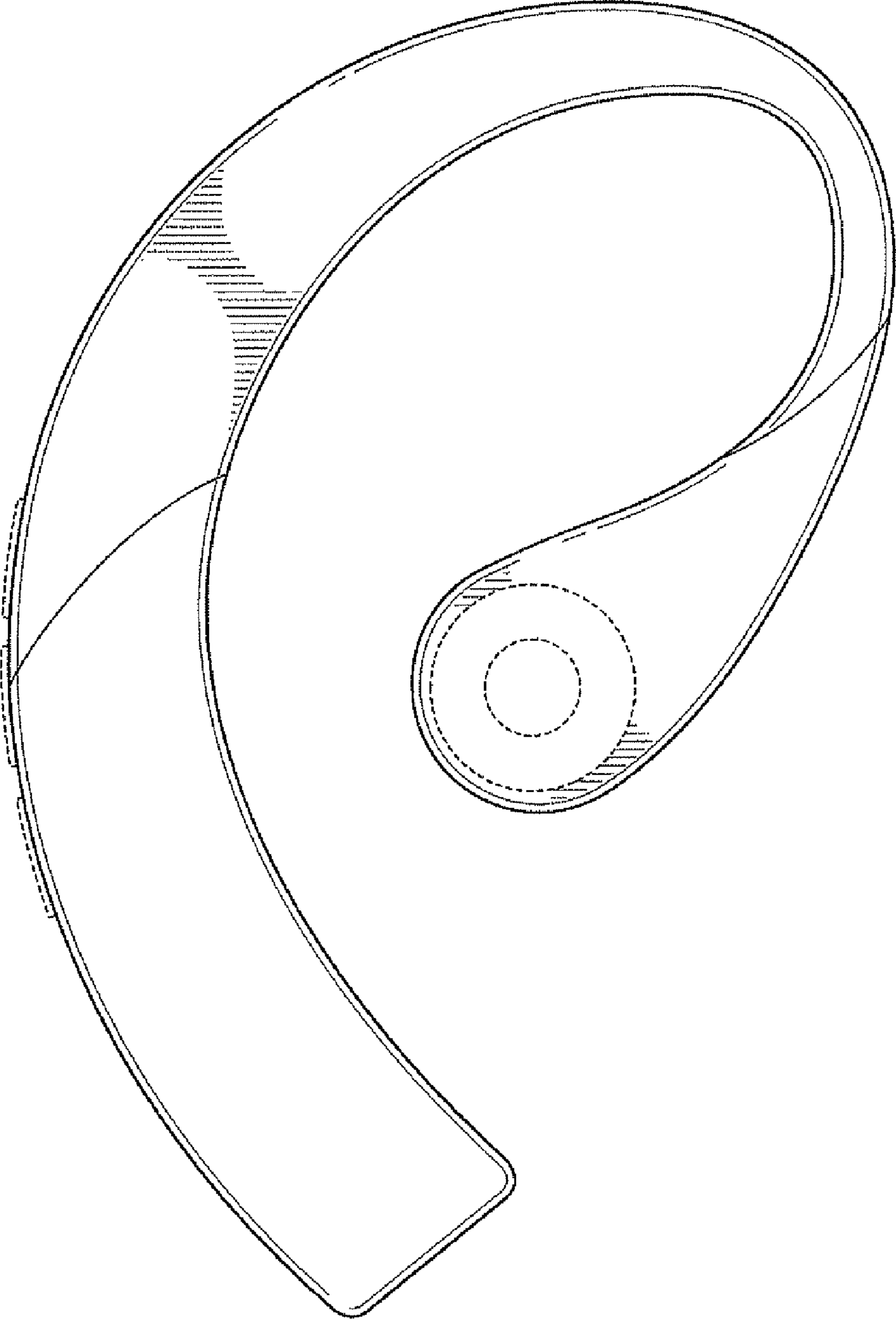

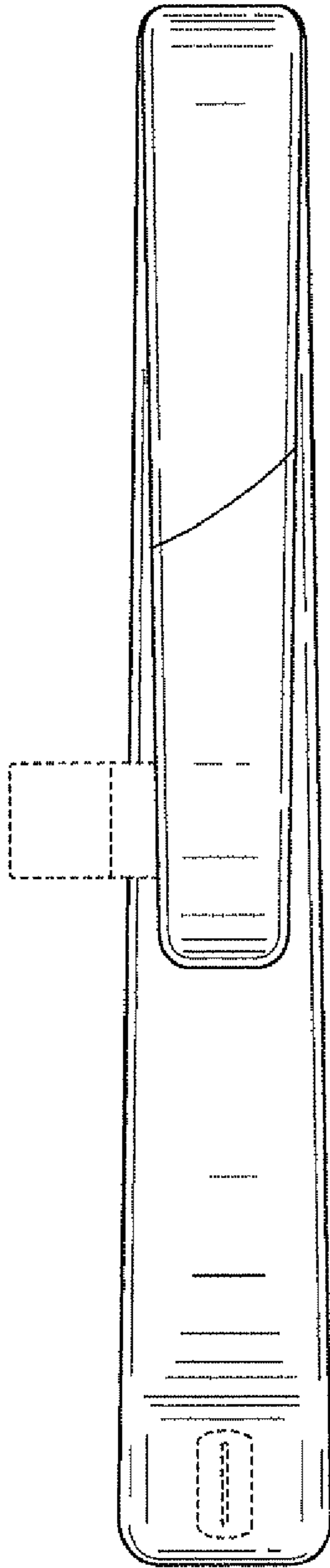

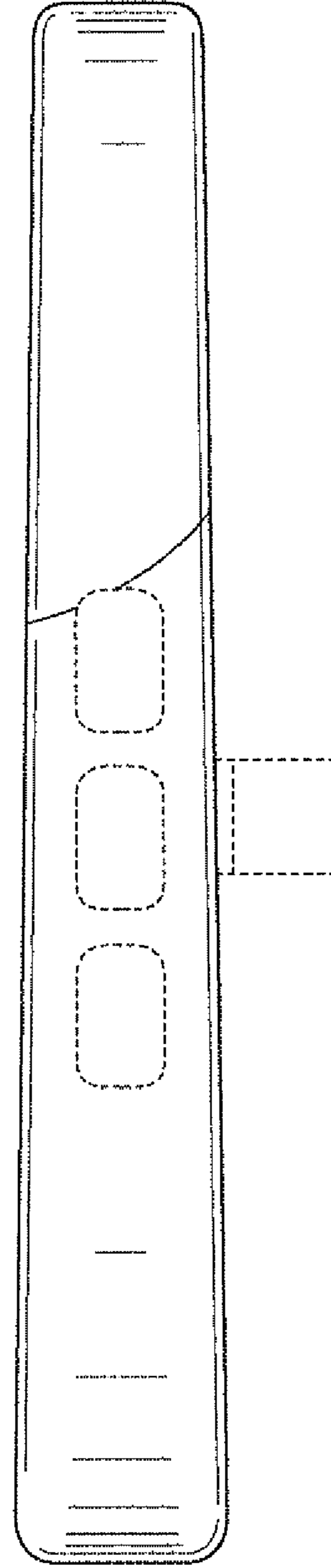

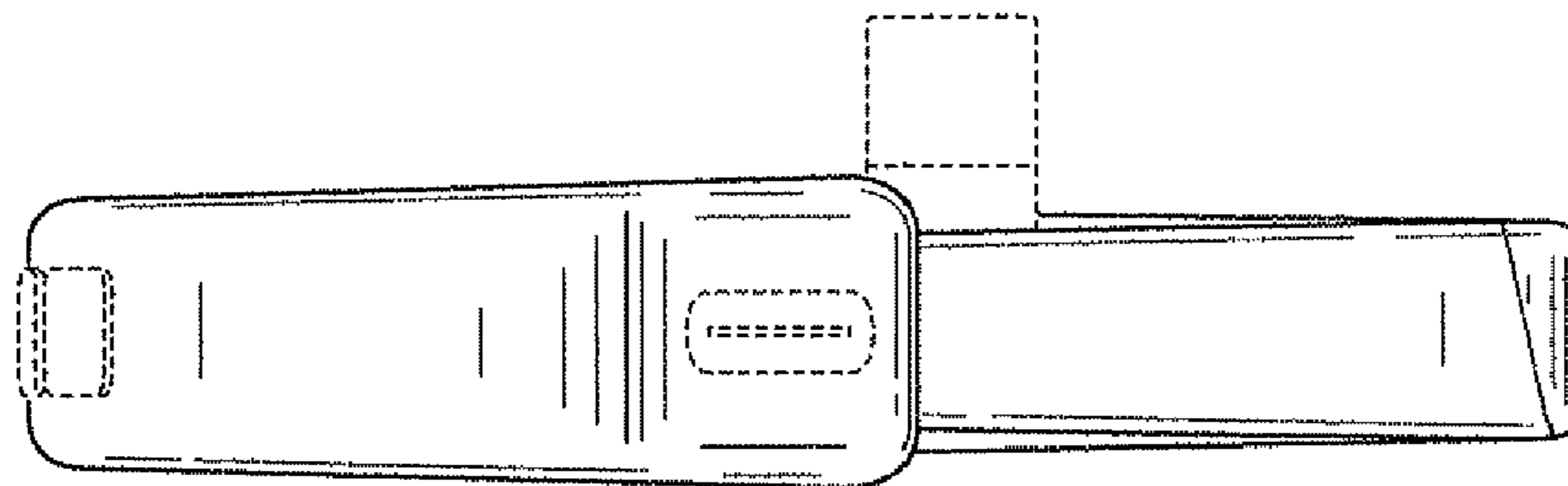
