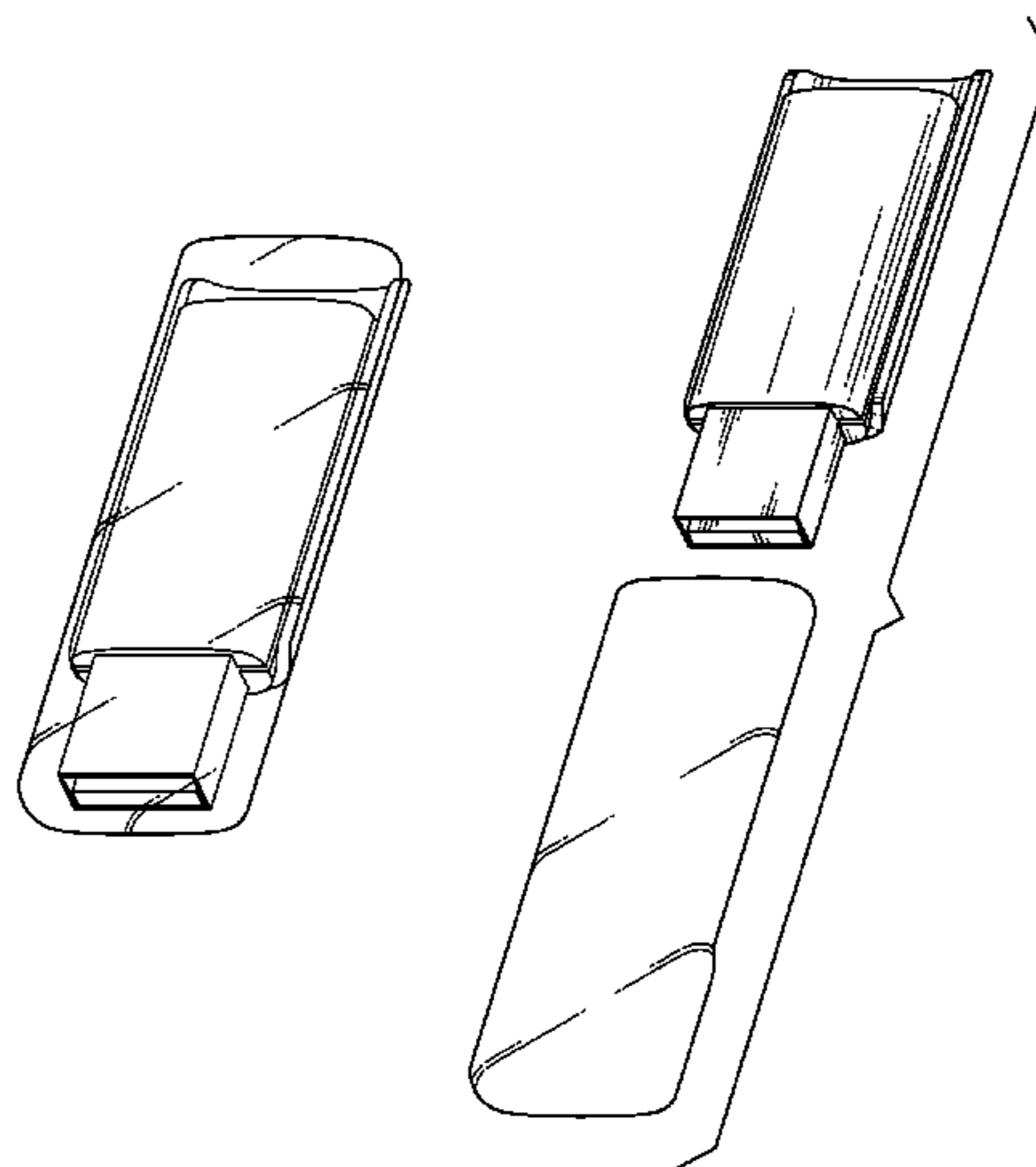

(57) **CLAIM**

The ornamental design for a recording medium, as shown and described.

FIG. 1 is a front perspective view of a recording medium, showing my new design;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a rear elevational view thereof;  
FIG. 4 is a top plan view thereof;  
FIG. 5 is a bottom plan view thereof;  
FIG. 6 is a right side elevational view thereof; the opposite side being a mirror image thereof;  
FIG. 7 is a front elevational view thereof with a cap in an attached state in use for completeness of illustration;  
FIG. 8 is a rear elevational view of FIG. 7;  
FIG. 9 is a right side elevational view of FIG. 7; the opposite side being a mirror image thereof; a top plan view of FIG. 7 being identical with FIG. 4; a bottom plan view of FIG. 7 being identical with FIG. 5;  
FIG. 10 is a rear perspective view of FIG. 7;  
FIG. 11 is a perspective view thereof with a cap in a removed state for completeness of illustration;  
FIG. 12 is a front elevational view thereof, shown without a cap for completeness of illustration;  
FIG. 13 is a rear elevational view of FIG. 12;  
FIG. 14 is a top plan view of FIG. 12;  
FIG. 15 is a bottom plan view of FIG. 12;  
FIG. 16 is a right side elevational view of FIG. 12; the opposite side being a mirror image thereof;  
FIG. 17 is a front elevational view of the cap thereof for completeness of illustration;  
FIG. 18 is a rear elevational view of FIG. 17;  
FIG. 19 is a bottom plan view of FIG. 17; the opposite side being identical with the FIG. 4; and,  
FIG. 20 is a right side elevational view of FIG. 17; and the opposite side being a mirror image thereof.

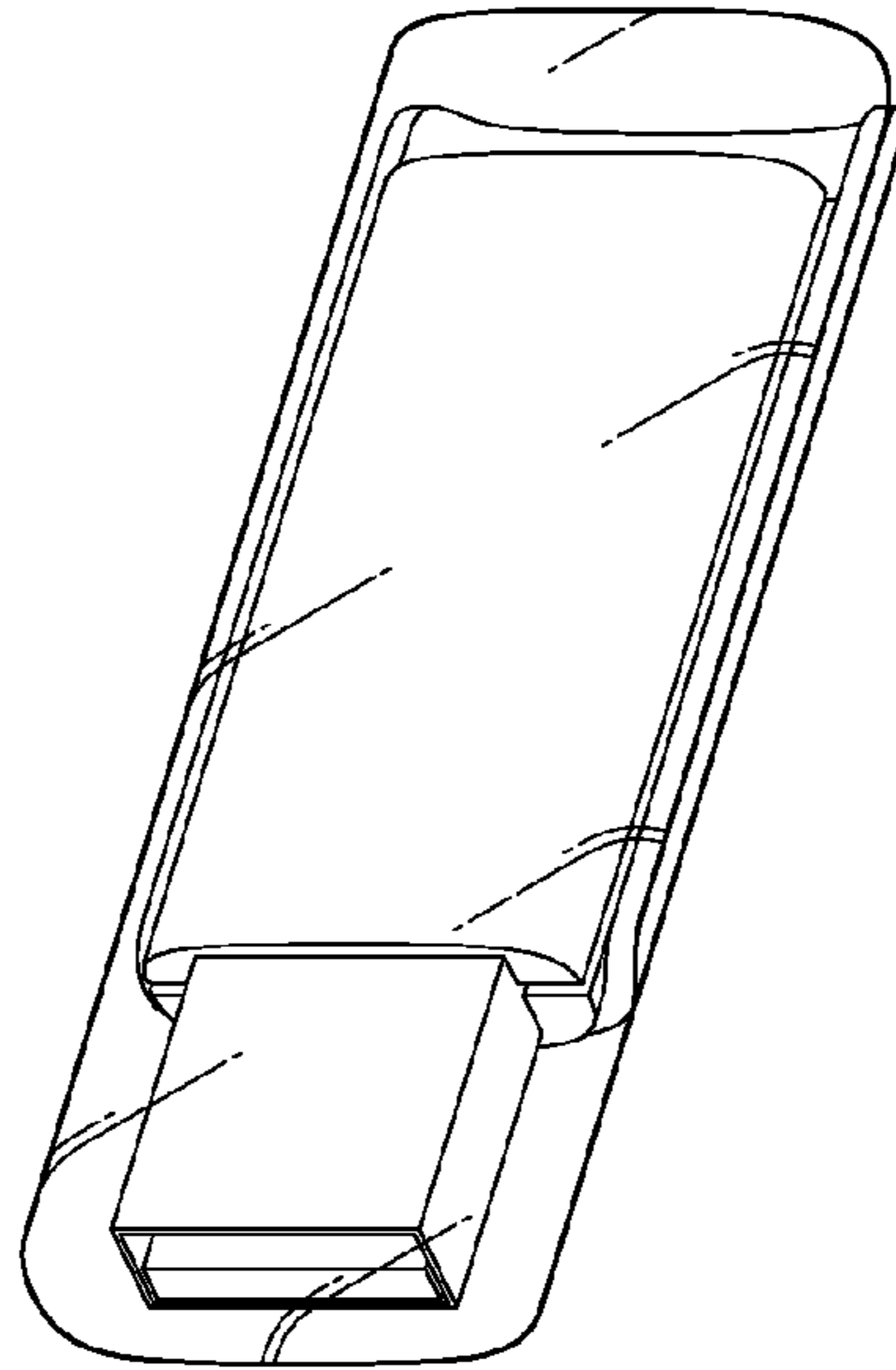

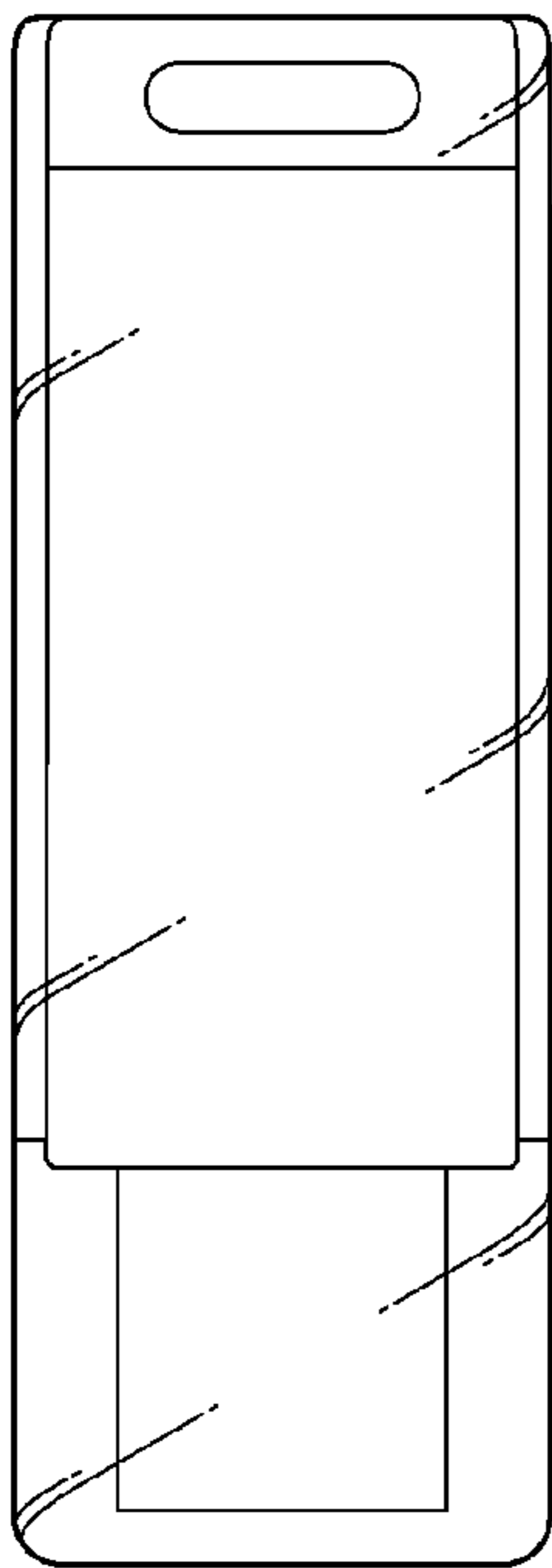

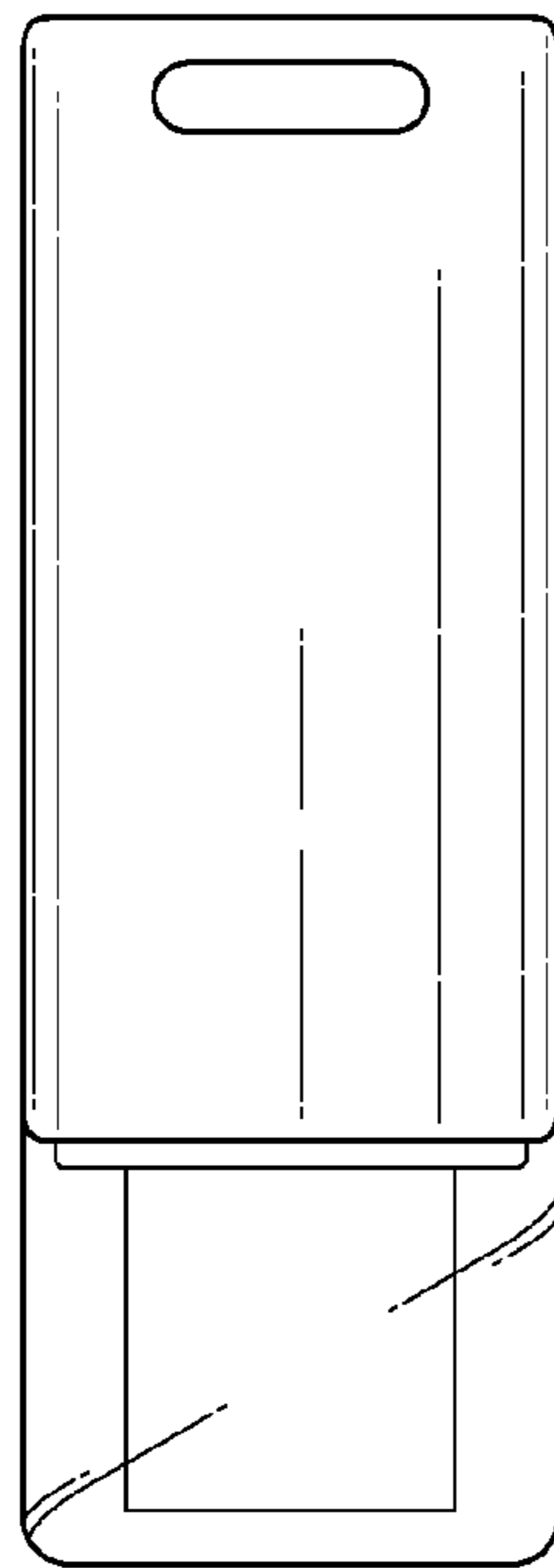

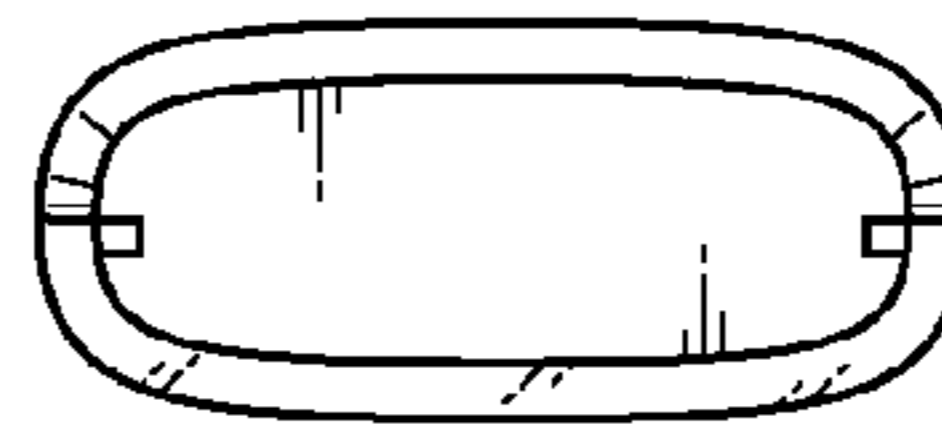

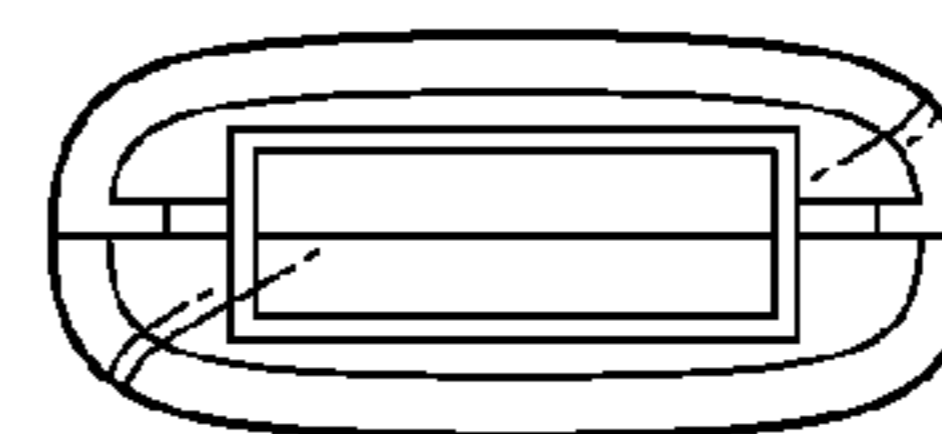

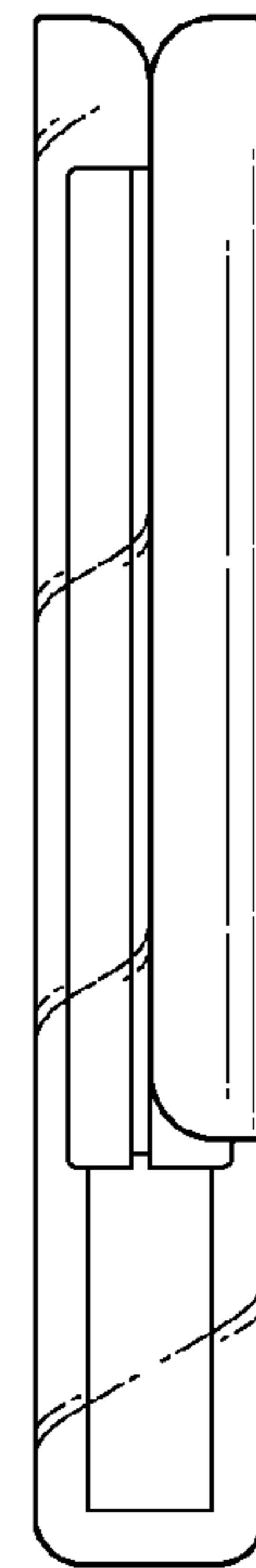

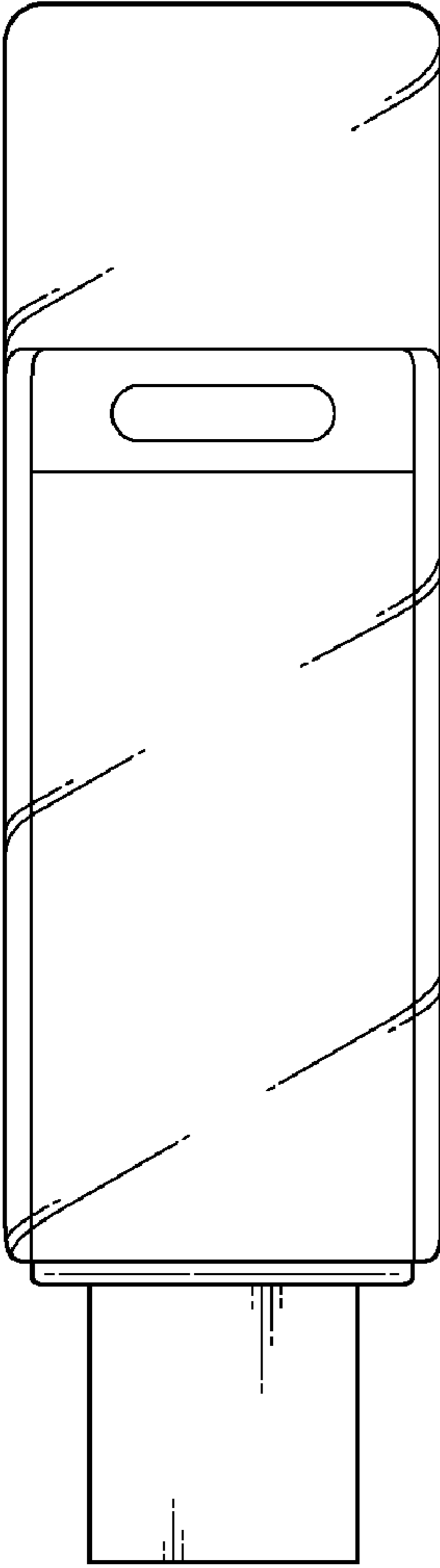

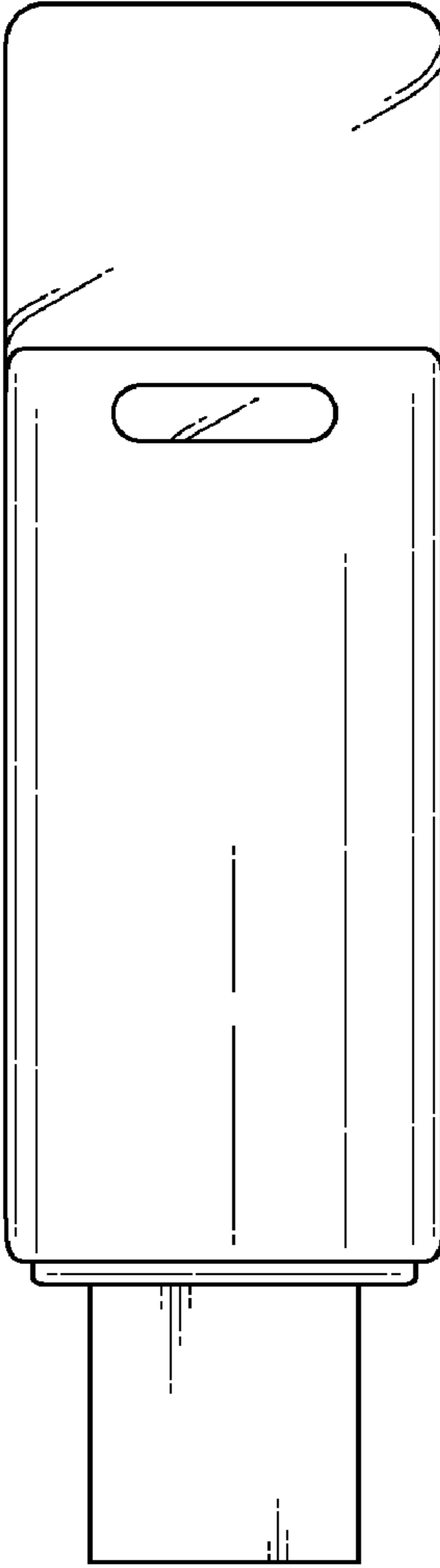

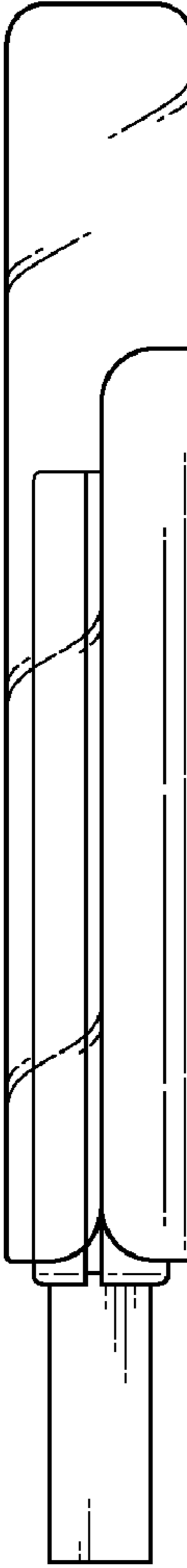

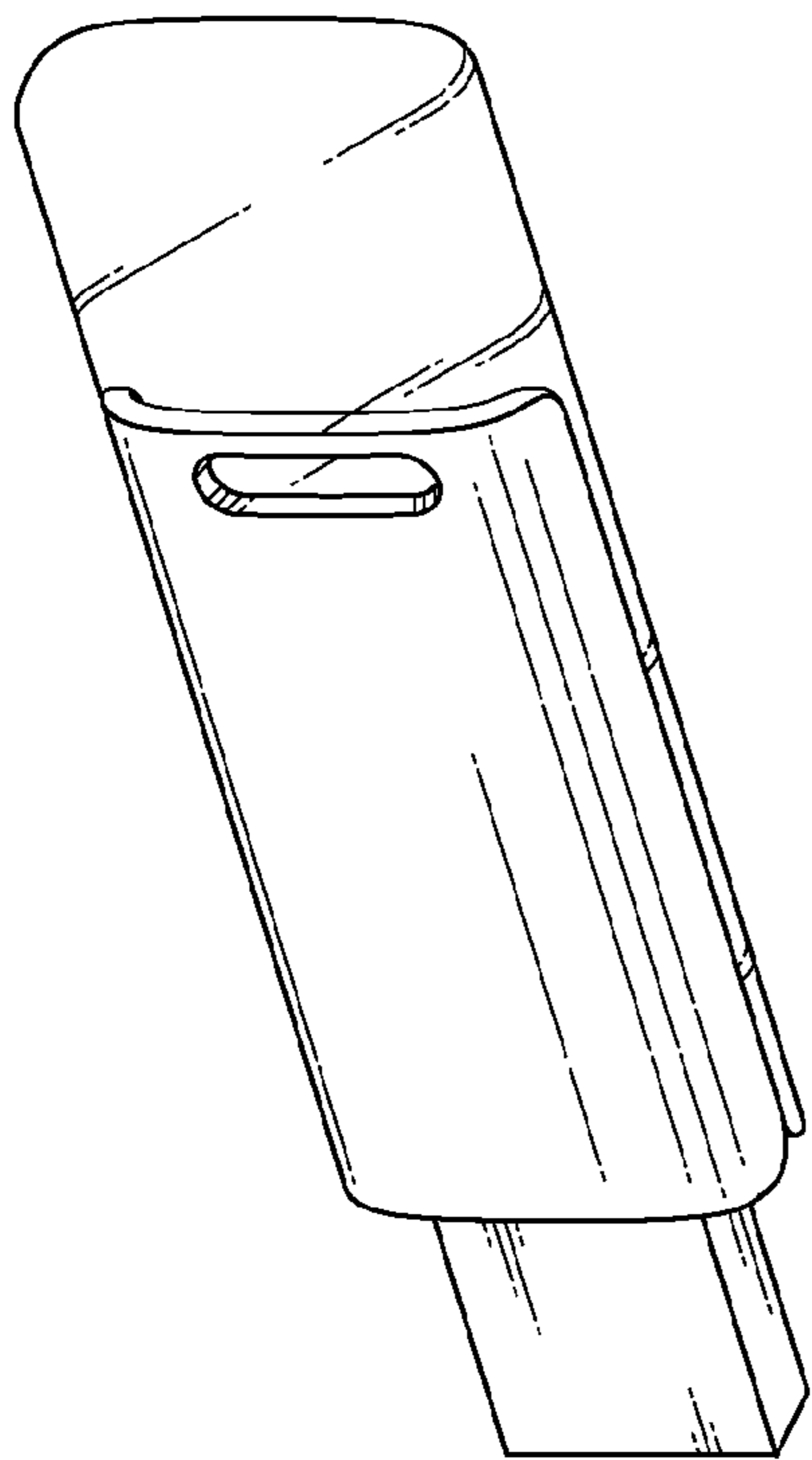

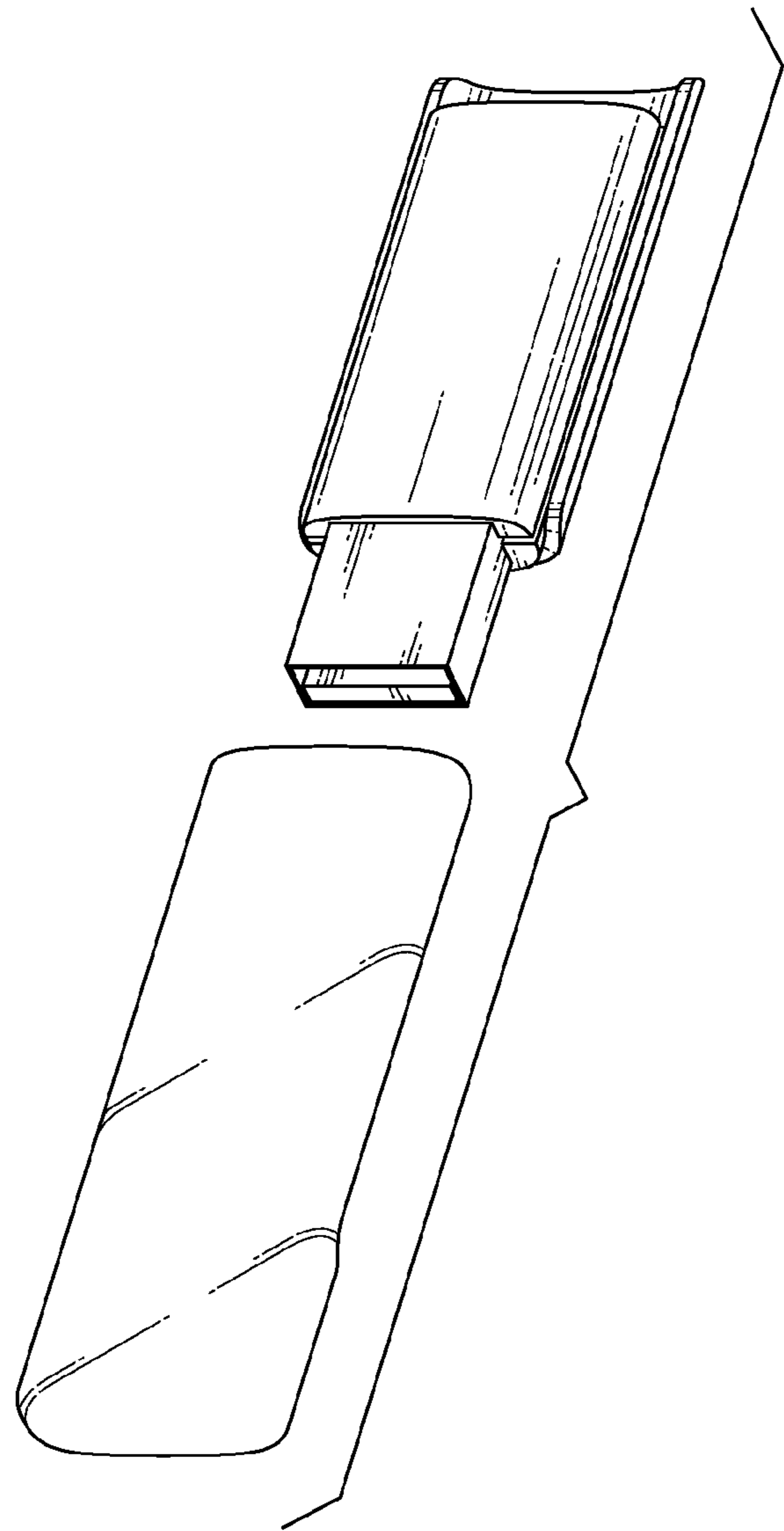

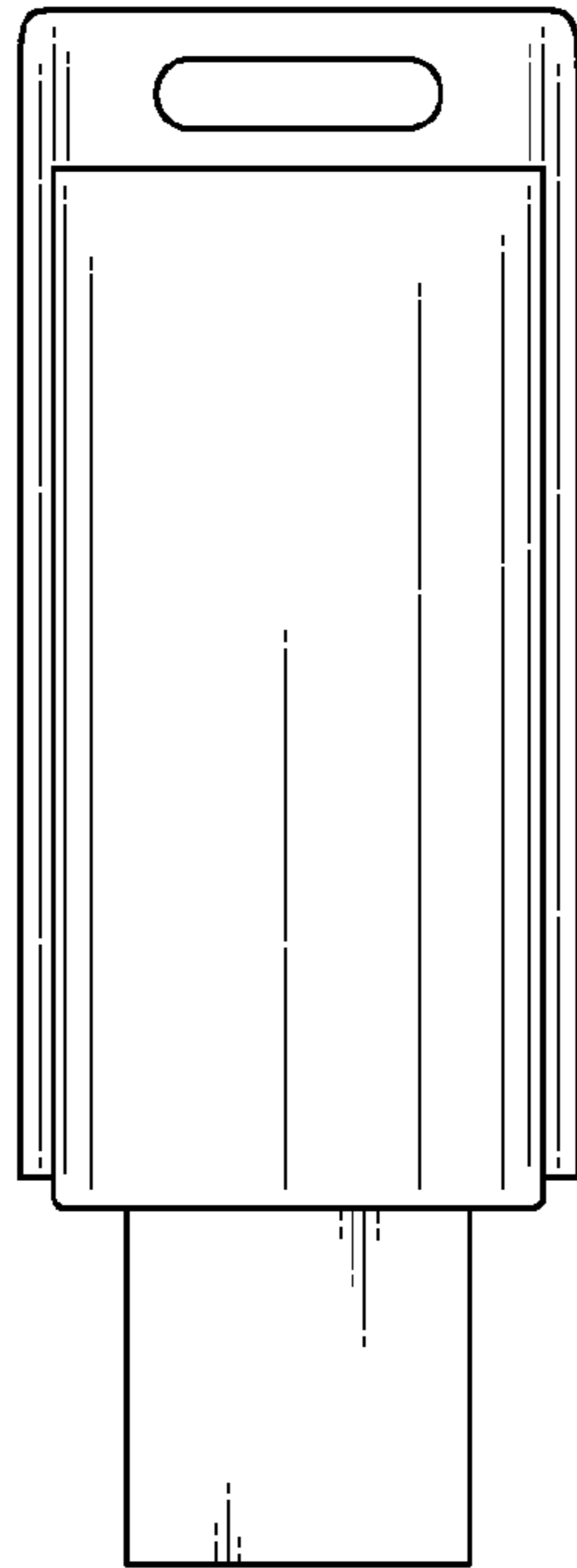

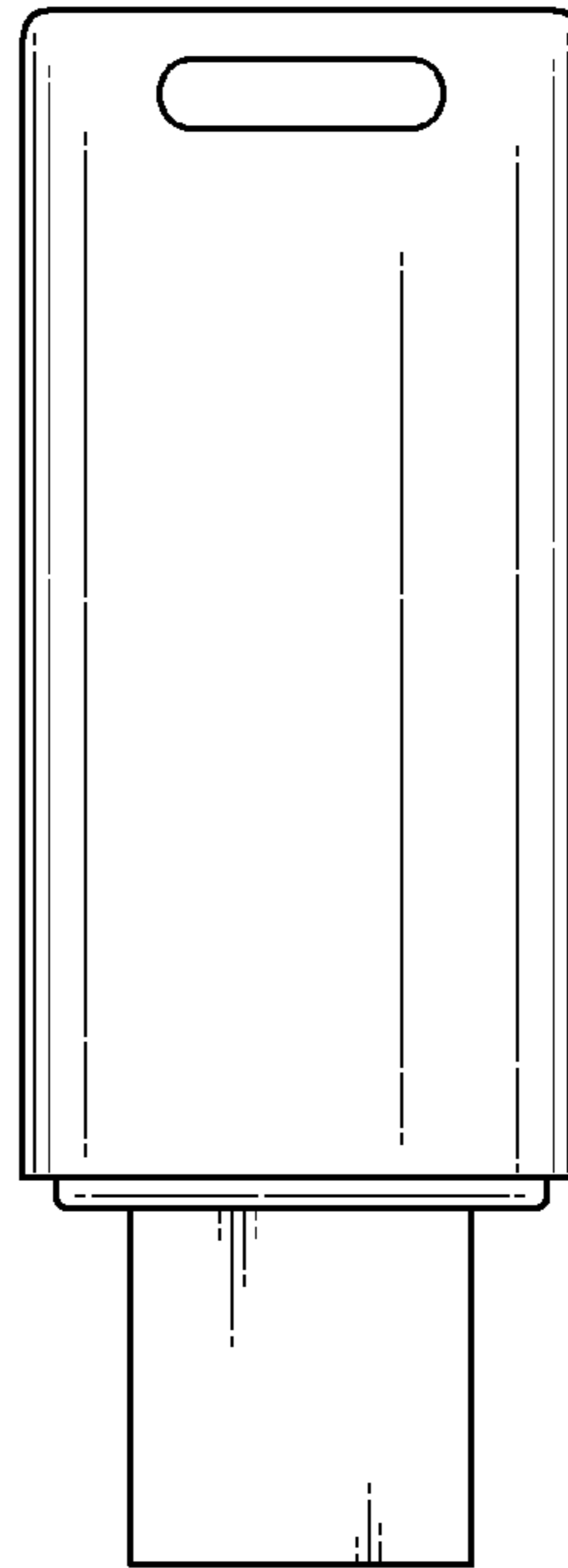

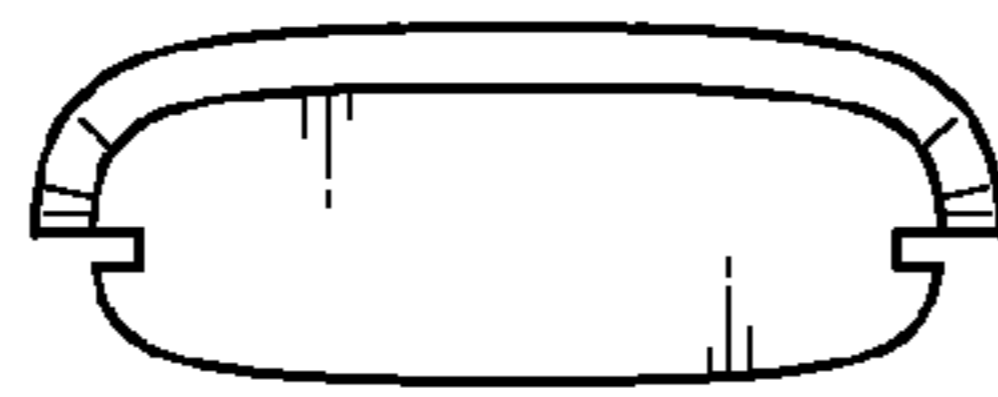

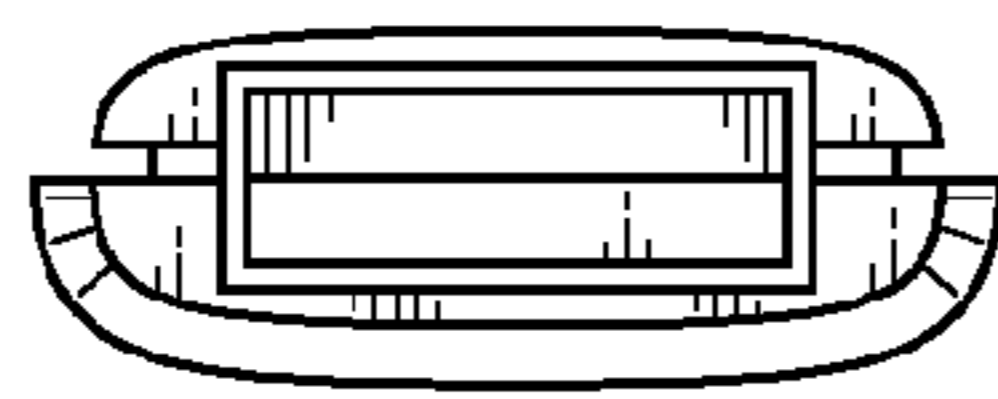

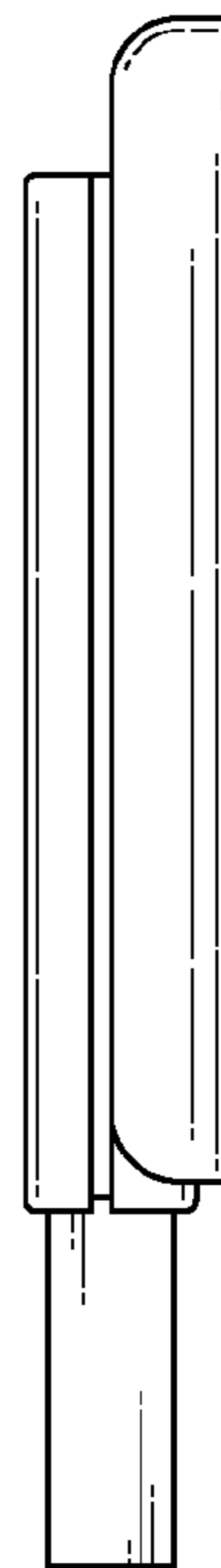

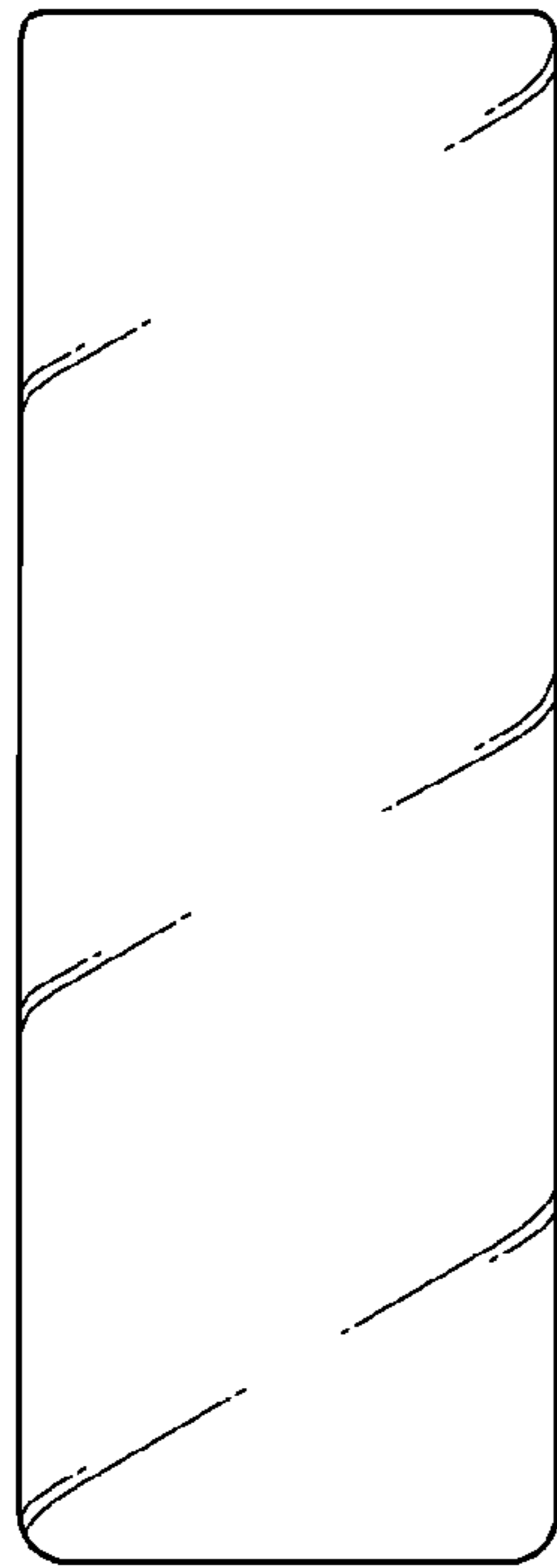

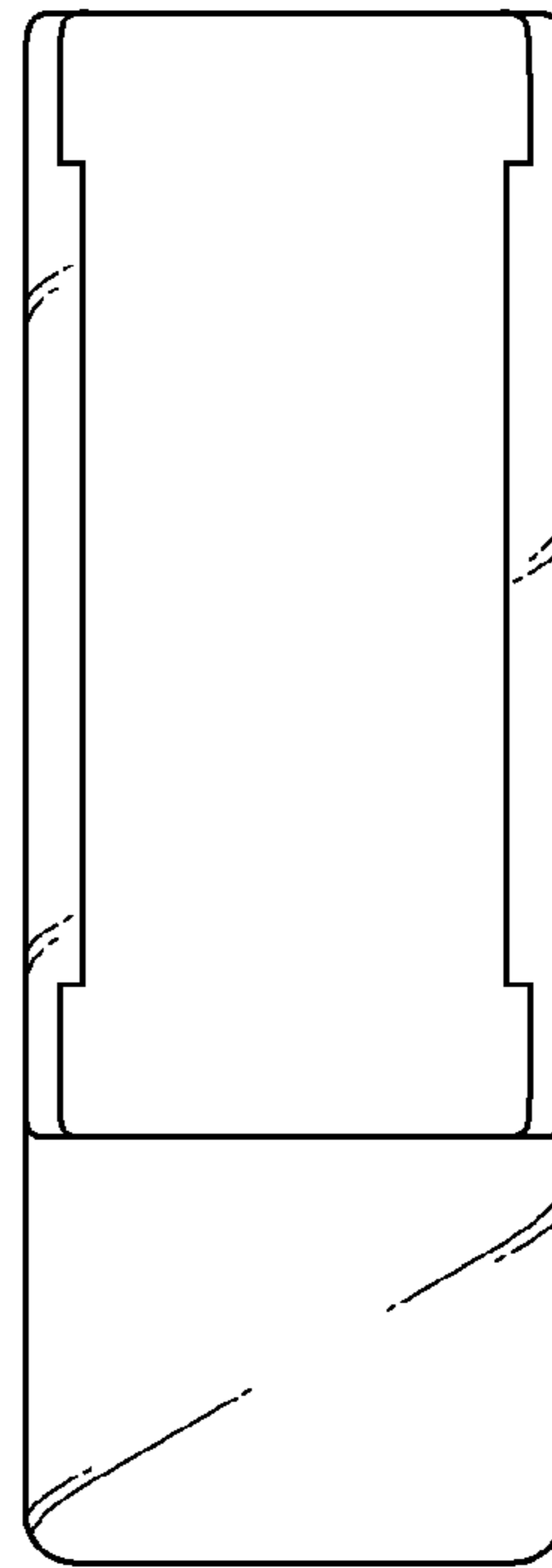

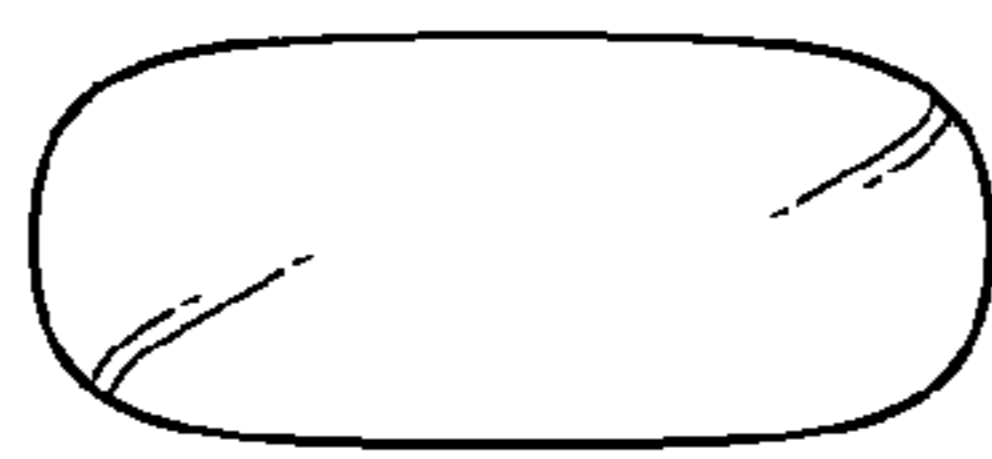
