DESCRIPTION

FIG. 4 is a left side elevation view of the uniform scrapbook of FIG. 1.

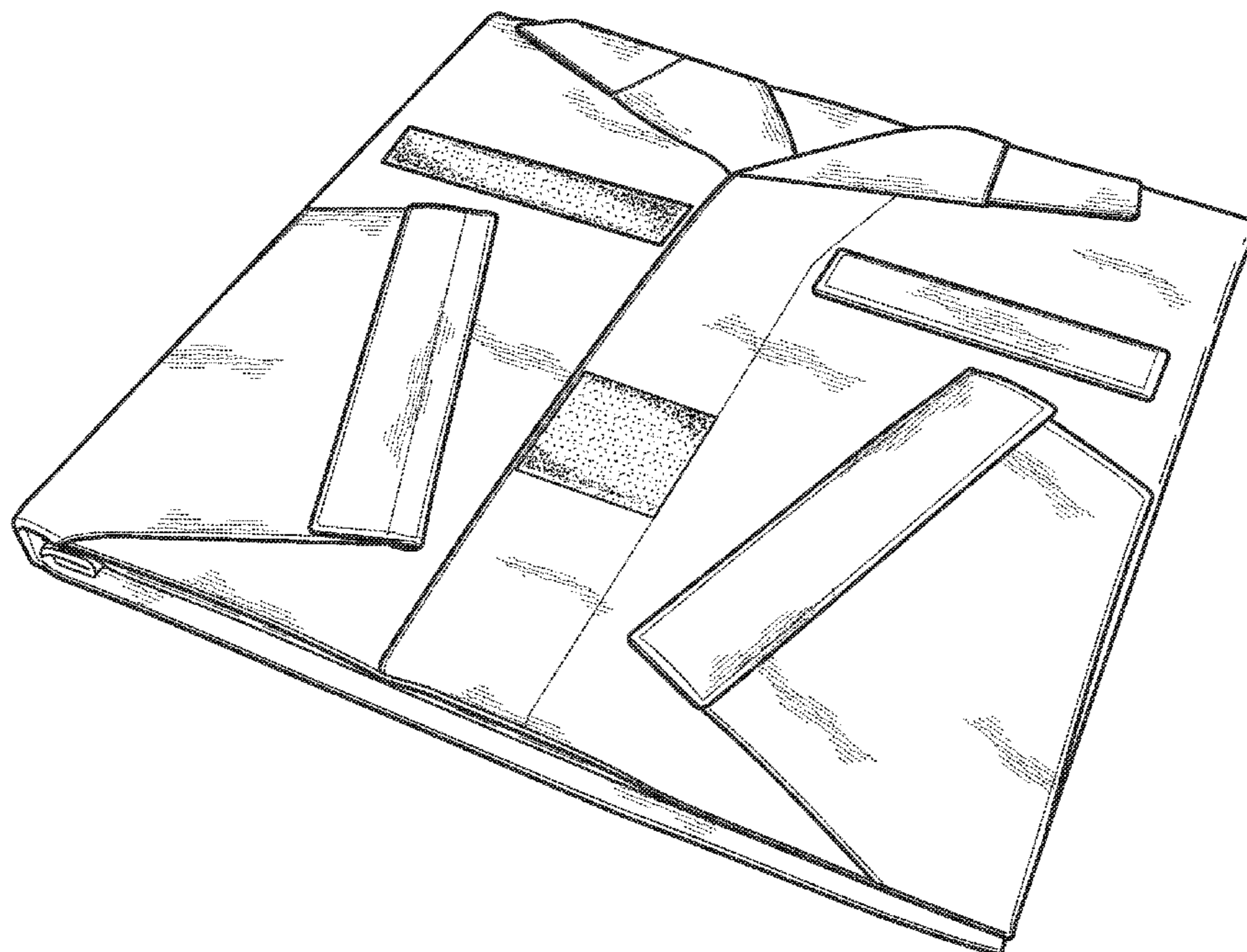
FIG. 5 is a right side elevation view of the uniform scrapbook of FIG. 1.

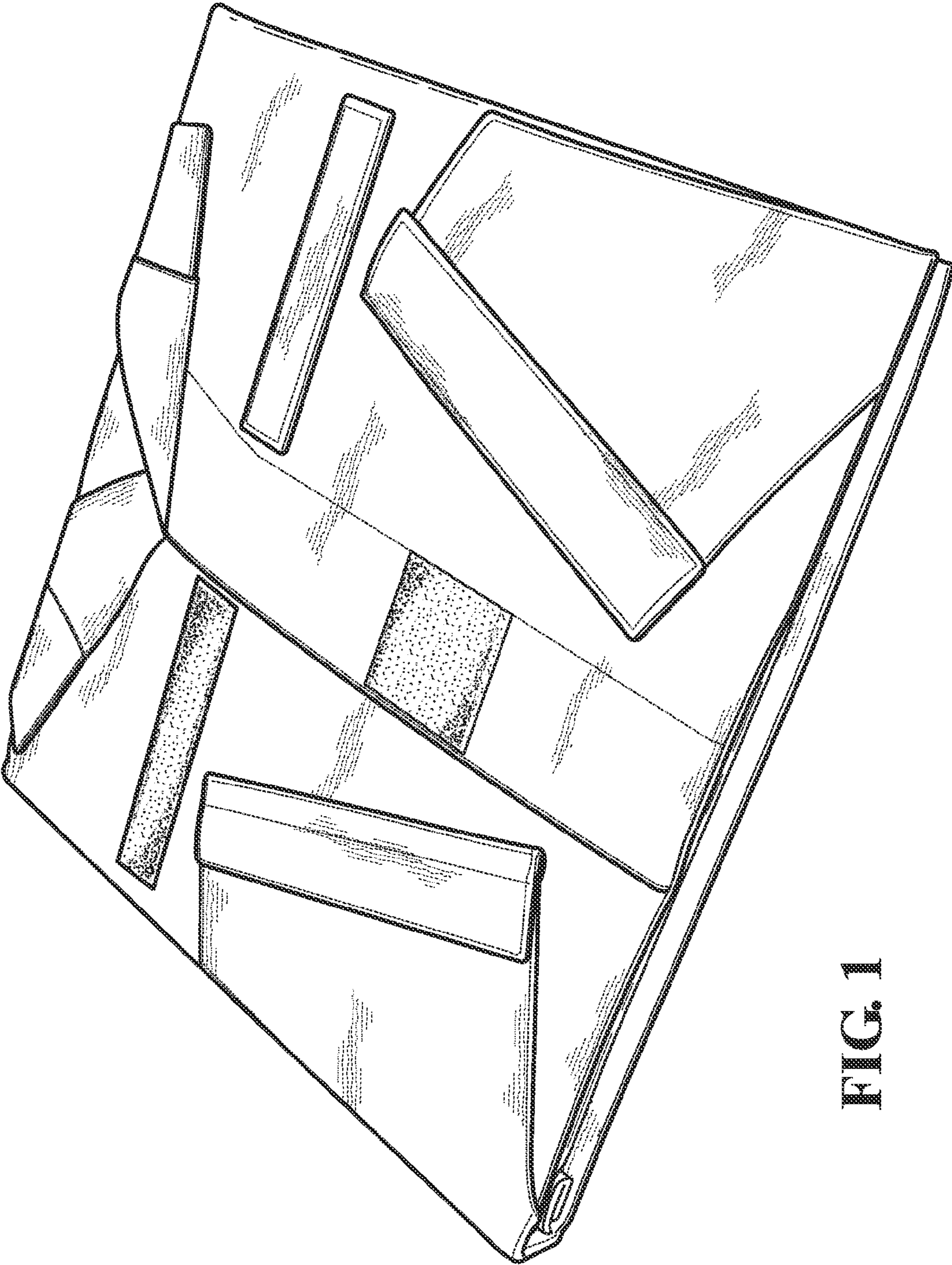

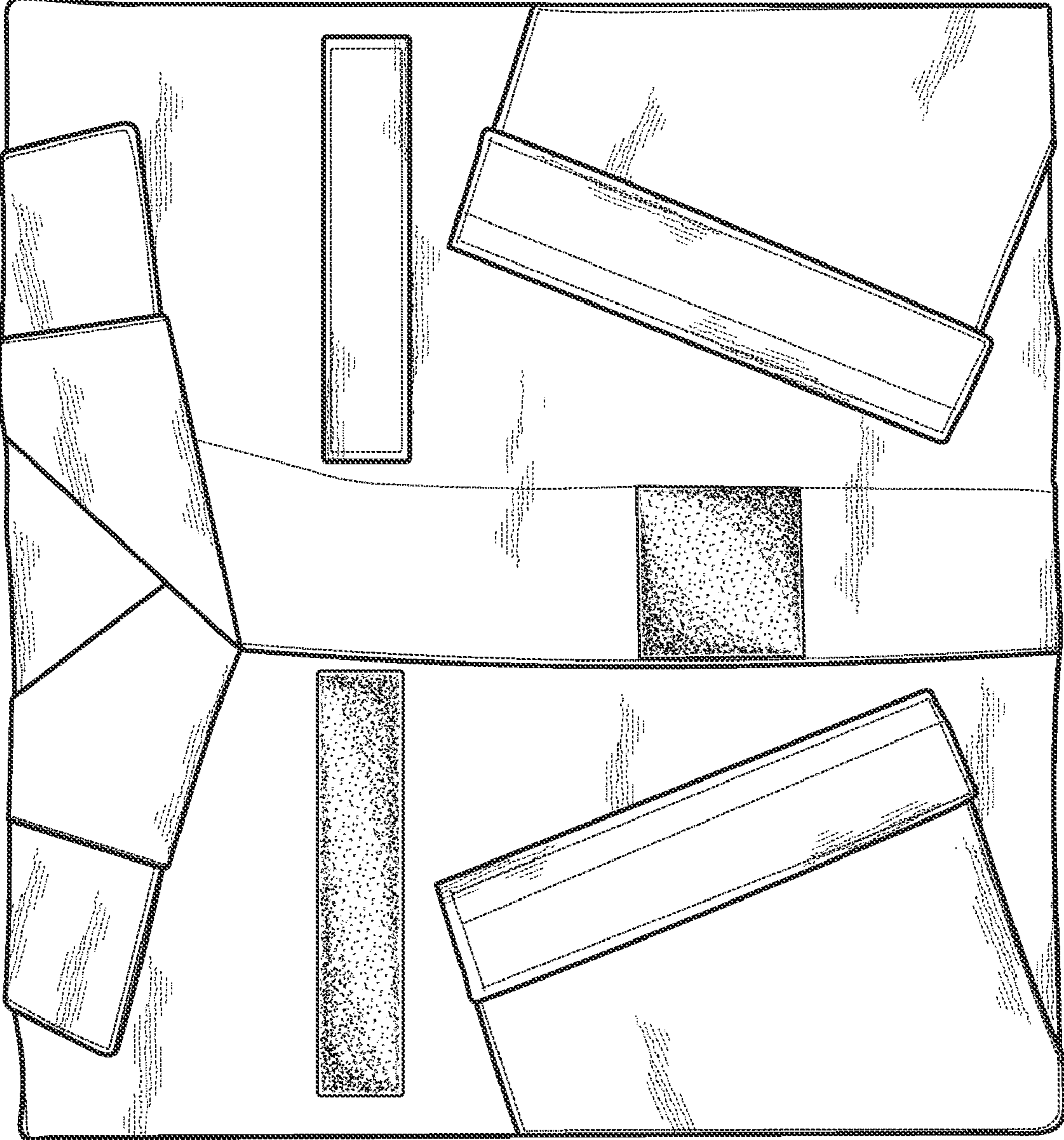

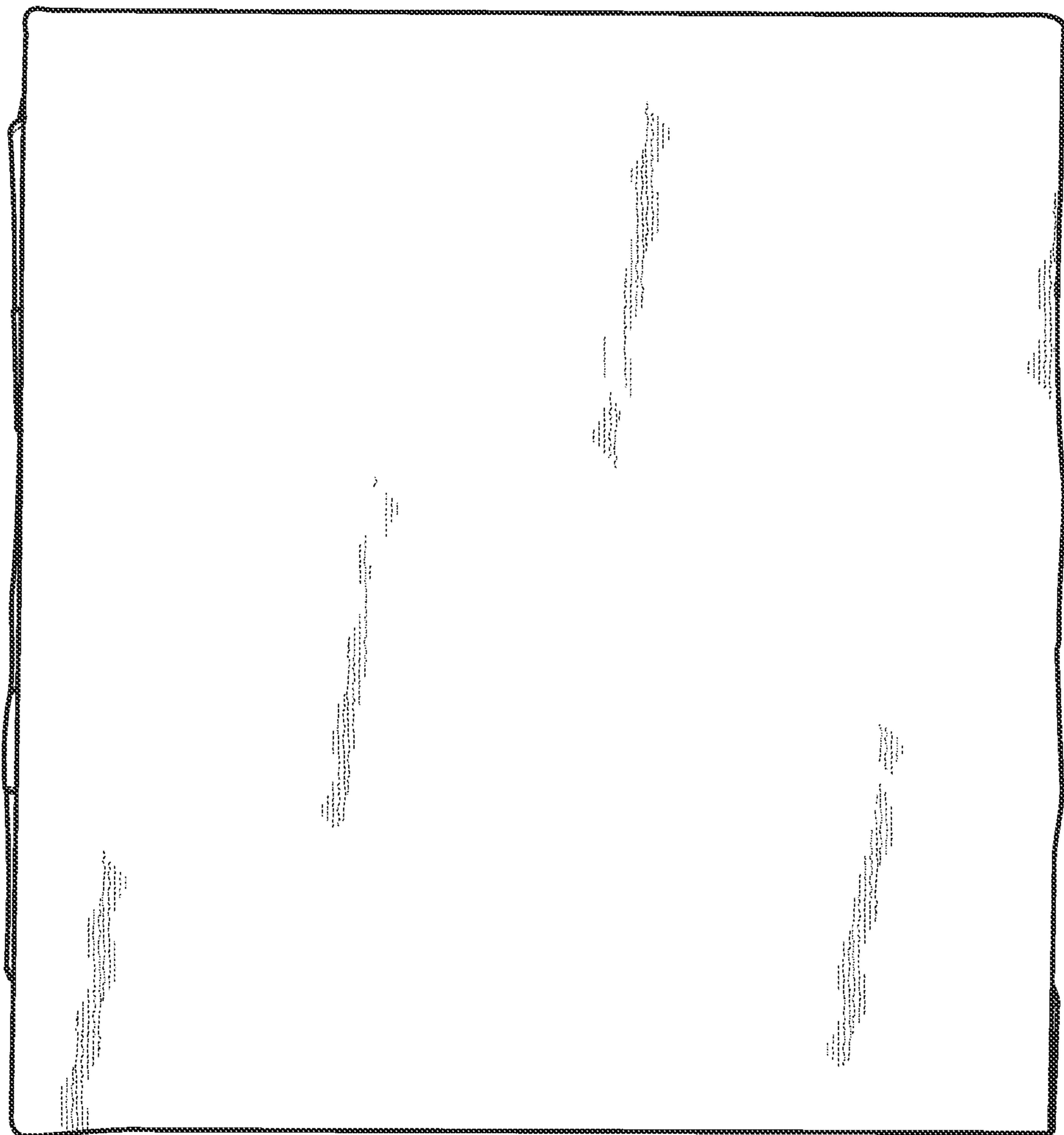

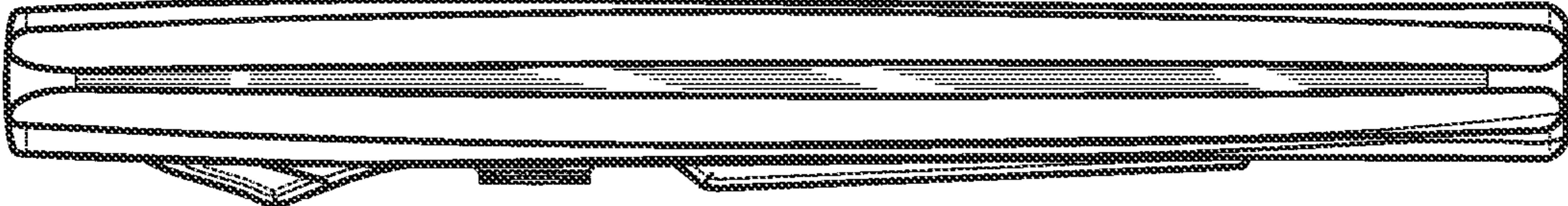

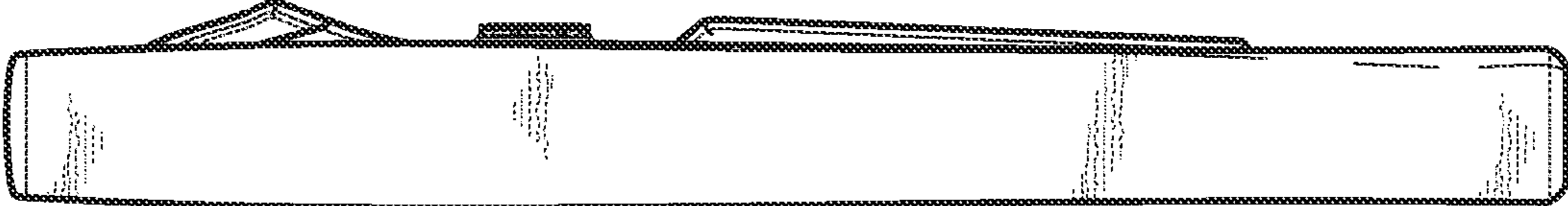

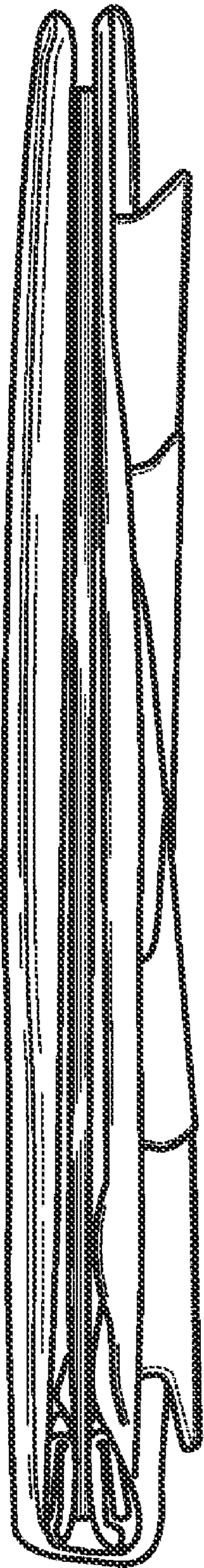

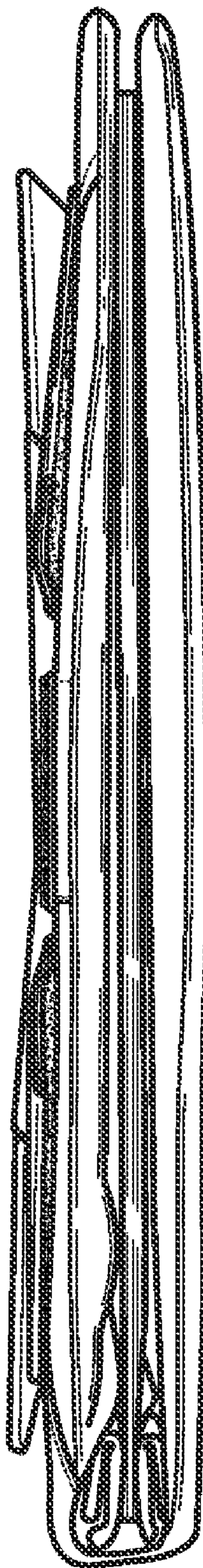

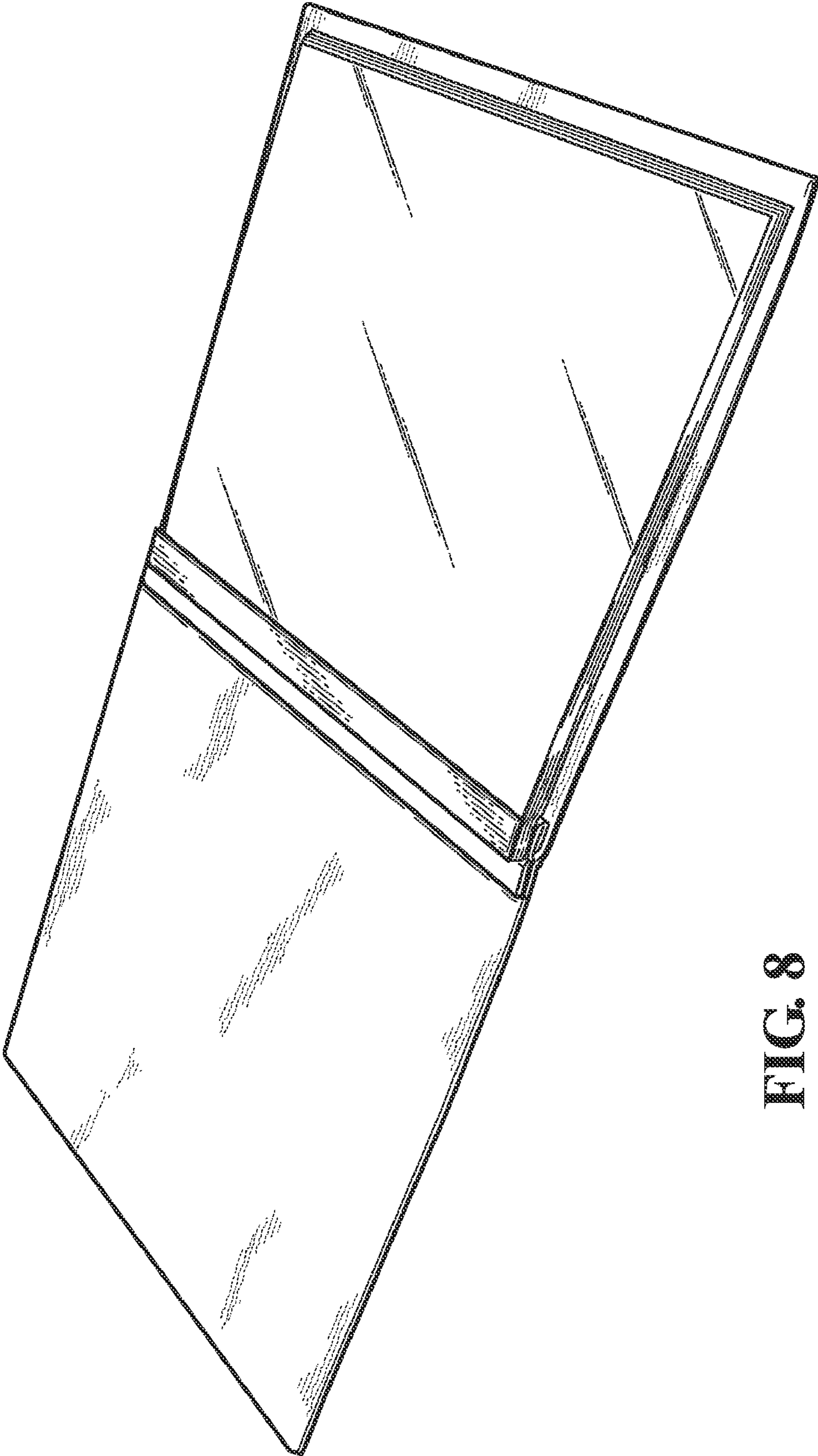
