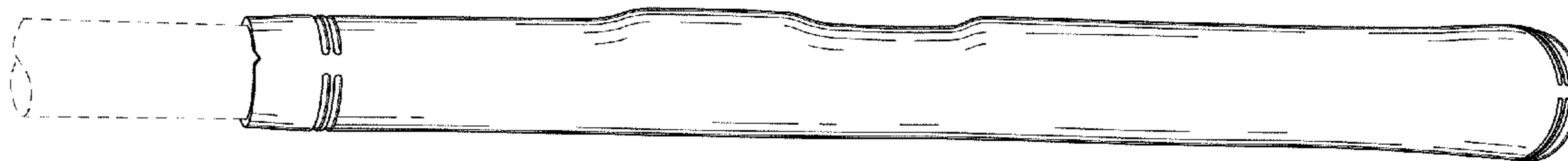
The ornamental design for a golf grip, as shown and described.

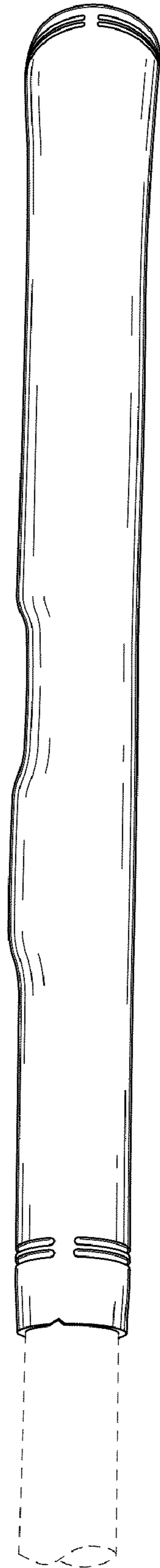
**DESCRIPTION**

FIG. 4 is a bottom plan view of the ornamental design of FIG. 1.

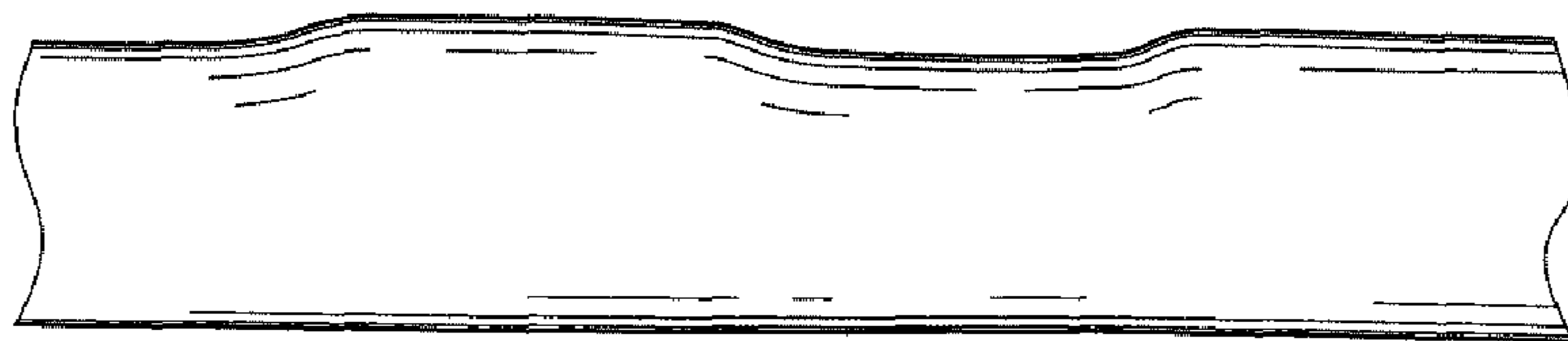

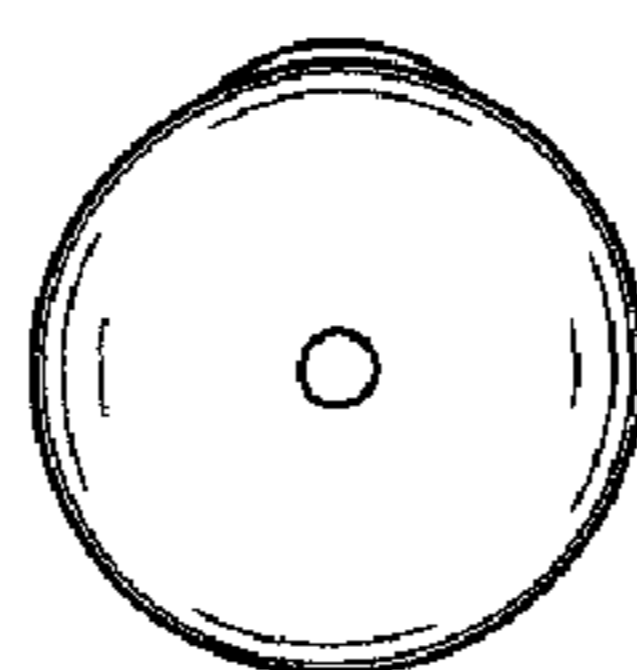




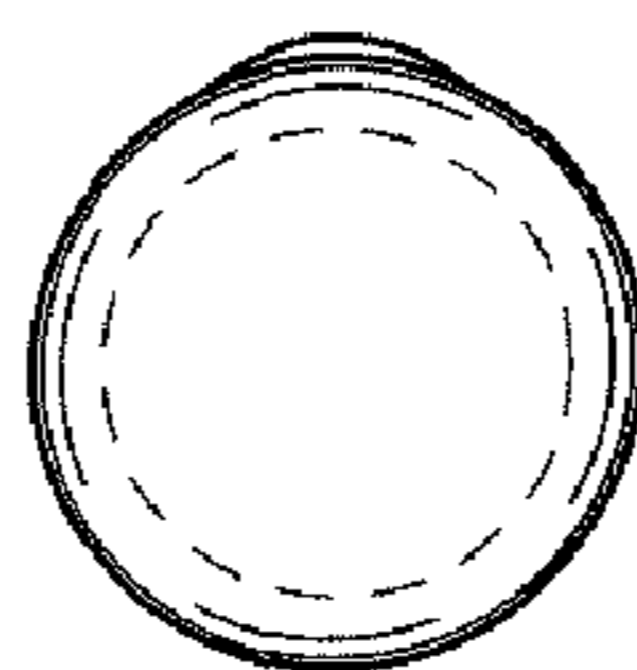
