FIG. 1 is a front perspective view of a cap;

FIG. 2 is a bottom plan view thereof;

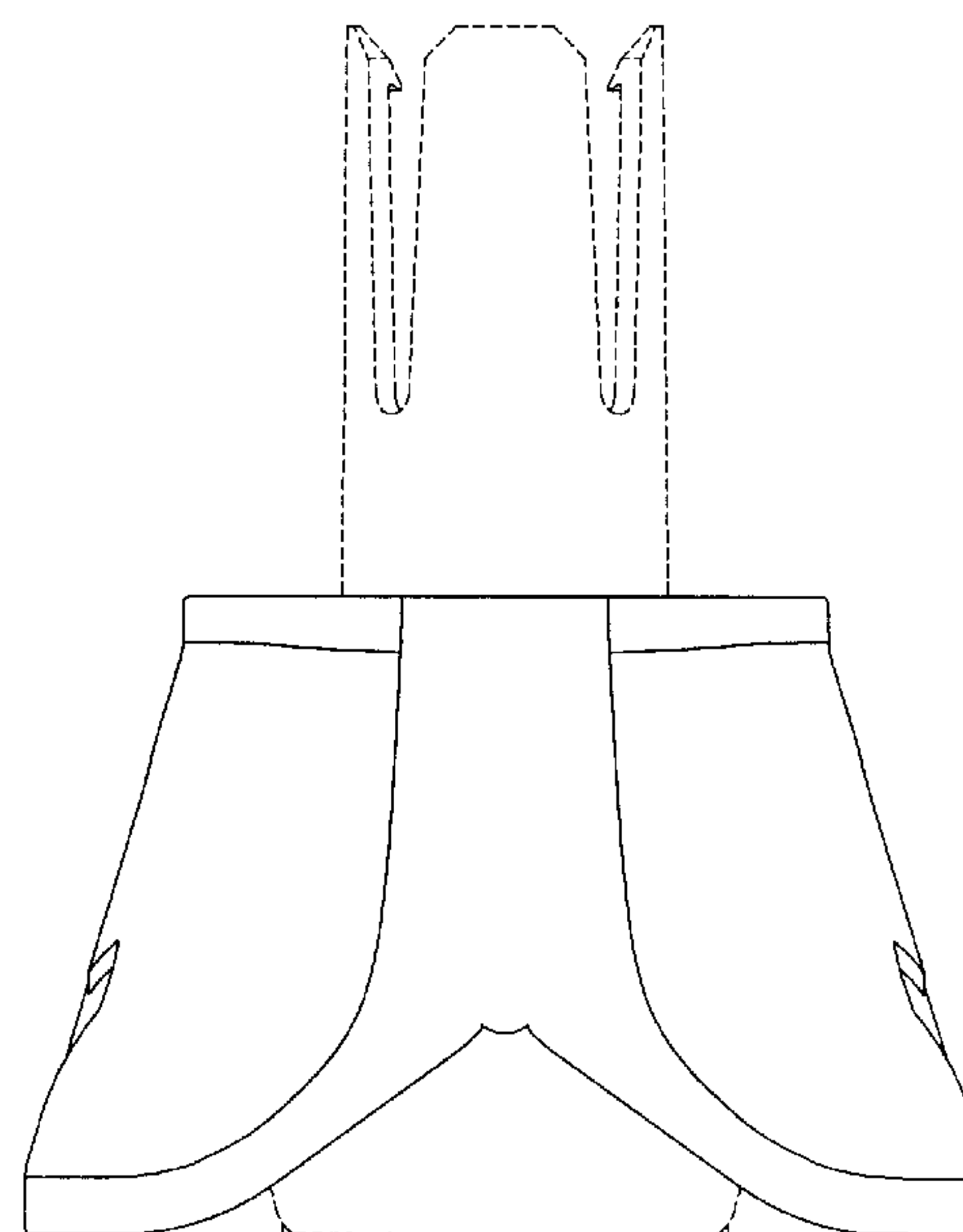
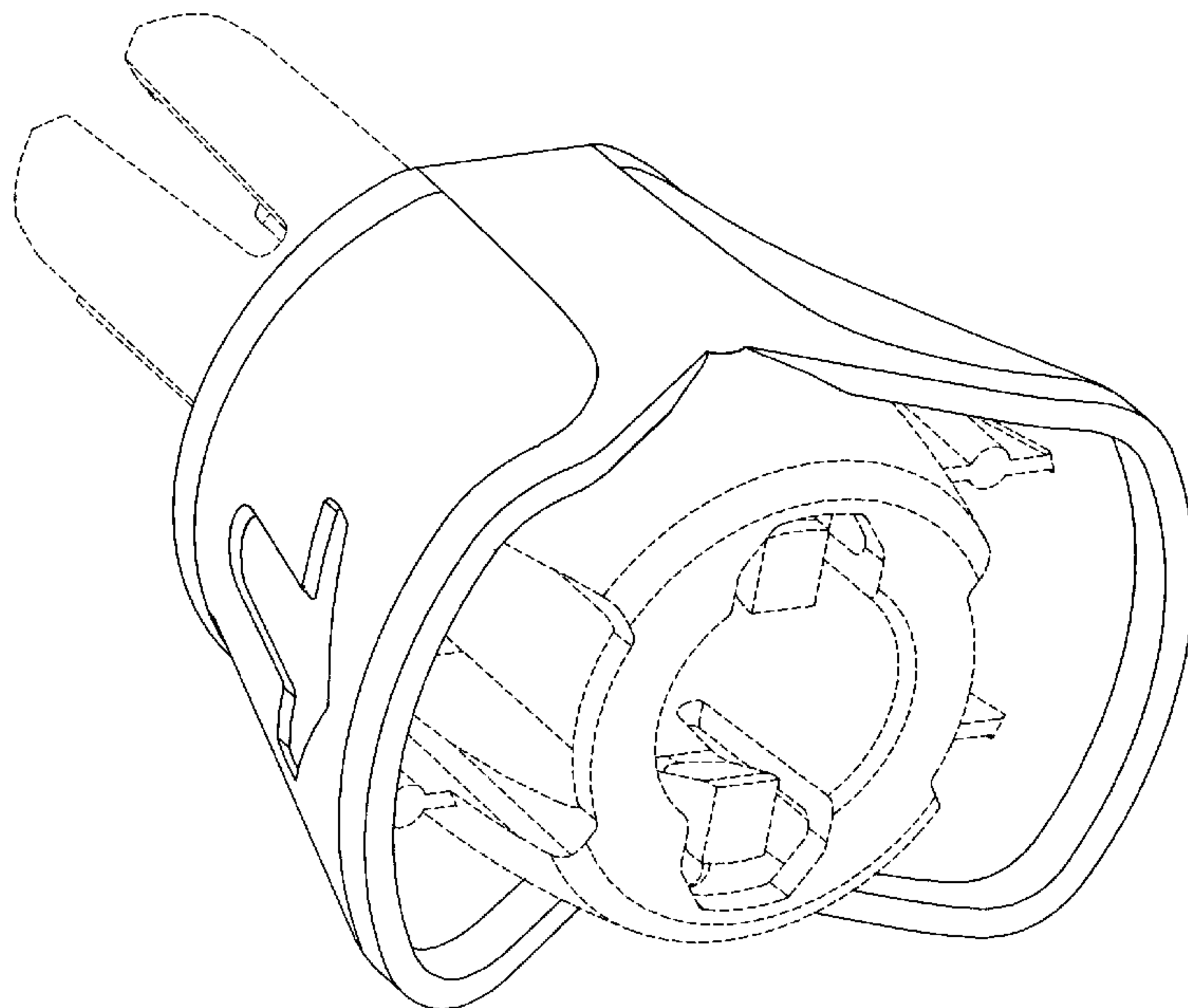
FIG. 3 is a front elevational view thereof, the rear elevational view being identical thereto;

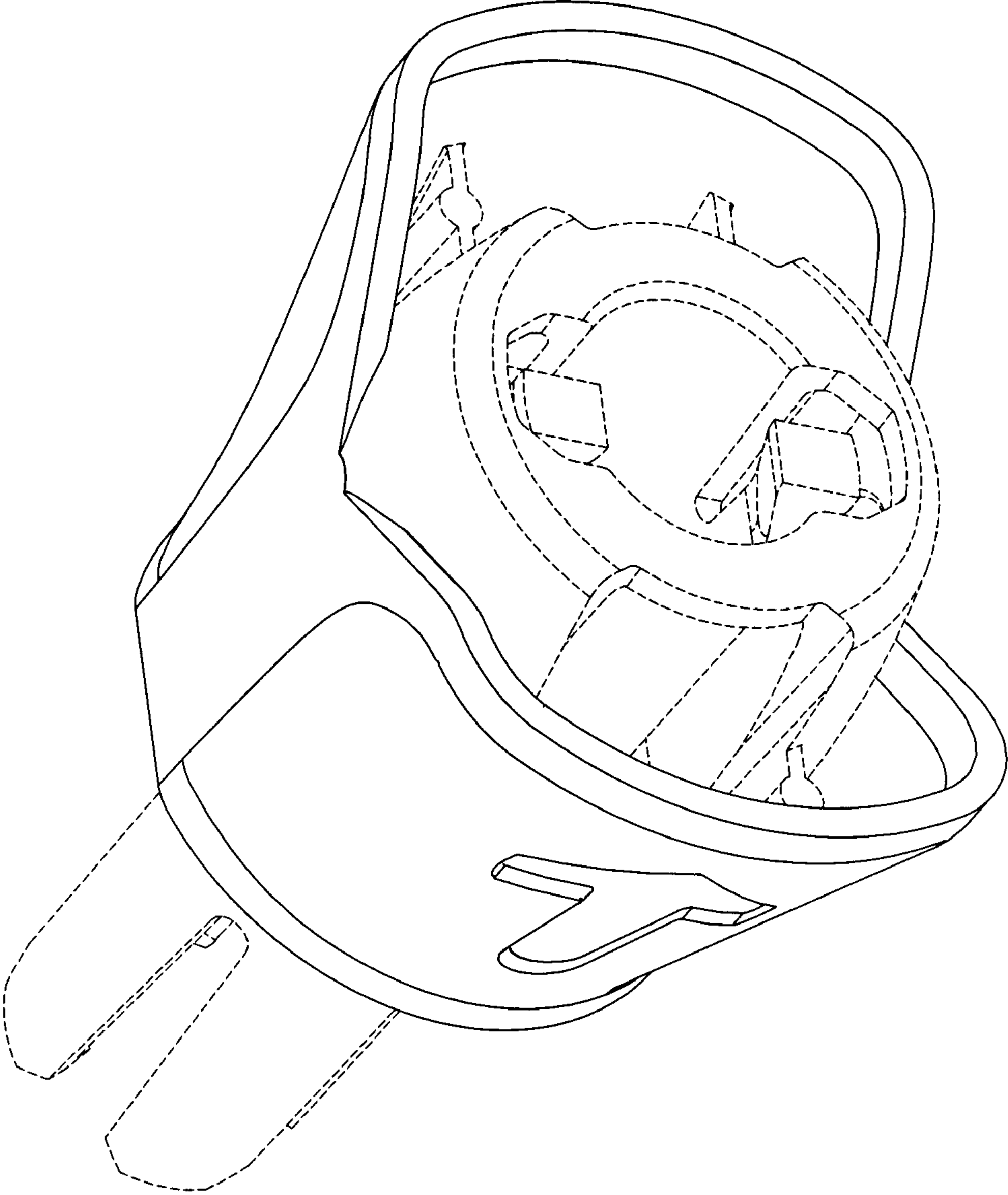

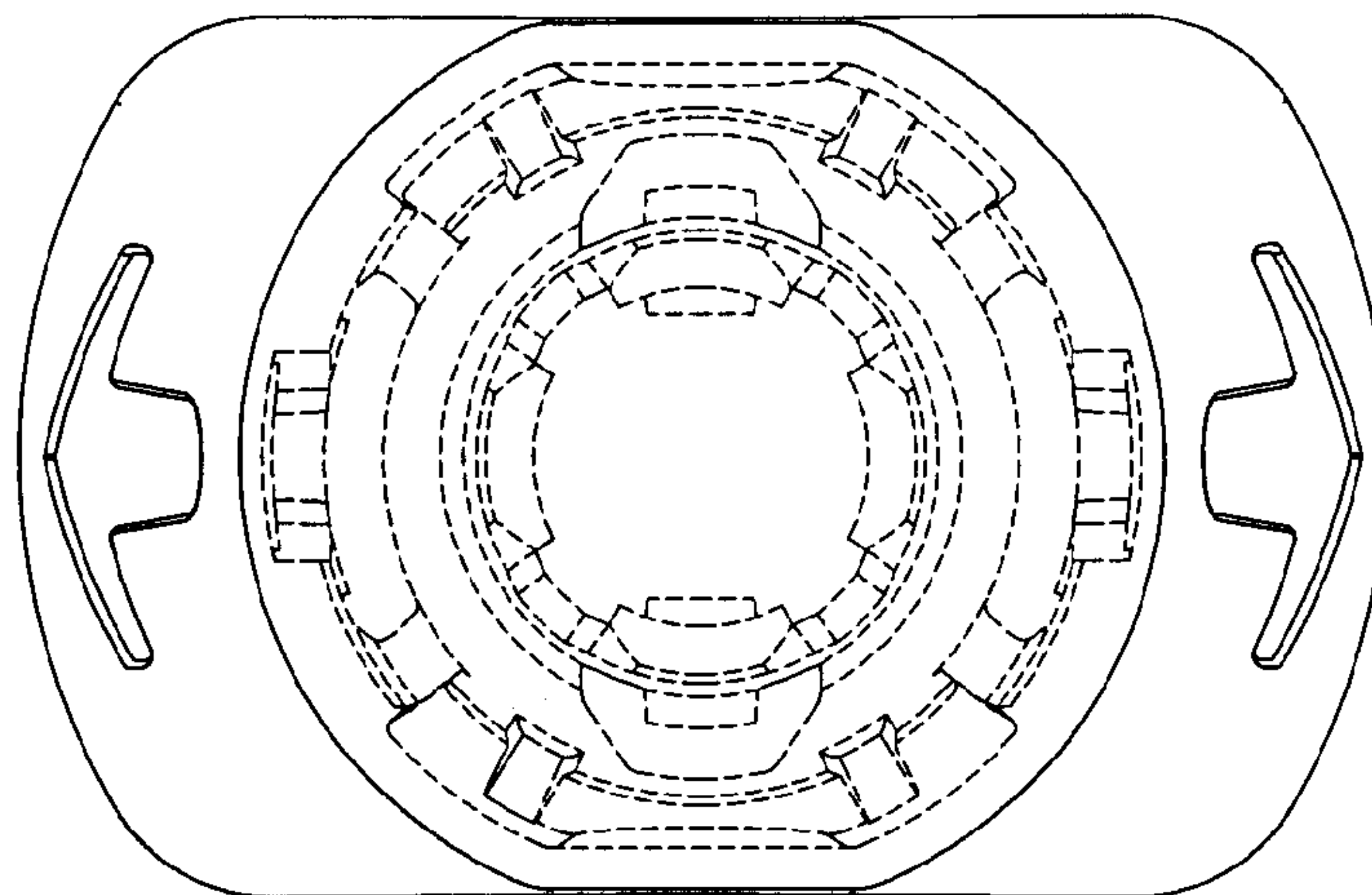

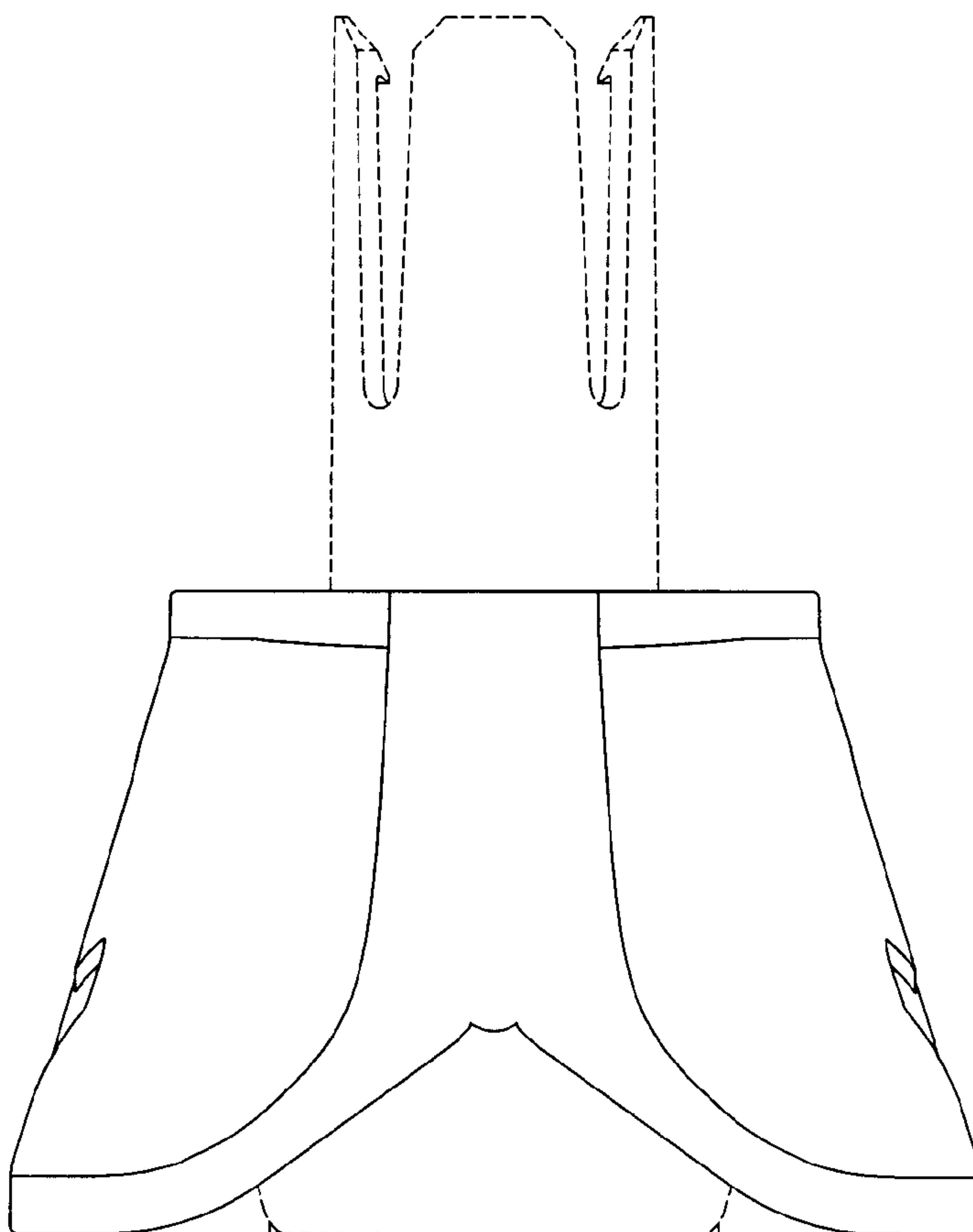

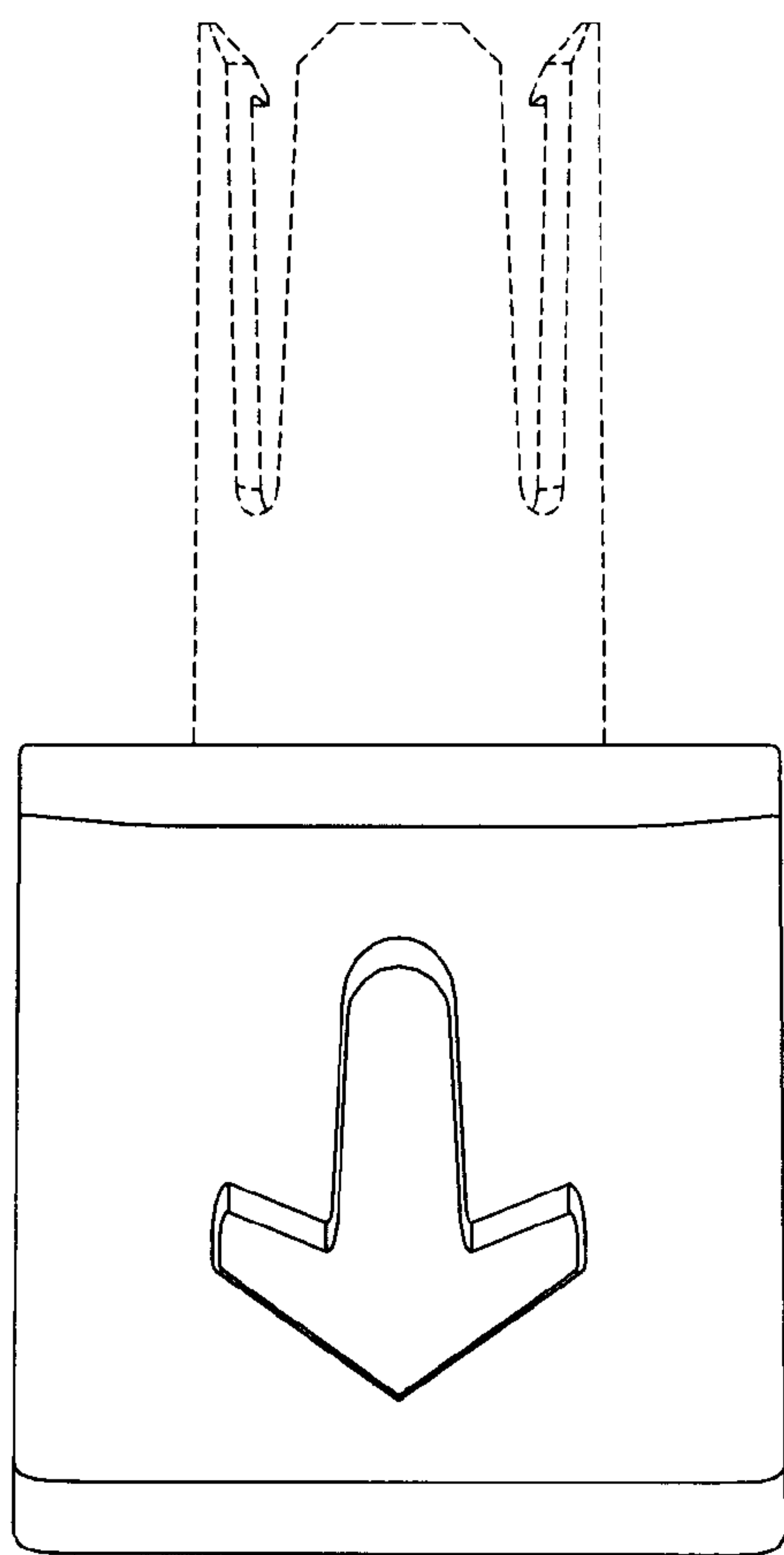

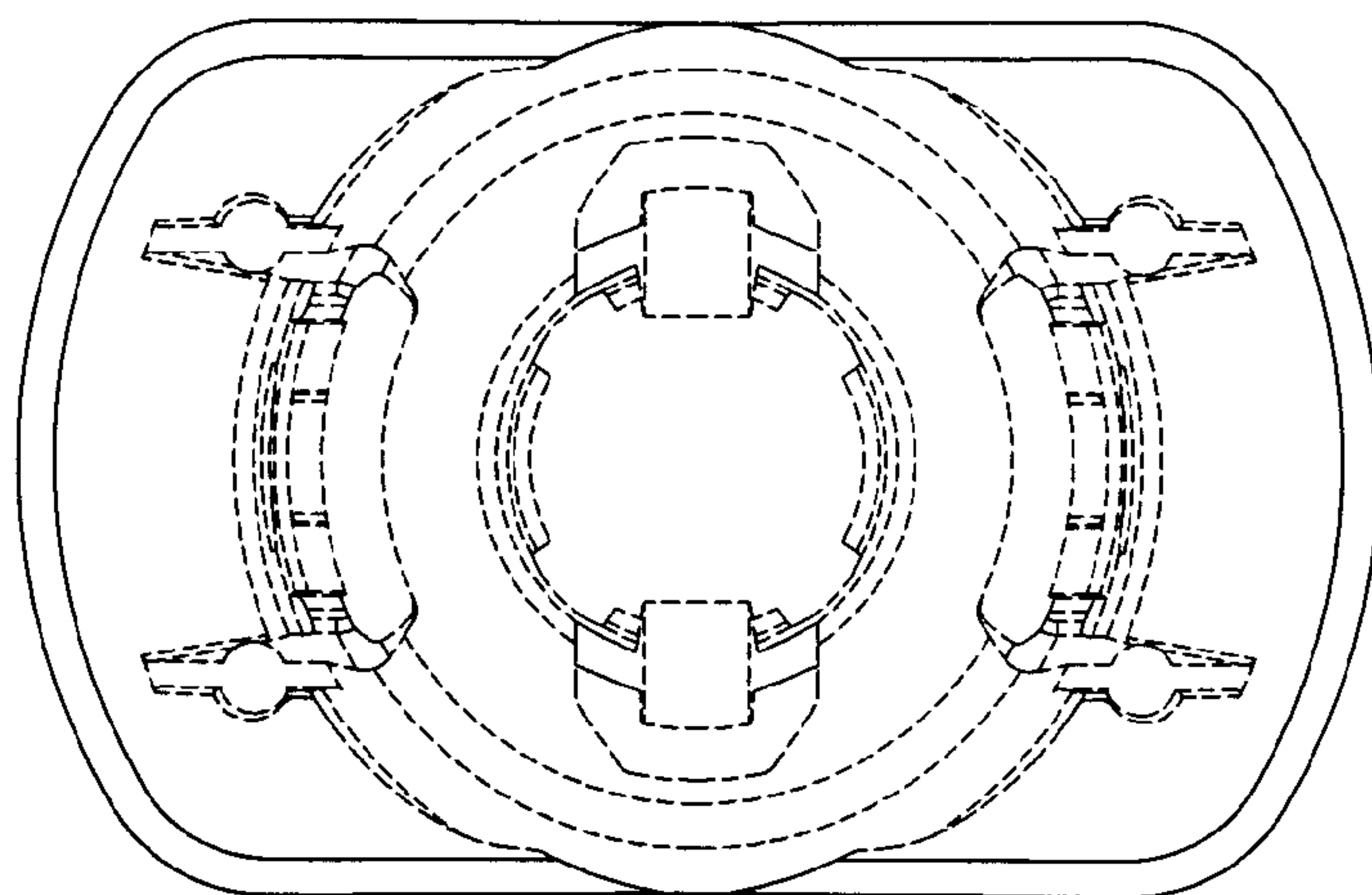
