FIG. 4 is a left side view of the roofing tile shown in FIG. 1.

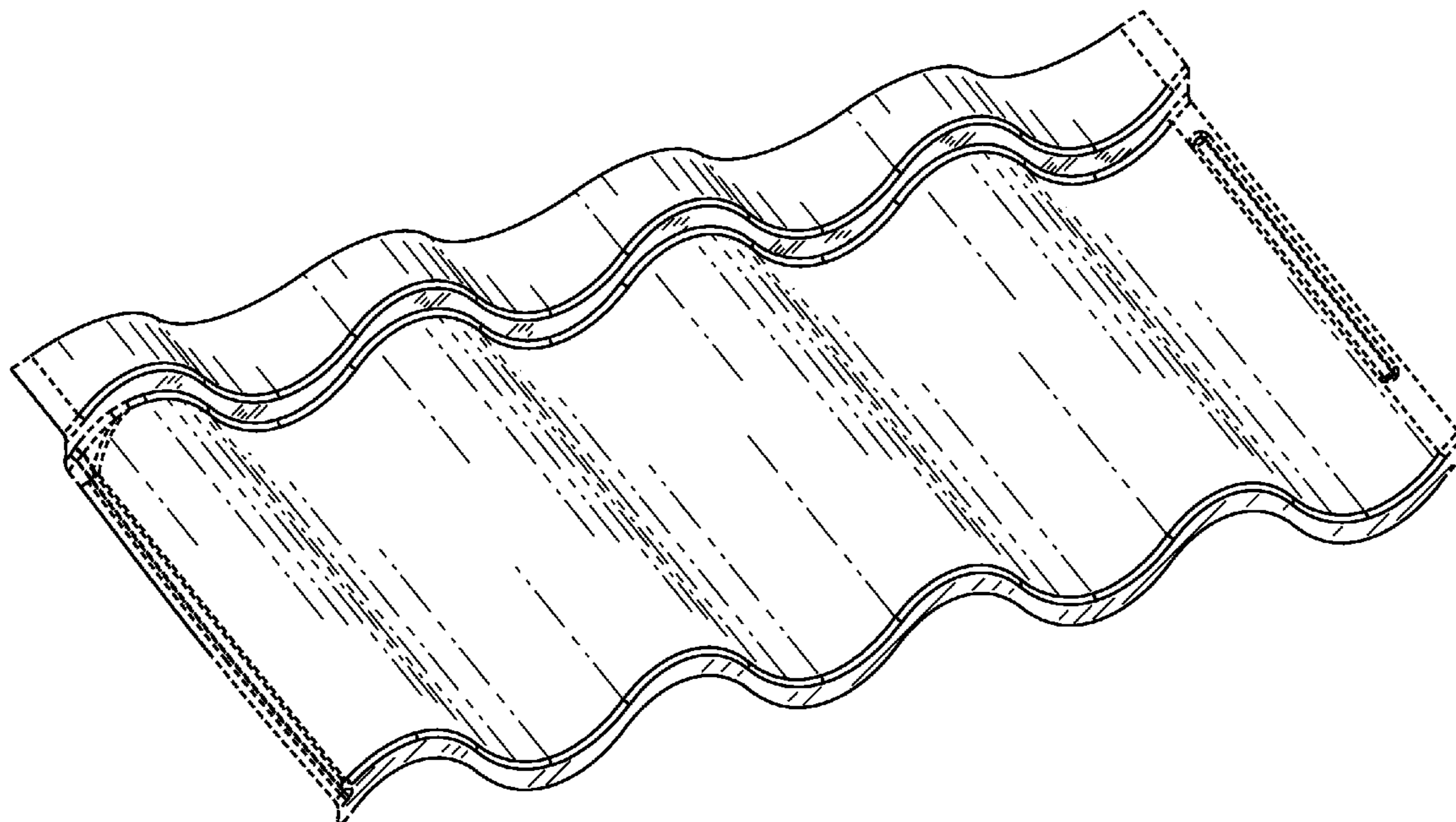
FIG. 5 is a bottom view of the roofing tile shown in FIG. 1.

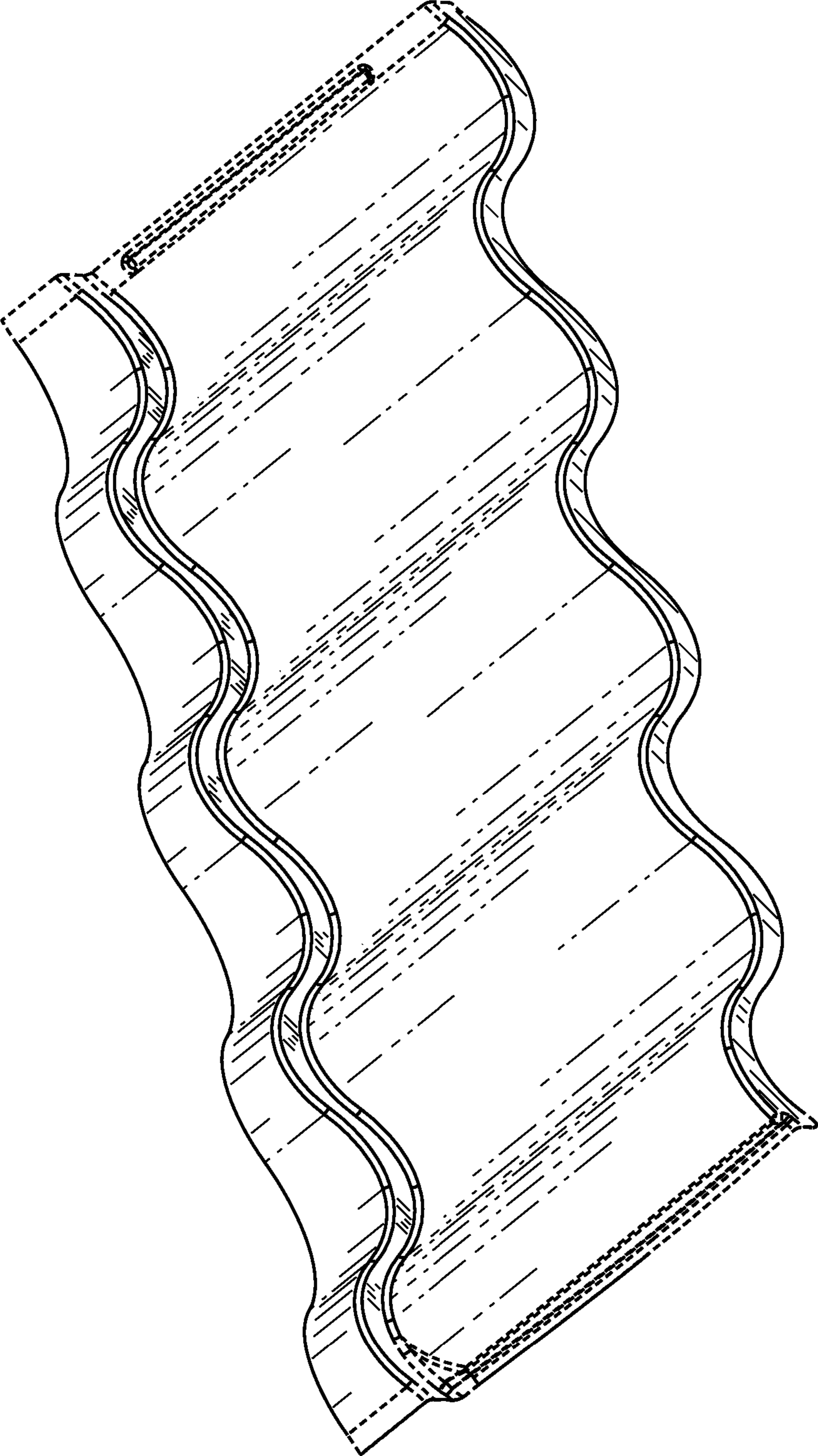
FIG. 6 is a rear view of the roofing tile shown in FIG. 1; and,

FIG. 7 is a front view of the roofing tile shown in FIG. 1.

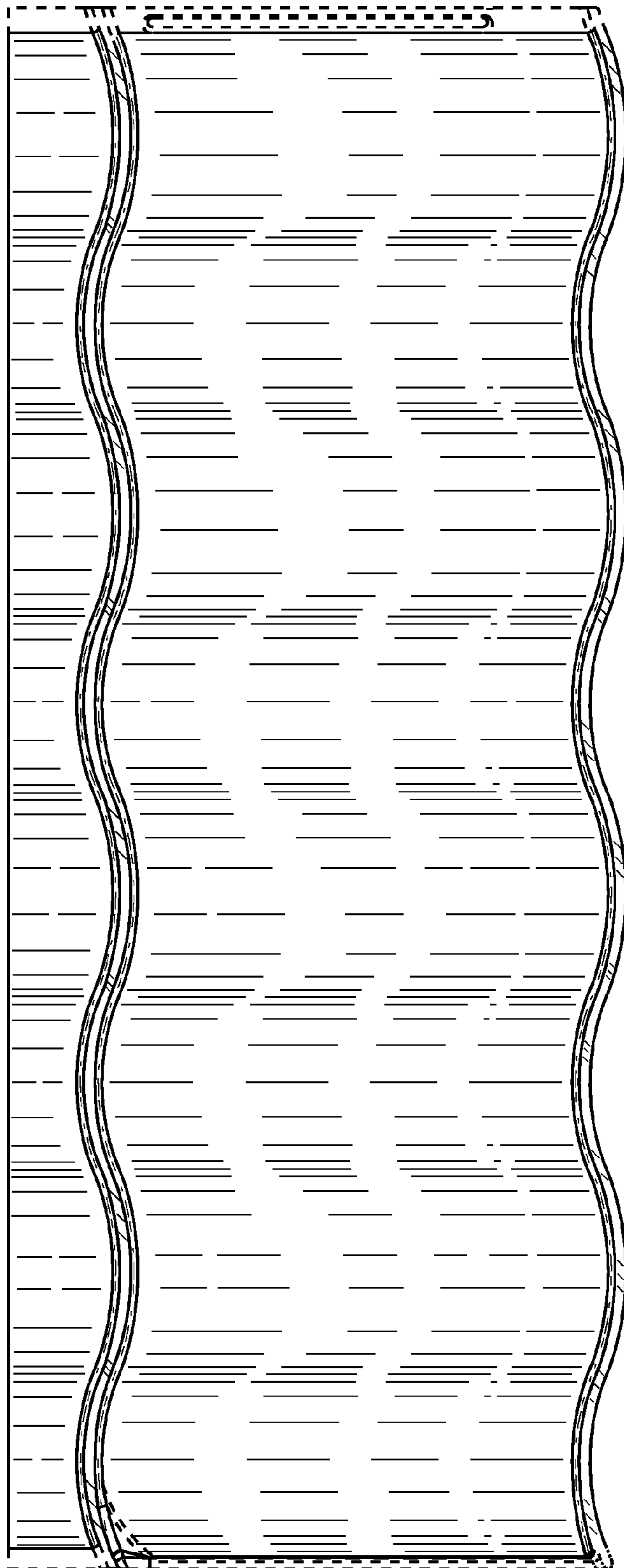

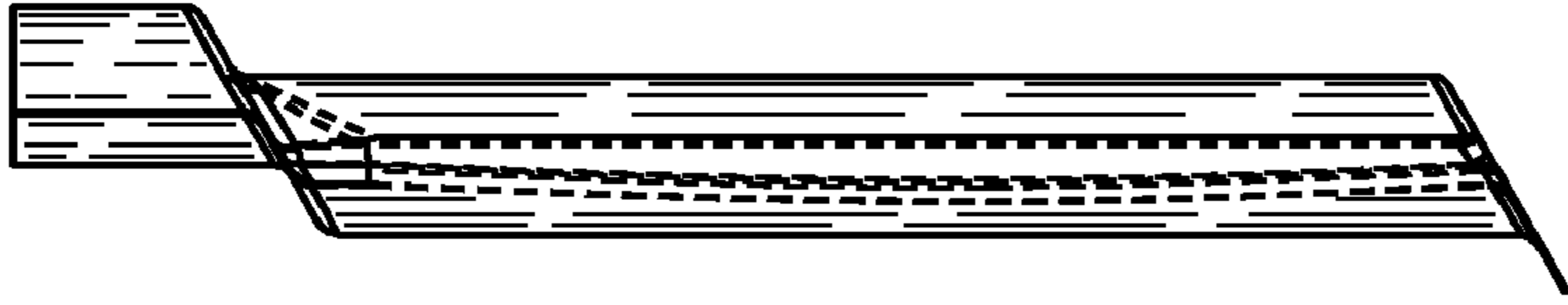

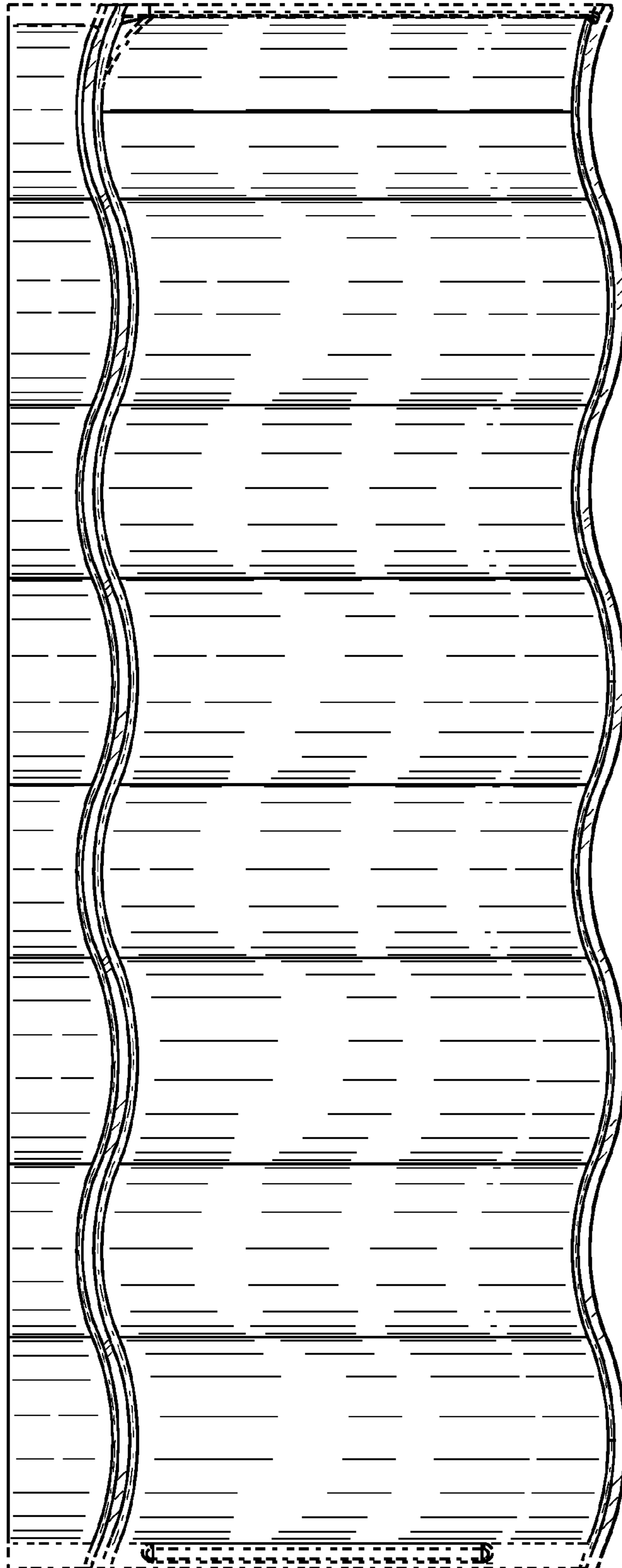

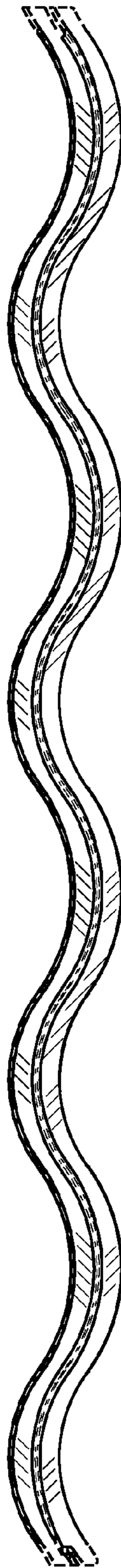
