(57) **CLAIM**

I claim an ornamental design for a heel portion of foot wear, as shown and described.

DESCRIPTION

FIG. 1 is a left side perspective view of a heel portion of foot wear showing the claimed design in association with the remainder of the foot wear shown in broken lines;

FIG. 2 is a right side perspective view thereof in association with the remainder of the foot wear shown in broken lines;

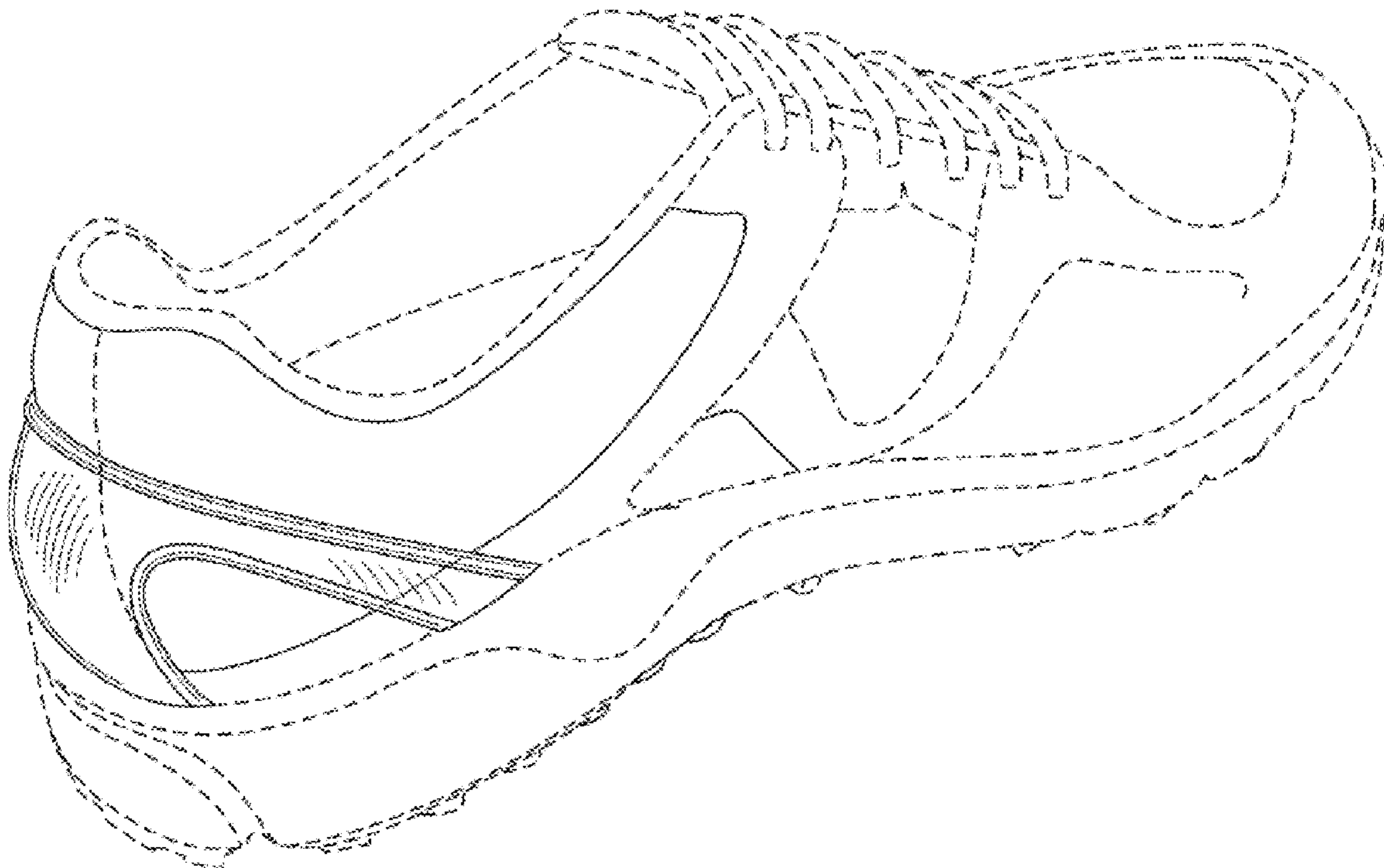
FIG. 3 is a rear view of a heel portion thereof in association with the remainder of the foot wear shown in broken lines;

FIG. 4 is a right side view of a heel portion of foot wear showing the claimed design in association with the remainder of the foot wear shown in broken lines;

FIG. 6 is a left side perspective view thereof in association with the remainder of the foot wear shown in broken lines.

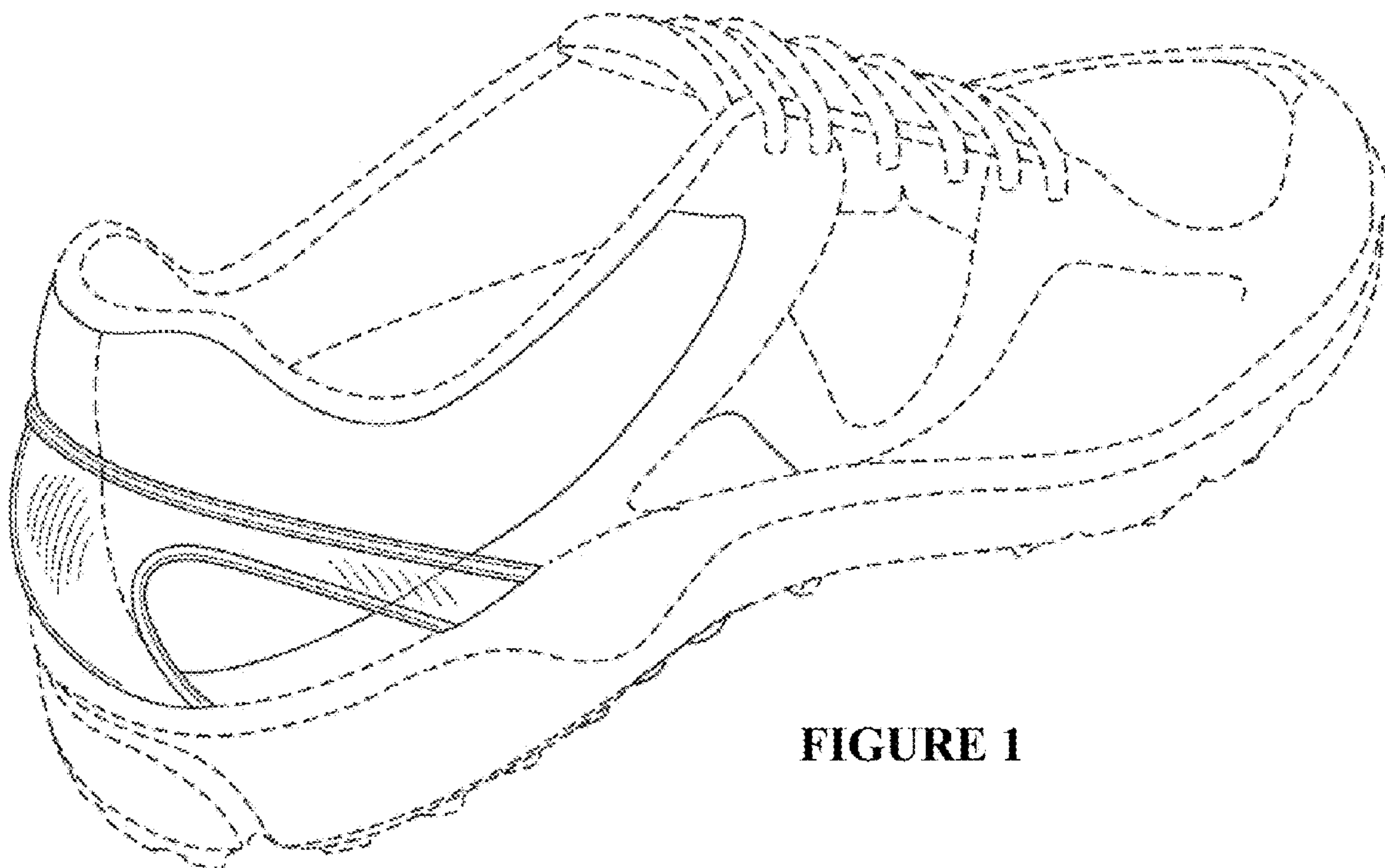

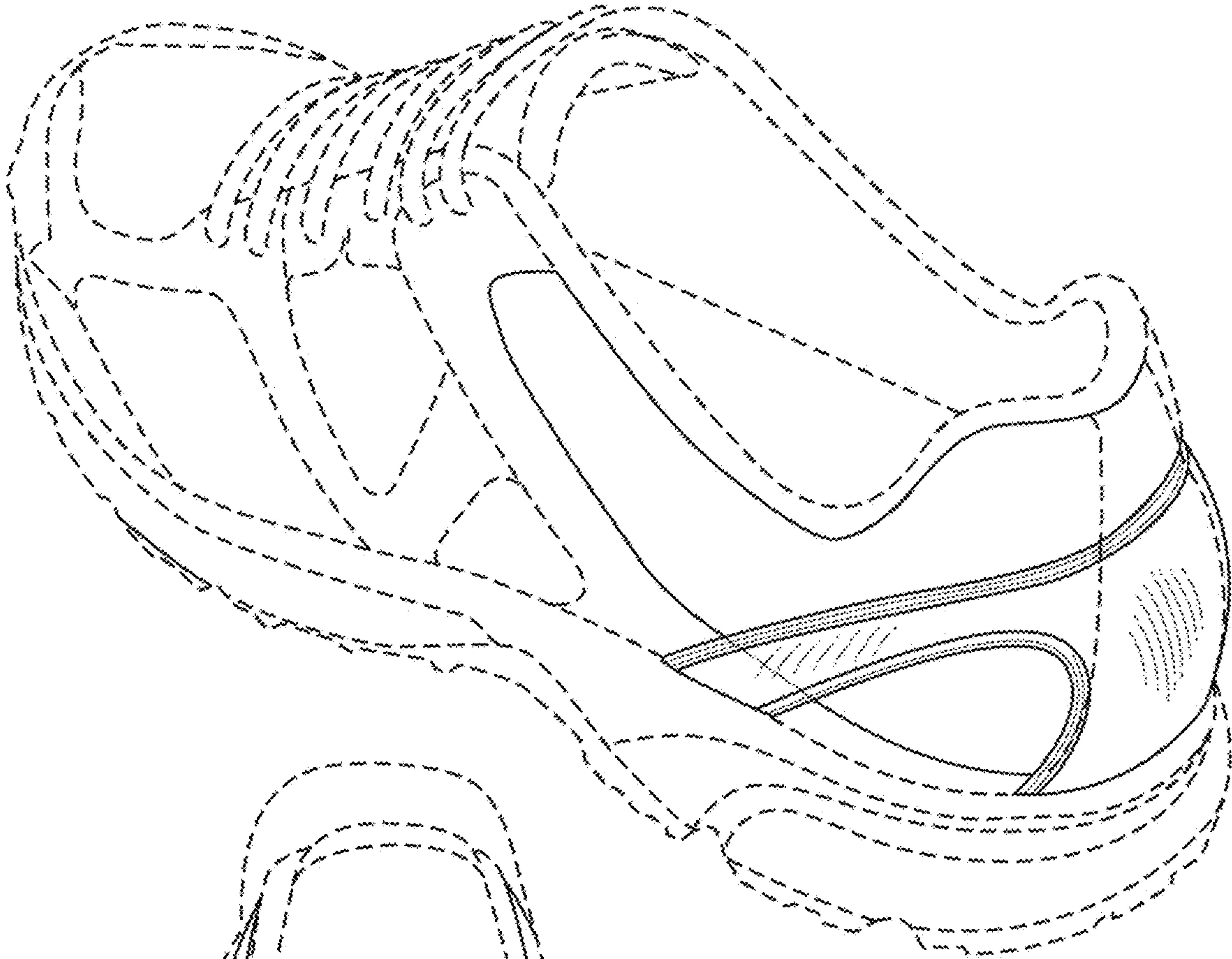

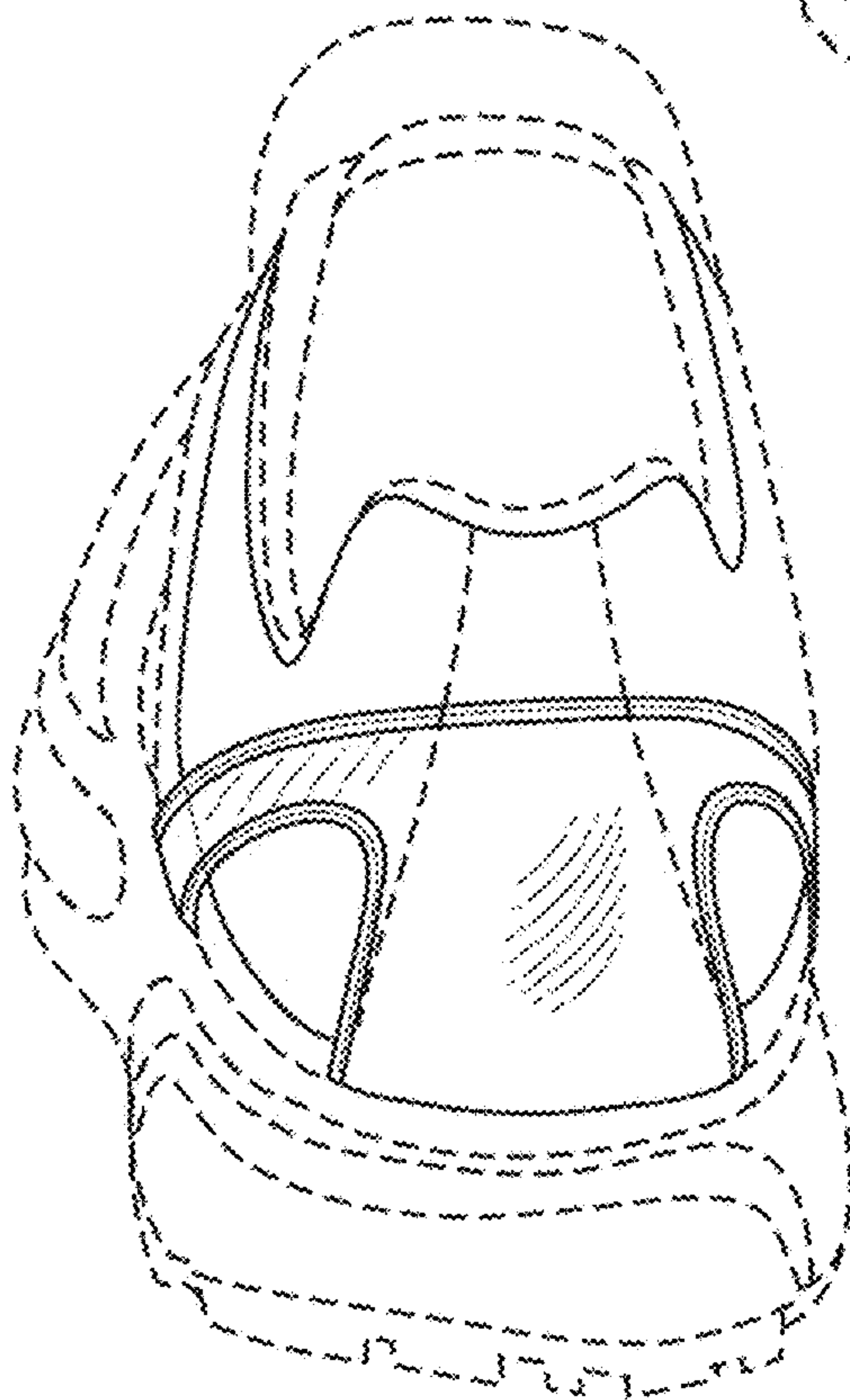

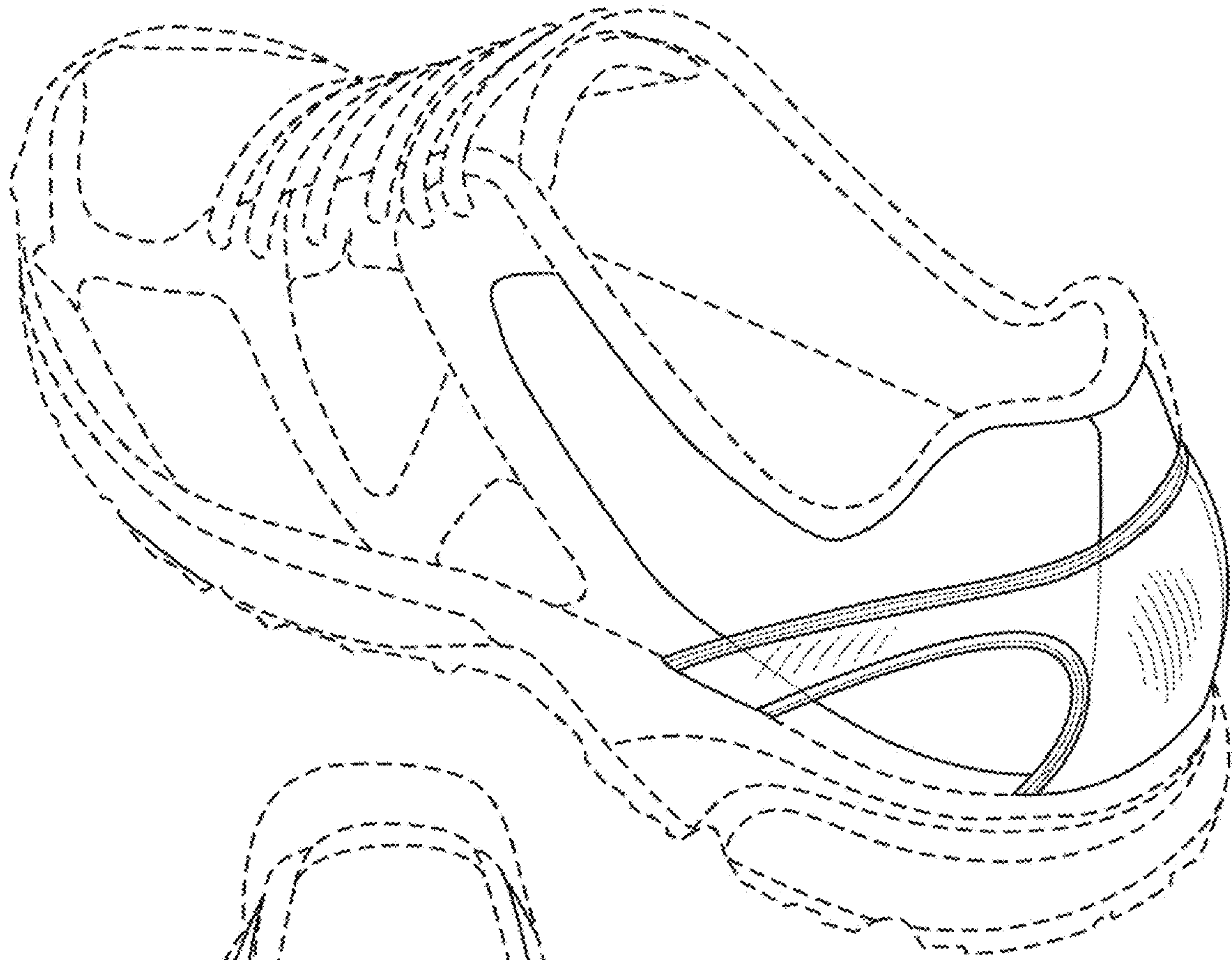

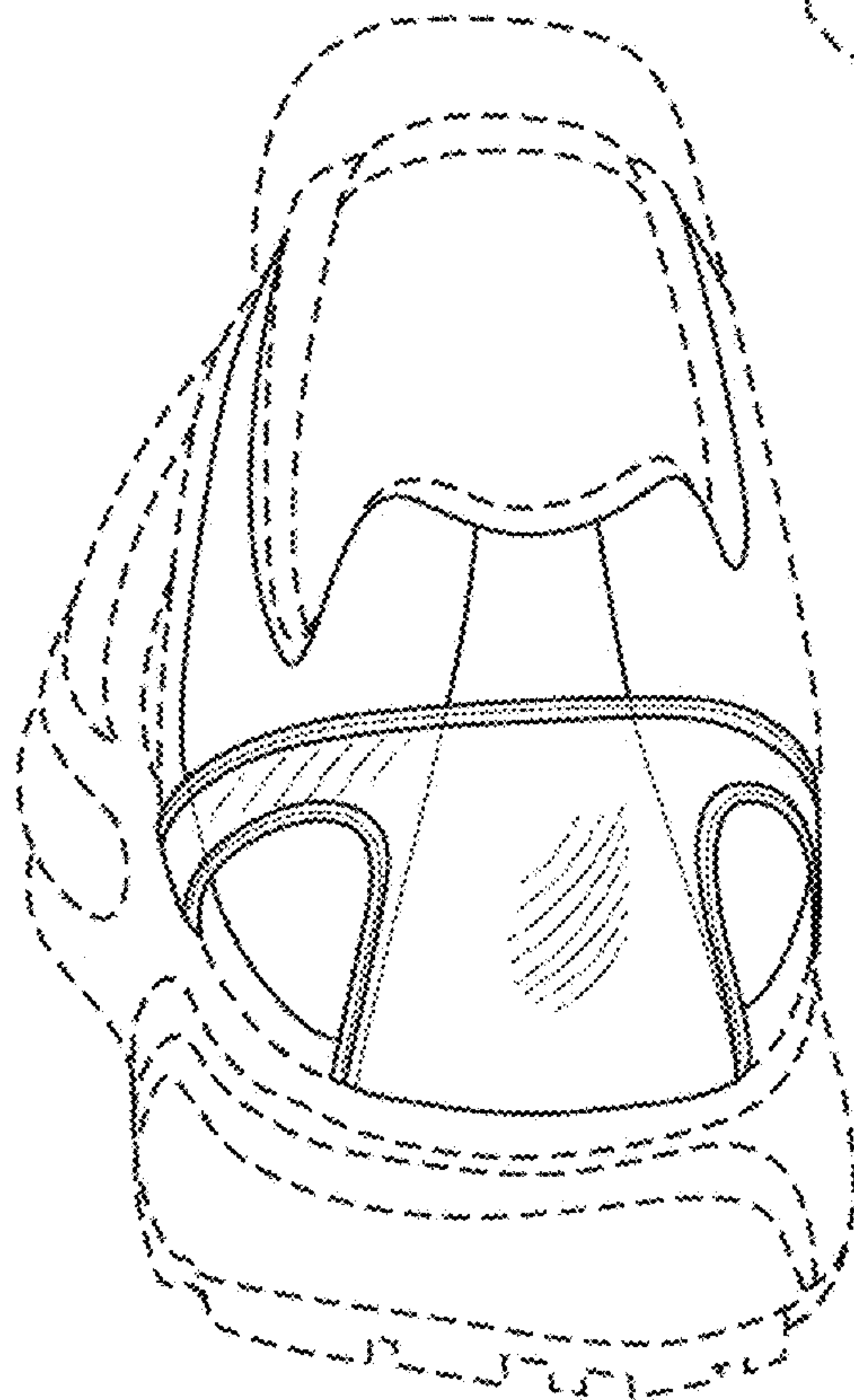

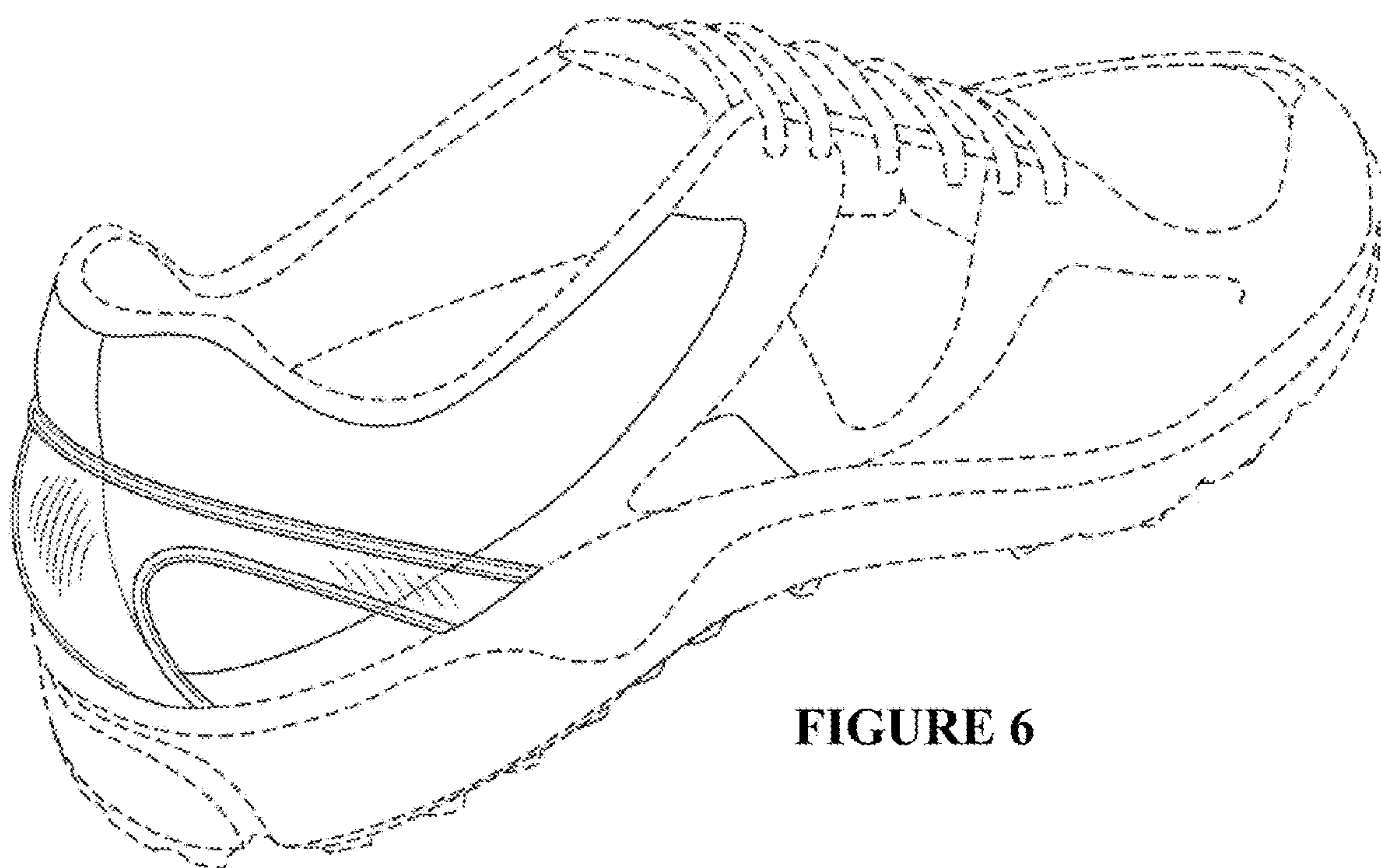
