(57) **CLAIM**

The ornamental design for a textile fabric with pattern, as shown and described.

**DESCRIPTION**

The sole FIGURE is a textile fabric with pattern.

The textile fabric with pattern is used in the manufacture of bags. The broken line boundary surrounding the design forms no part of the claimed design and depicts a repeat unit of the claim; it is understood that the design may repeat uniformly in one or more directions.
