(57) **CLAIM**

The ornamental design for a cookware lid handle with arching lower grip, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view from above of the “cookware lid handle with arching lower grip”, showing my new design;

FIG. 2 is a top plan view thereof;

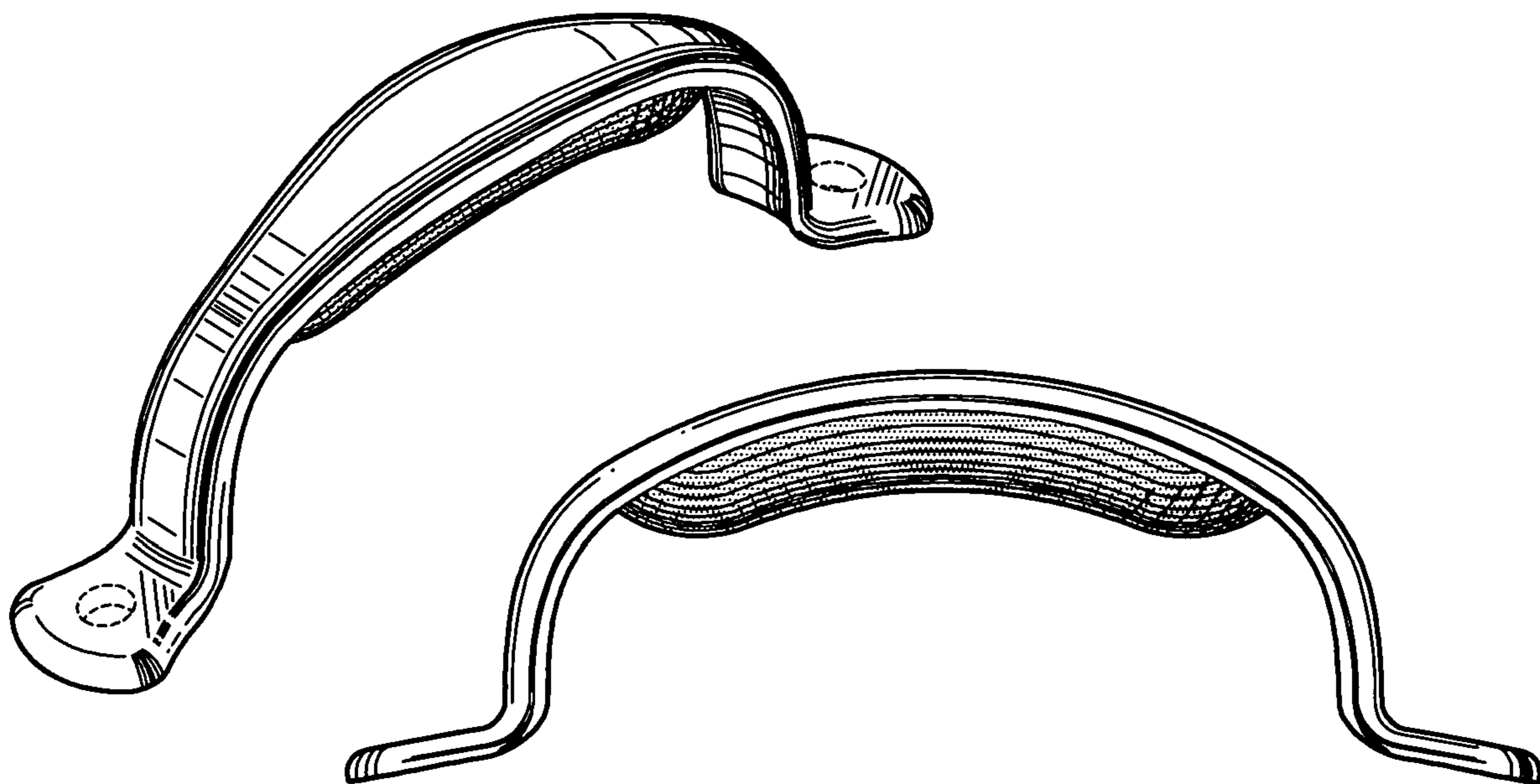
FIG. 3 is a side elevation view thereof;

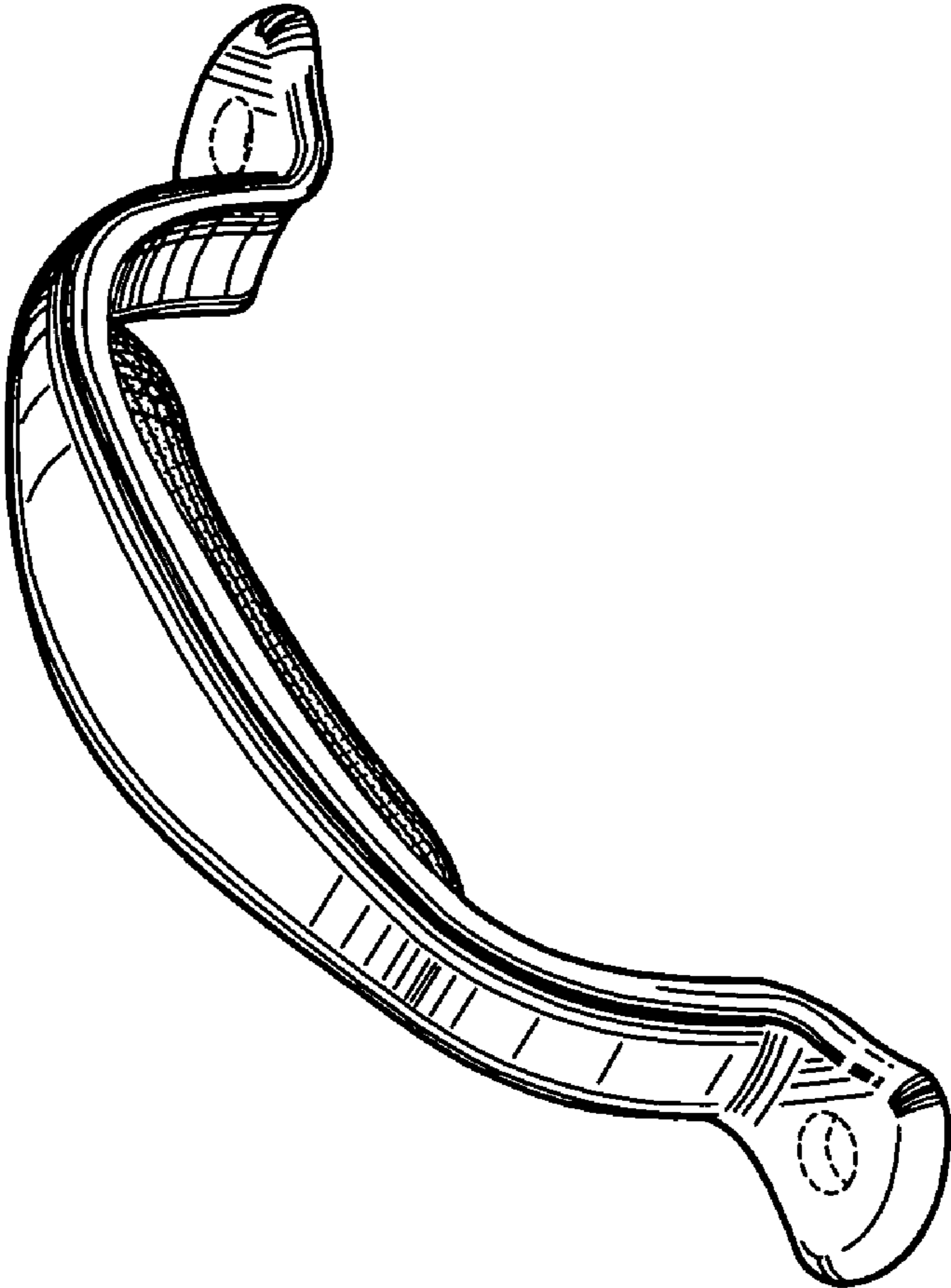

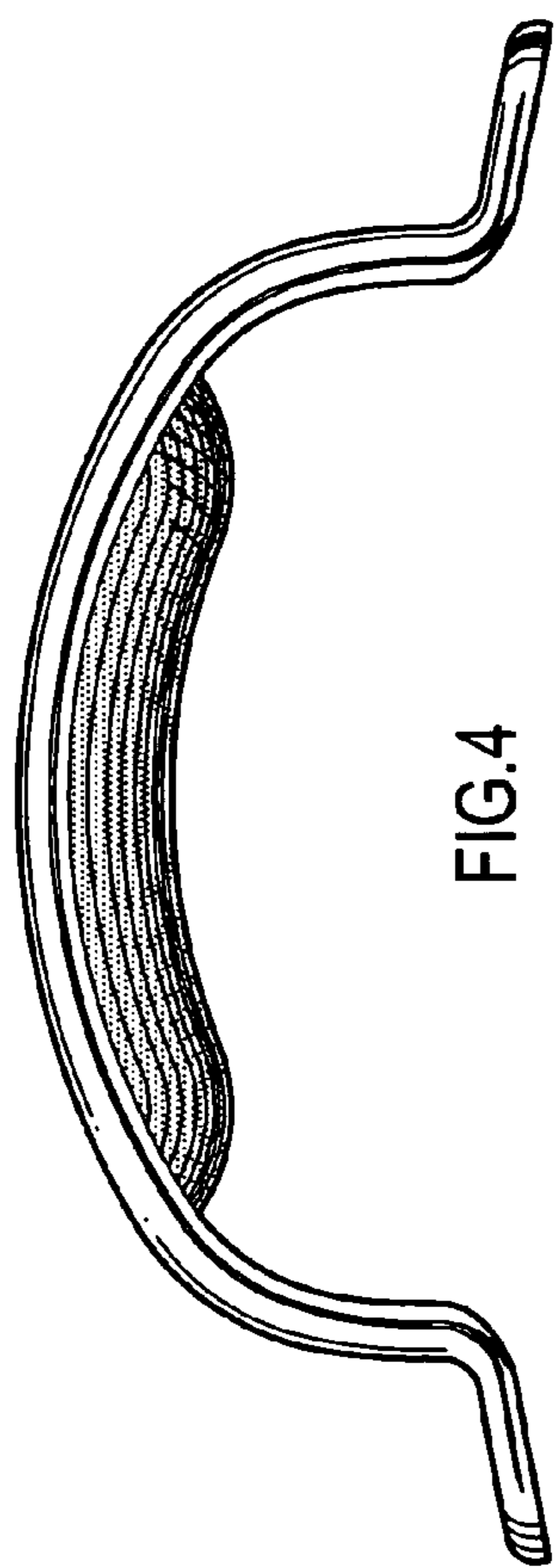

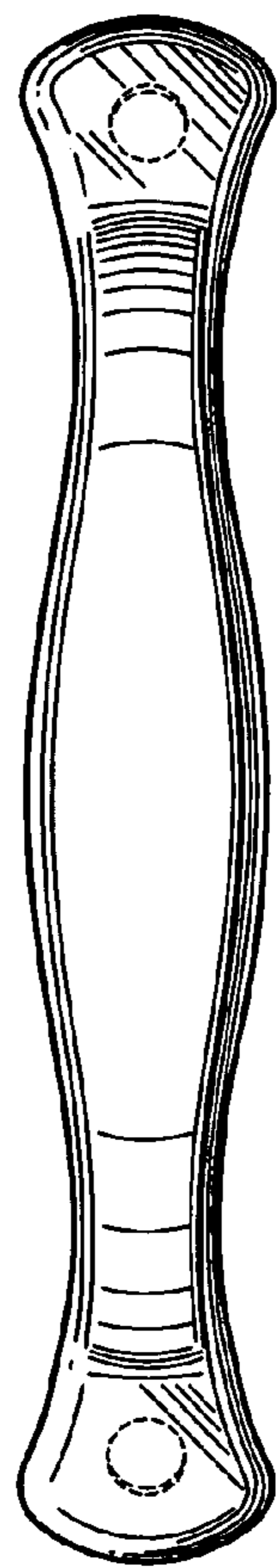

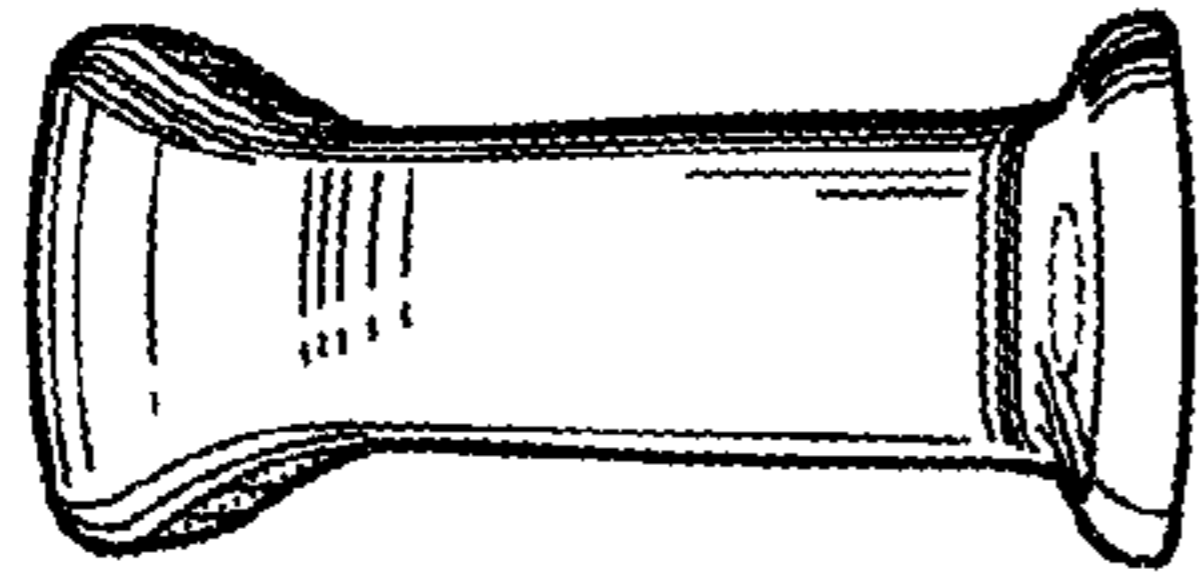

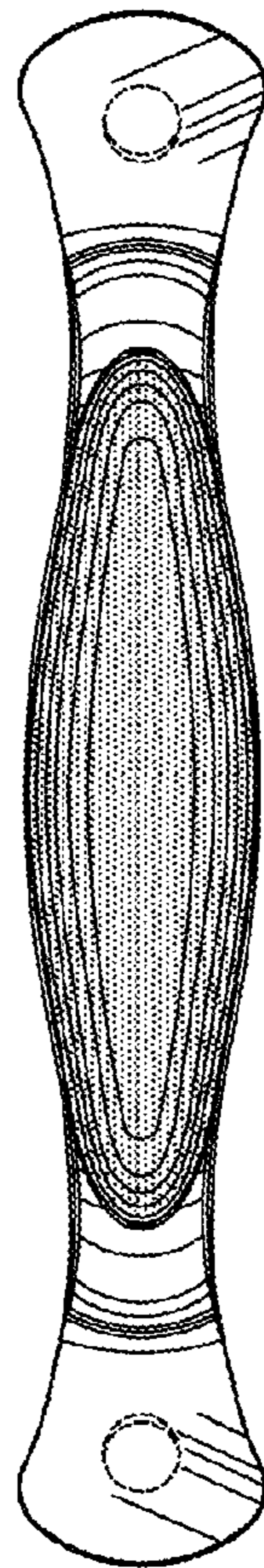
