1.

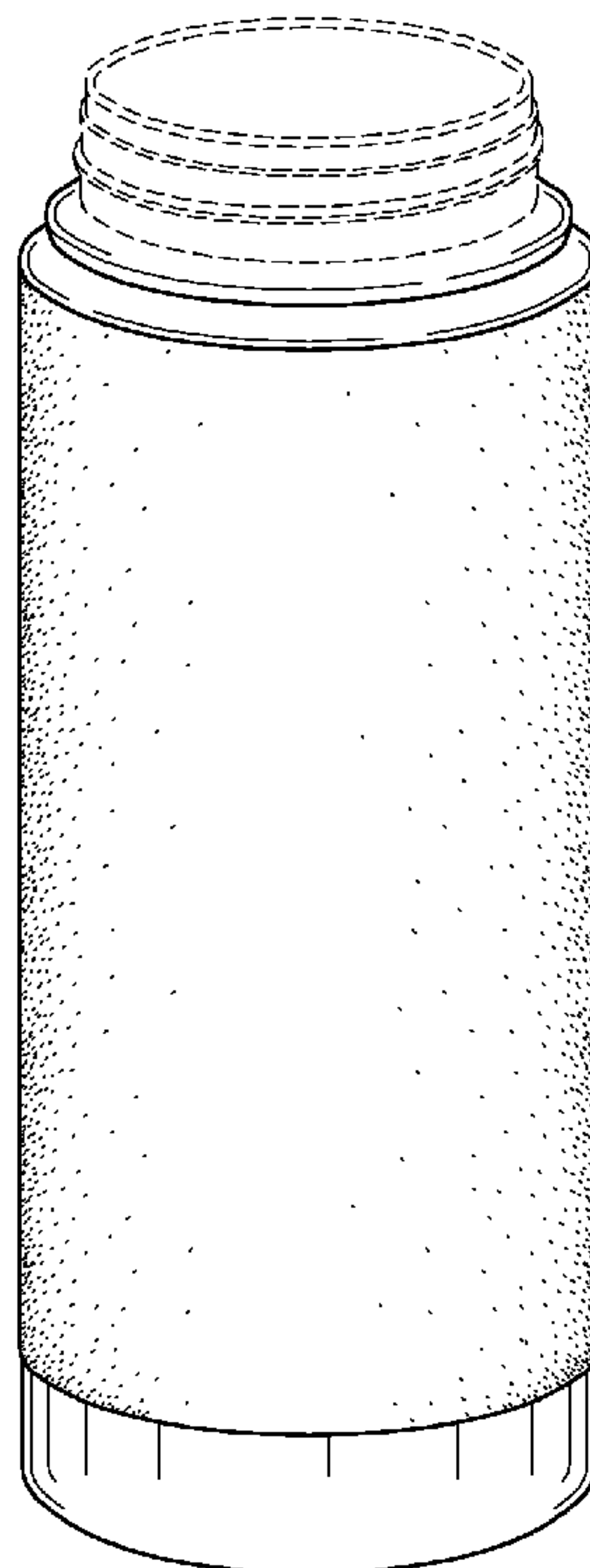
FIG. 5 is a right elevation view of the reusable bottle of FIG.

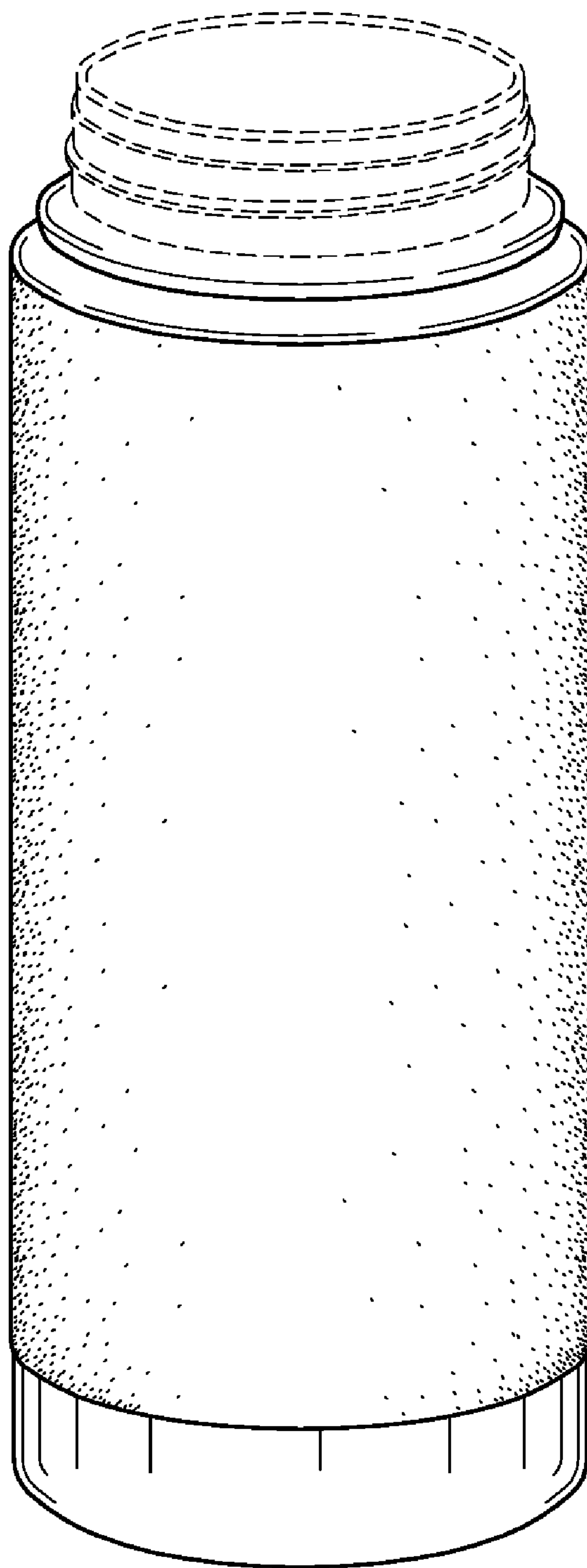

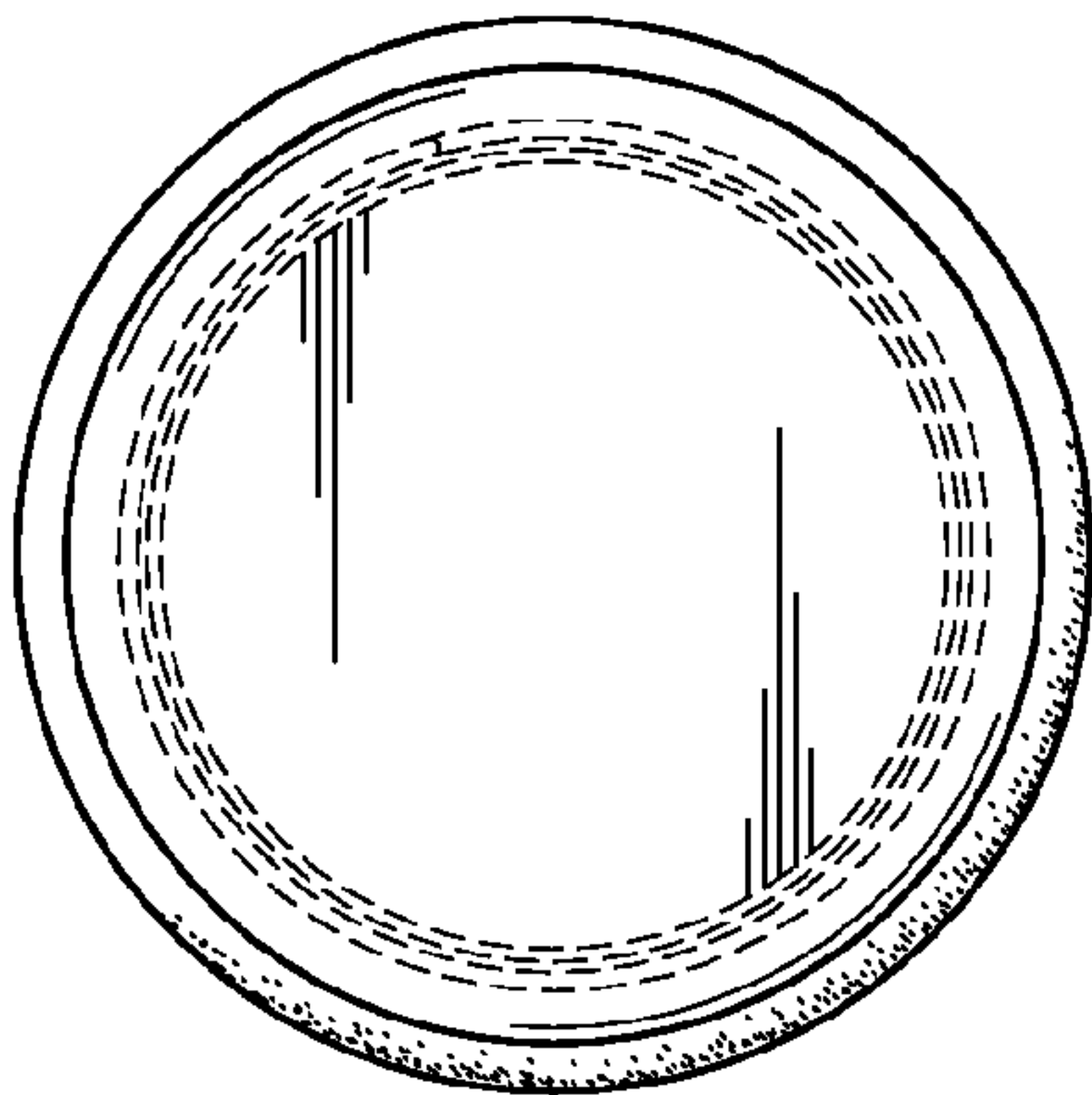

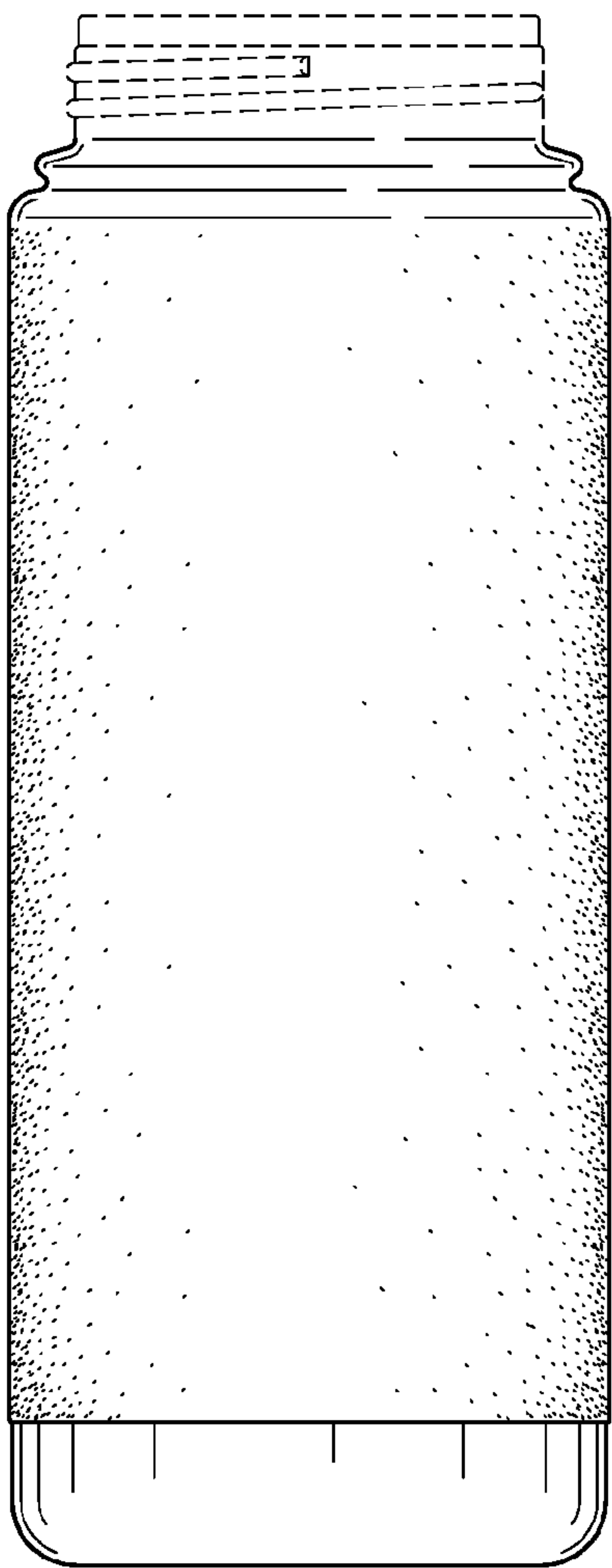

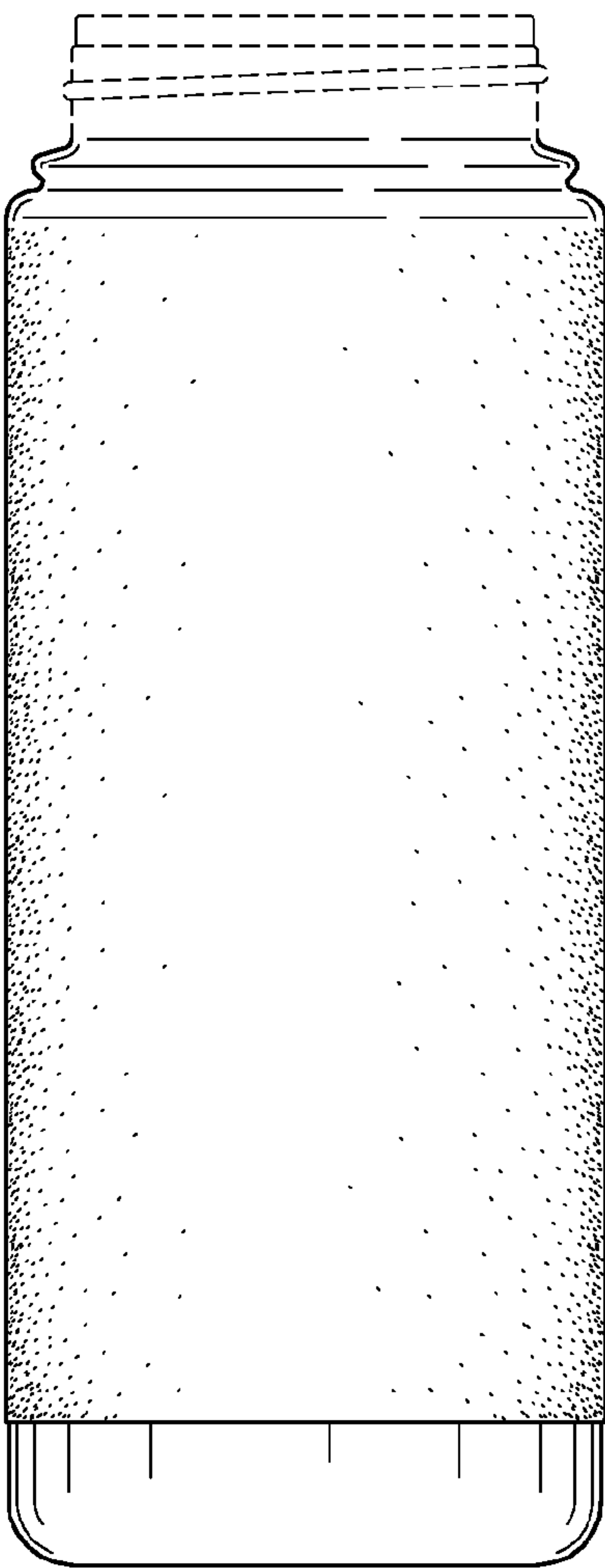

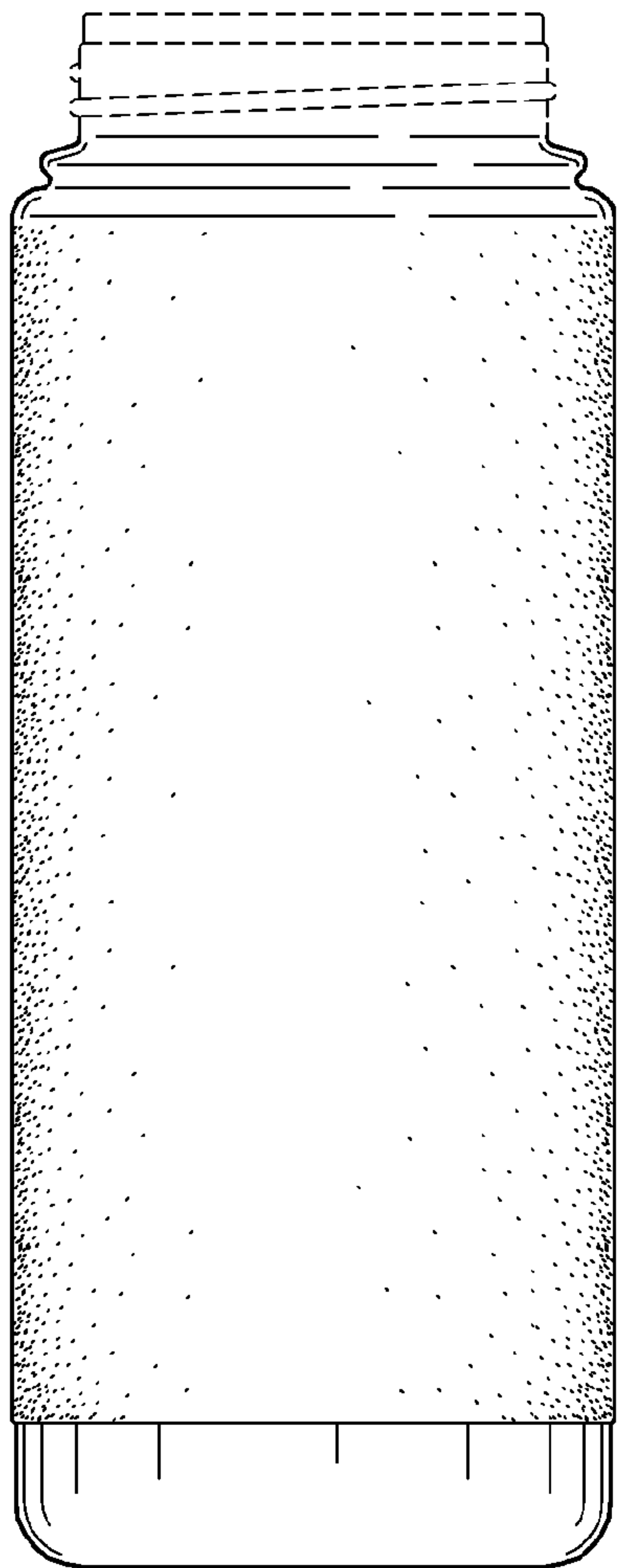

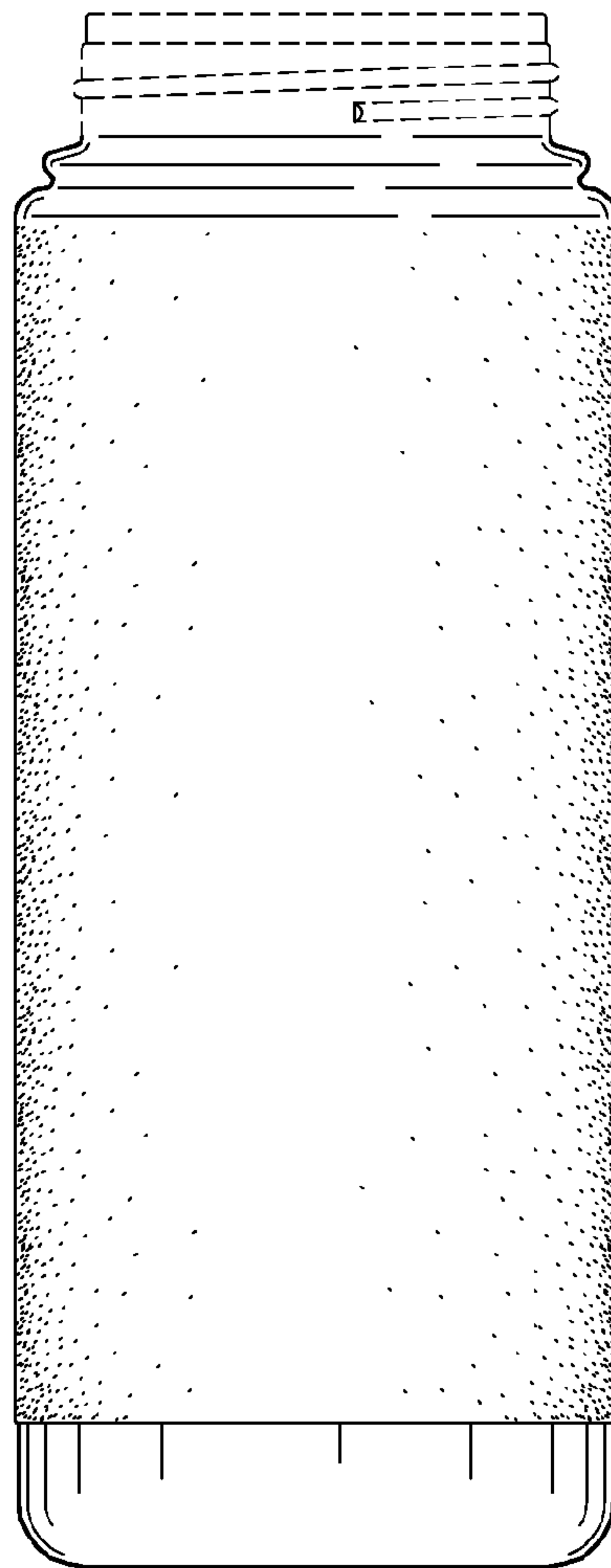

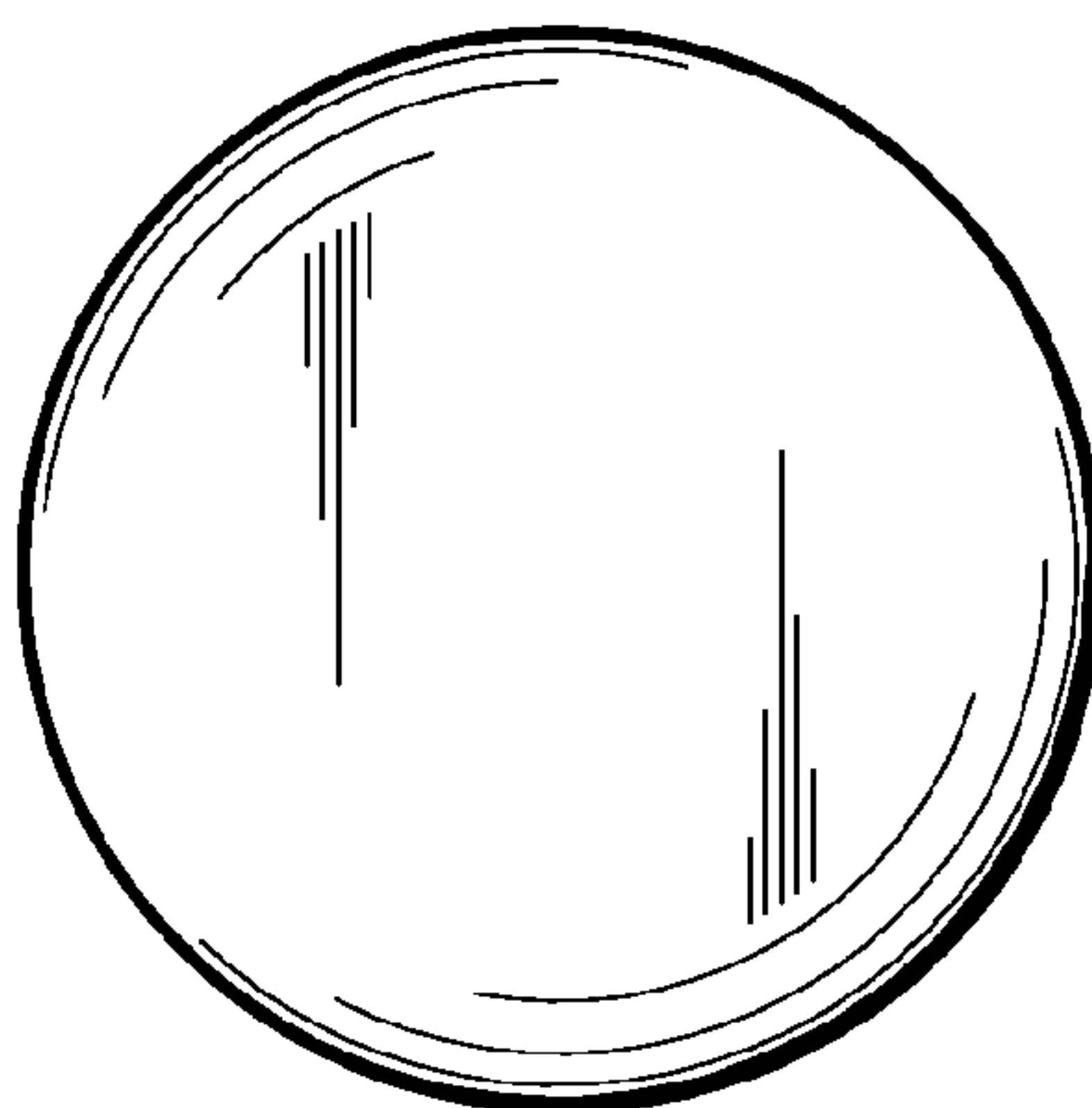
