DESCRIPTION

FIG. 1 is a front perspective view of a bottle showing our new design;

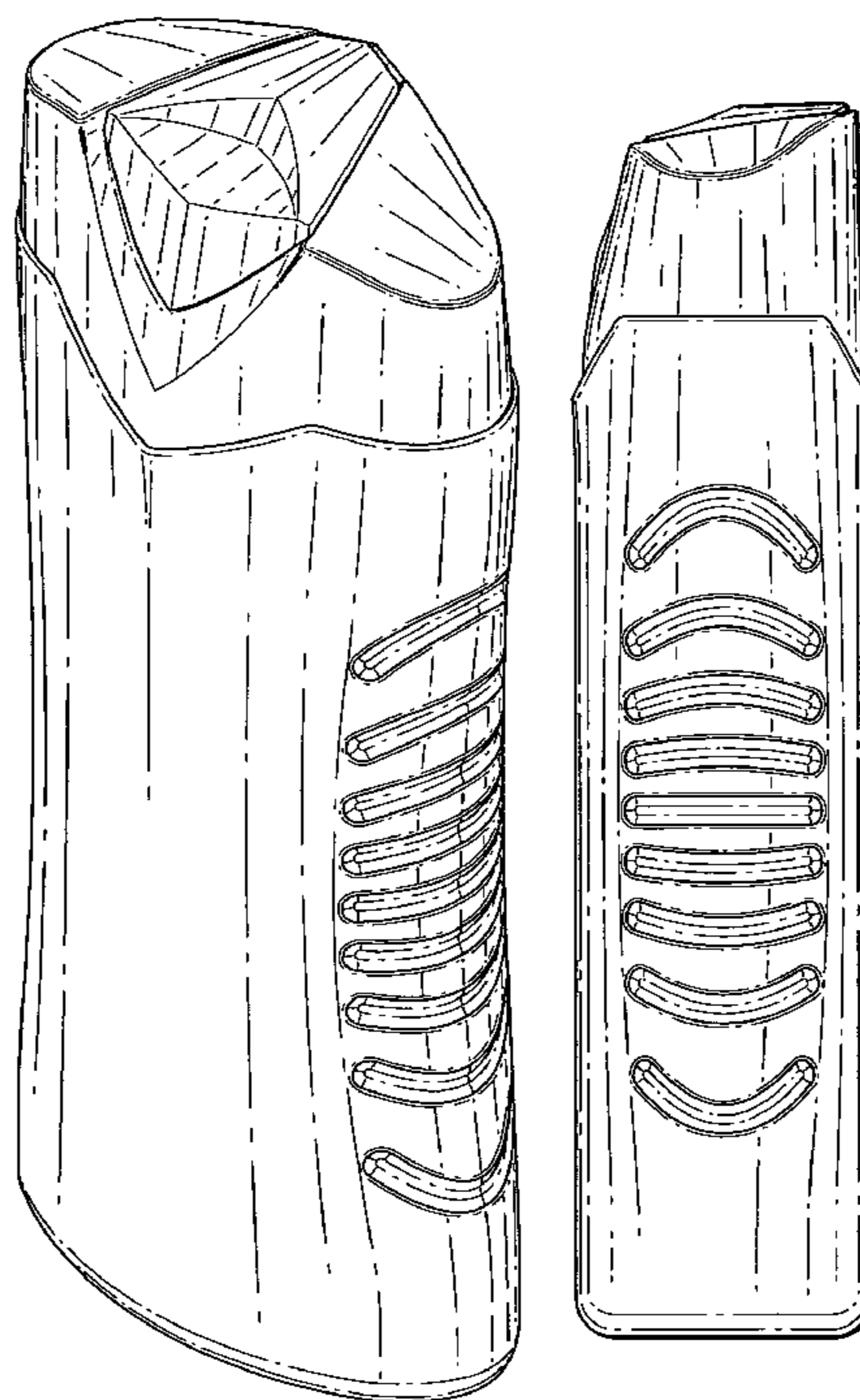

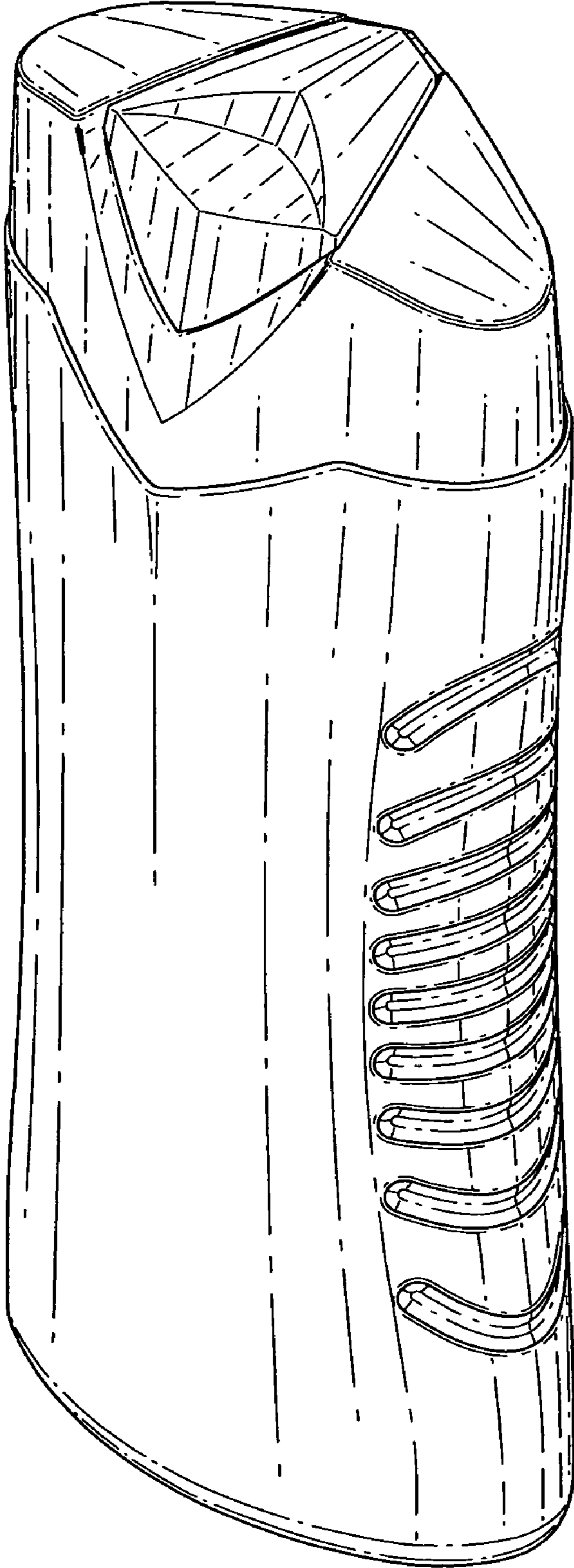

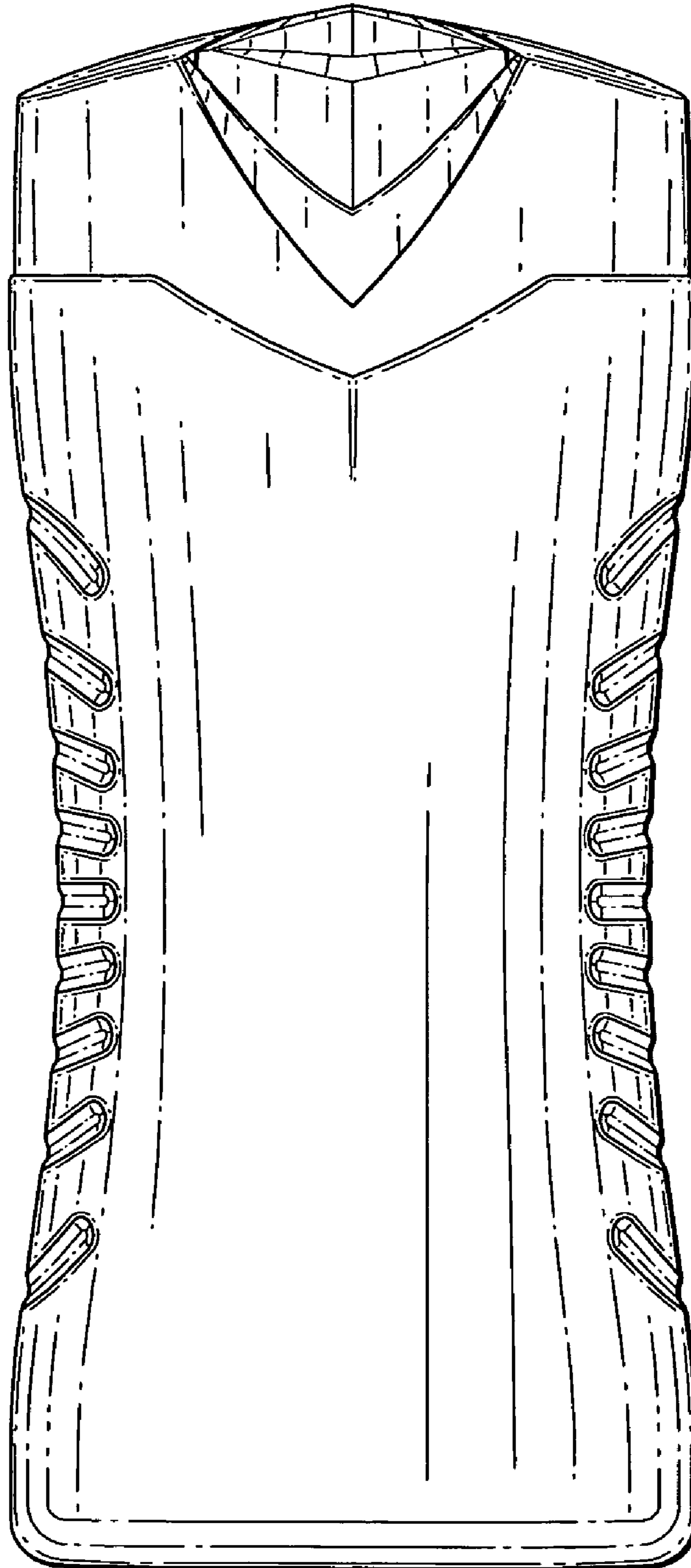

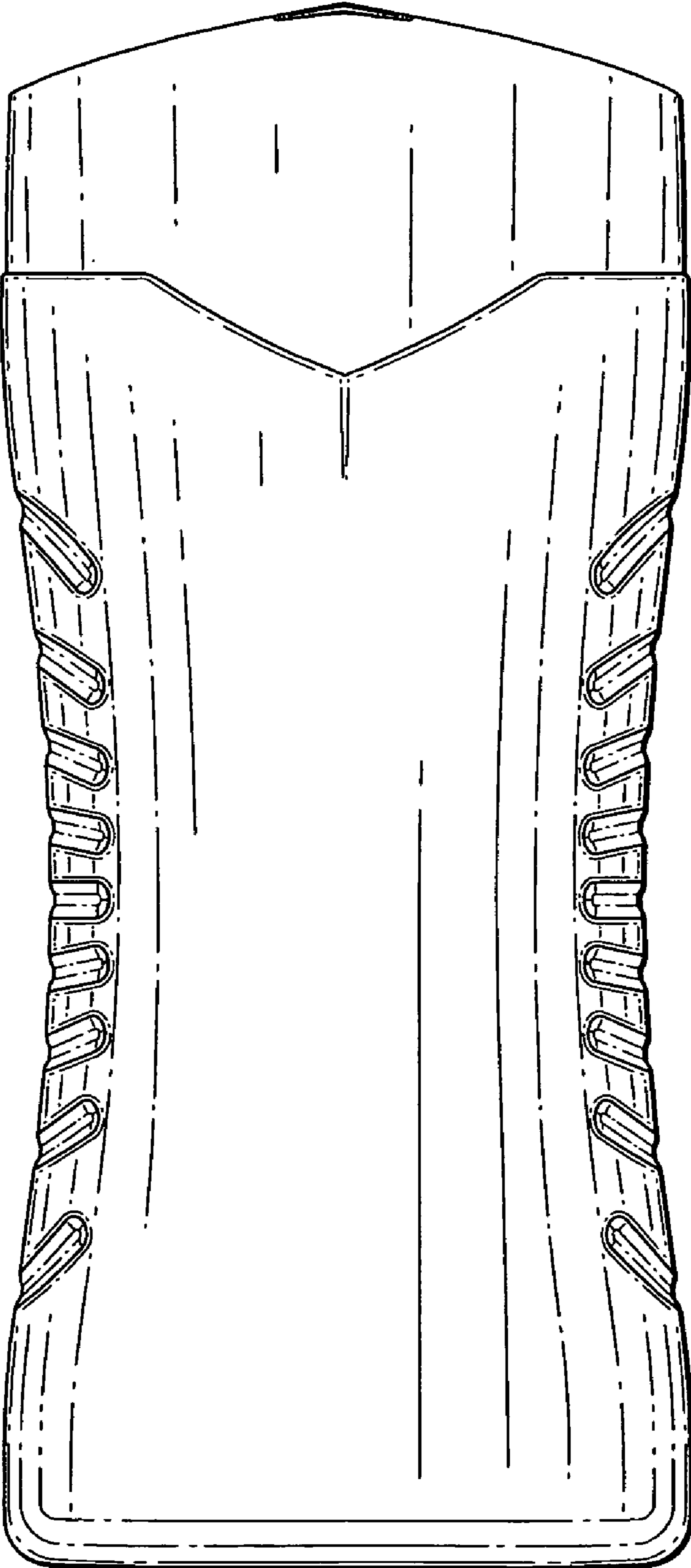

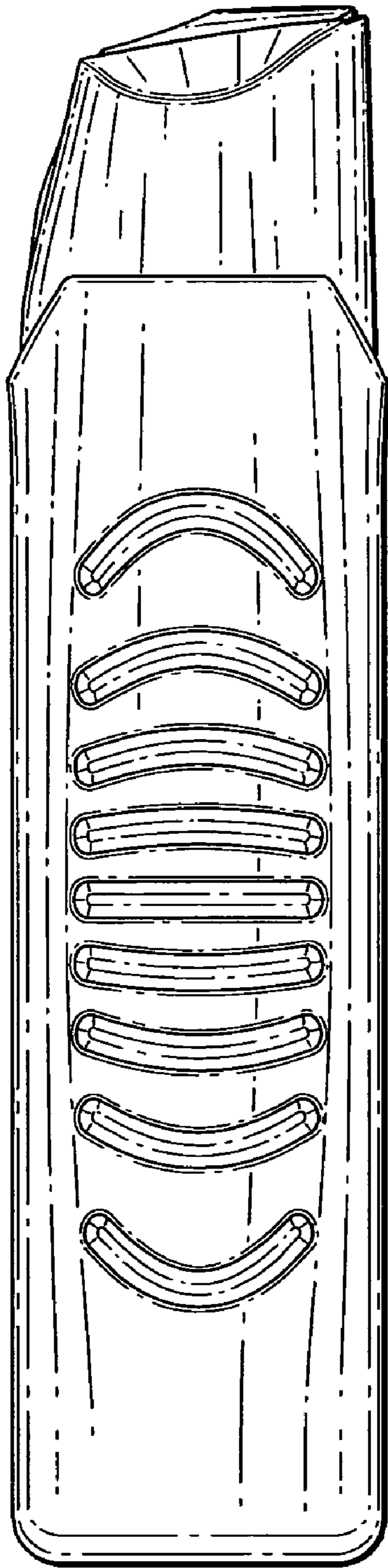

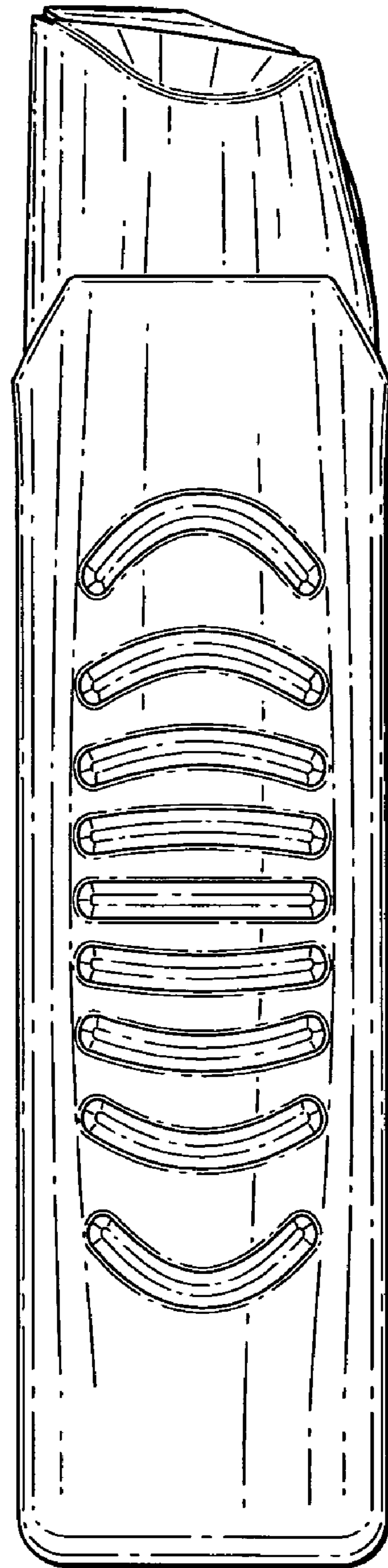

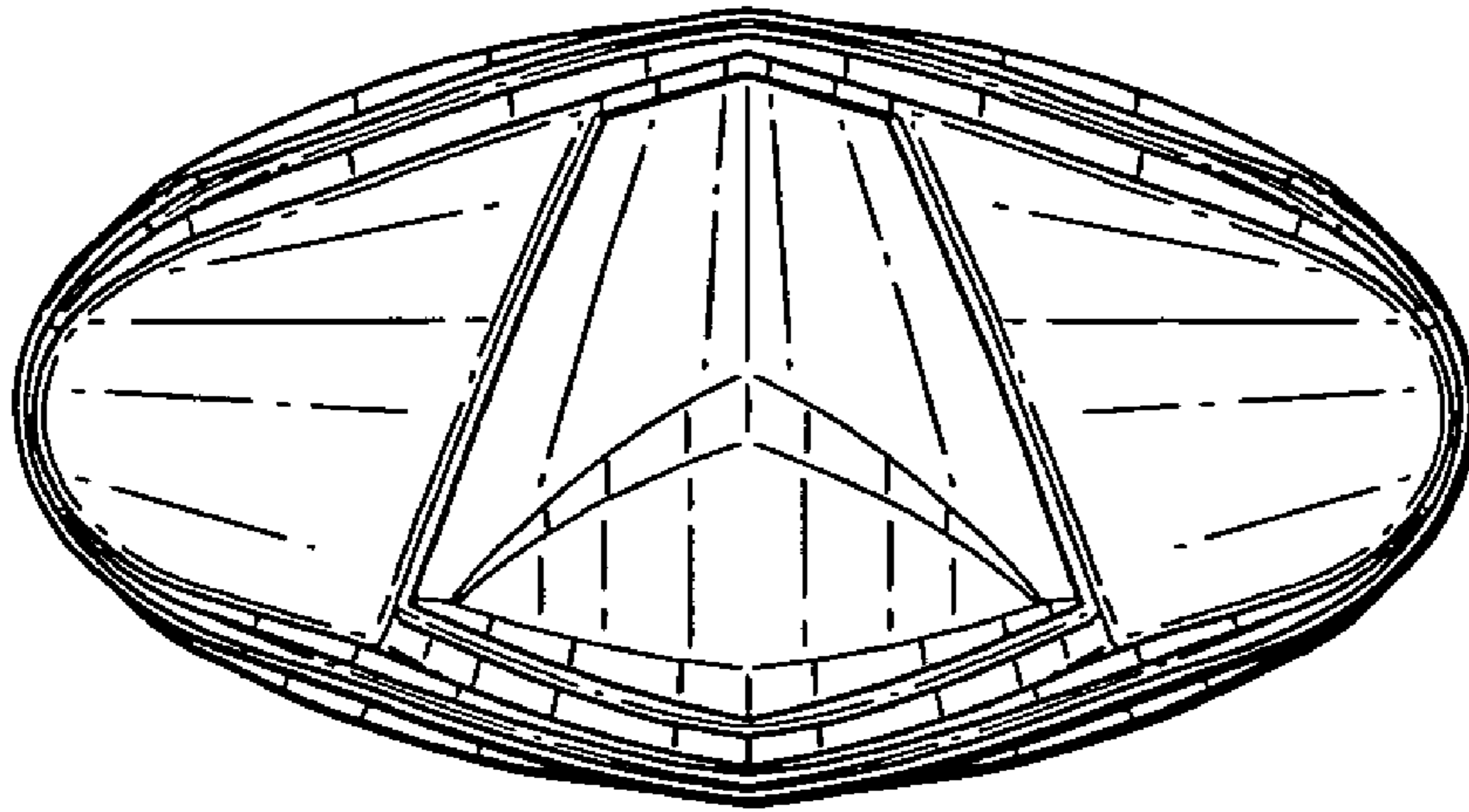
