FIG. 4 is a top plan view of the combined fragrance bottle and cap shown in FIG. 1; and,

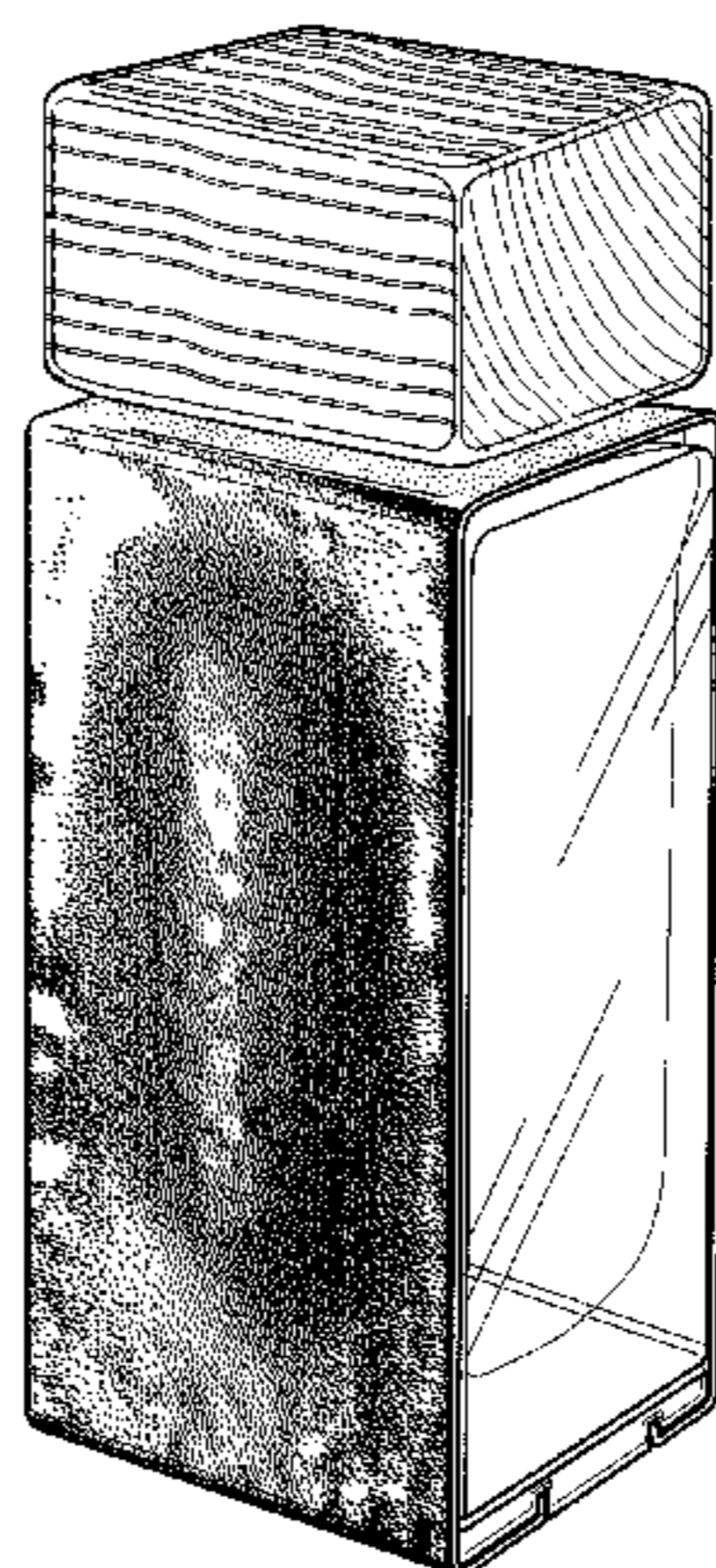
FIG. 5 is a bottom plan view of the combined fragrance bottle and cap shown in FIG. 1.

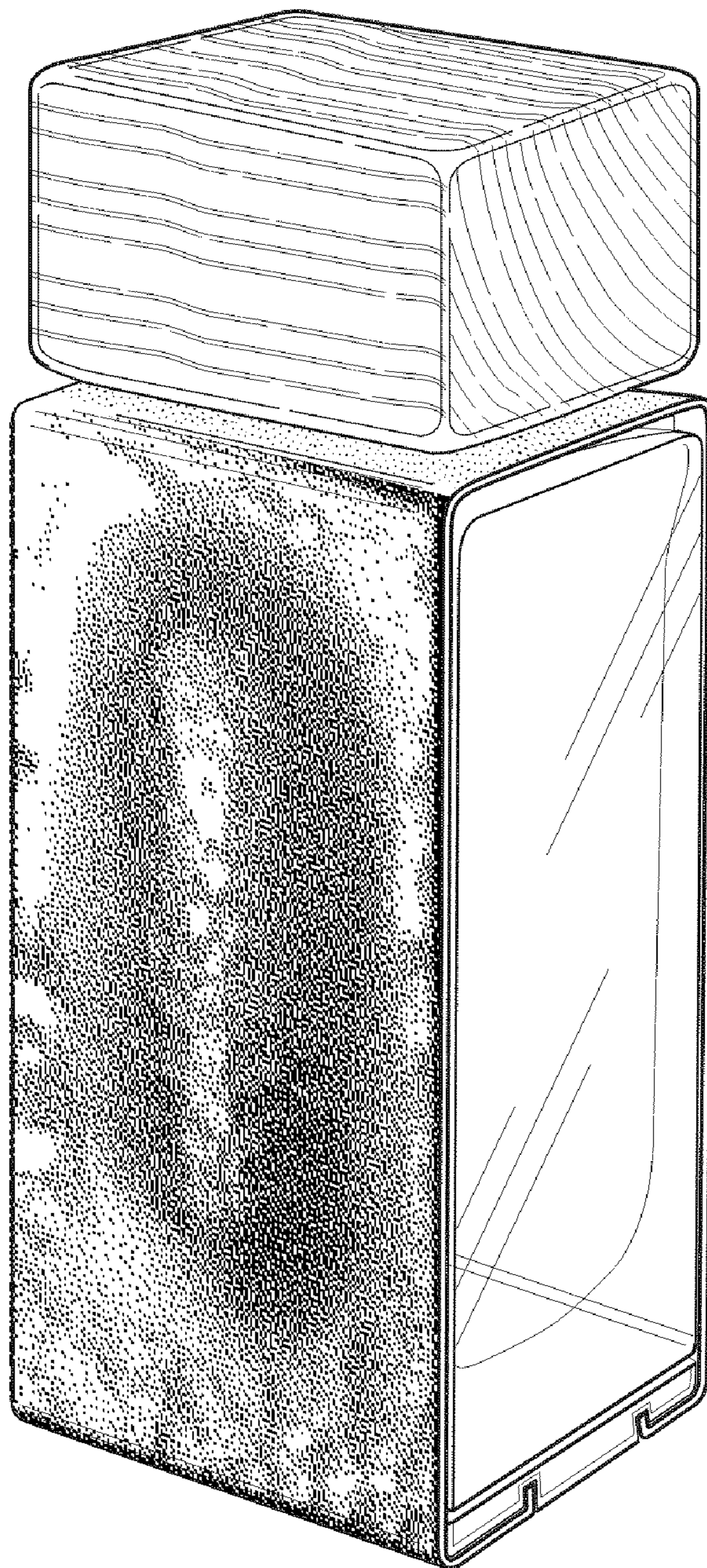

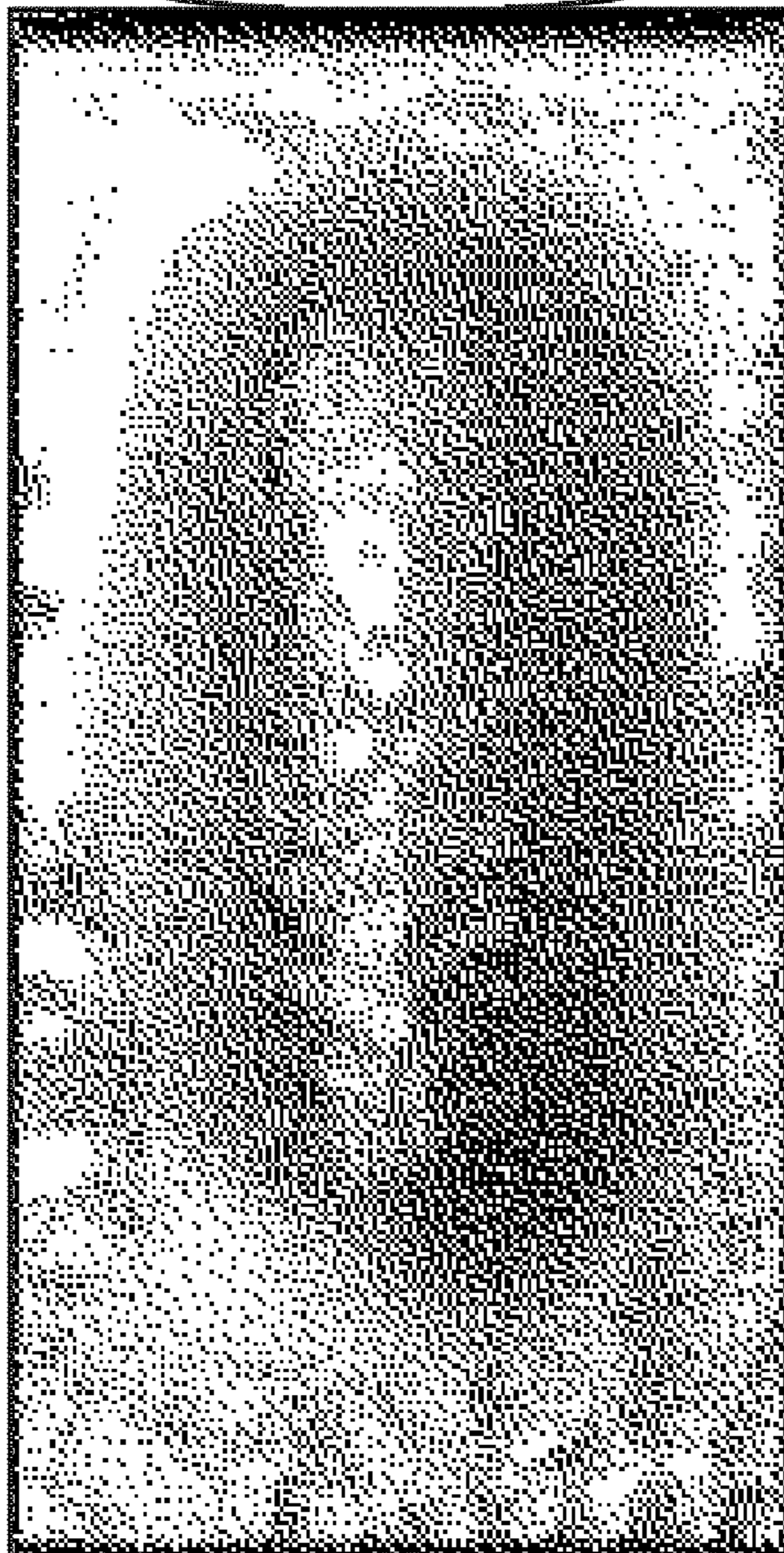
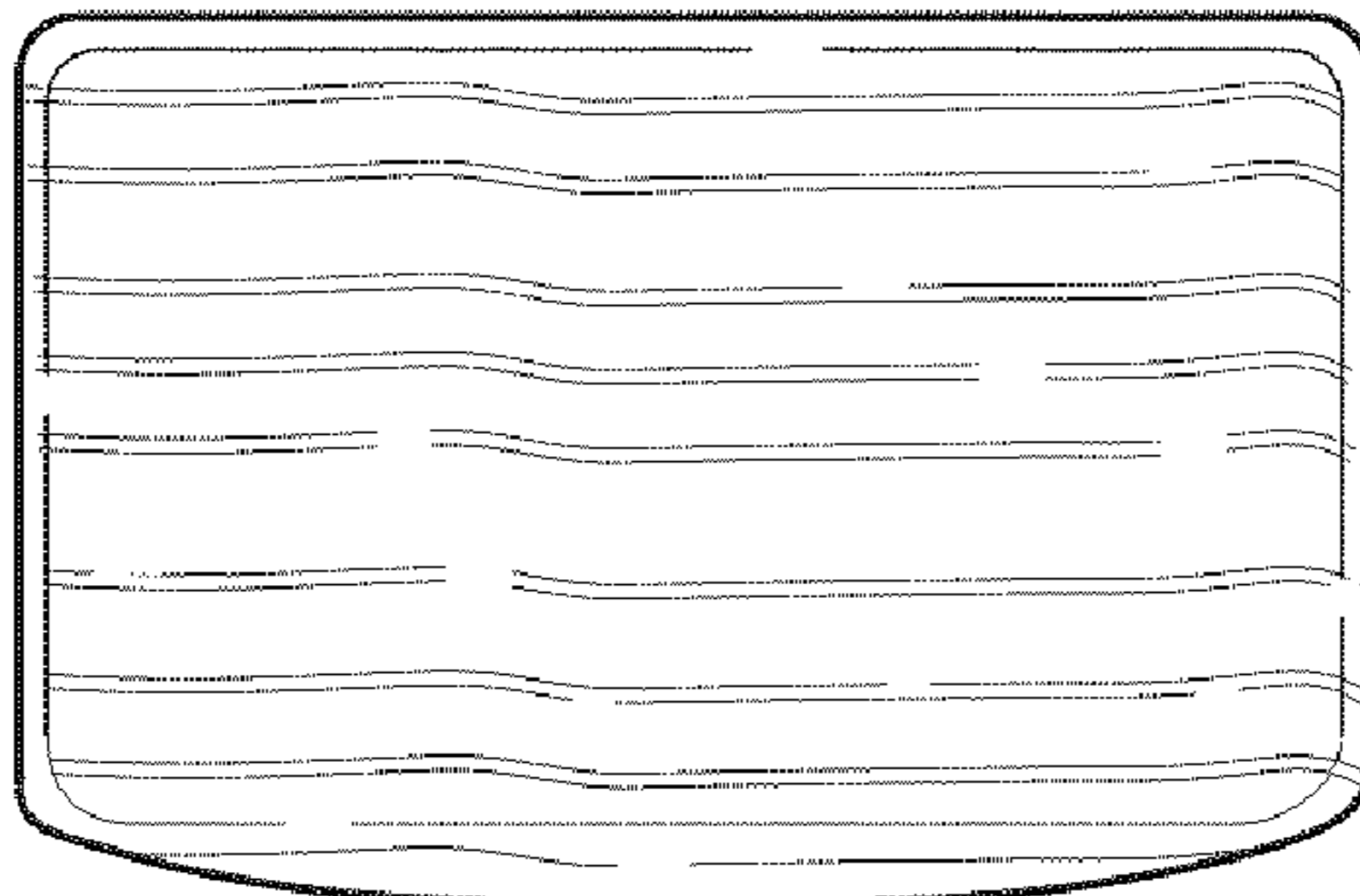

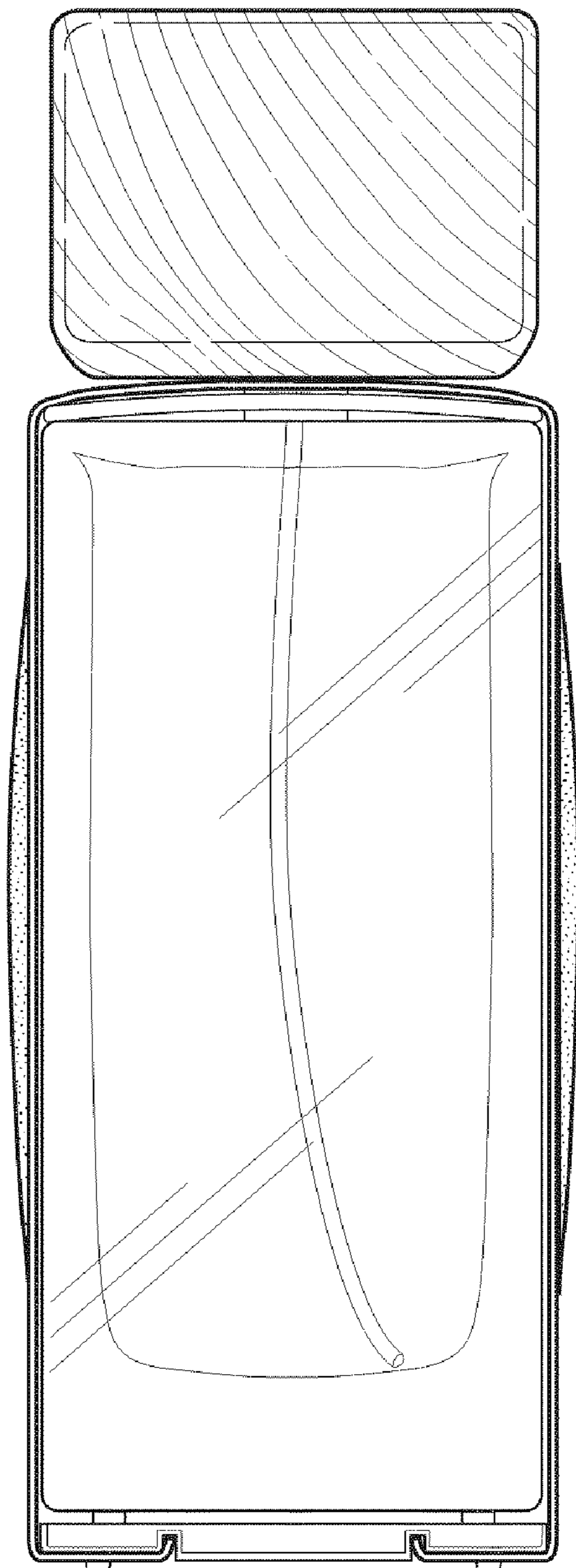

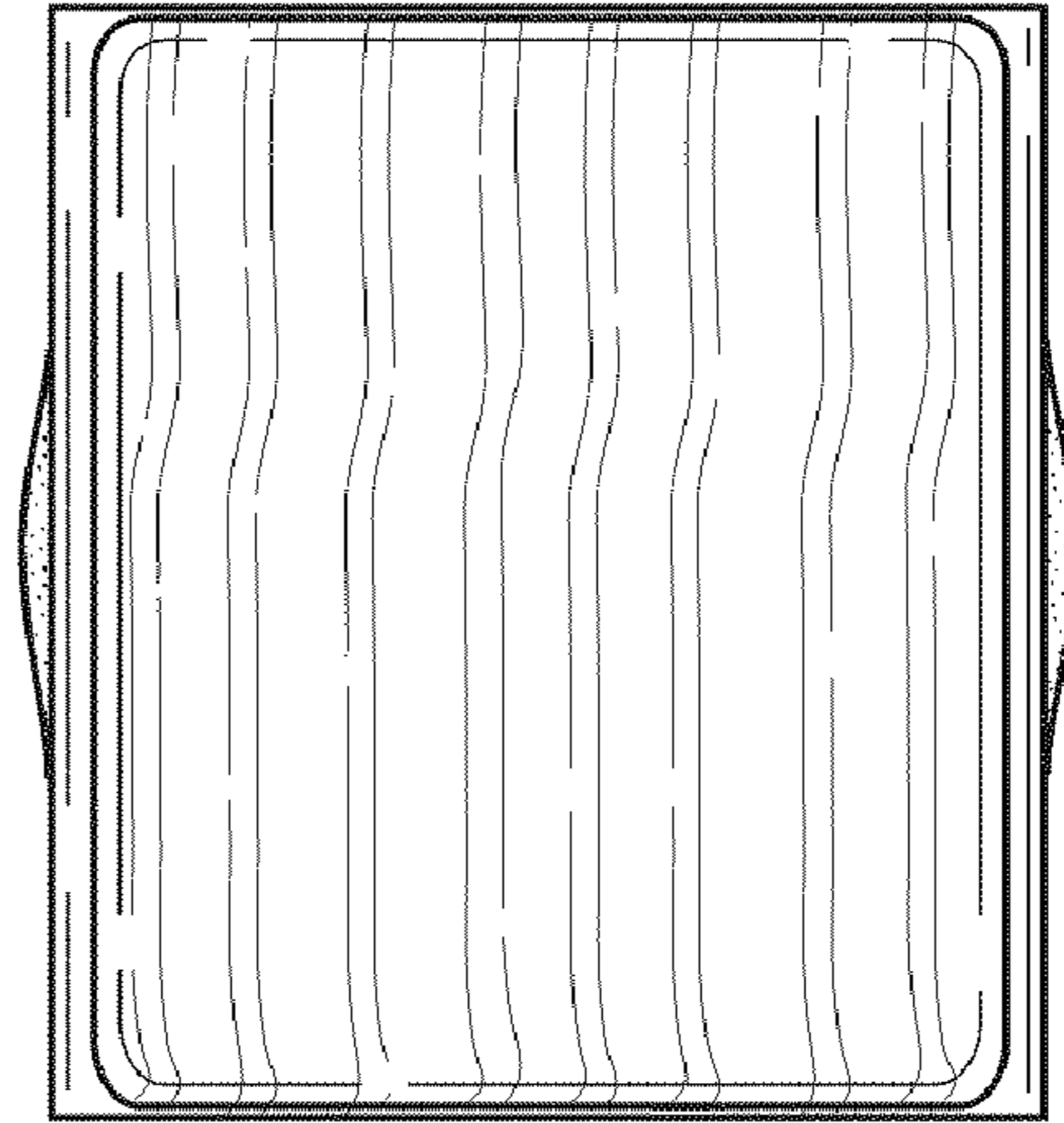
