(57) **CLAIM**

The ornamental design for a magnetic jewelry clasp, as shown and described.

DESCRIPTION

FIG. 1 is a top, front perspective view of the magnetic jewelry clasp, with a portion of unclaimed environmental structure shown;

FIG. 2 is a bottom, front perspective view thereof;

FIG. 3 is a front view thereof;

FIG. 4 is a top, front perspective view thereof, but in a closed position;

FIG. 5 is a side view thereof, shown without the unclaimed structure;

FIG. 6 is the opposite side view of the clasp of FIG. 5;

FIG. 7 is a front view of the clasp of FIG. 5;

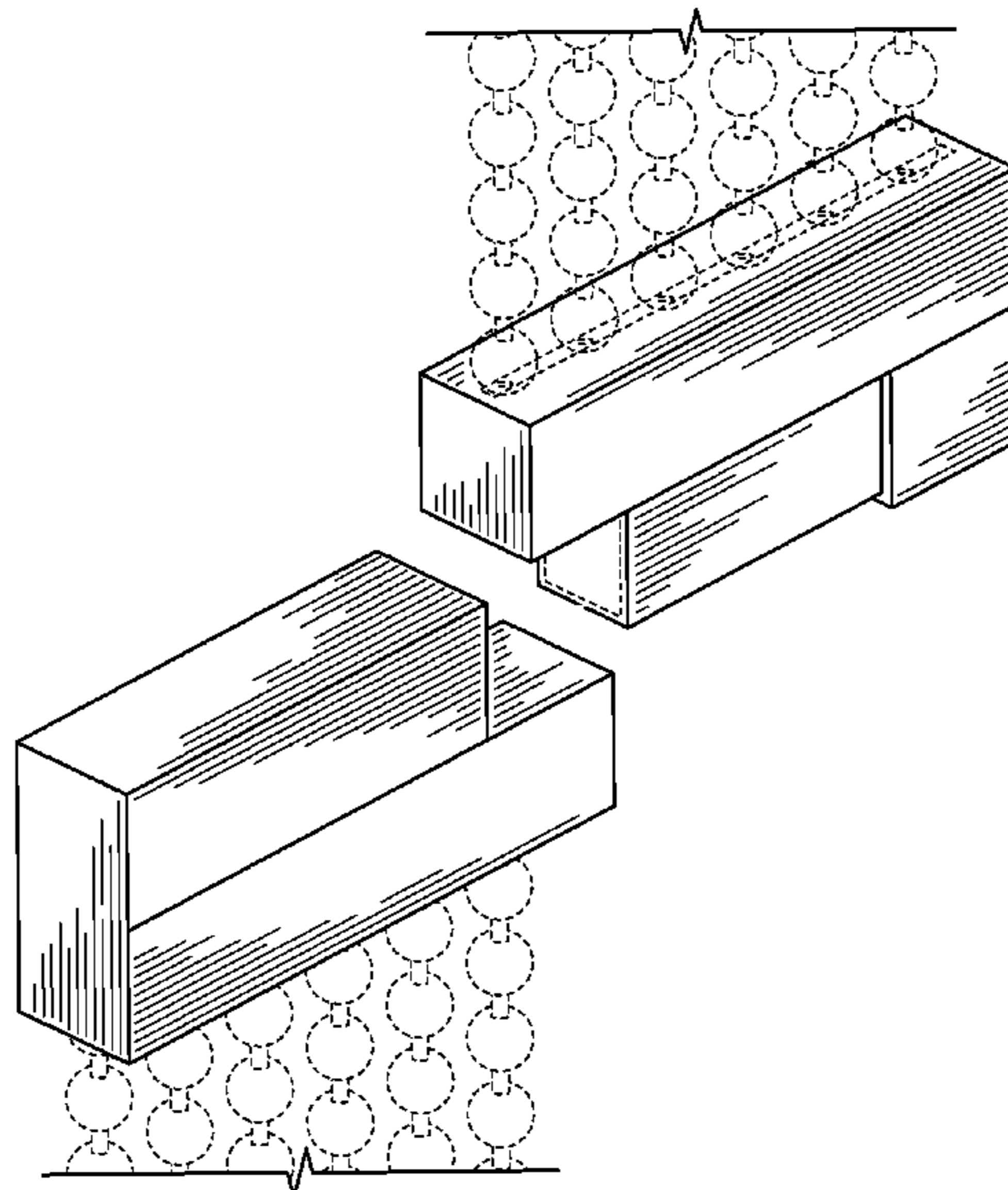
FIG. 8 is a rear view of the clasp of FIG. 5;

FIG. 9 is a top view of the clasp of FIG. 5; and,

FIG. 10 is a bottom view of the clasp of FIG. 5.

The broken lines shown in the drawings represent environmental structure and unclaimed portions of the magnetic jewelry clasp, and form no part of the claimed design.

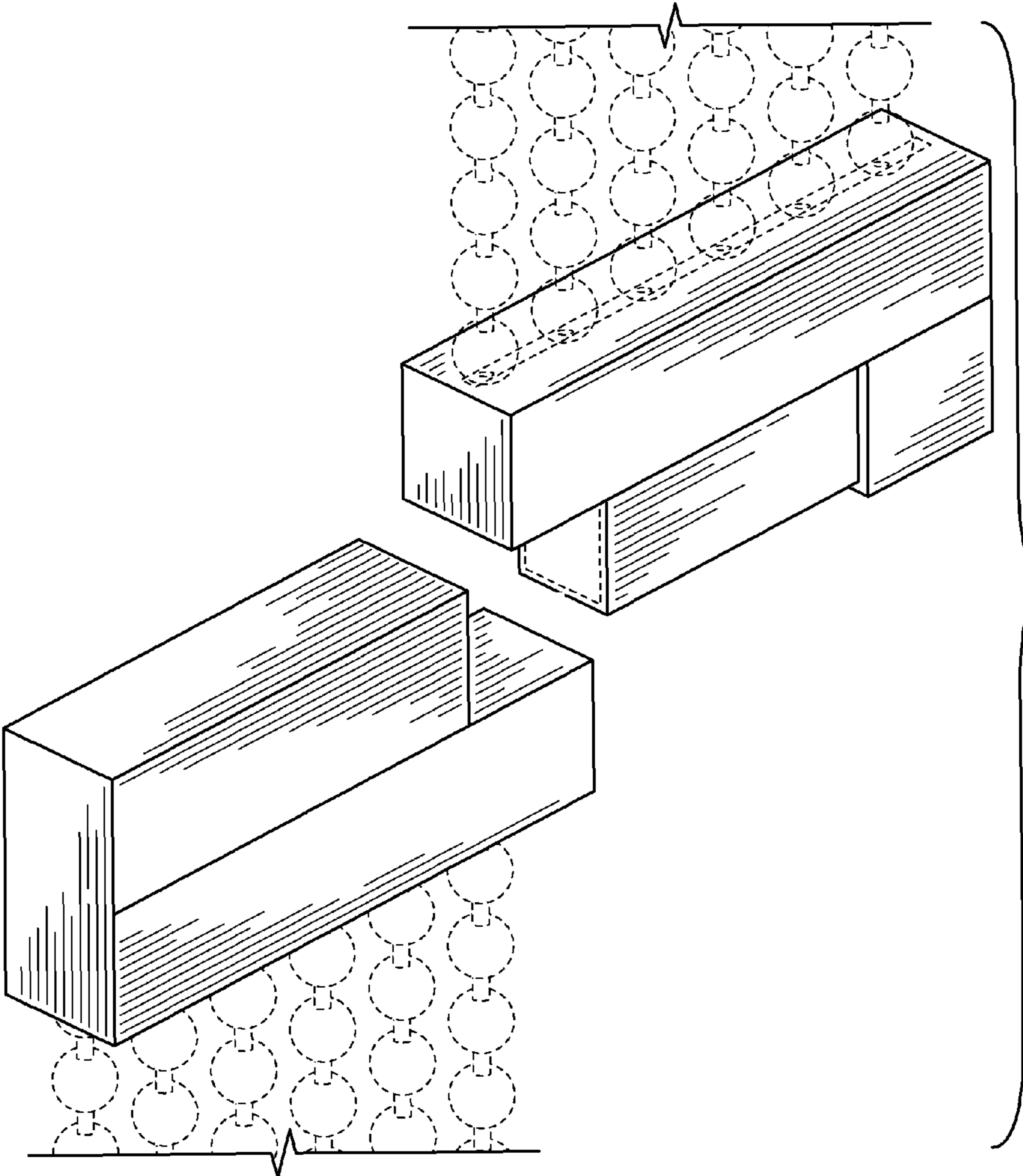

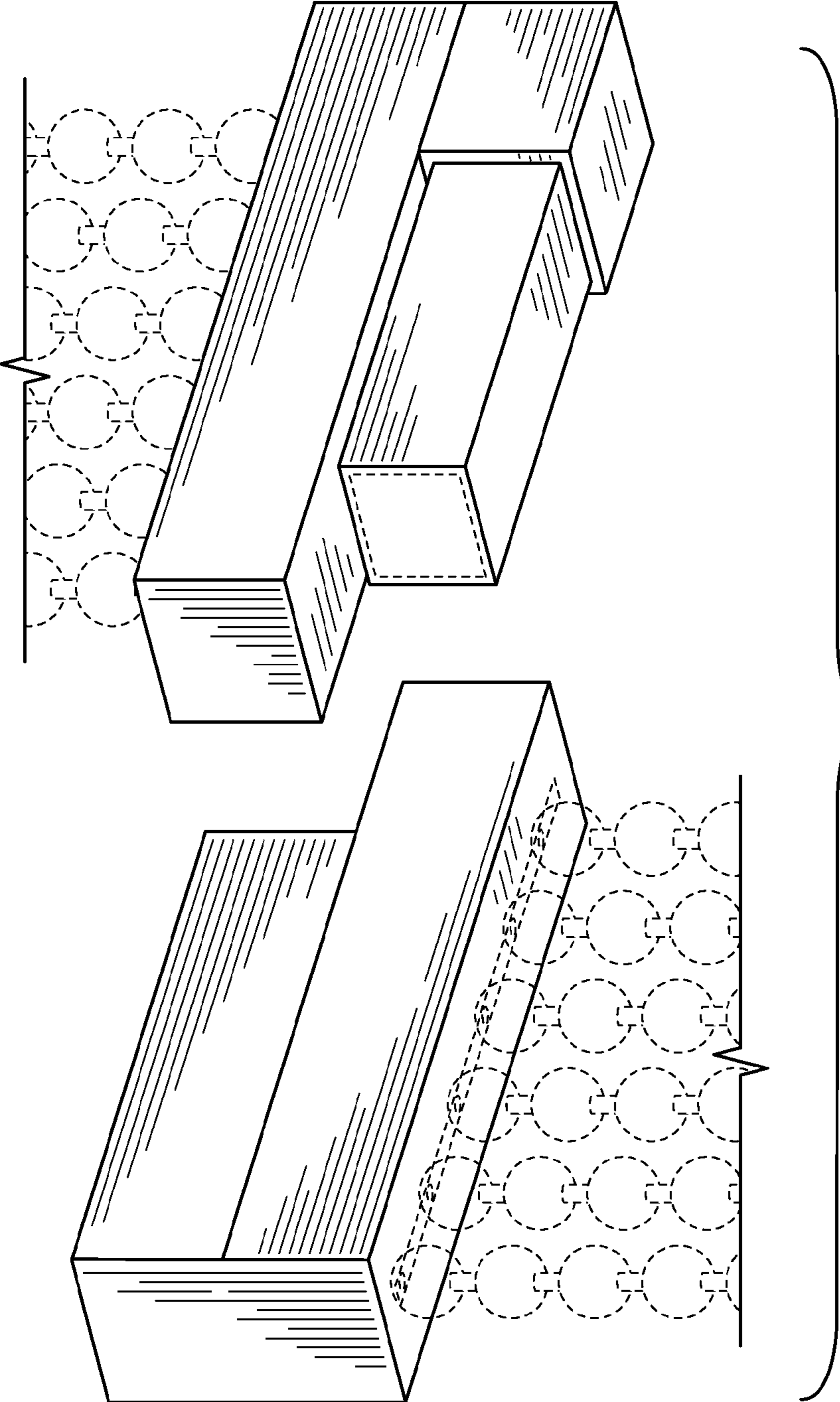

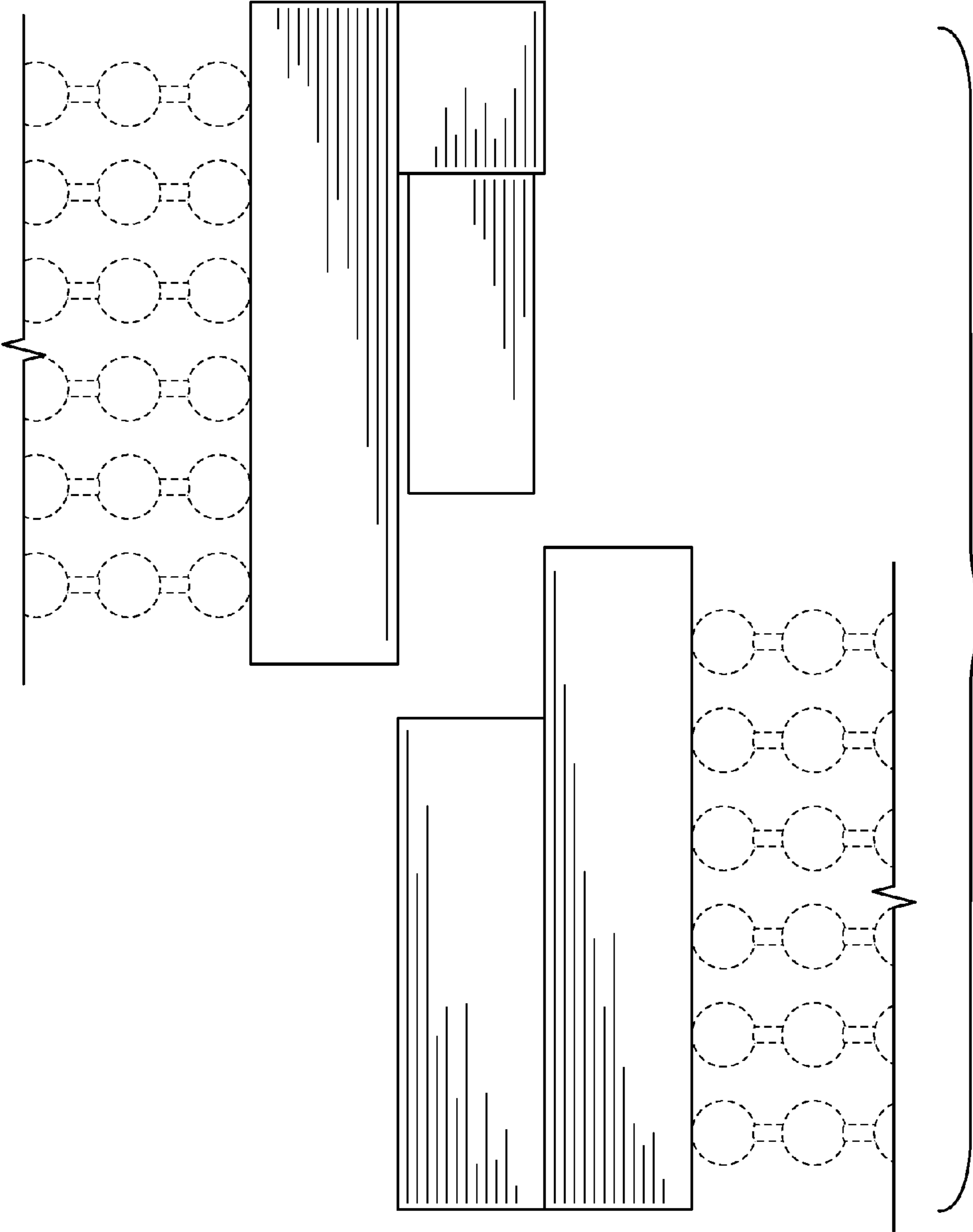

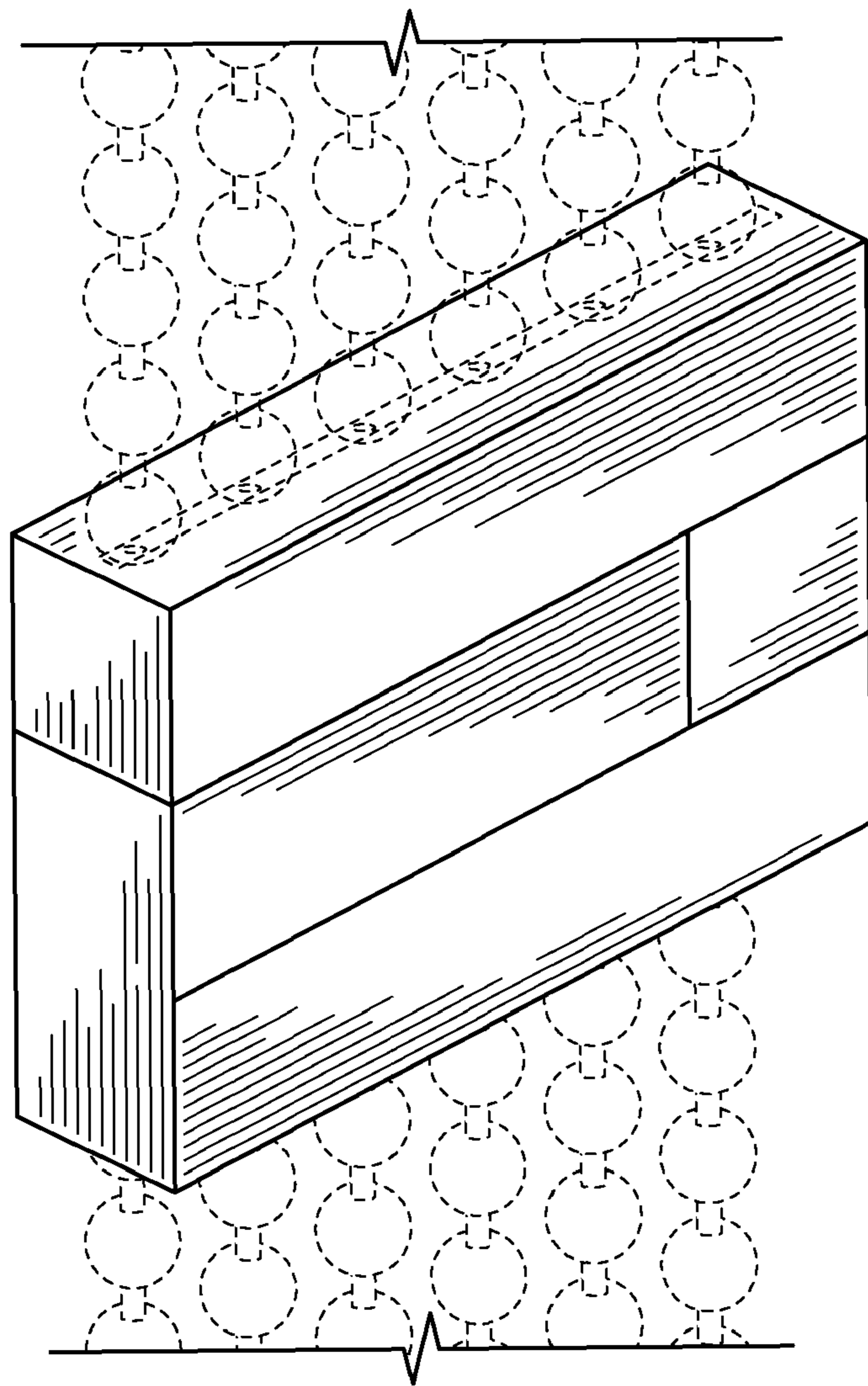

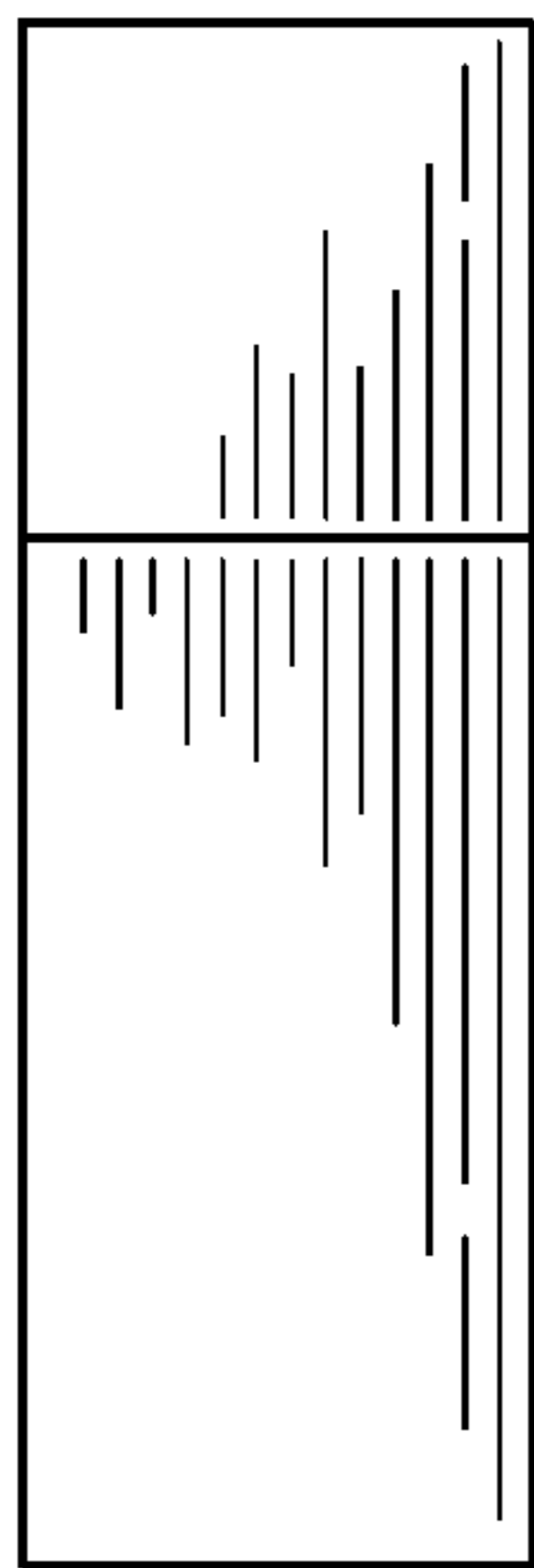

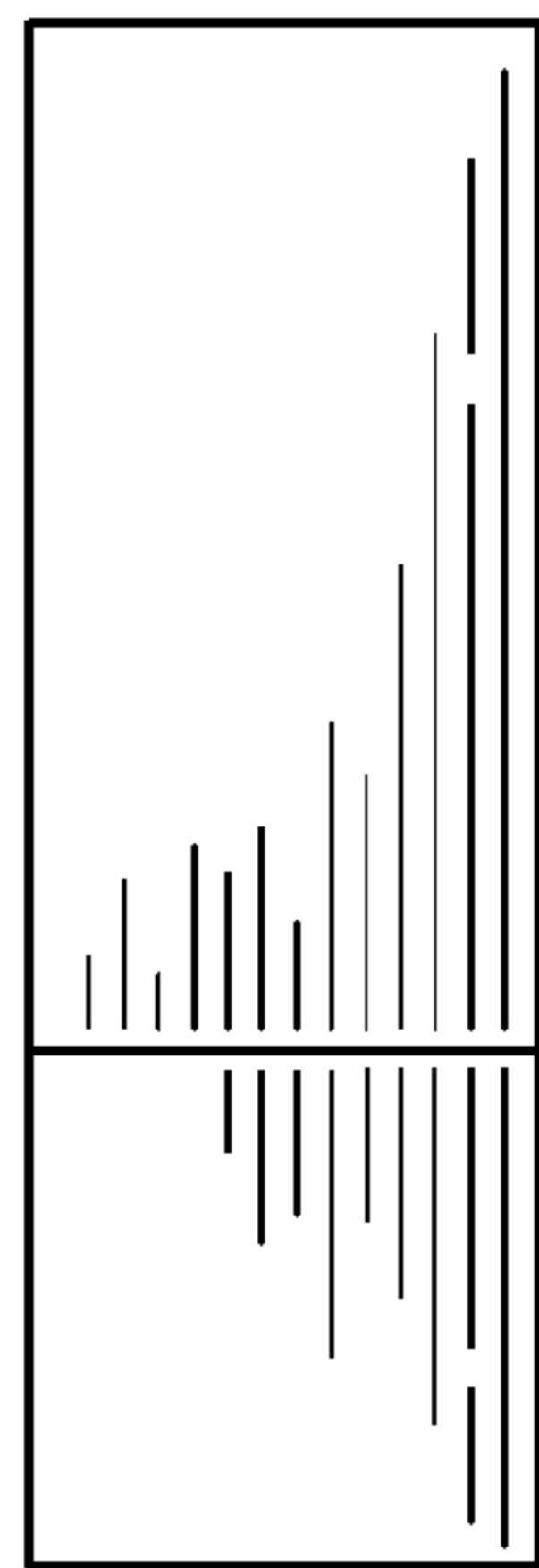

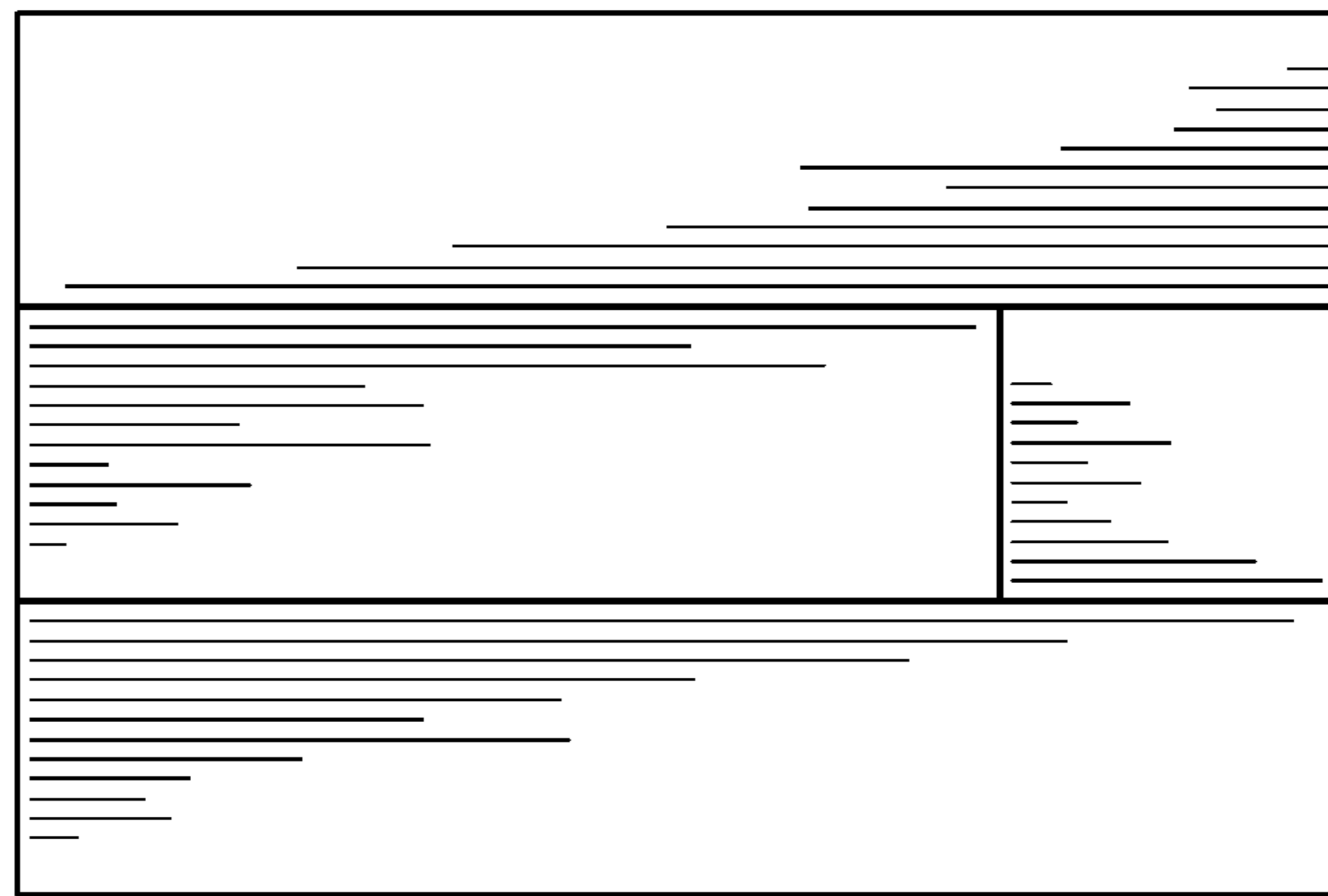

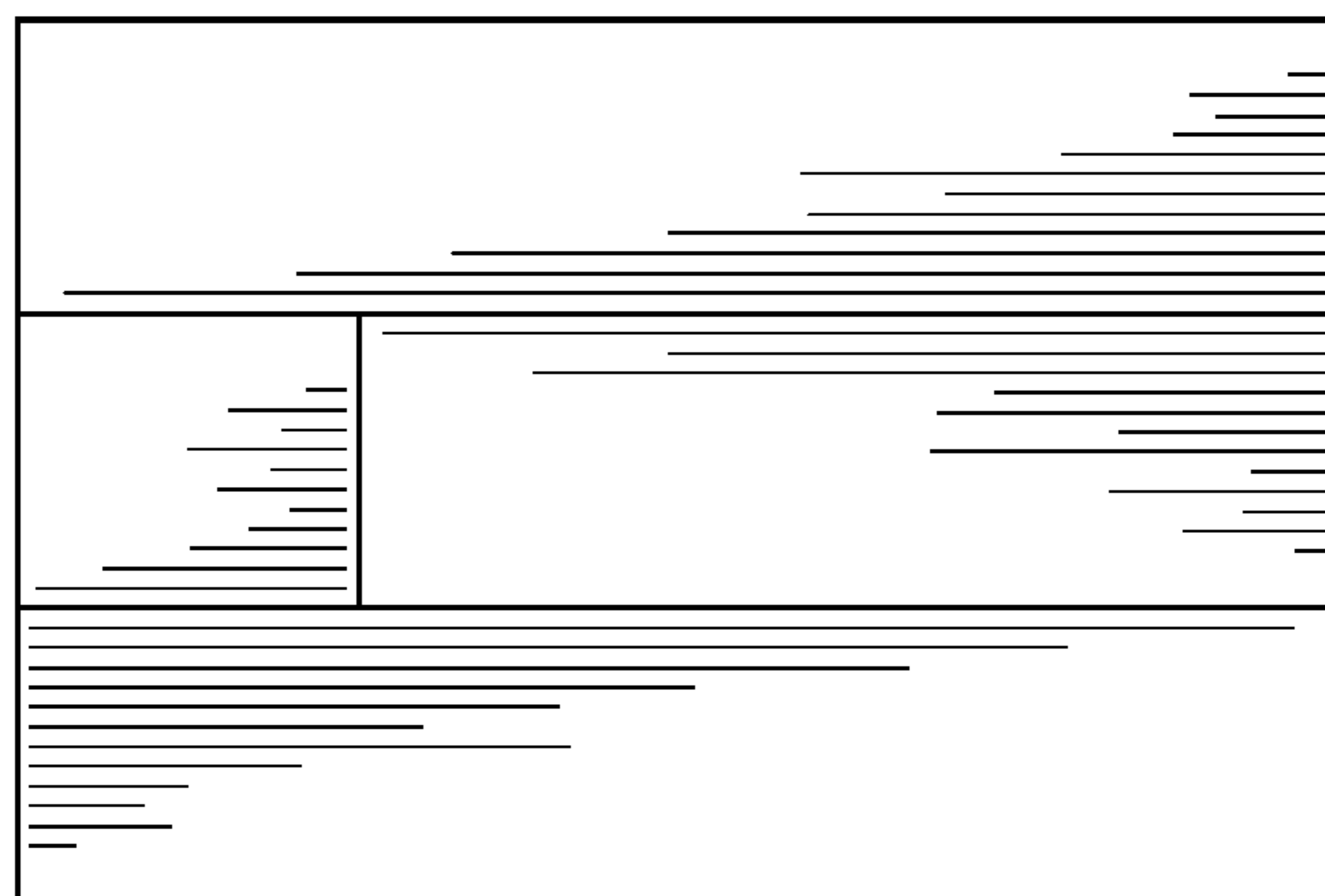

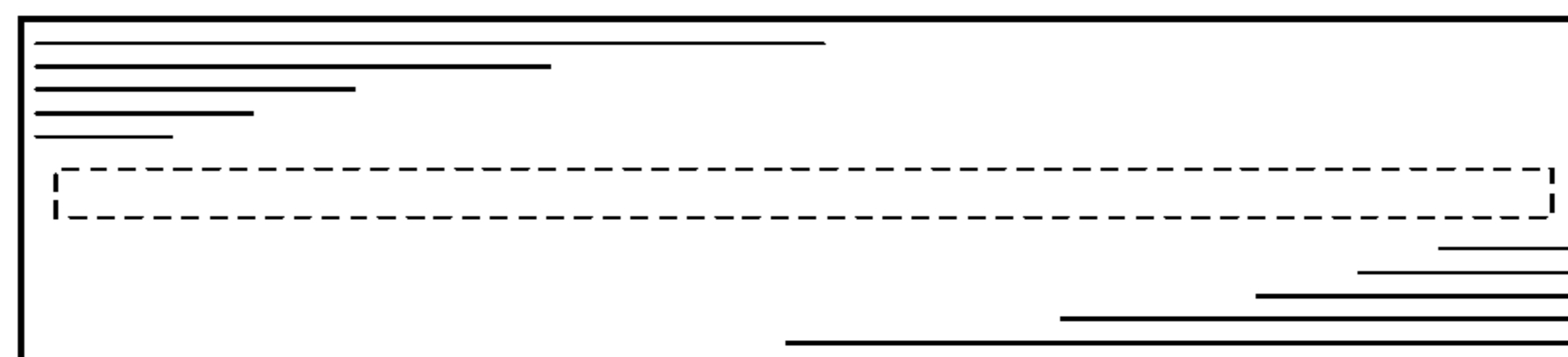

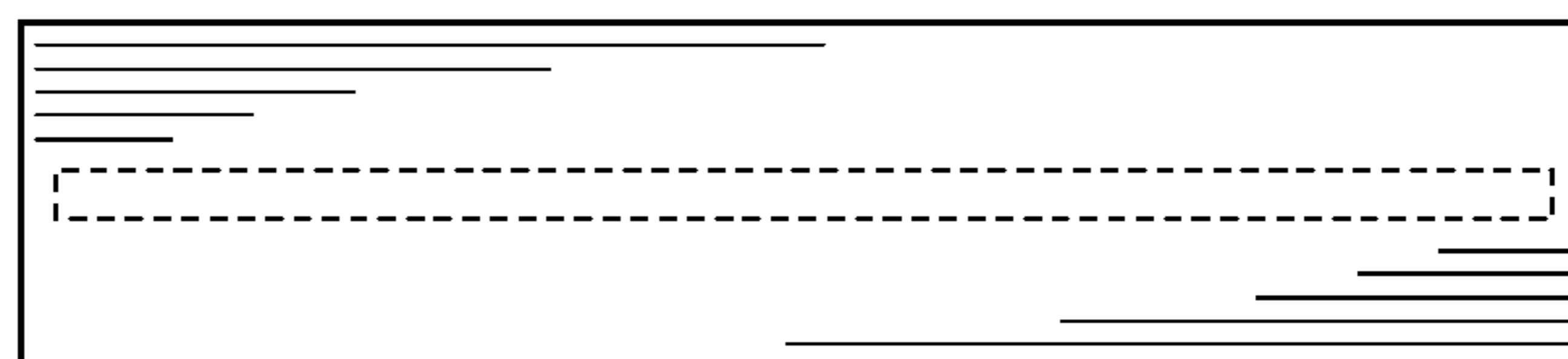
