DESCRIPTION

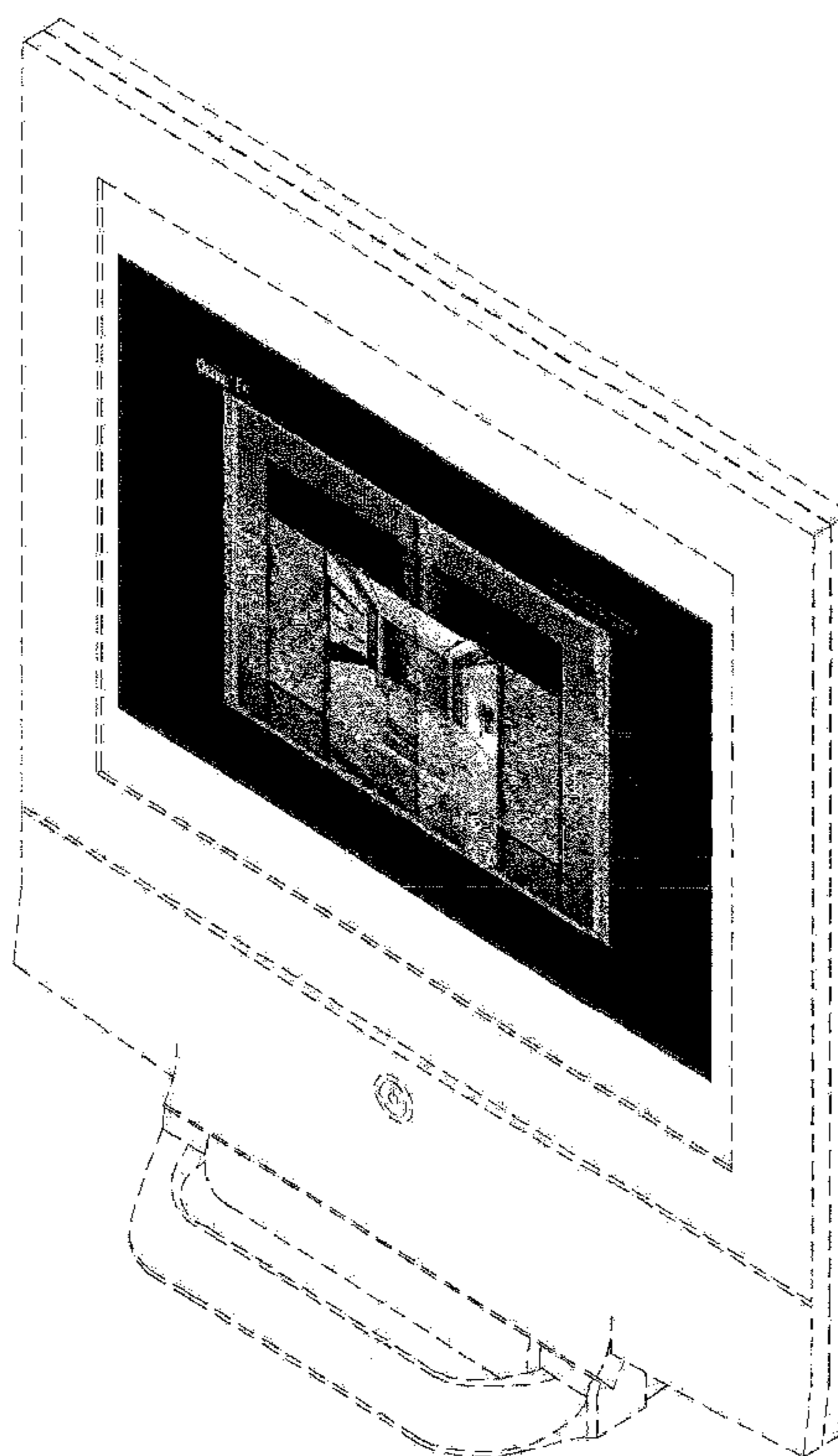
FIG. 1 is a perspective view of a portion of a computer monitor with a computer icon showing my new design;

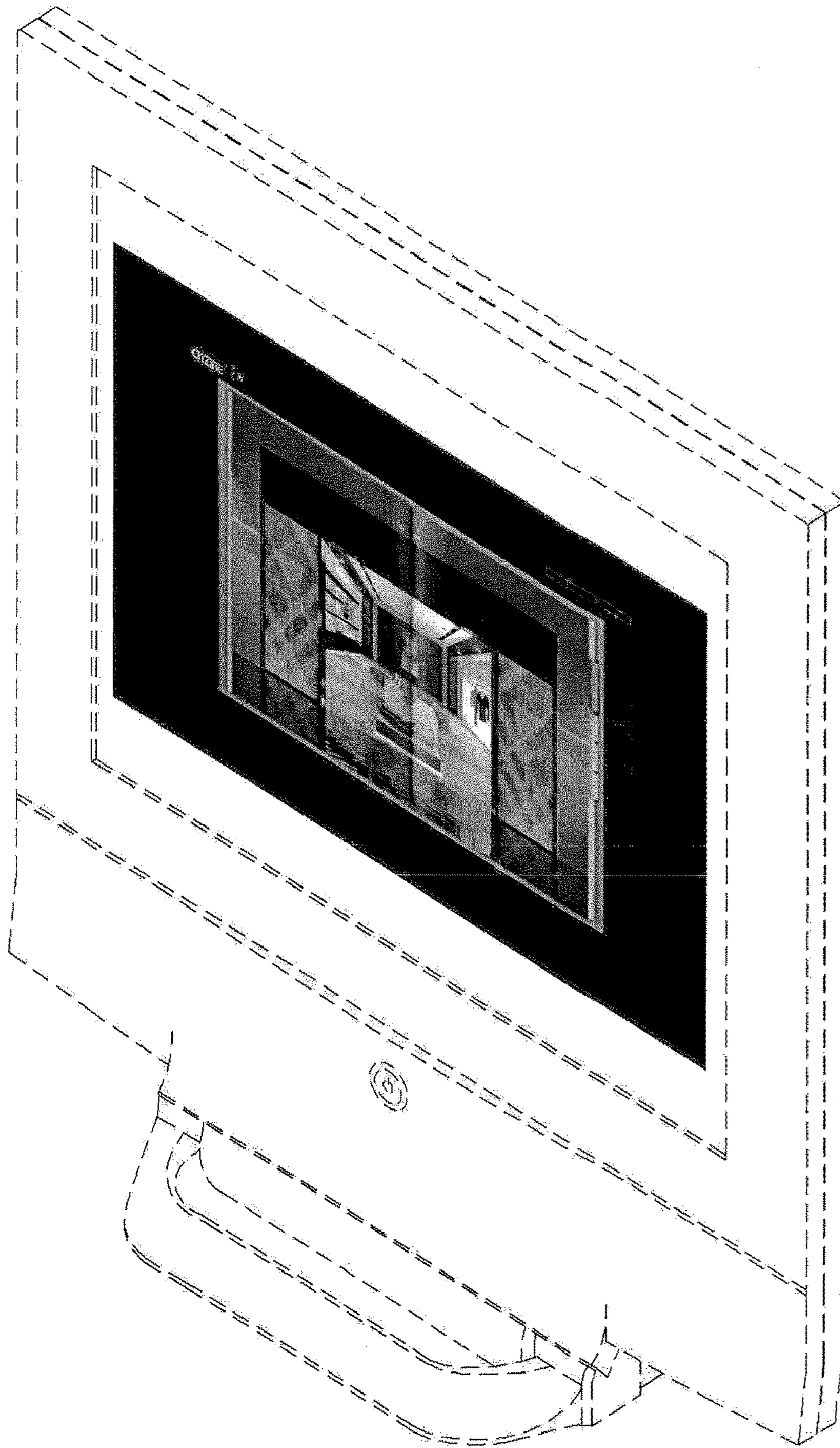

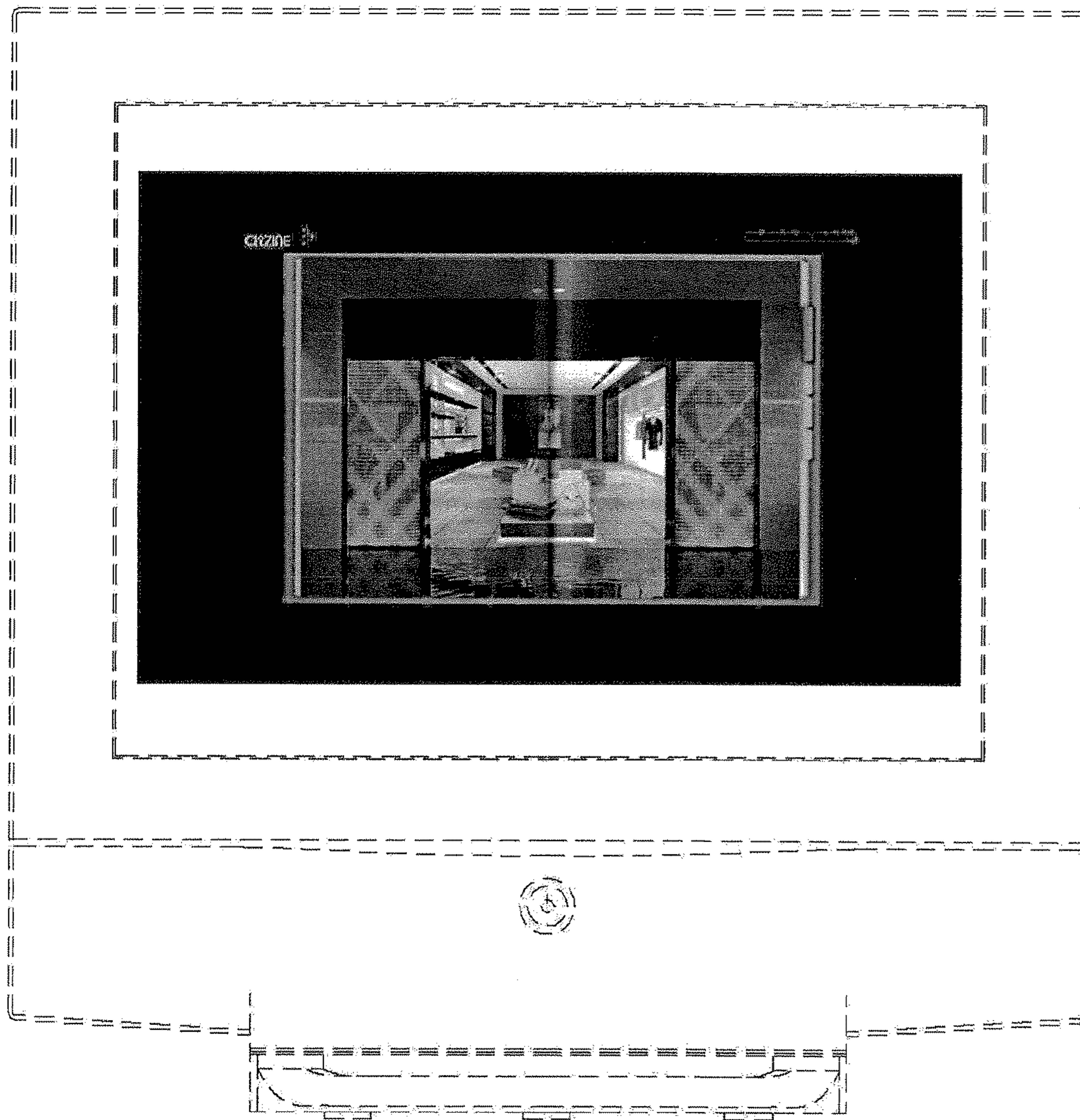

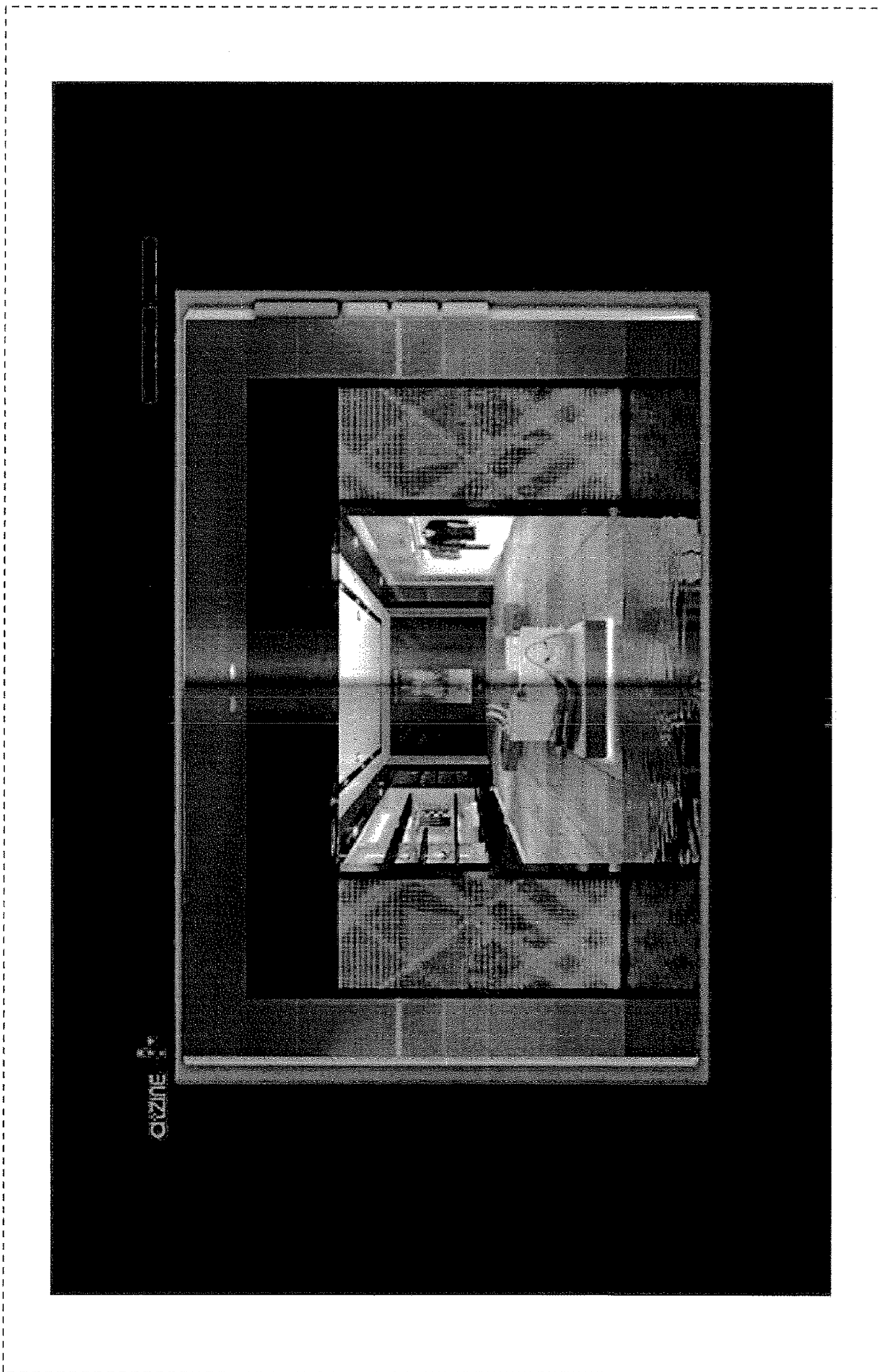
