The ornamental design for a digital video camera, as shown and described.

DESCRIPTION

FIG. 1 is a front, top and right side perspective view of a digital video camera showing my new design;

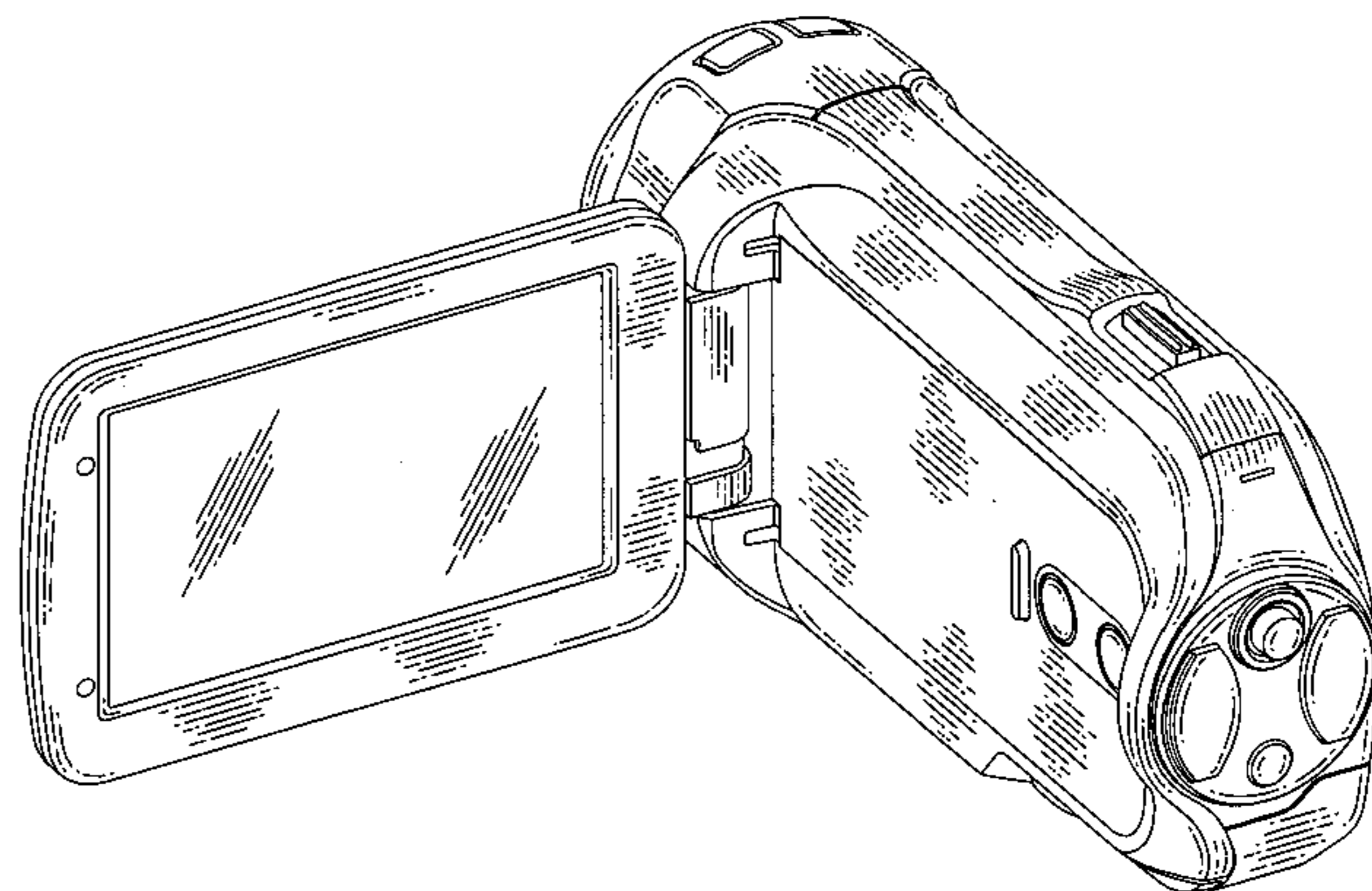
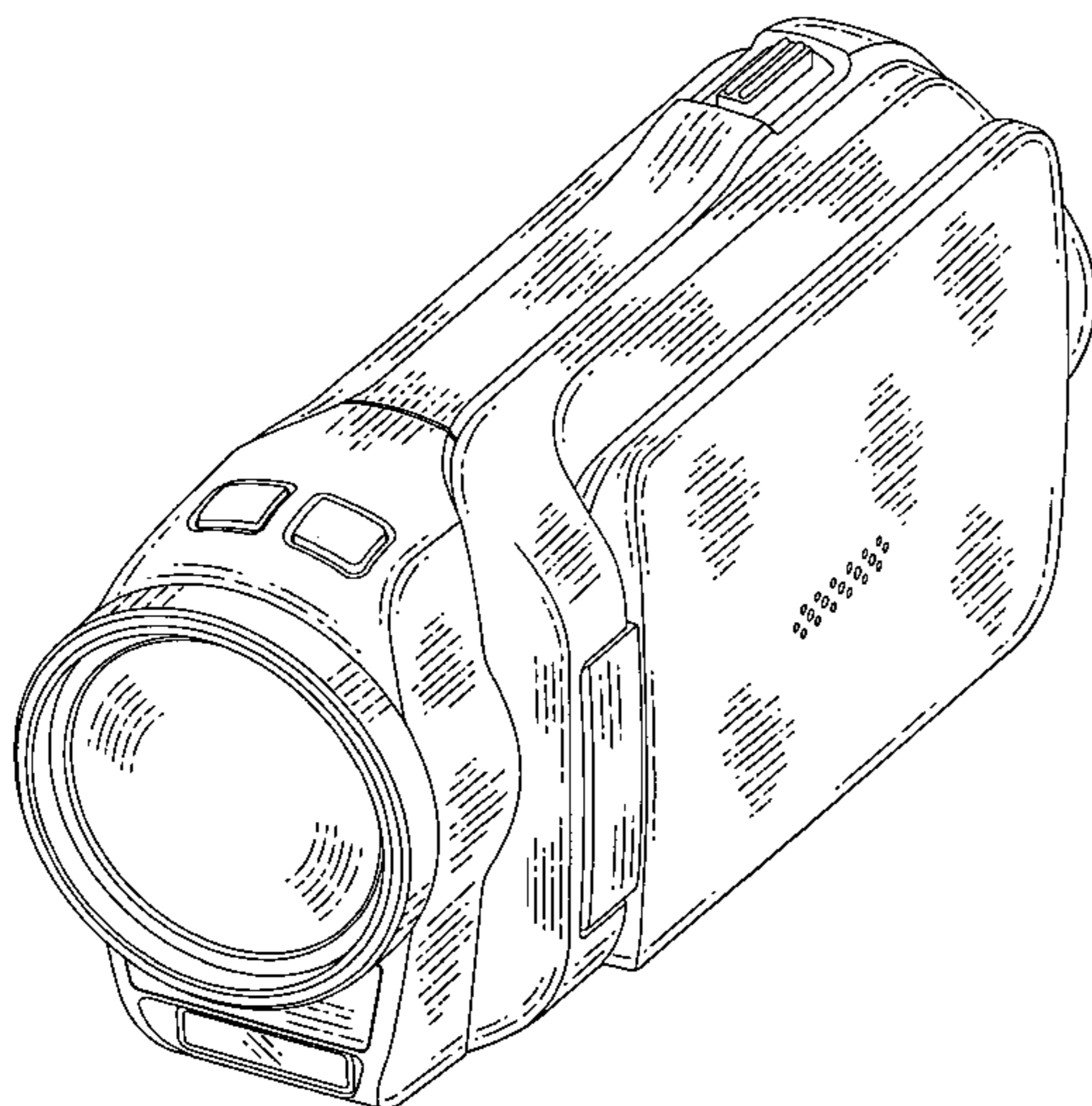

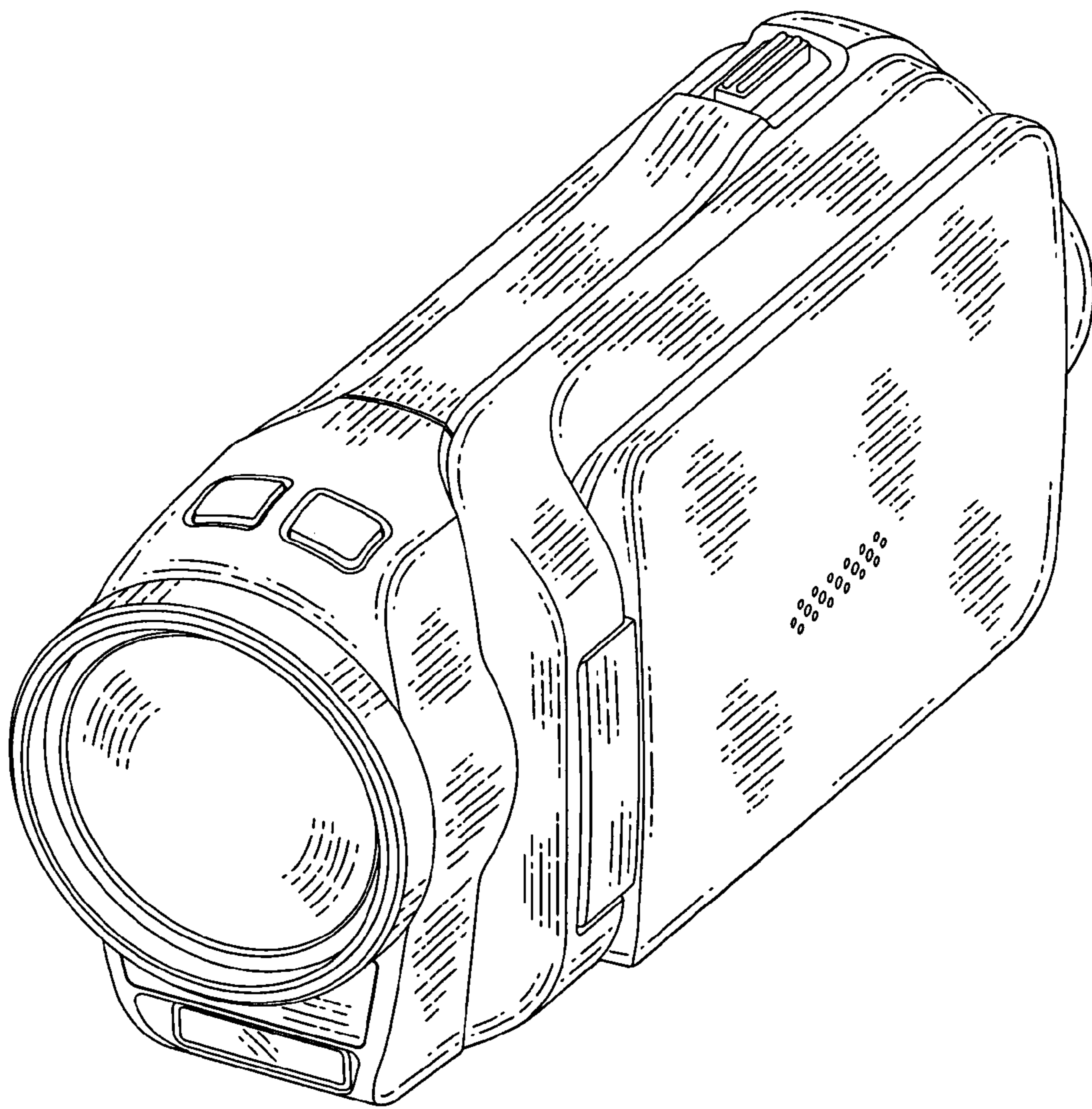

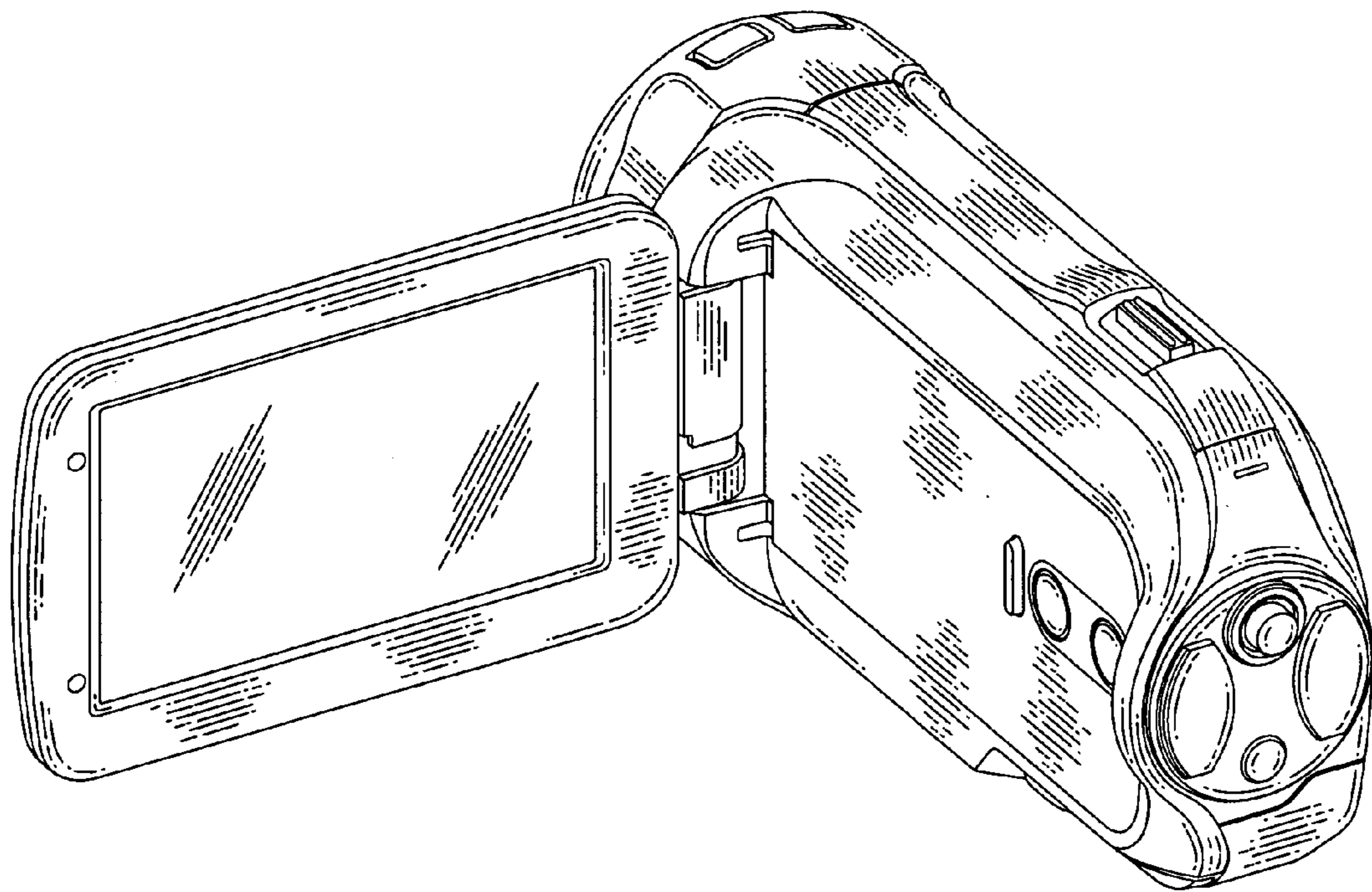

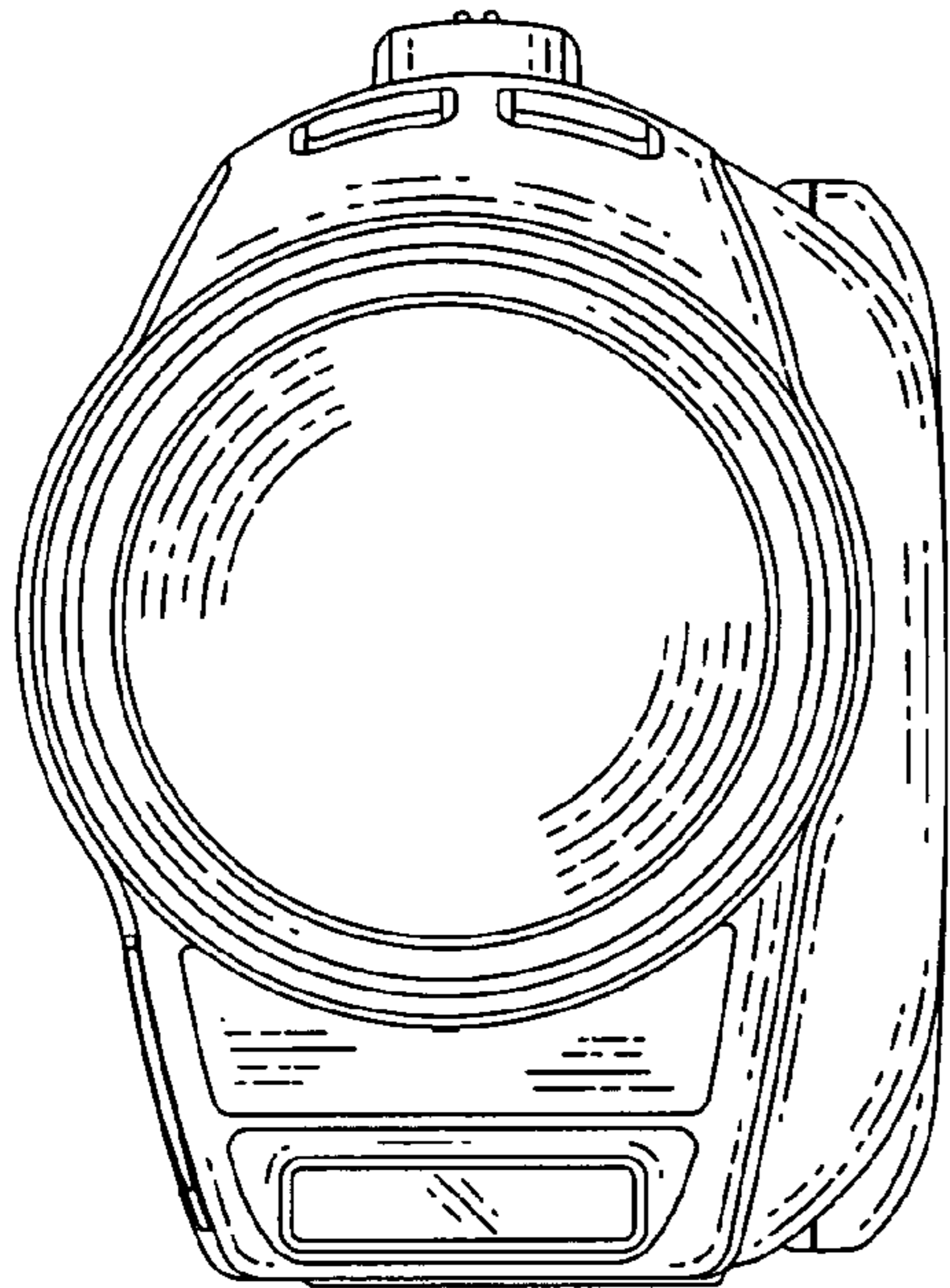

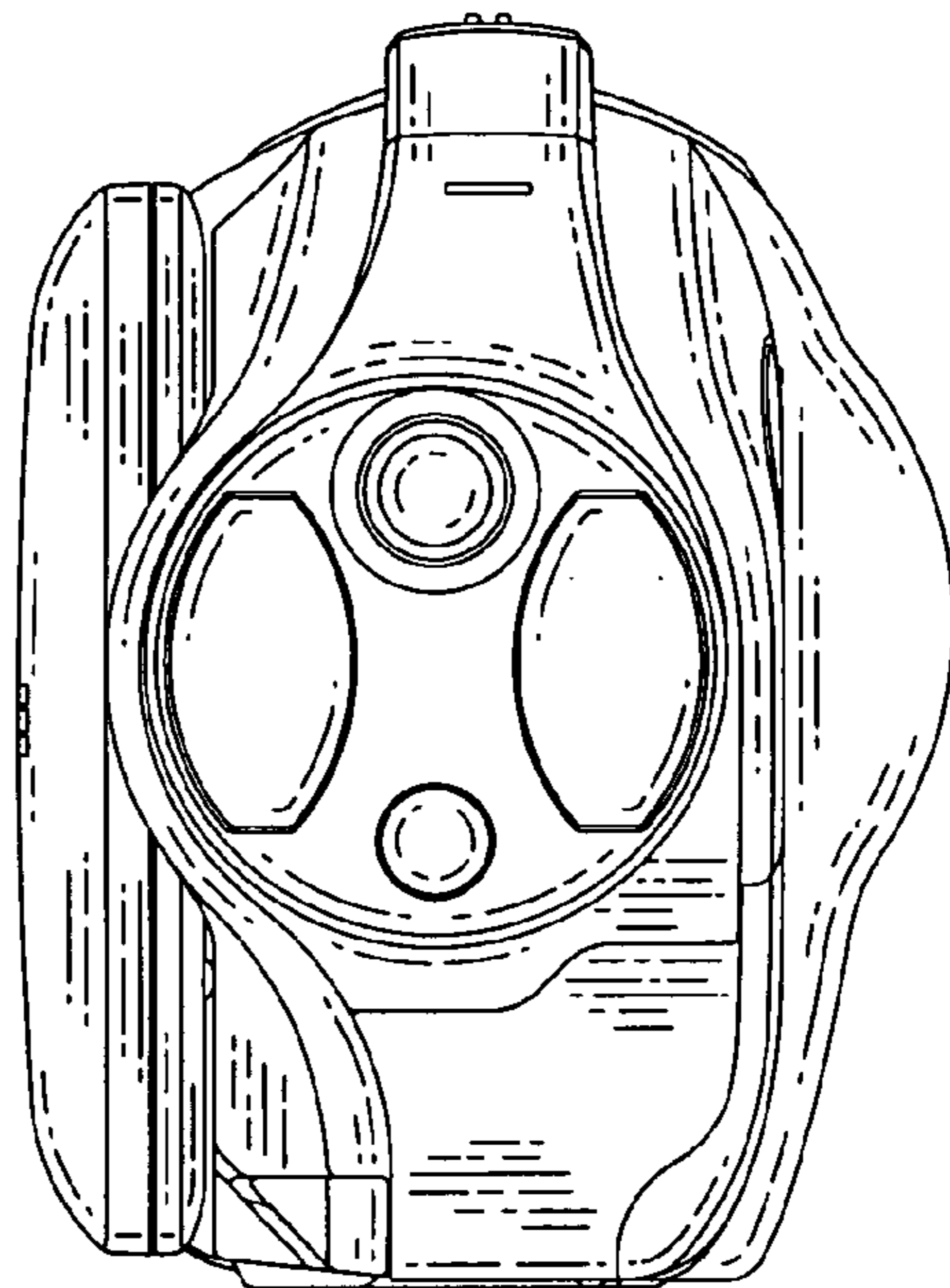

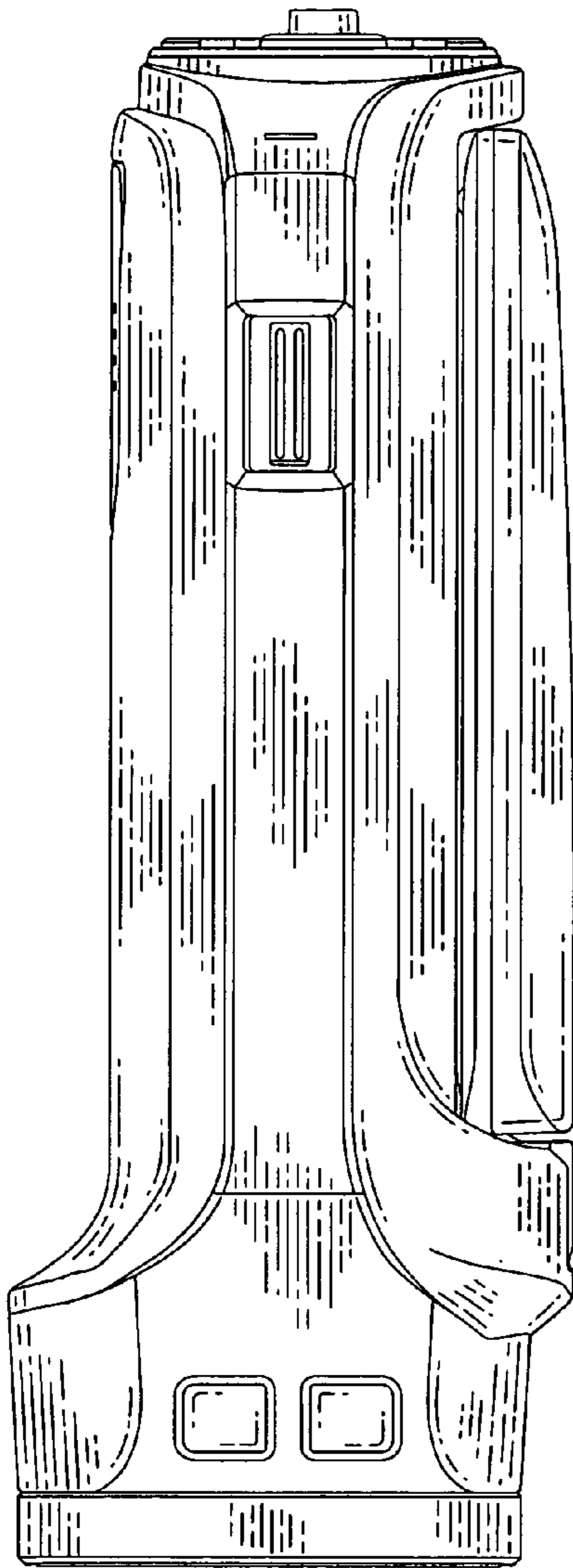
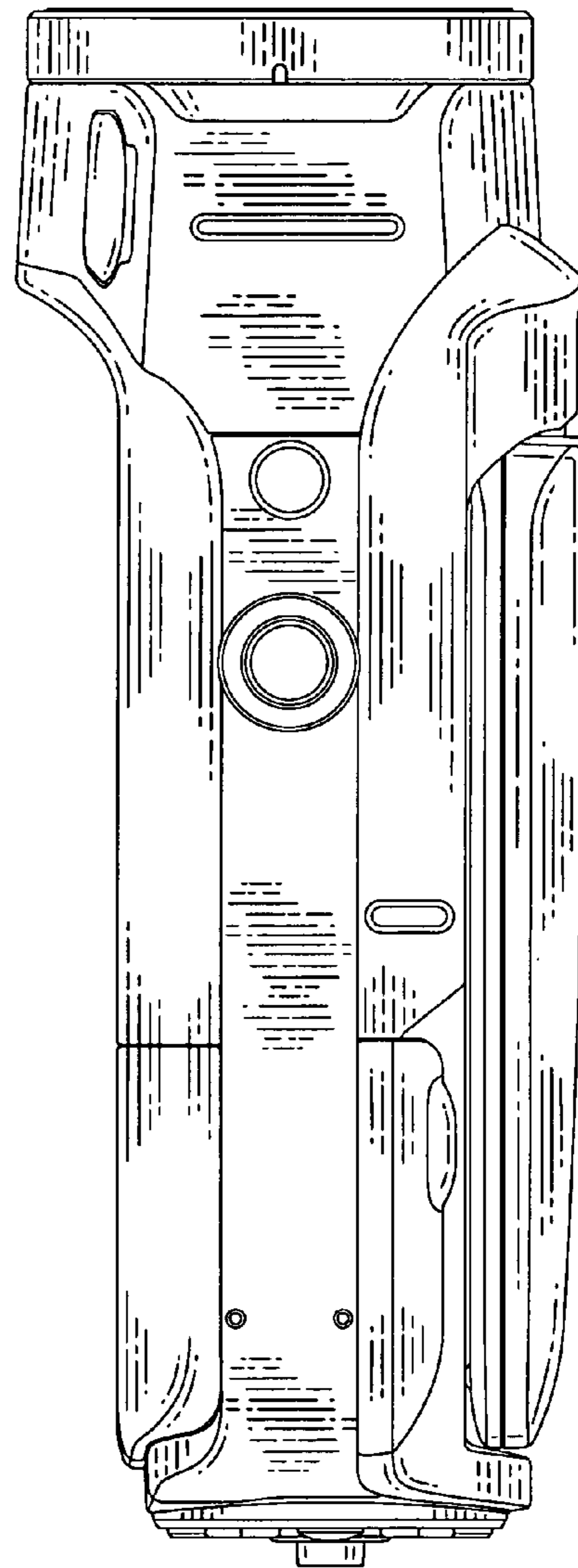

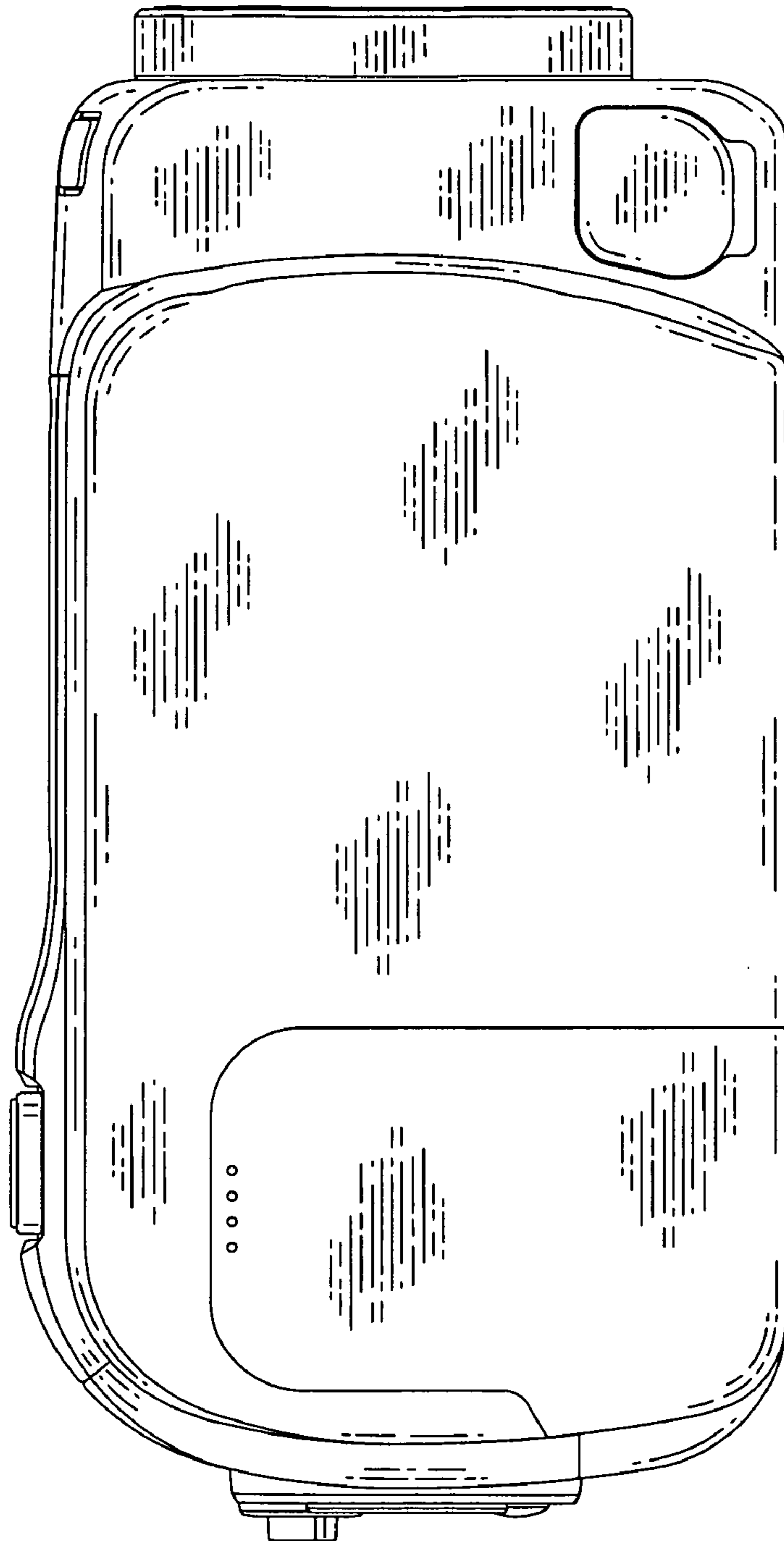

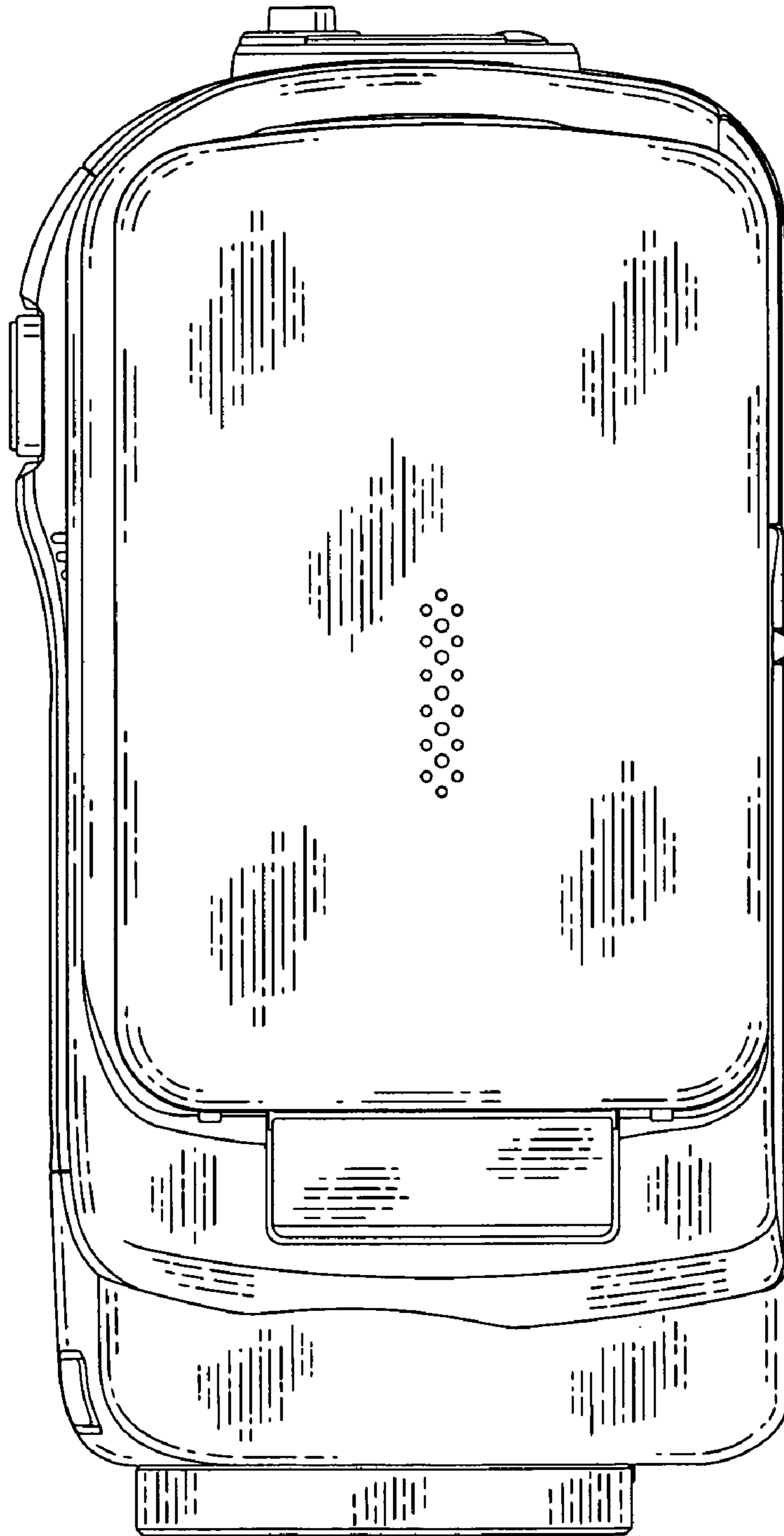
