(57) **CLAIM**

The ornamental design for an LED tasklight, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front, and right side perspective view of an LED tasklight which embodies our design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

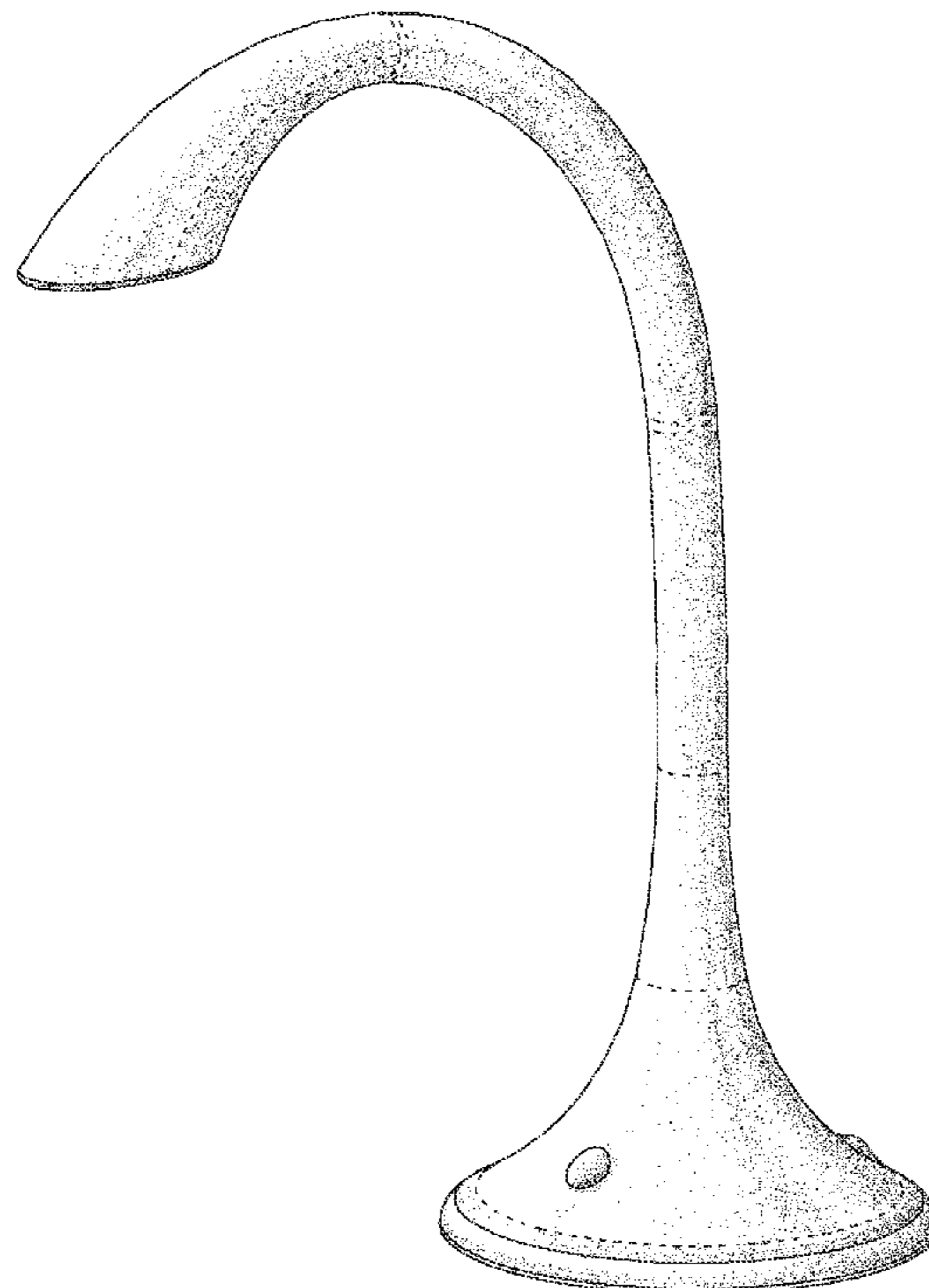
FIG. 4 is a left side elevational view thereof, the right side view thereof being a mirror image of that shown;

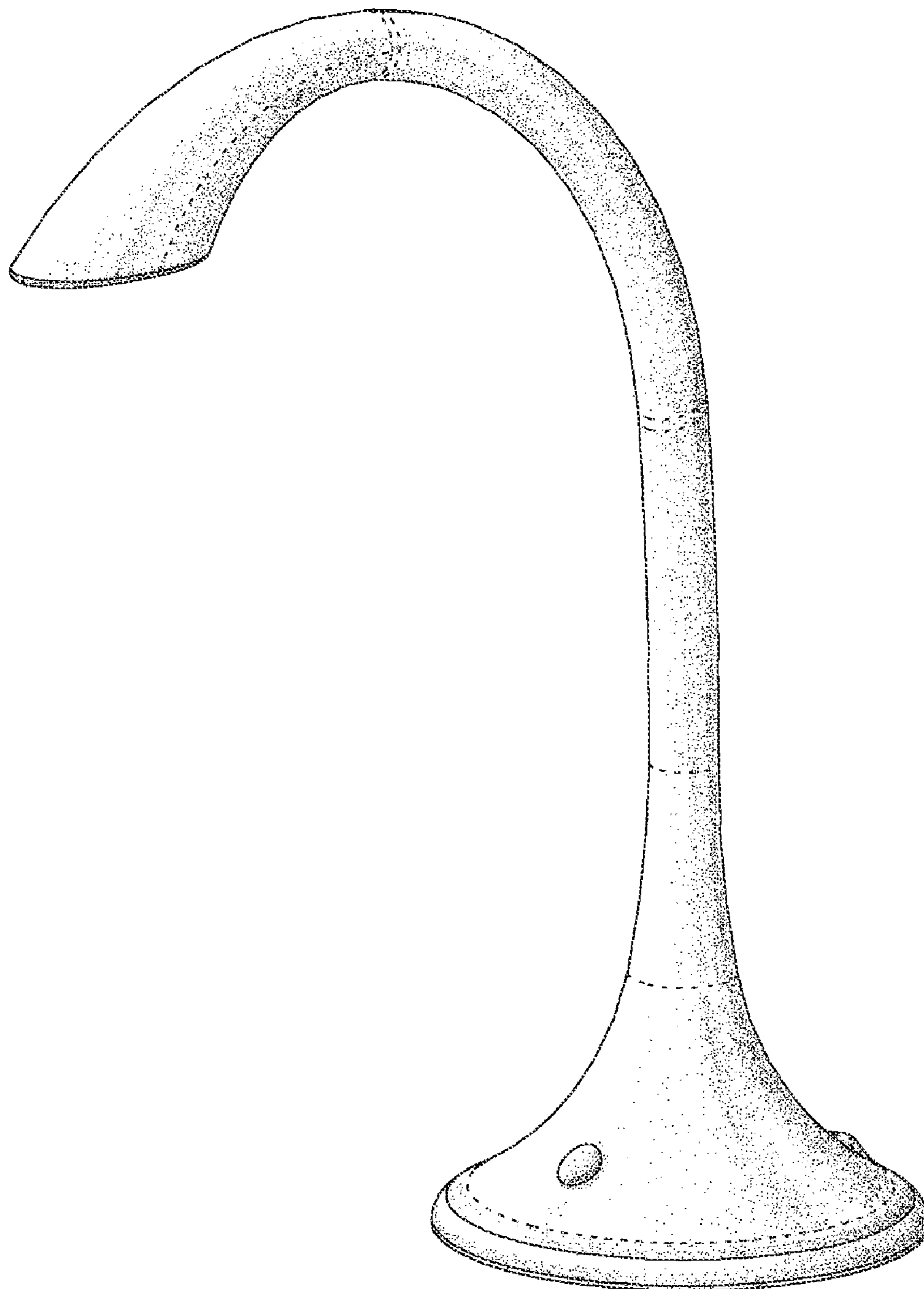
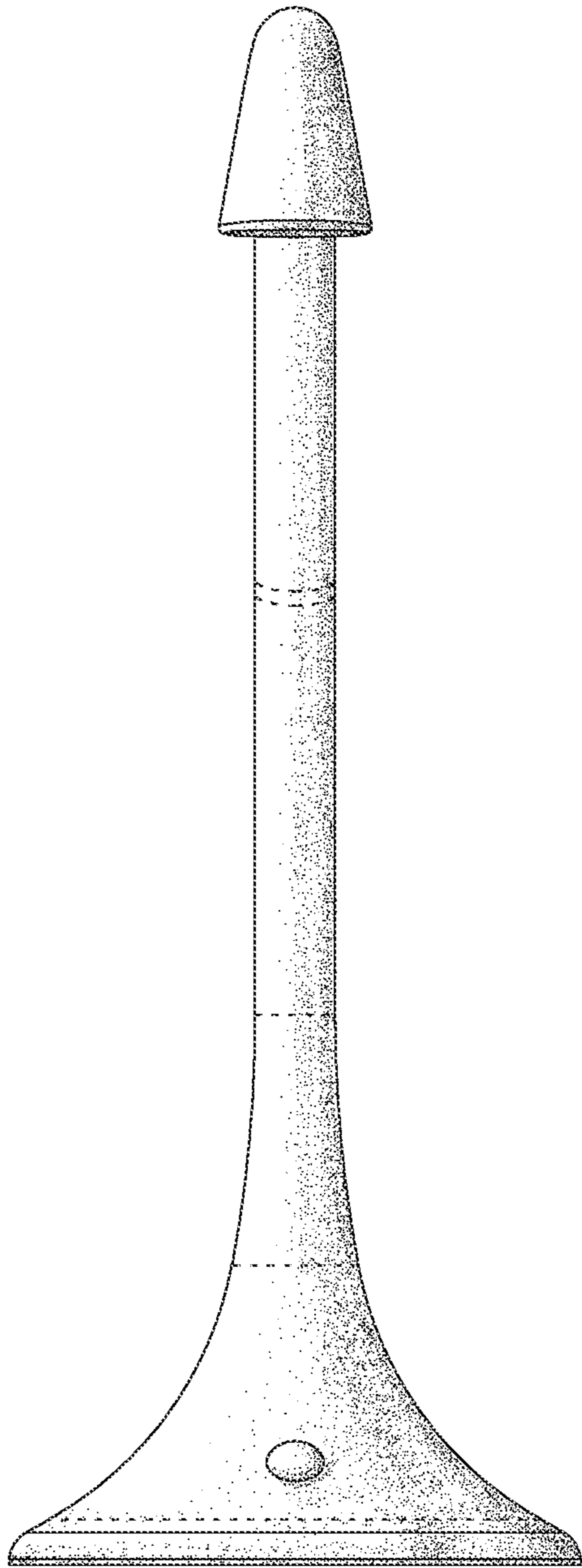
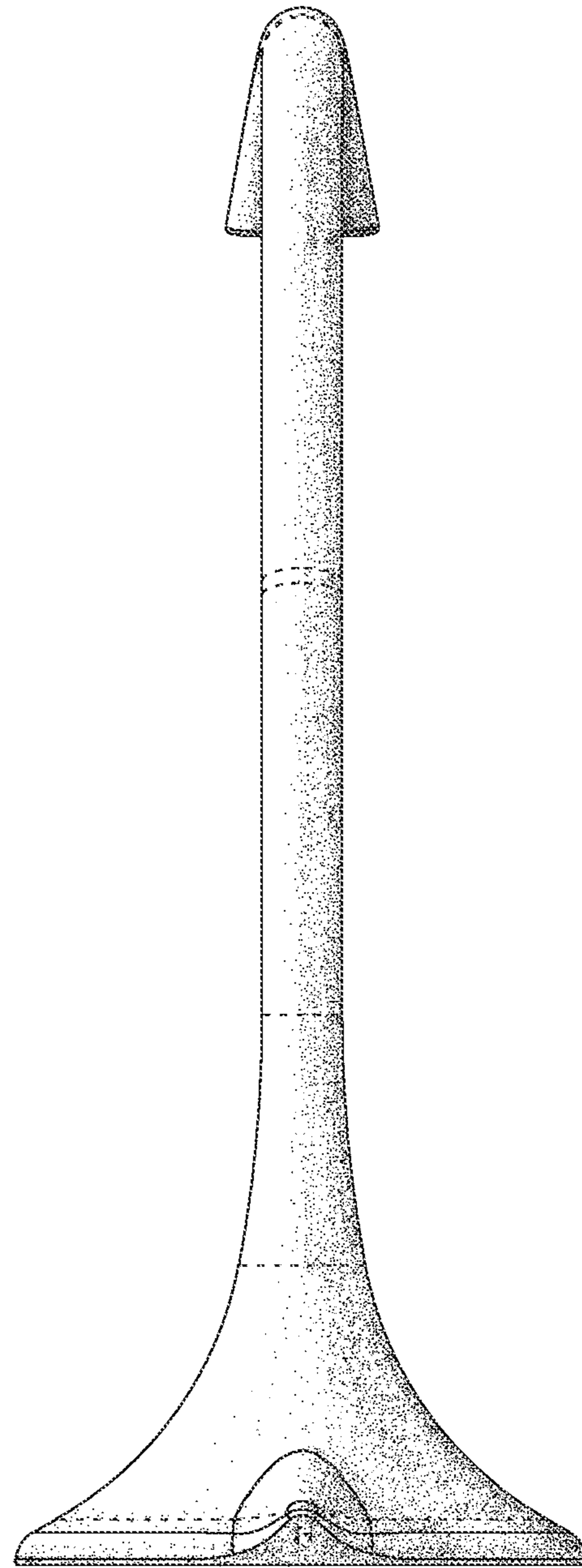

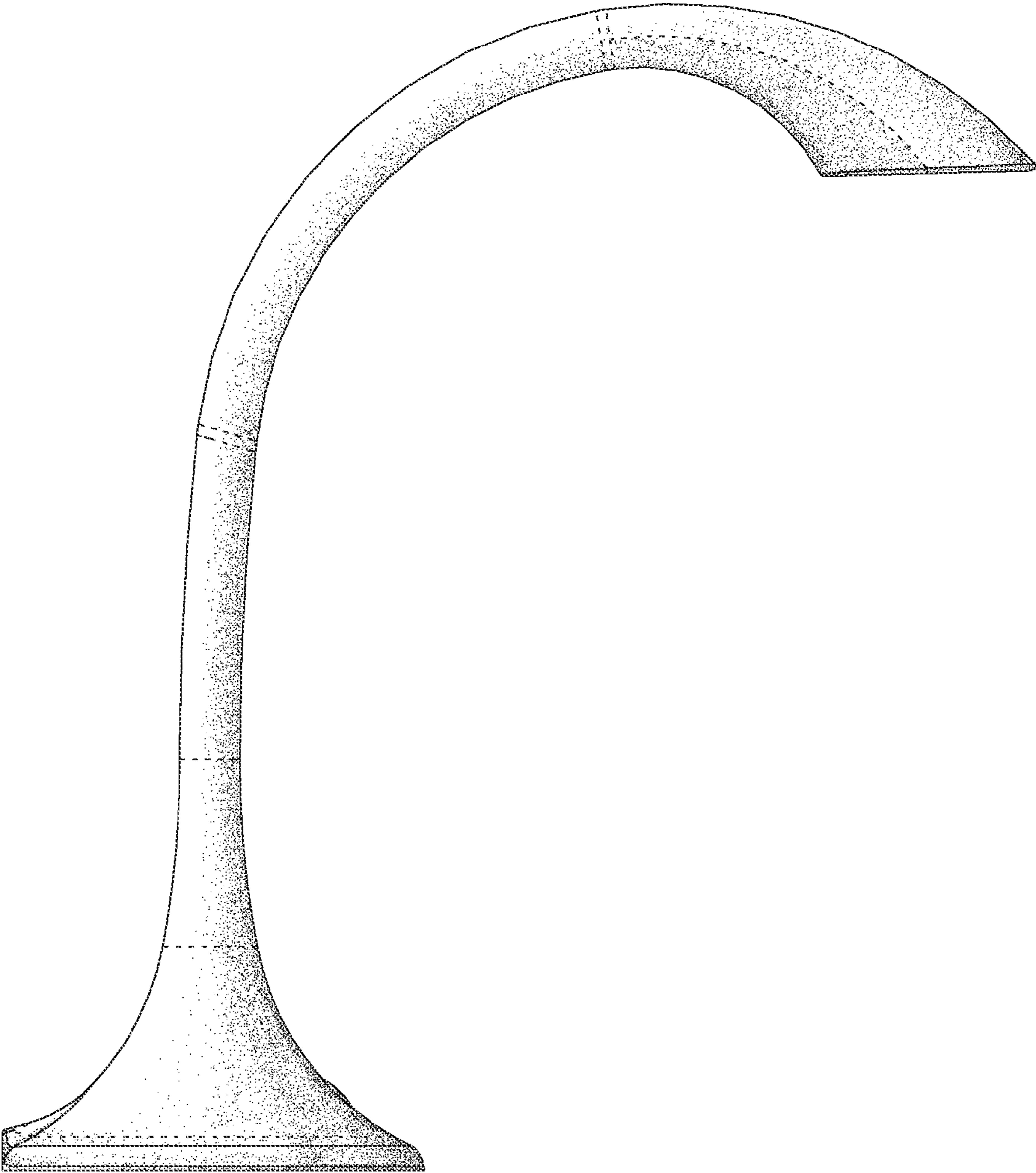
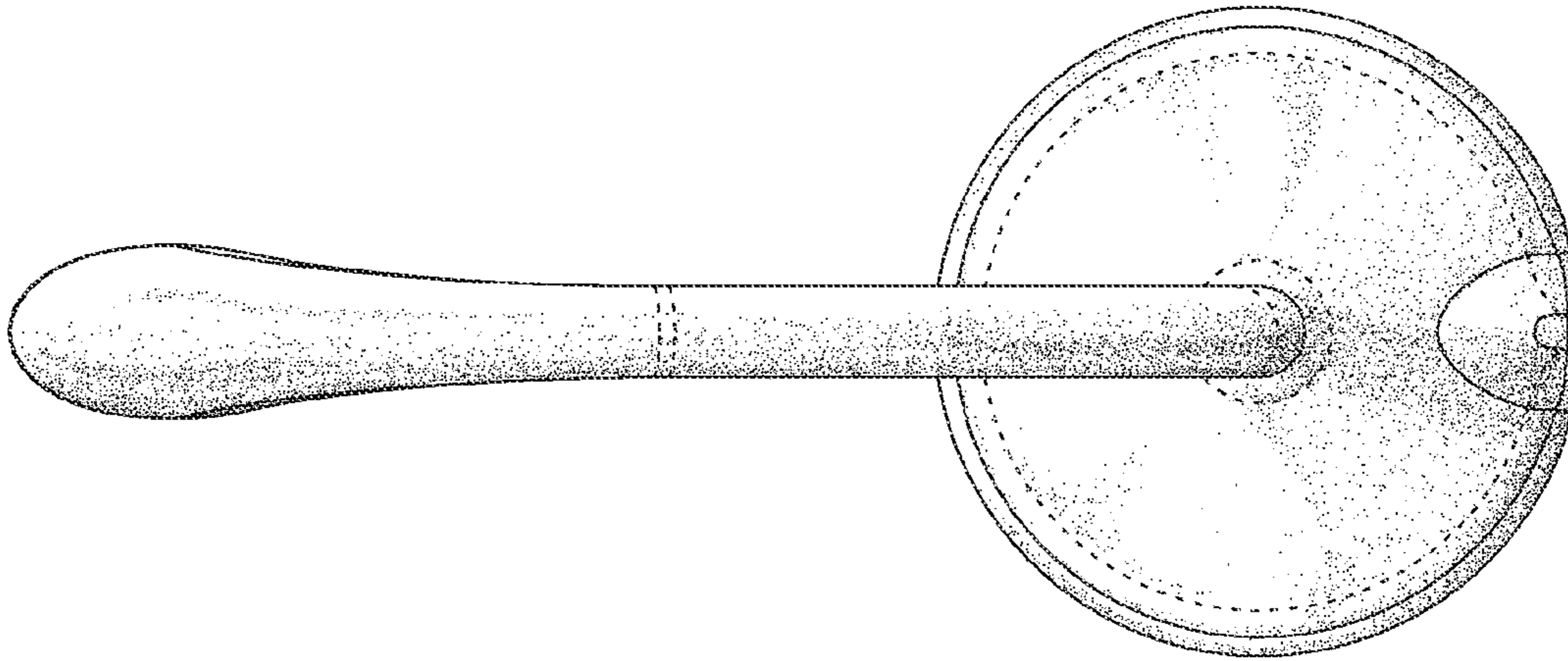
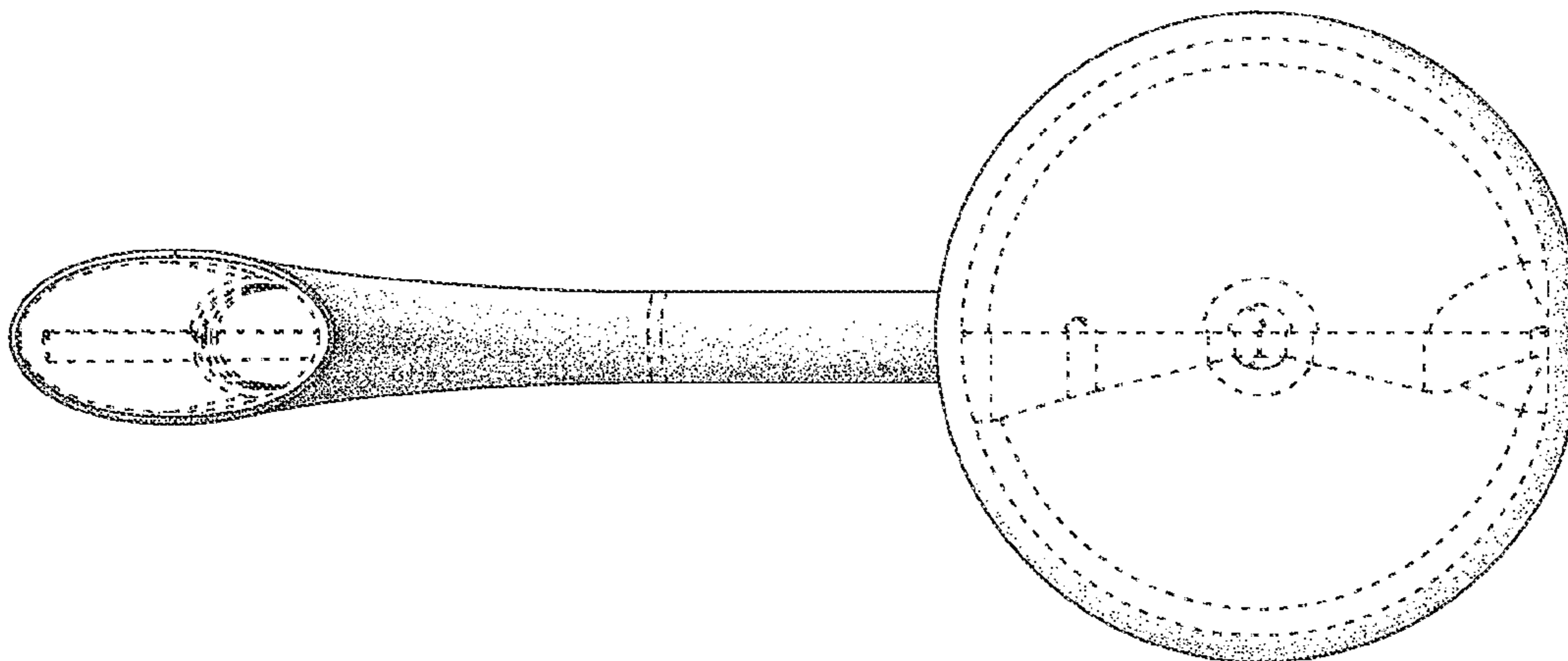
