DESCRIPTION

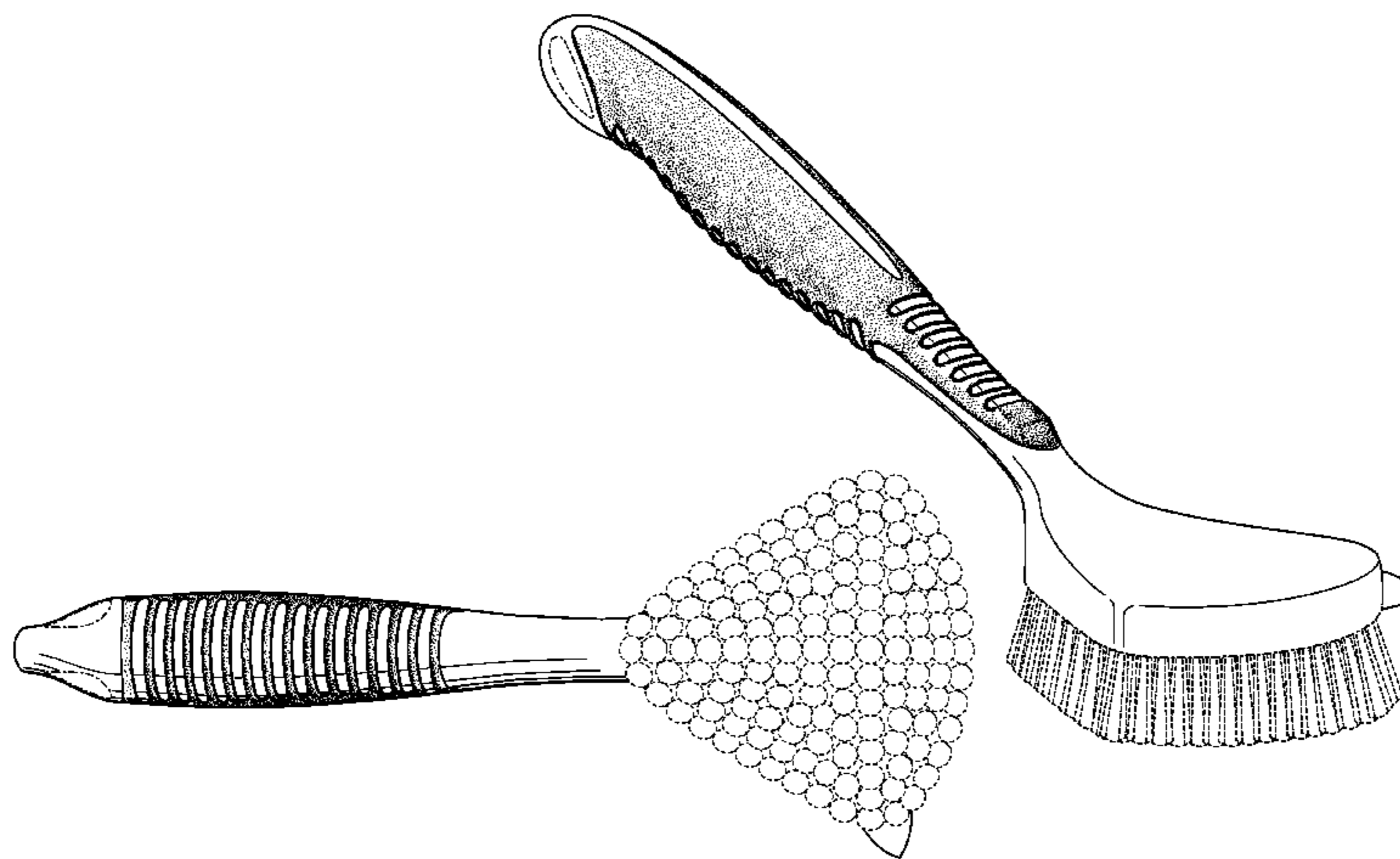
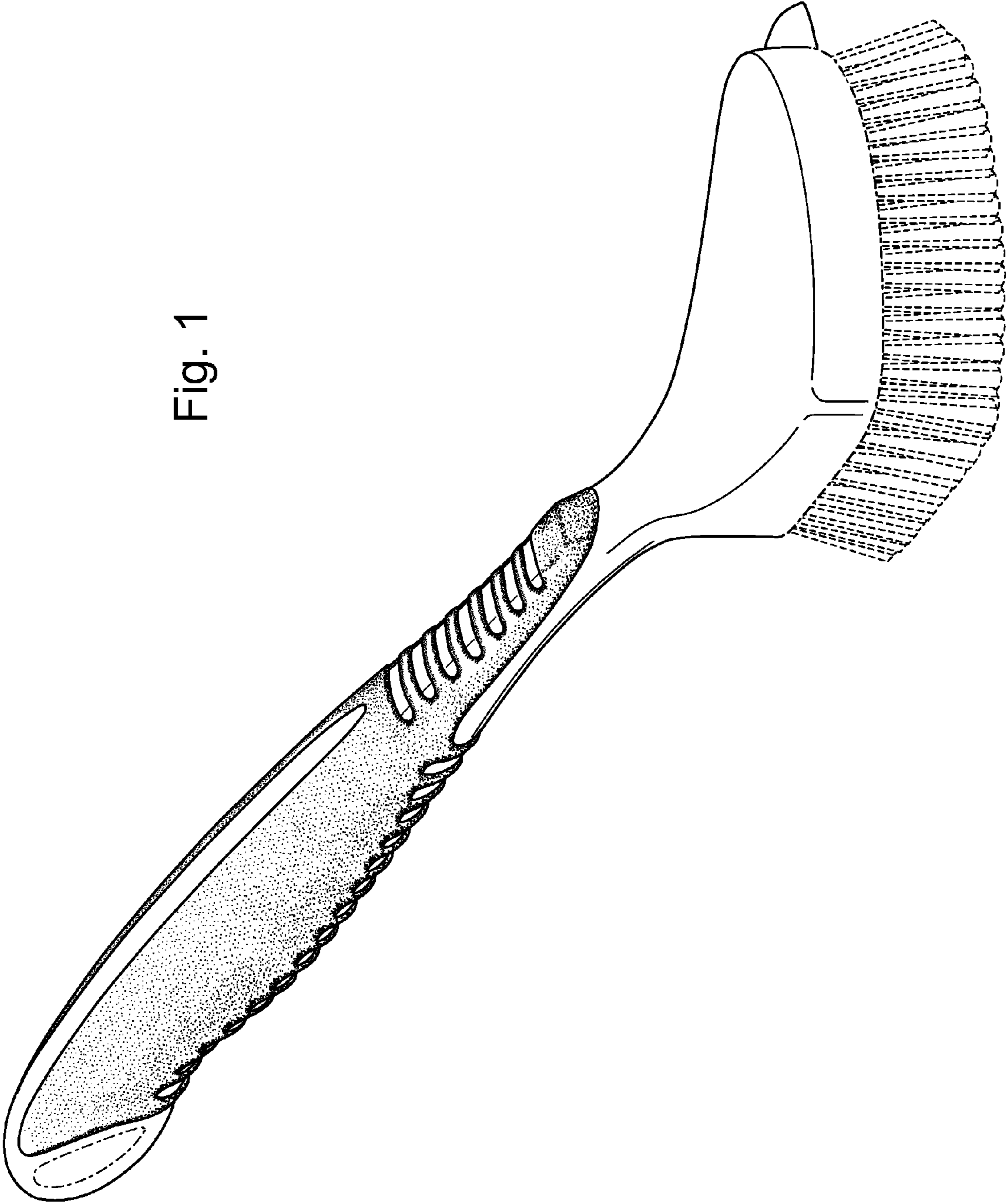

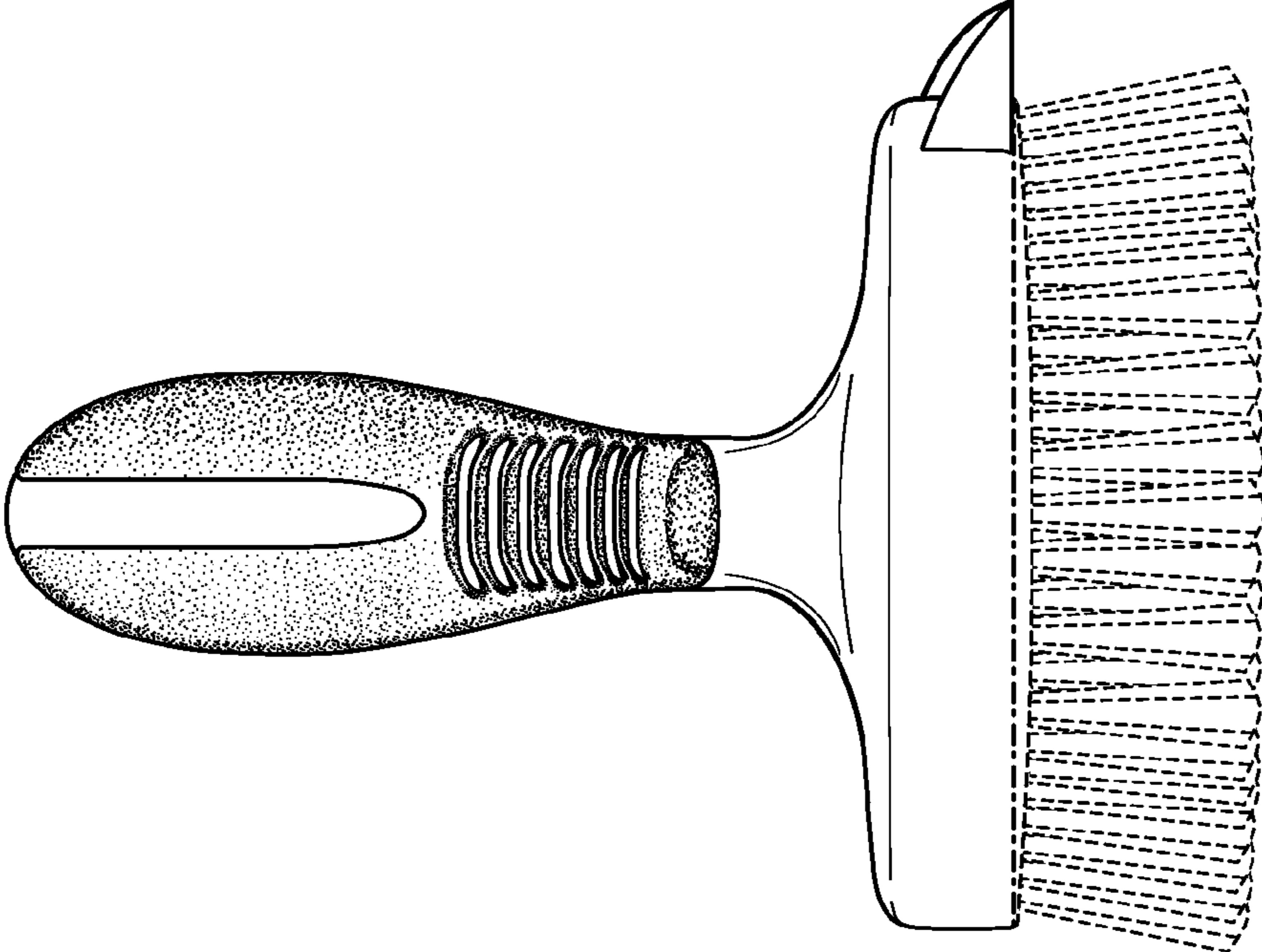
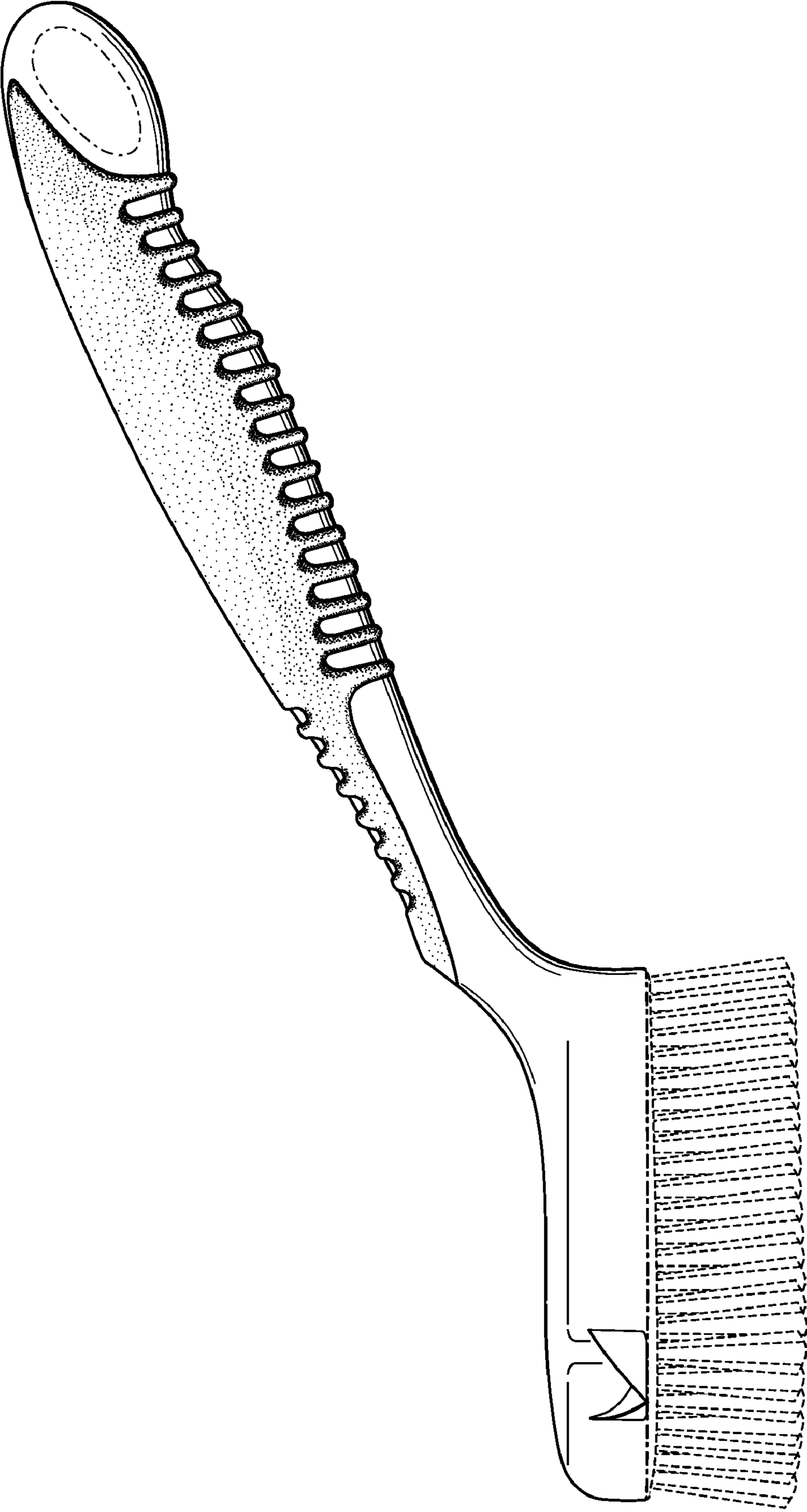

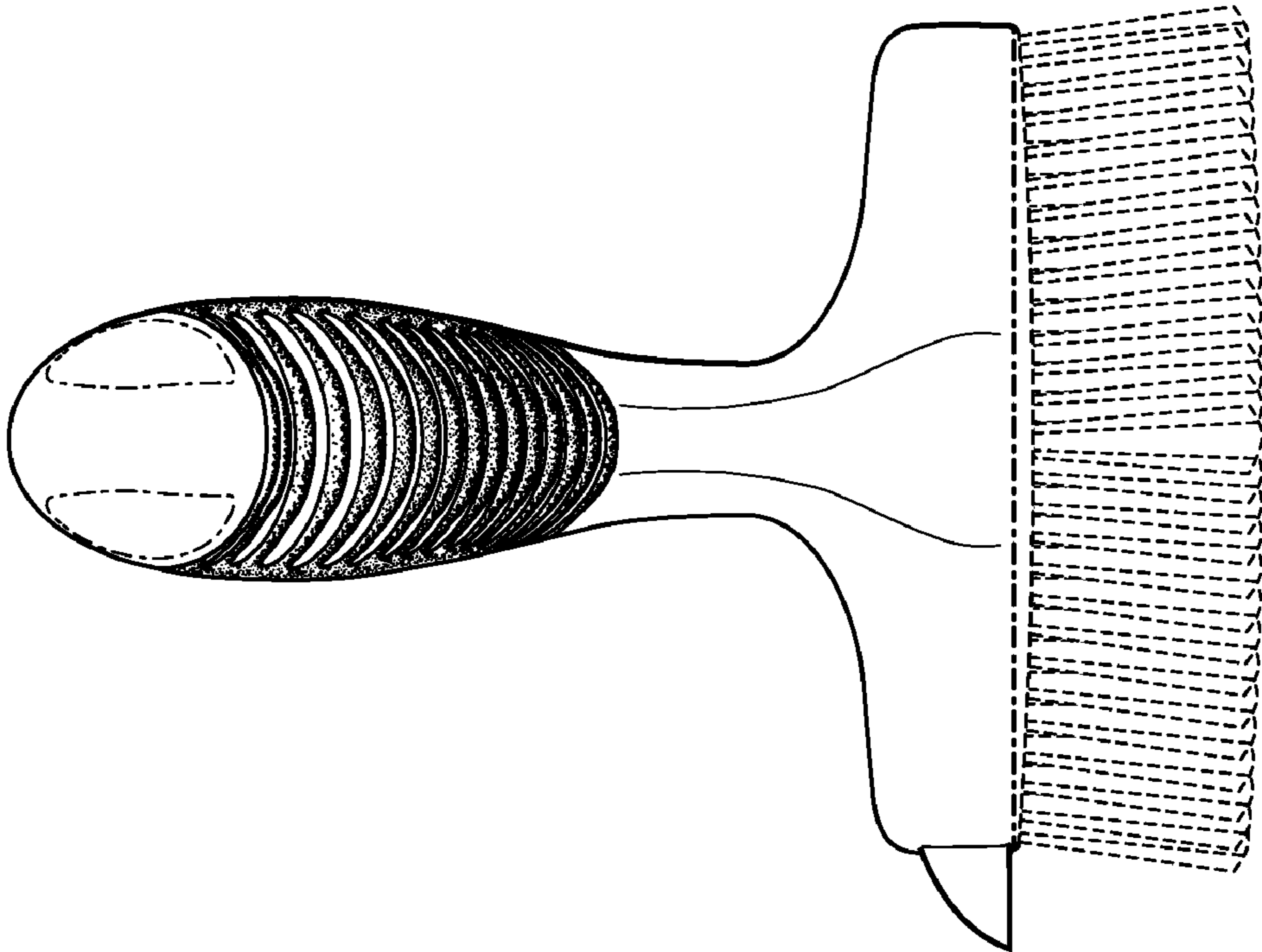

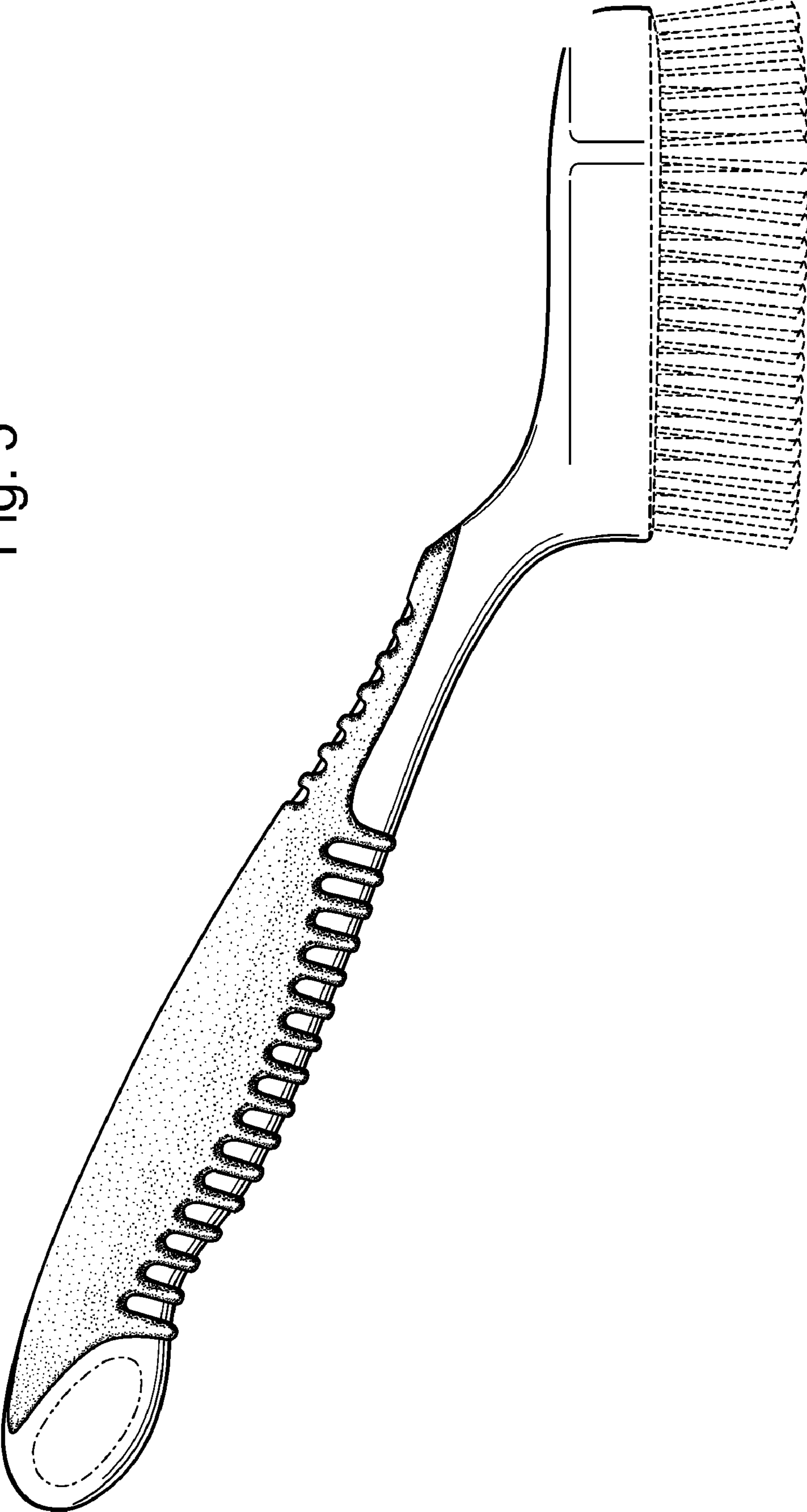
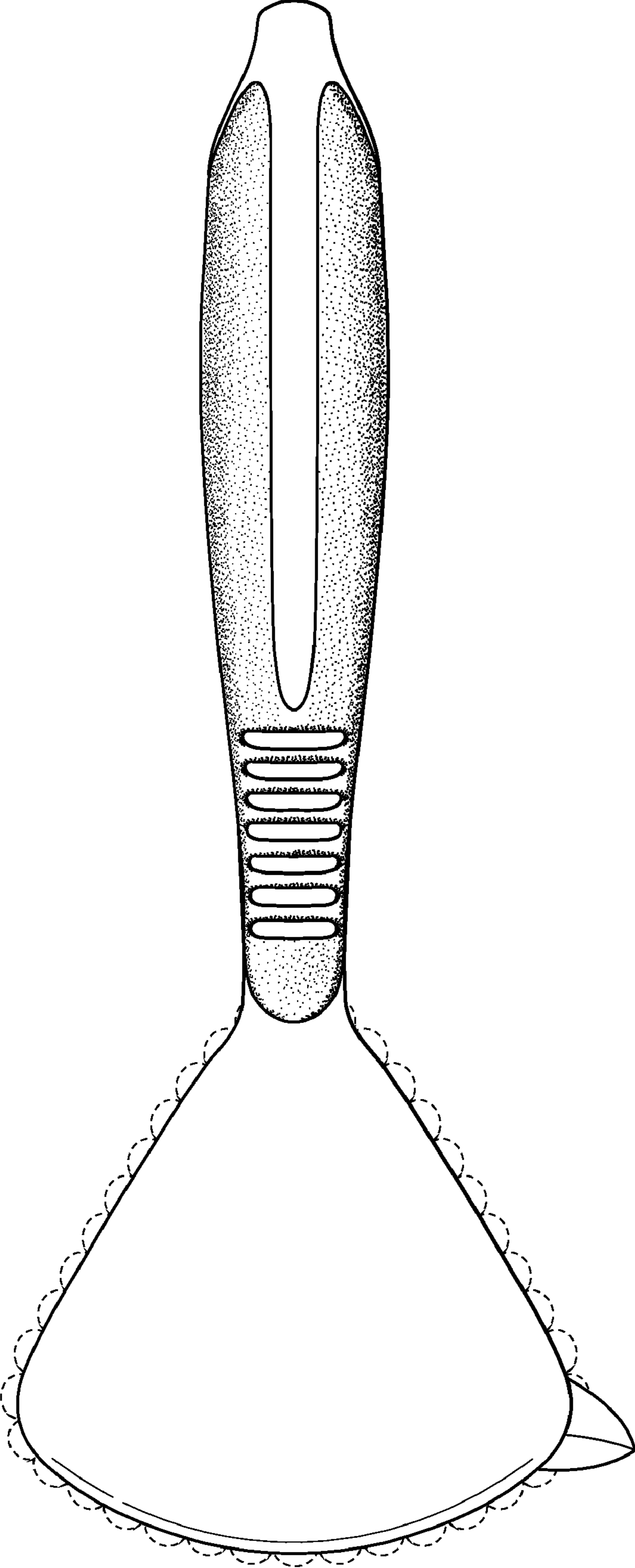

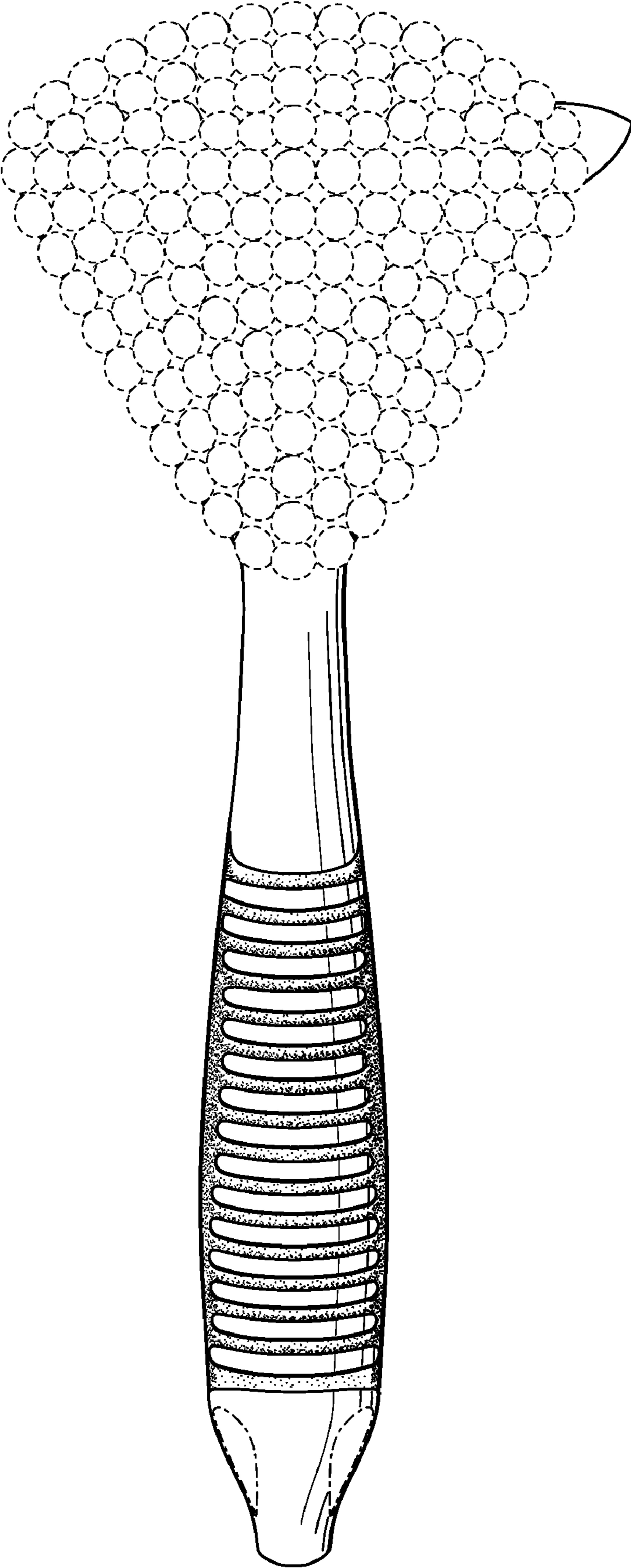
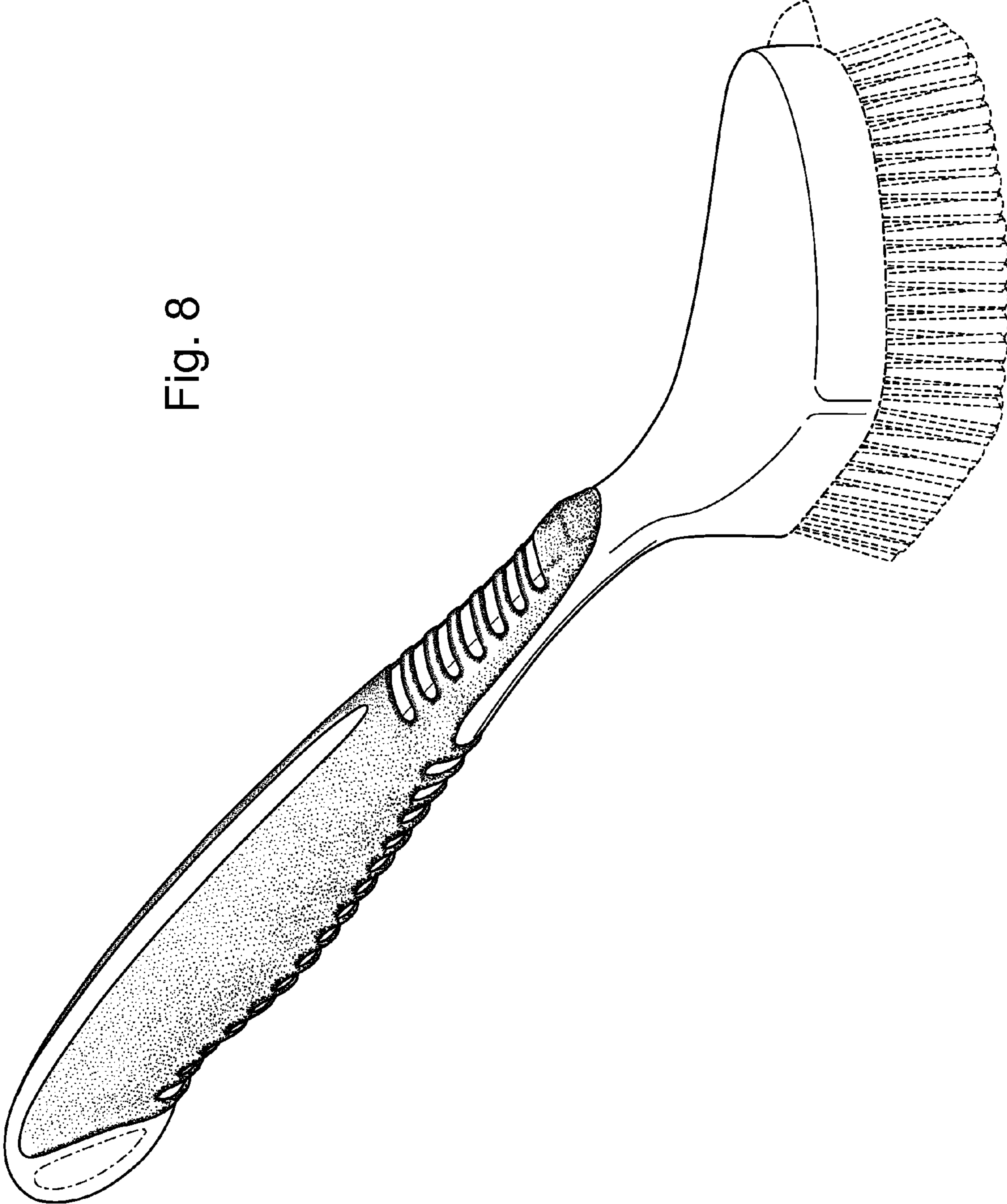

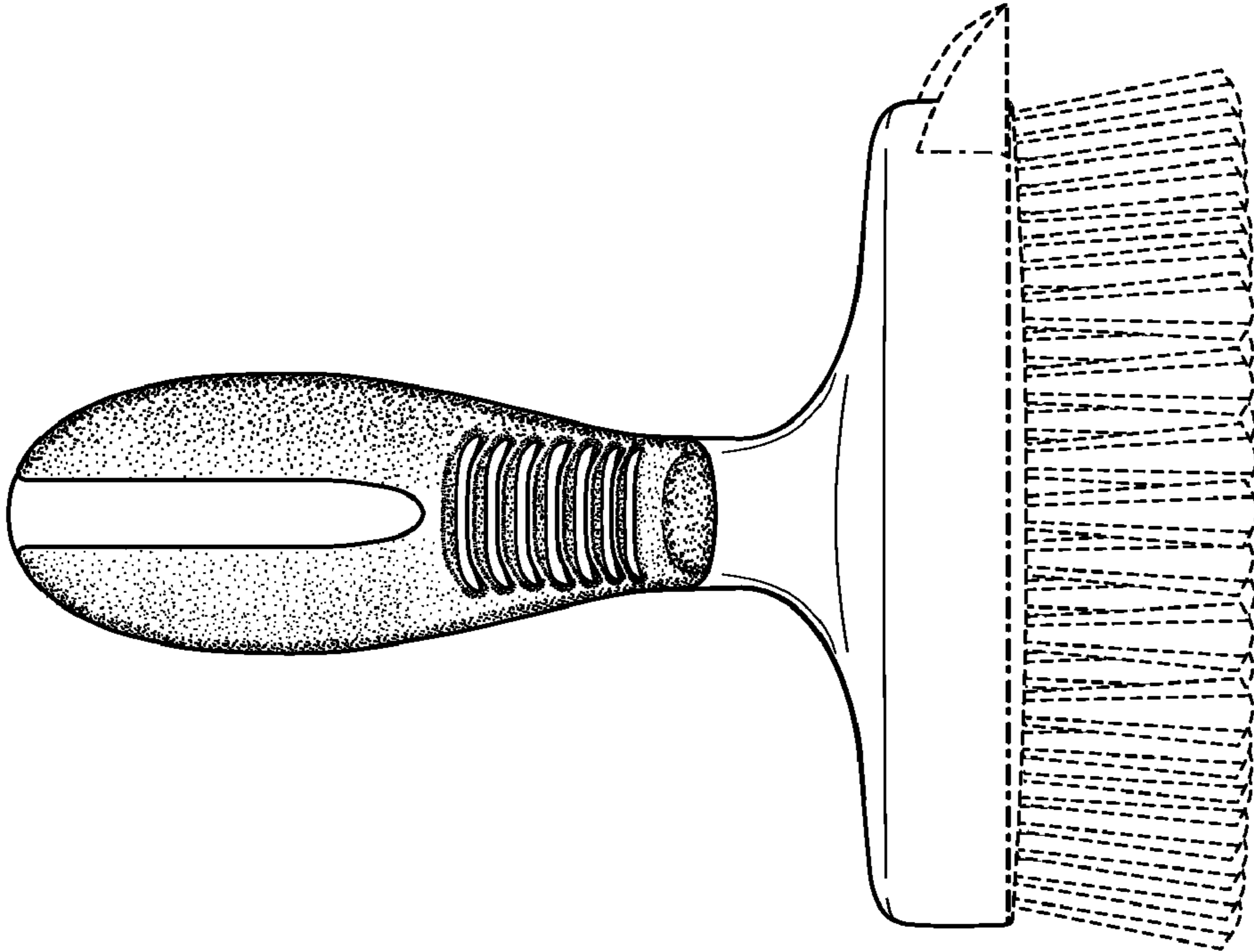
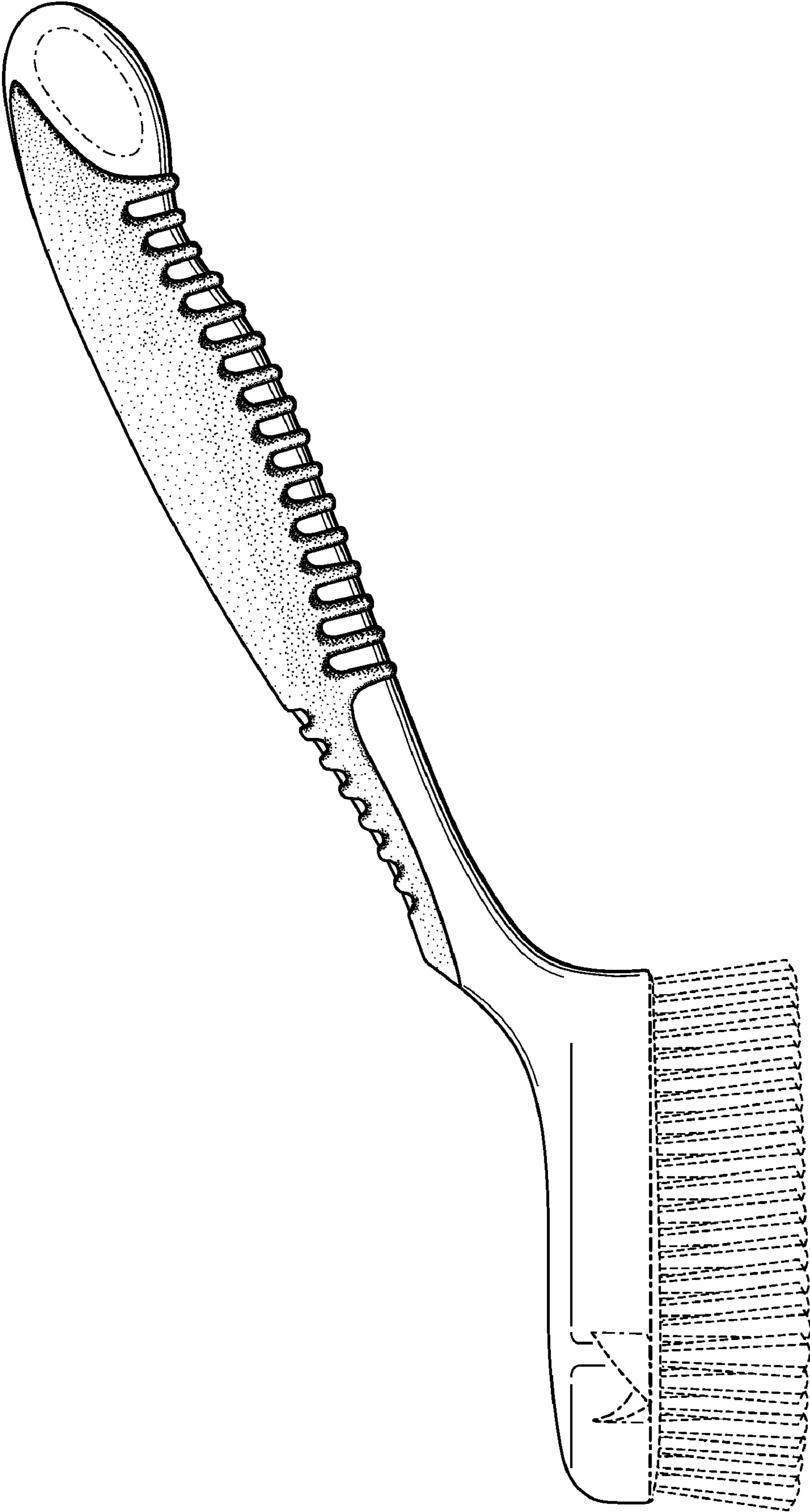

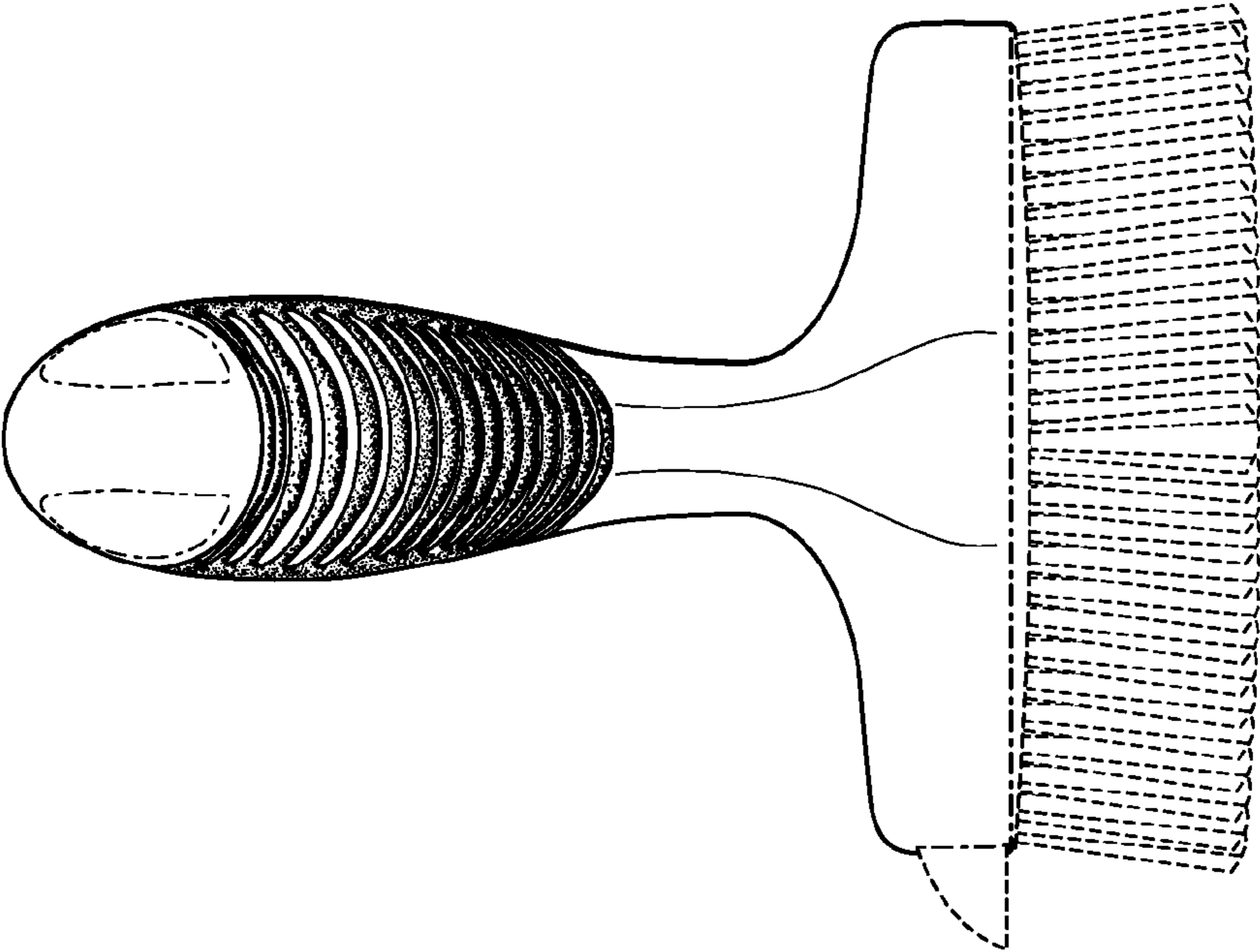

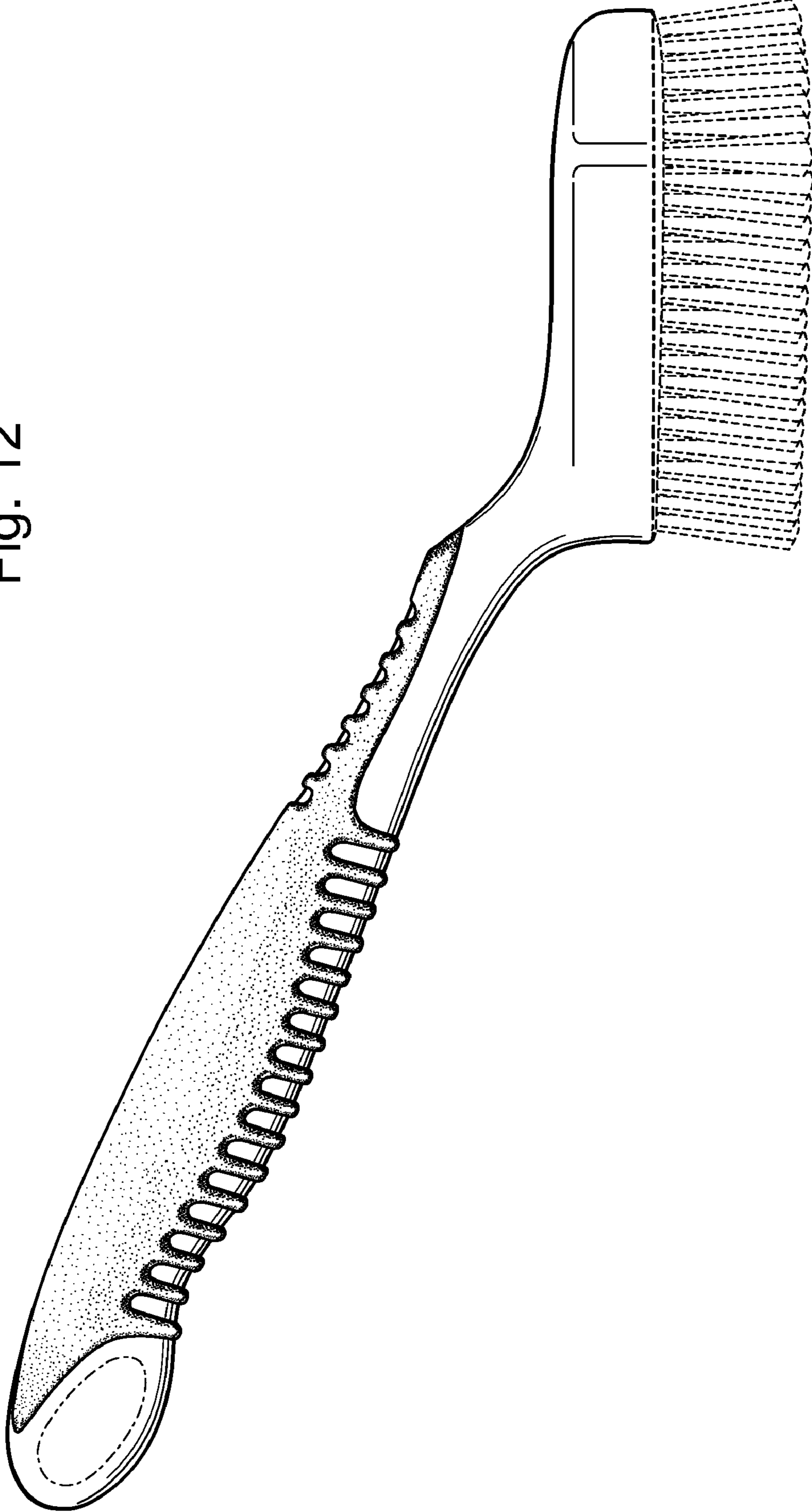
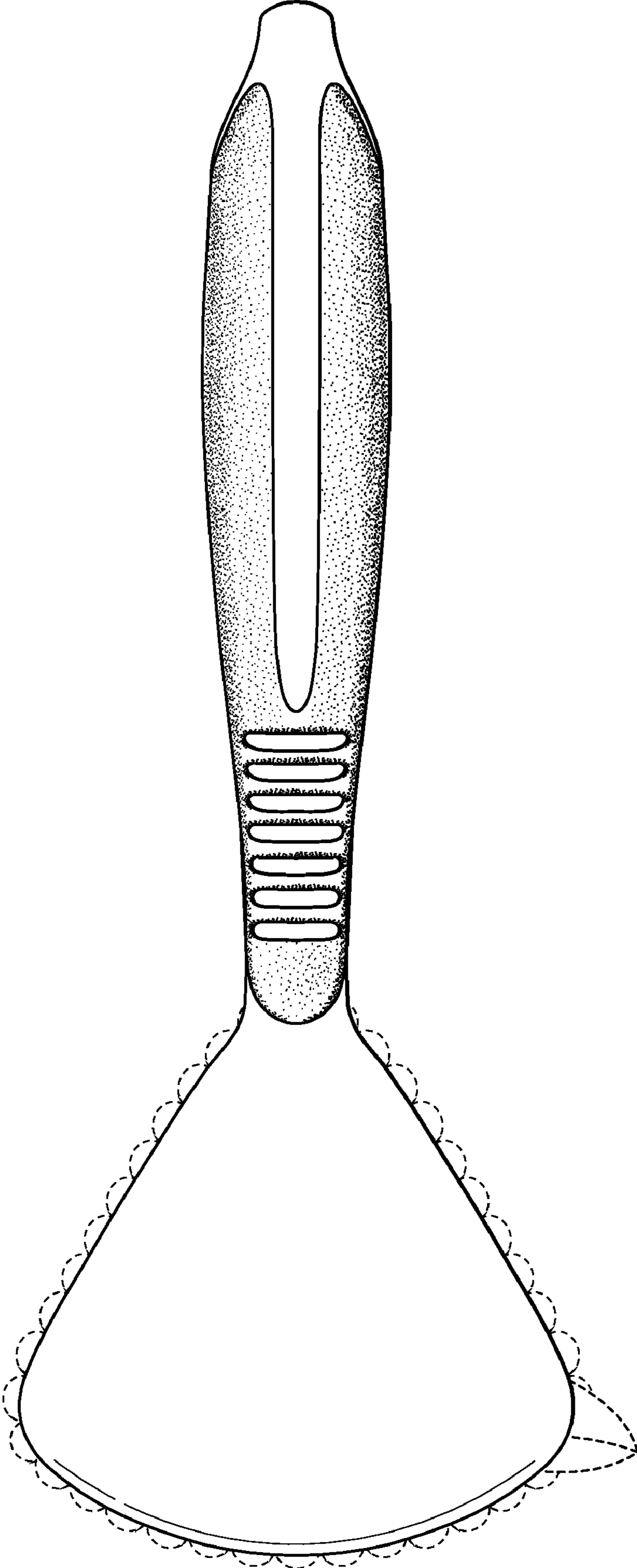

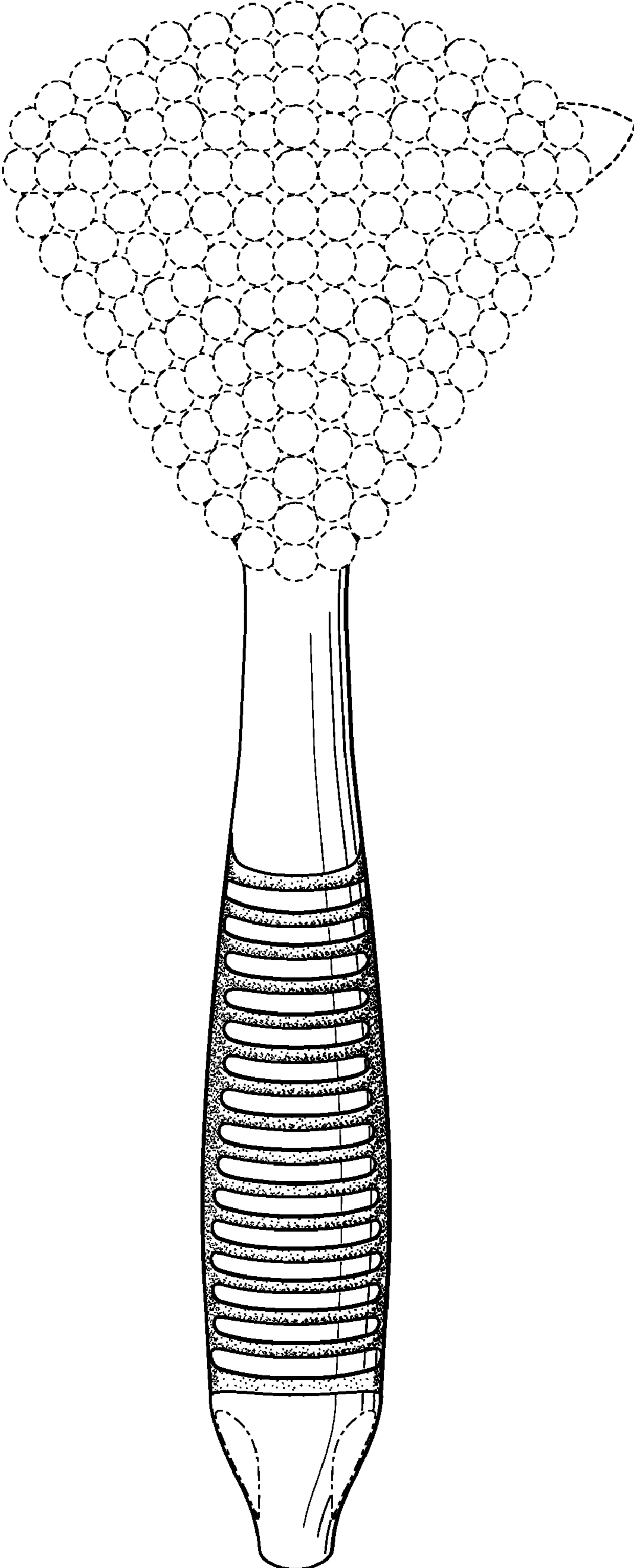
