FIG. 3 is another reduced perspective view thereof shown in an alternate environment of use; the broken lines in the drawing represent unclaimed environmental matter.

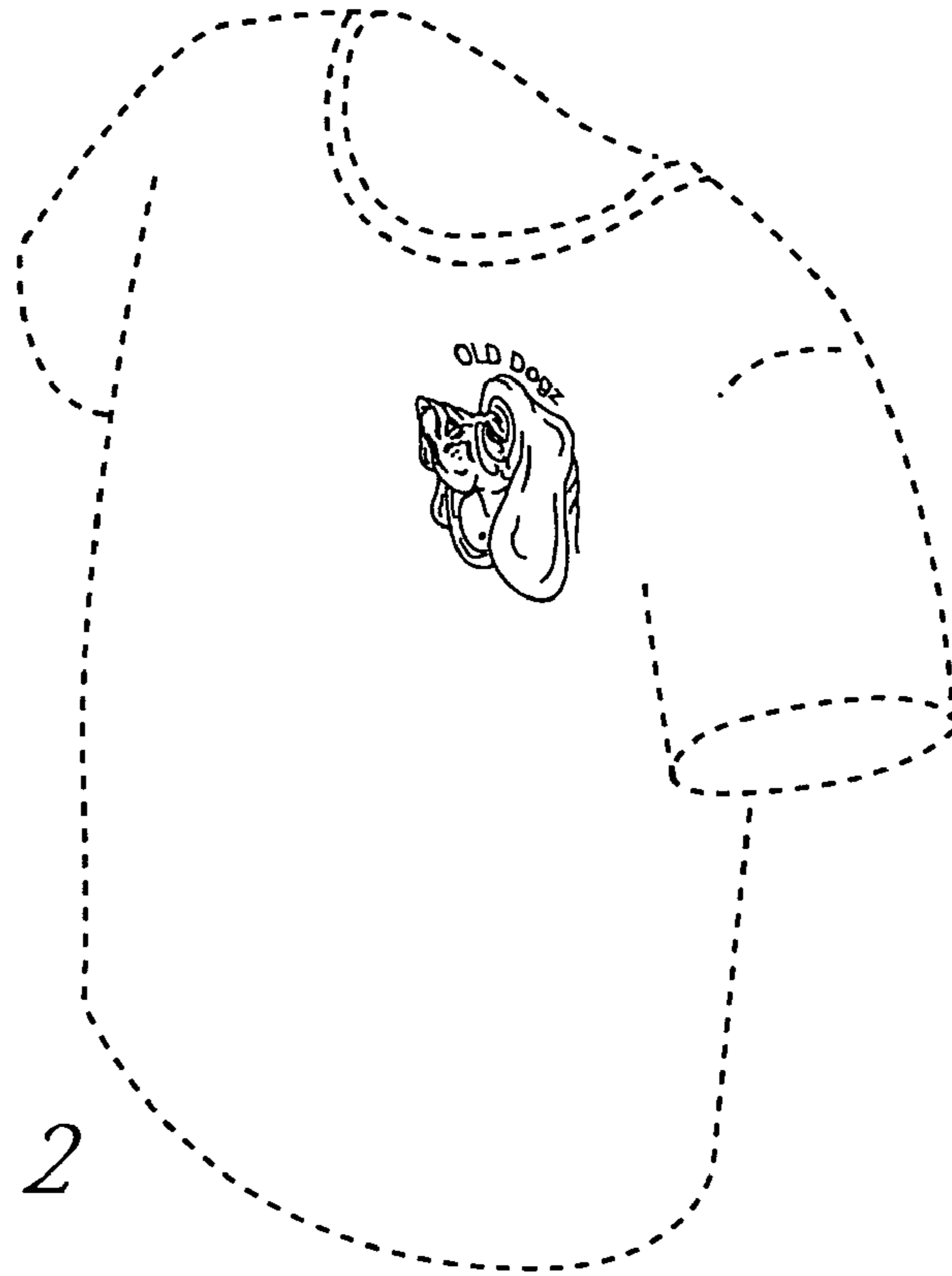

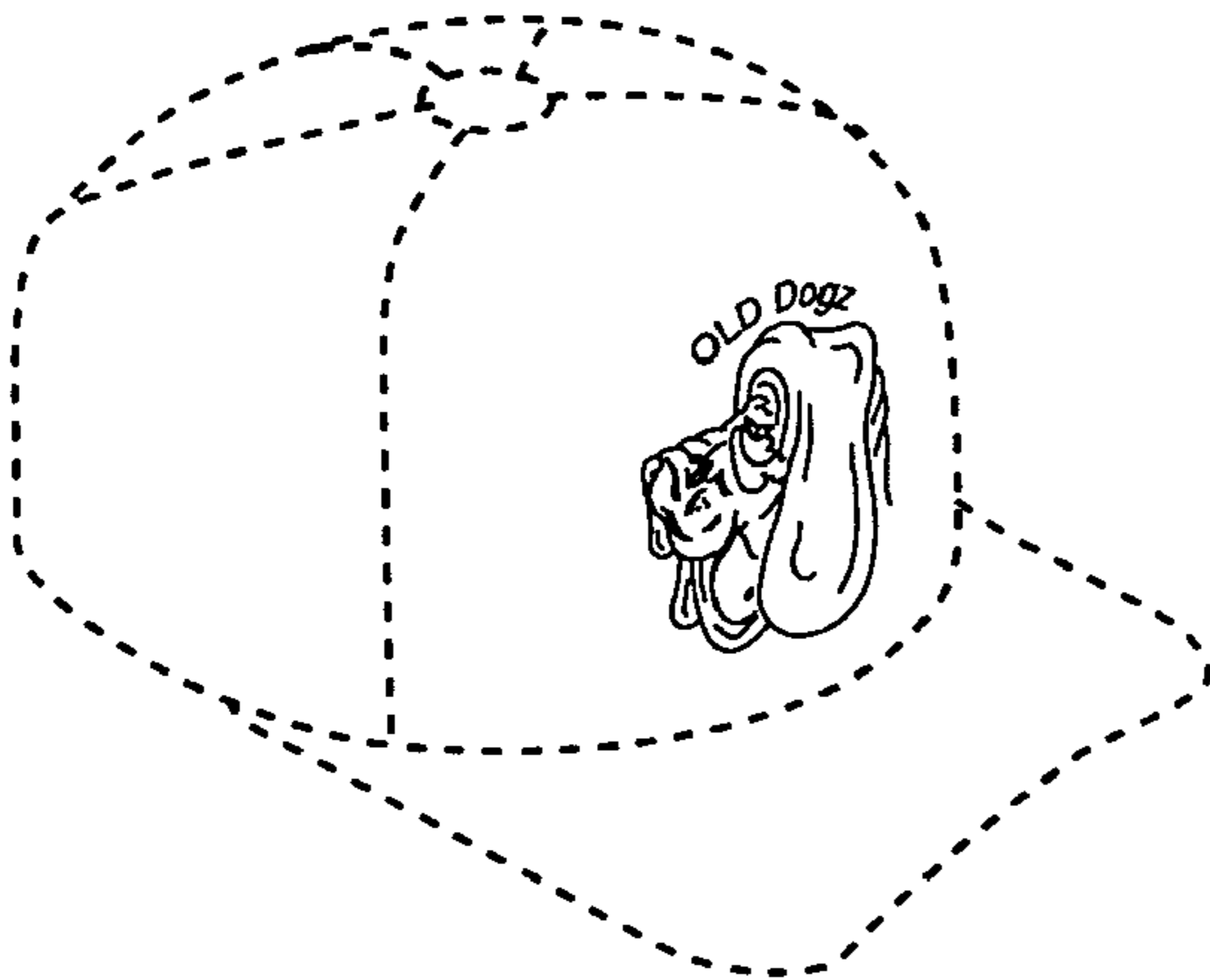
