DESCRIPTION

FIG. 1 is a top left side perspective view of a beverage container showing my new design;

FIG. 4 is a right side elevational view thereof;

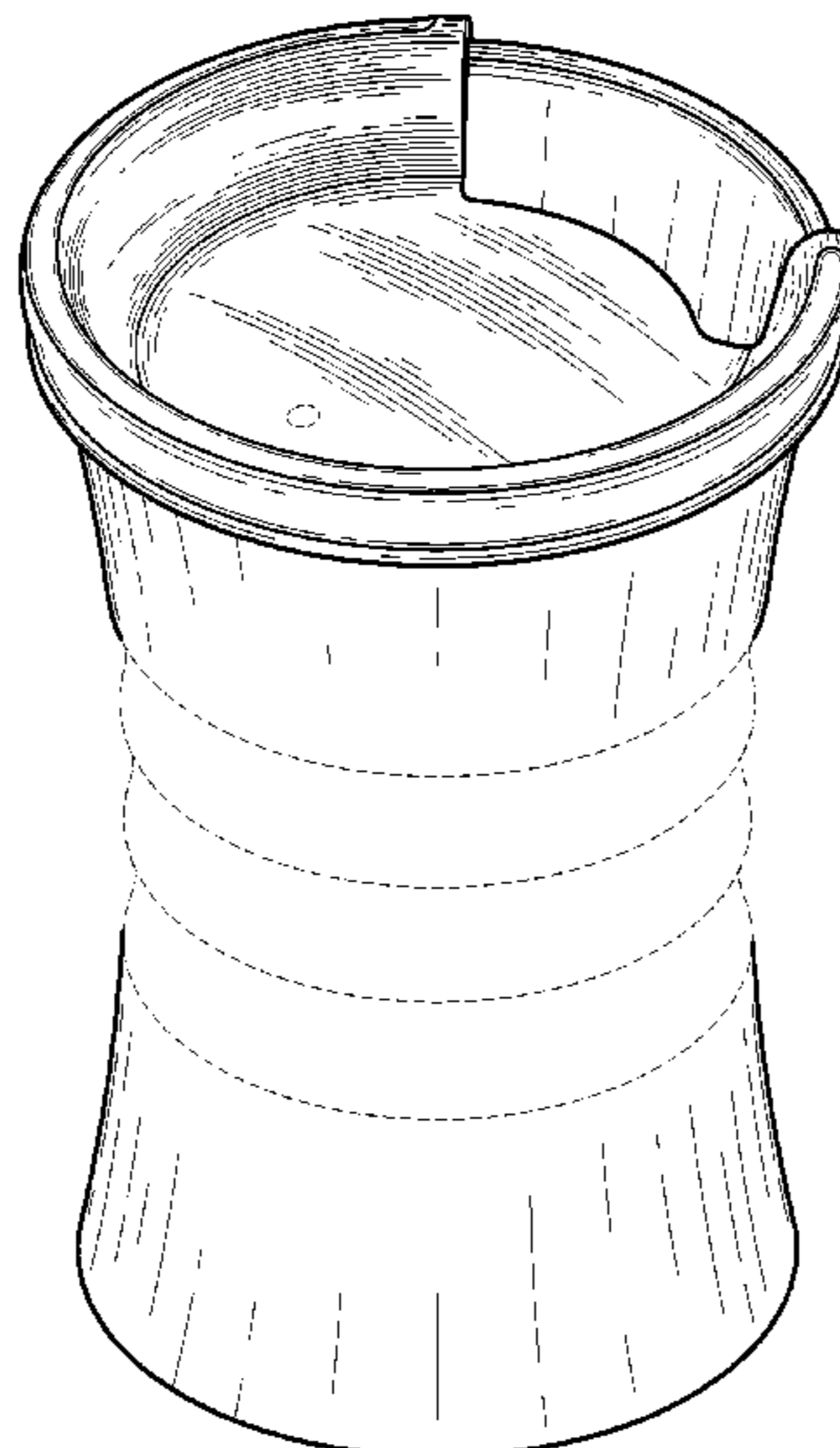
FIG. 5 is a left side elevational view thereof;

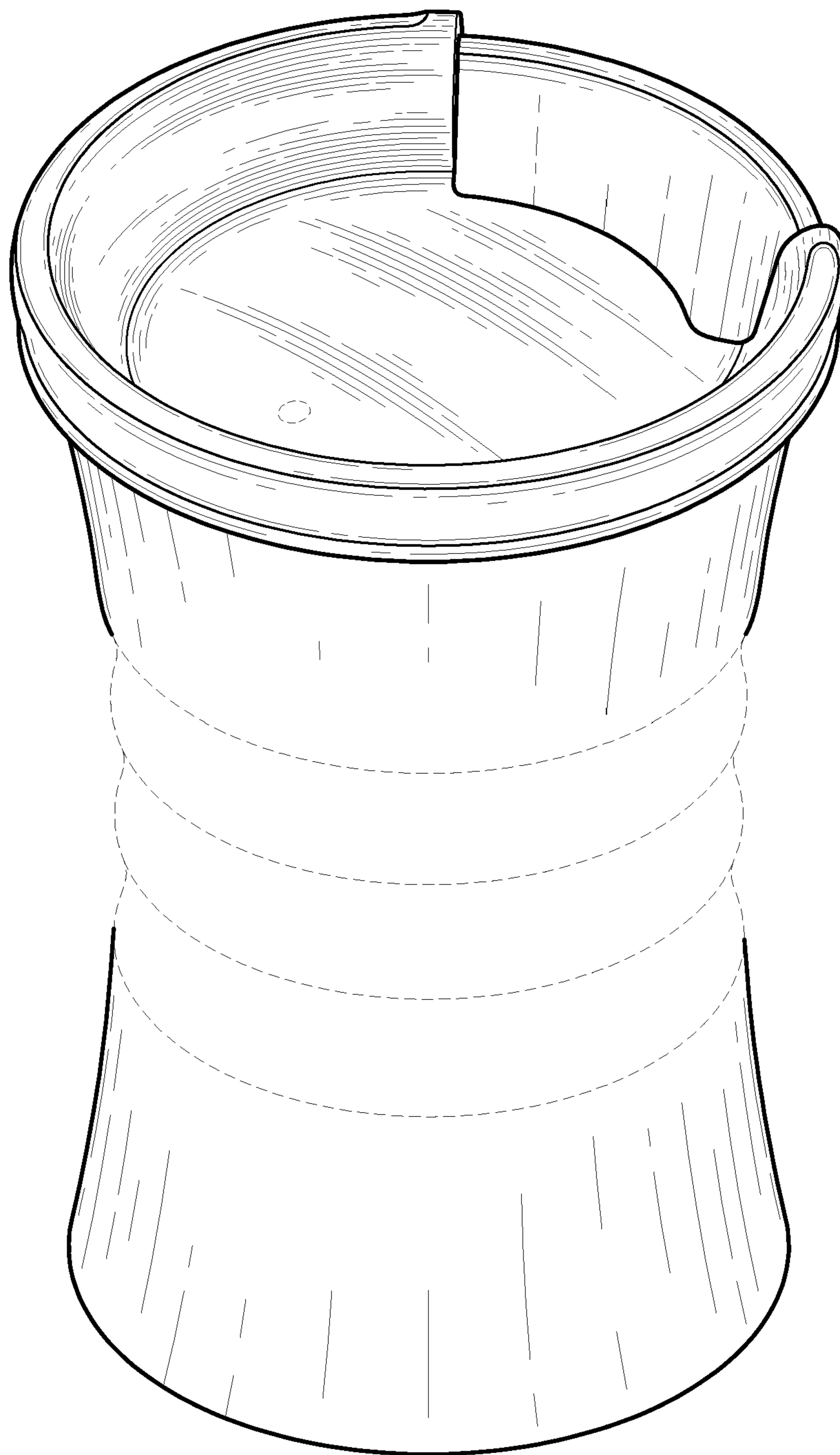

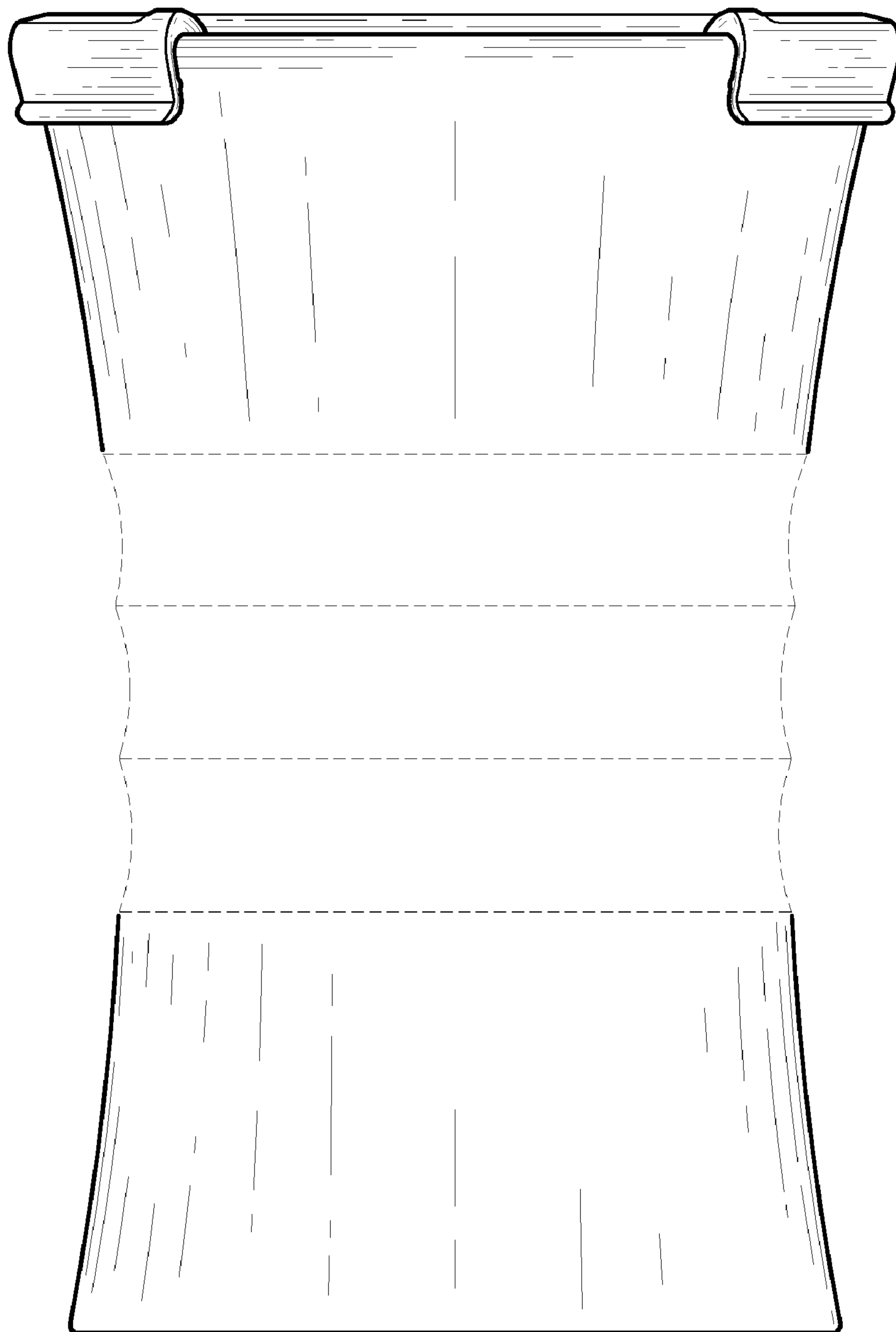

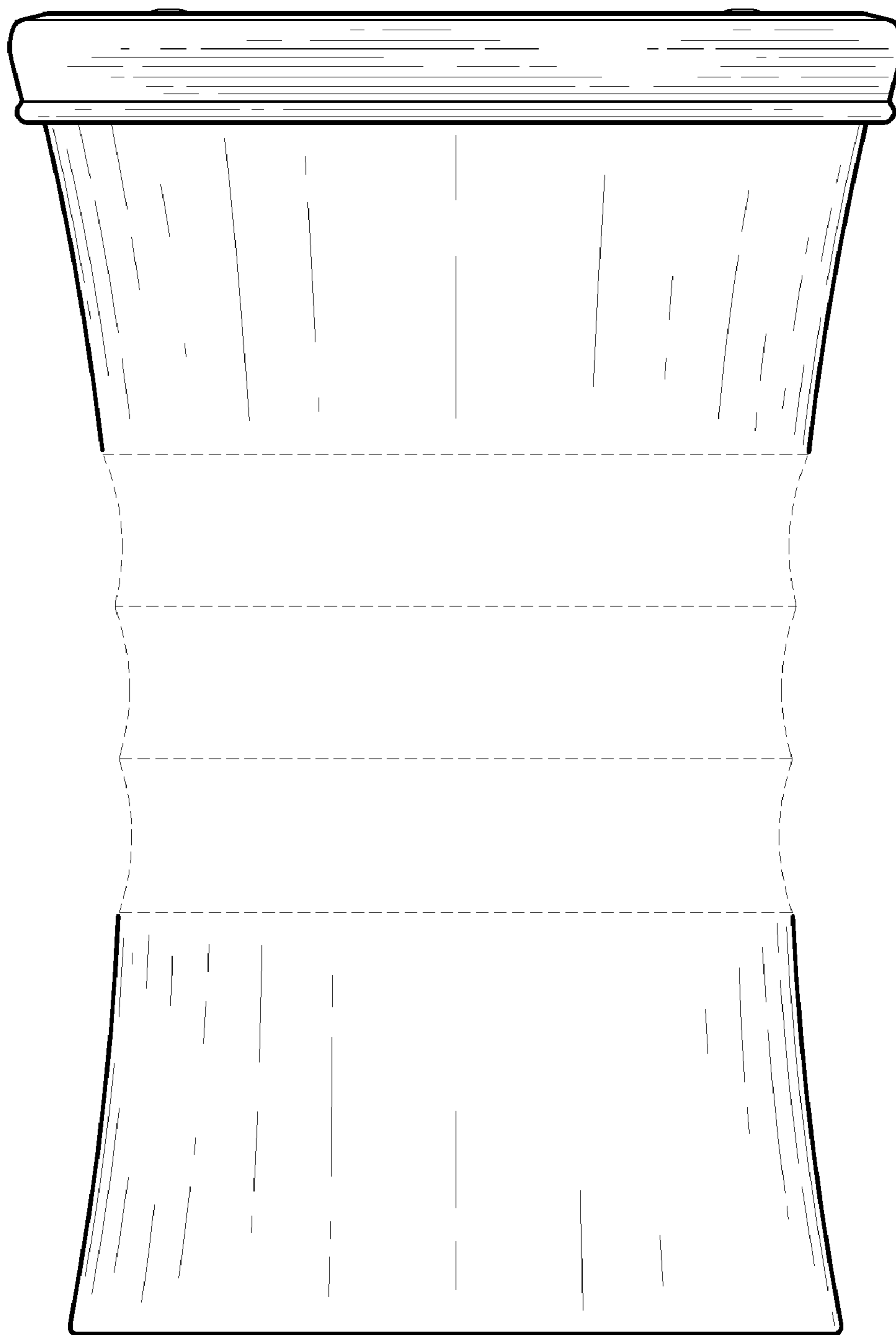

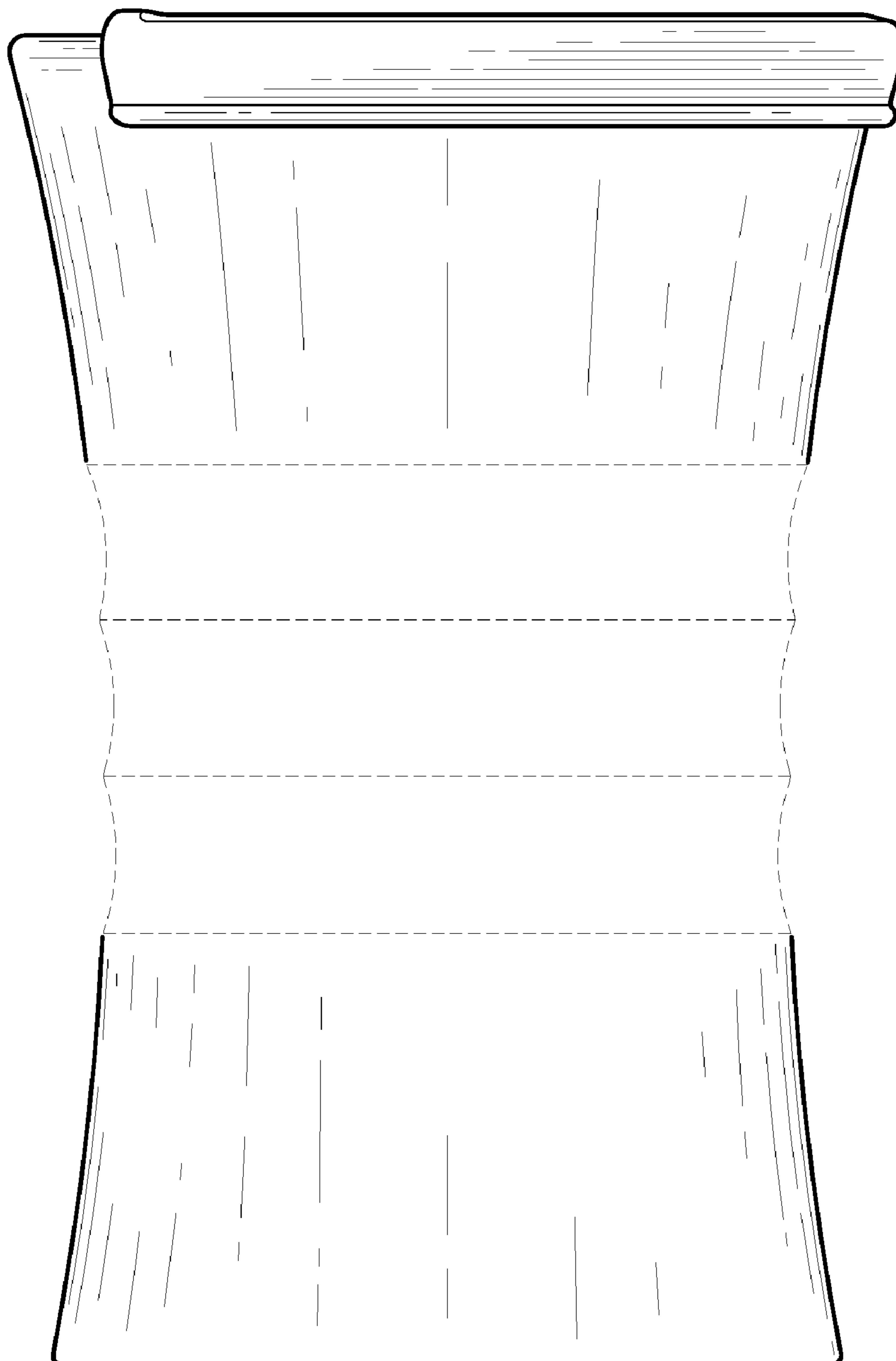

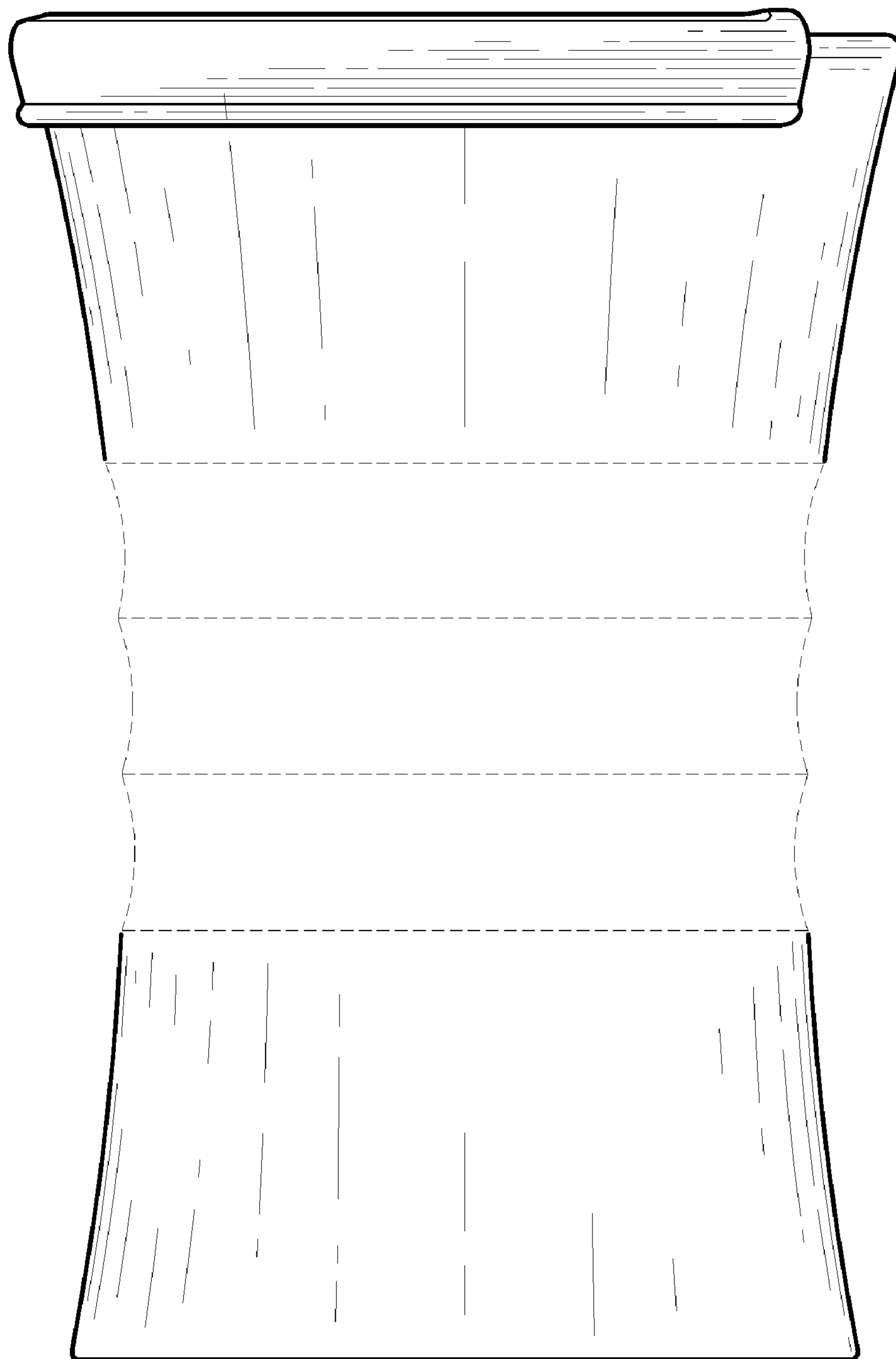

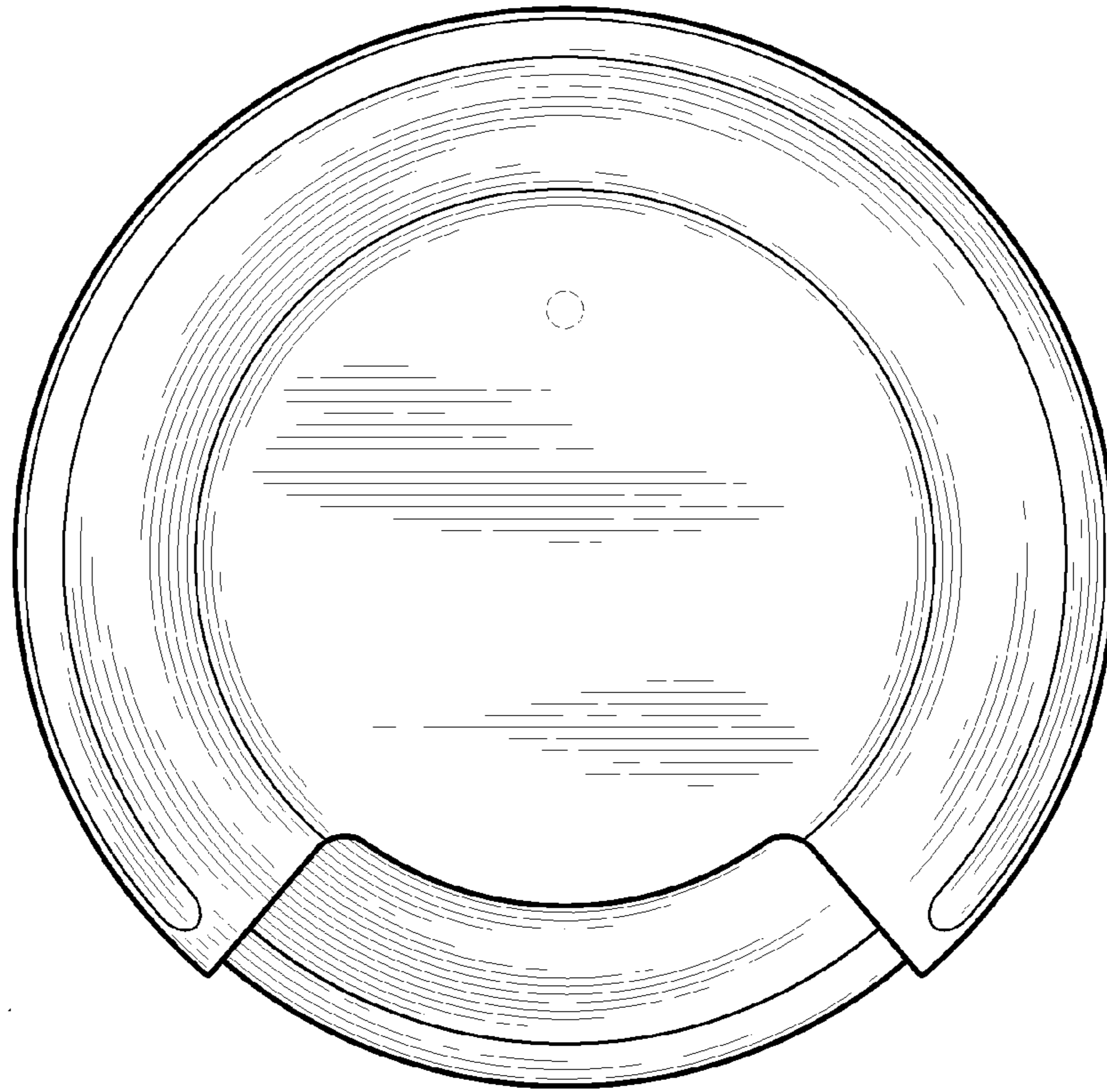

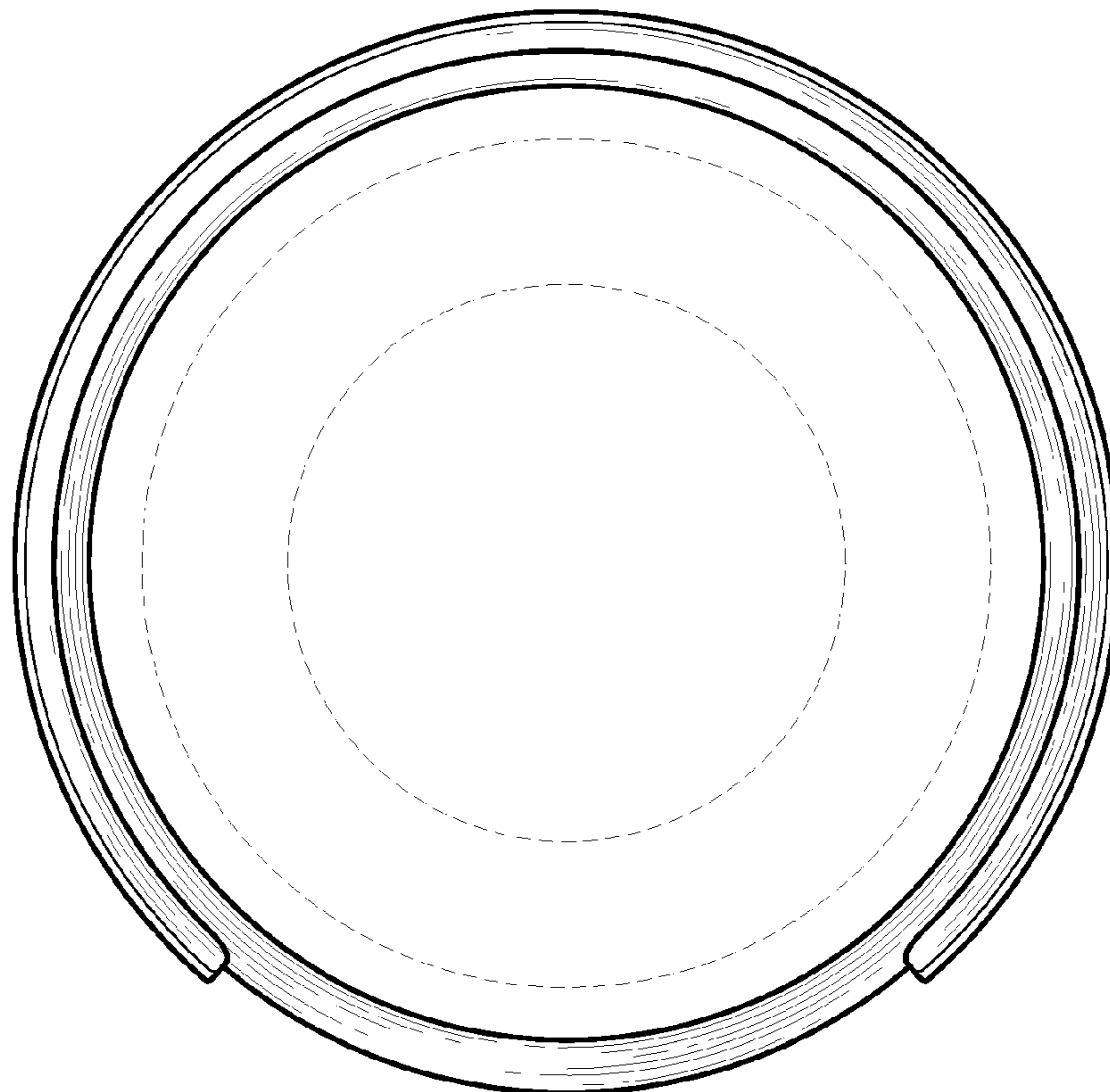
