(57) **CLAIM**

The ornamental design for a angle cut screw-in adjustable head ground spike, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of the angle cut screw-in adjustable head ground spike;

FIG. 2 is a back view of the angle cut screw-in adjustable head ground spike;

FIG. 3 is a left-side view of the angle cut screw-in adjustable head ground spike;

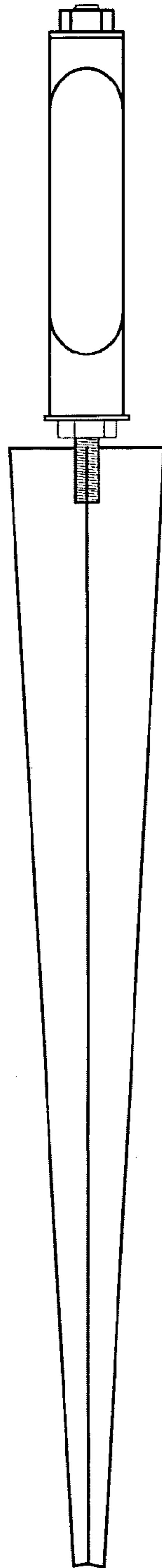

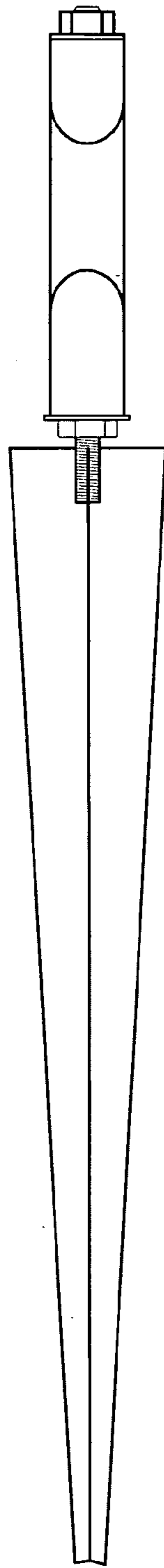

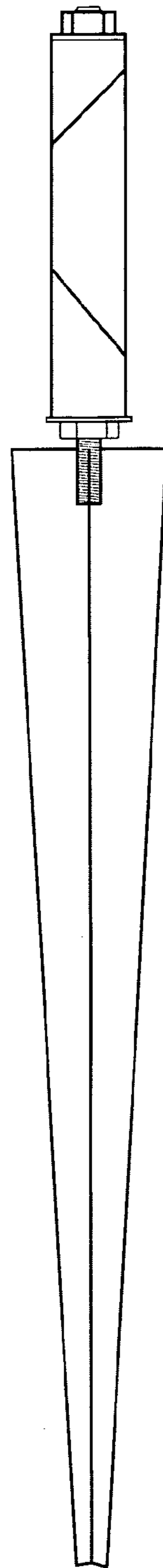

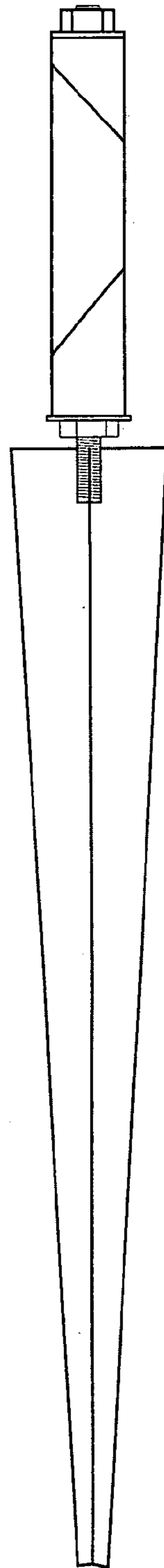

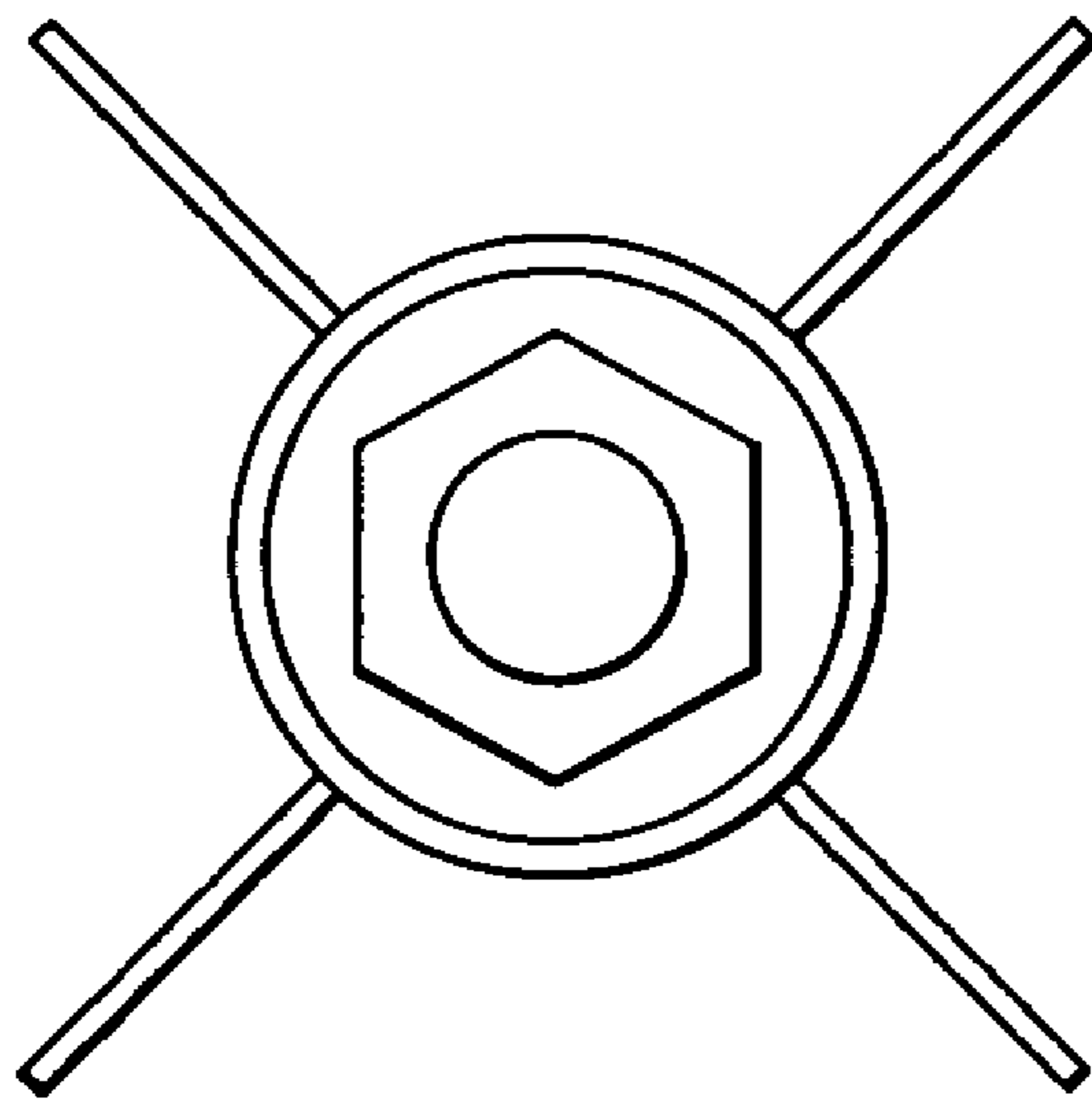

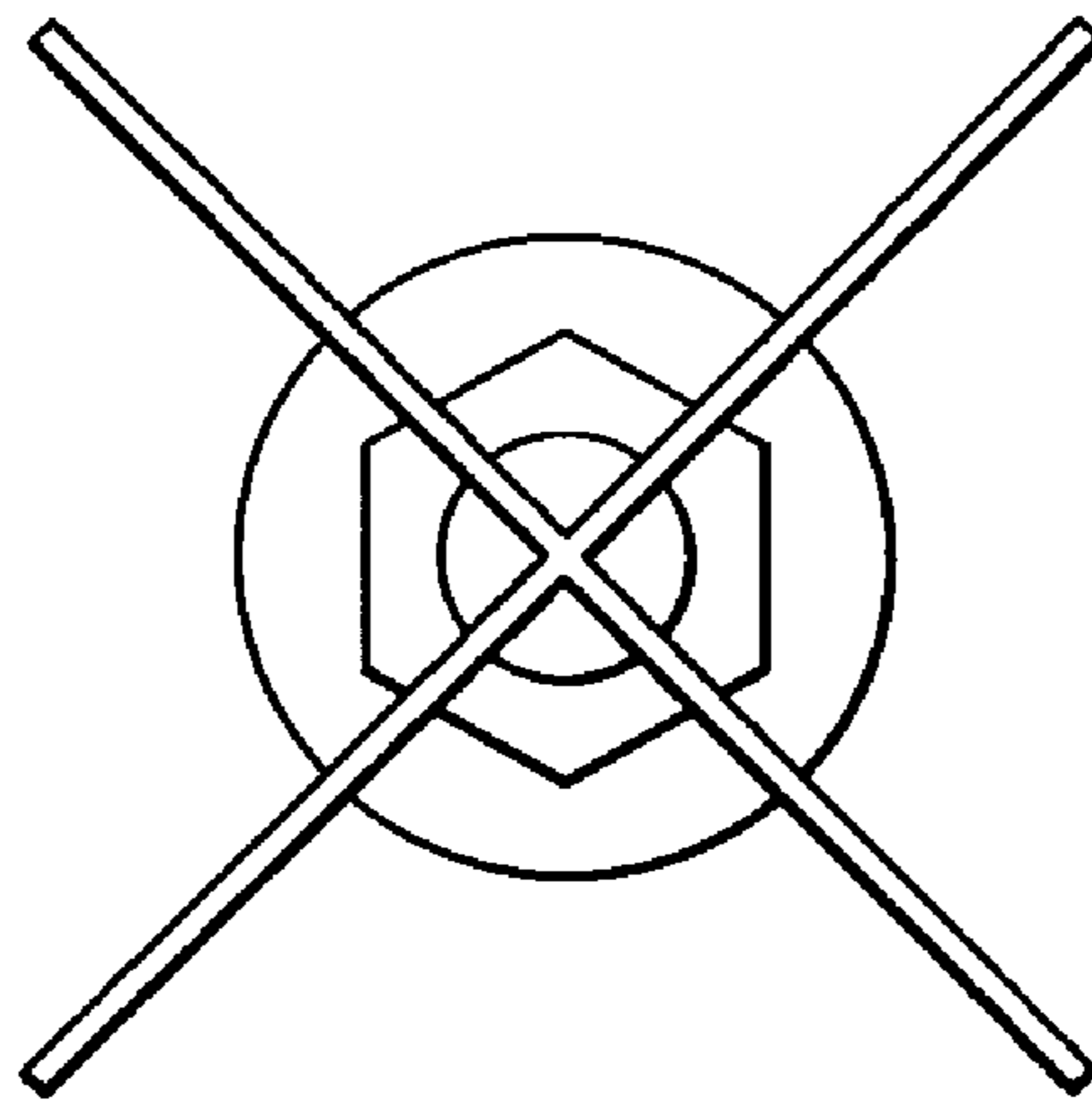

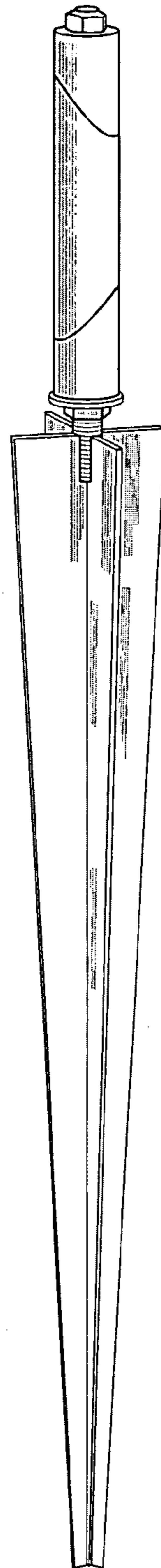

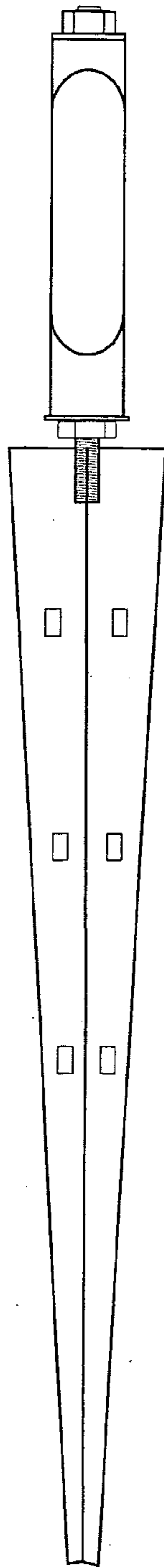

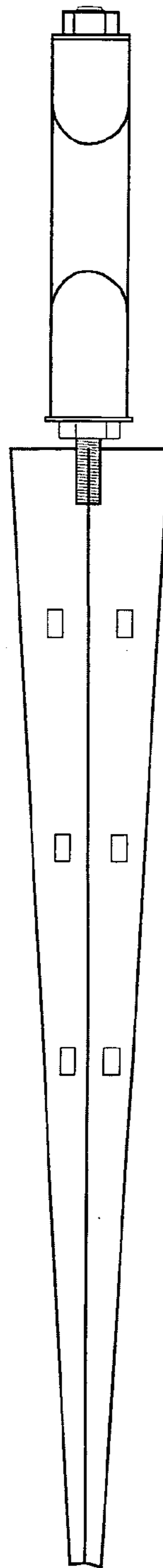

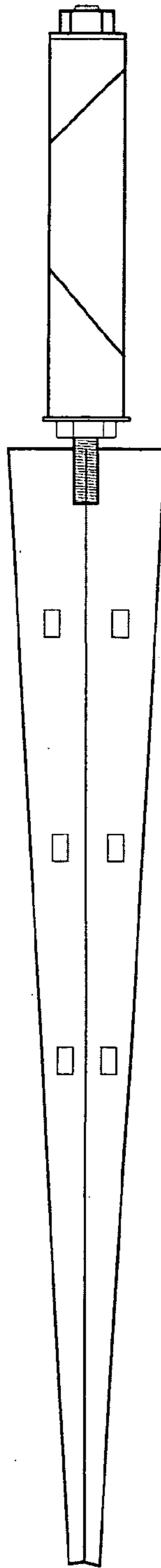

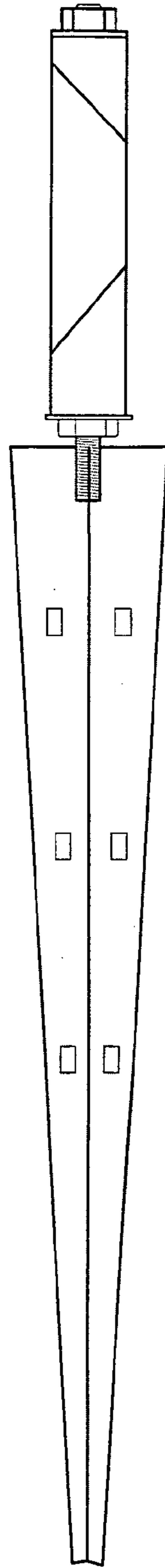

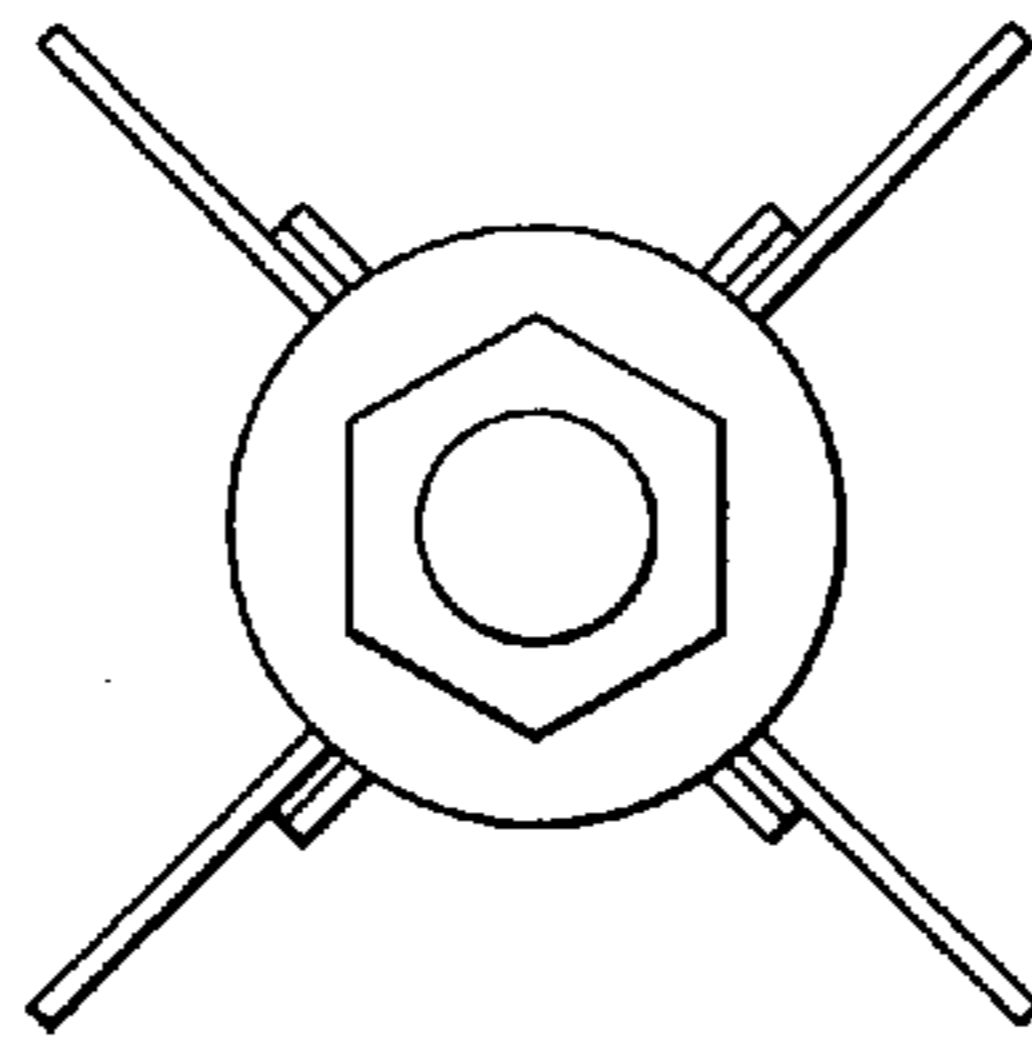

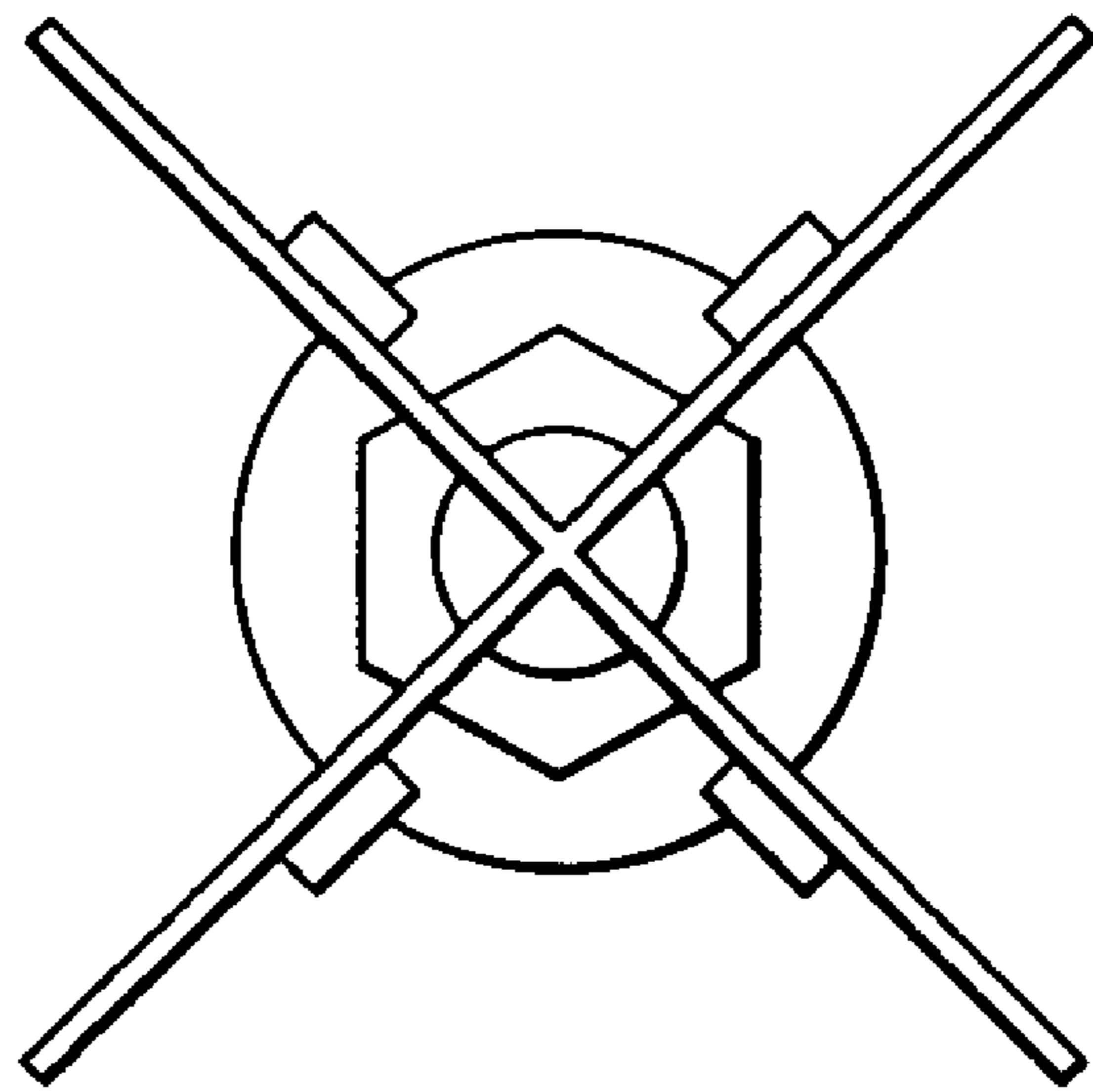

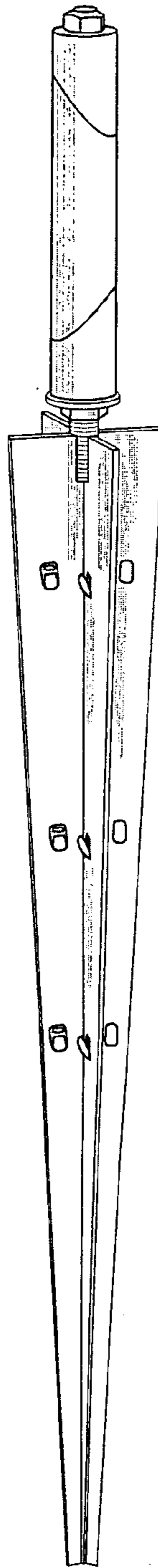
